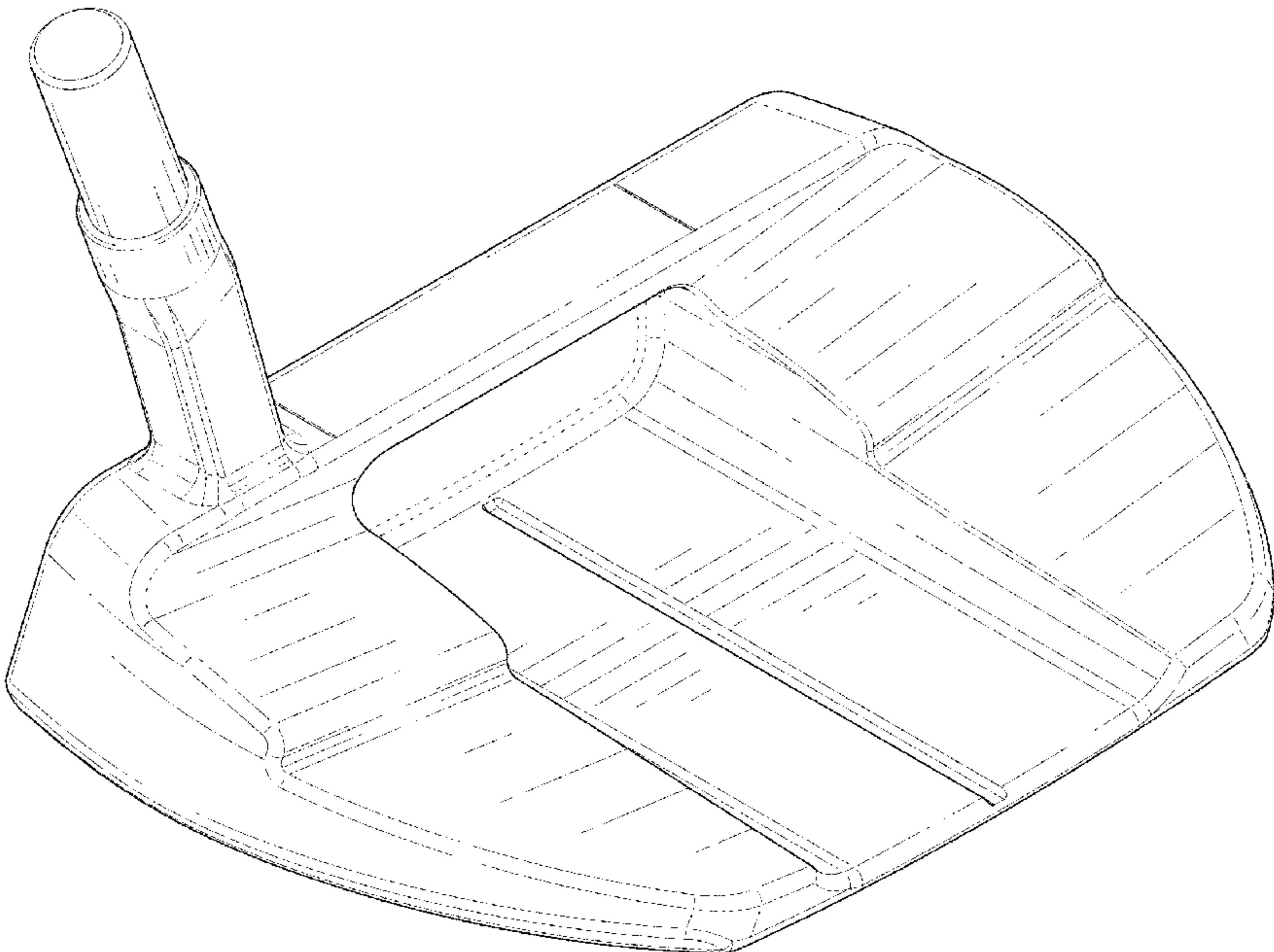
(57) CLAIM

The ornamental design for a golf club head as shown and described.

DESCRIPTION

FIG. 1 is a rear, heel-side, top perspective view of a golf club head, showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a toe-side elevational view thereof;
FIG. 5 is a heel-side elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines depict parts of the golf club head that form no part of the claimed design.

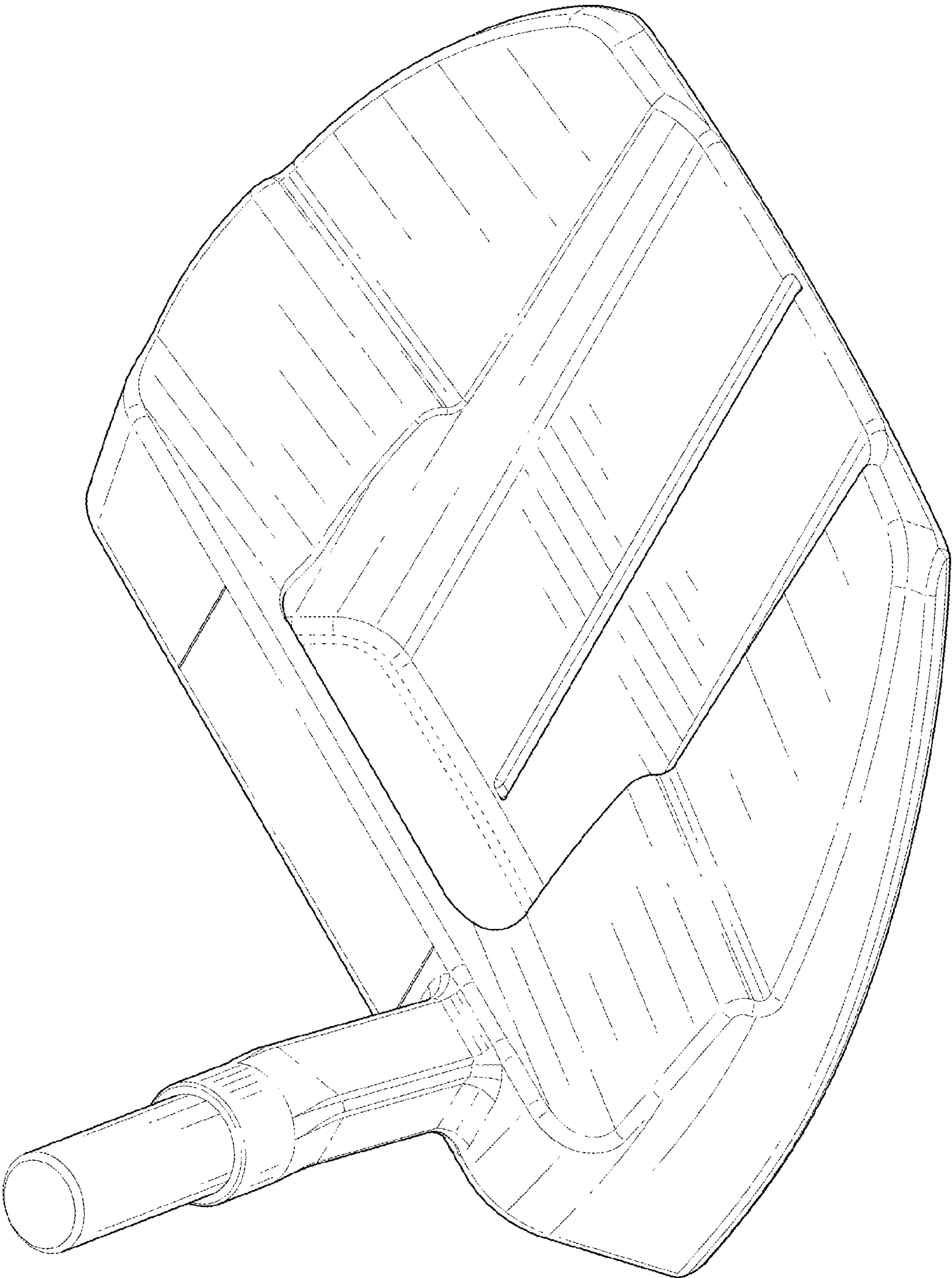

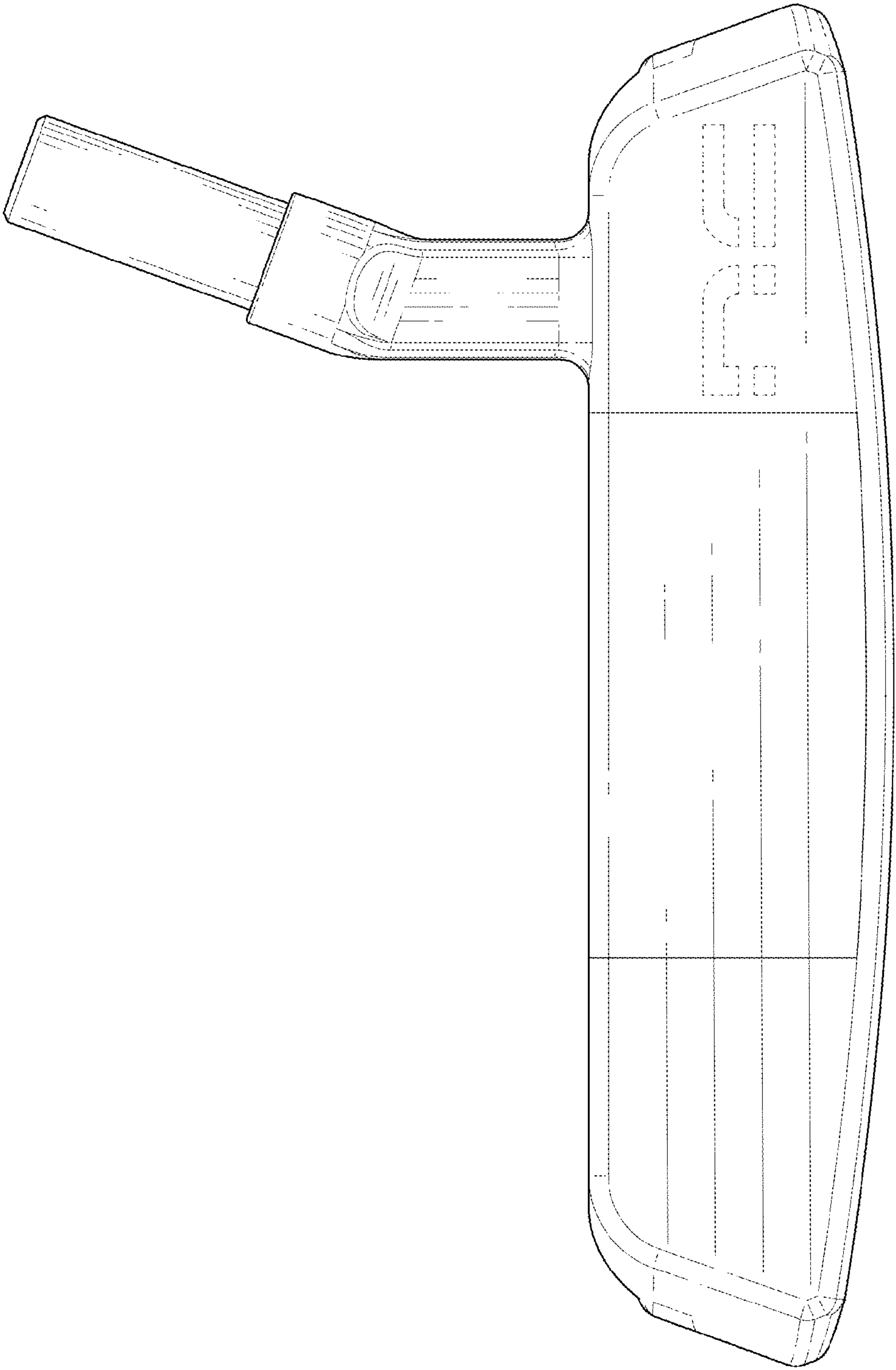

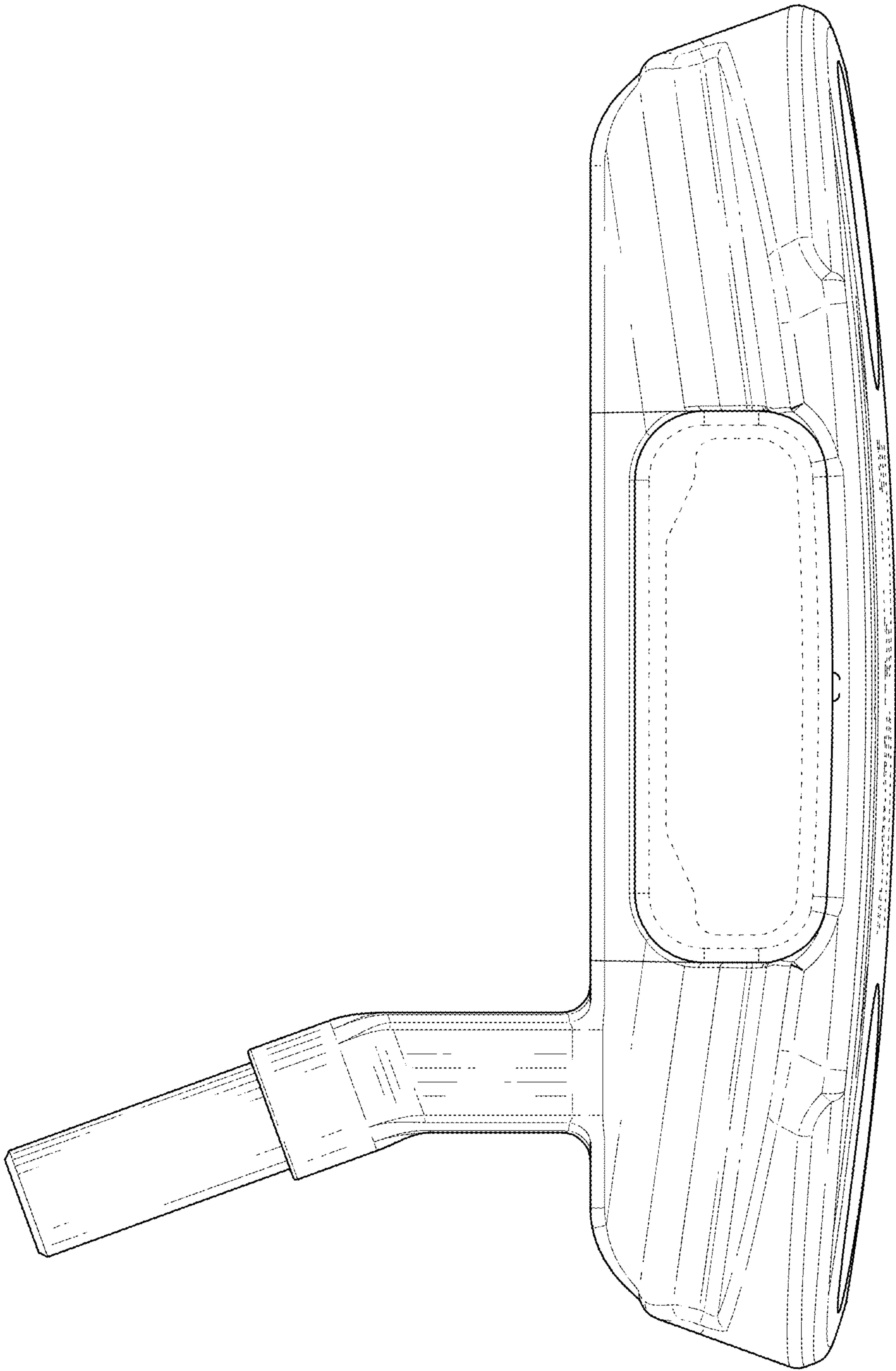

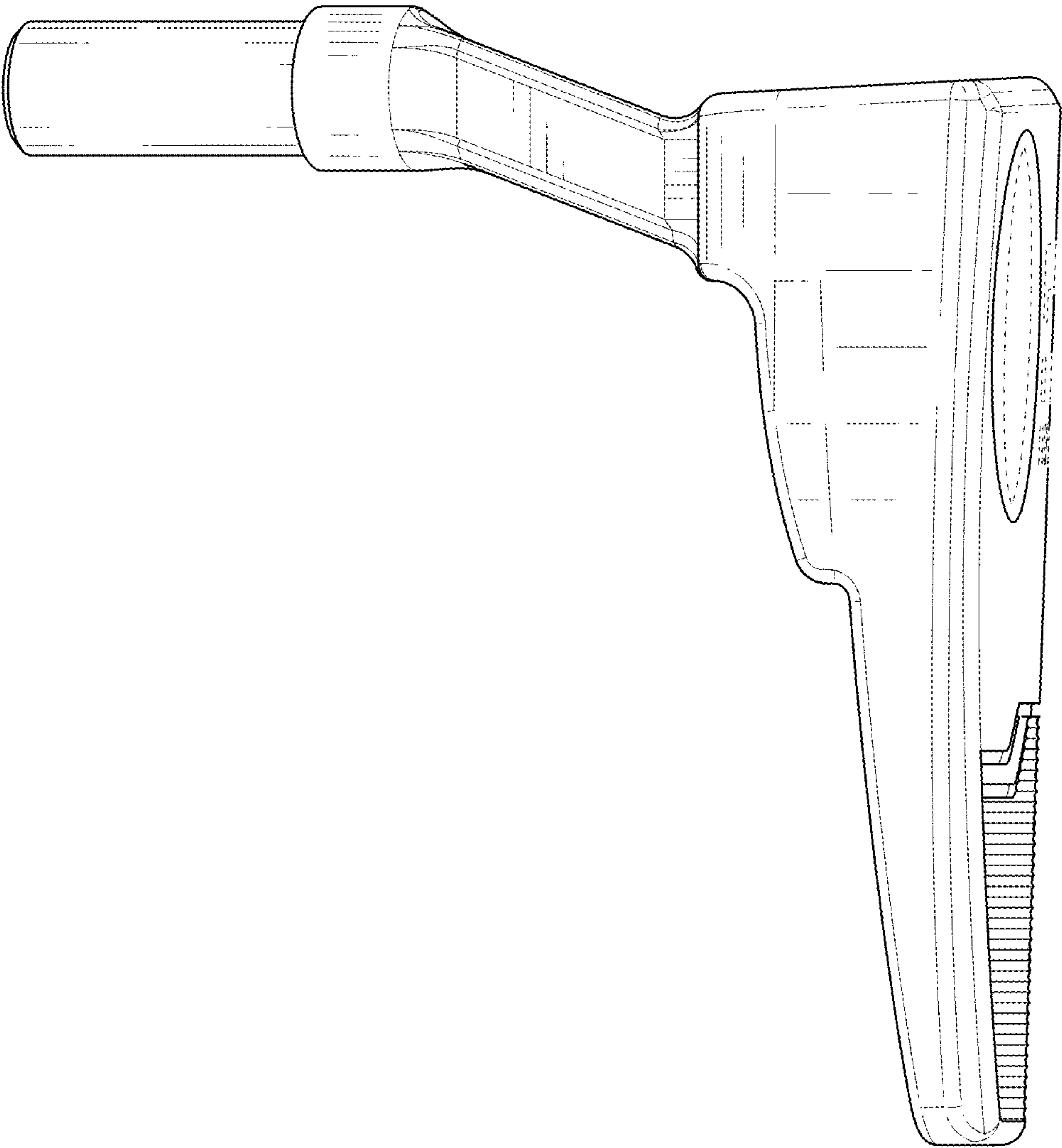

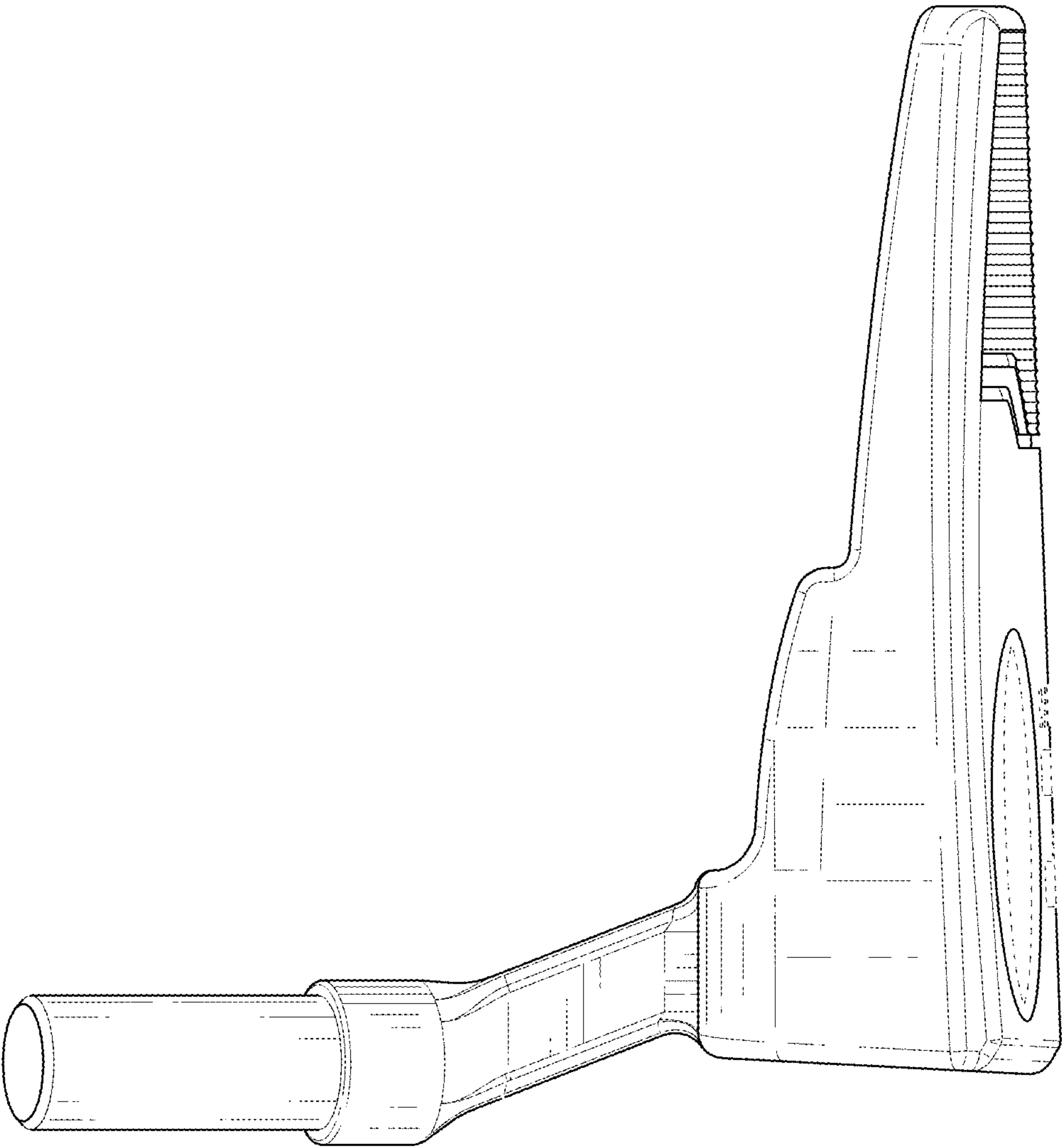

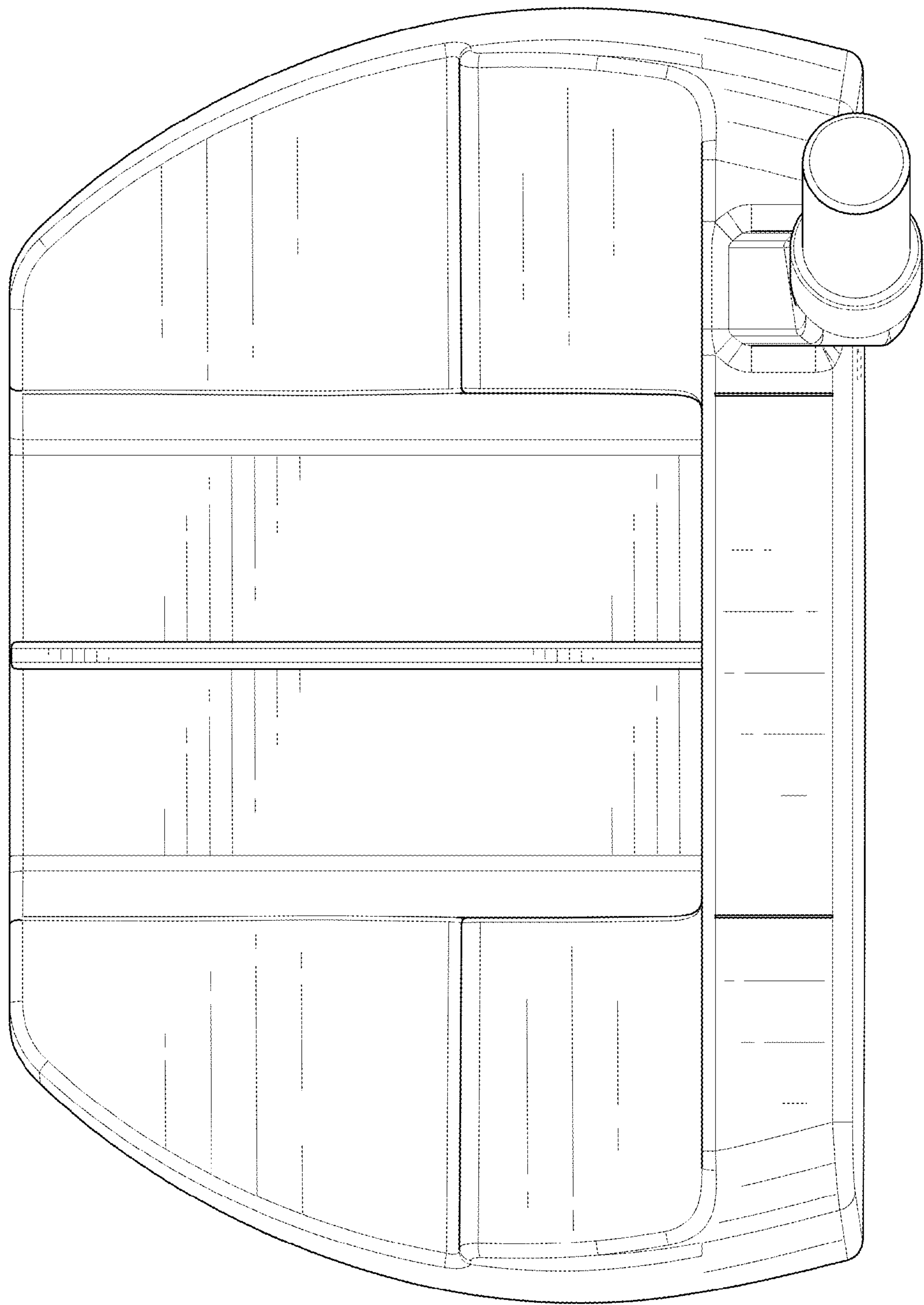

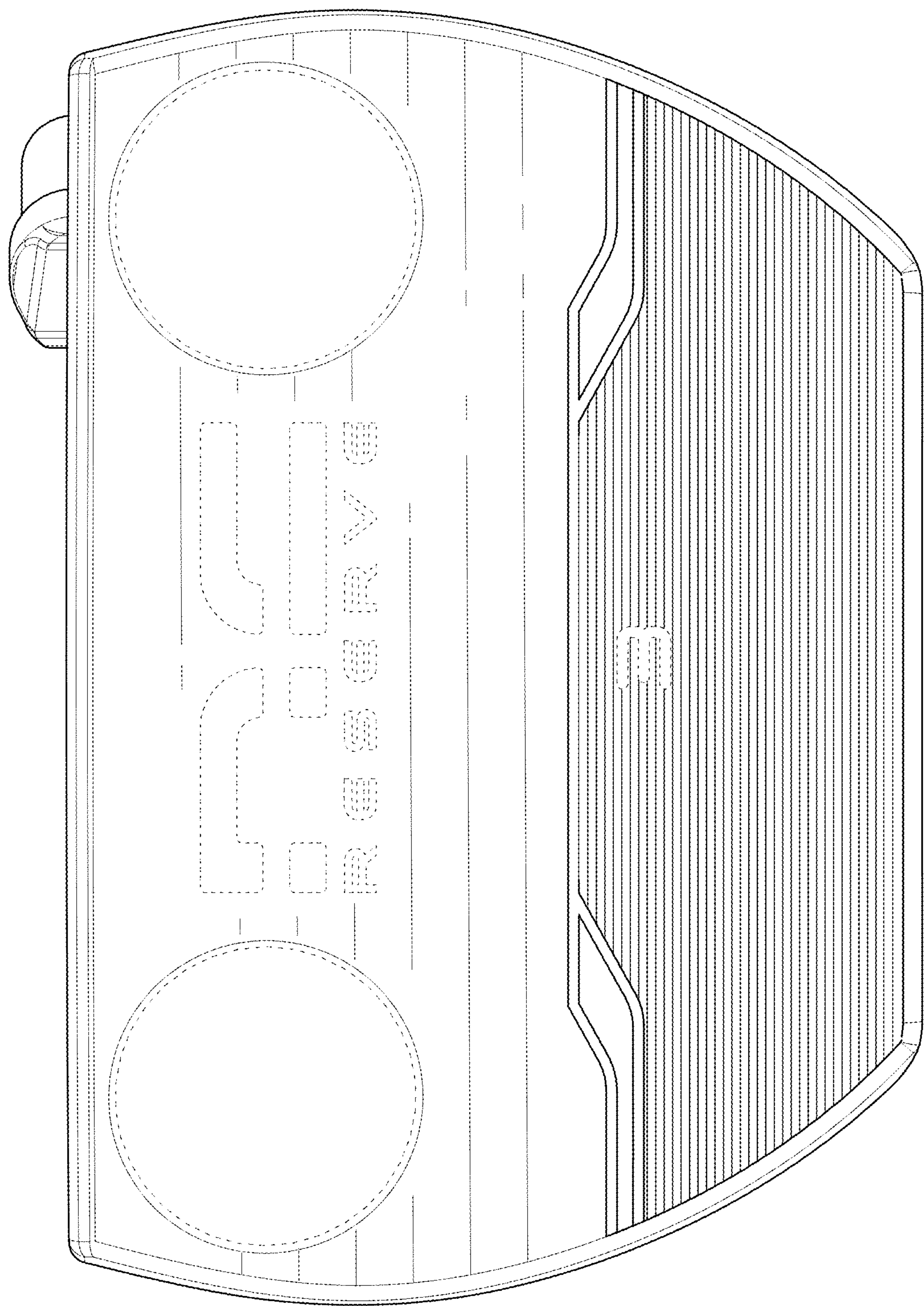
