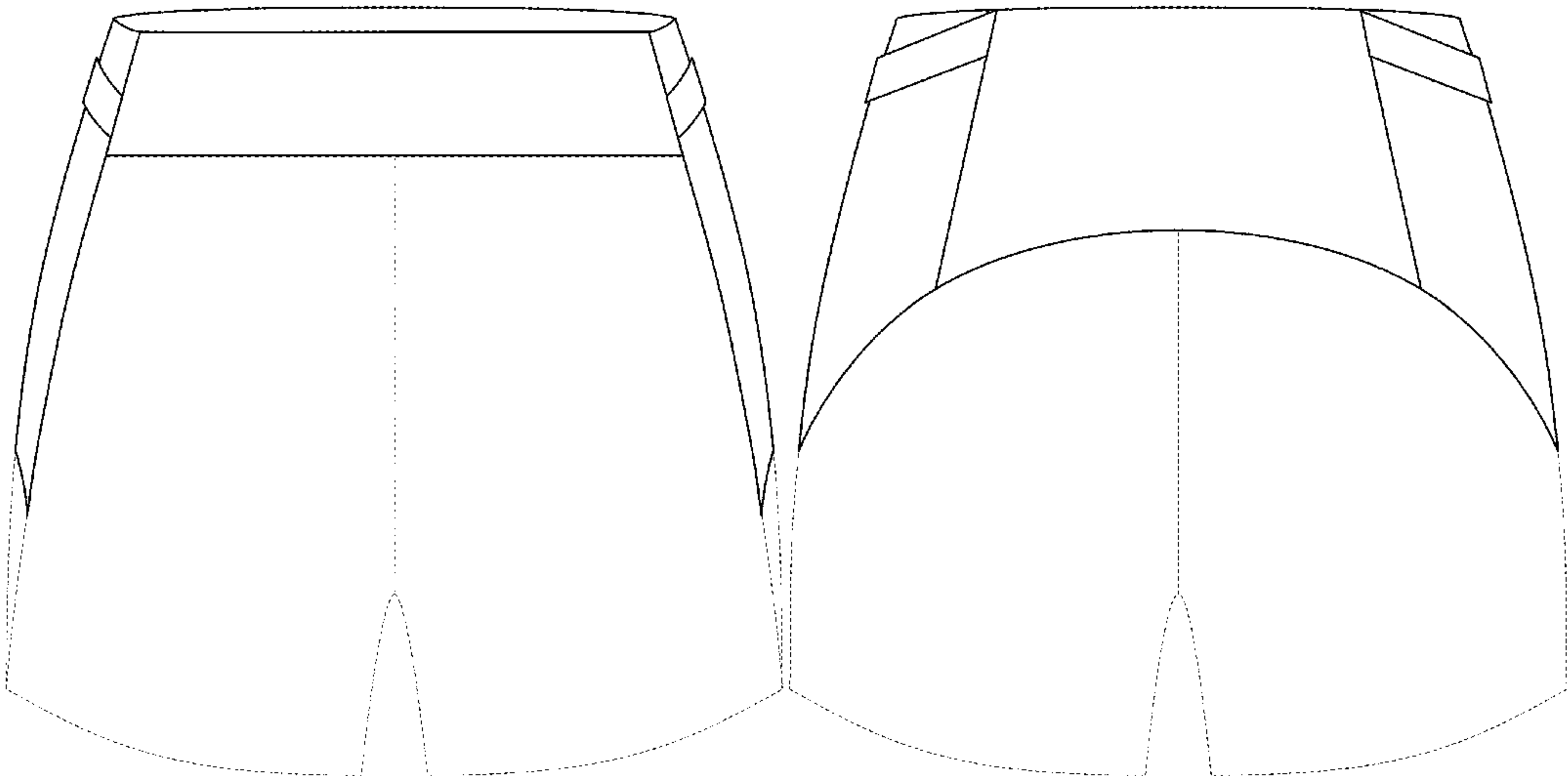
(57) CLAIM

The ornamental design for a bottom wear garment, as shown and described.

DESCRIPTION

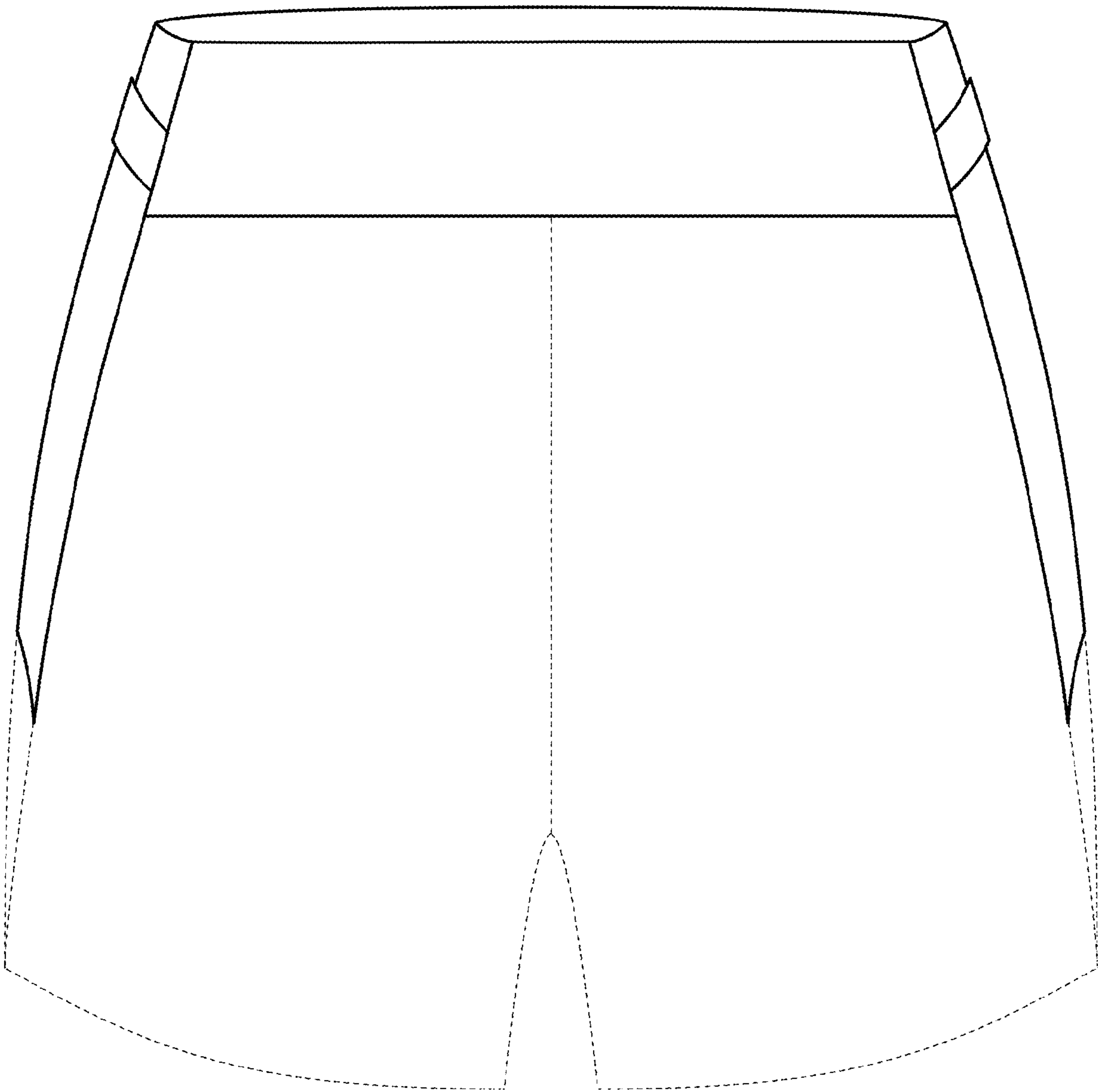

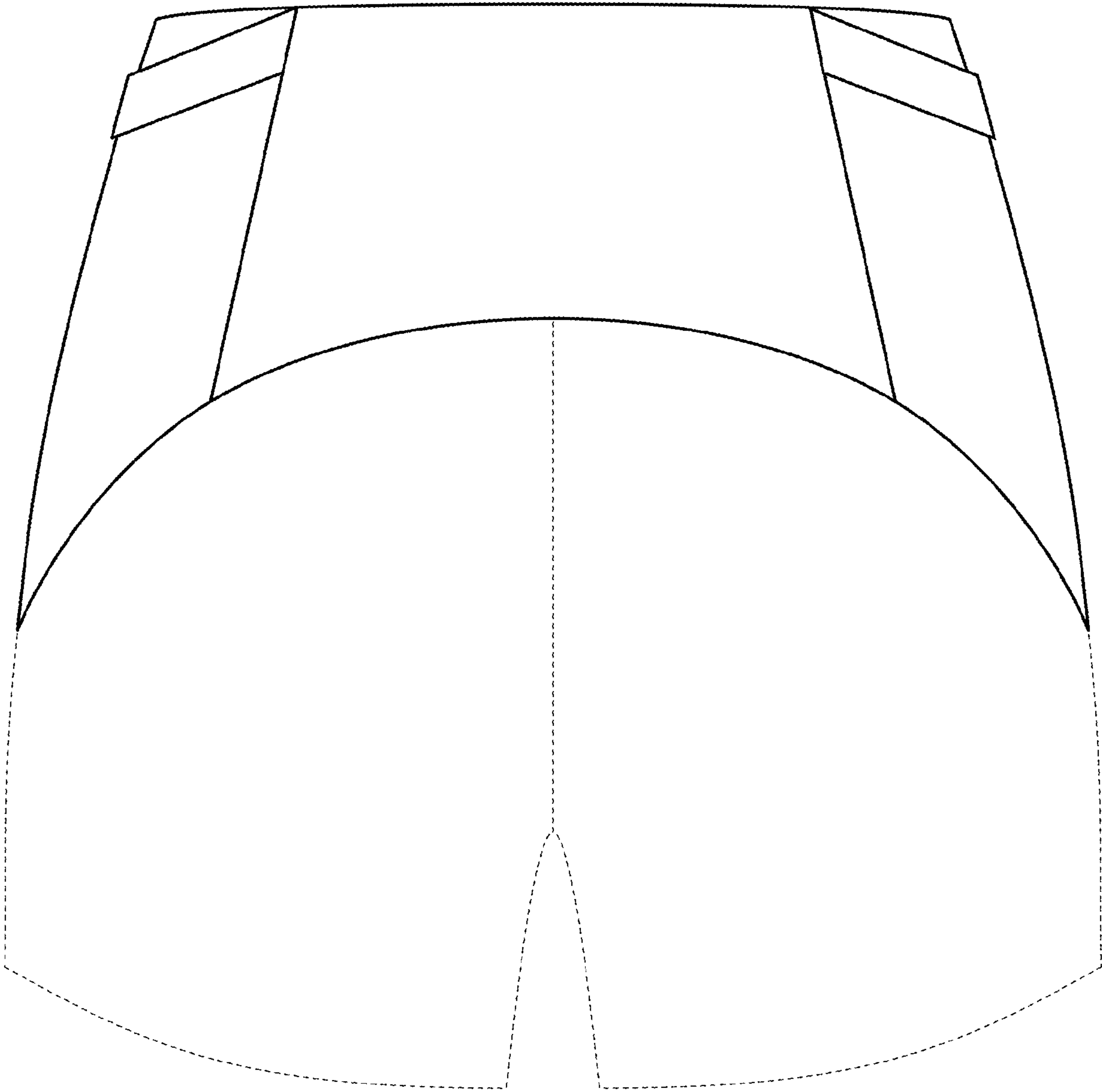

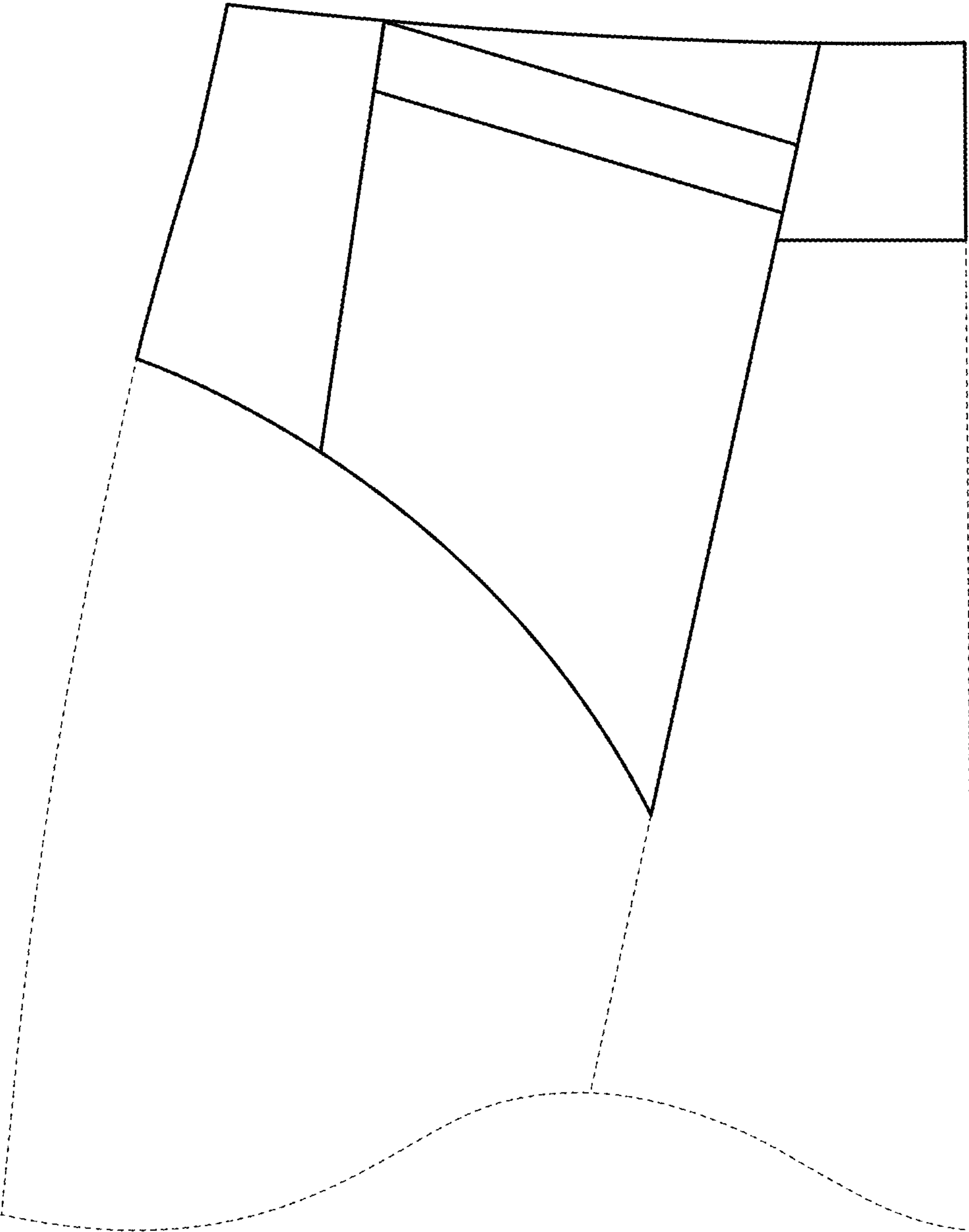

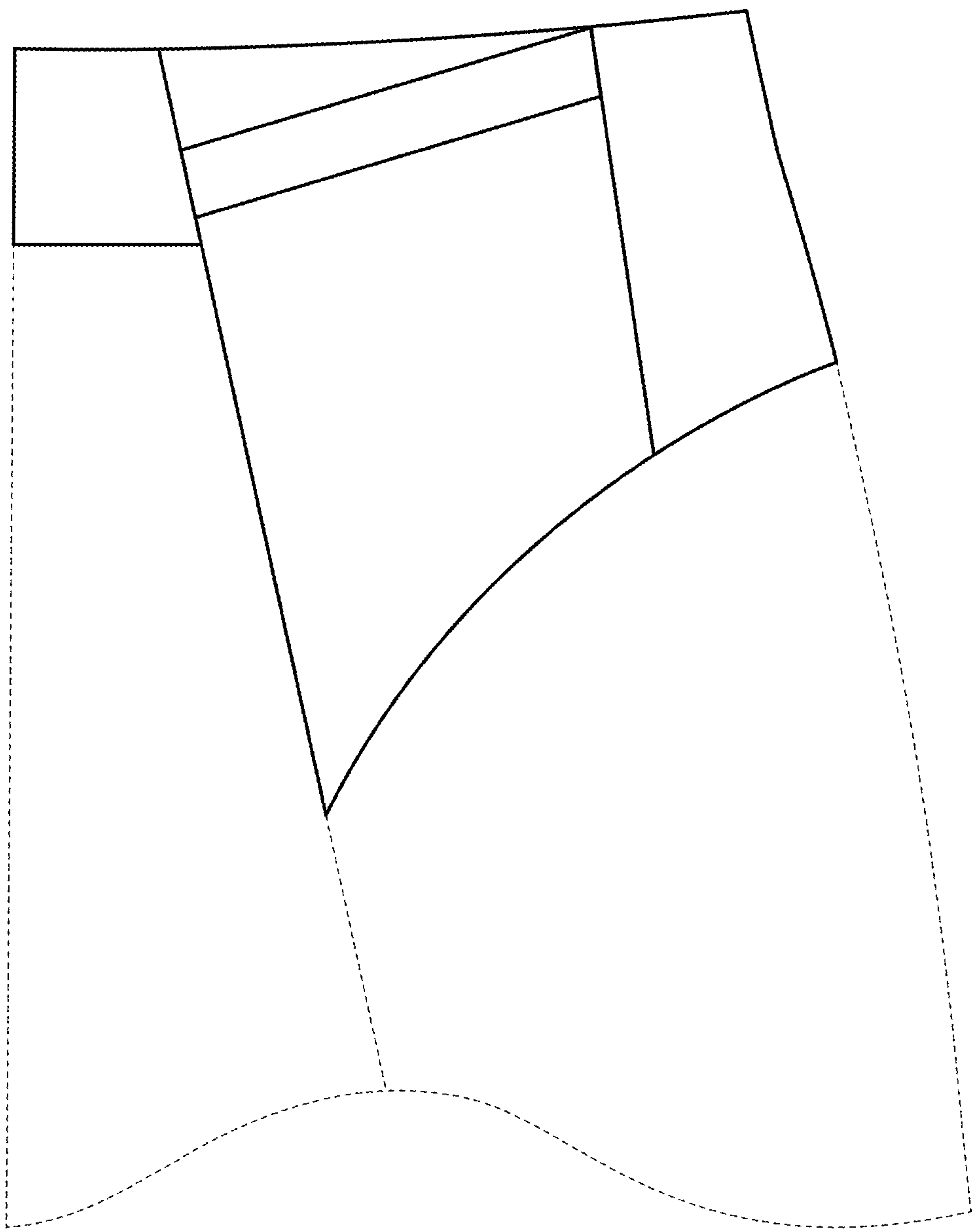

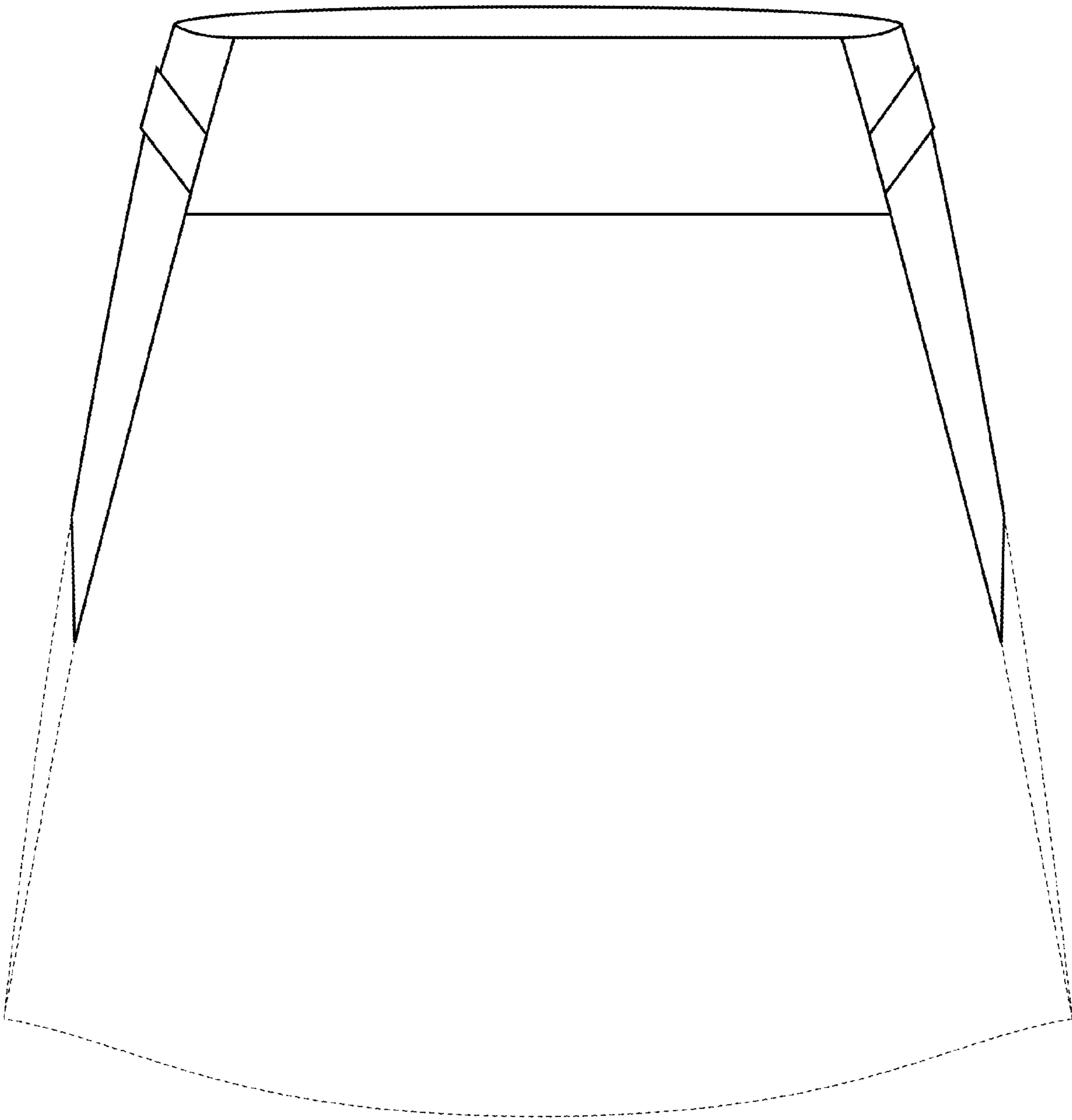

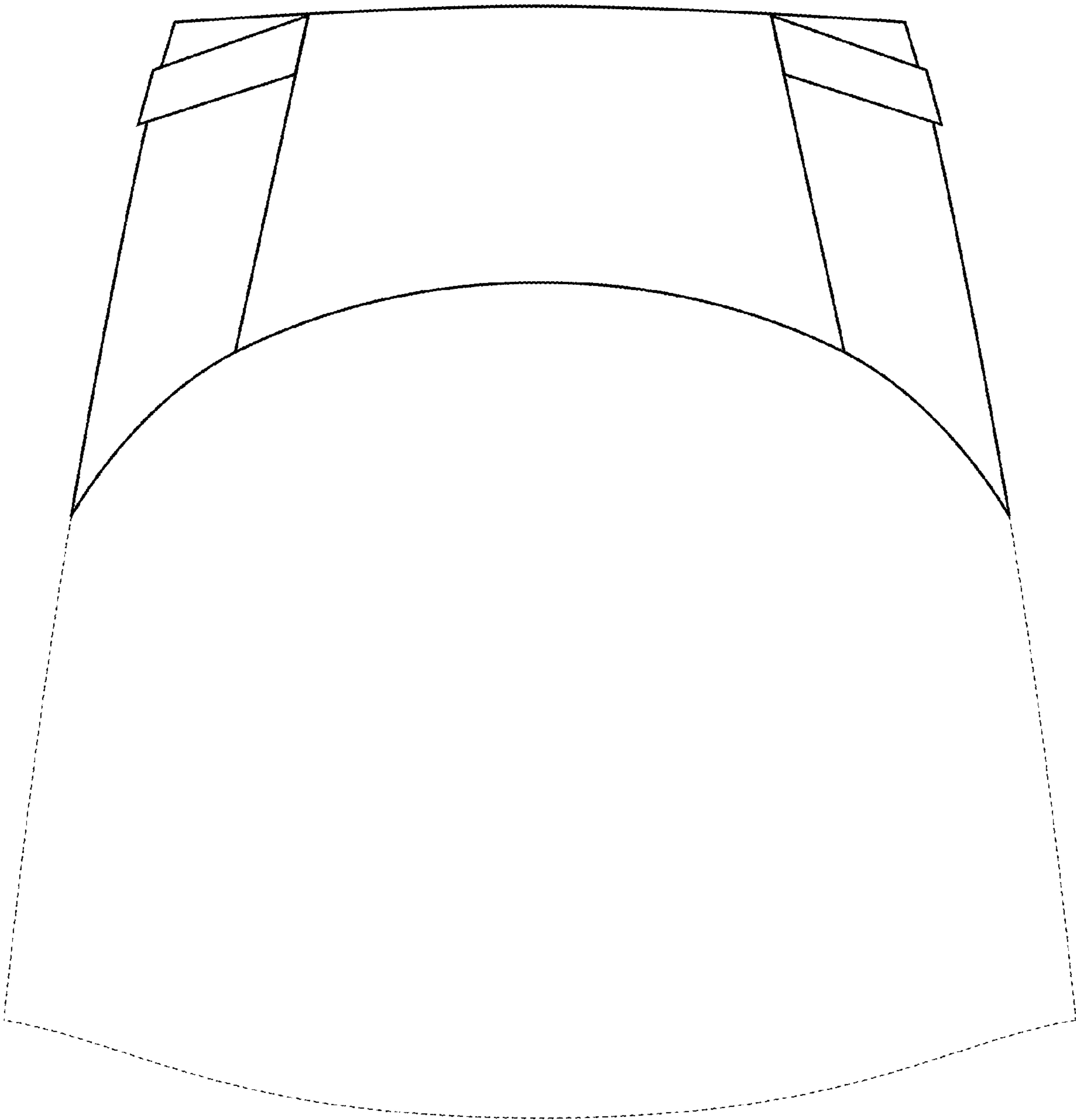

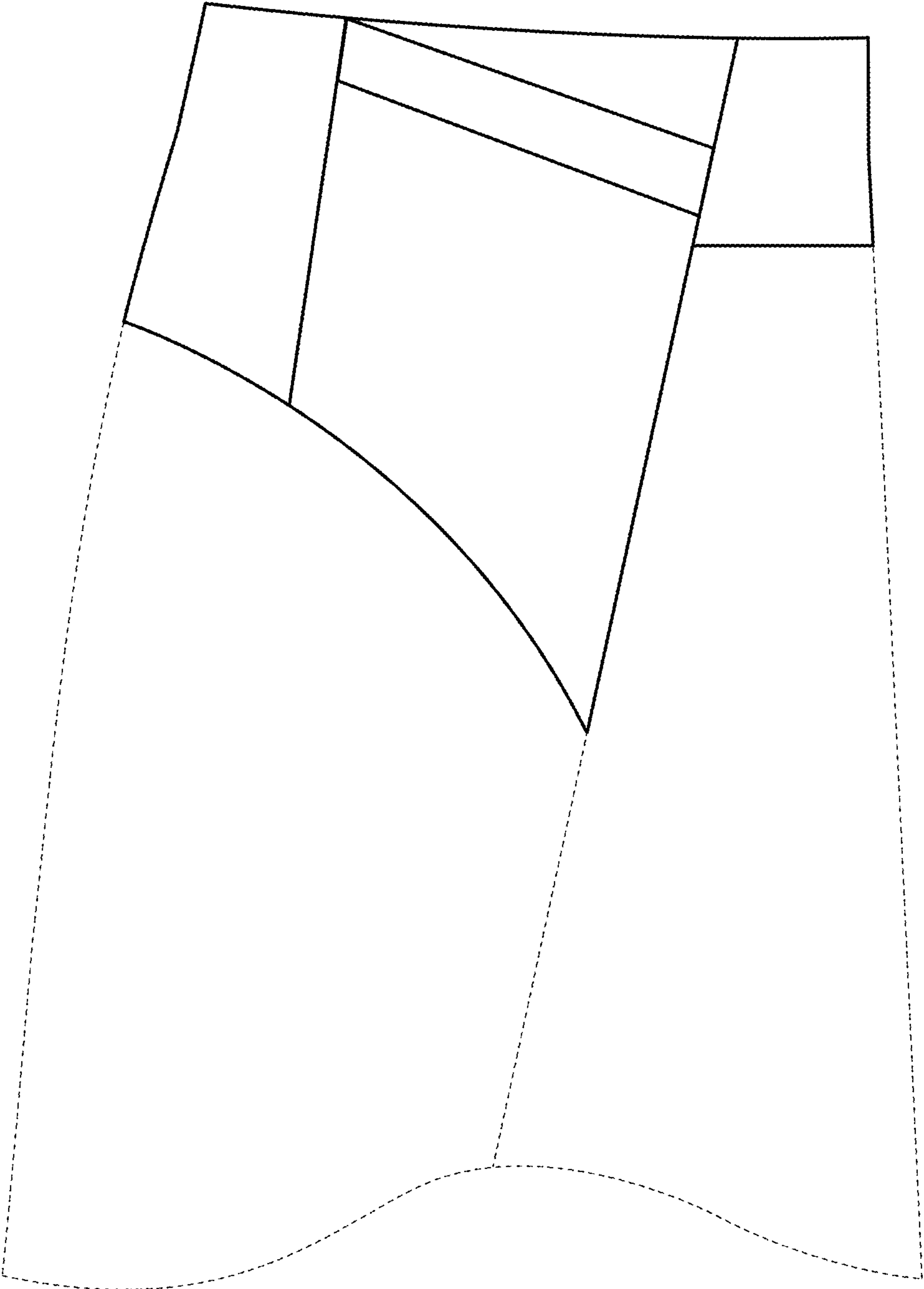

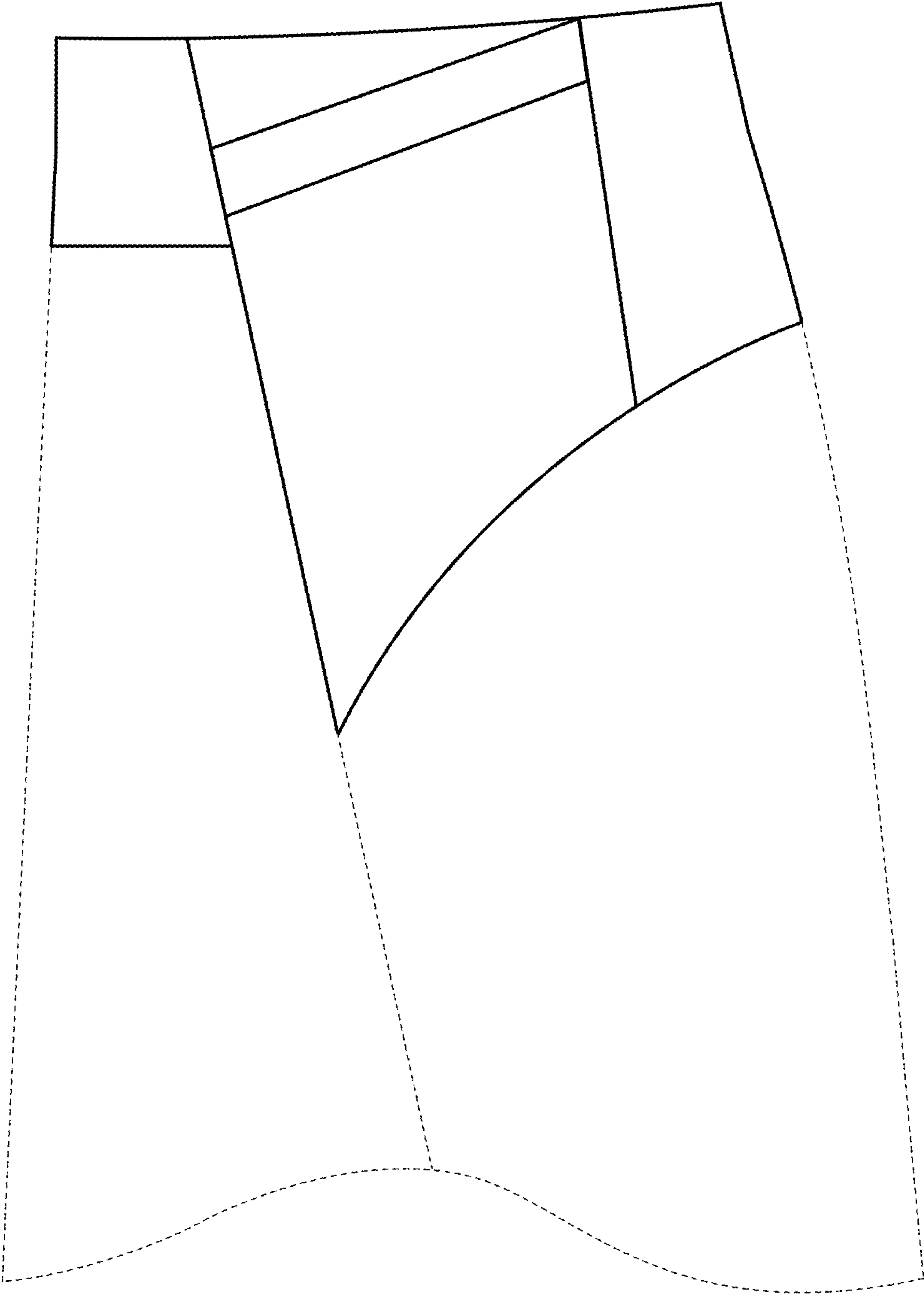

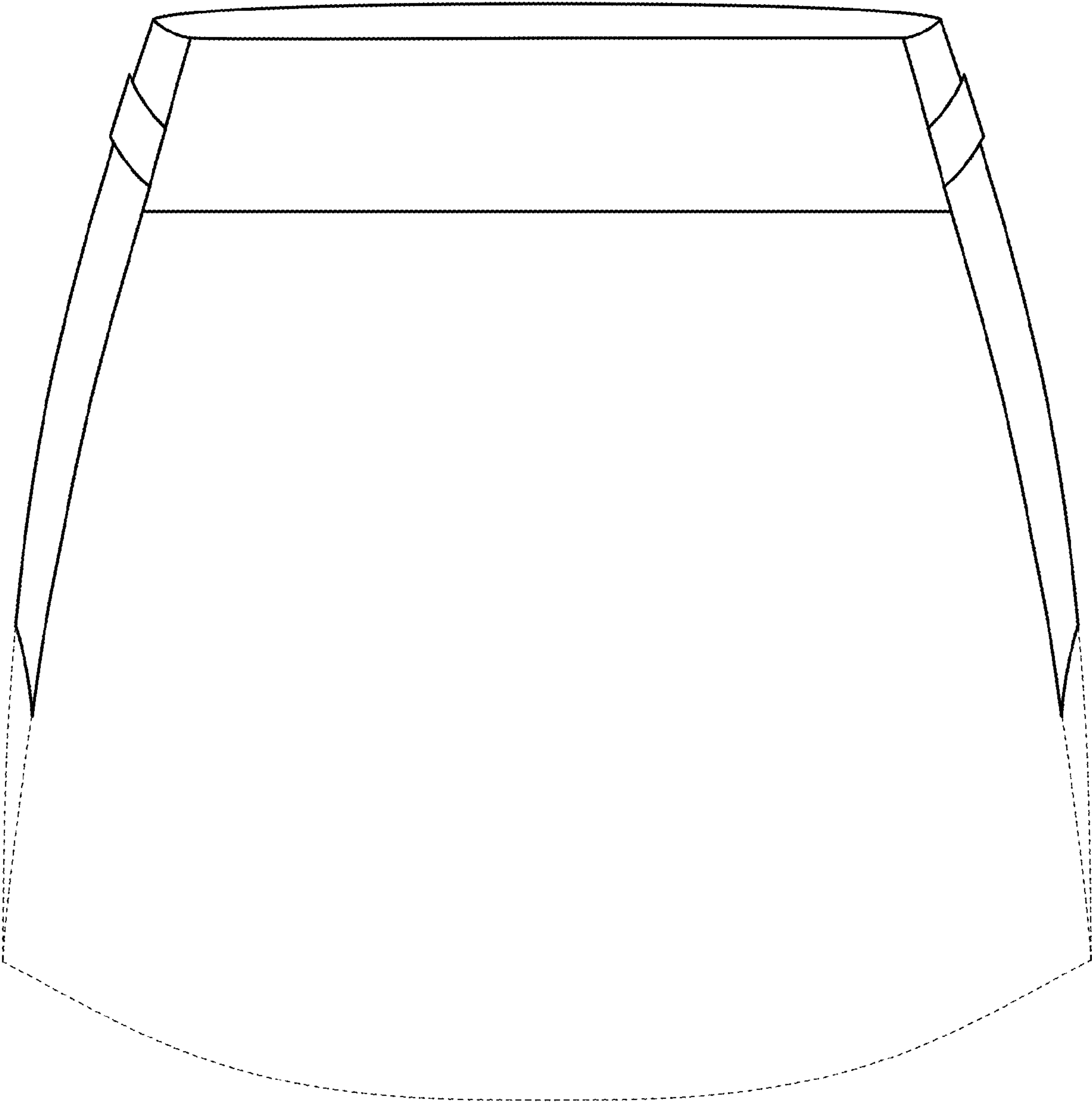

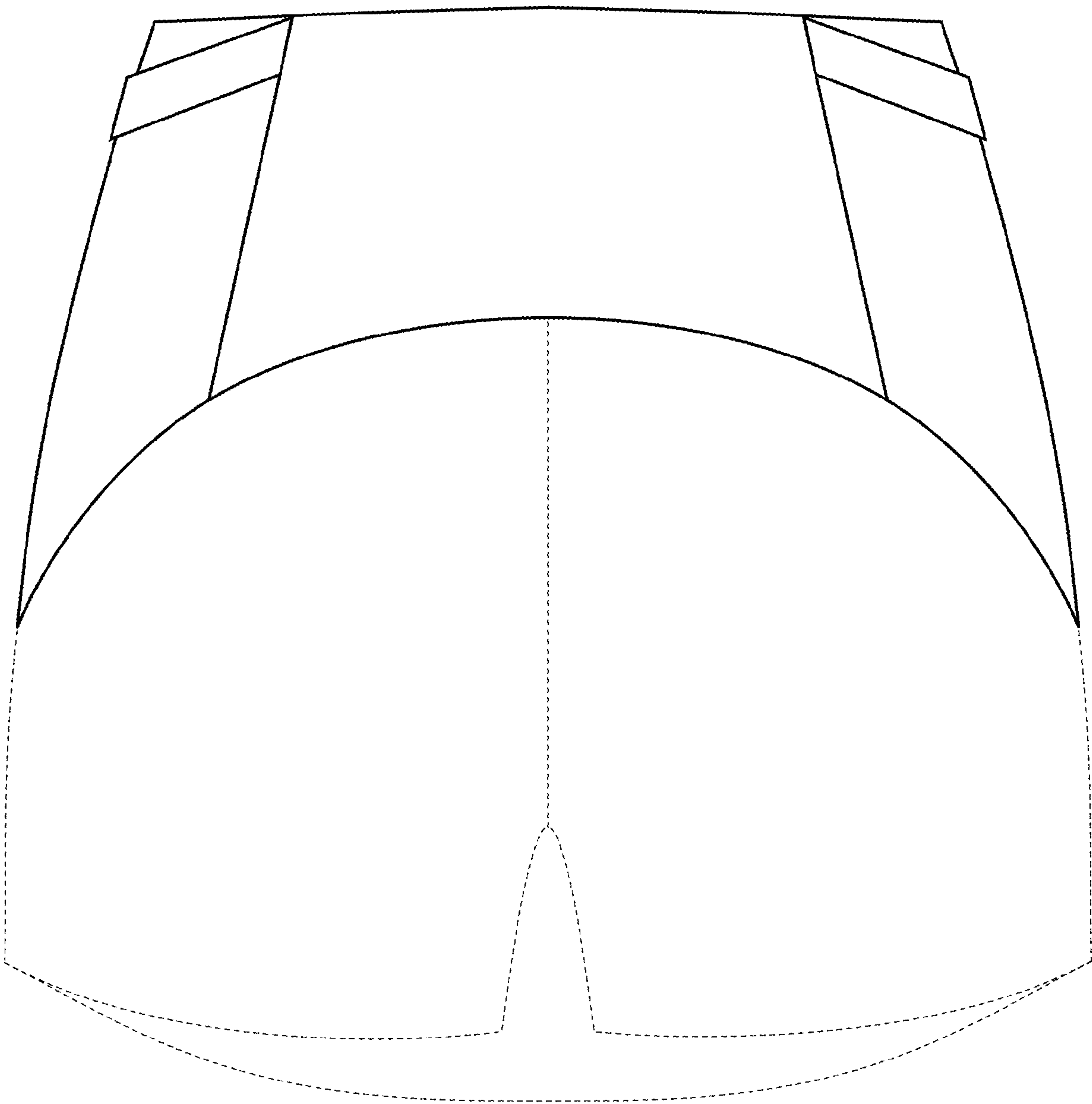

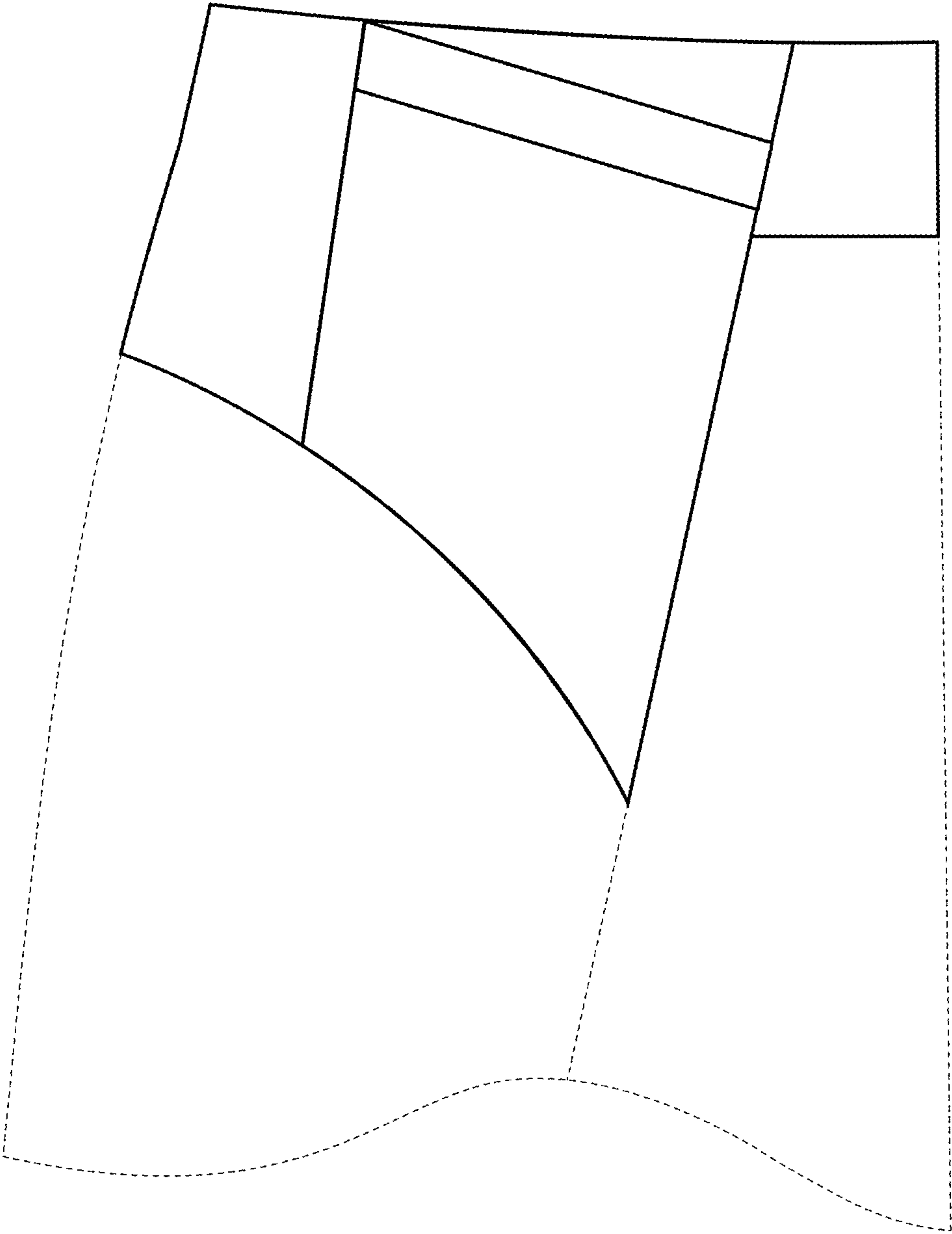

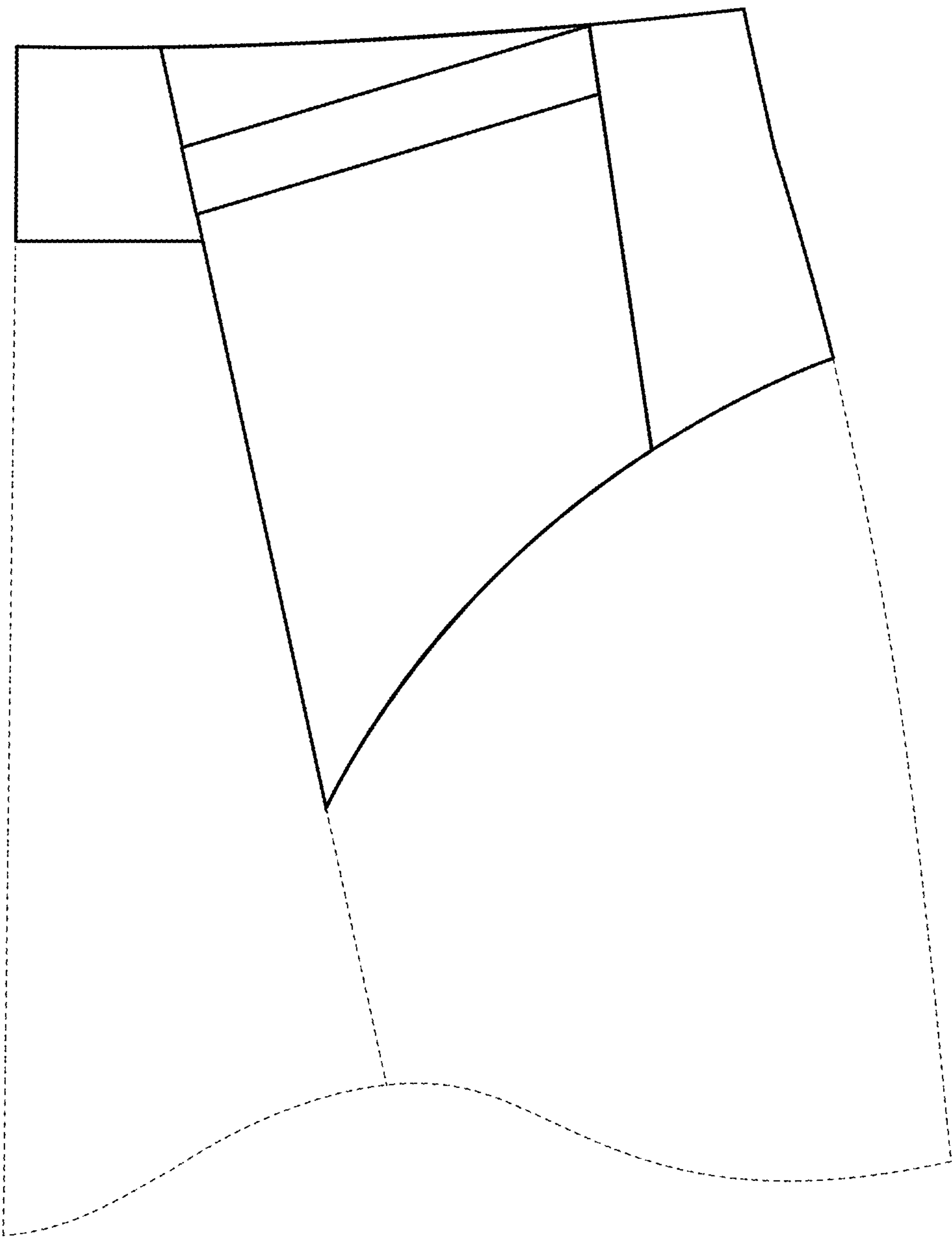

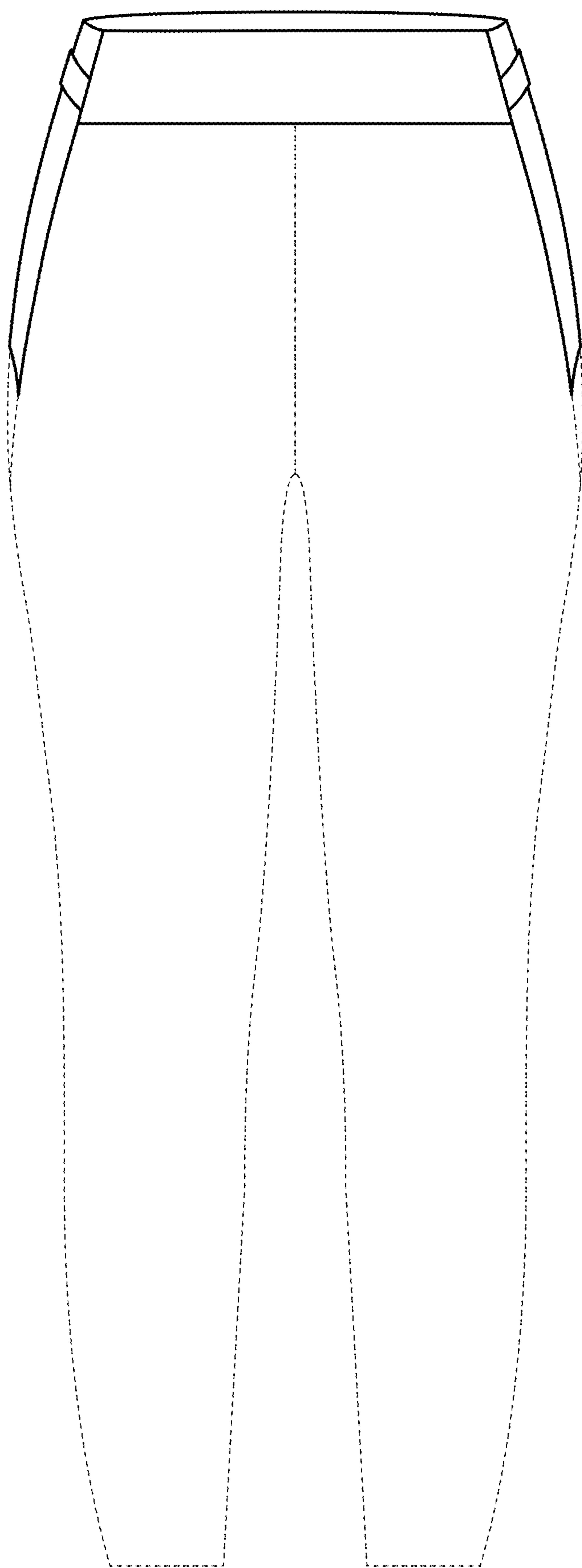

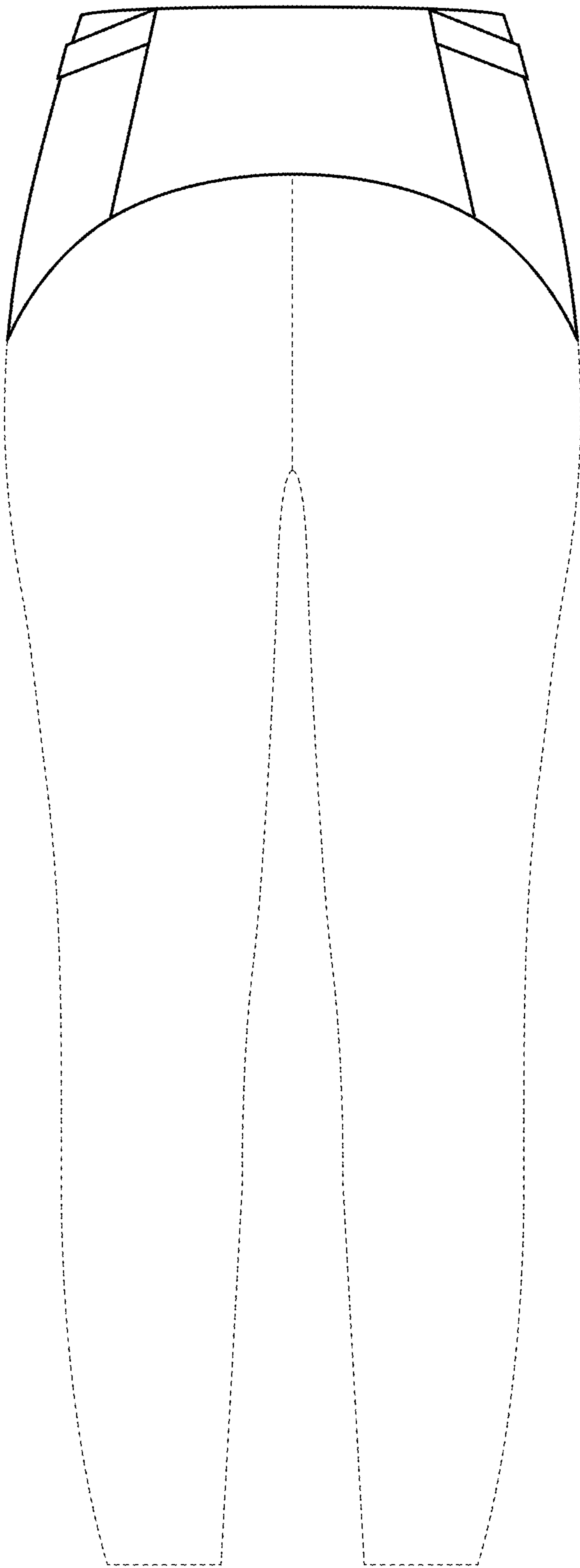

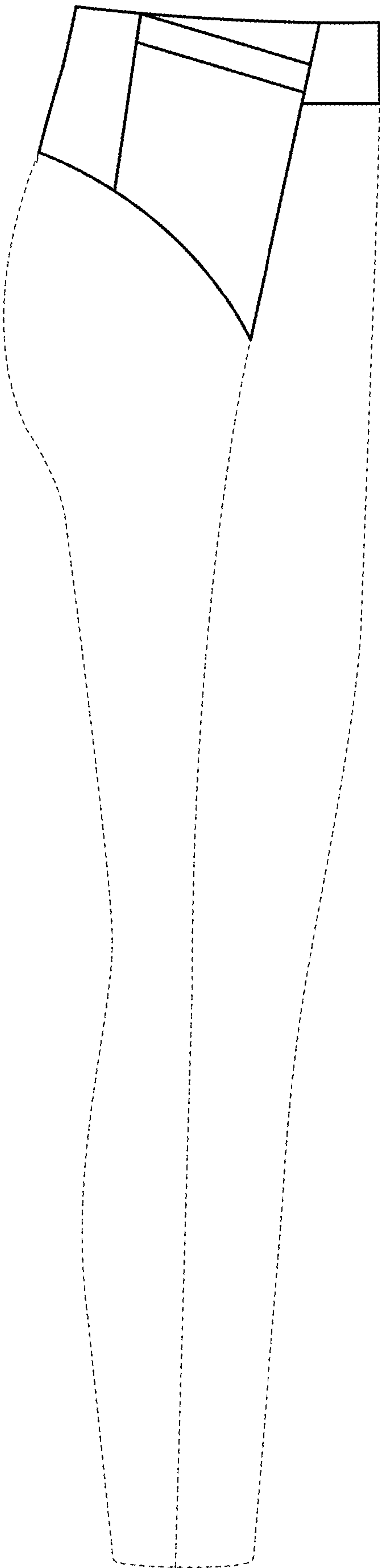

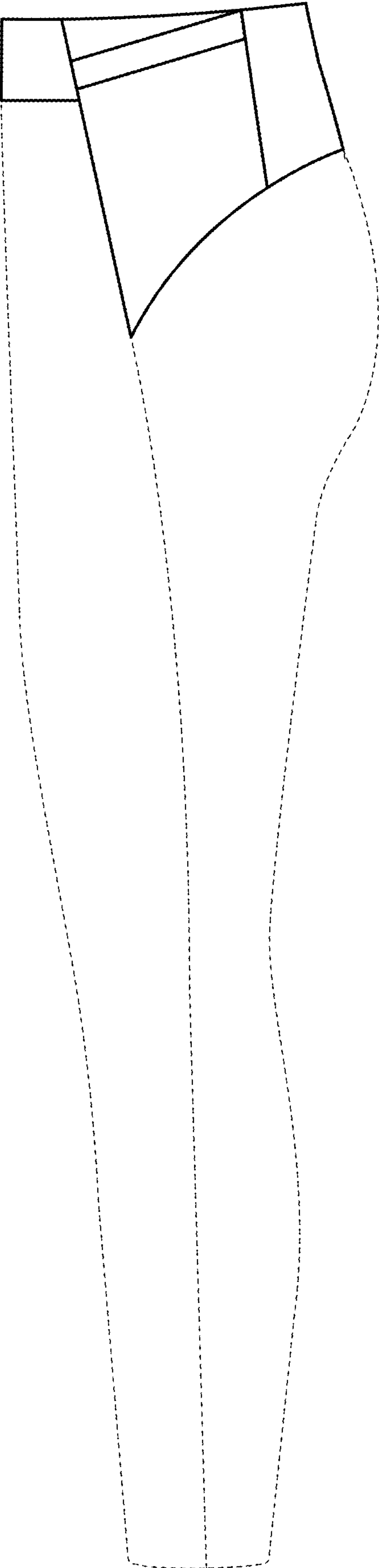
