The ornamental design for spectacles, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective of spectacles, showing my new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a side view thereof;

FIG. 5 is a side view thereof, opposite that of FIG. 4;

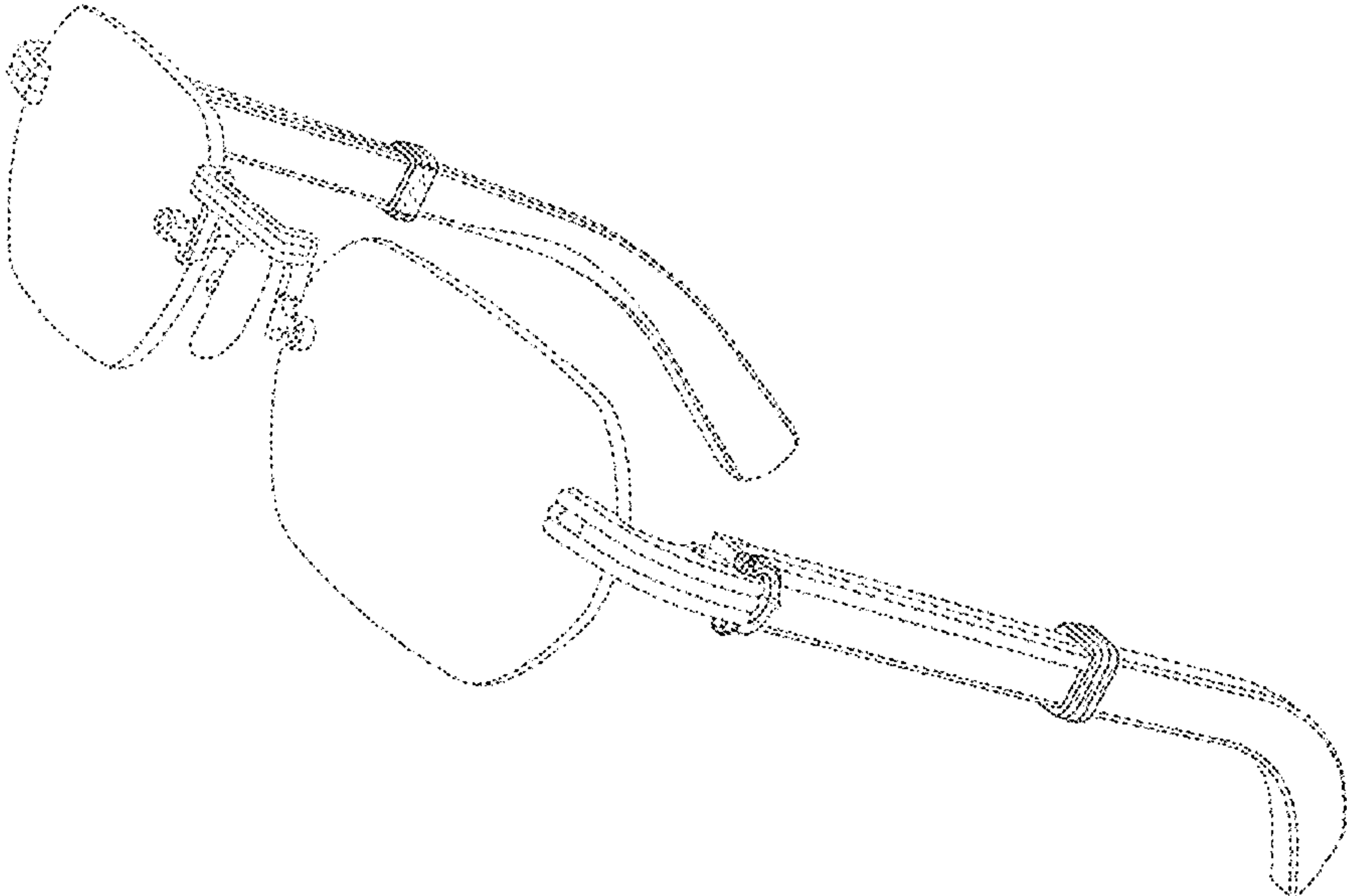
FIG. 6 is a top view thereof;

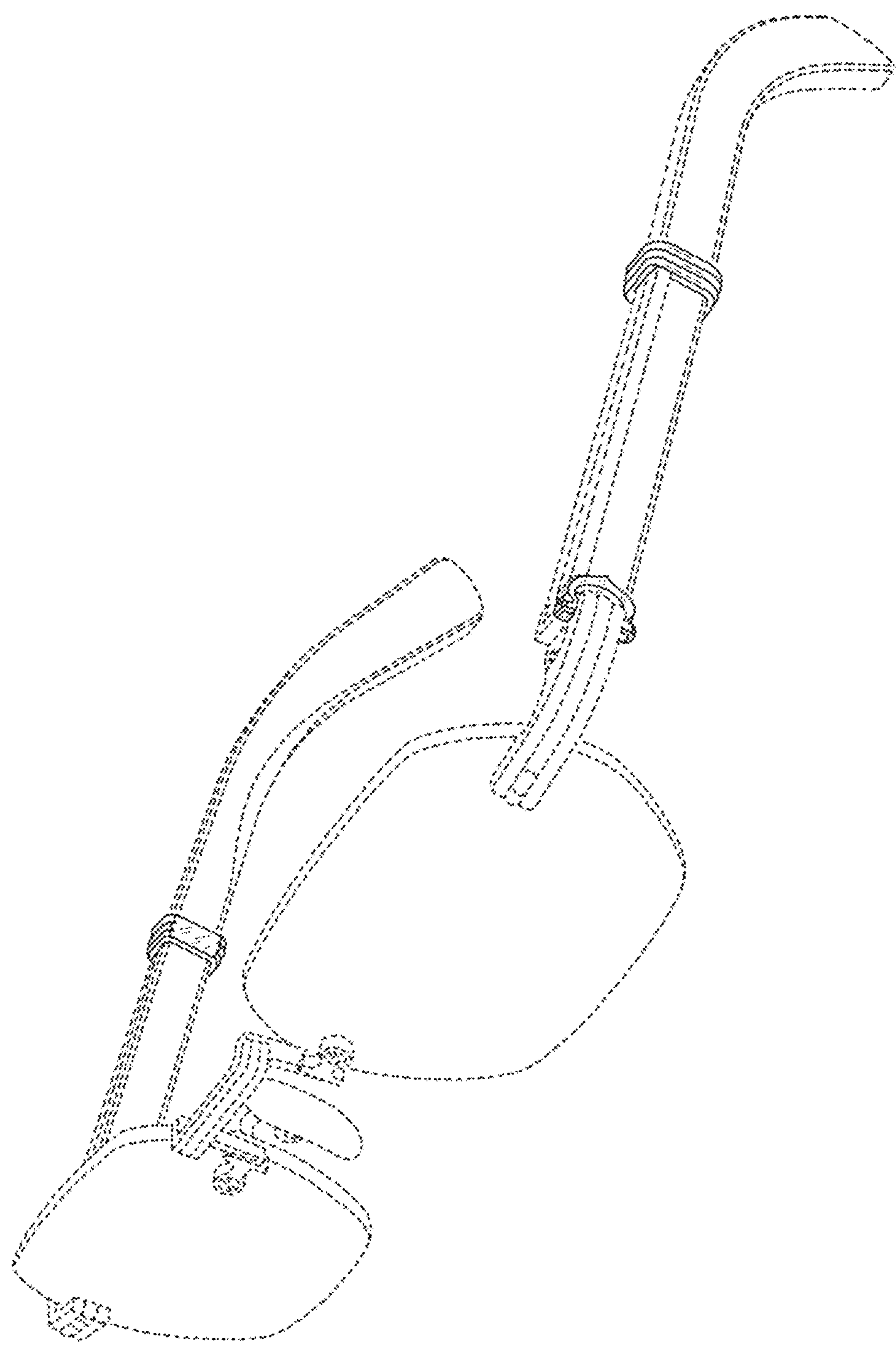

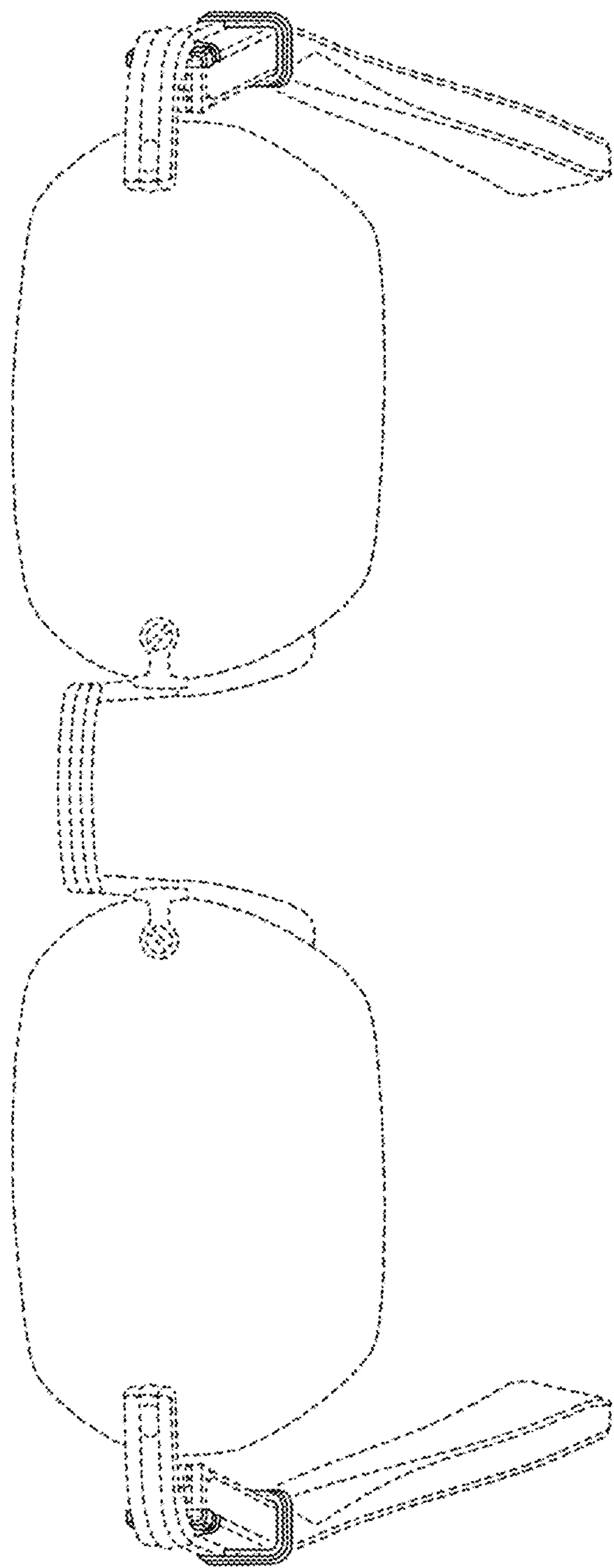

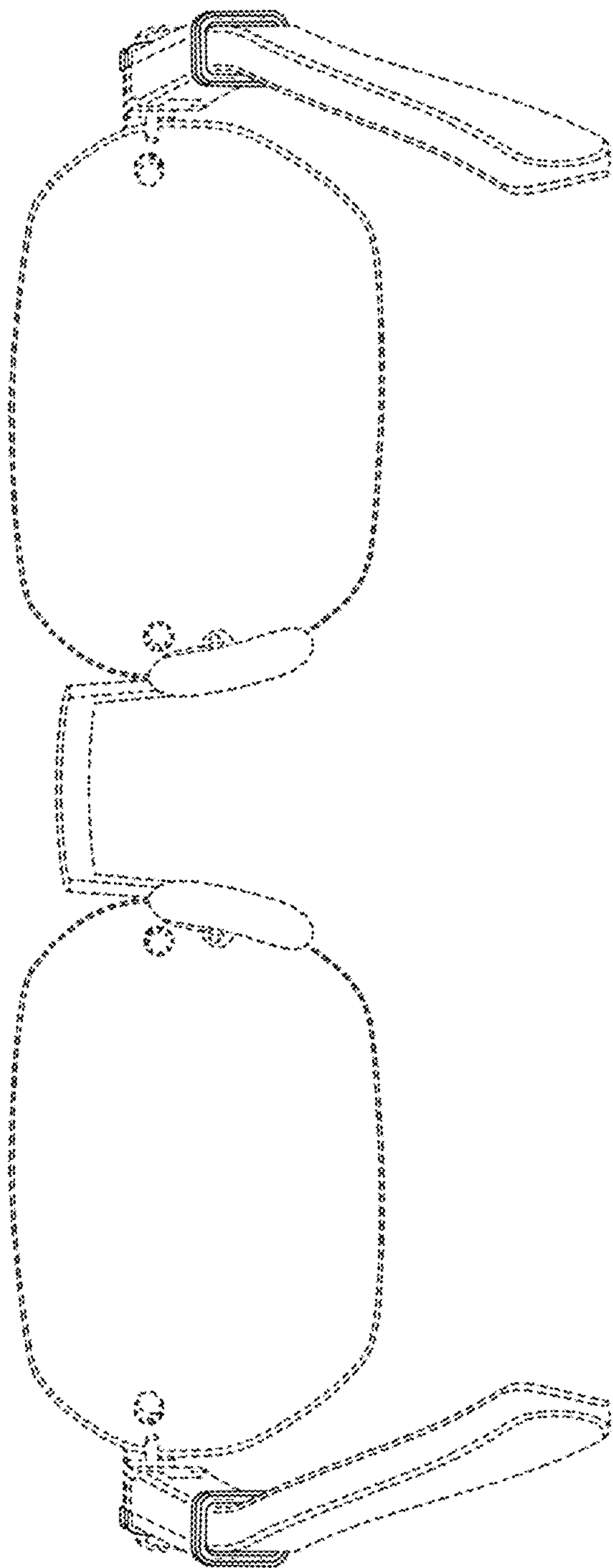

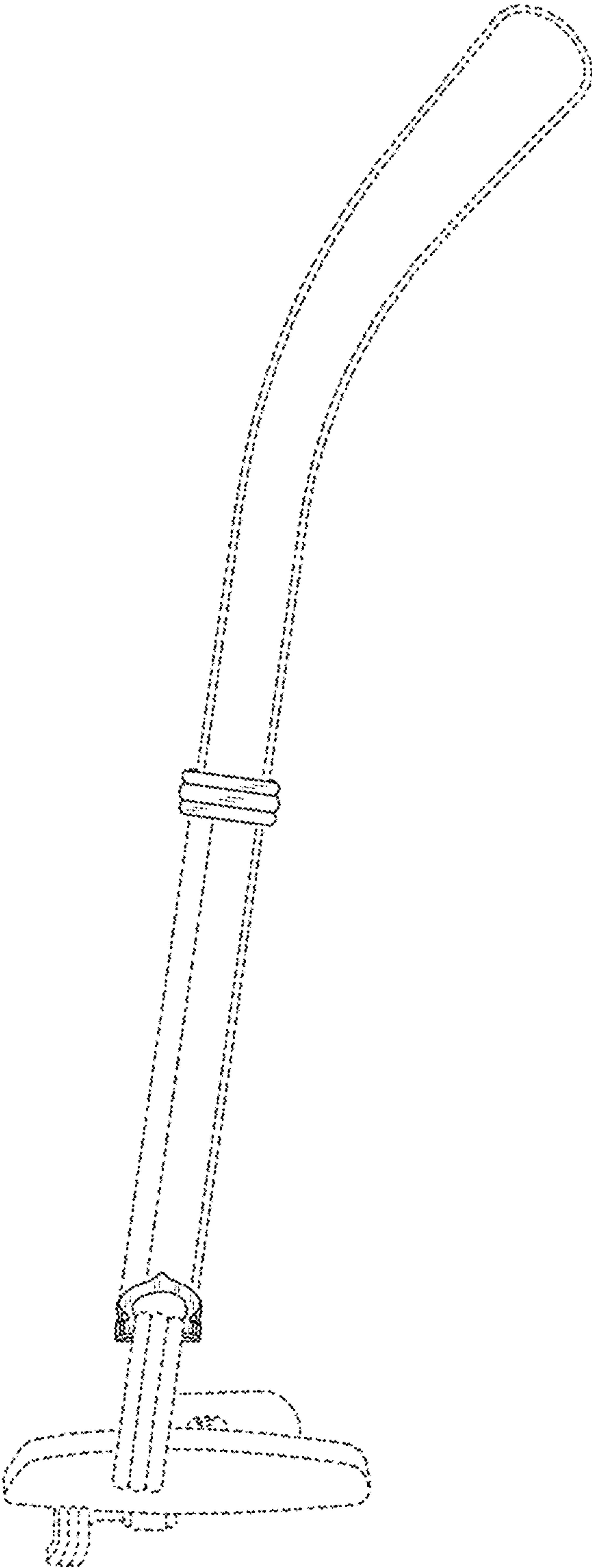

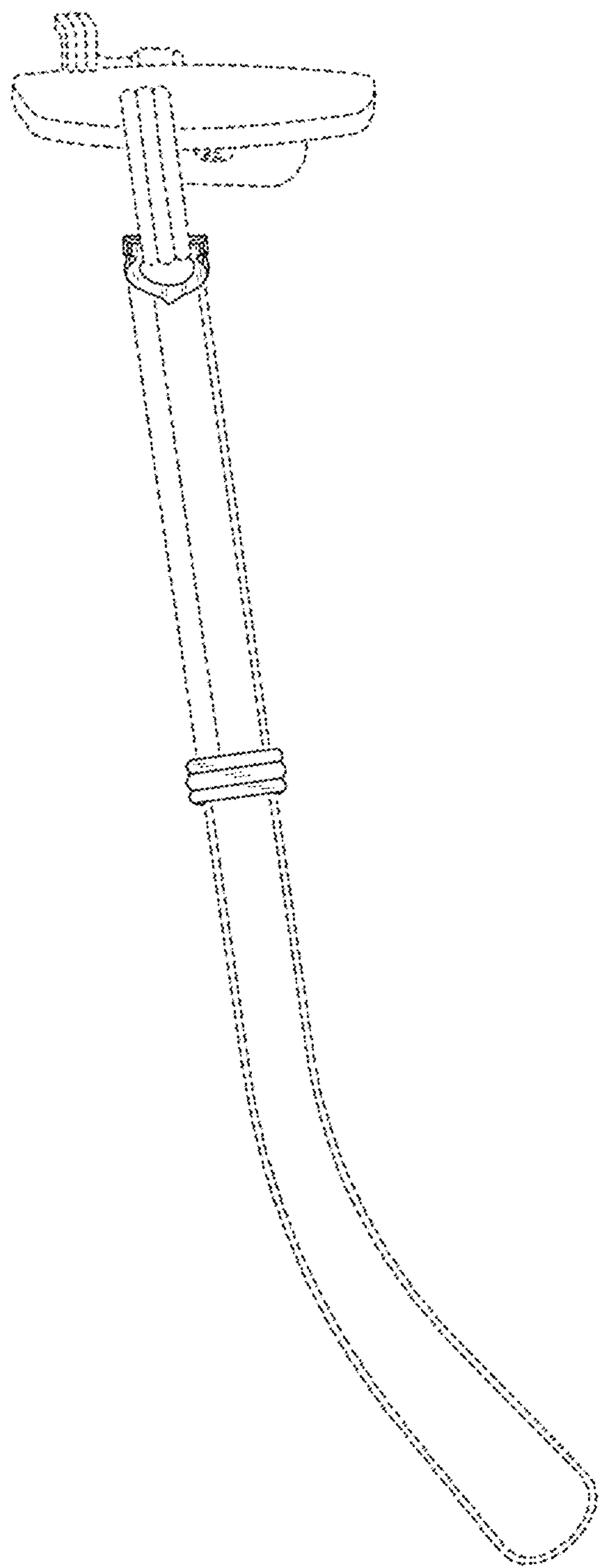

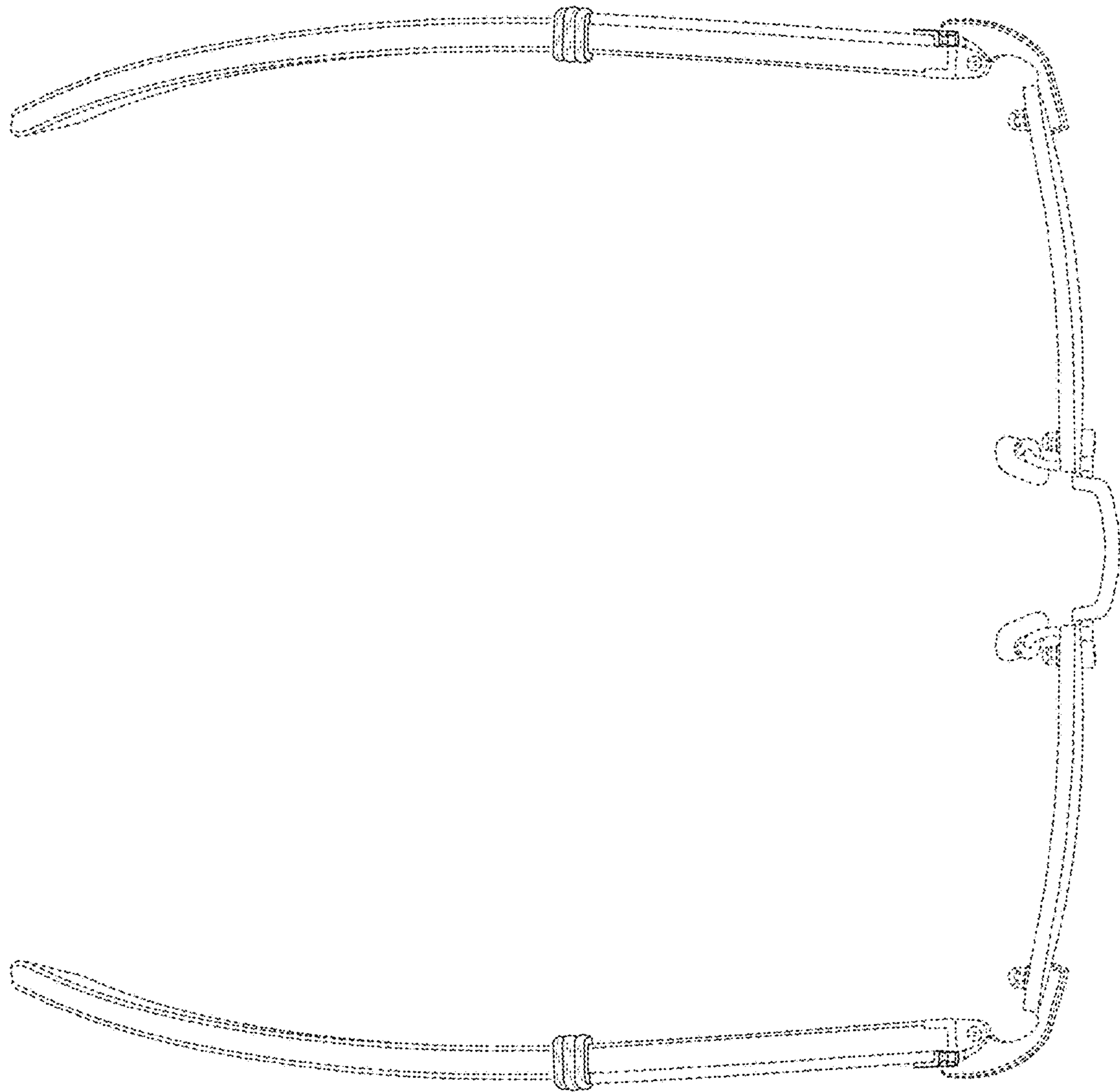

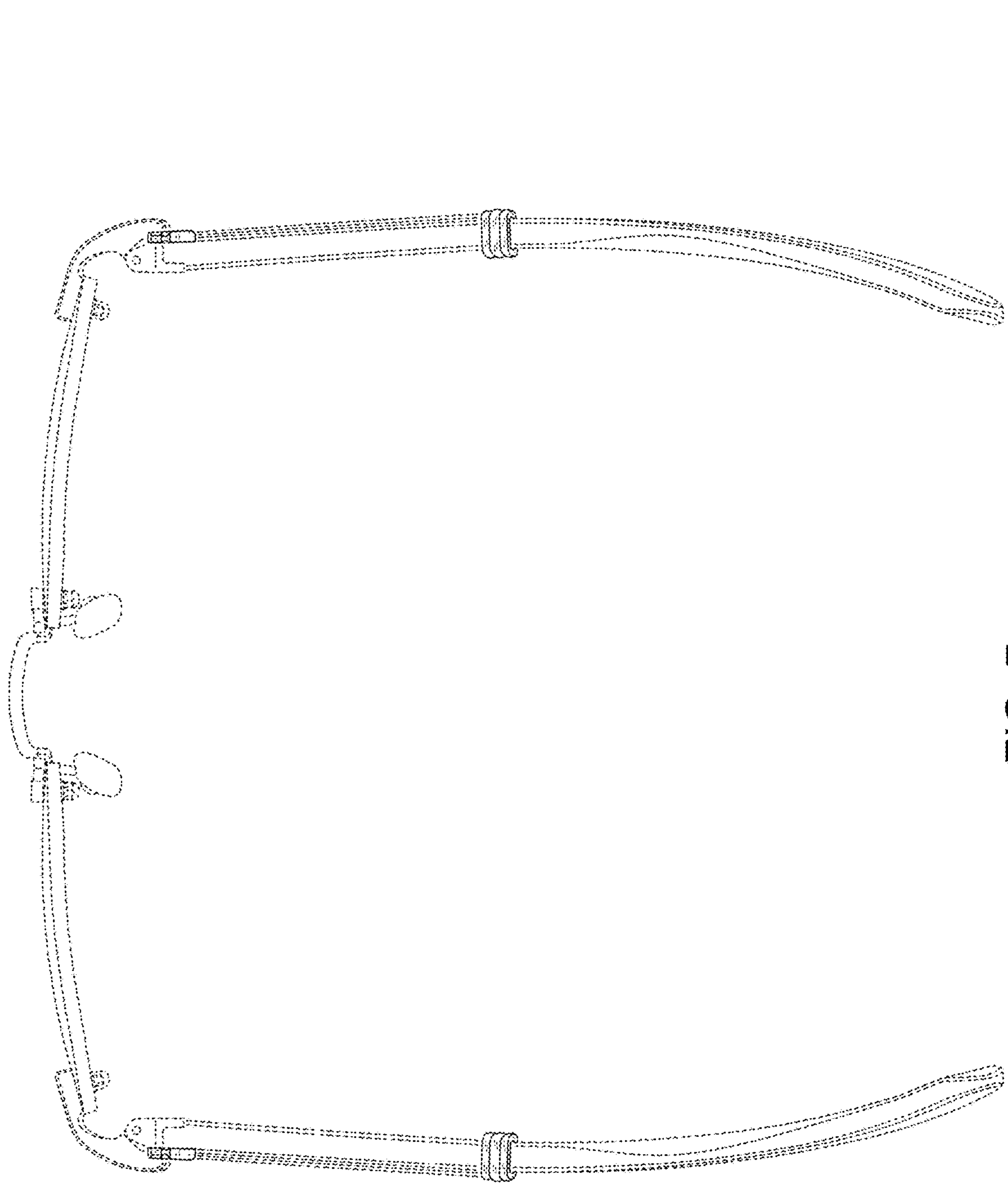

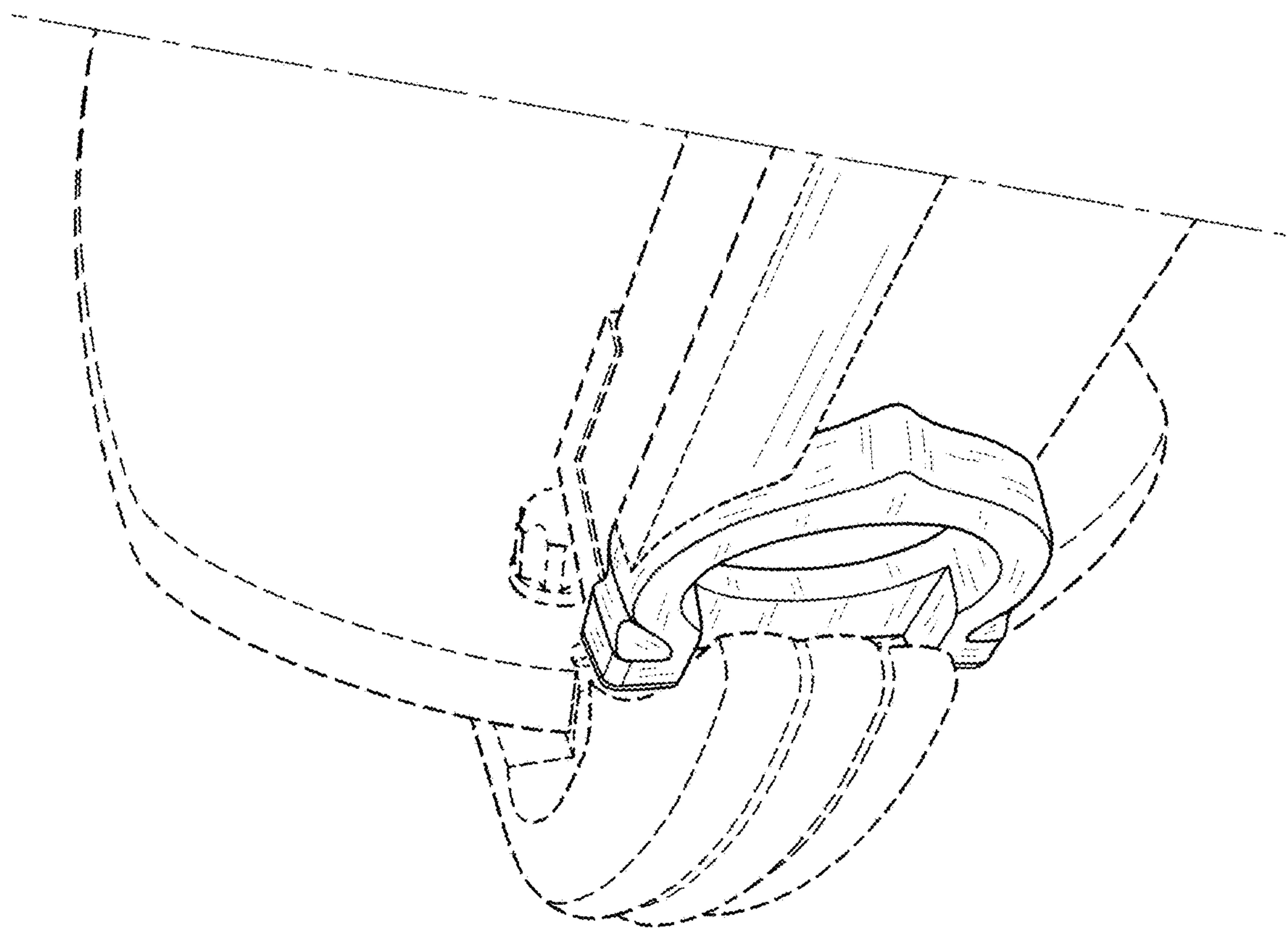
