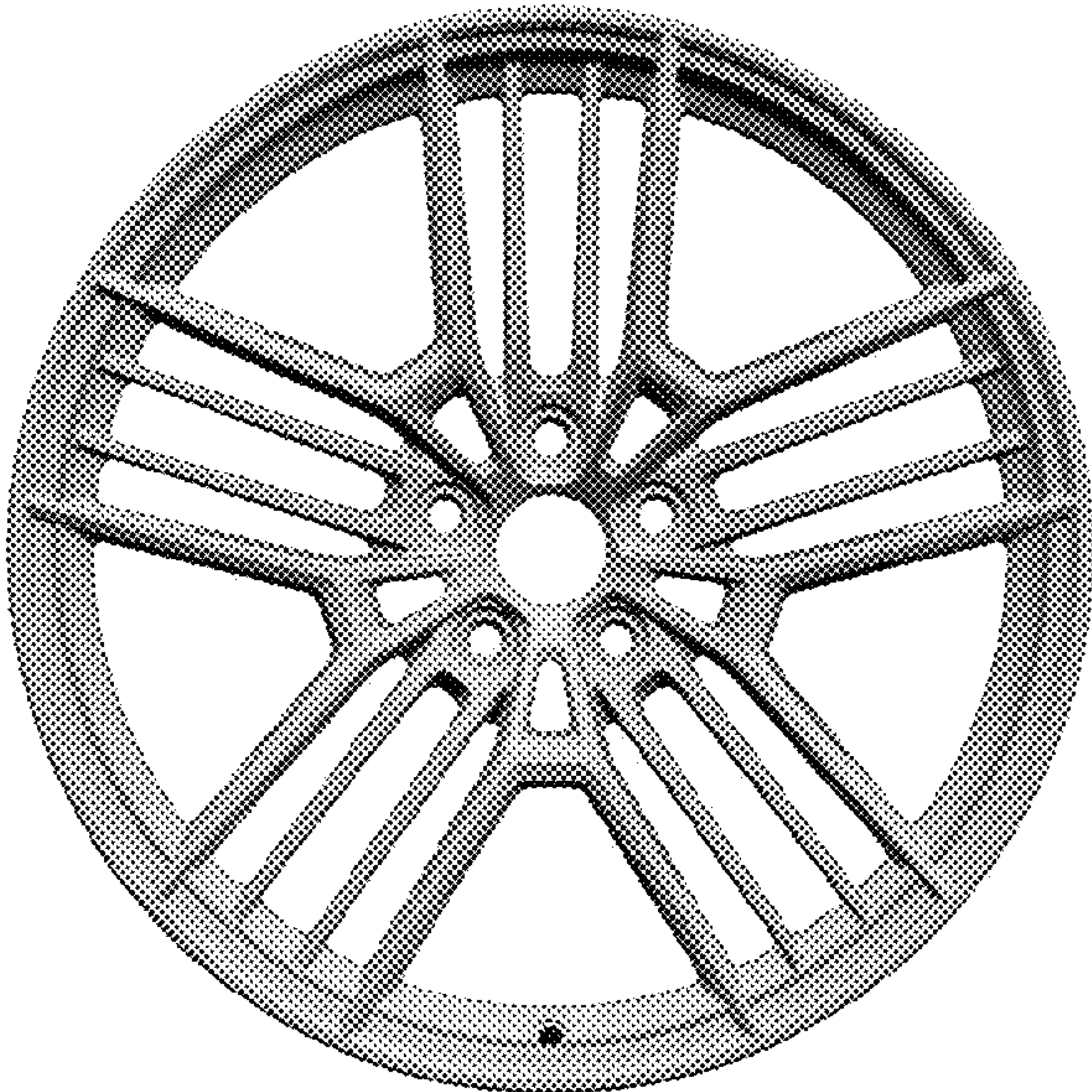
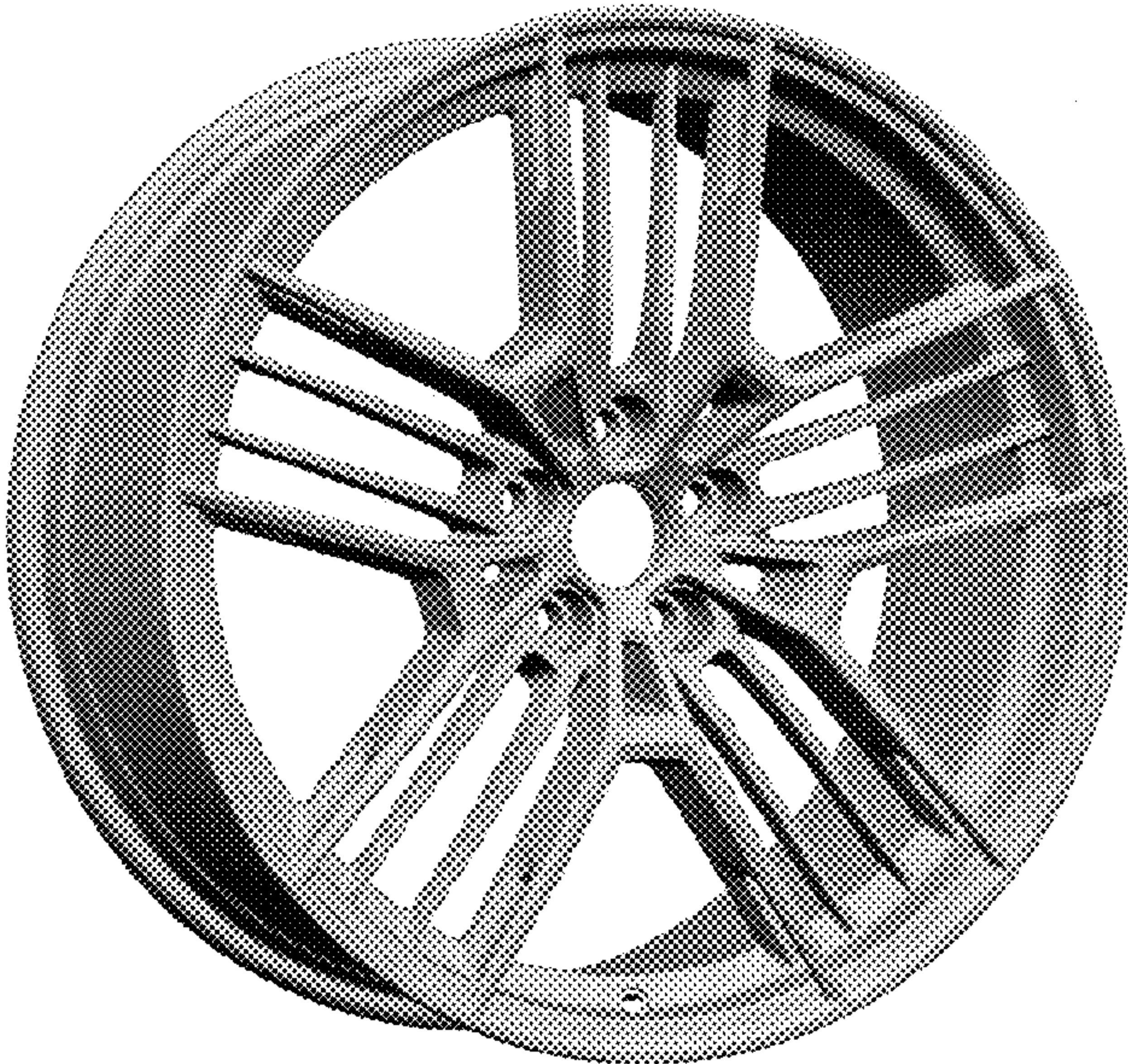
The ornamental design for a vehicle wheel, toy vehicle wheel, and/or replicas thereof as shown and described.

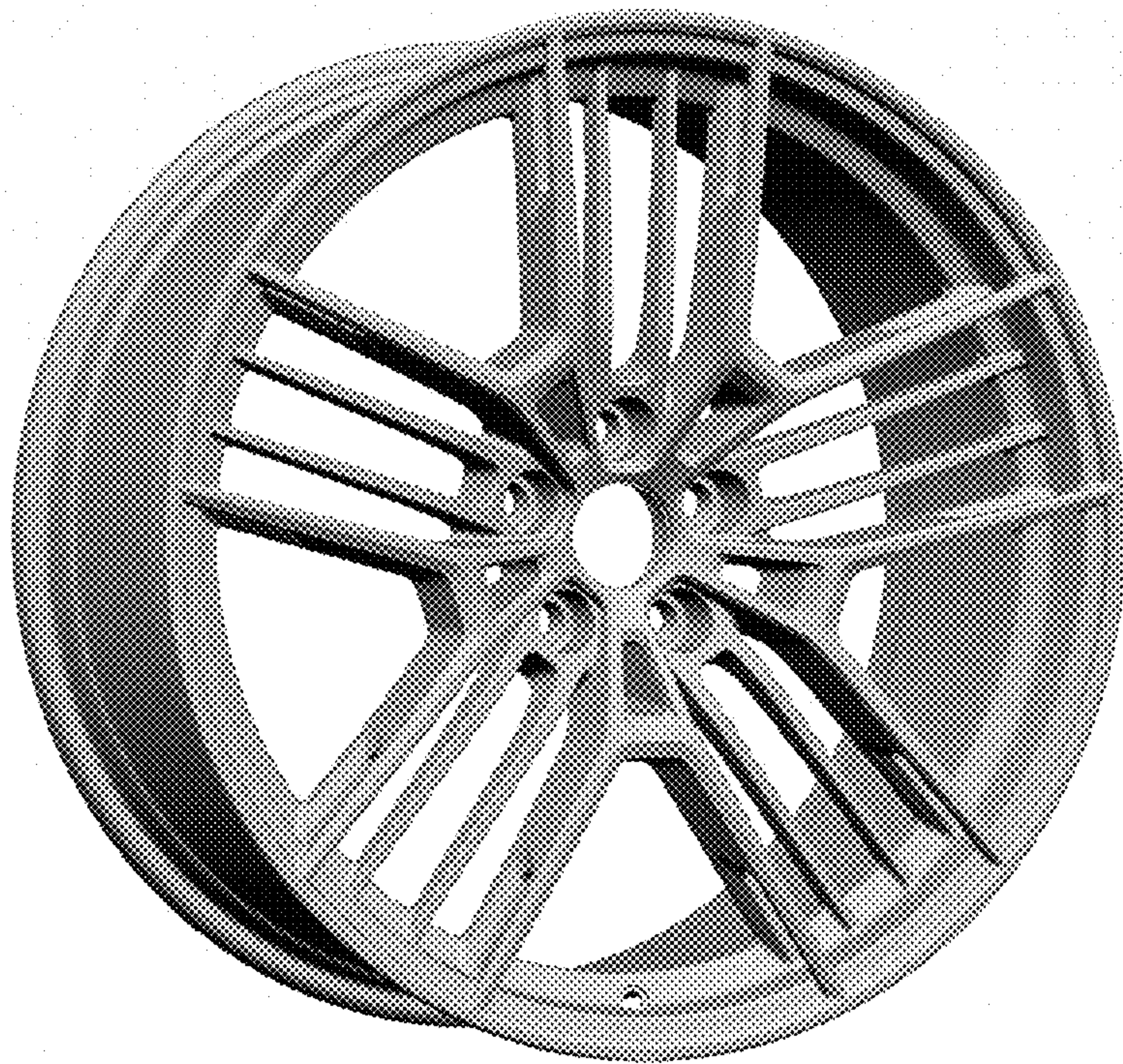

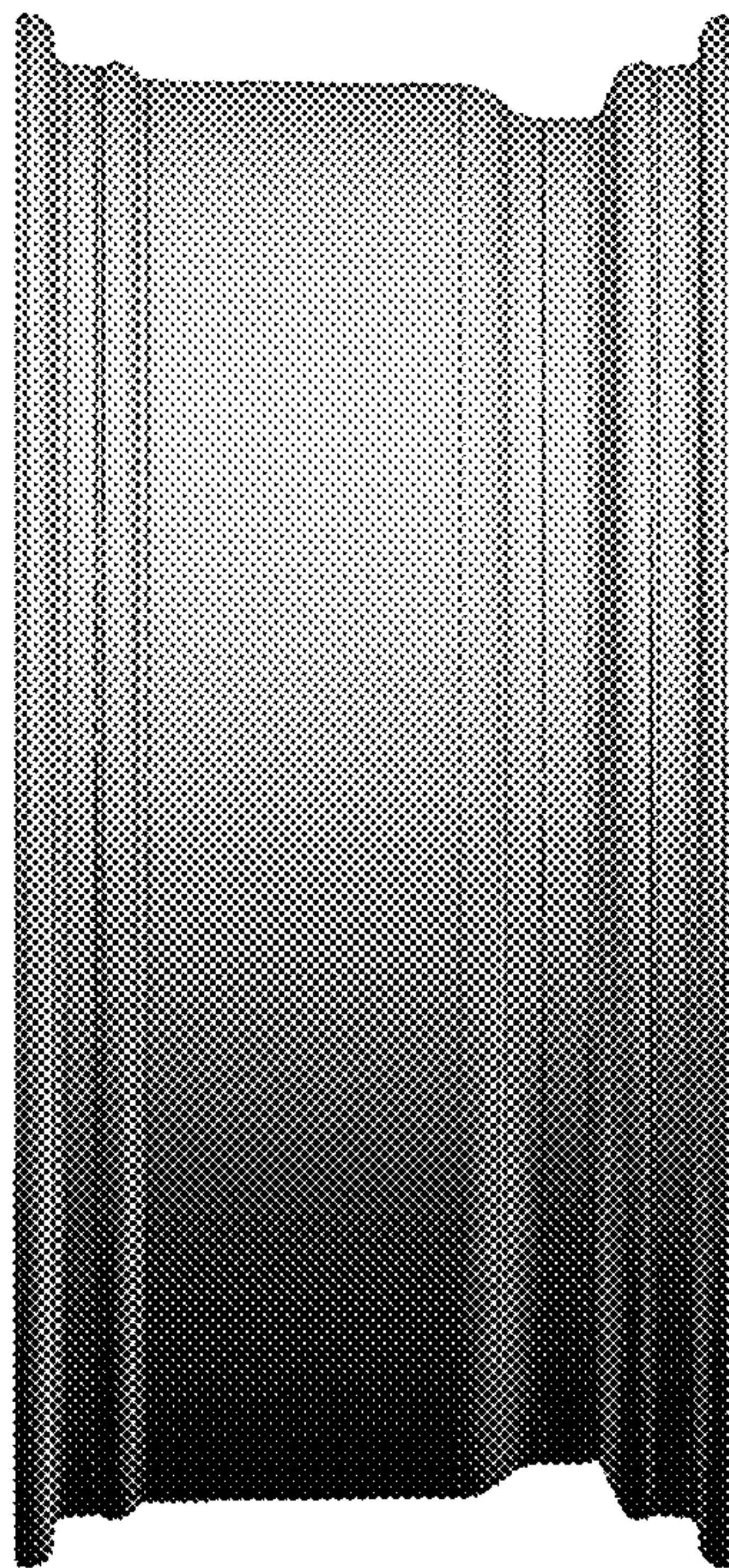
