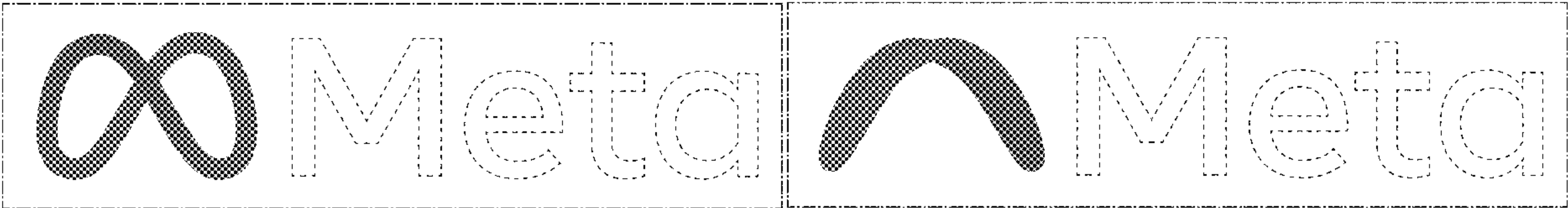
FIG. 1 is a front view of a display screen or portion thereof with an animated graphical user interface showing a first image;

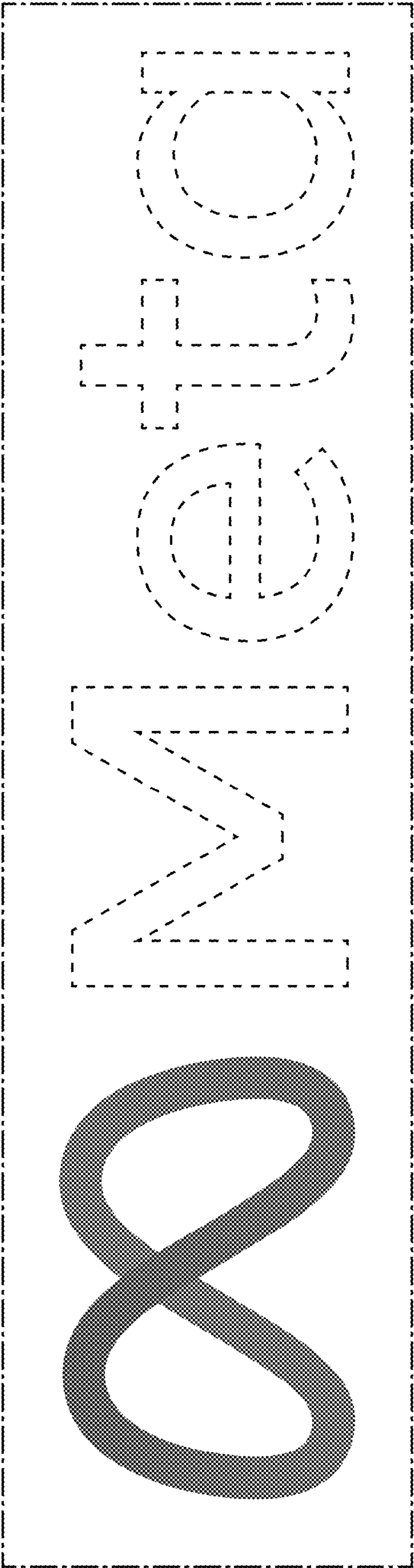

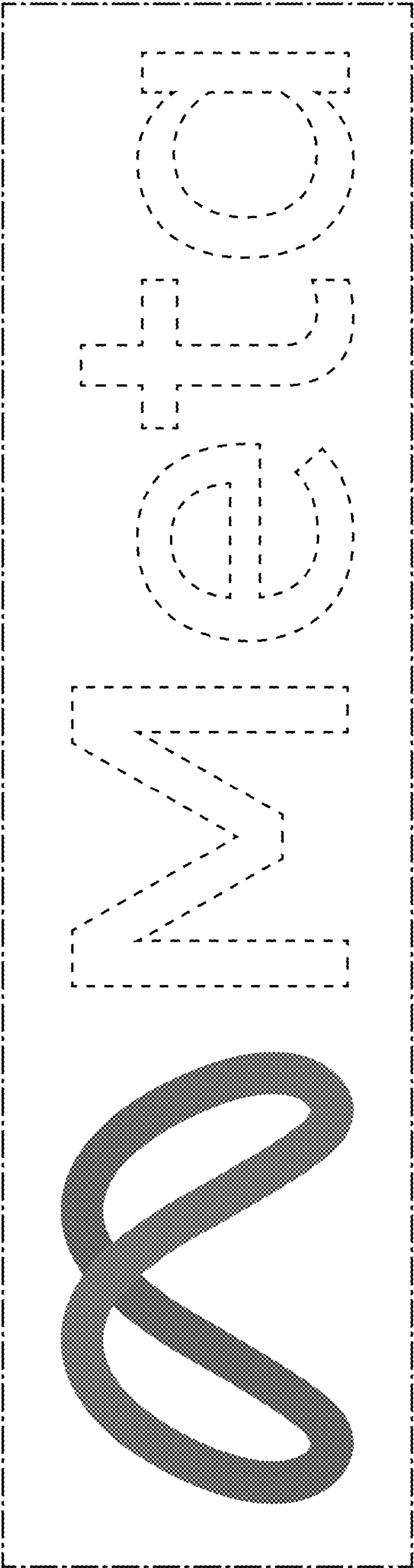

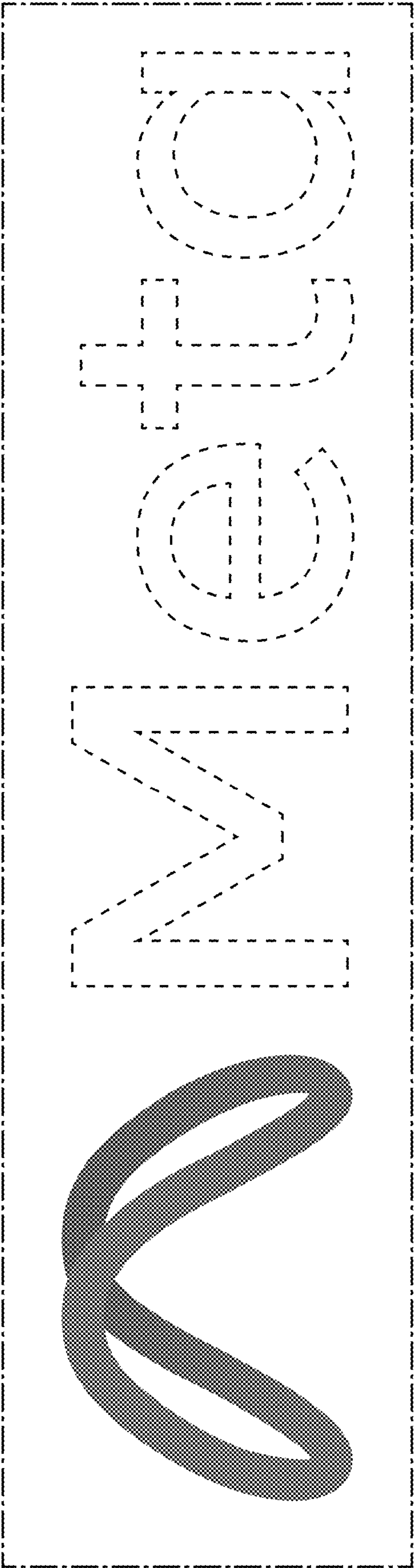

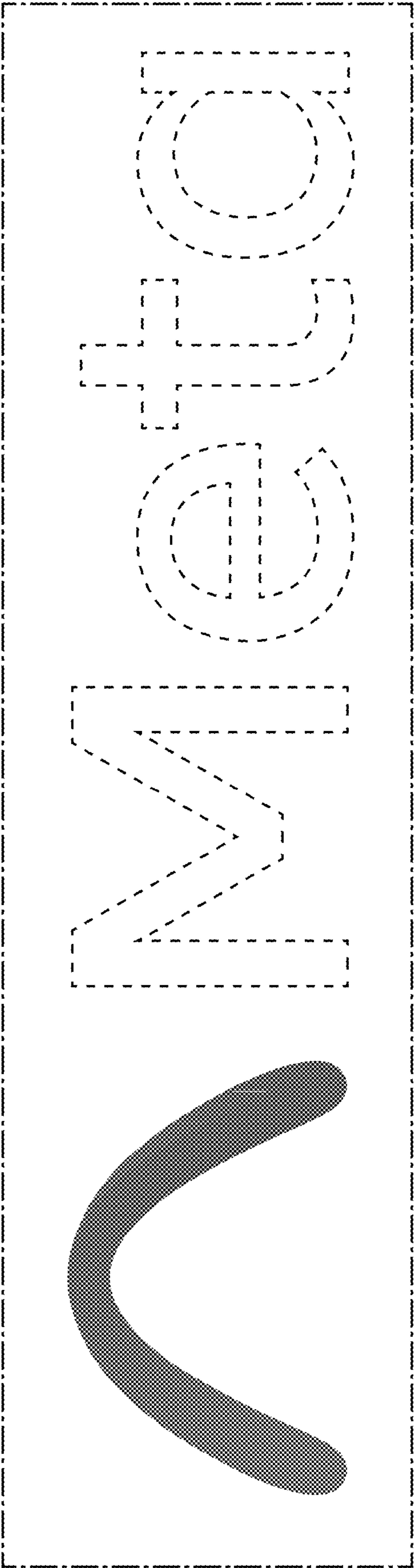

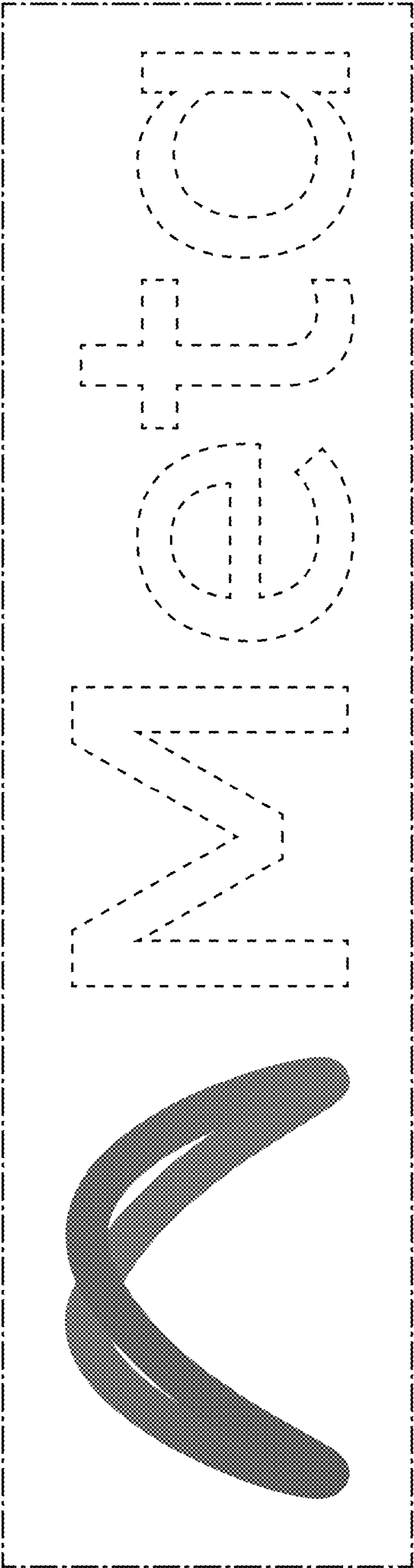

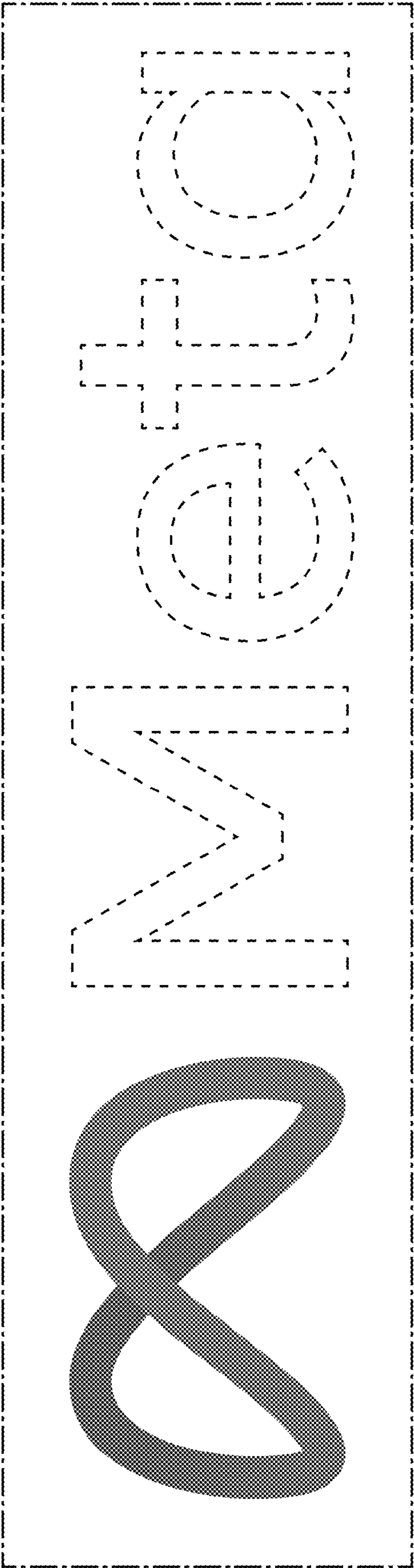

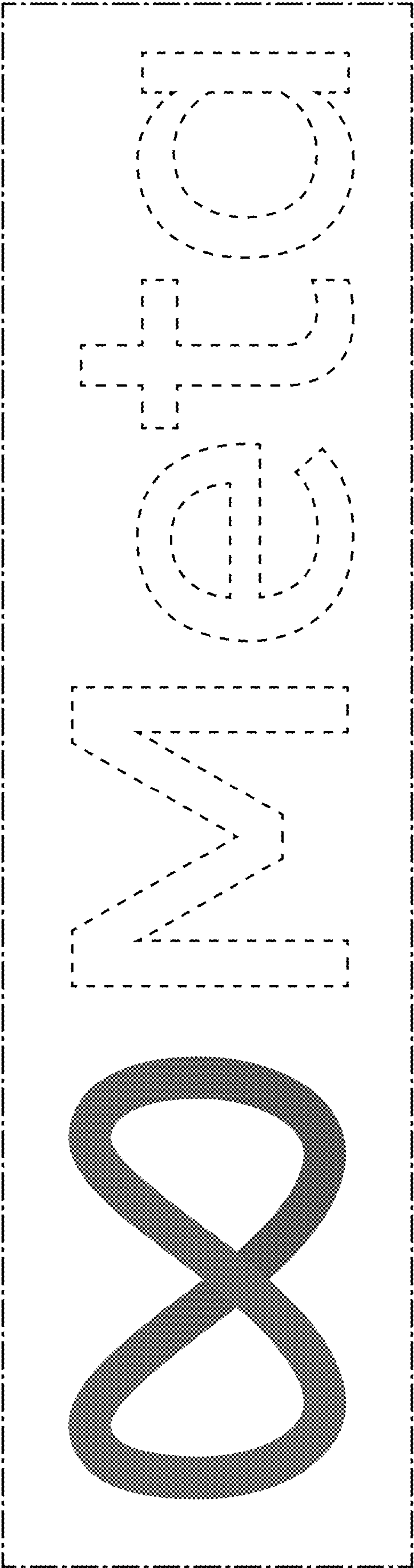

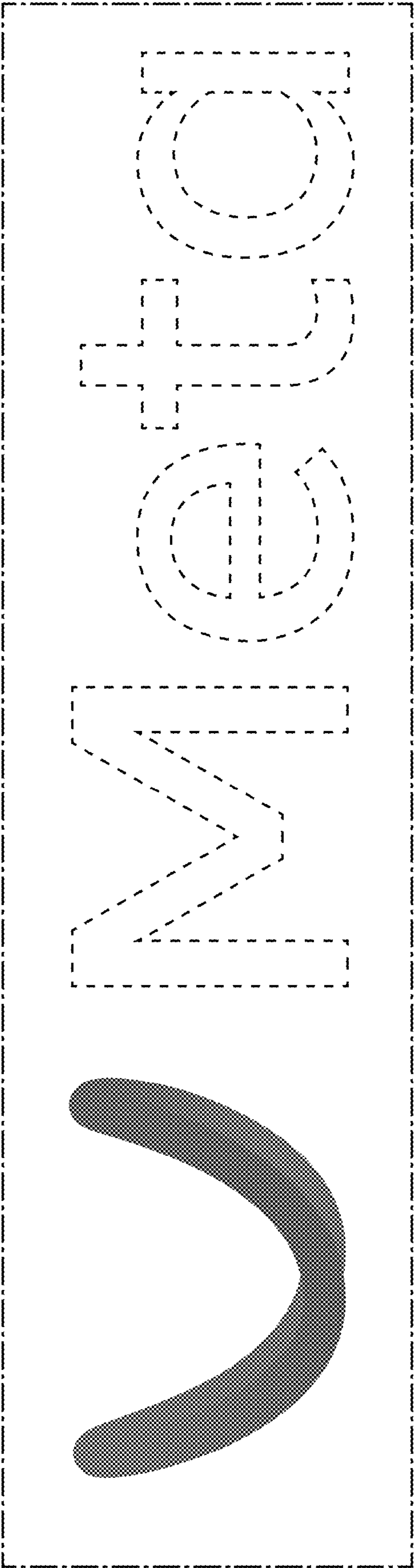

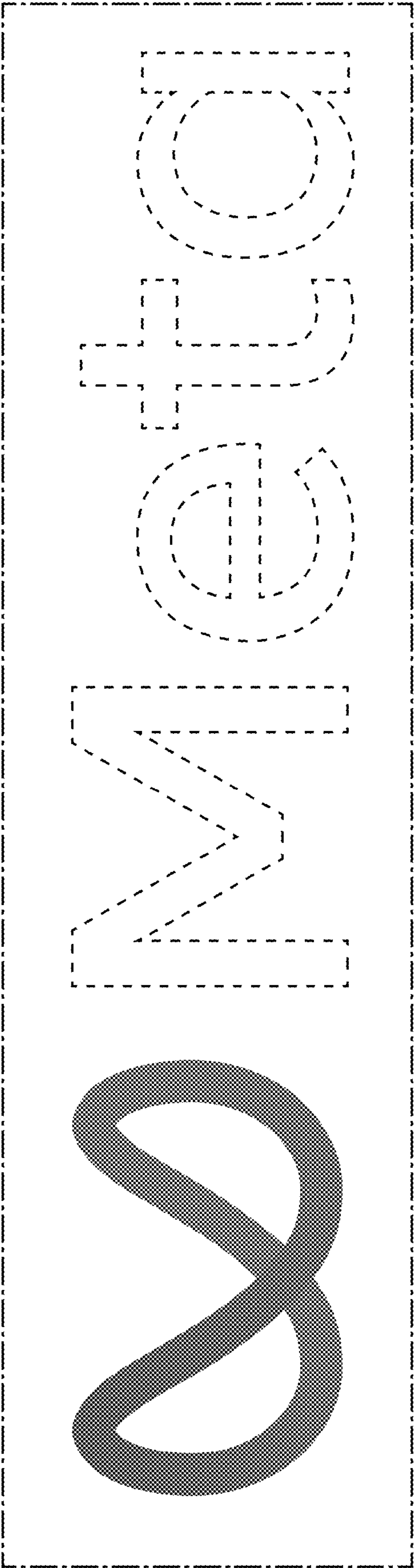

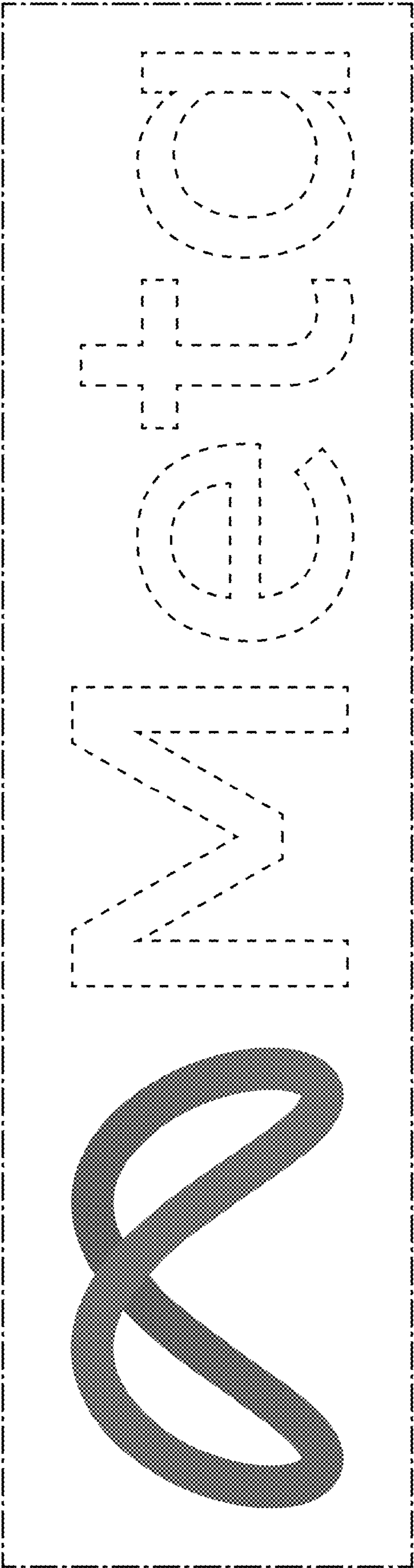

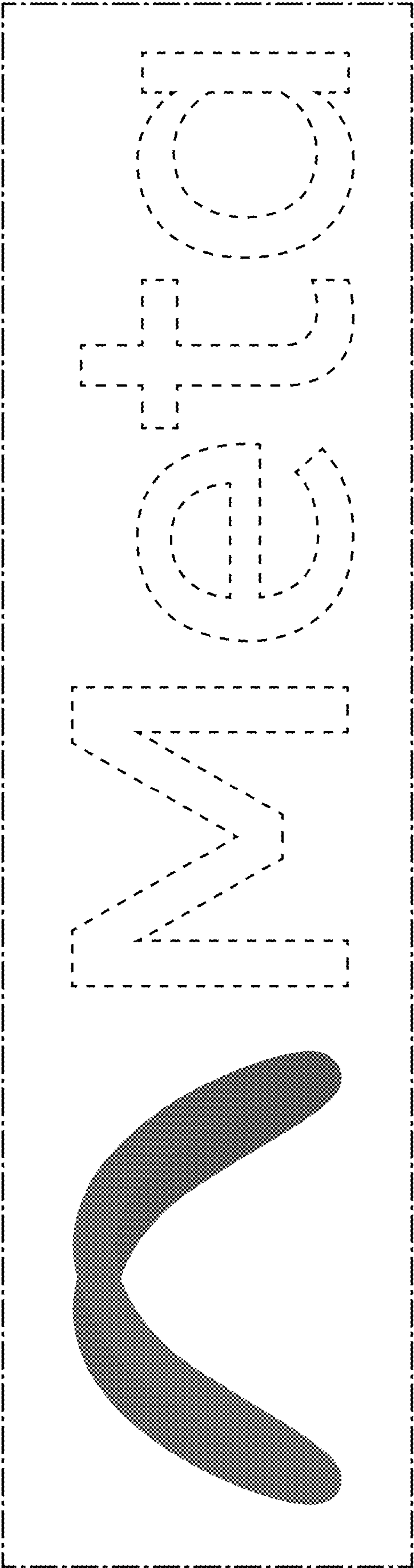

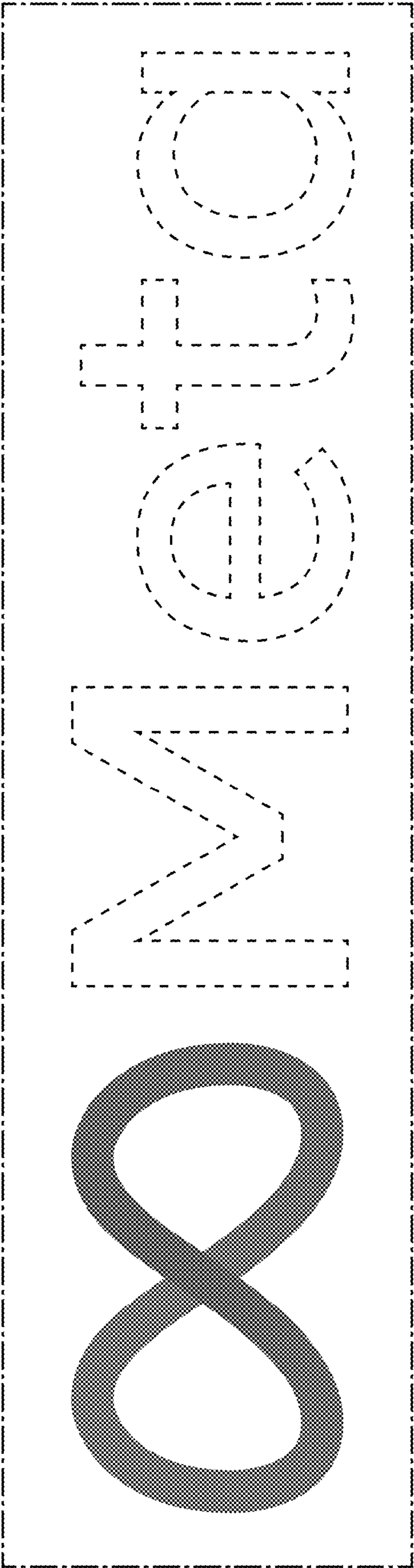

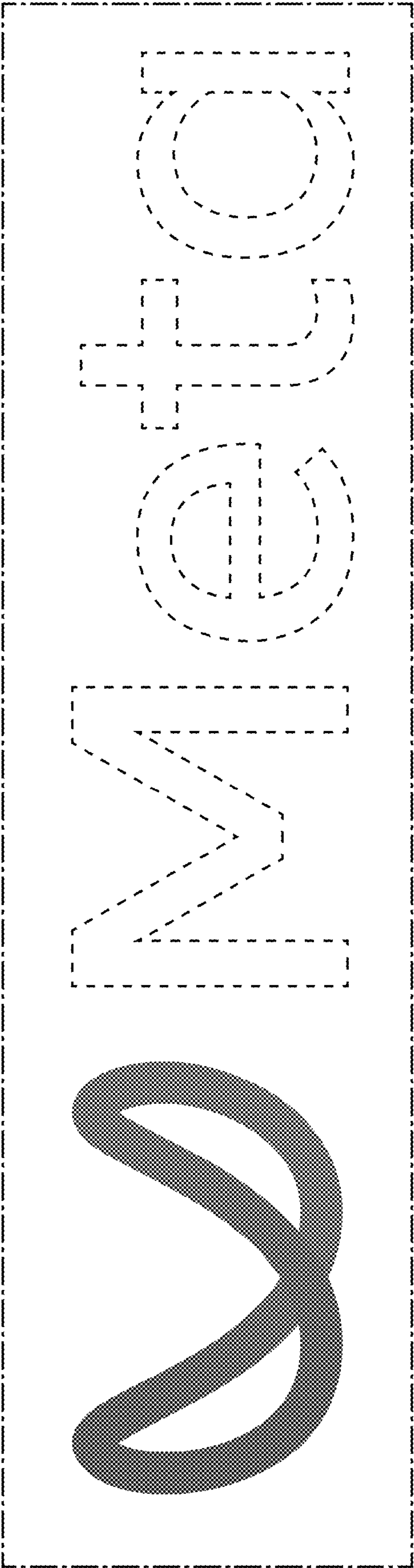

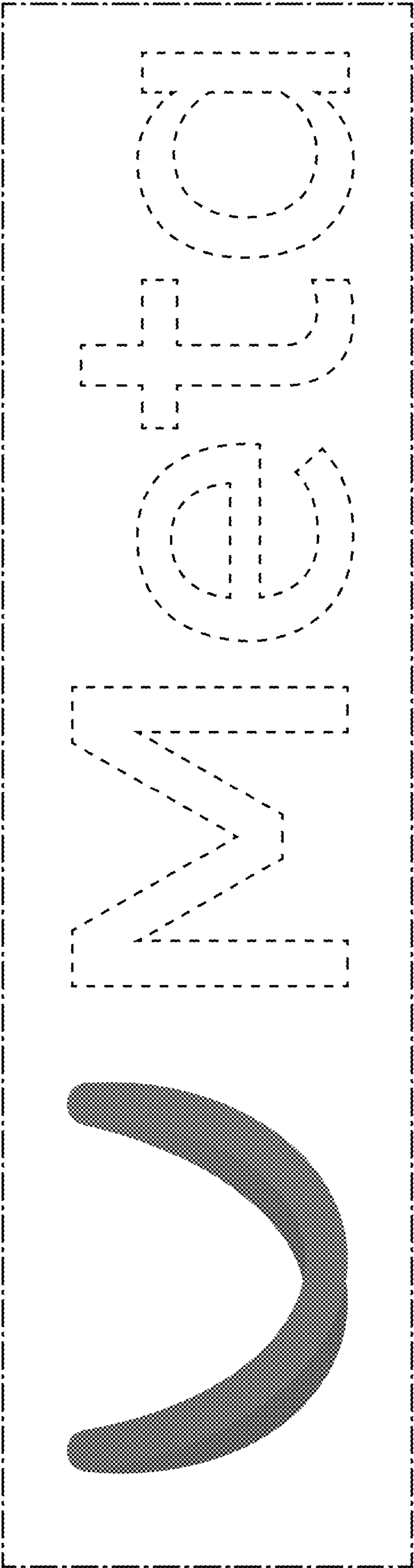

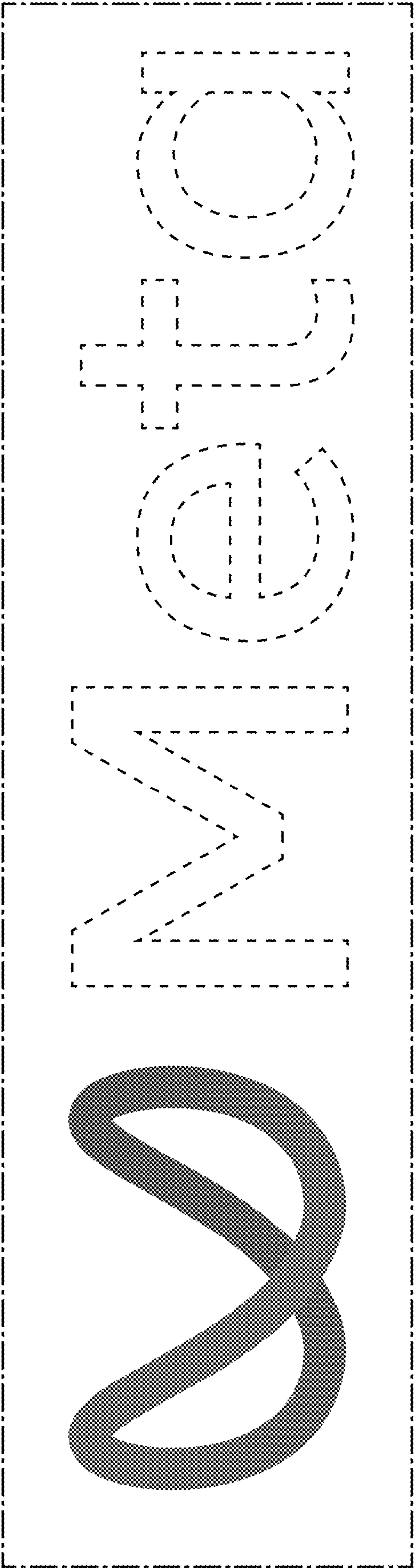

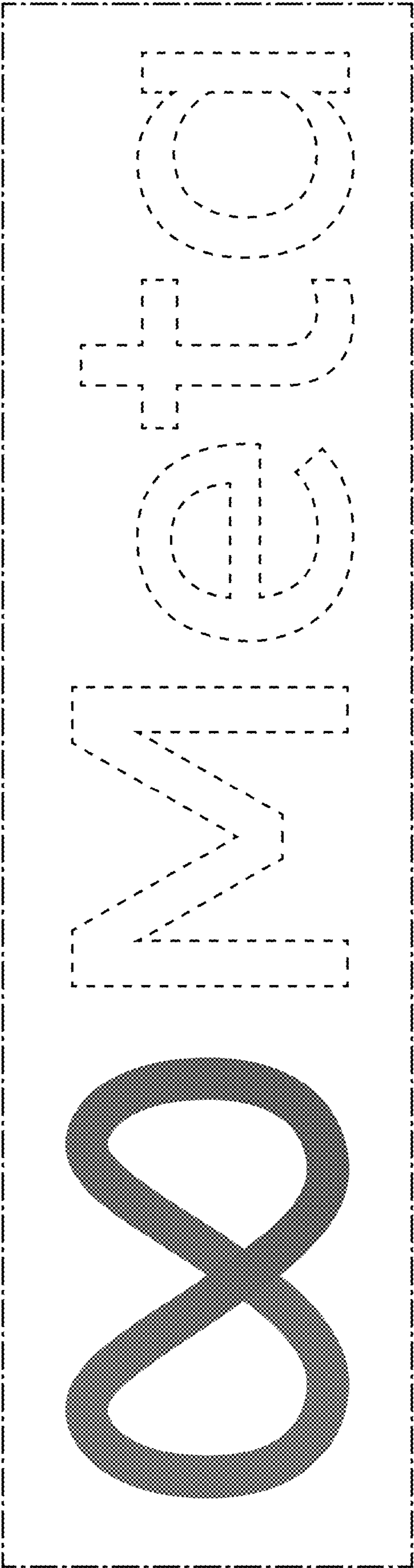

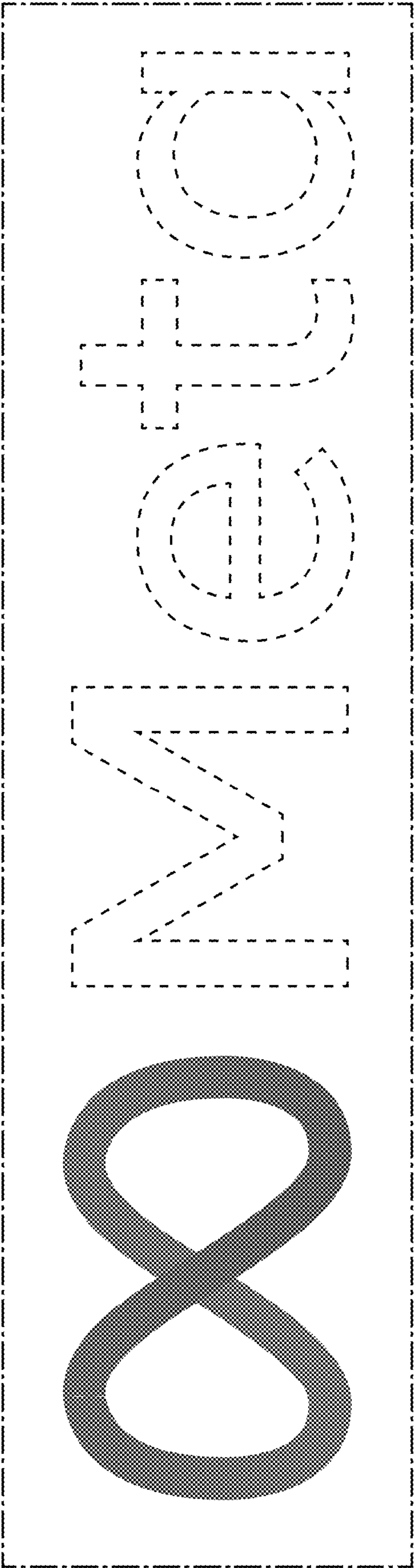
