(57) **CLAIM**

The ornamental design for a garment, as shown and
described.

DESCRIPTION

FIG. 1 is a front view of a garment according to the design;
FIG. 2 is a rear view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a rear perspective view thereof shown in an
environment of use; and,
FIG. 6 is a rear view thereof shown in an environment of use.
The unshaded portions of the garment shown in dash-dash
broken lines in FIGS. 1-6 do not form part of the claimed
design. The partial human figure outlined by dash-dash
broken lines in FIGS. 5-6 assists to illustrate the garment in
a position or environment of use and forms no part of the
claimed design. The dot-dash broken lines shown on the
garment in FIGS. 2-6 illustrate a boundary of the claimed
design and form no part of the claimed design.

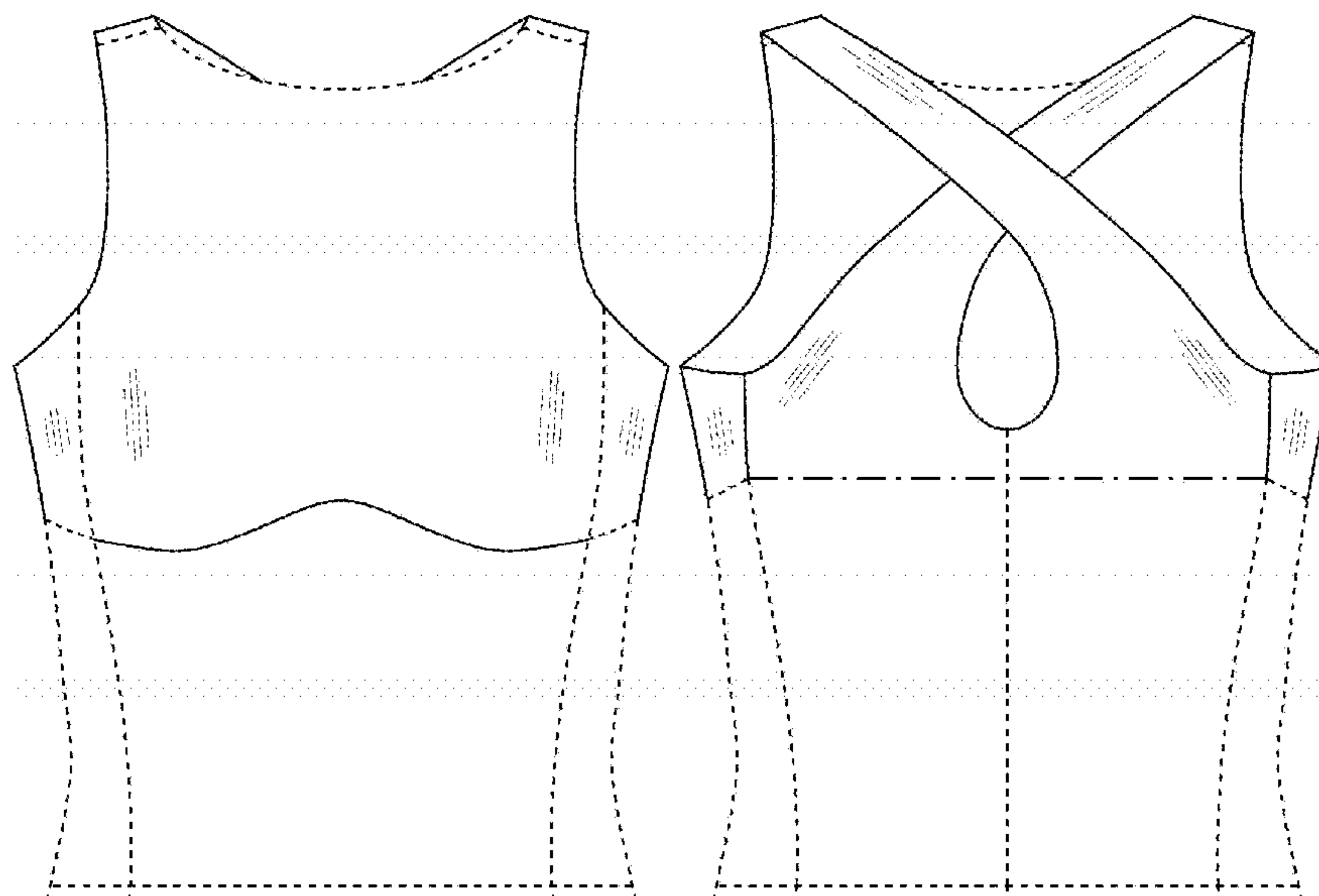

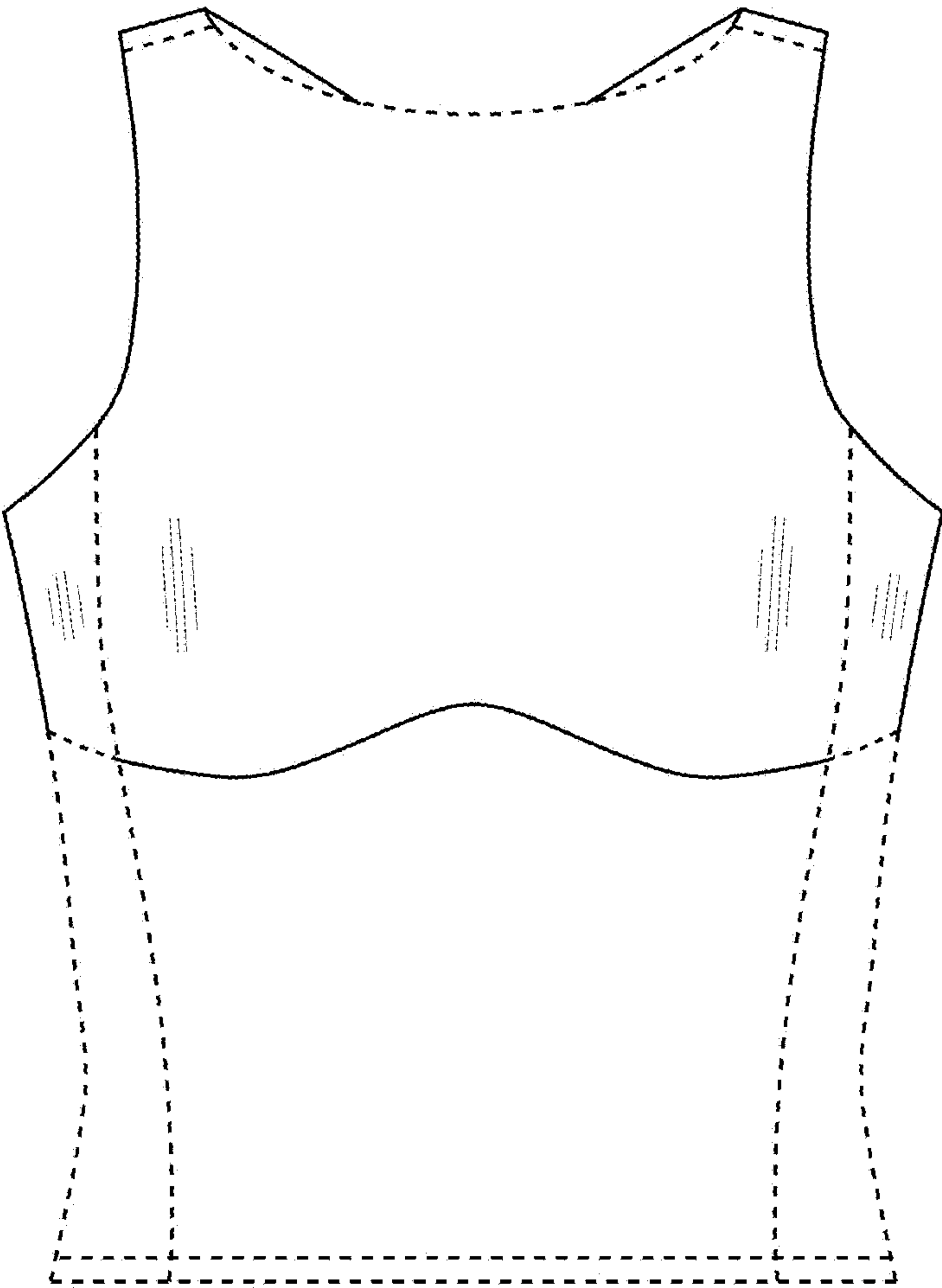

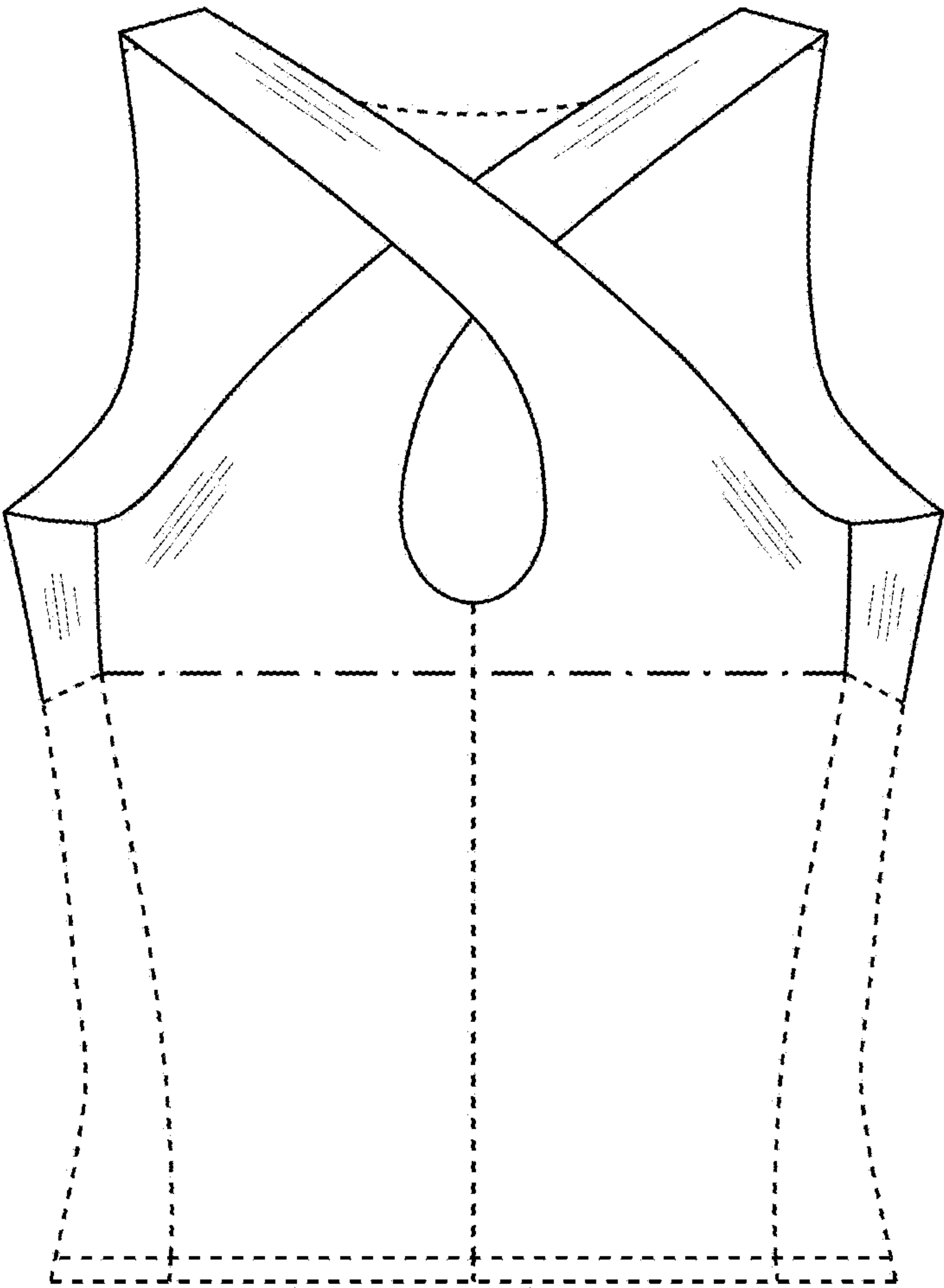

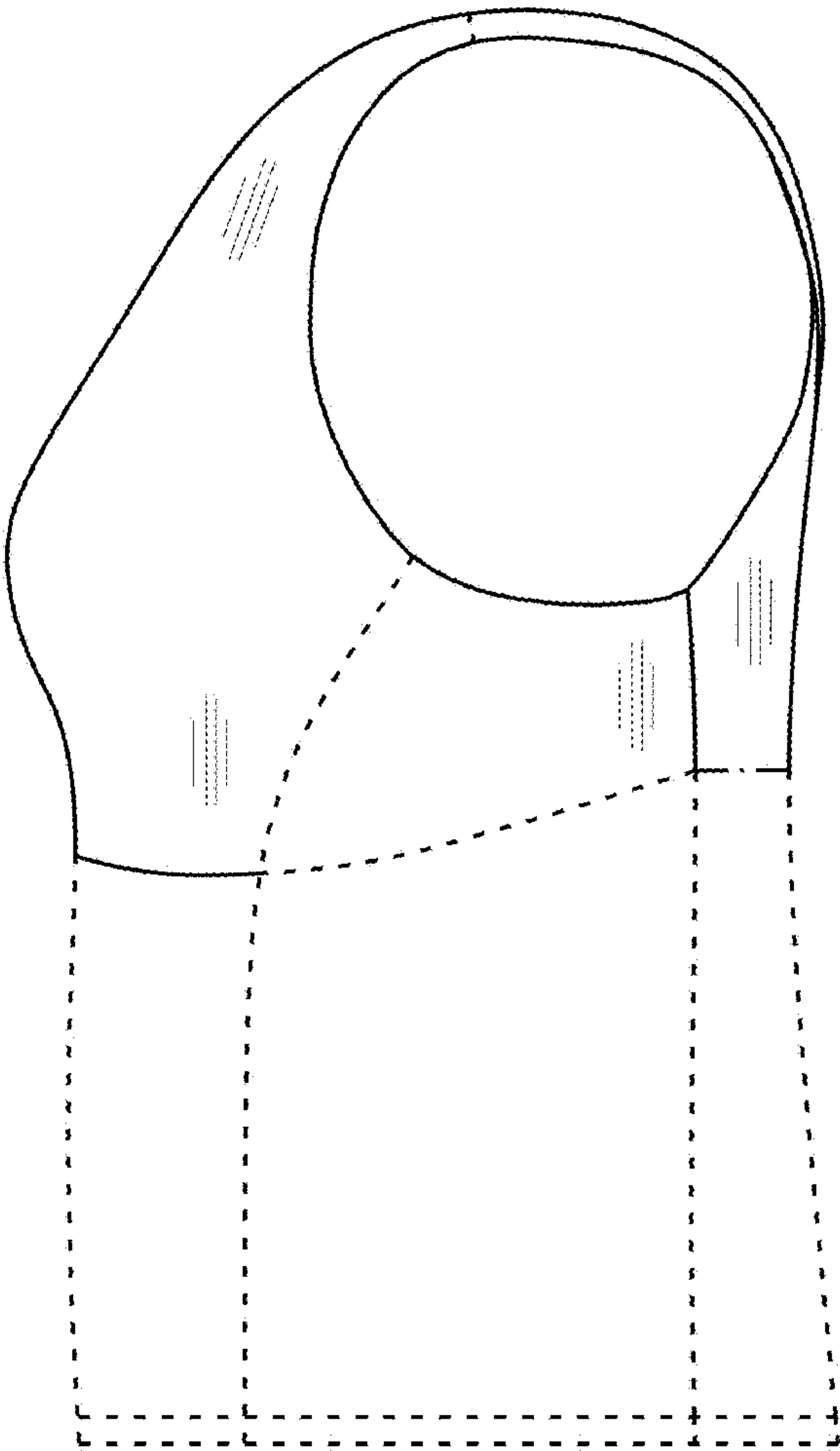

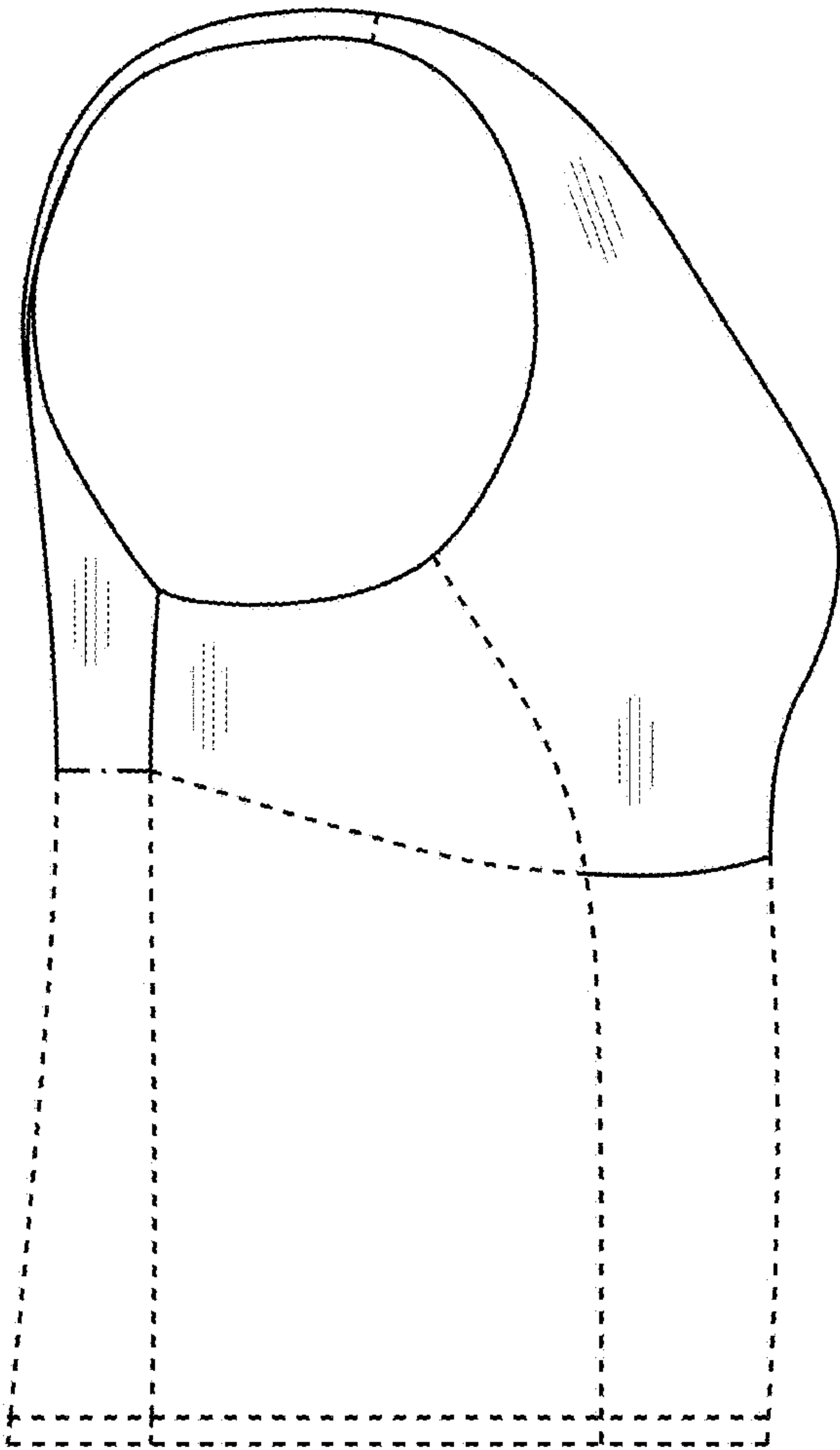

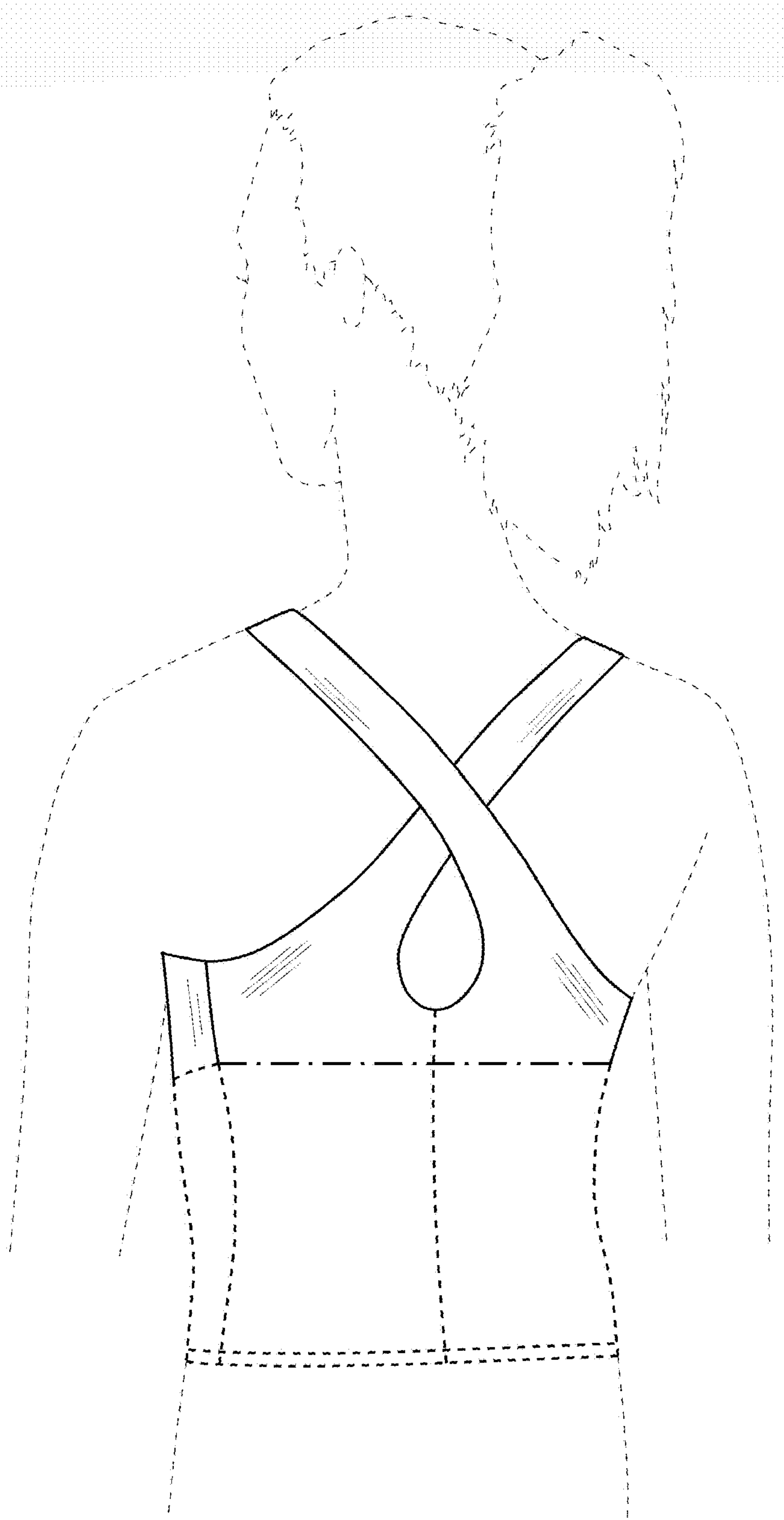

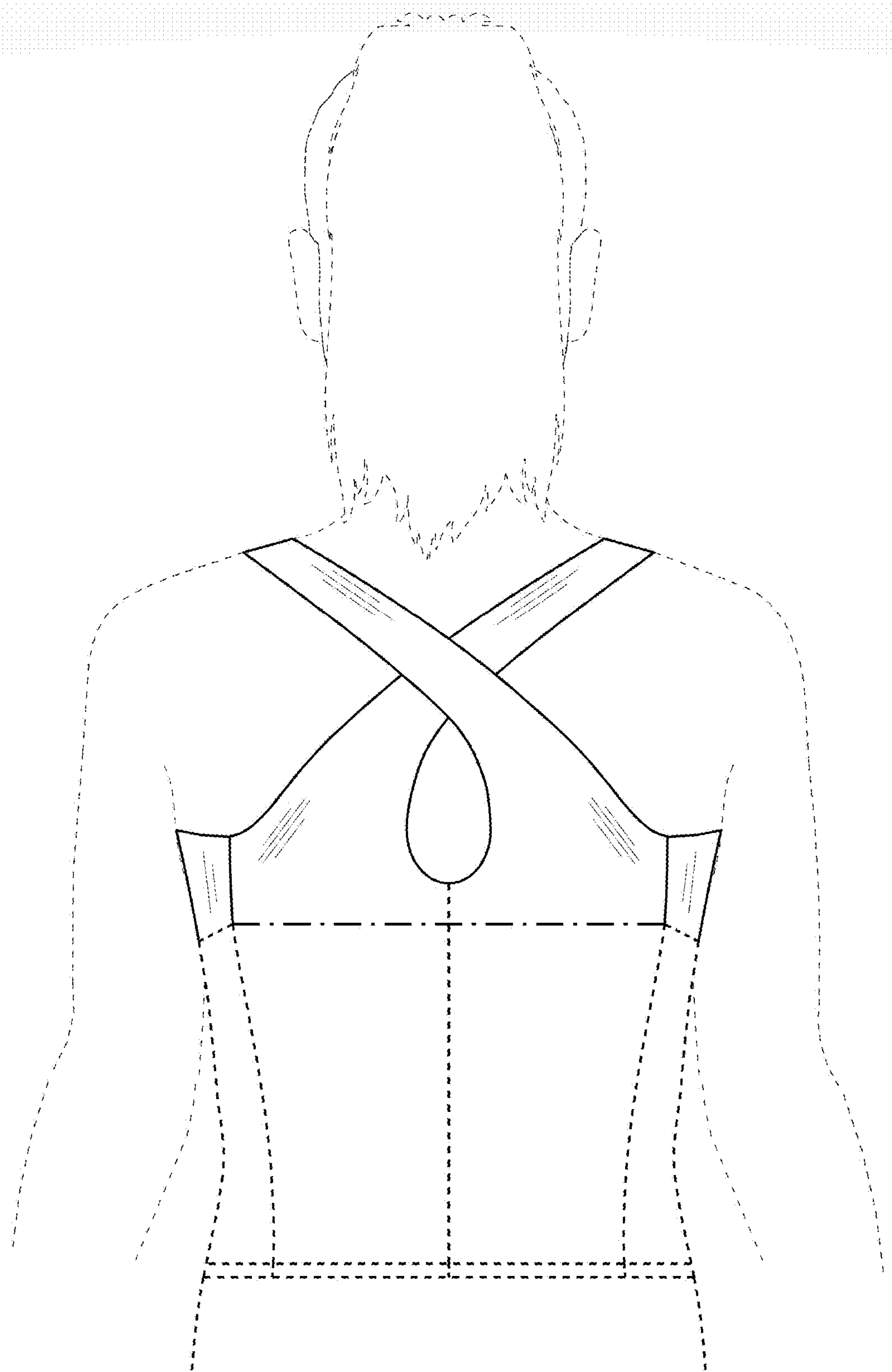
