The ornamental design for a display screen or portion thereof with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with a graphical user interface showing the new design;
FIG. 2 is a front view of a second embodiment thereof; and,
FIG. 3 is a front view of a third embodiment thereof.

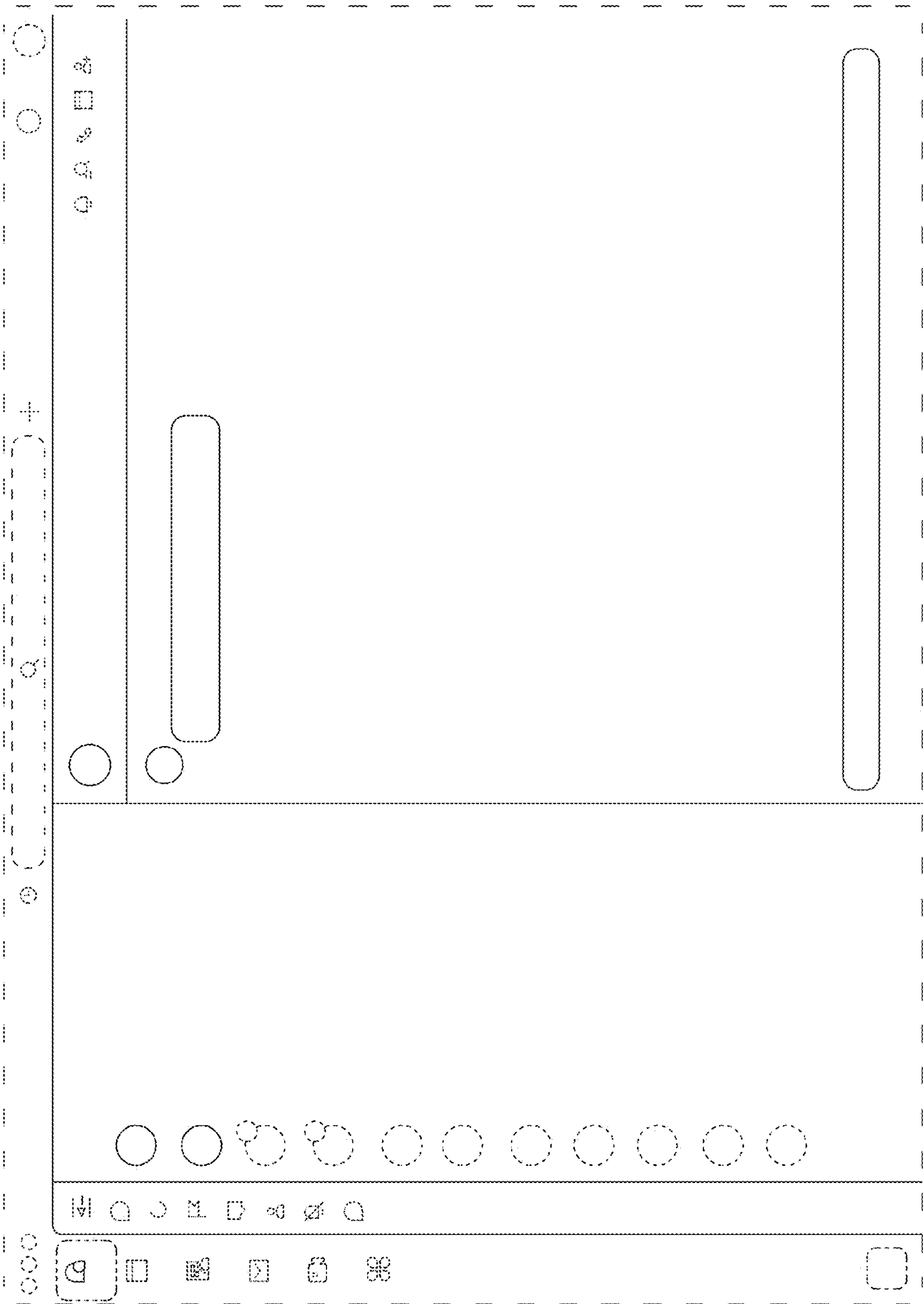

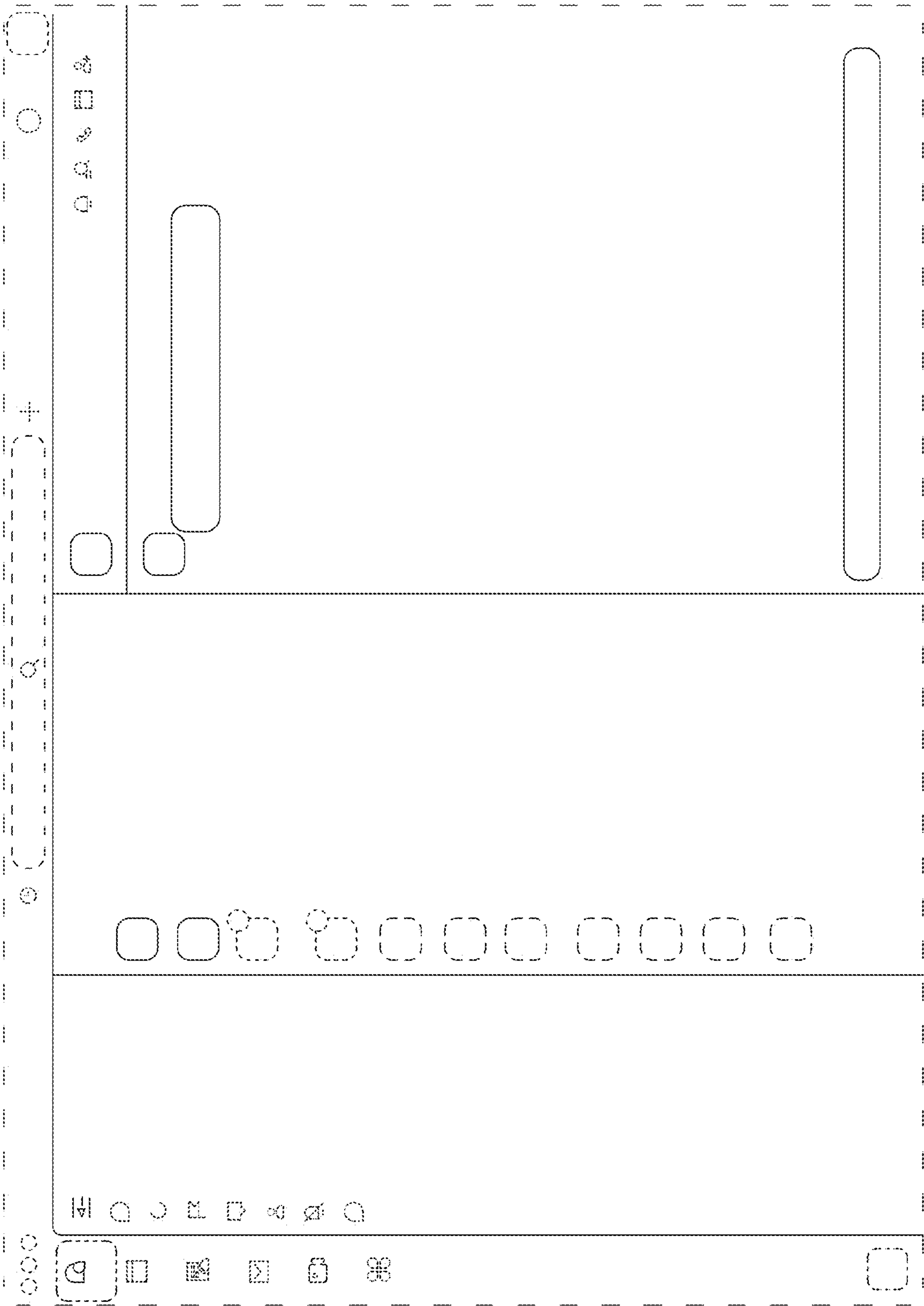
