DESCRIPTION

FIG. 1 is a perspective view of a spa shell showing our new design;

FIG. 12 is a cross-sectional view thereof, taken in the direction of line 12-12 of FIG. 3;

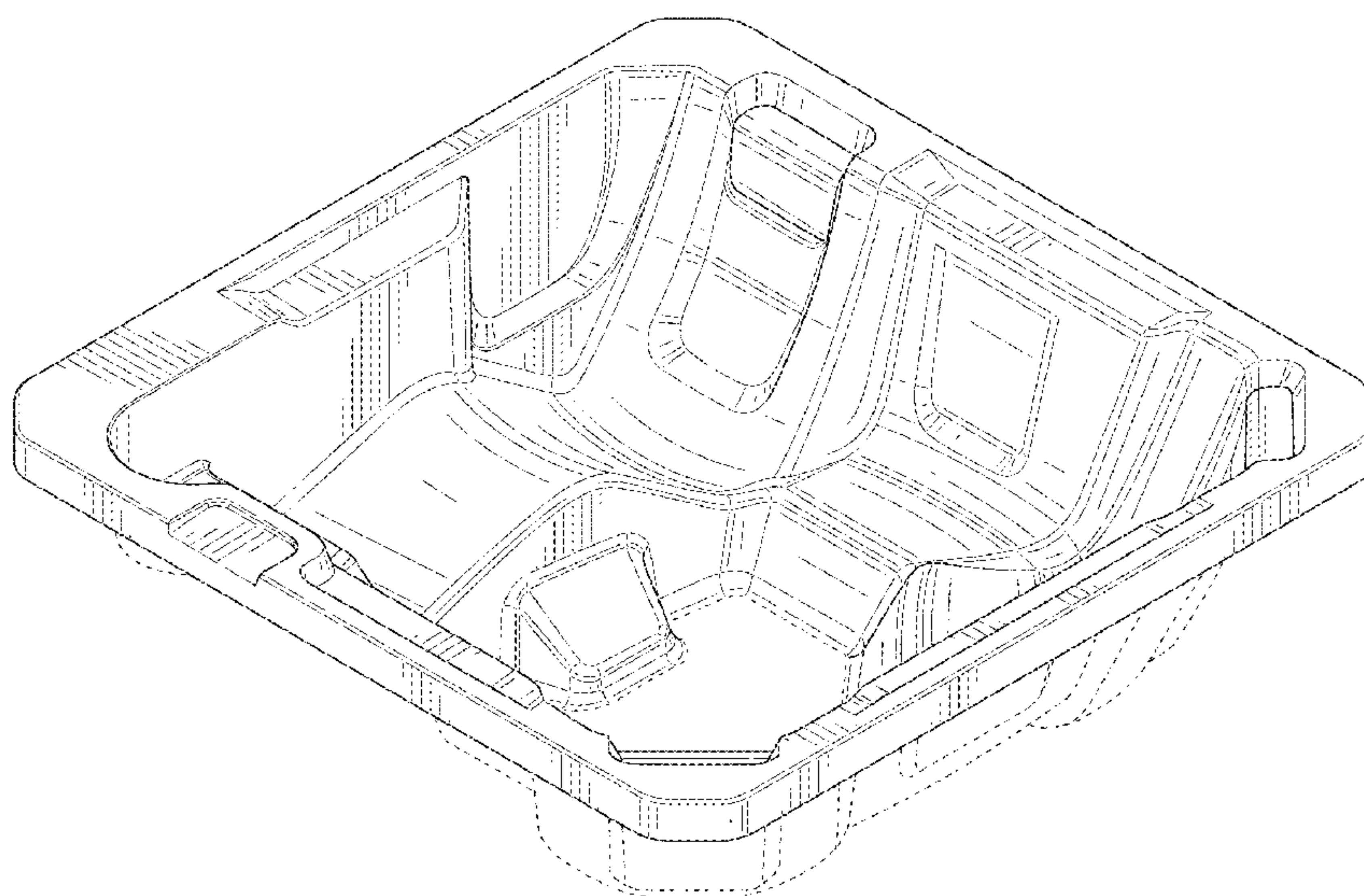
FIG. 13 is a cross-sectional view thereof, taken in the direction of line 13-13 of FIG. 3;

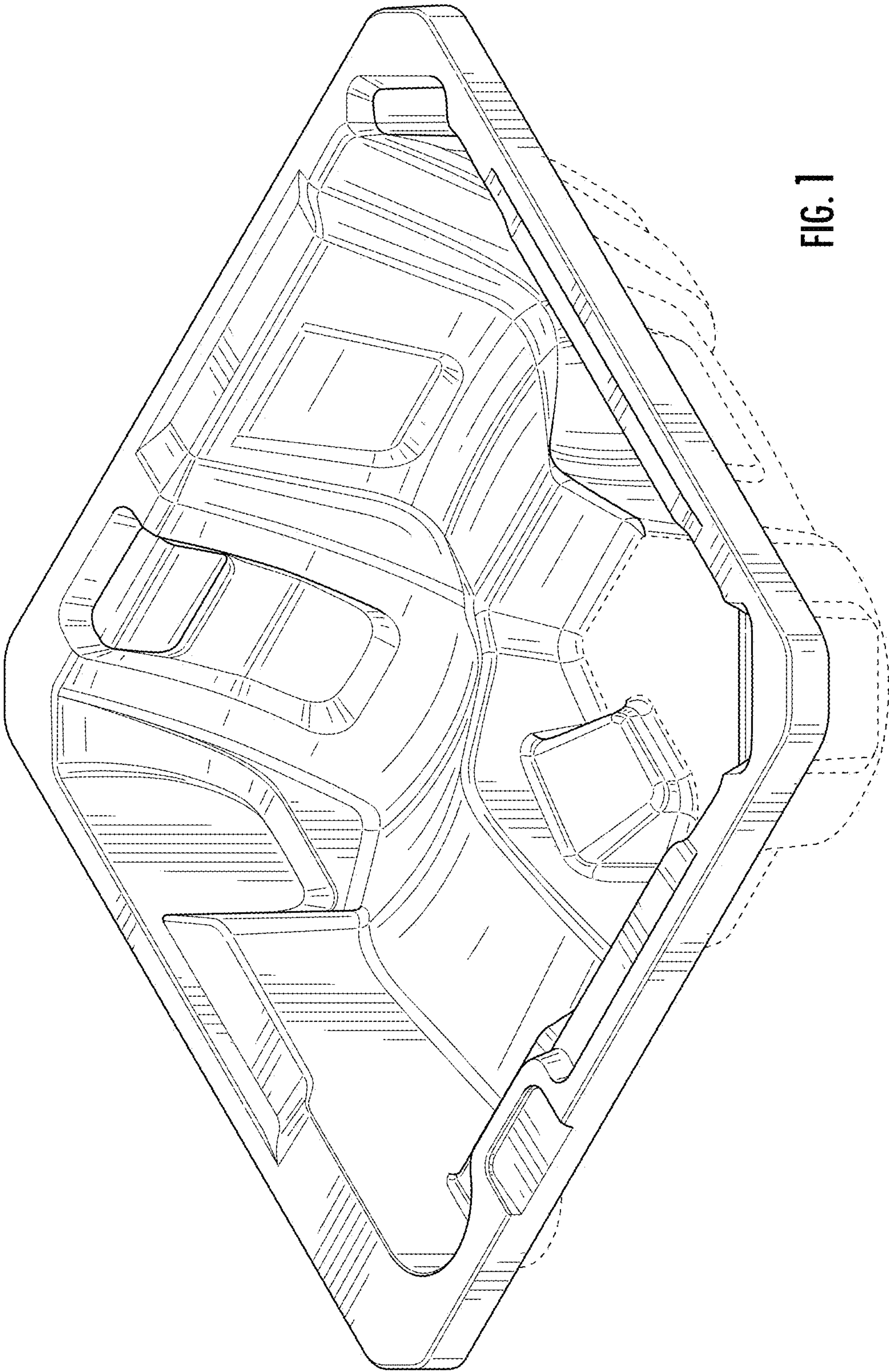

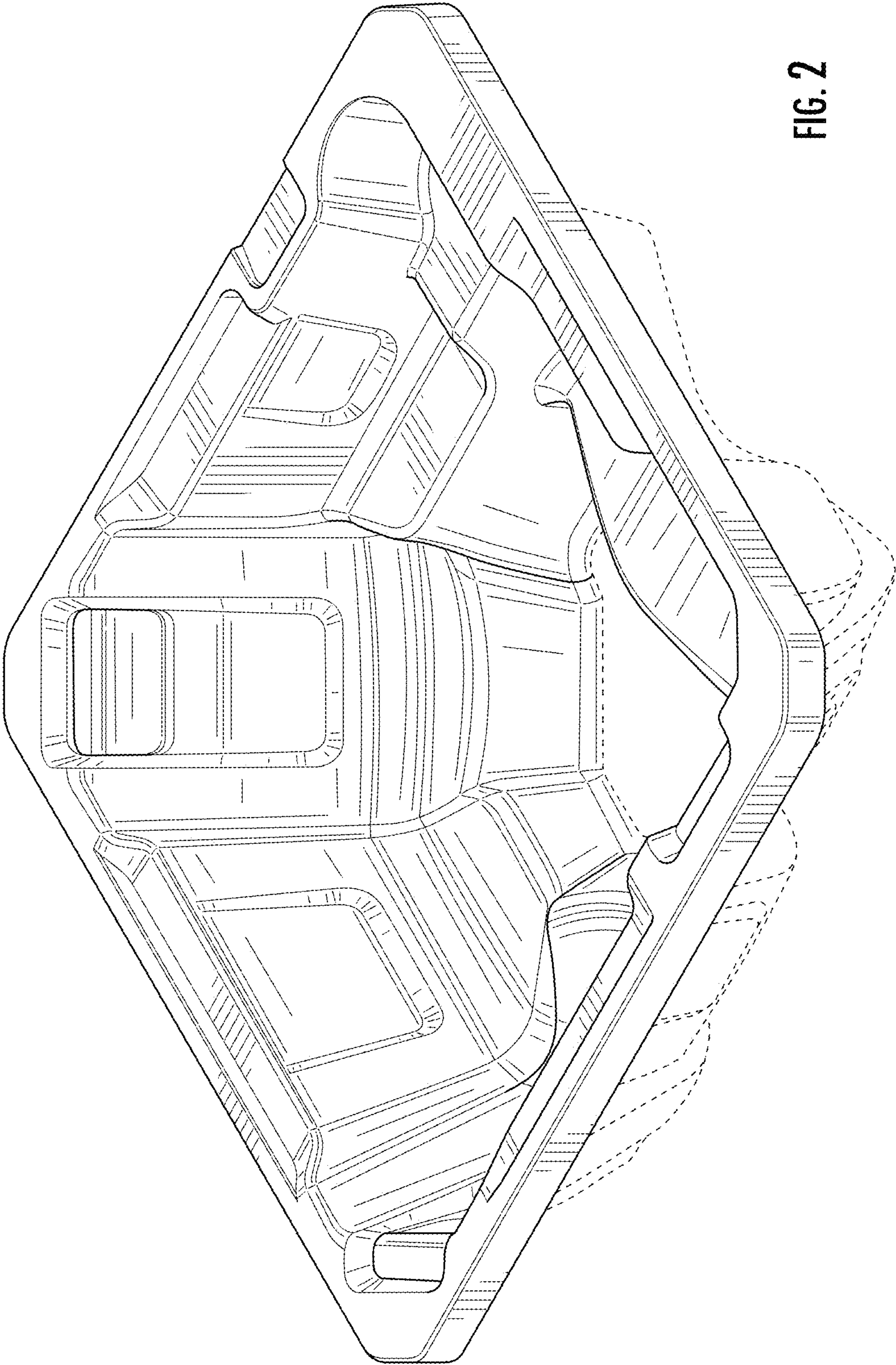

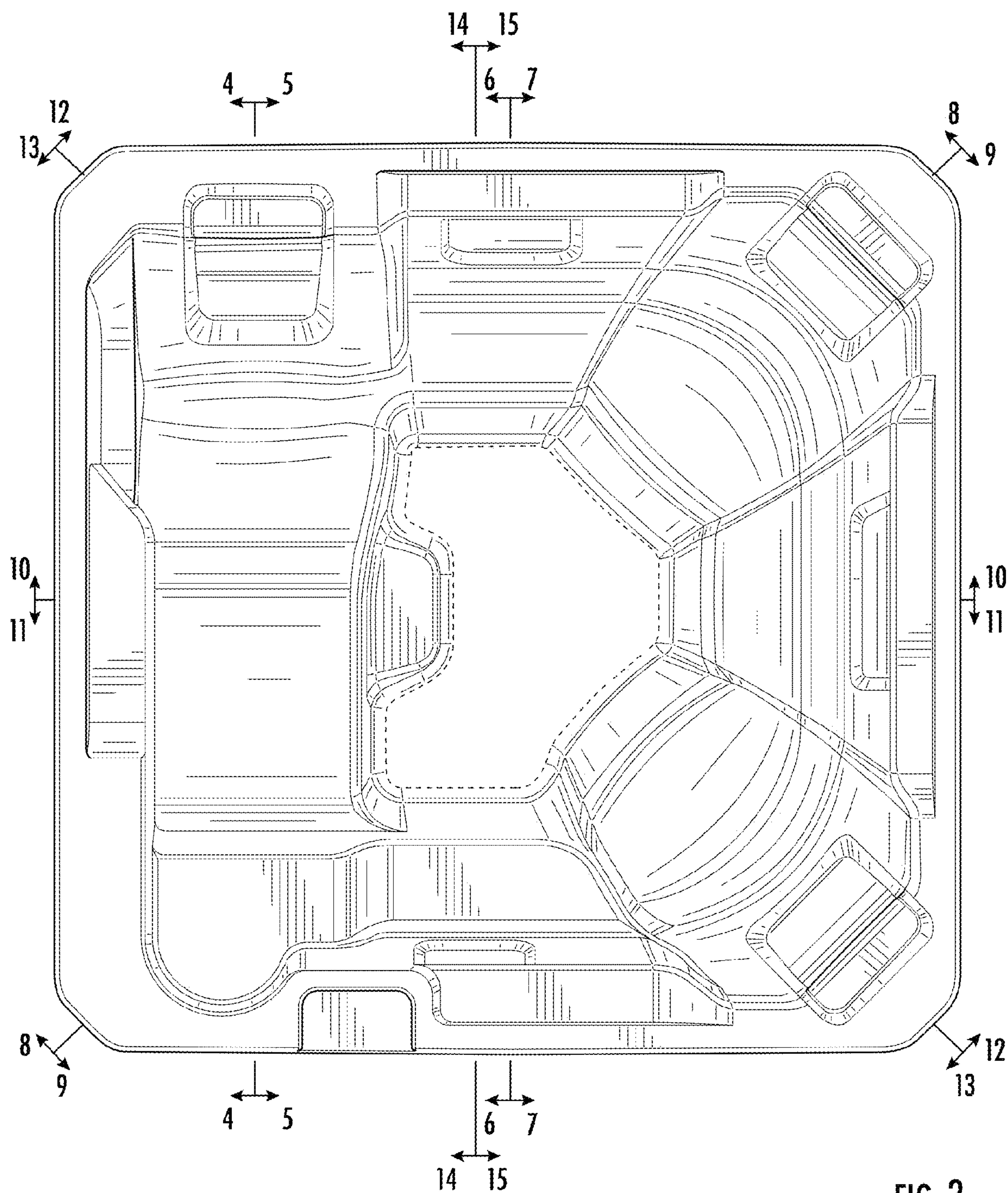

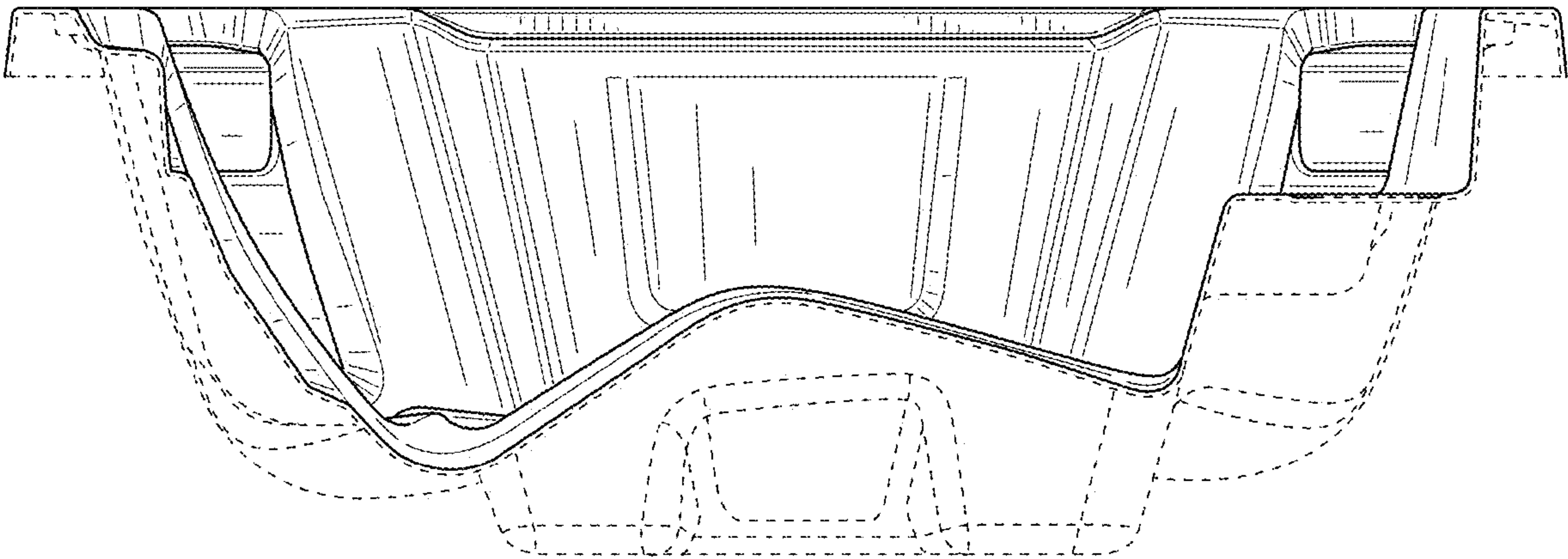

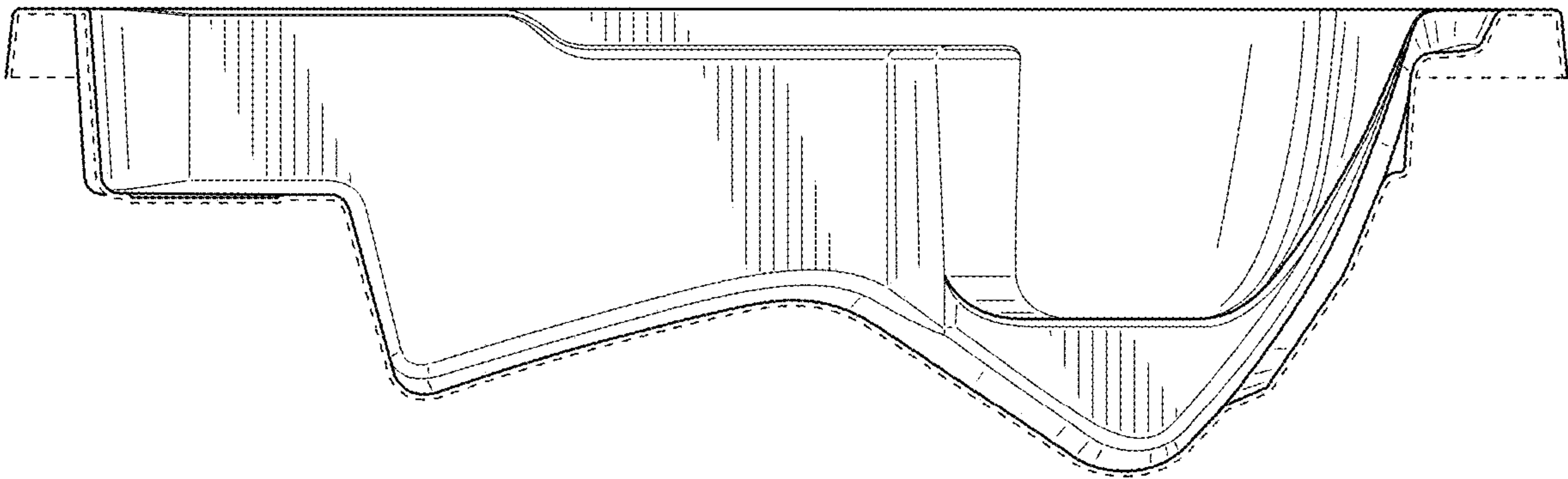

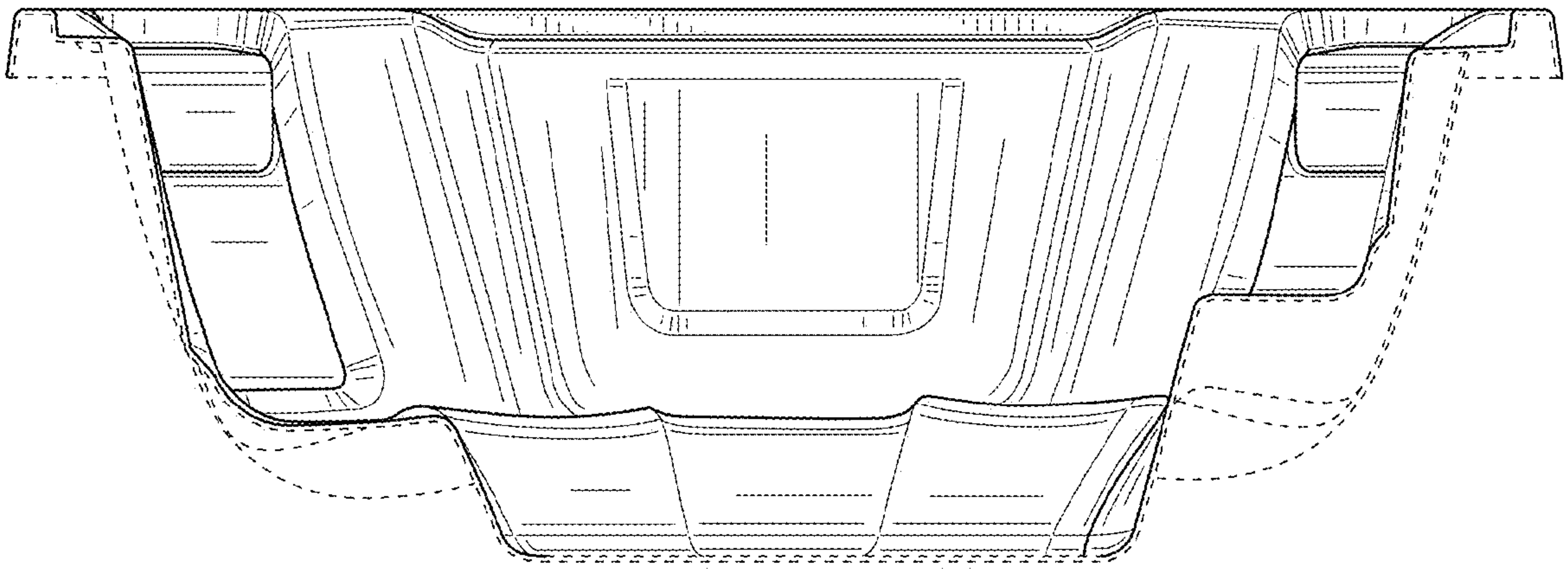

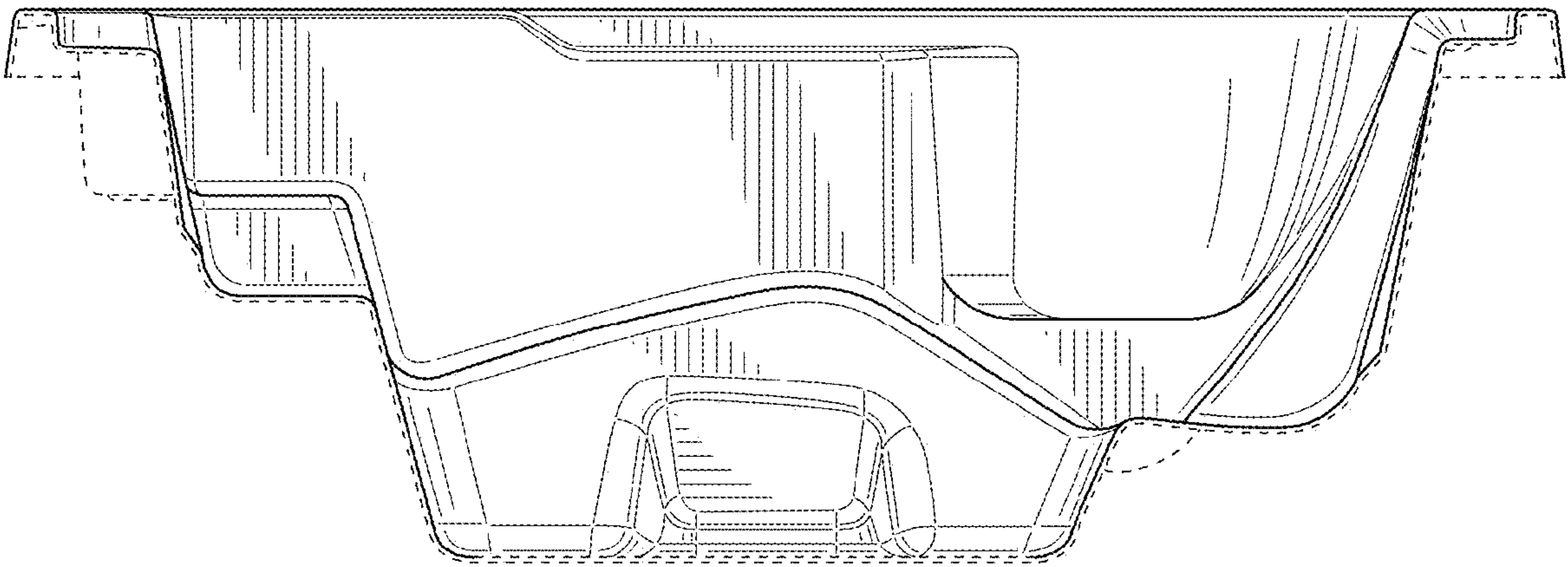

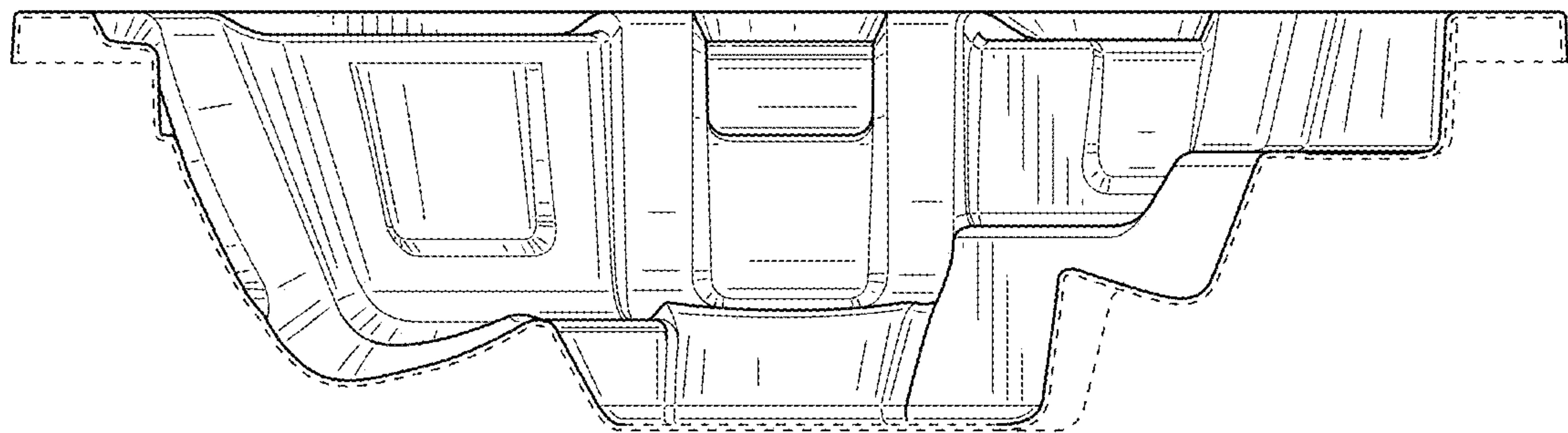

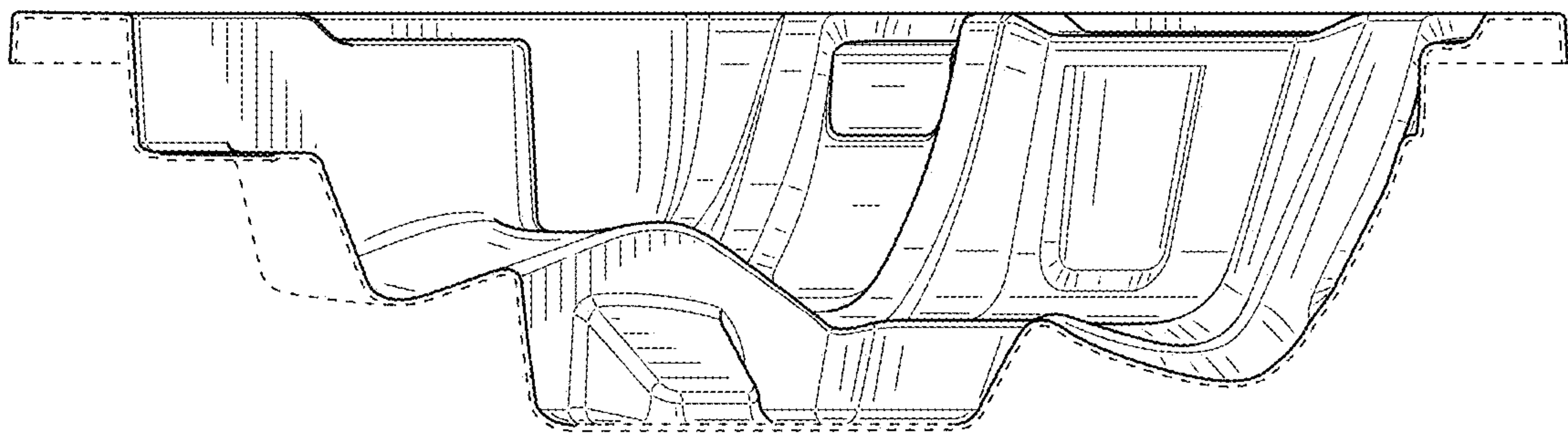

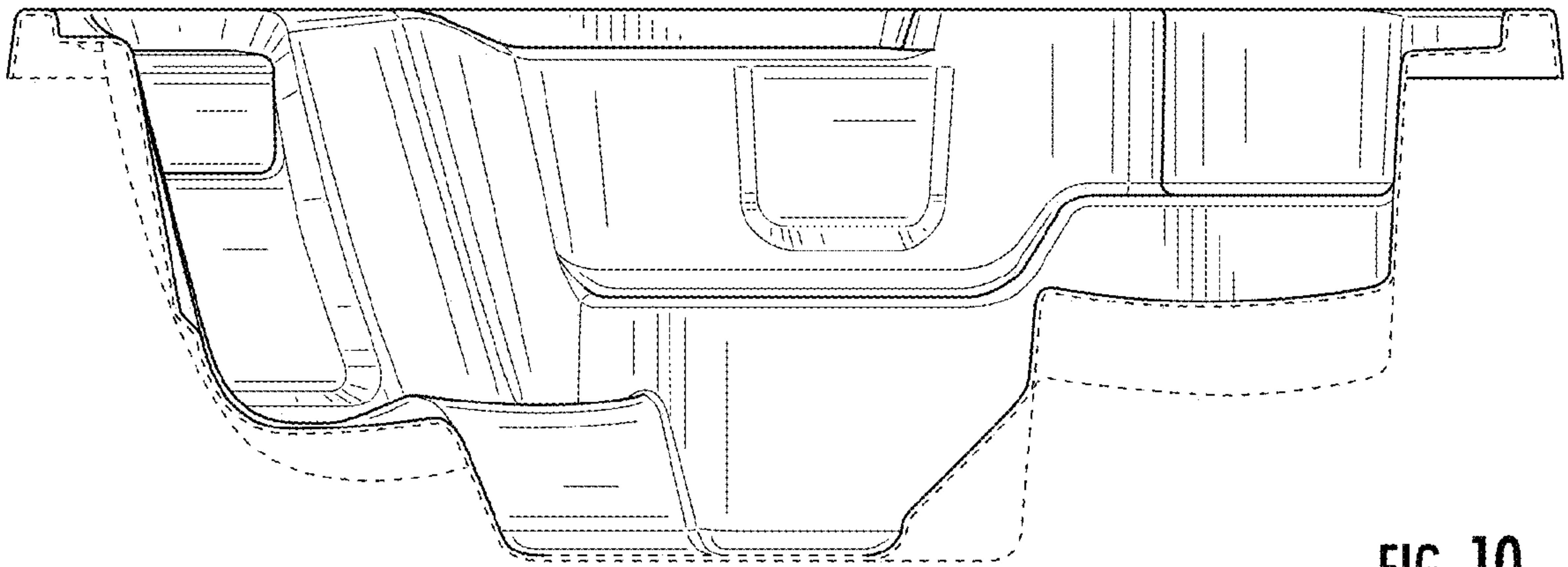

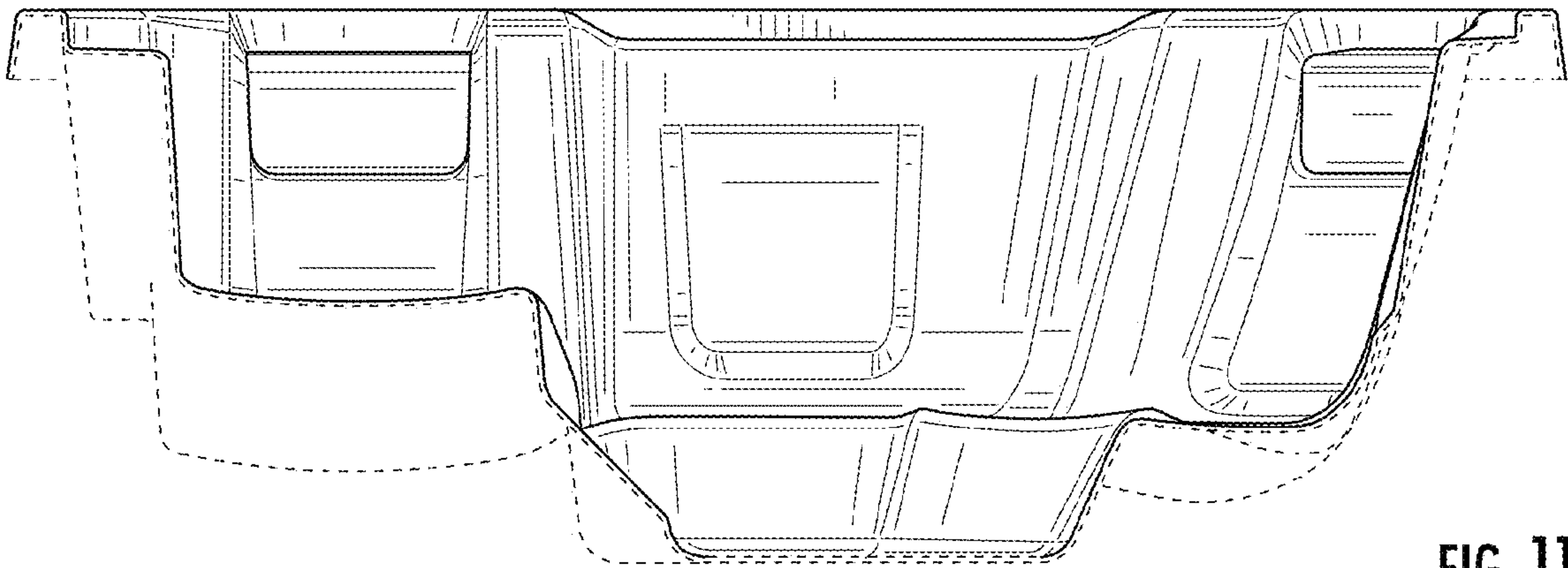

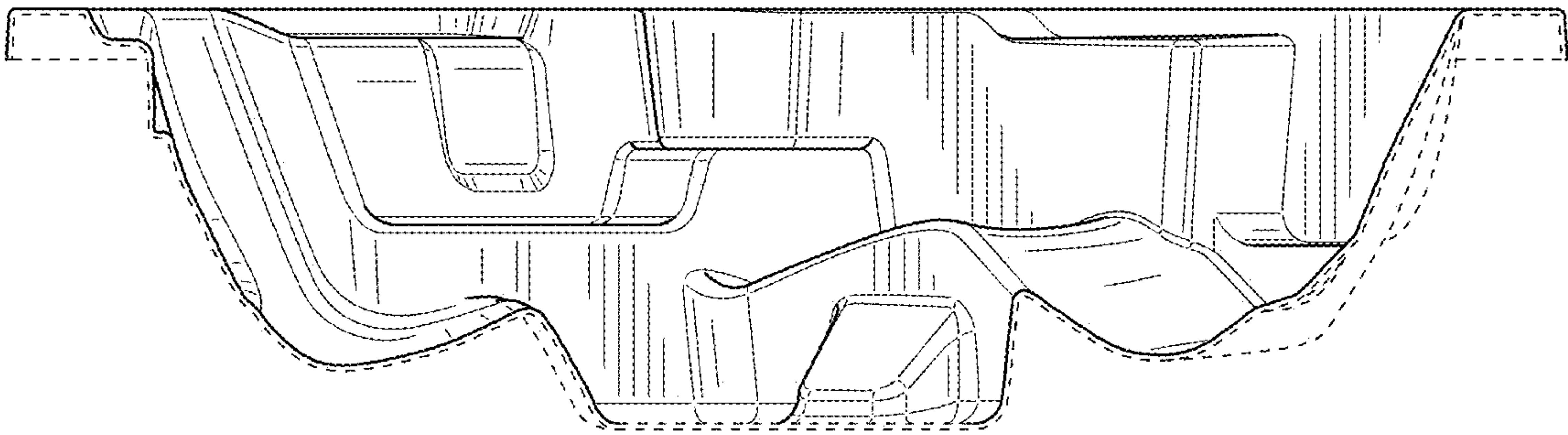

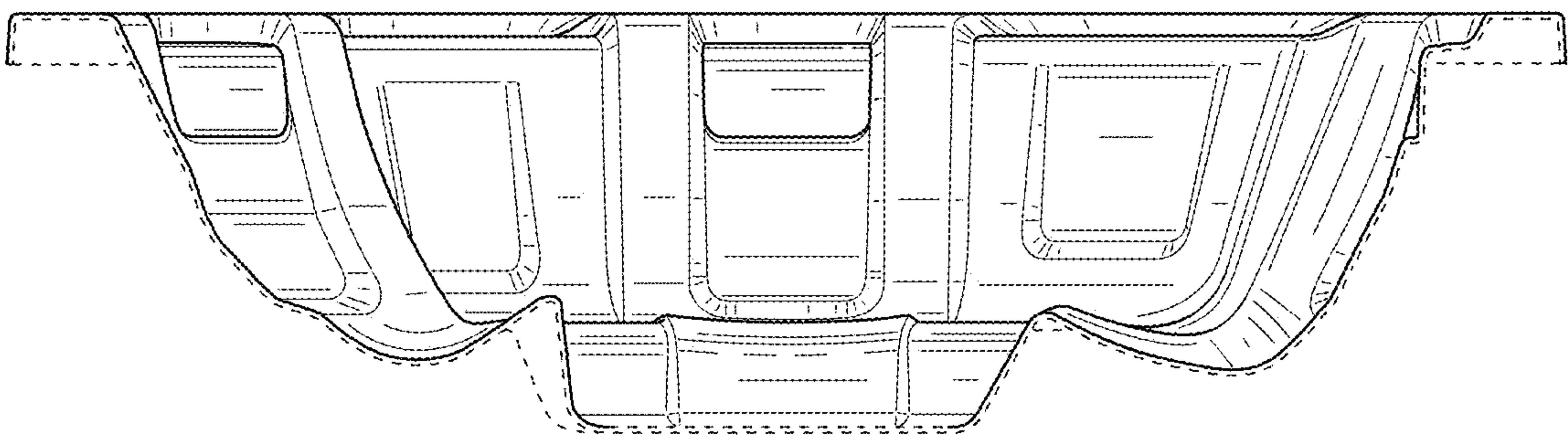

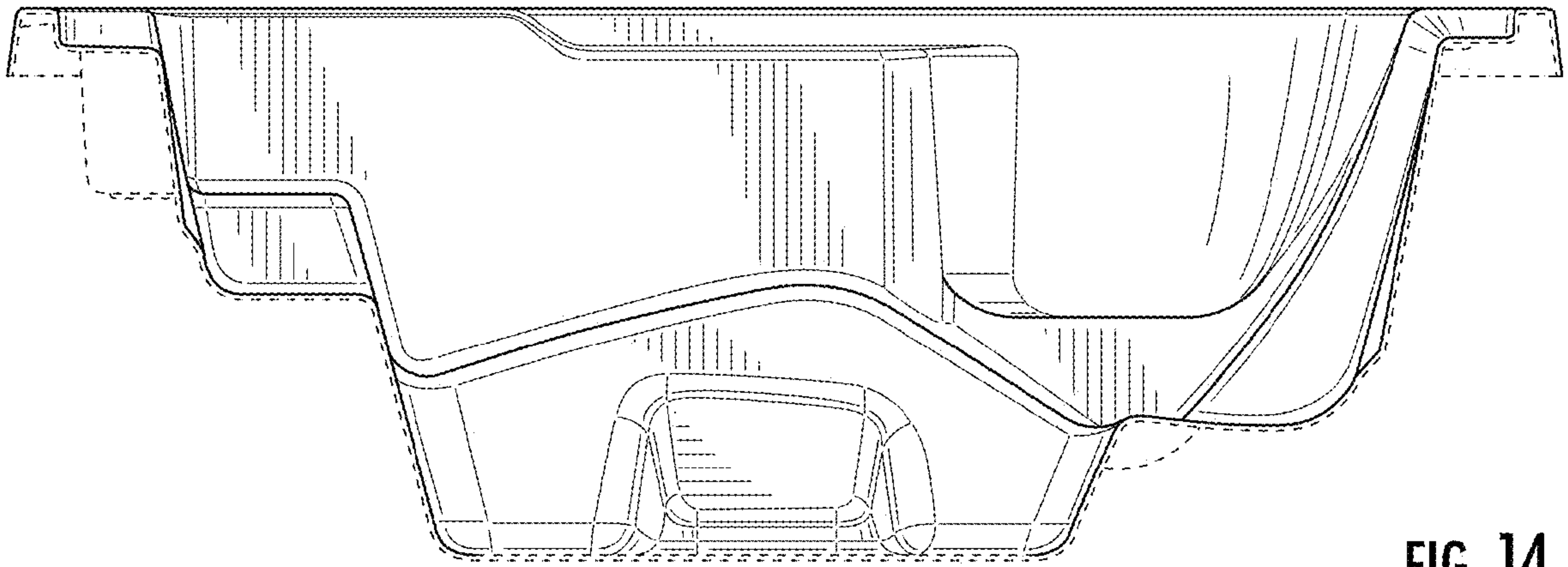

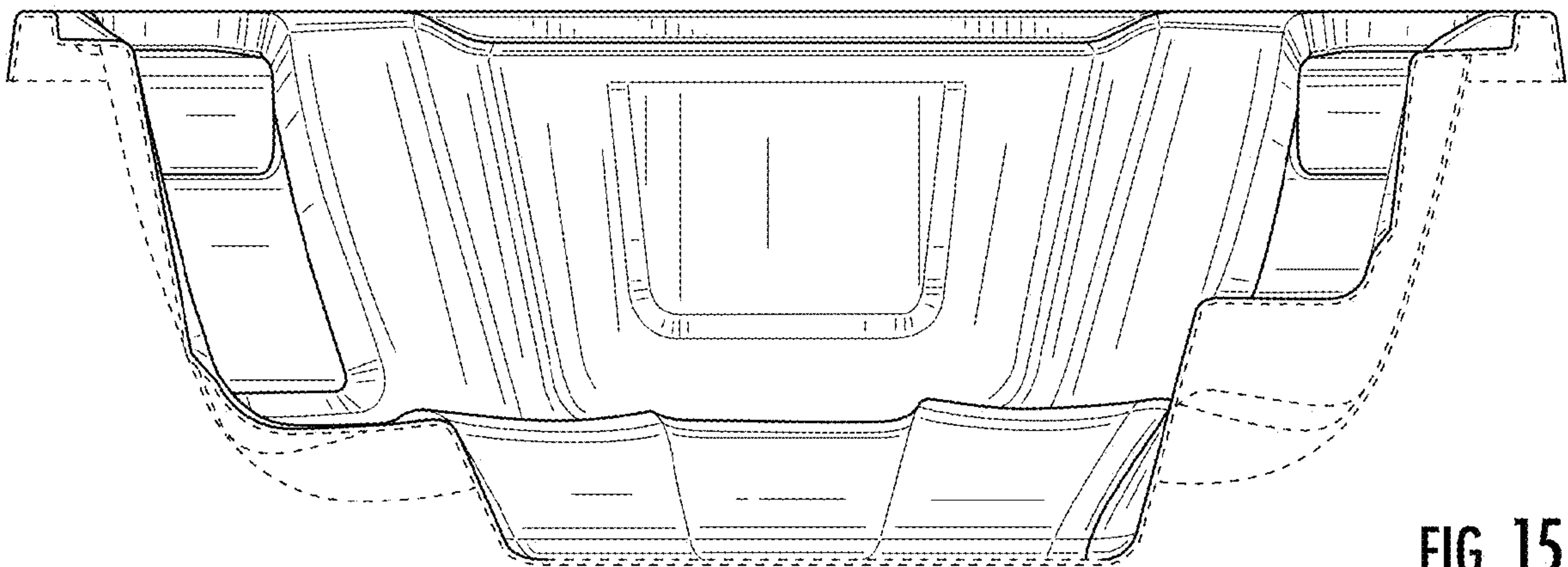
