DESCRIPTION

FIG. 1 is a perspective view of a footwear upper embodying the new design;

FIG. 4 is a right side view thereof;

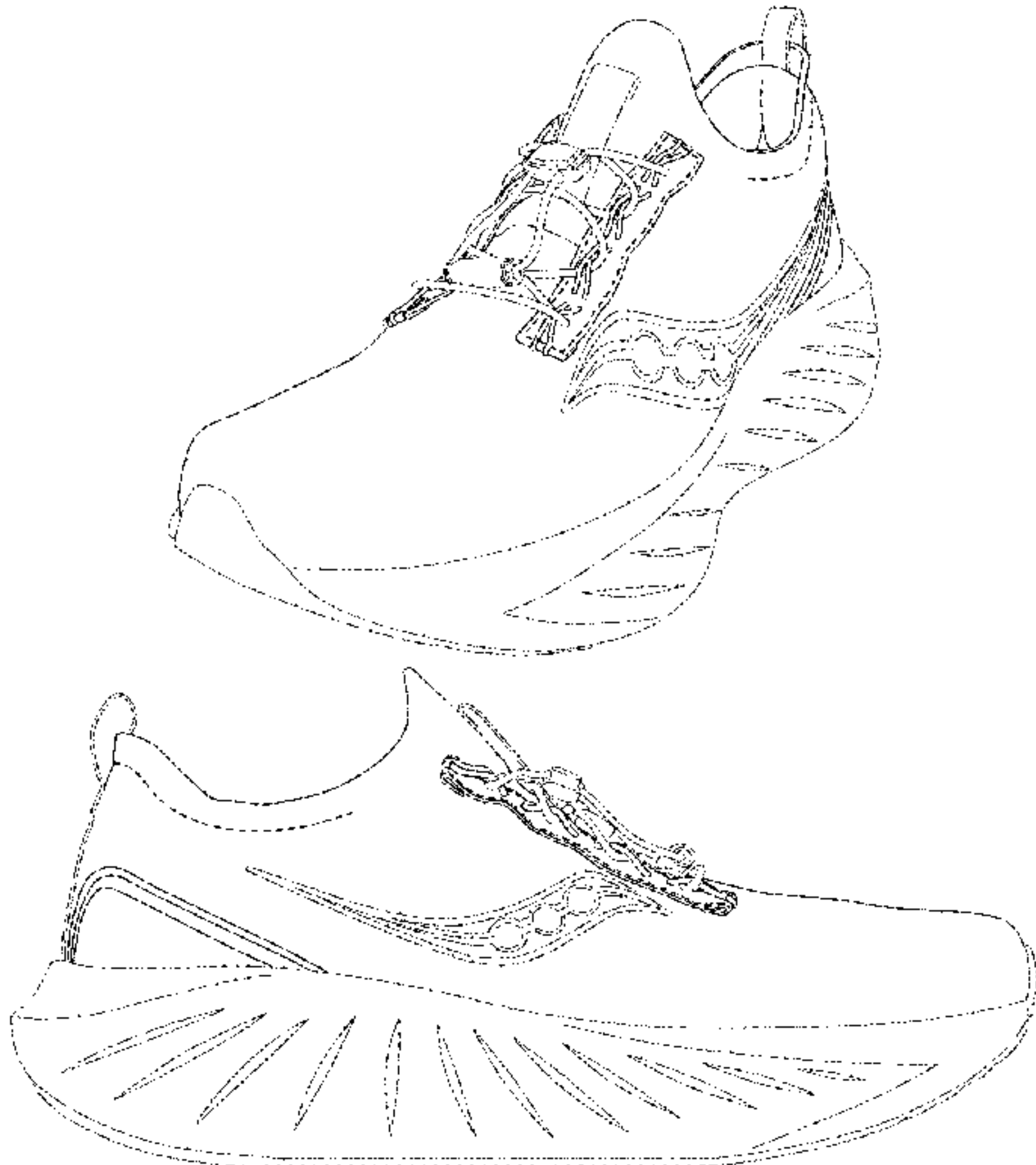
FIG. 5 is a left side view thereof;

The evenly spaced dash-dash broken lines in the figures depict stitching, which forms part of the claimed design.

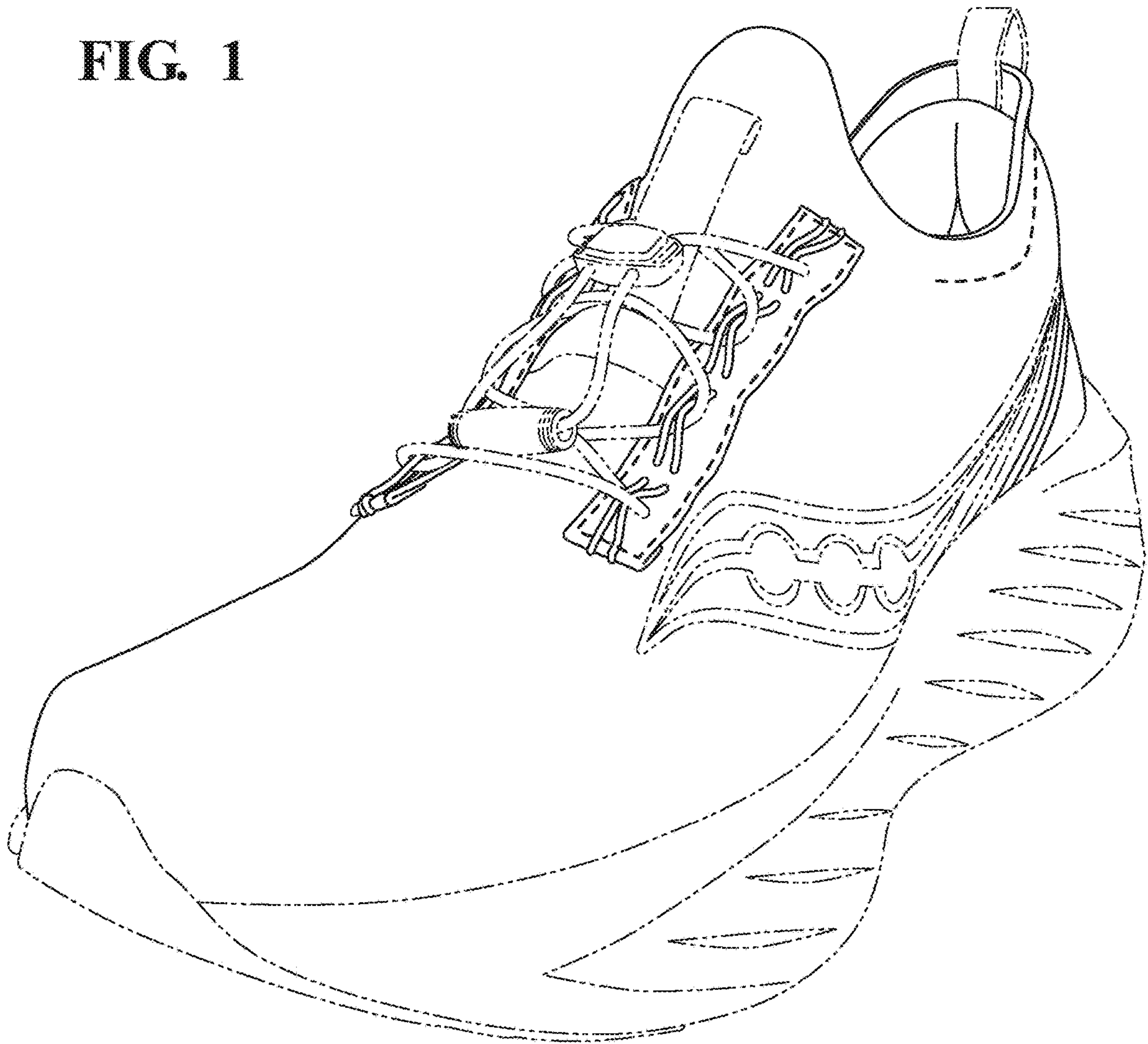

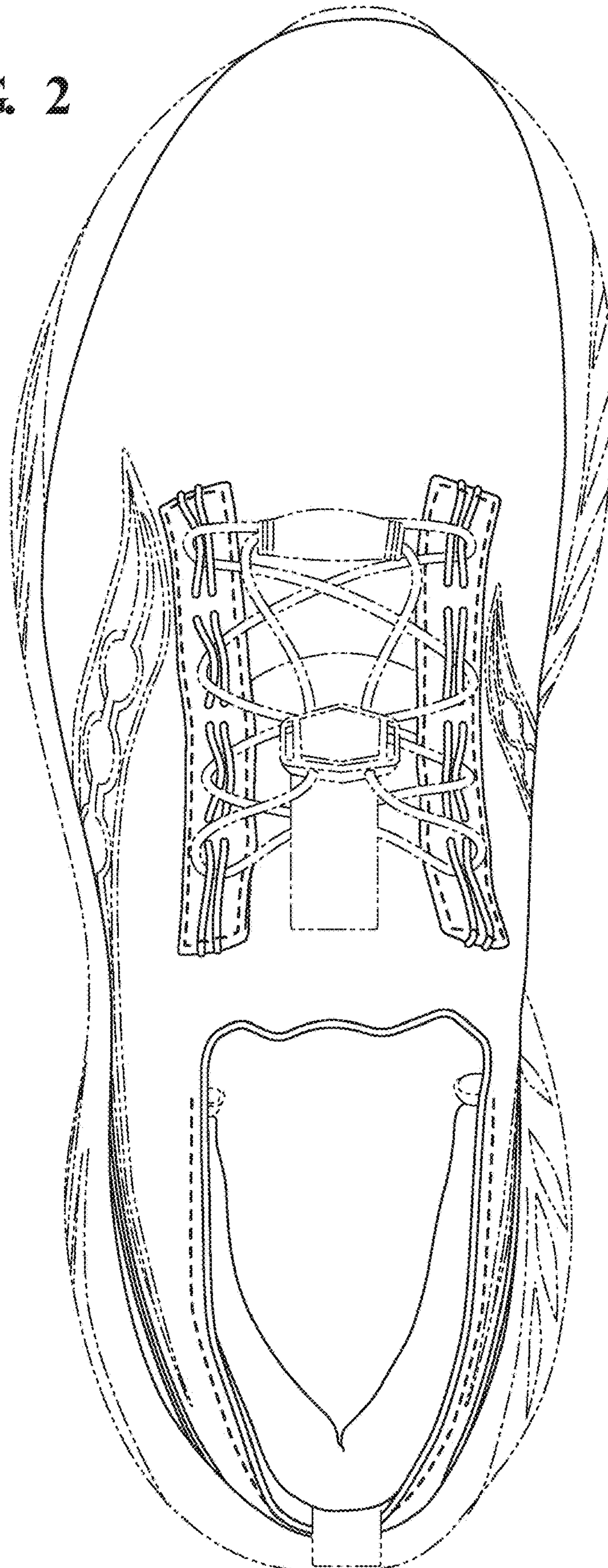
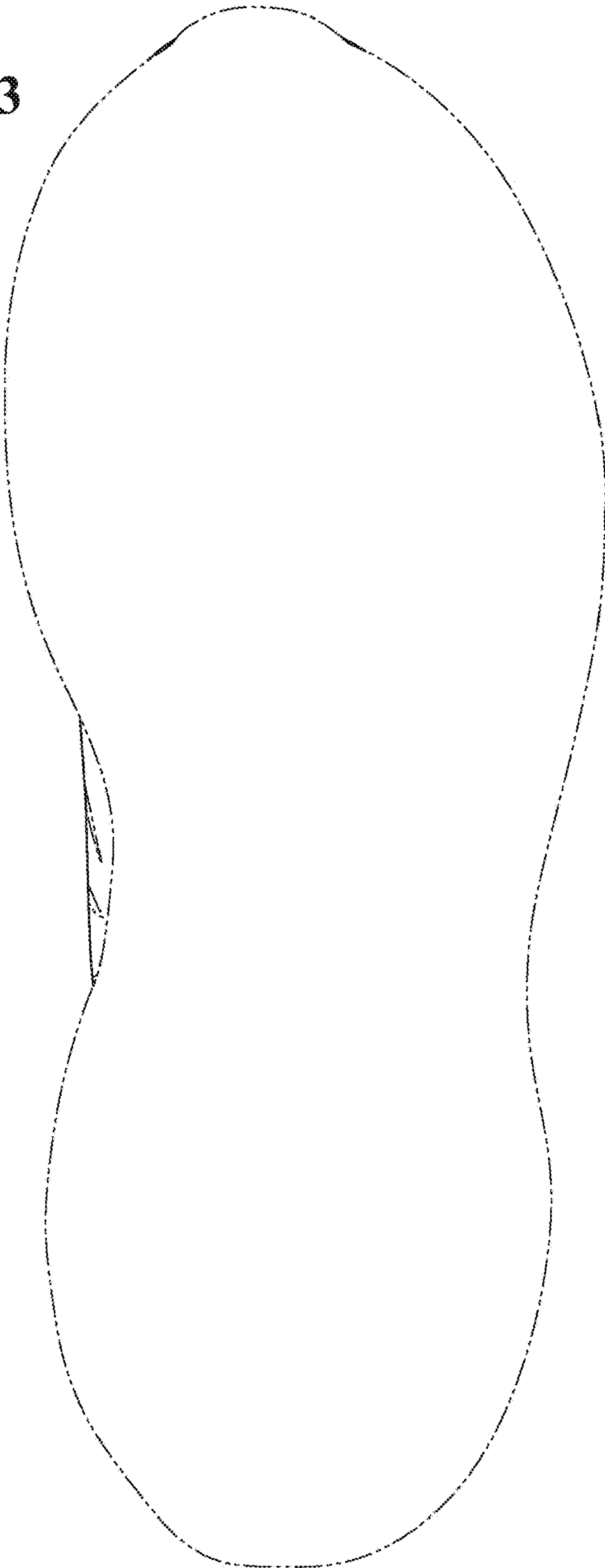

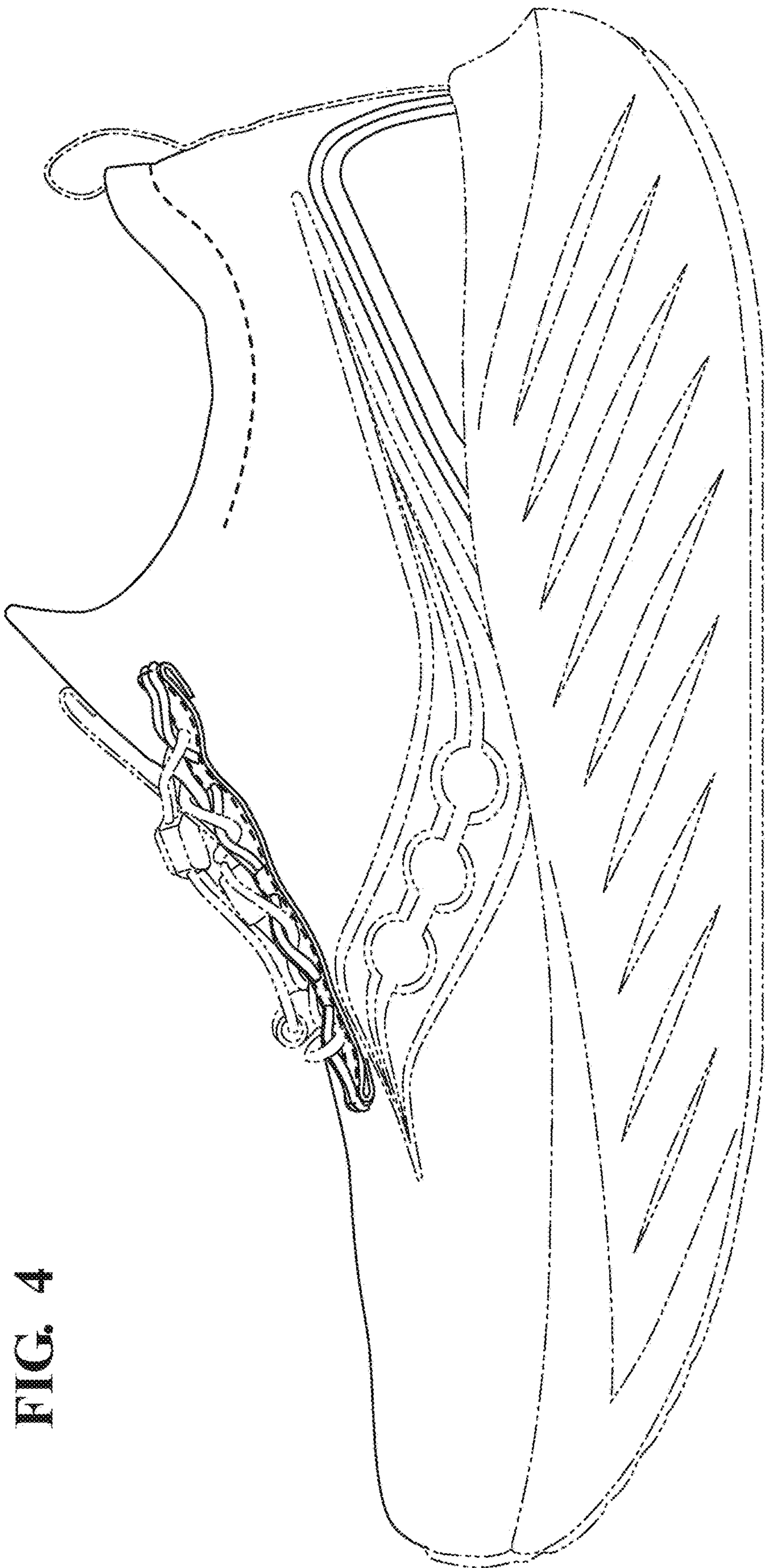
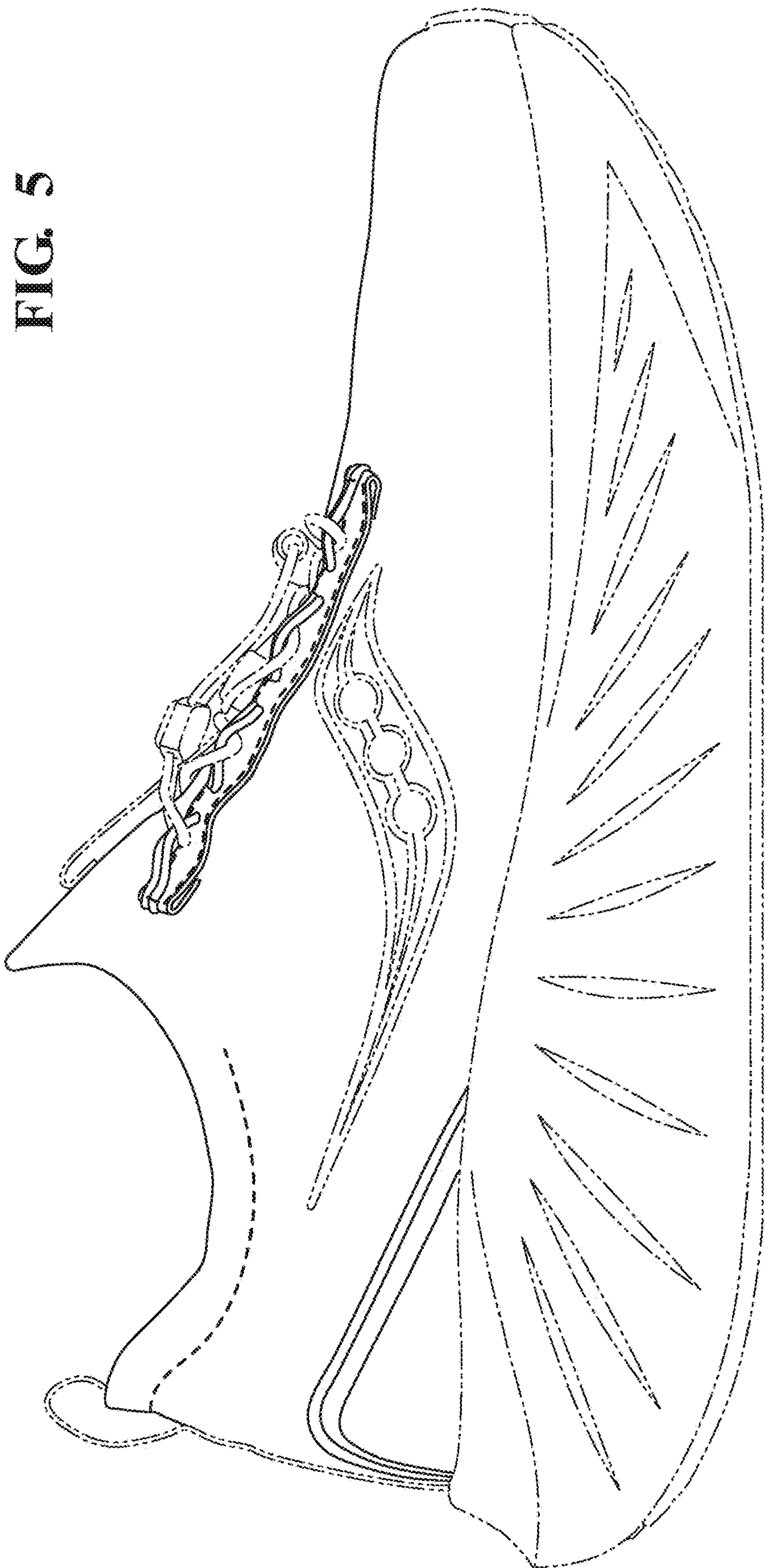

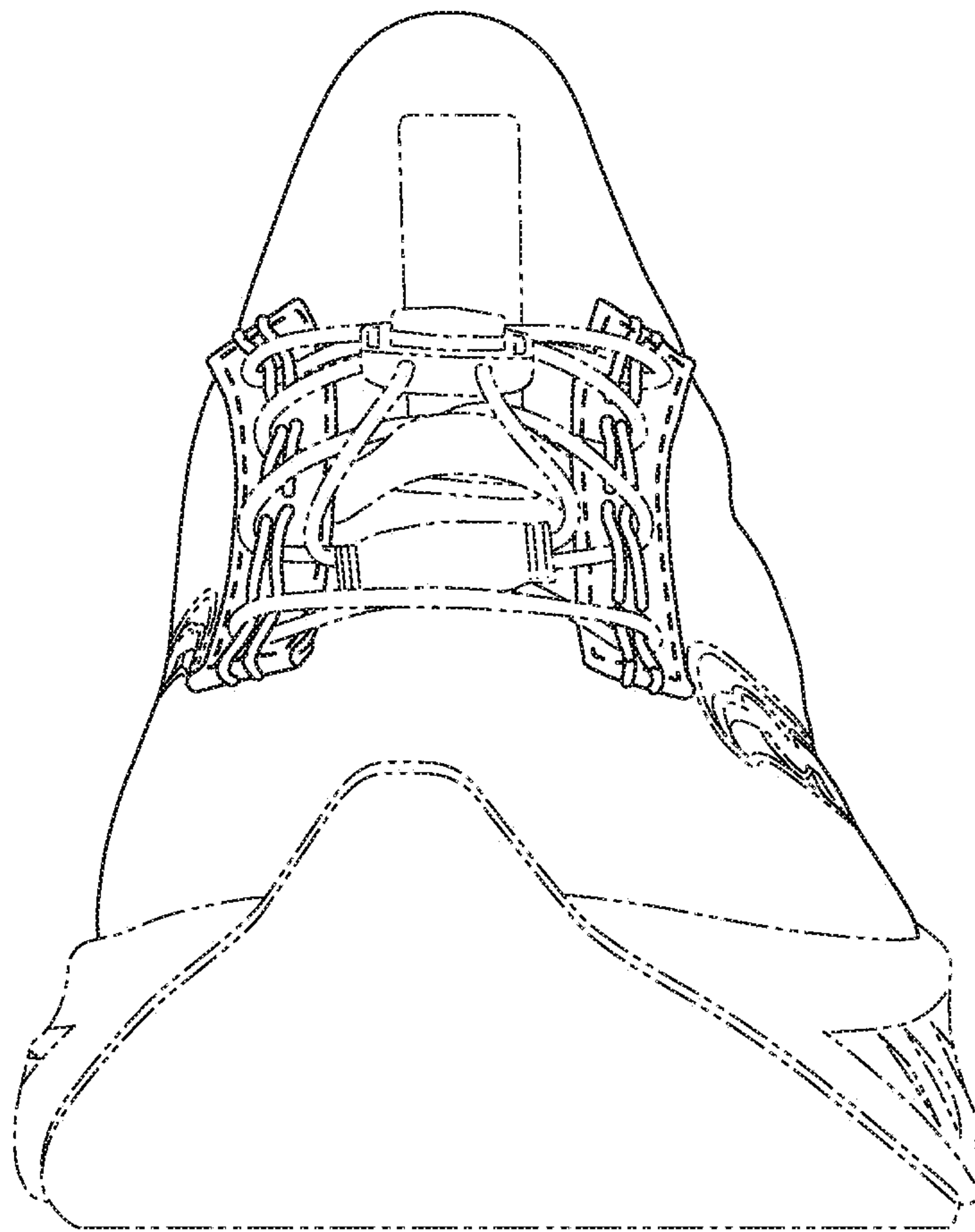

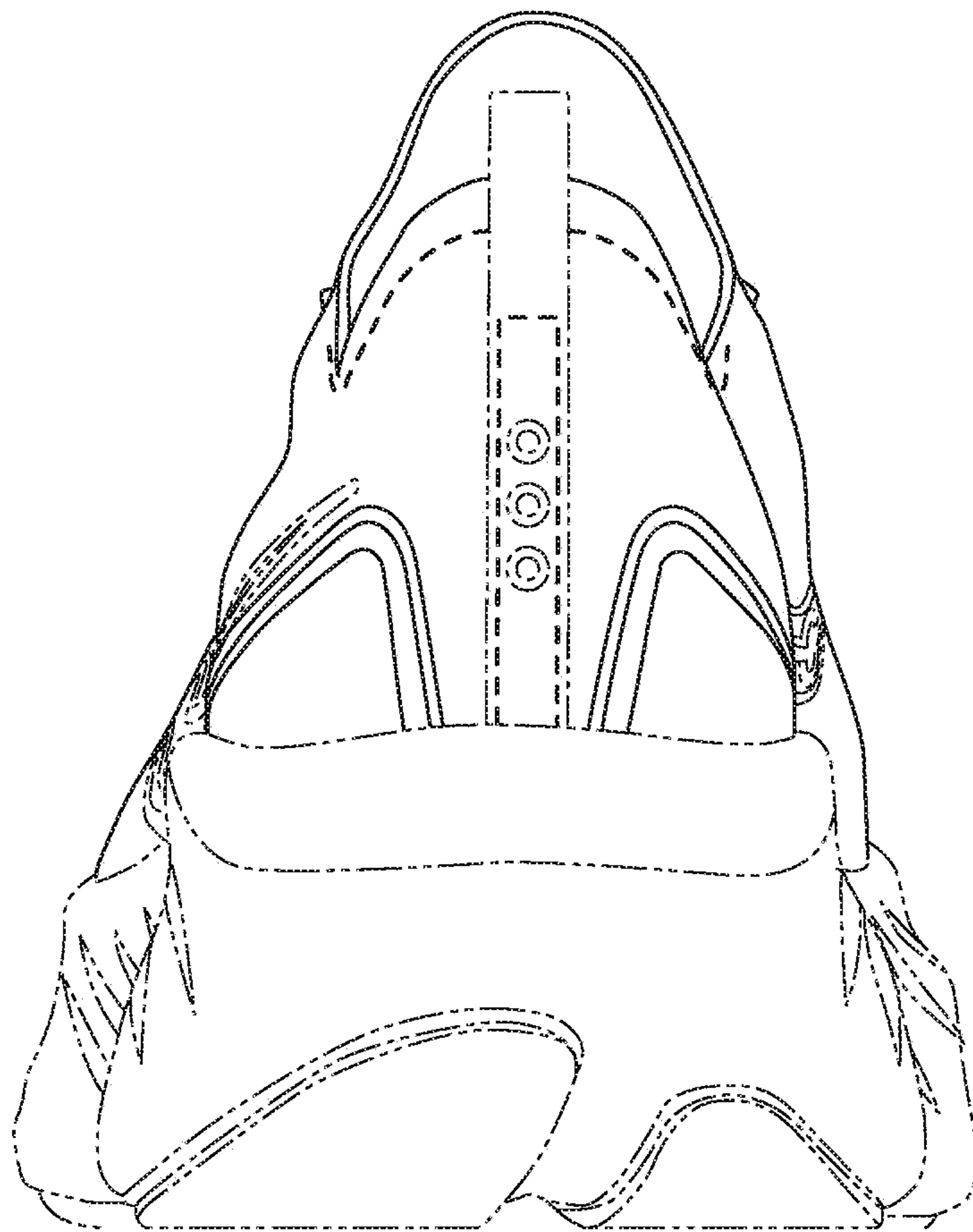
