(57) CLAIM

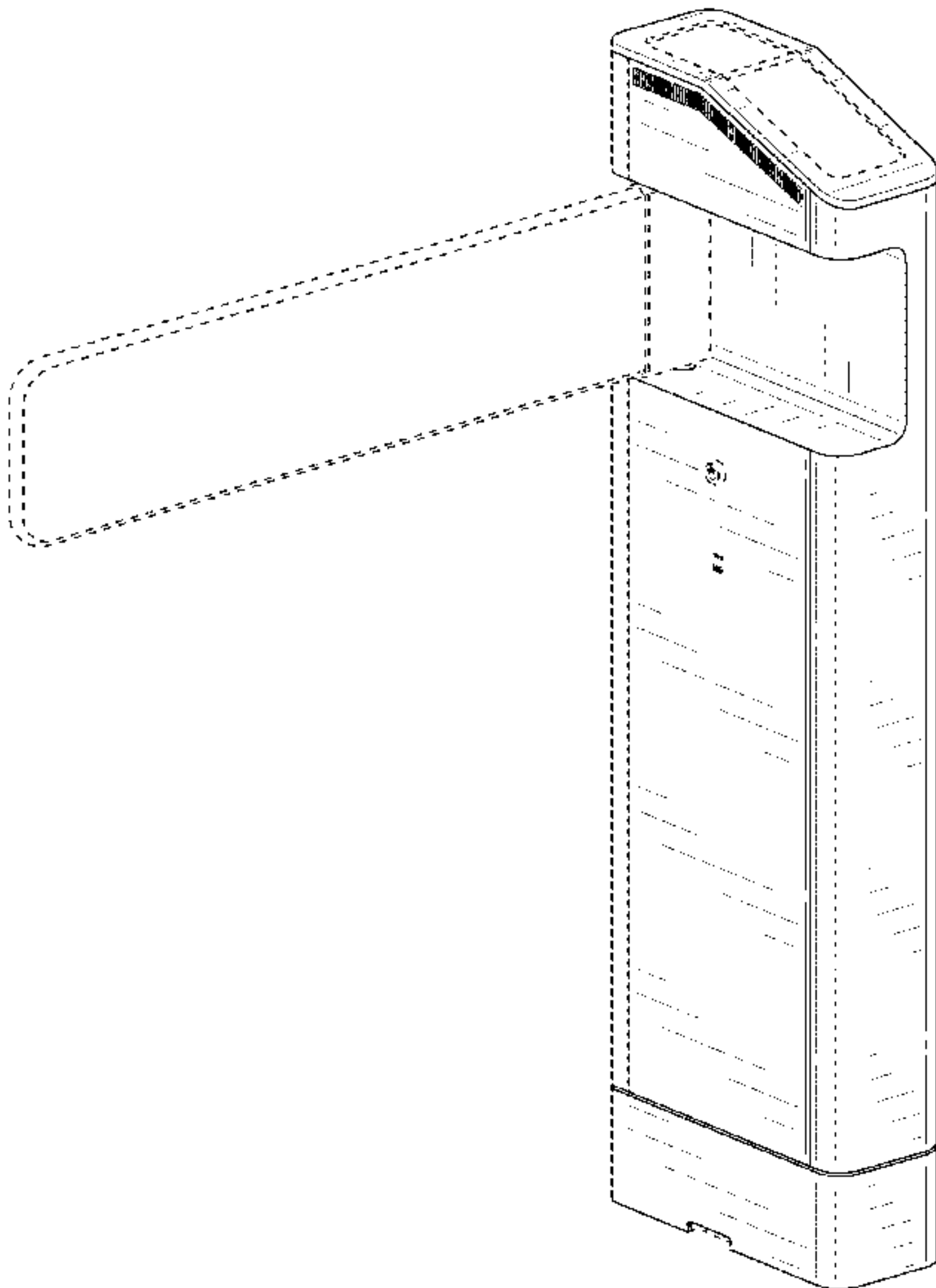
The ornamental design for a pedestal scanner, as shown and described.

DESCRIPTION

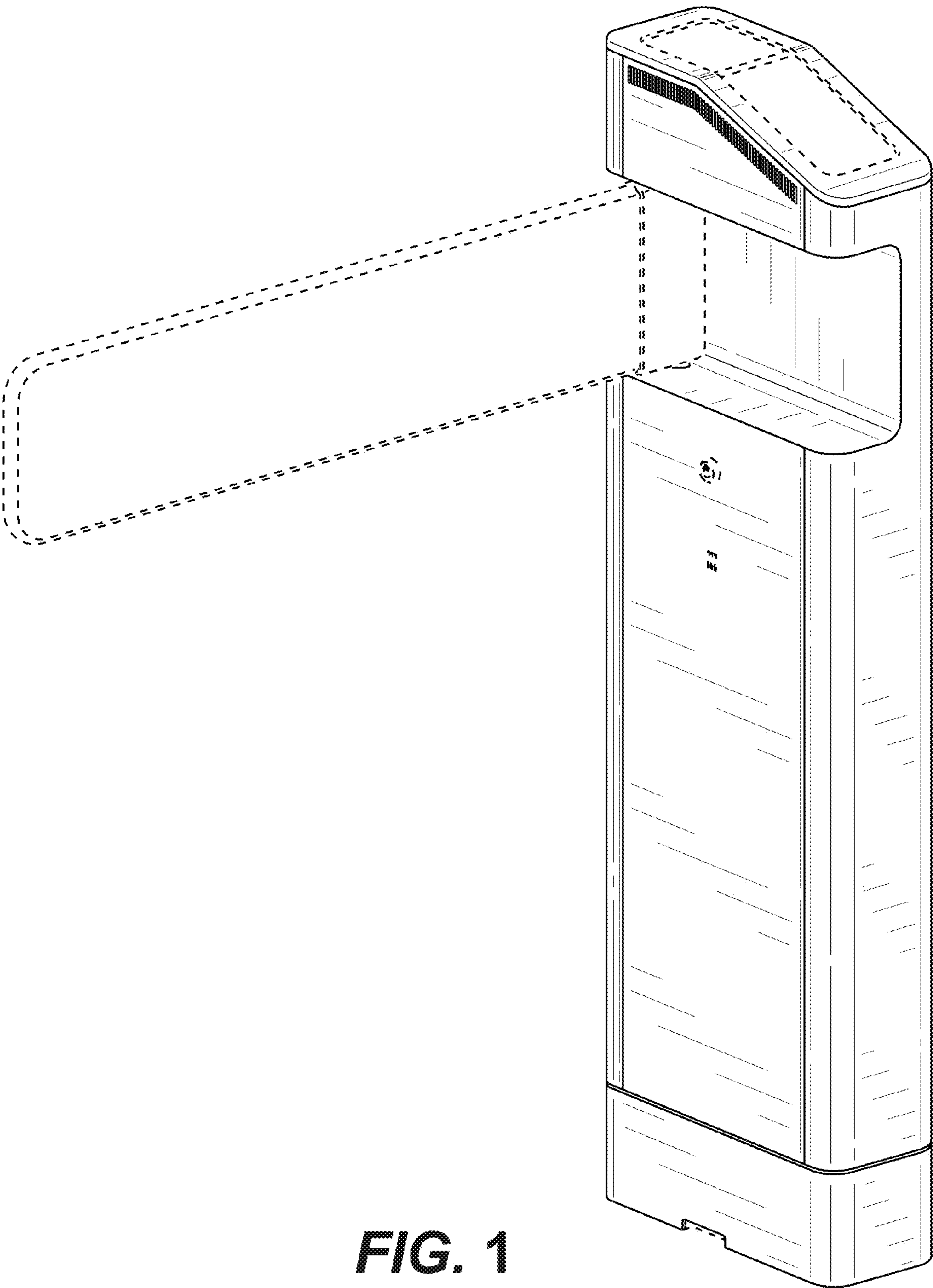
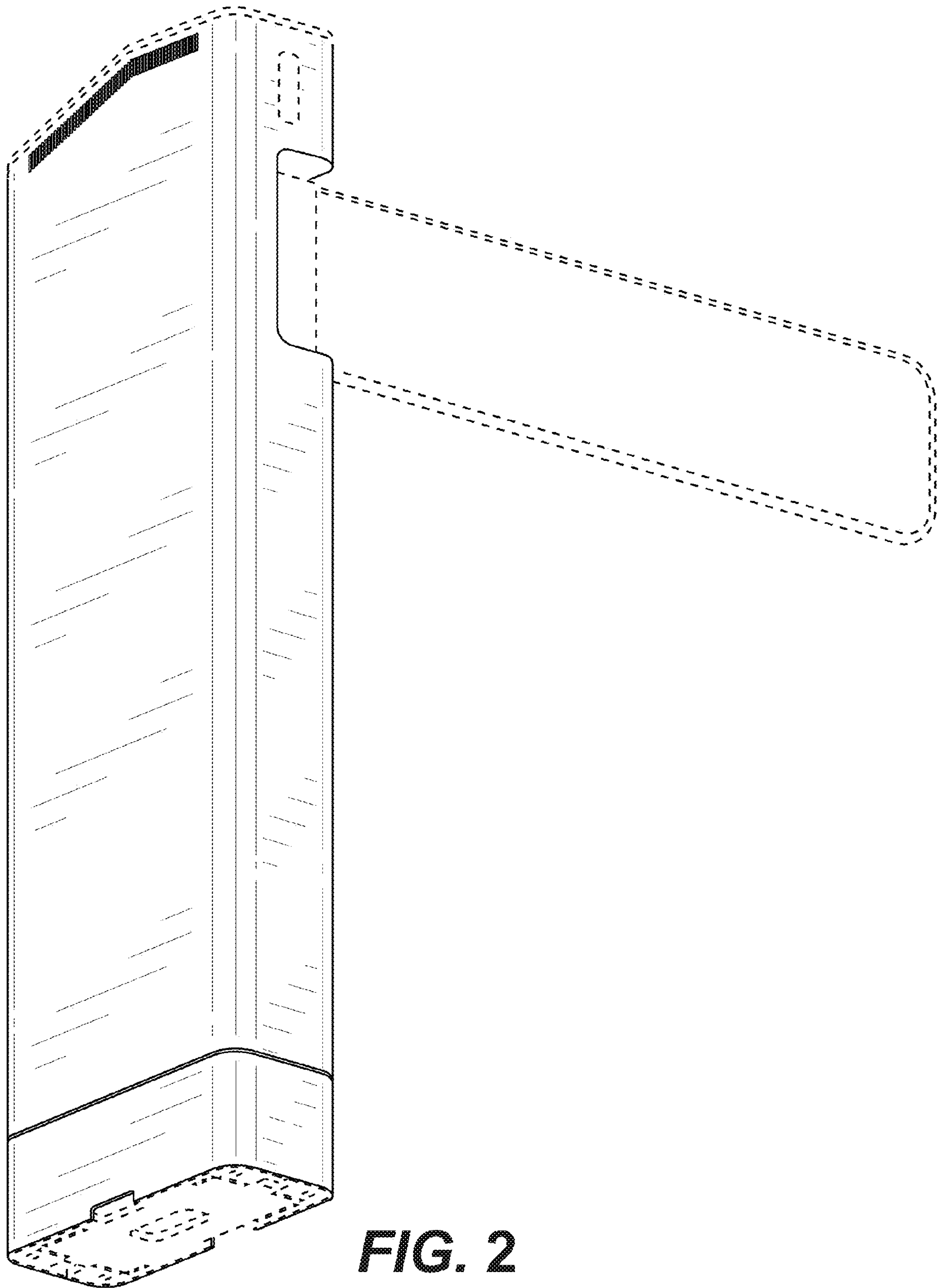

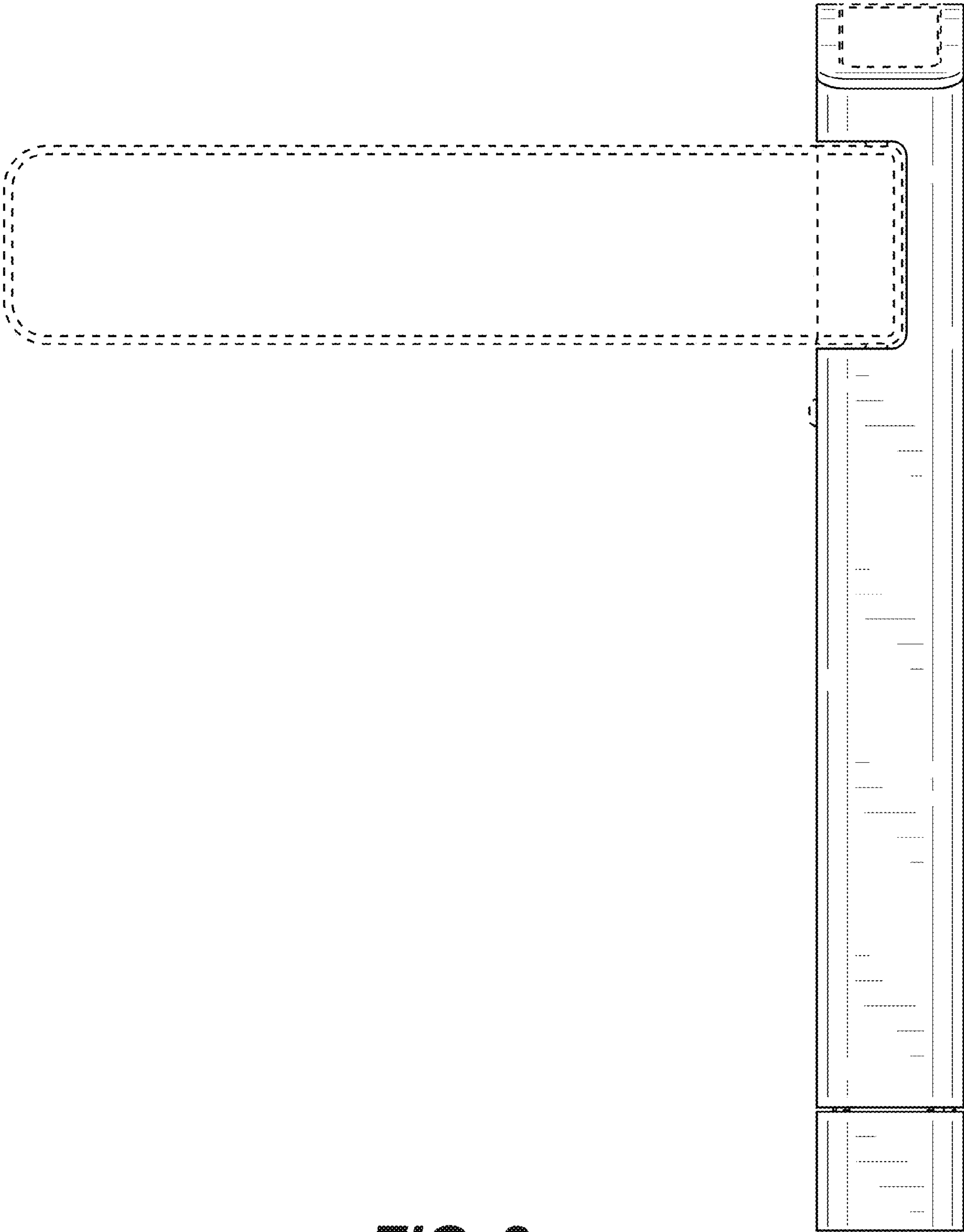

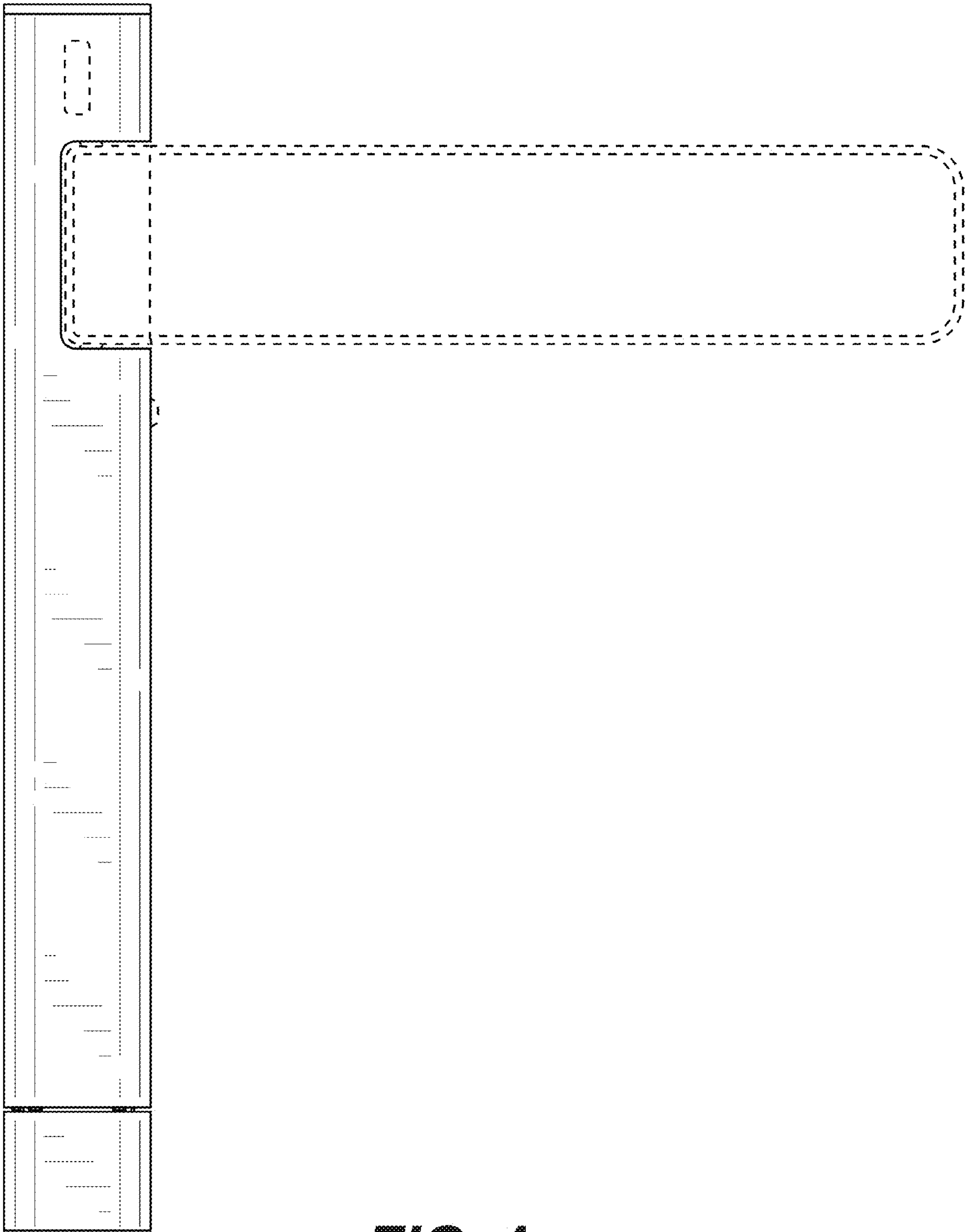

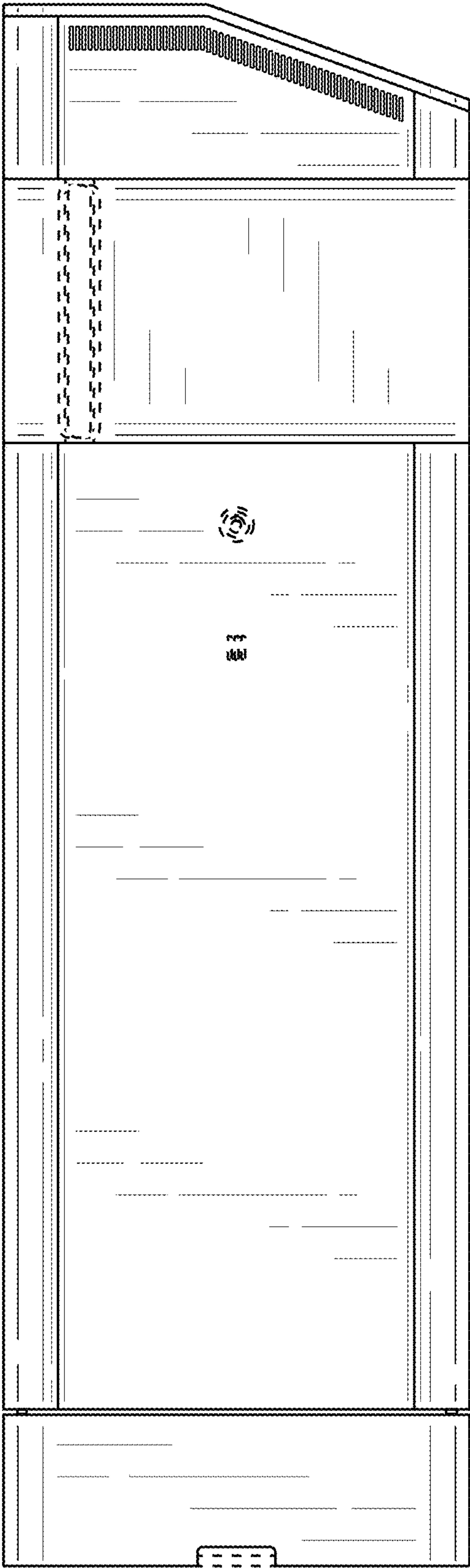

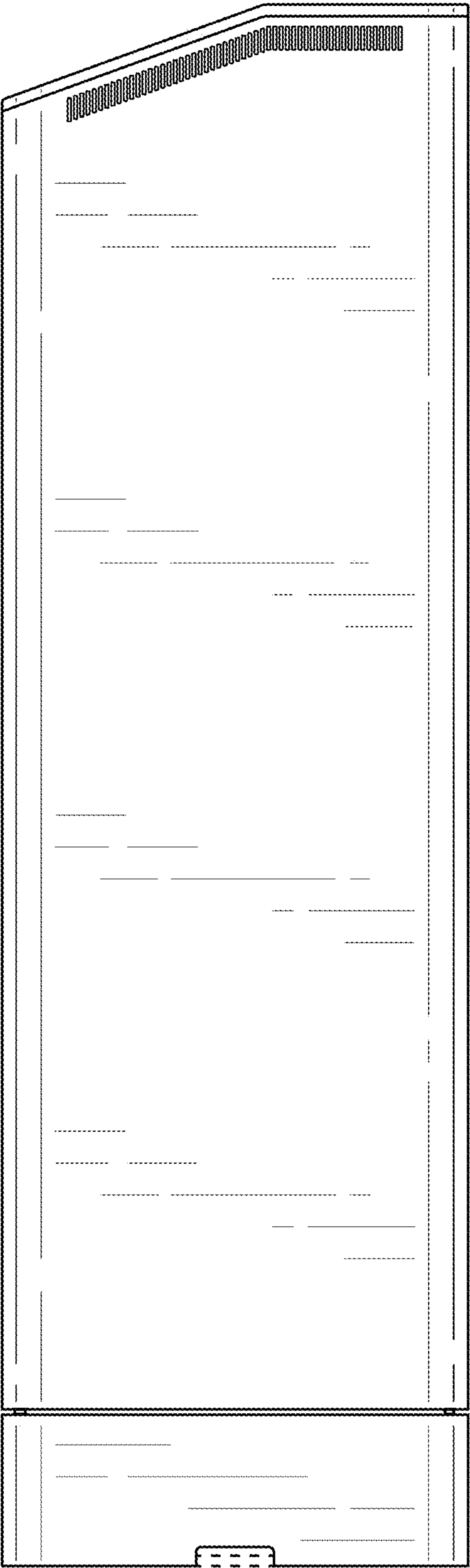

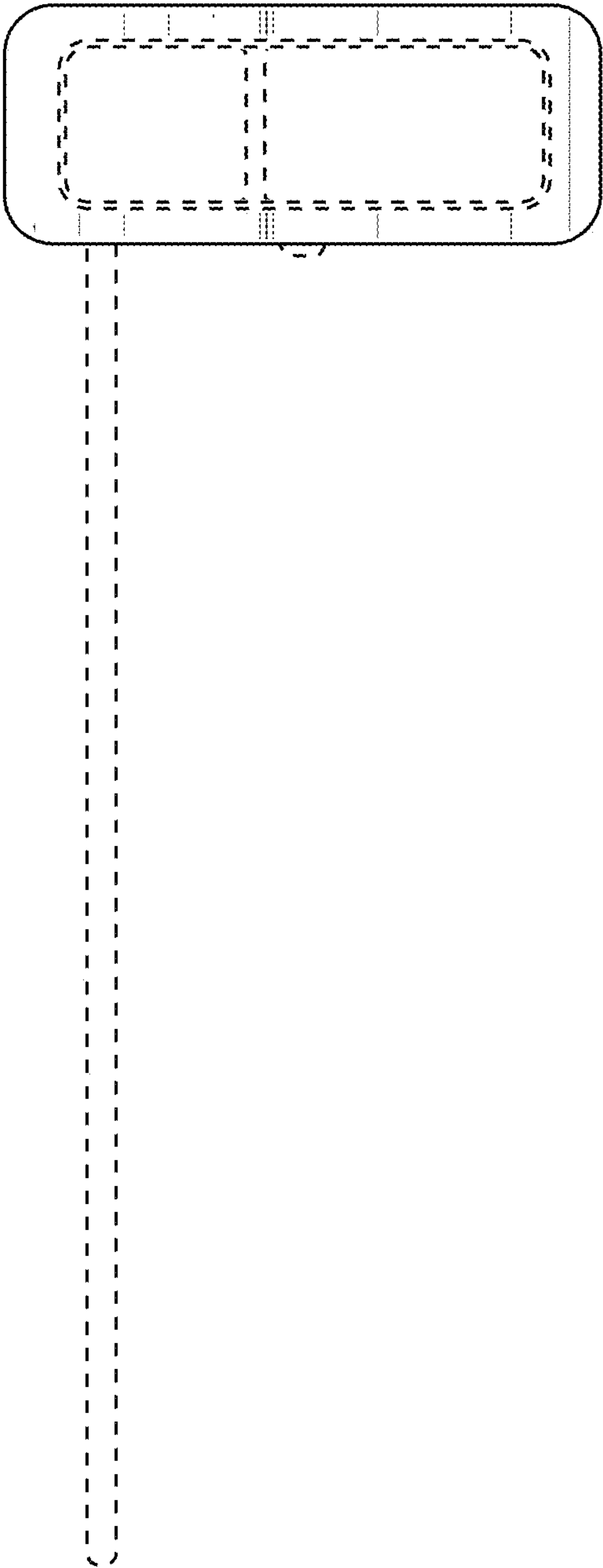

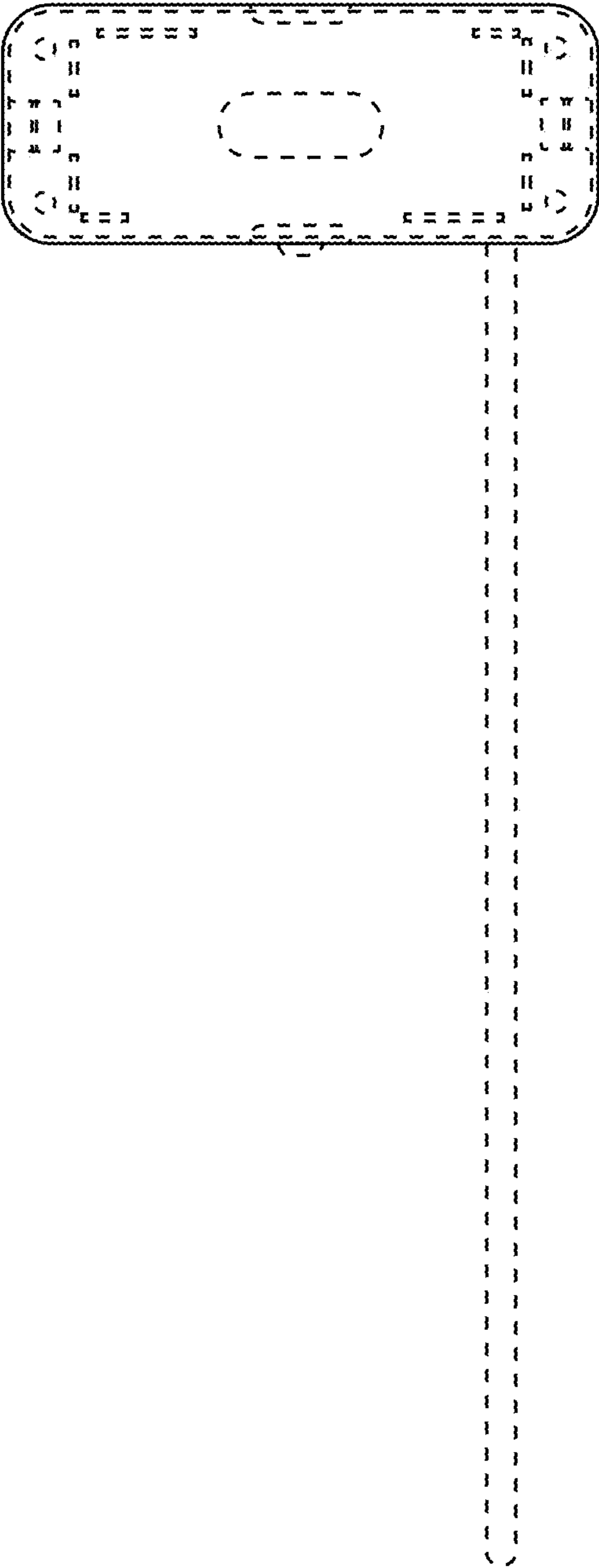
