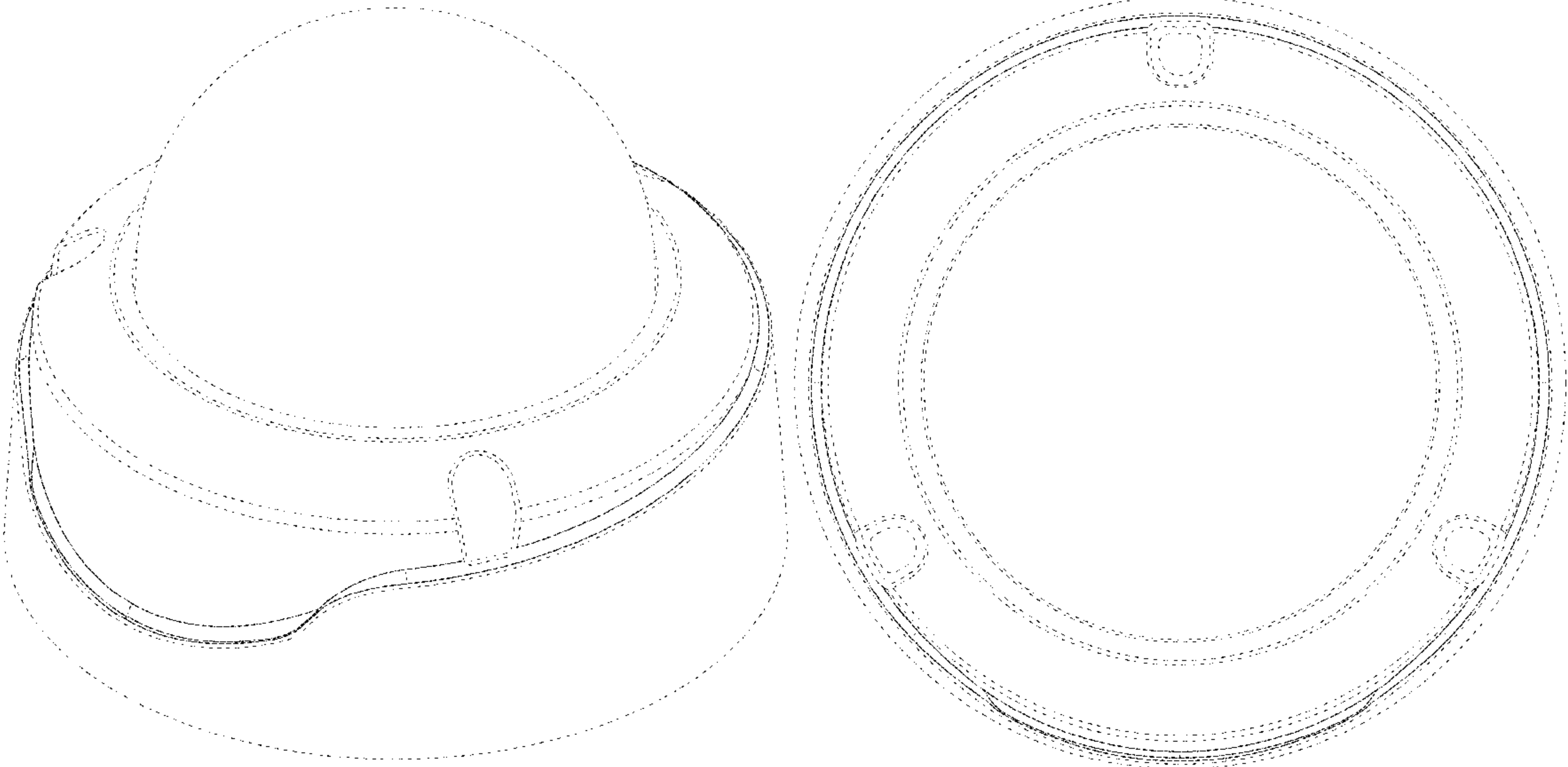
(57) CLAIM

The ornamental design for a surveillance camera, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a surveillance camera showing my new design;
FIG. 2 is a bottom, rear, left side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left side elevation view thereof;

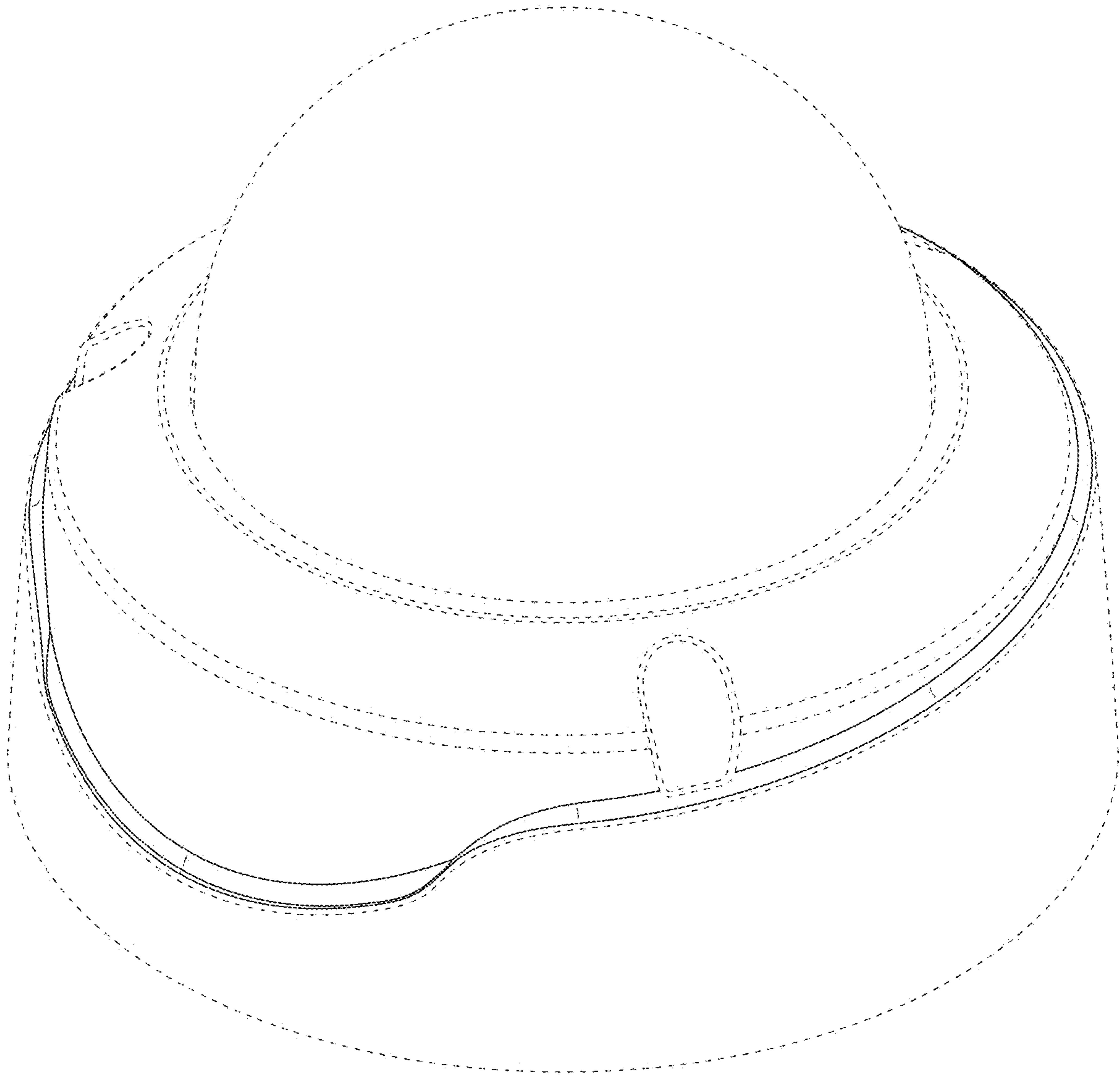

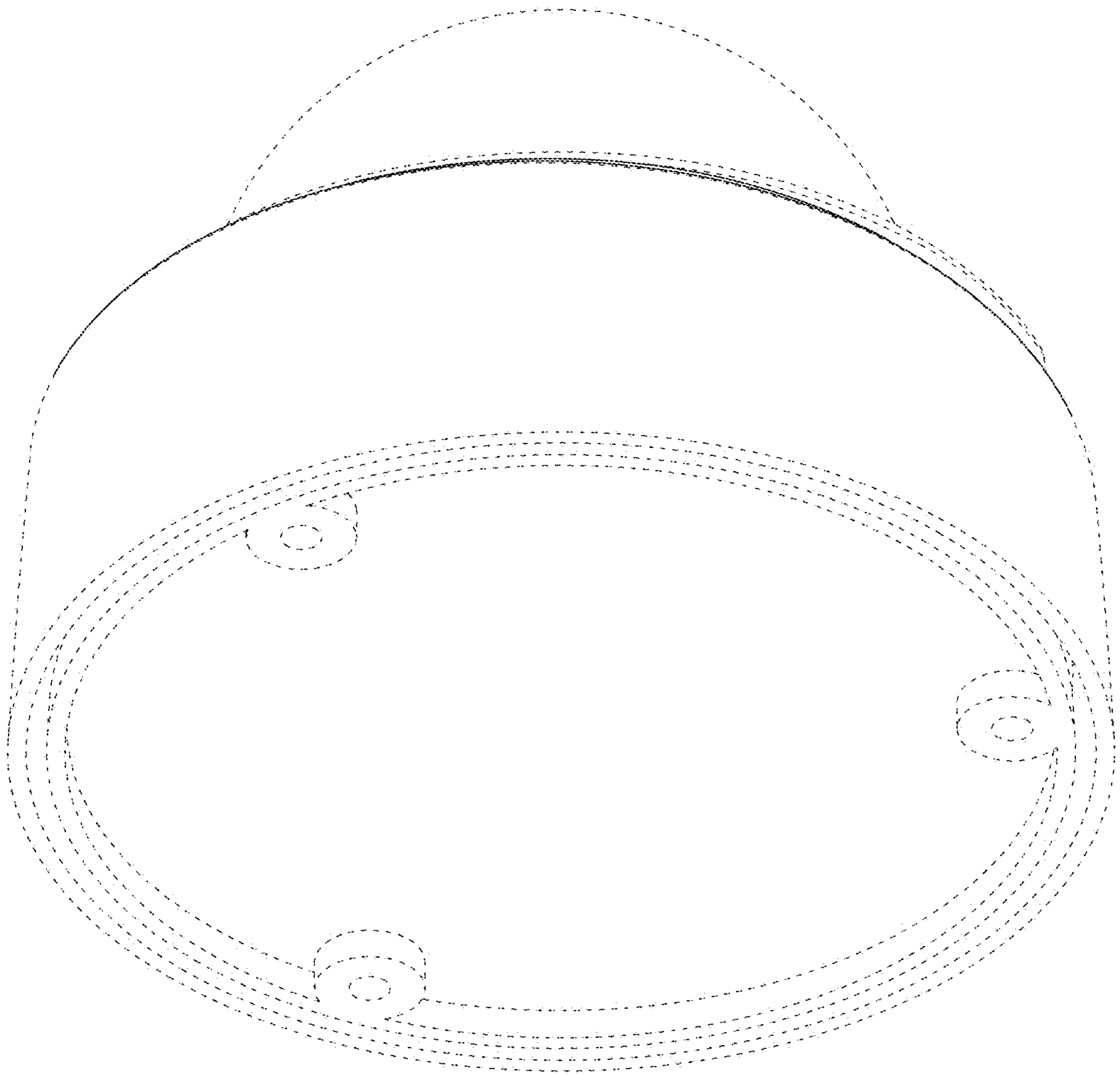

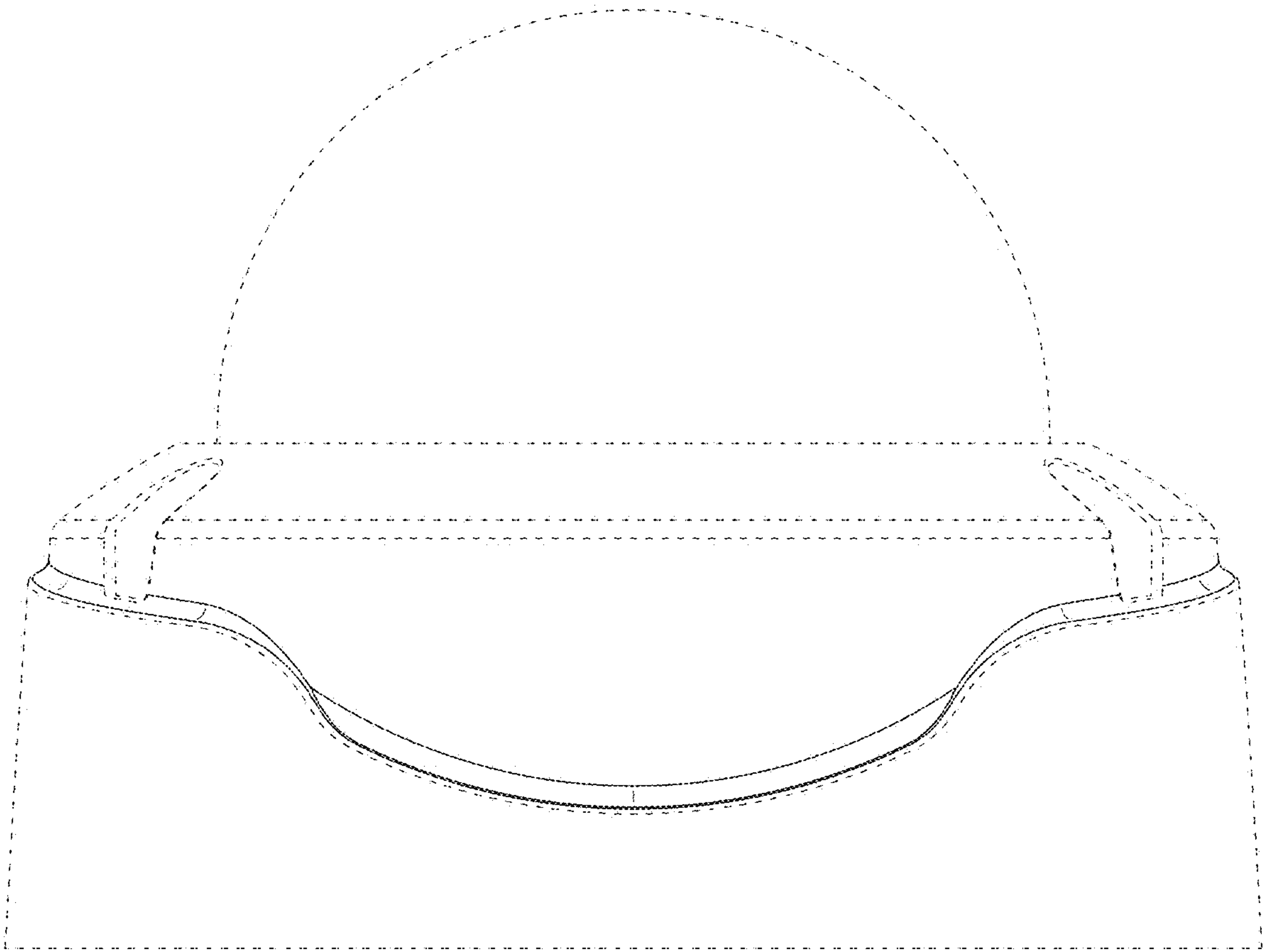

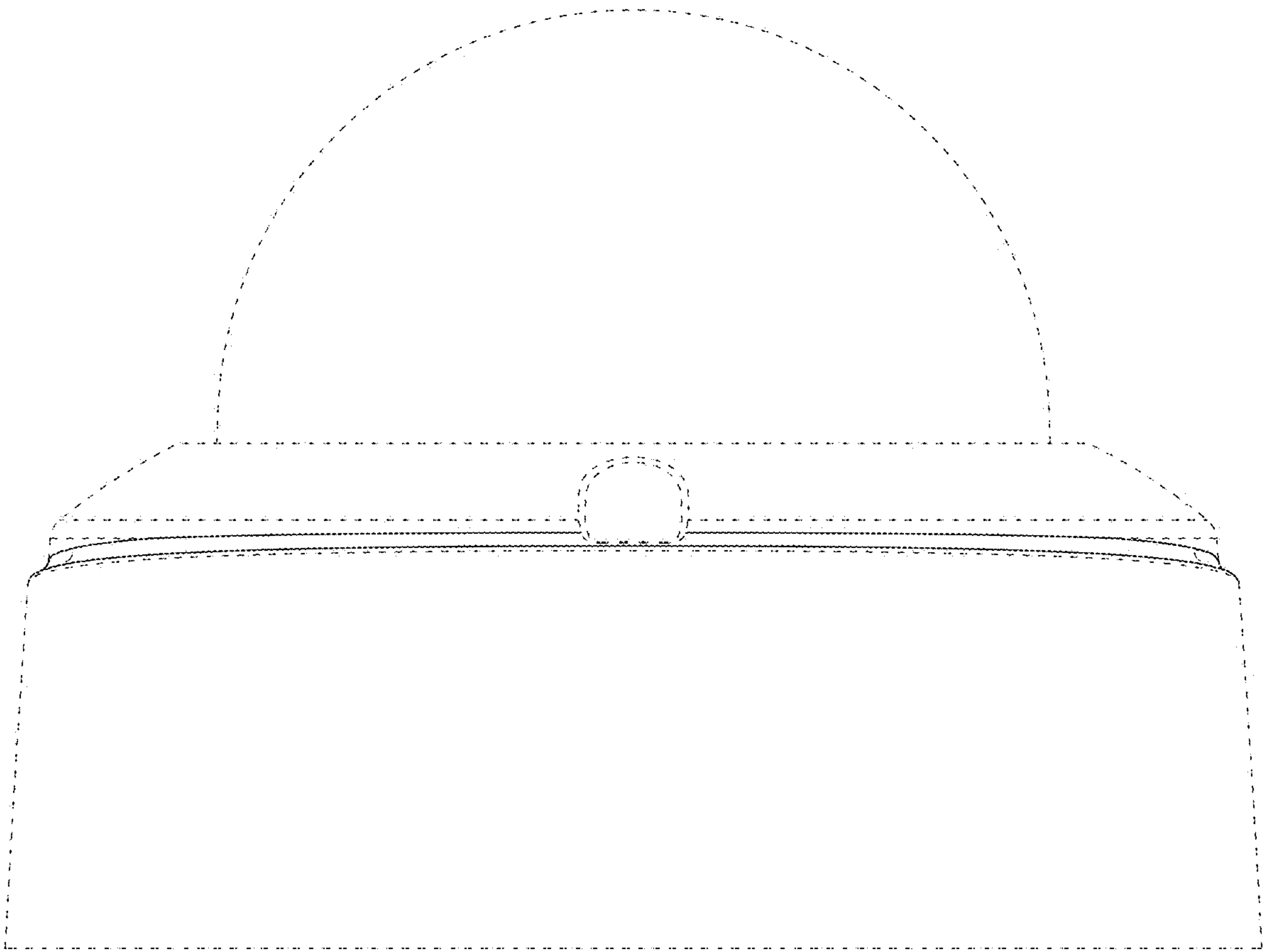

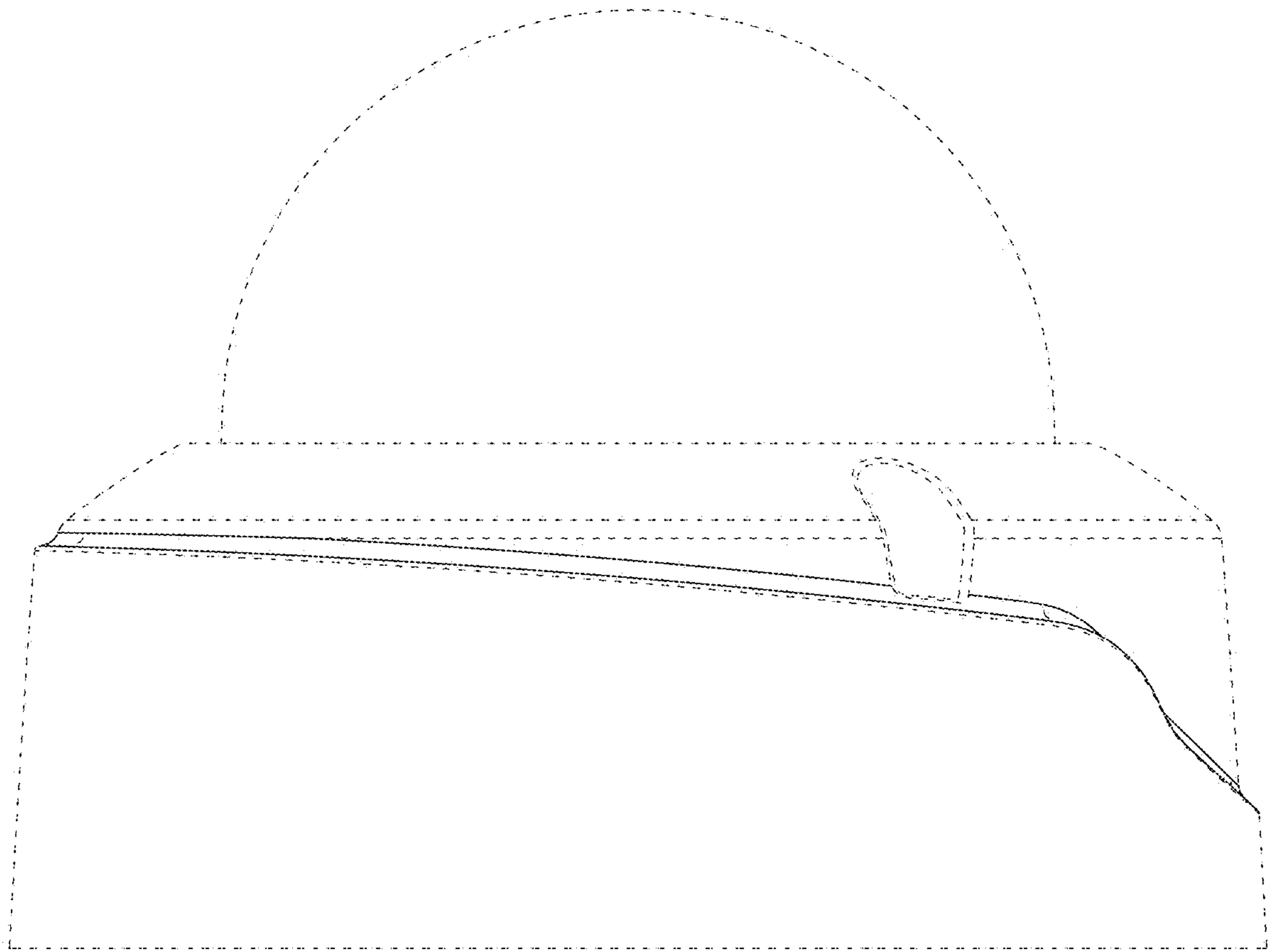

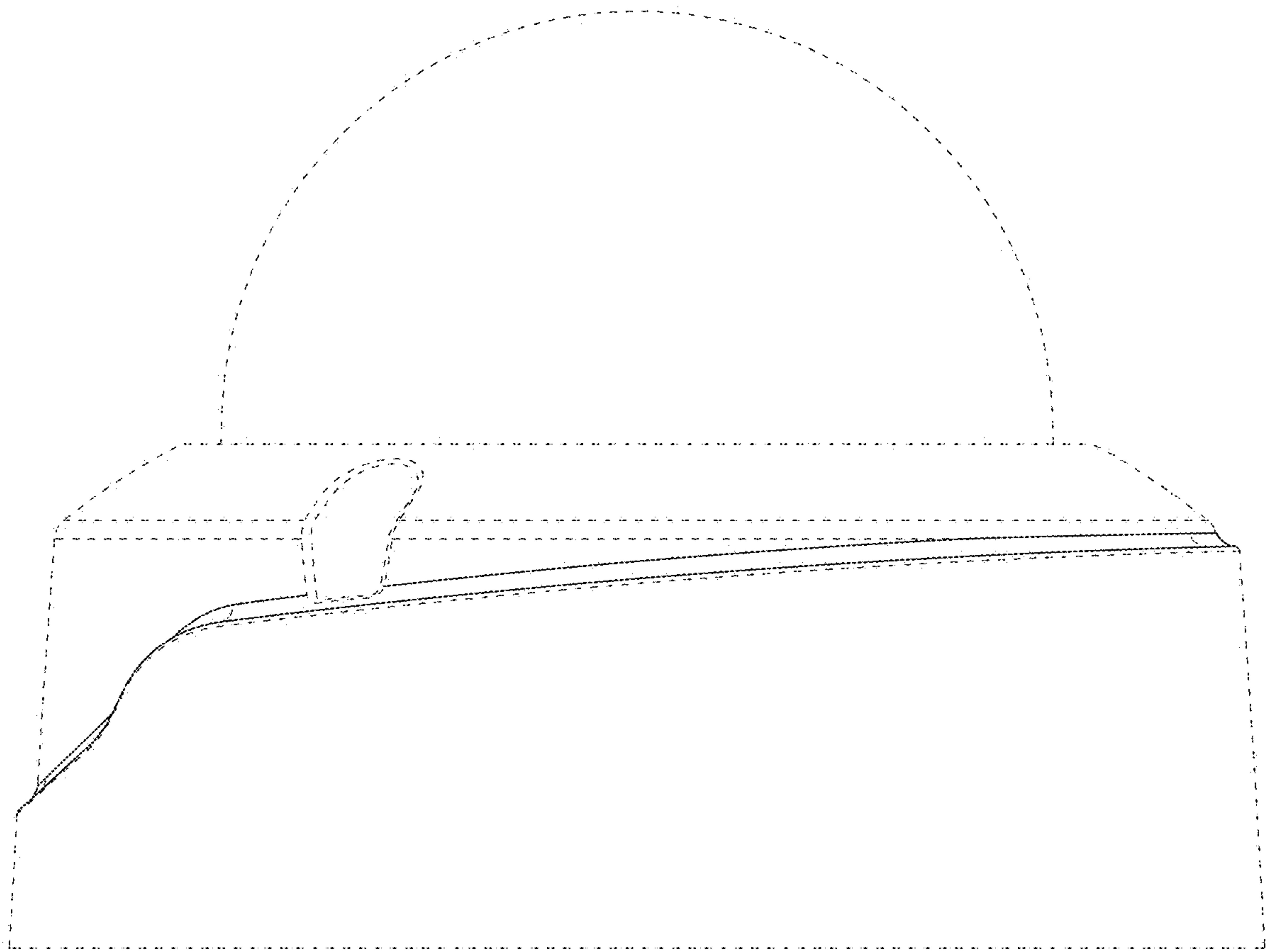

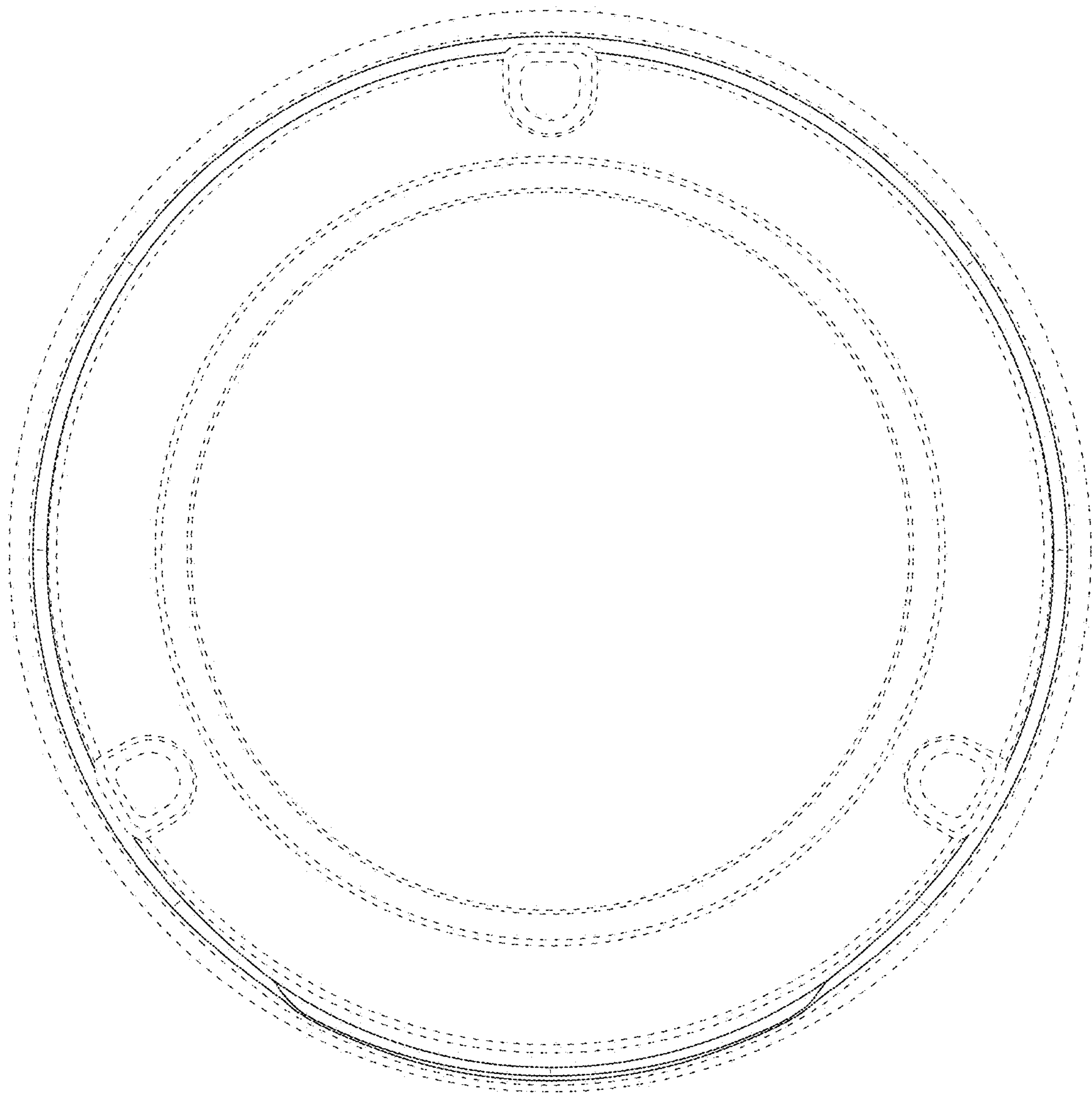

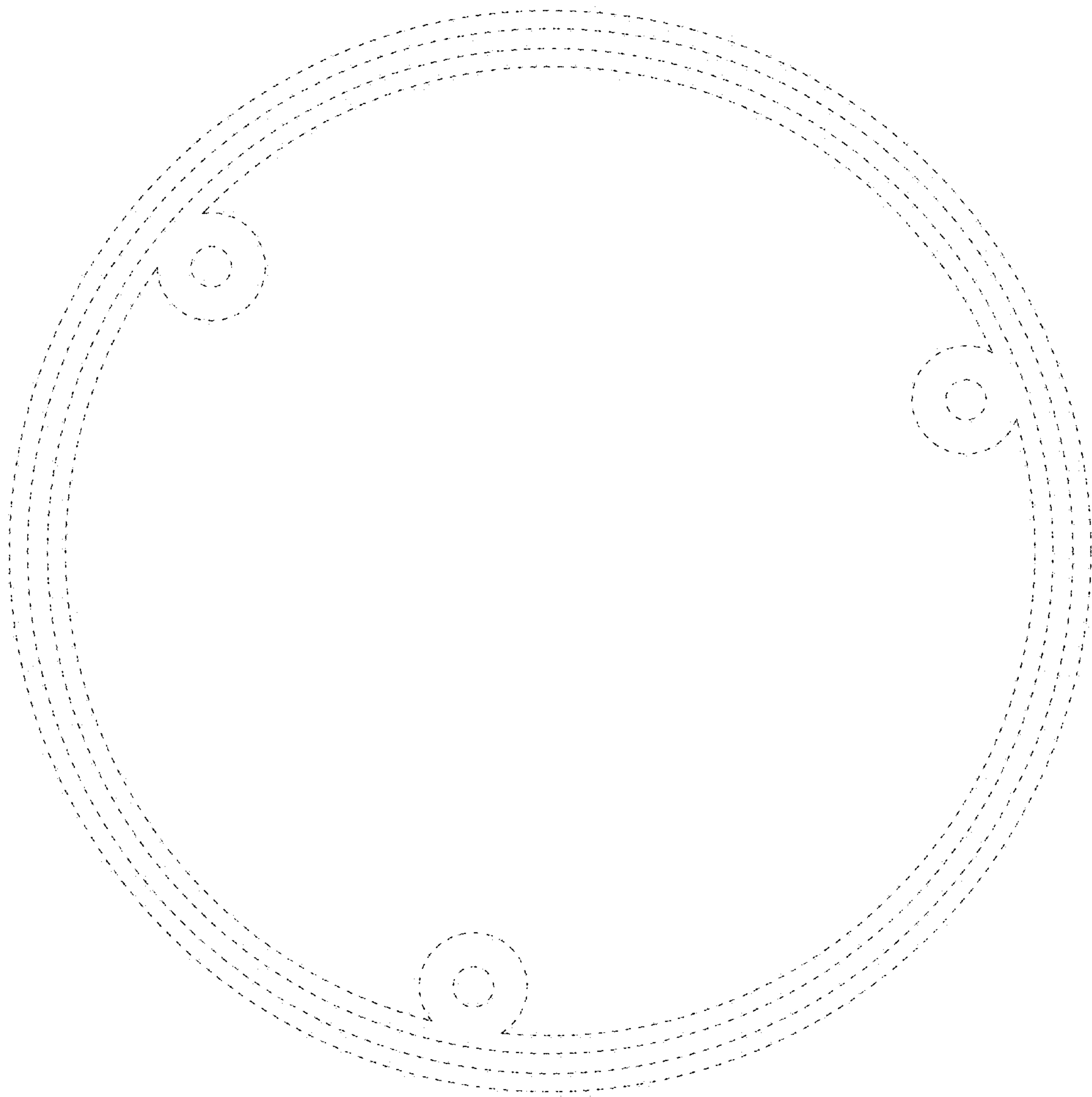
