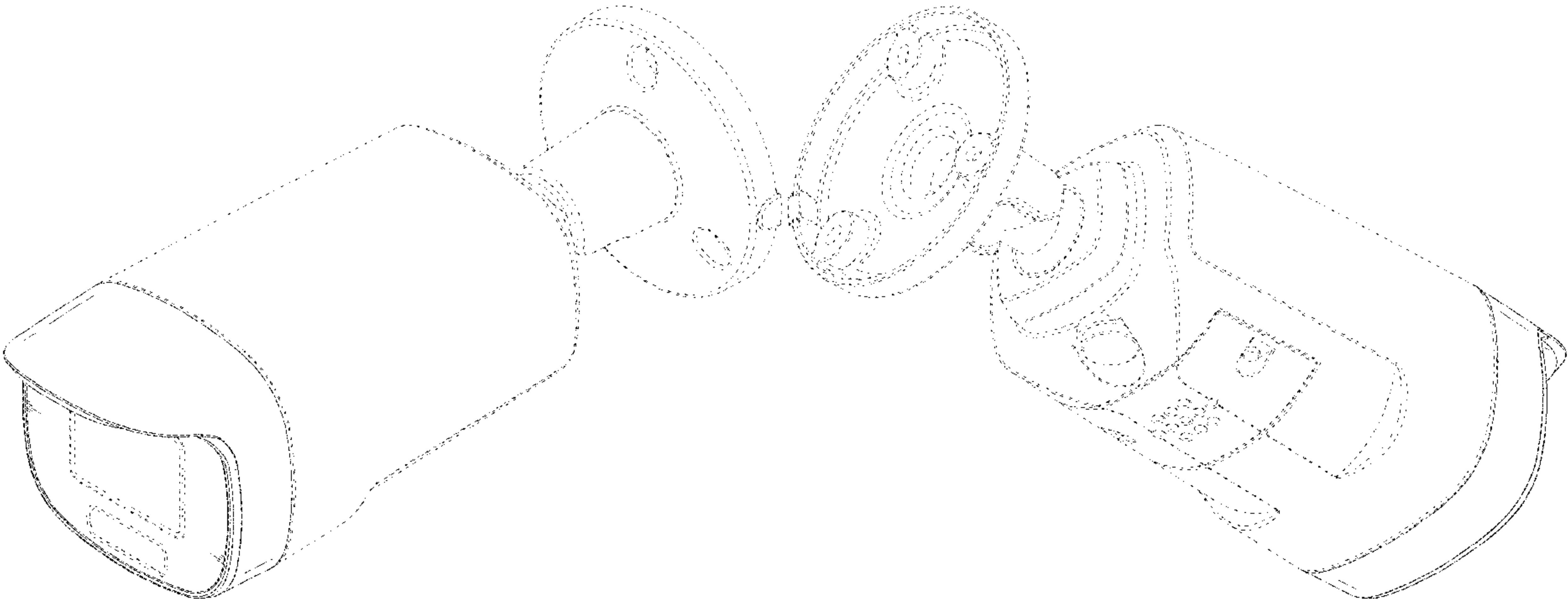
(57) CLAIM

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a surveillance camera showing my new design;

FIG. 4 is a rear elevation view thereof;

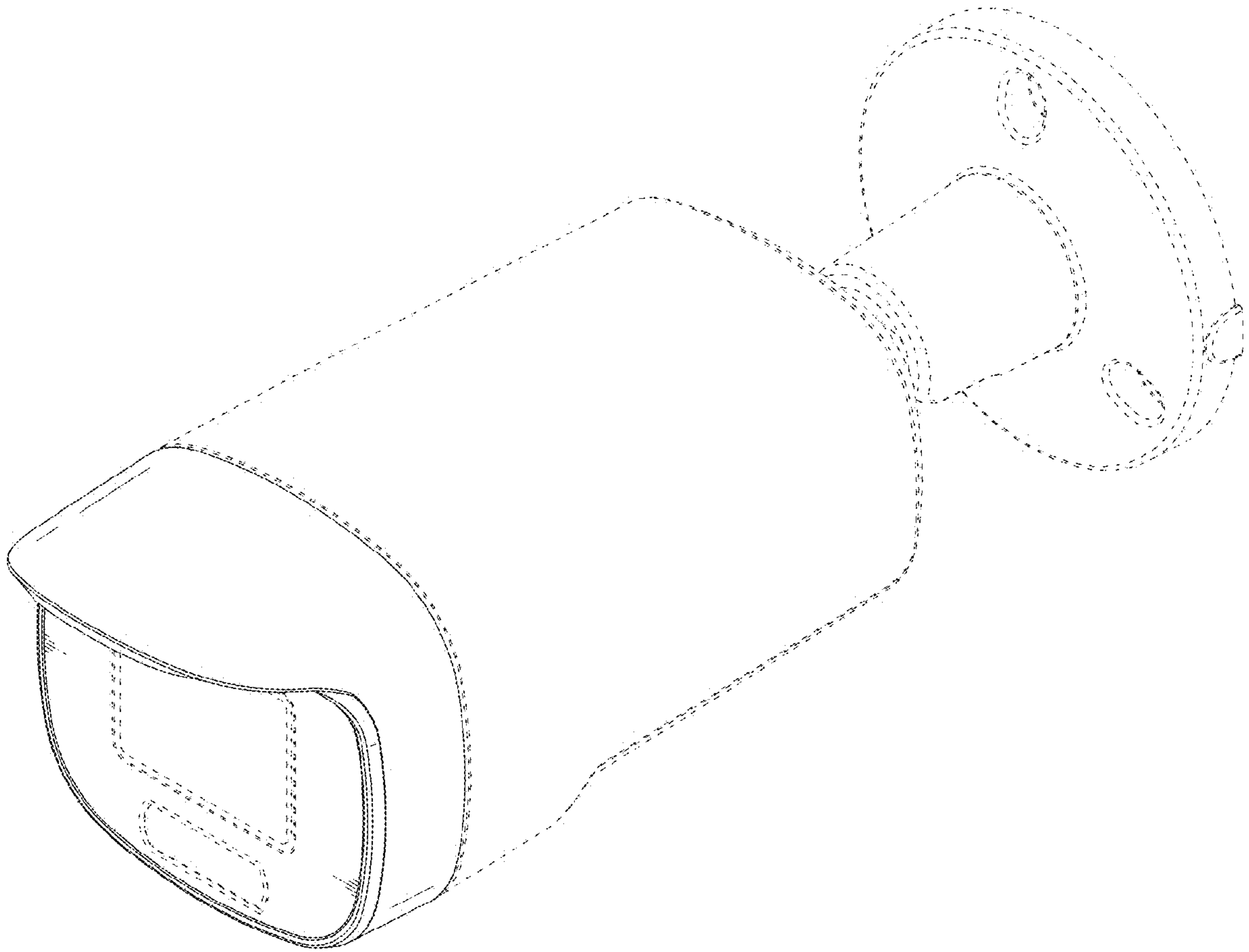

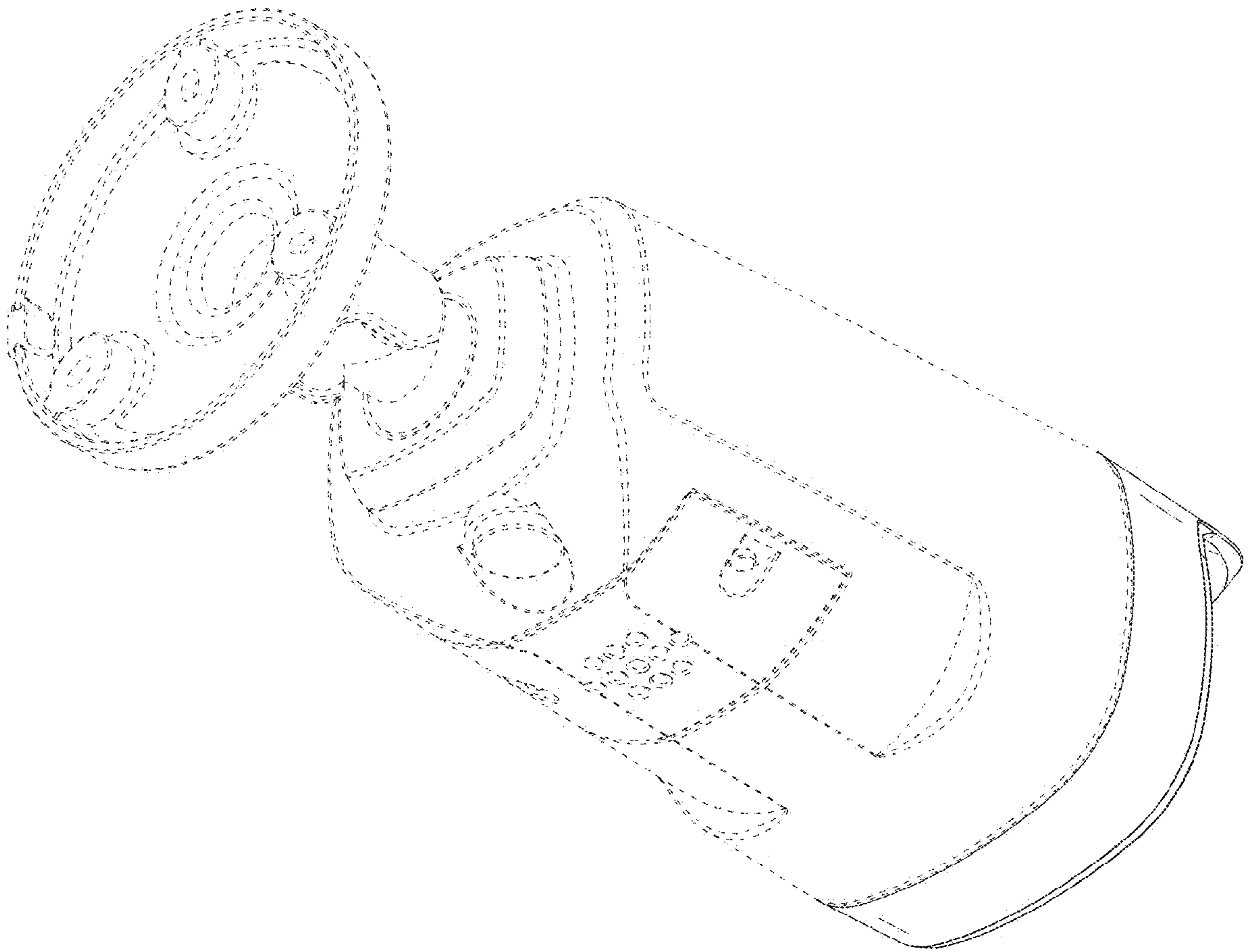

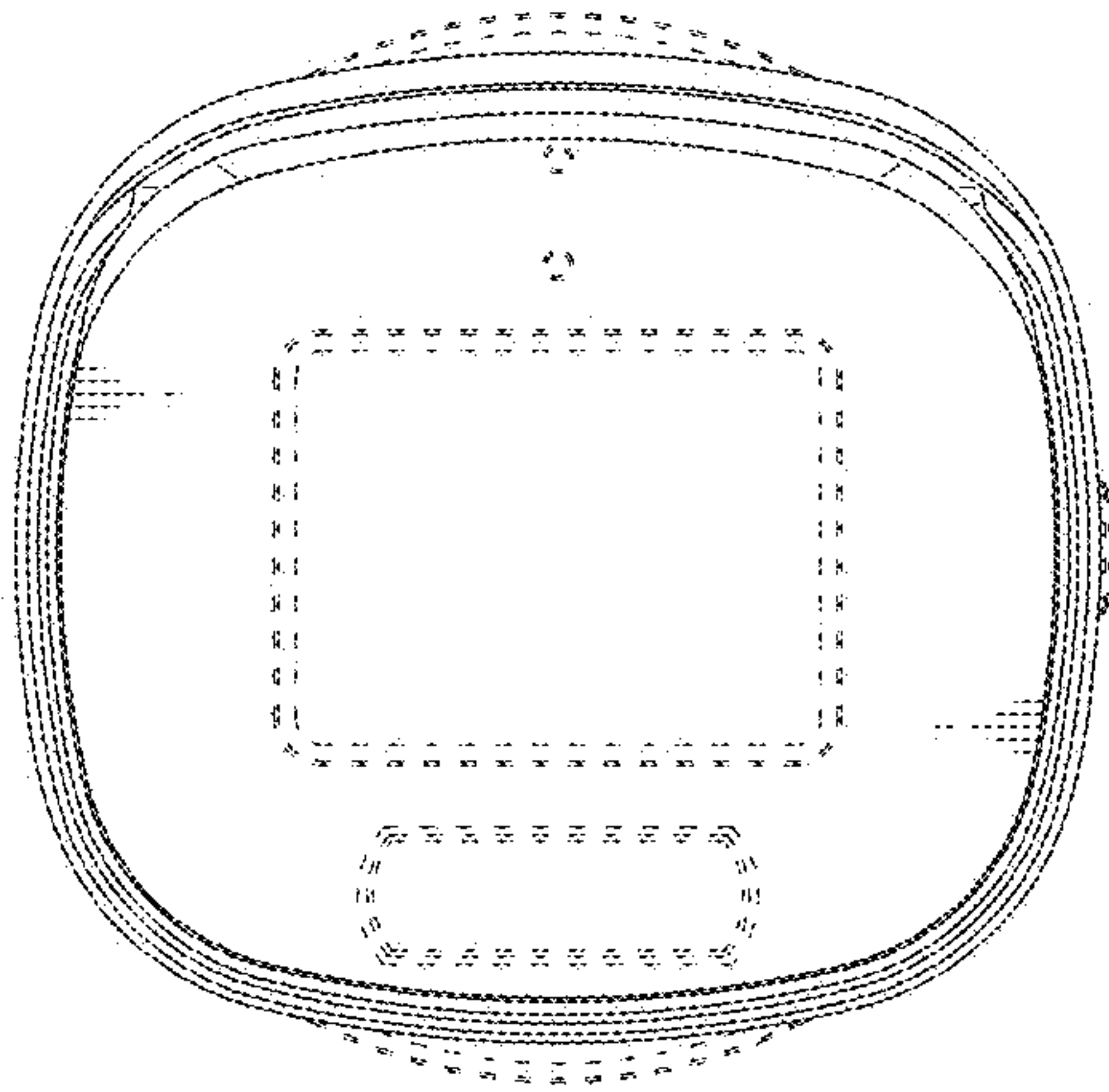

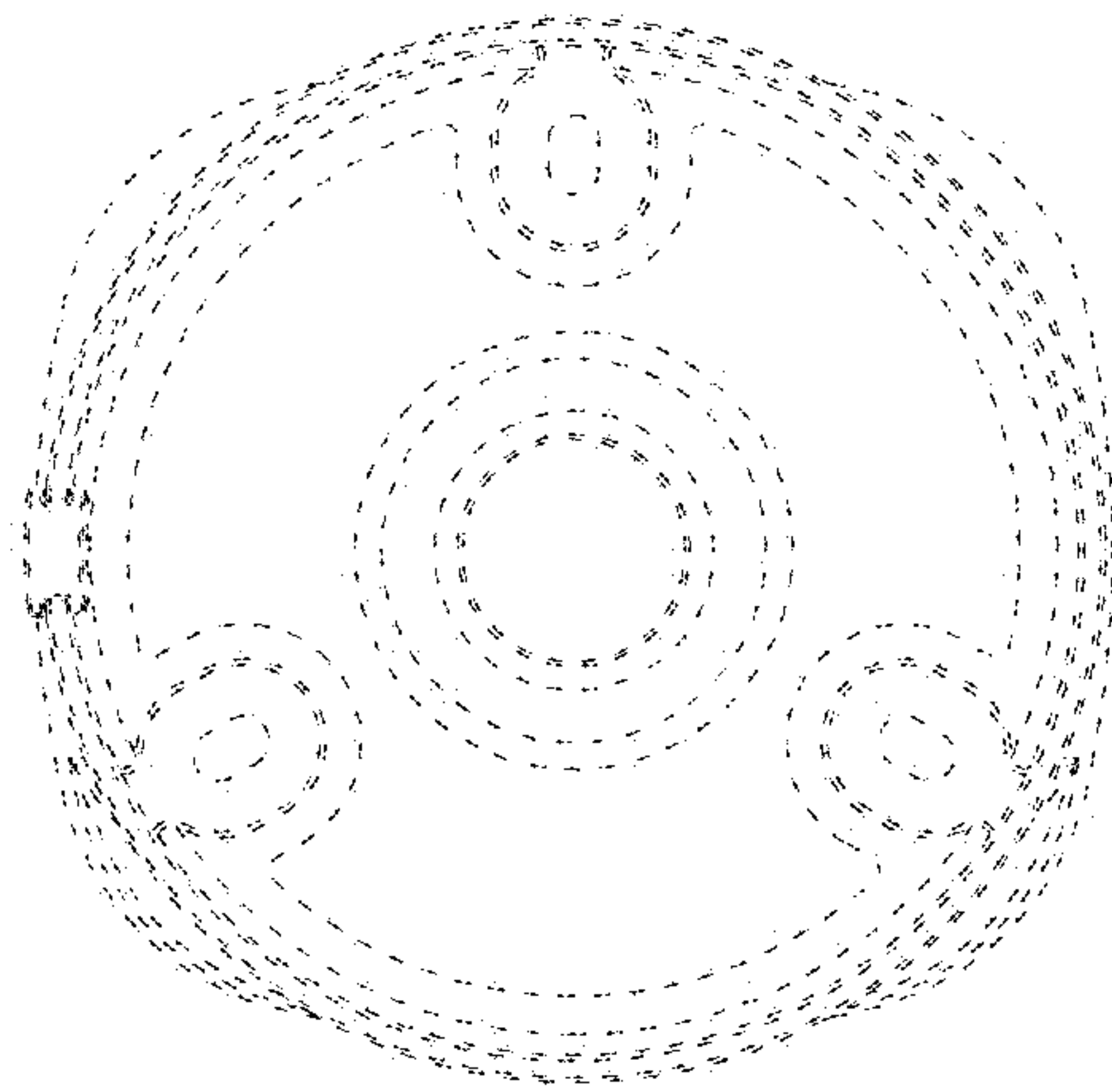

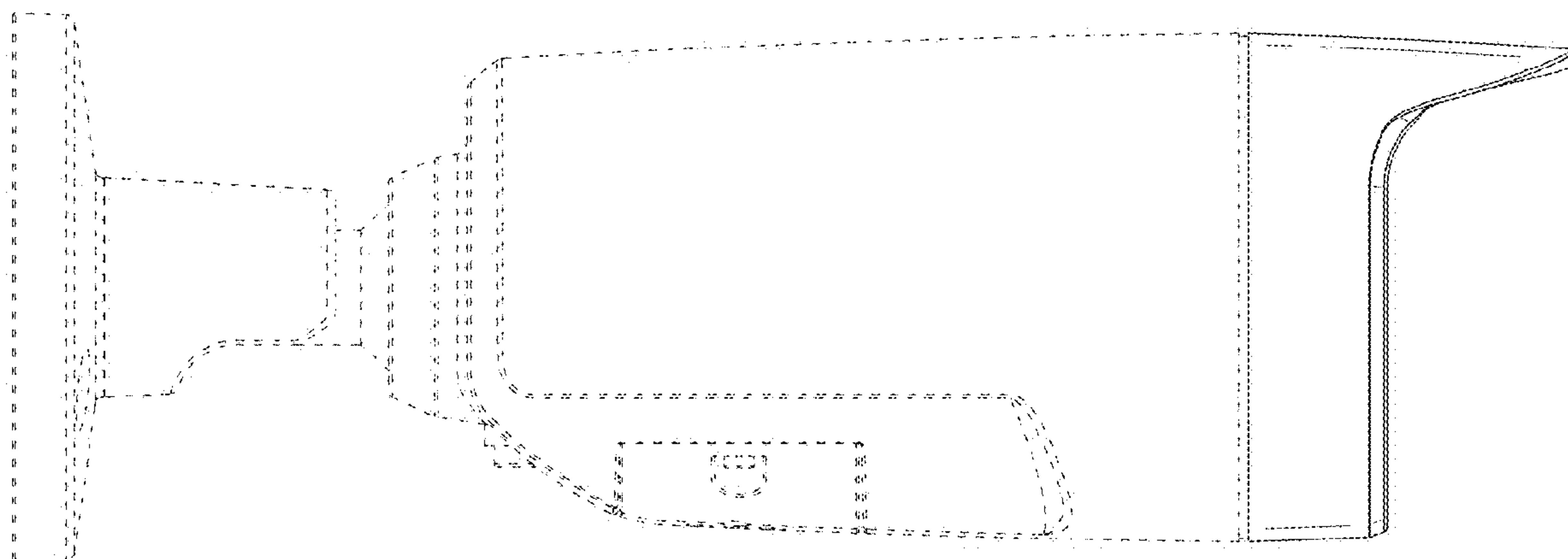

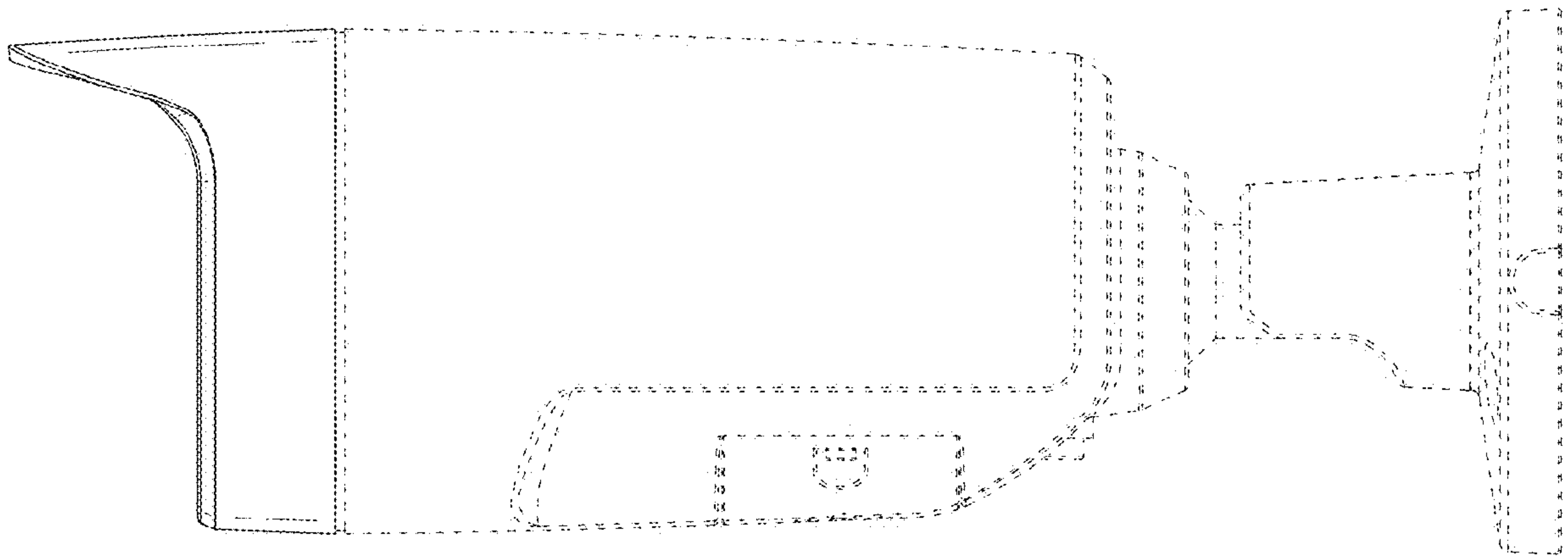

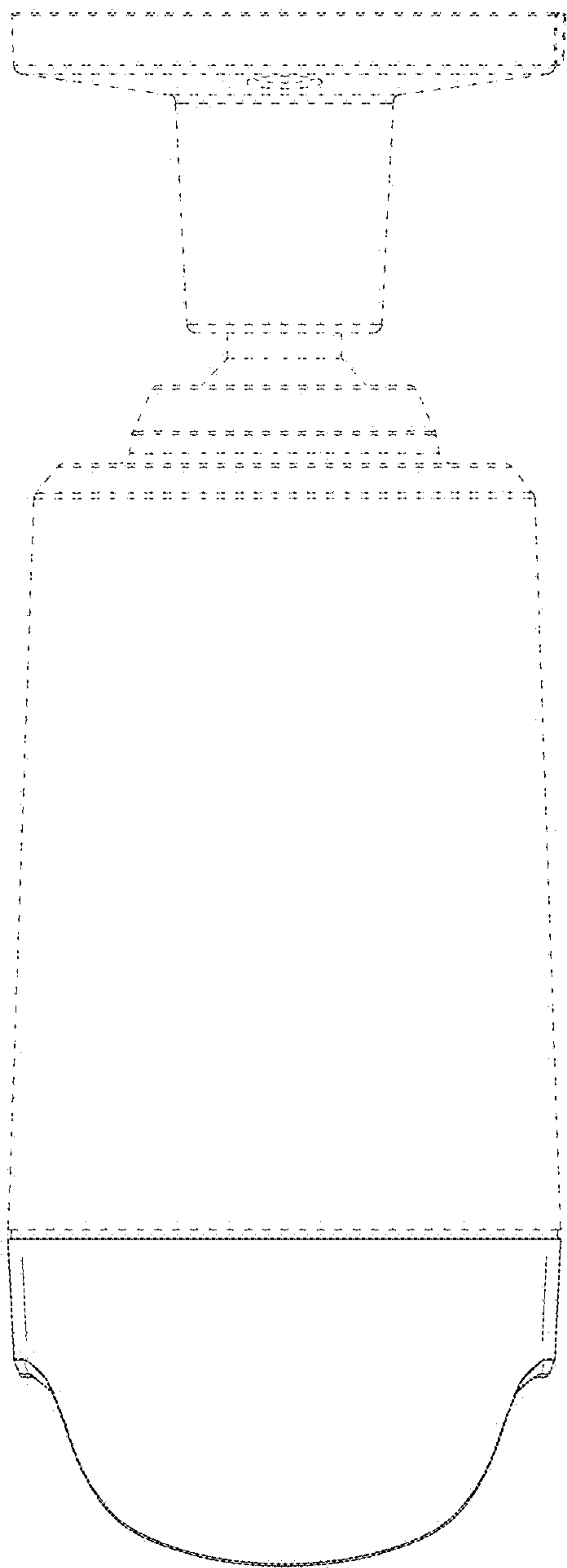

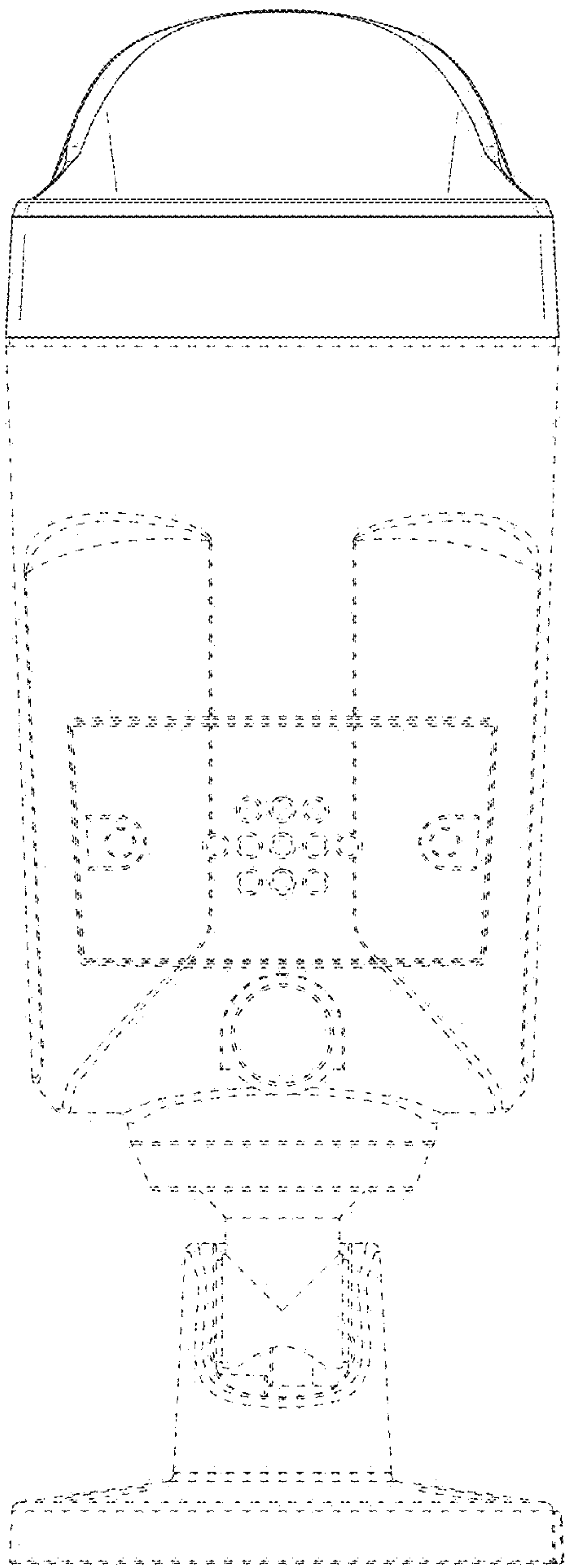
