DESCRIPTION

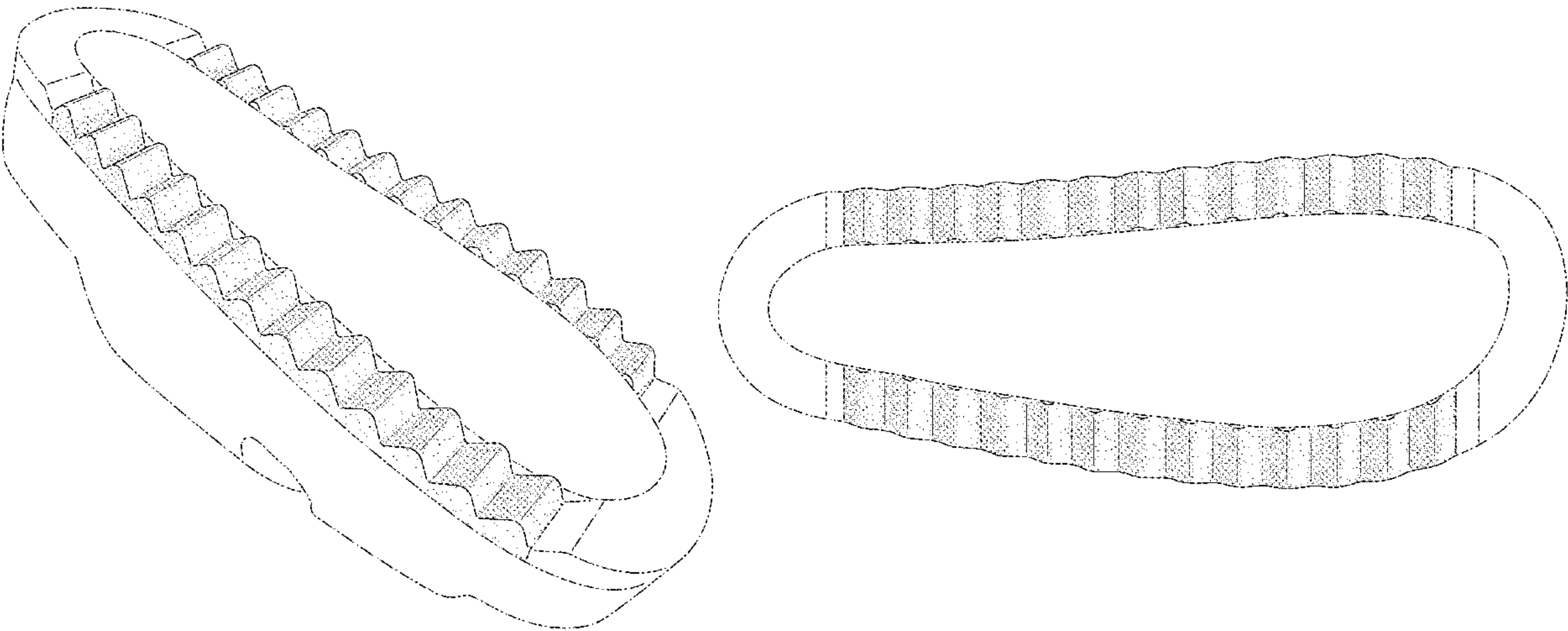
FIG. 1 is a bottom front perspective view of a shoe showing my new design;

FIG. 2 is a bottom view thereof; and,

FIG. 3 is a bottom rear perspective view thereof.

The unshaded, internally facing surfaces of the tread rows form no part of the claimed design. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

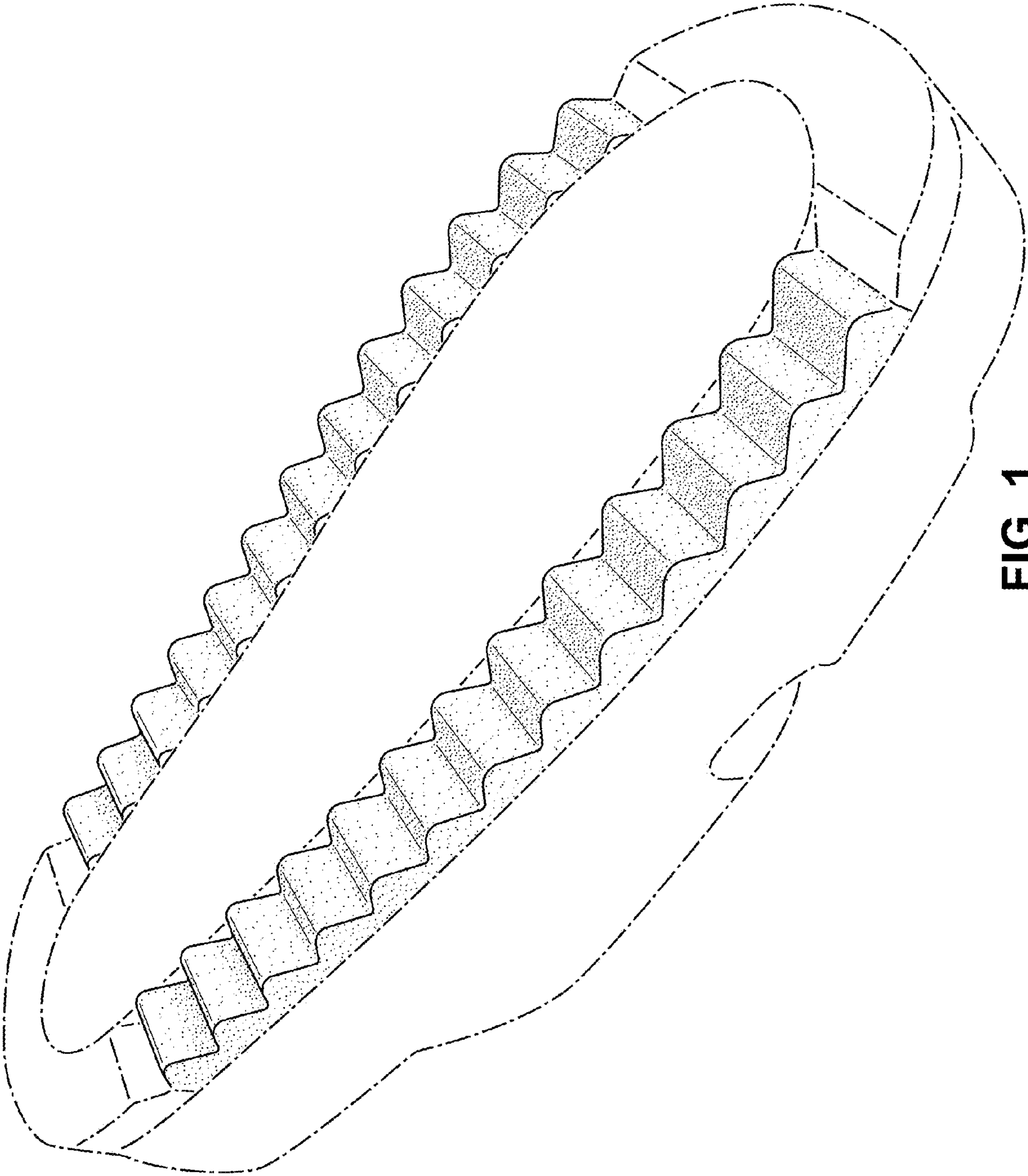

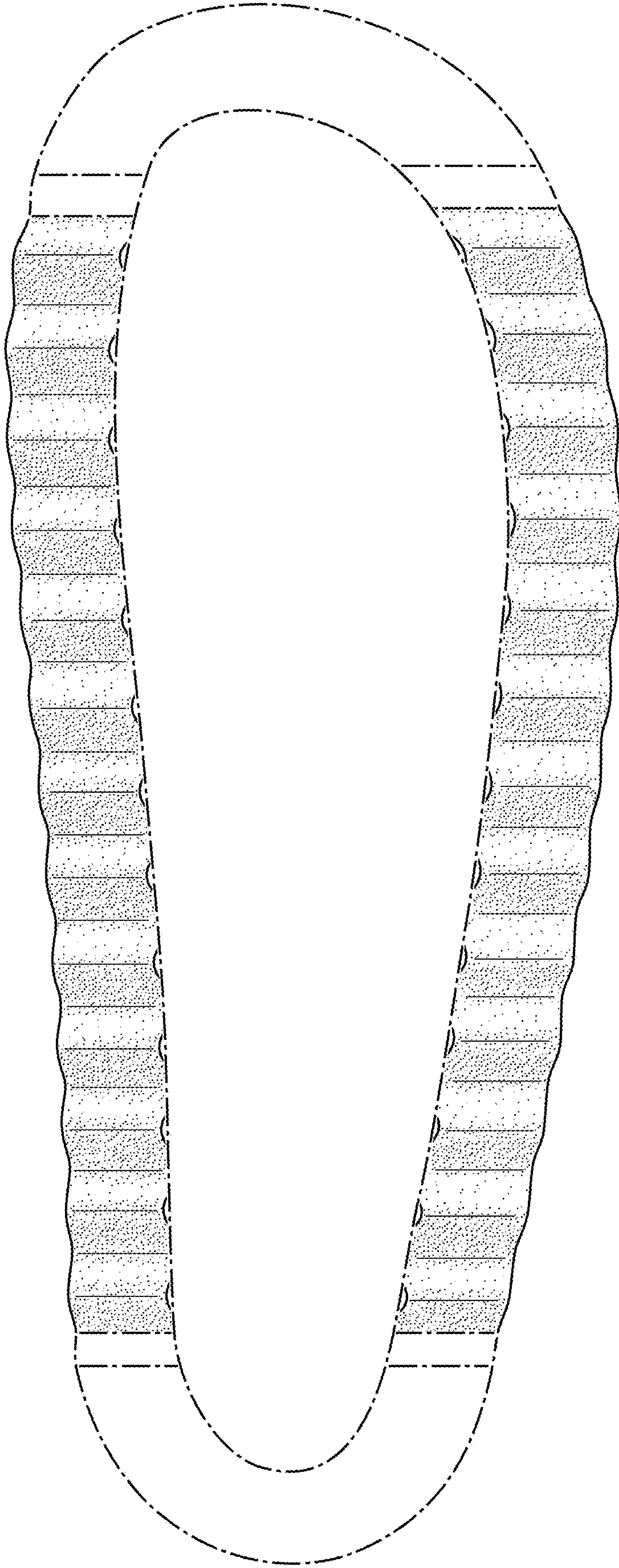

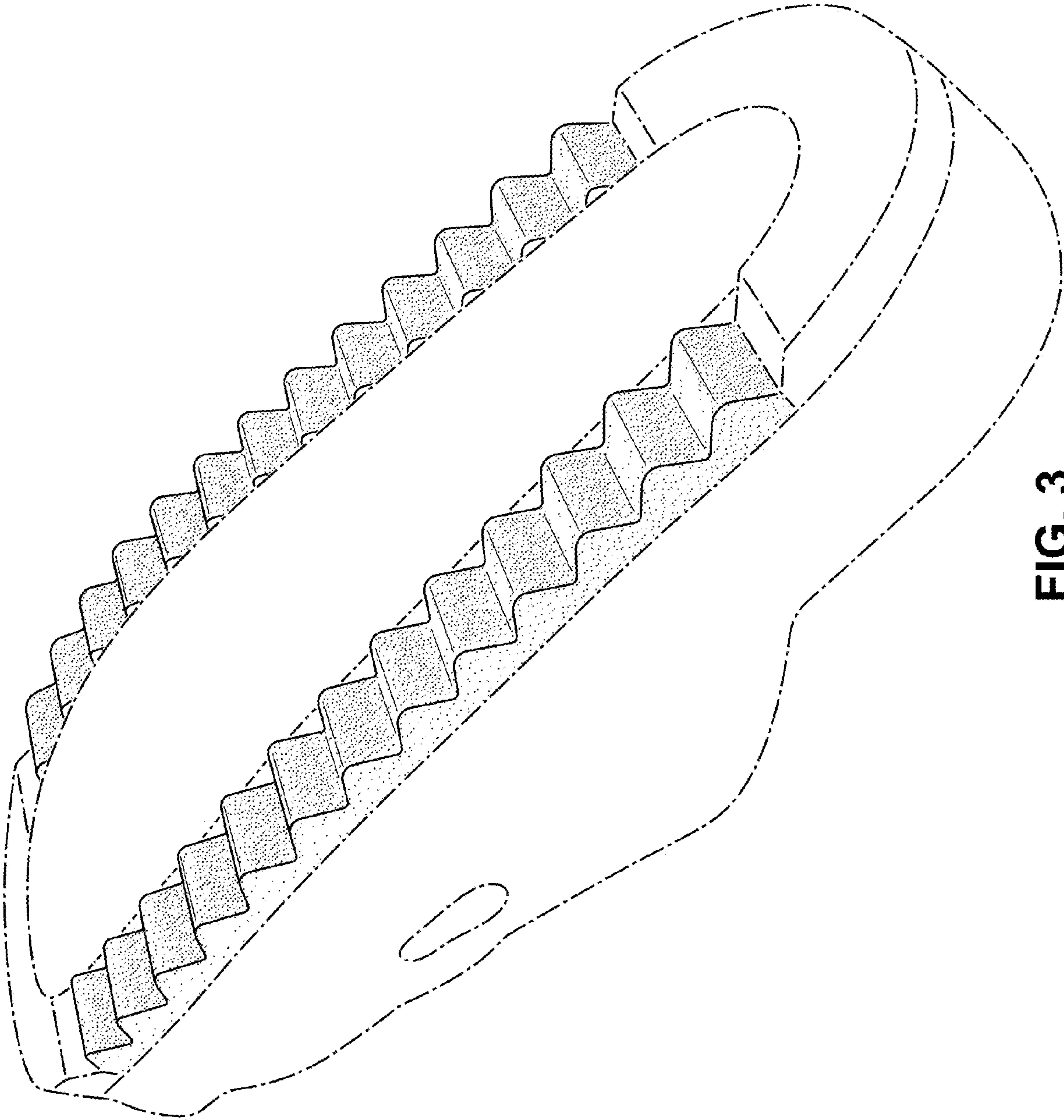
