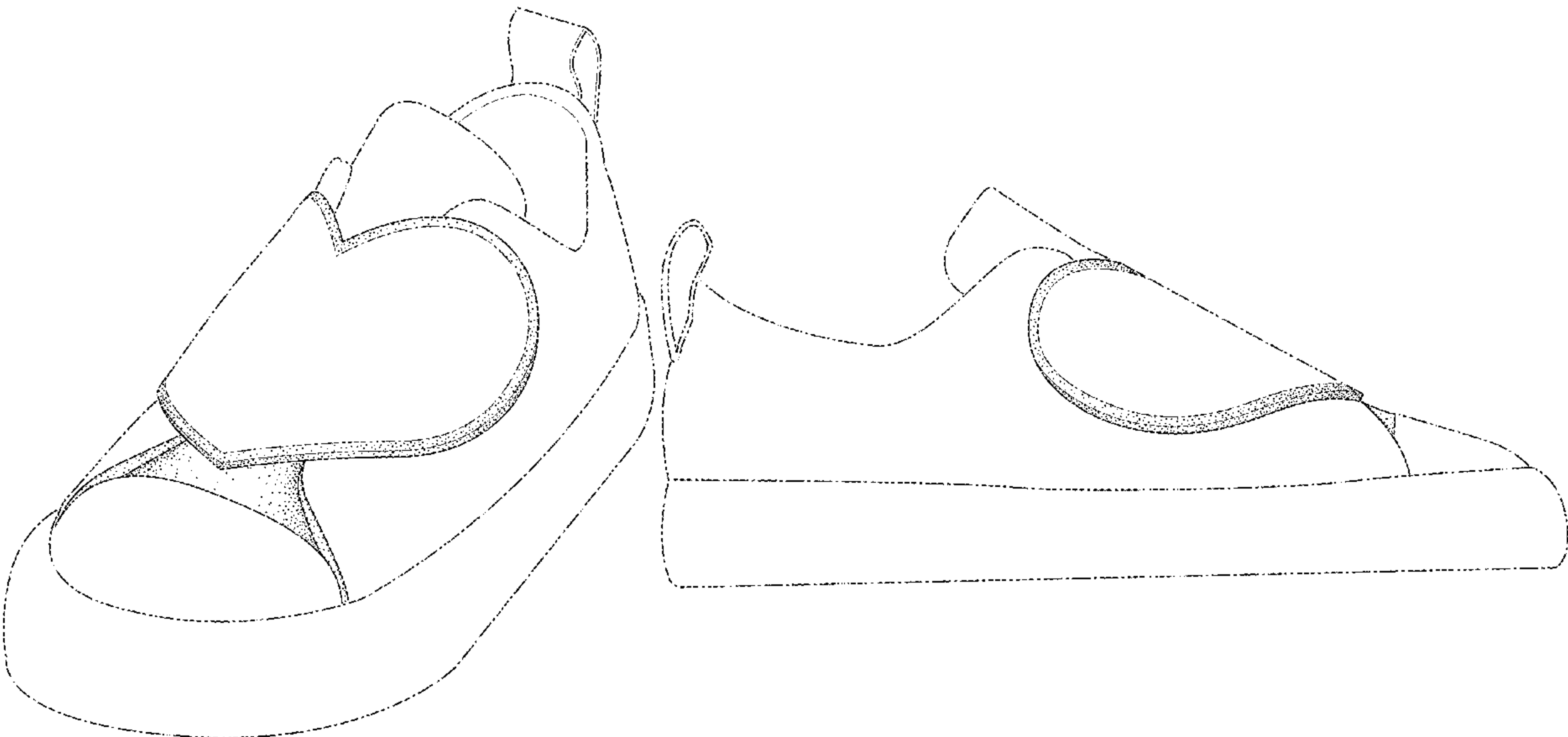
(57) **CLAIM**

The ornamental design for a shoe as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing our new design;
FIG. 2 is a side view thereof;
FIG. 3 is an opposite side front perspective view thereof;
and,
FIG. 4 is an opposite side view thereof.
The broken lines immediately adjacent to the internal perimeter of the shaded area define the internal bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

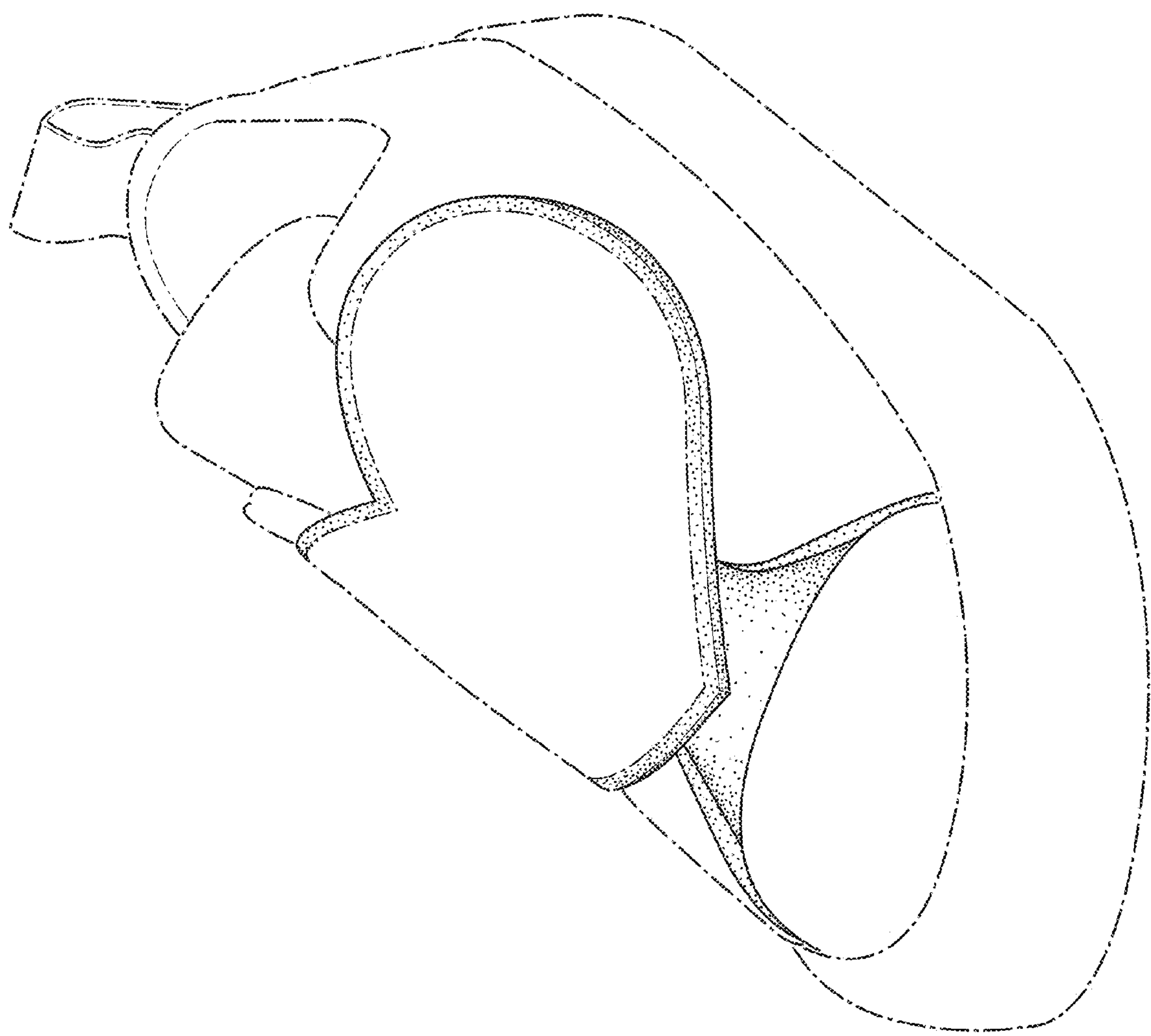

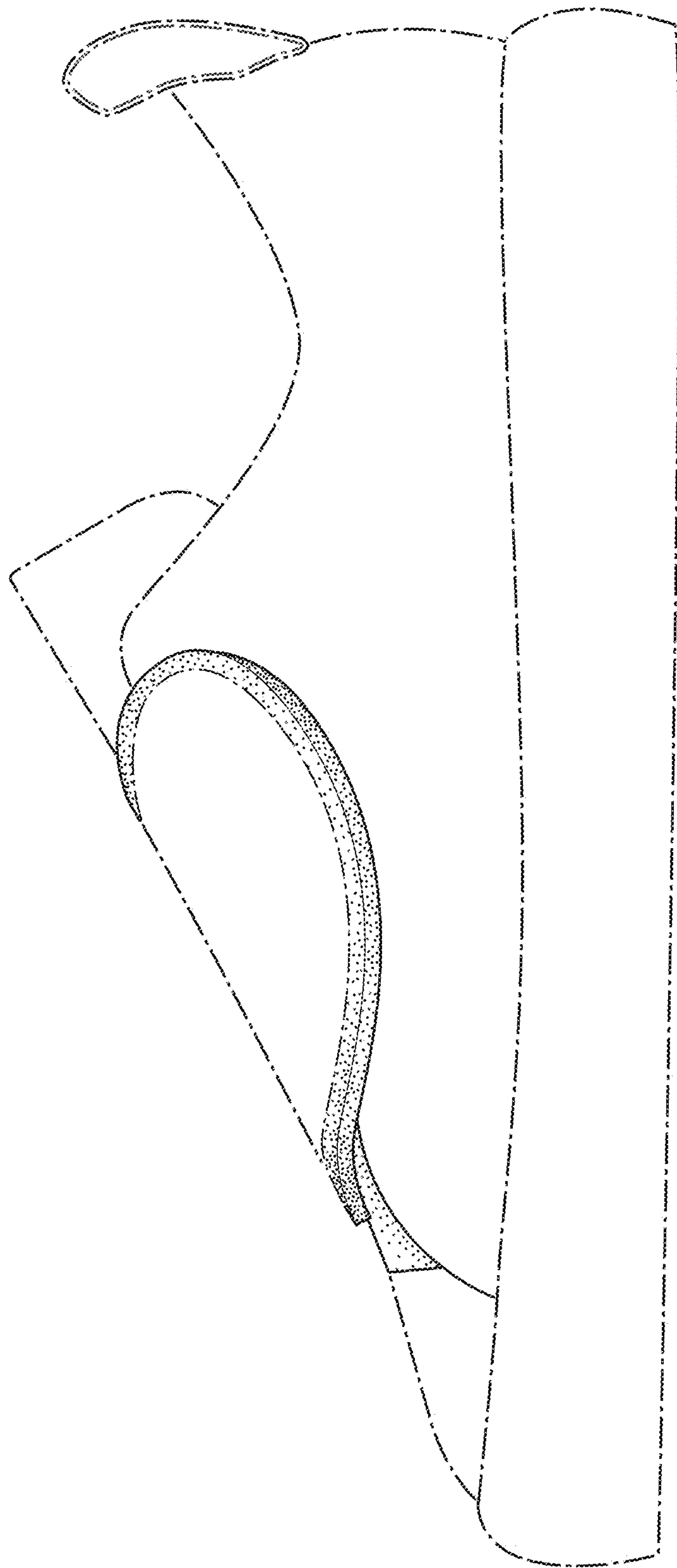

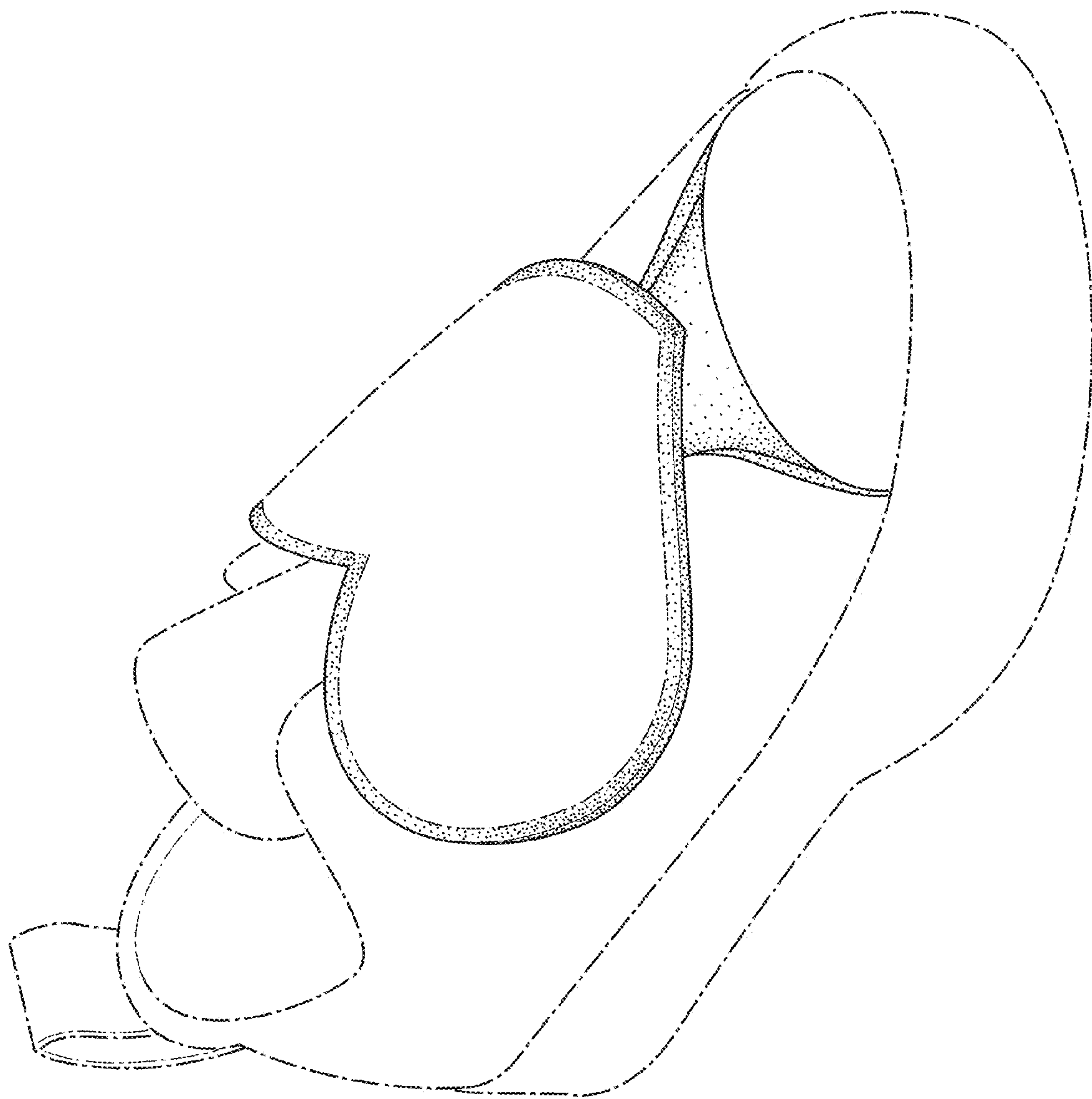

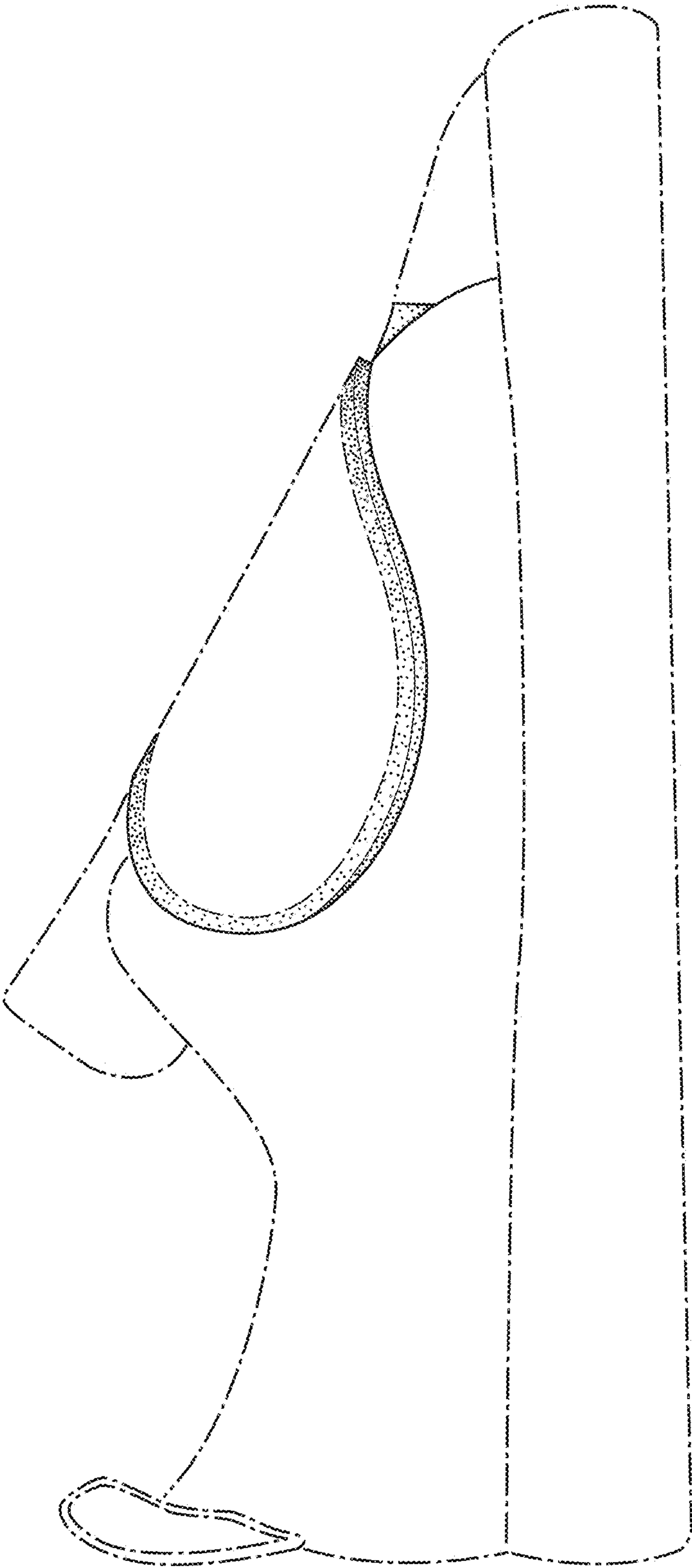
