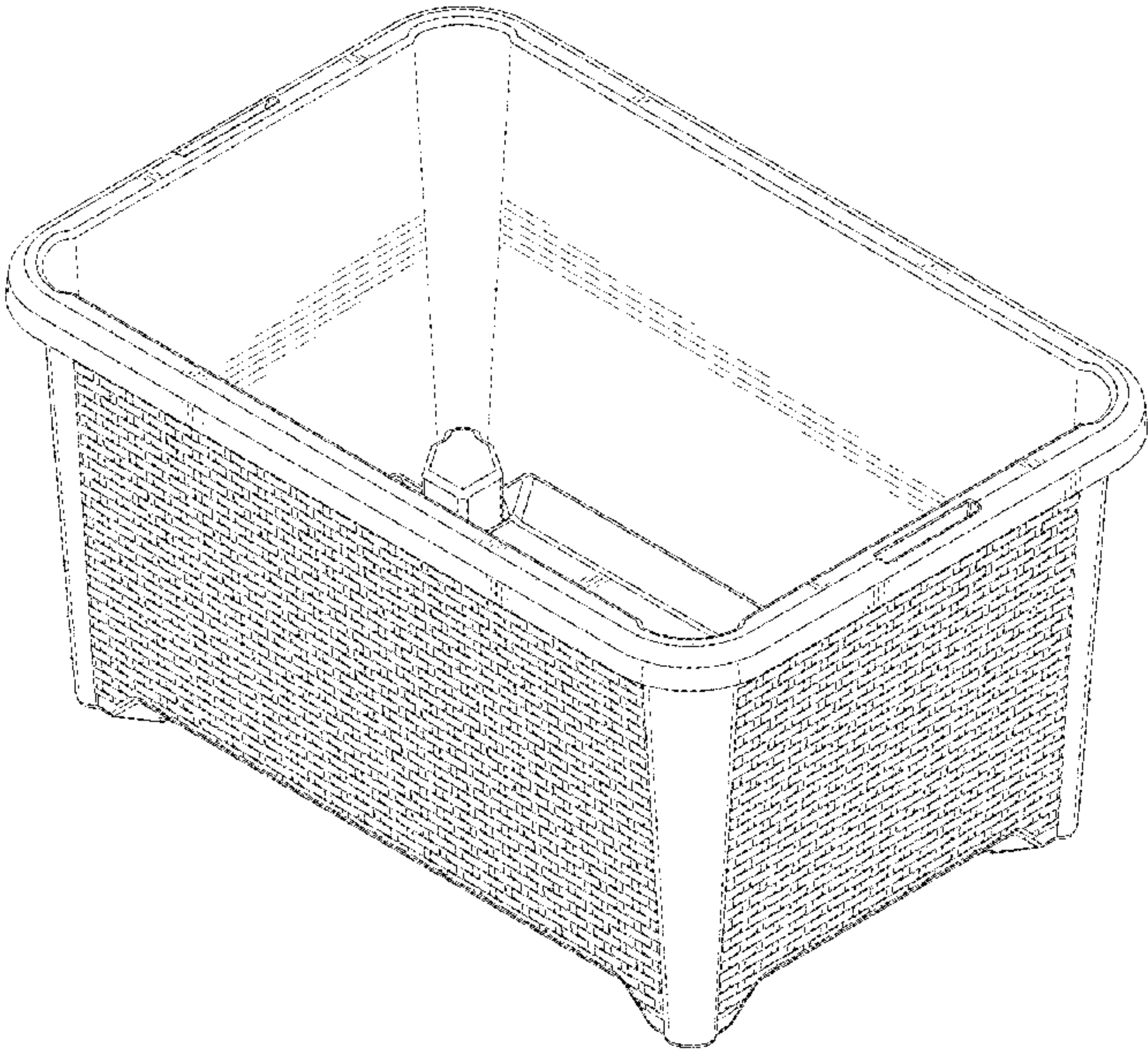
(57) CLAIM

The ornamental design for a container for outdoor patio box with wicker pattern as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a container for outdoor patio box with wicker pattern;
FIG. 2 is a bottom perspective view thereof
FIG. 3 is a front elevational view thereof, a rear elevational view is not shown because it is a mirror image of the front elevational view;
FIG. 4 is a right-side elevational view thereof, a left-side elevational view is not shown because it is a mirror image the right-side elevational view;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is another bottom perspective view thereof.
The dash-dash broken lines shown in the drawings depict portions of the container for outdoor patio box with wicker pattern that form no part of the claimed design.

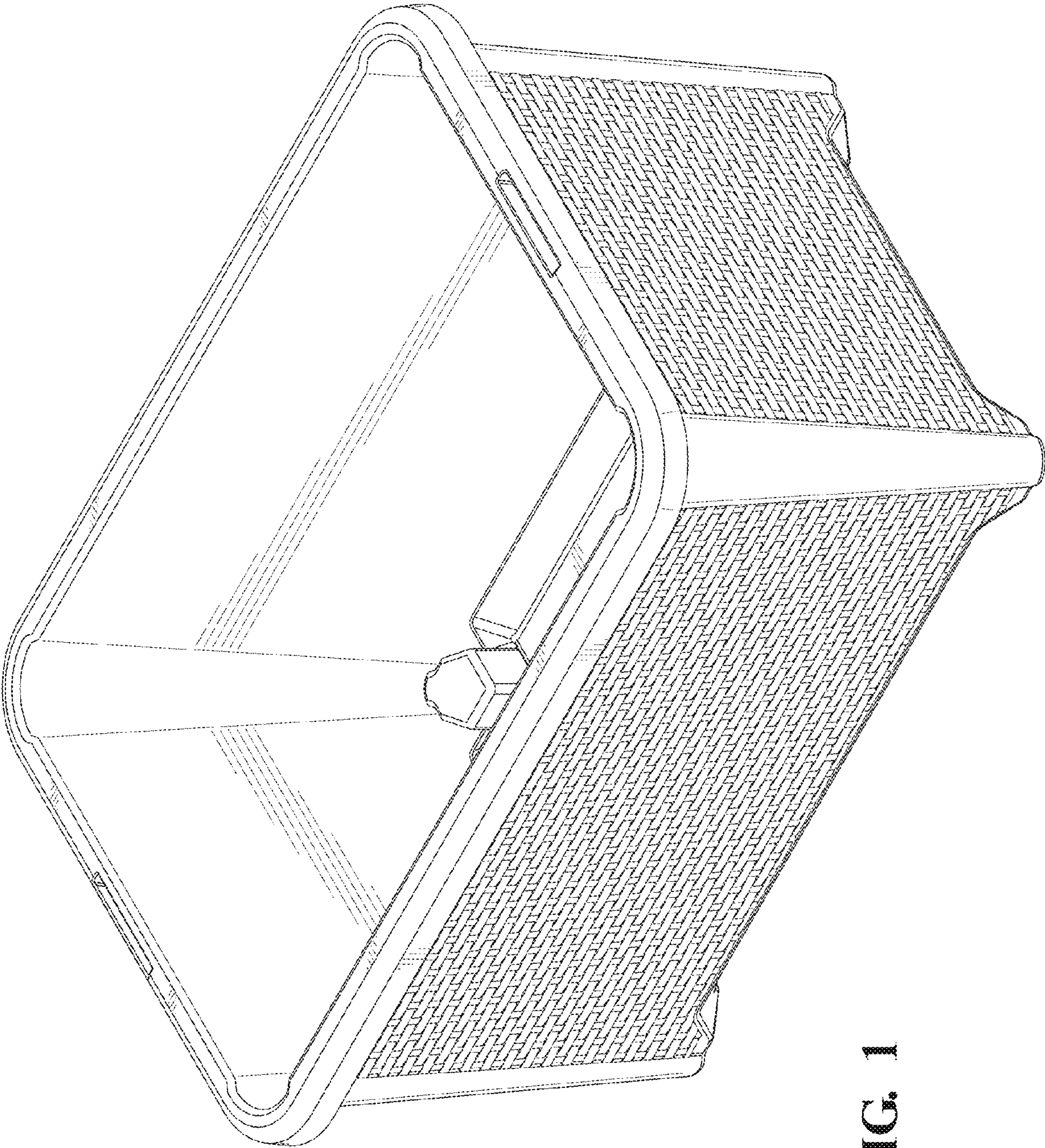

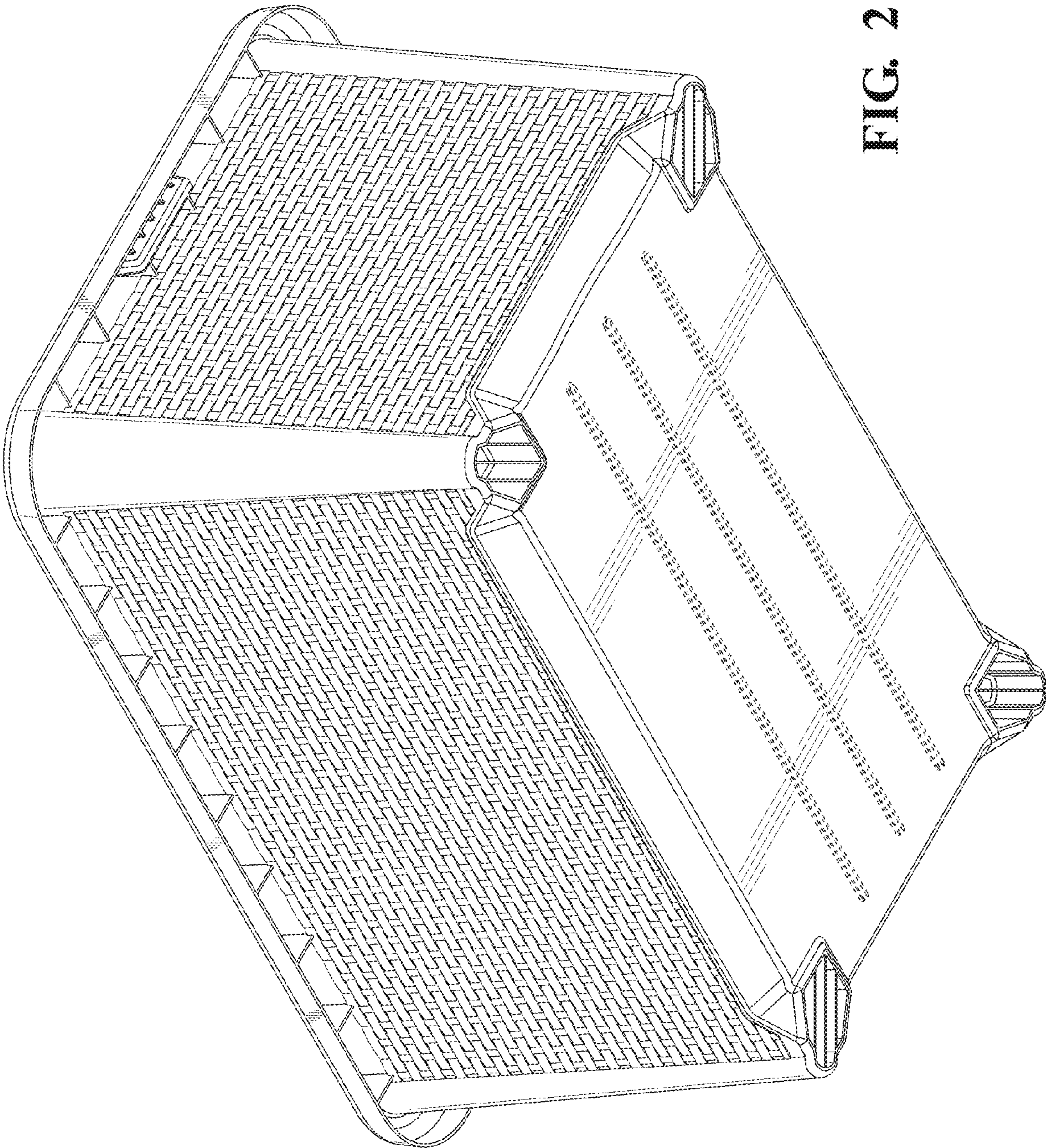

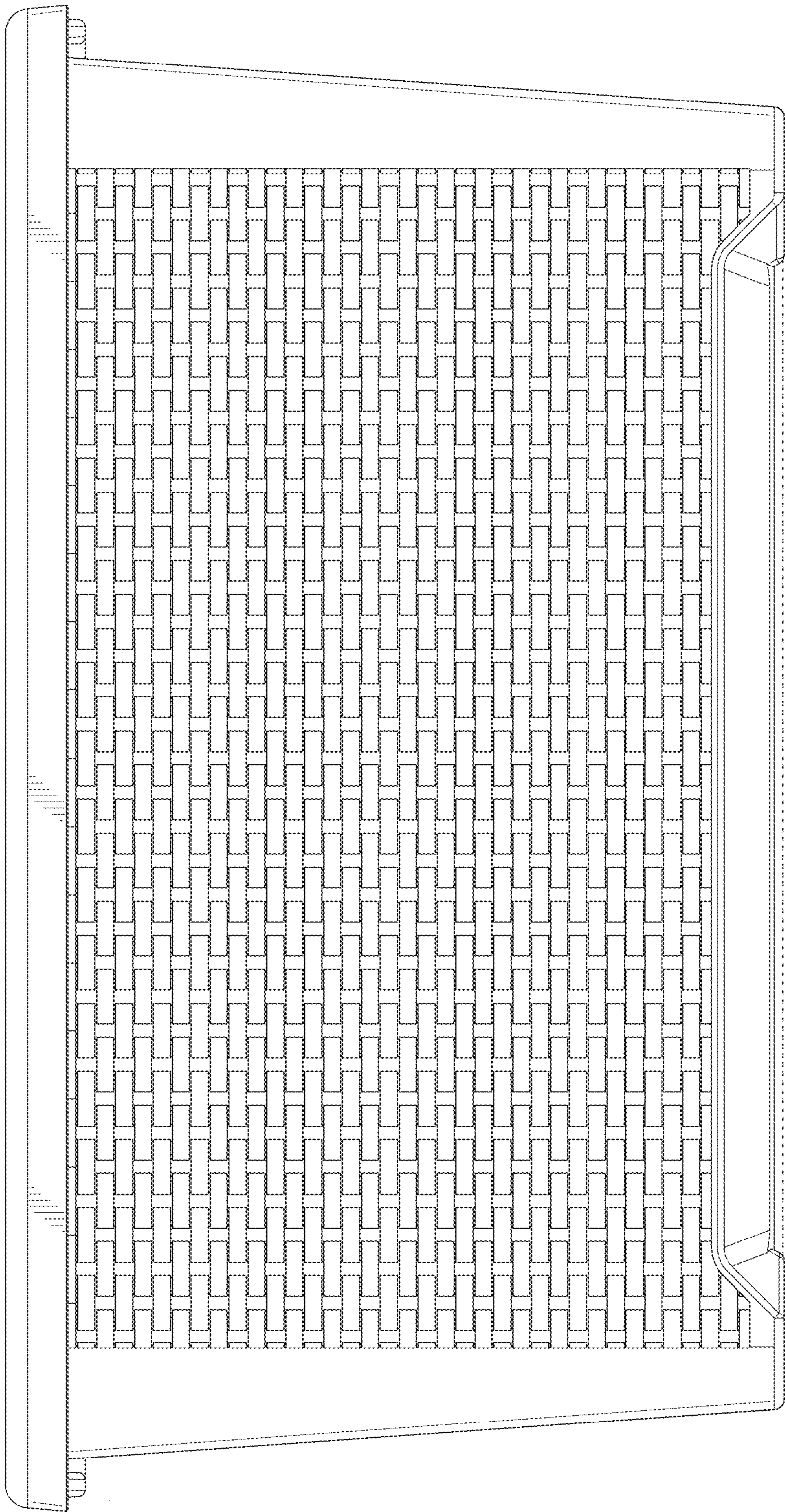

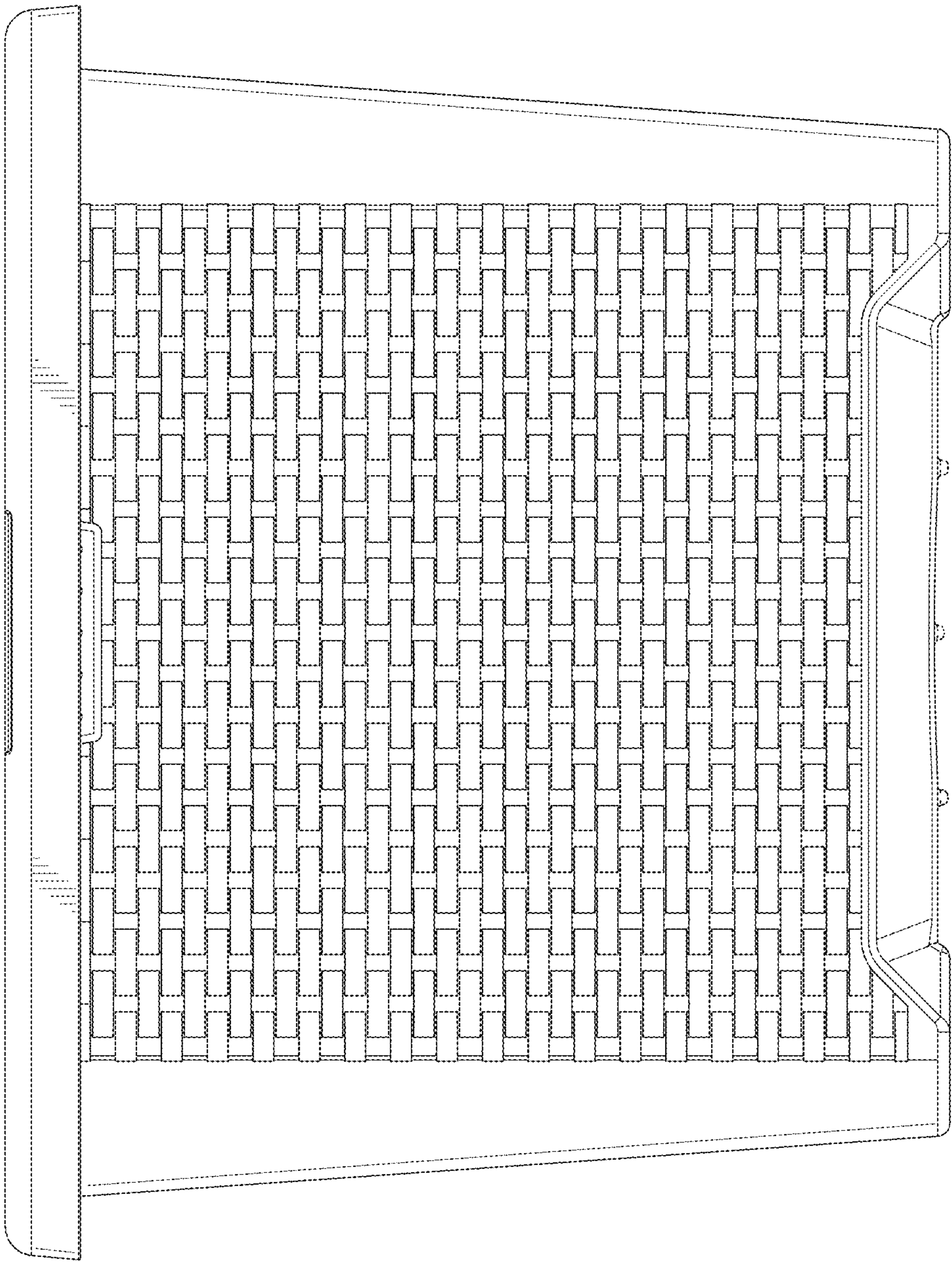

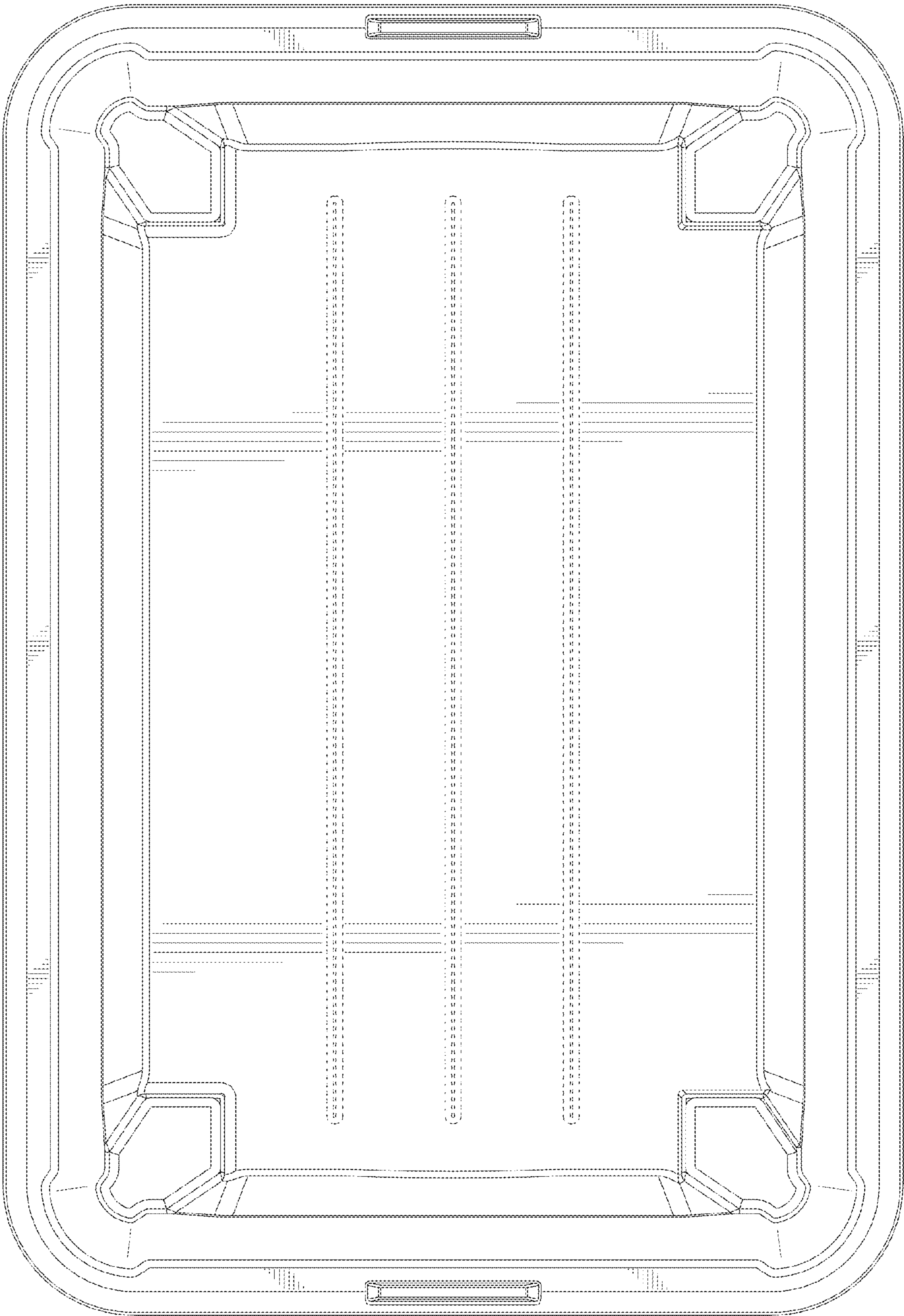

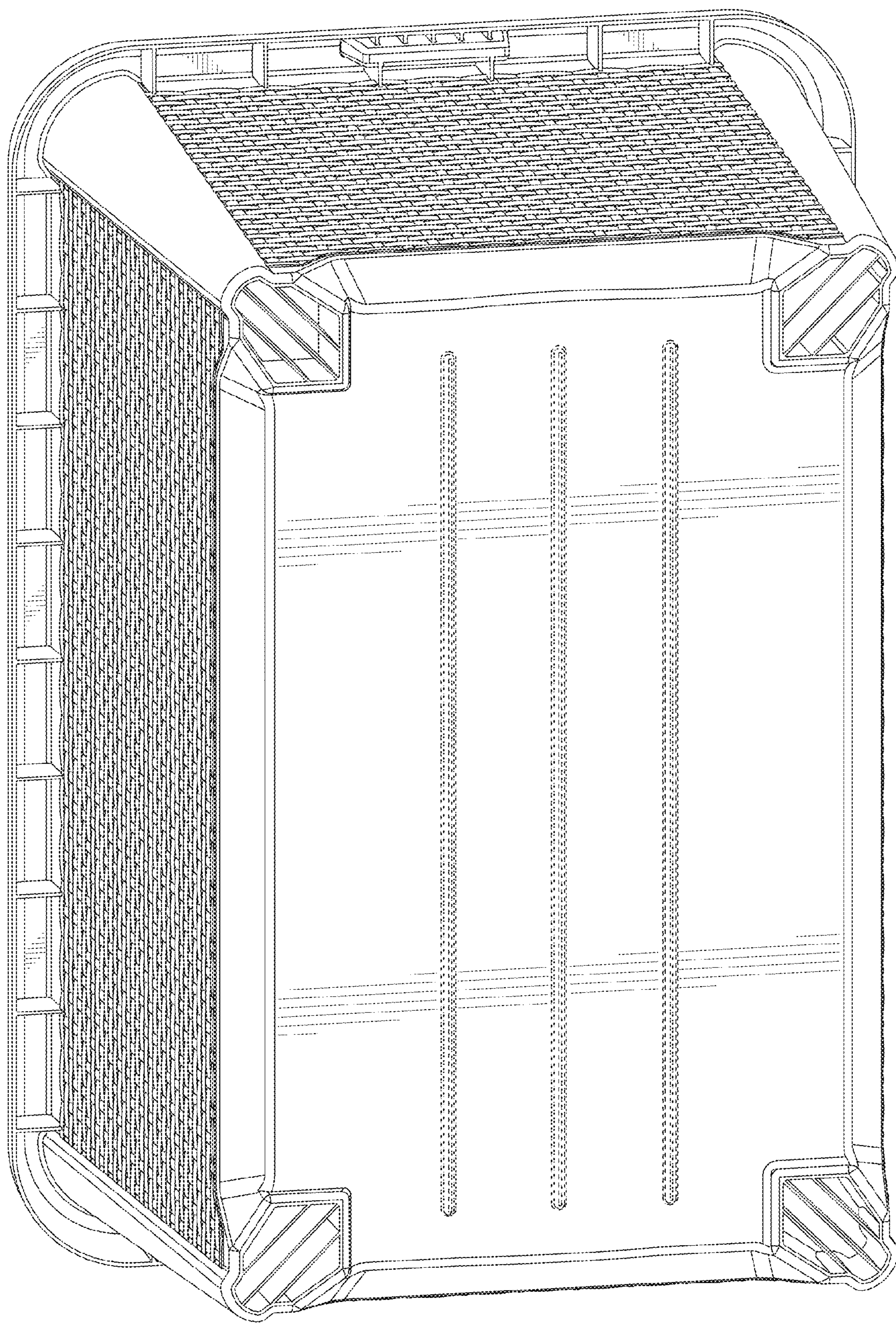
