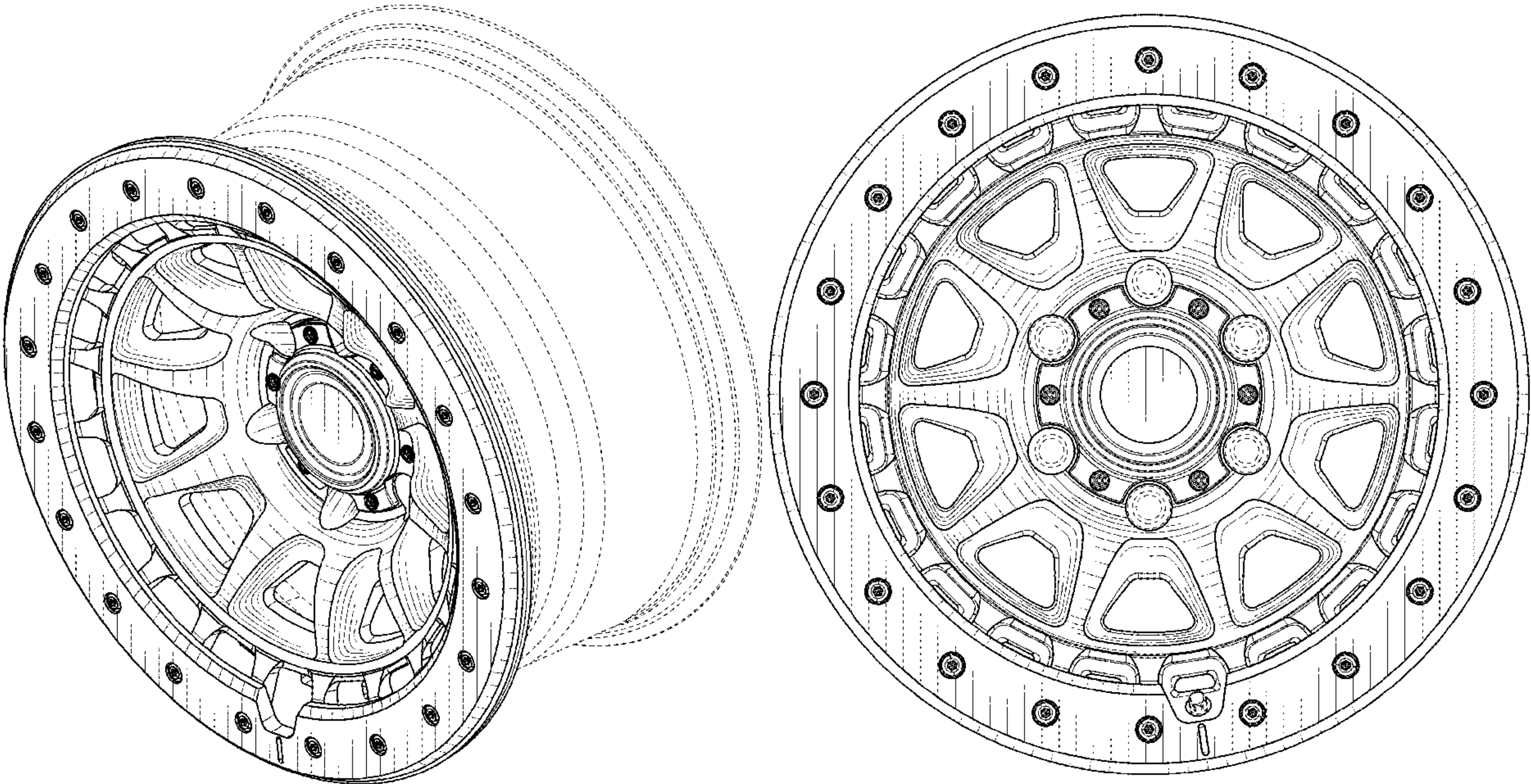
CLAIM

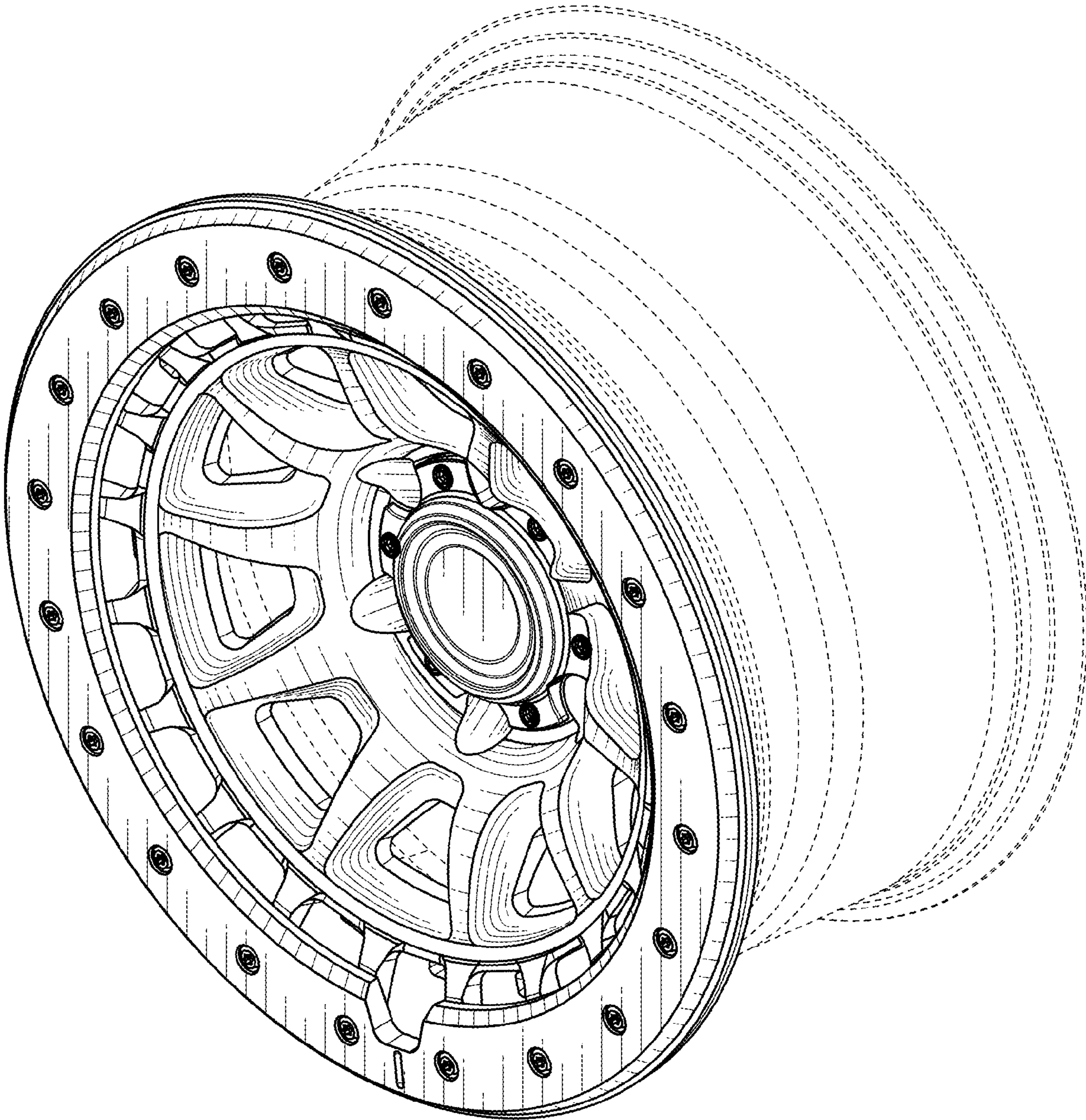

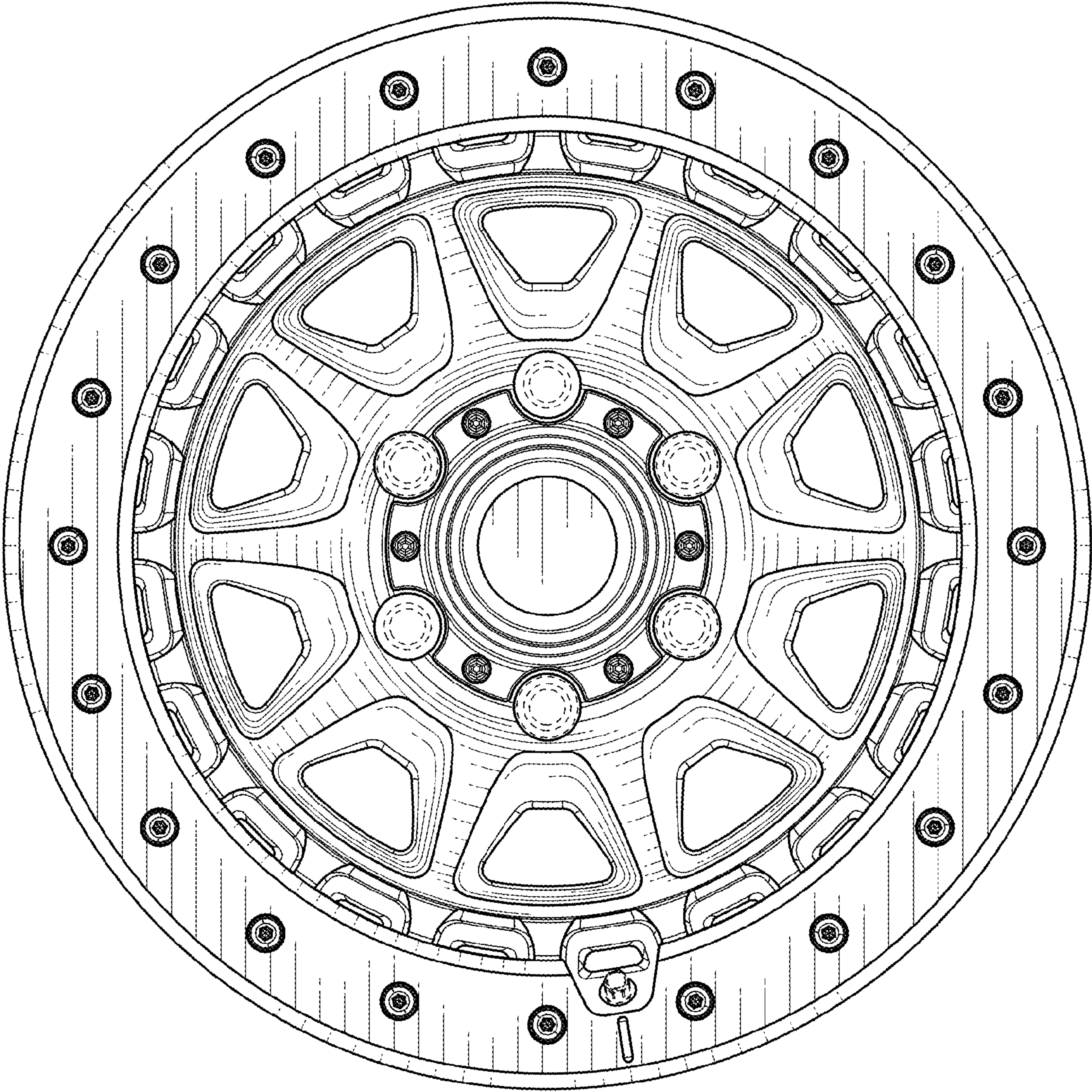
