FIG. 11 is an enlarged view of the encircled portion 11 in FIG. 4; and,

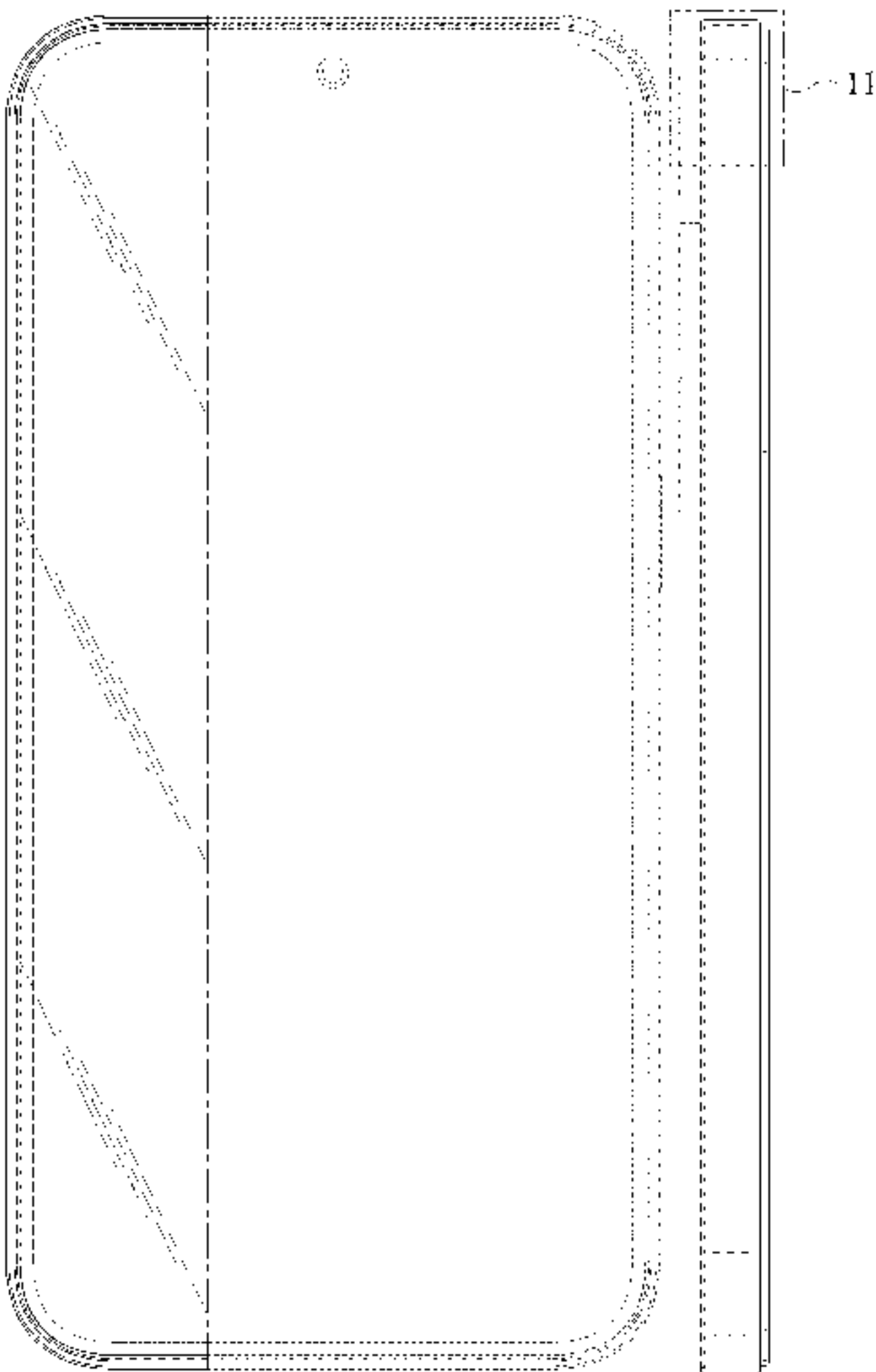
FIG. 12 is an enlarged view of the encircled portion 12 in FIG. 8.

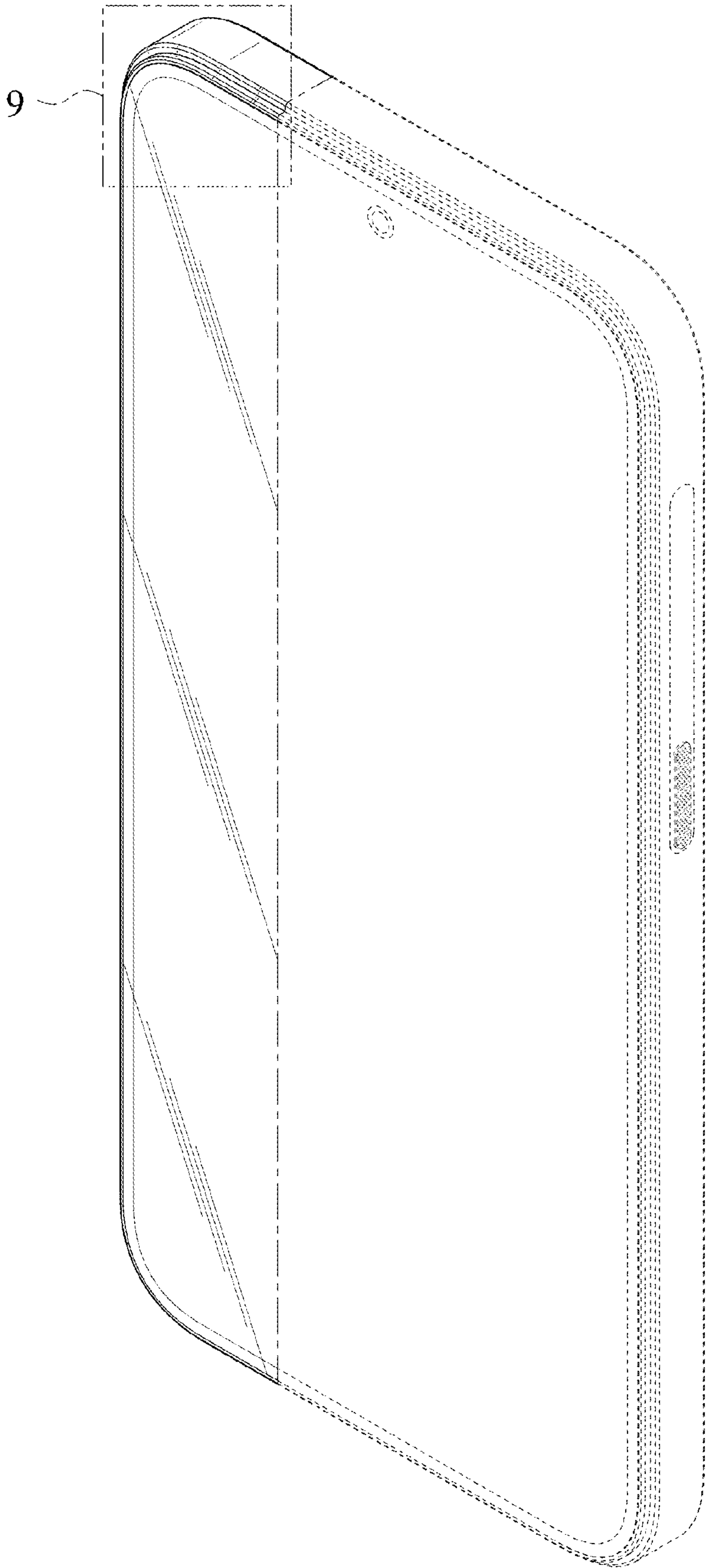

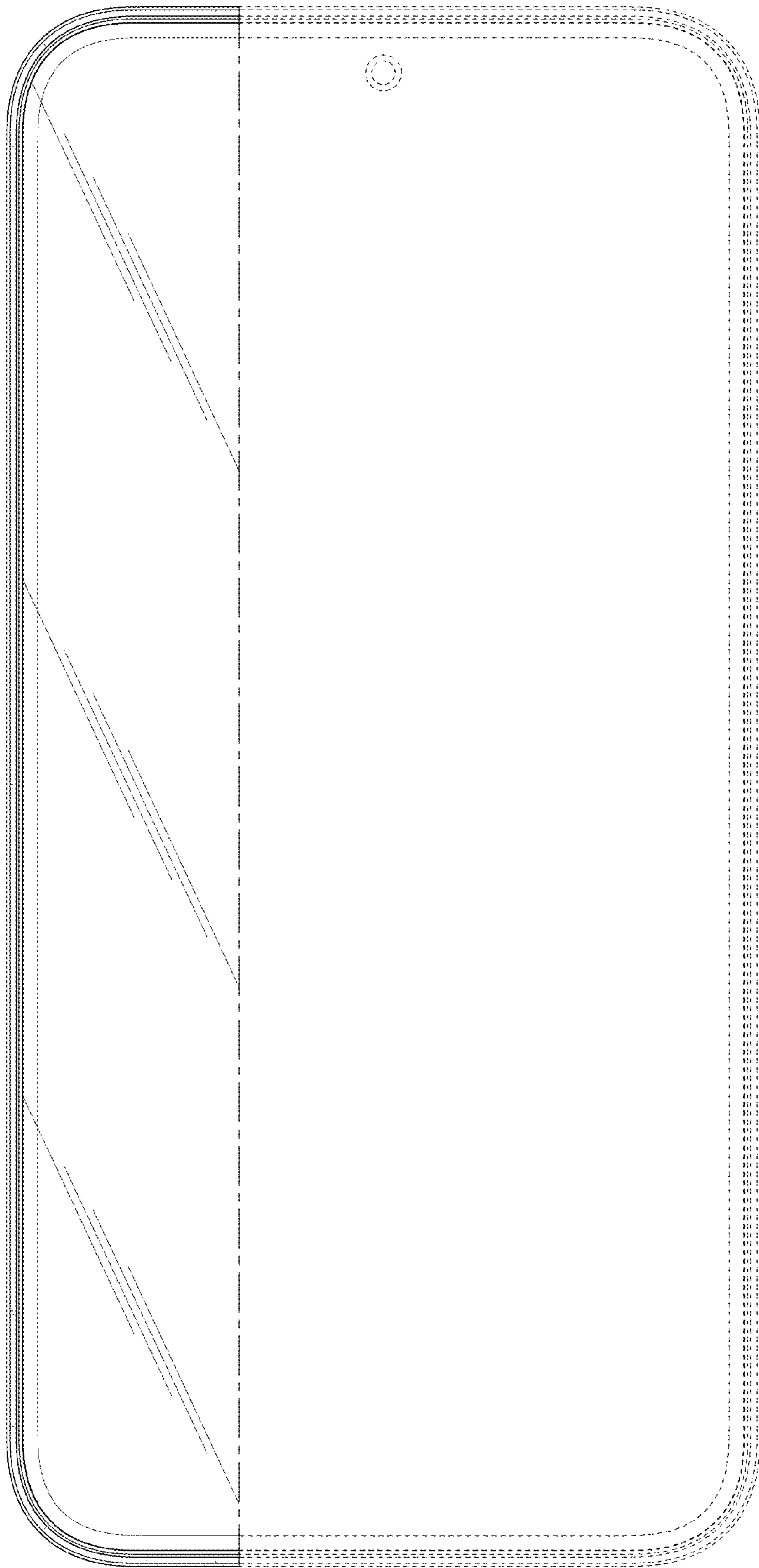

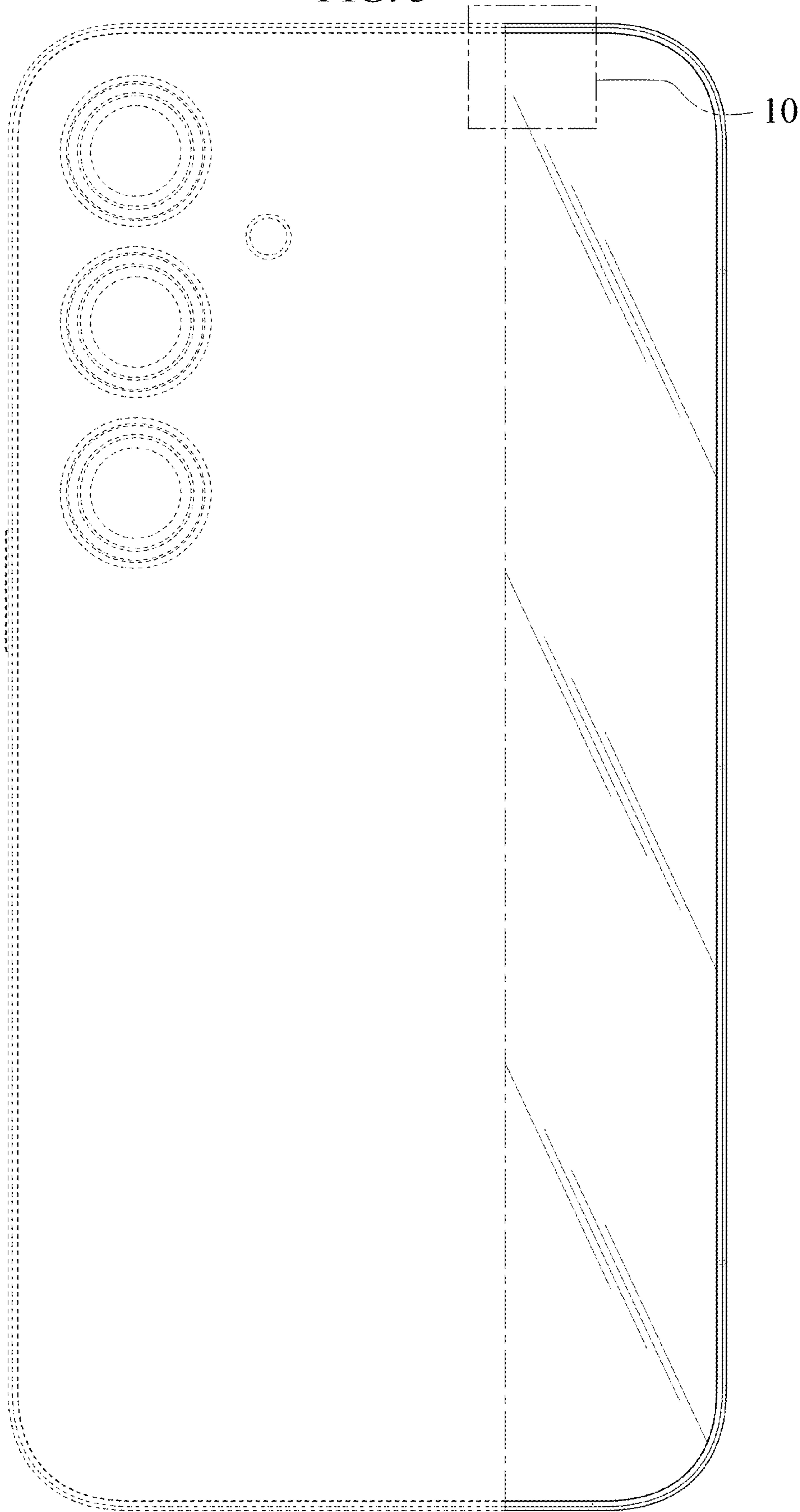

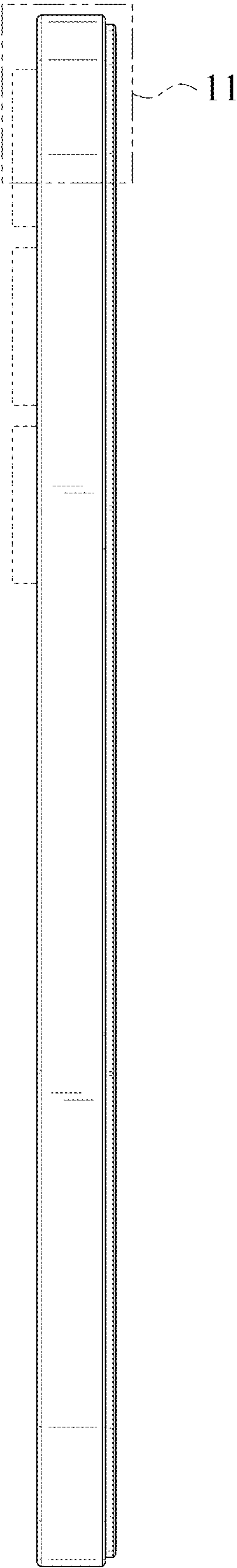

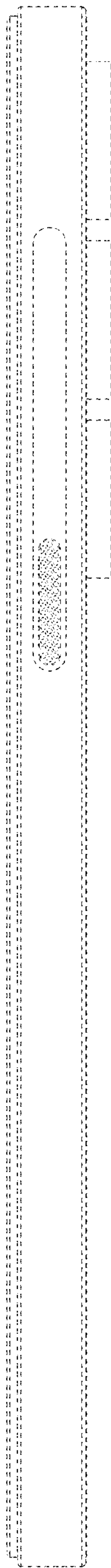

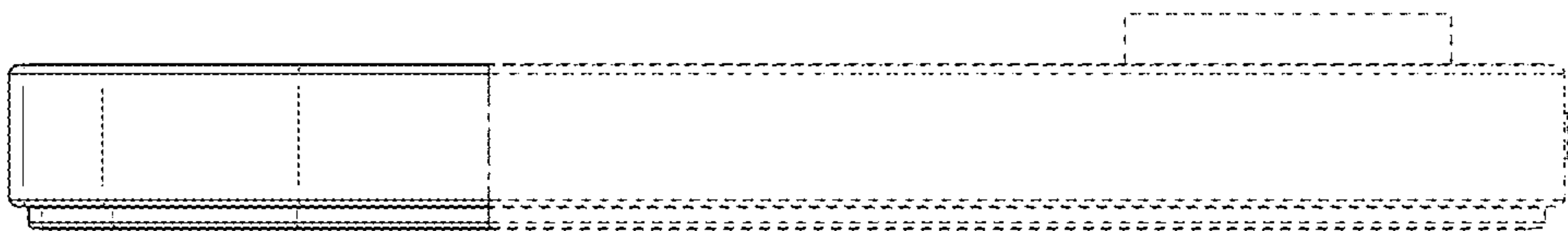

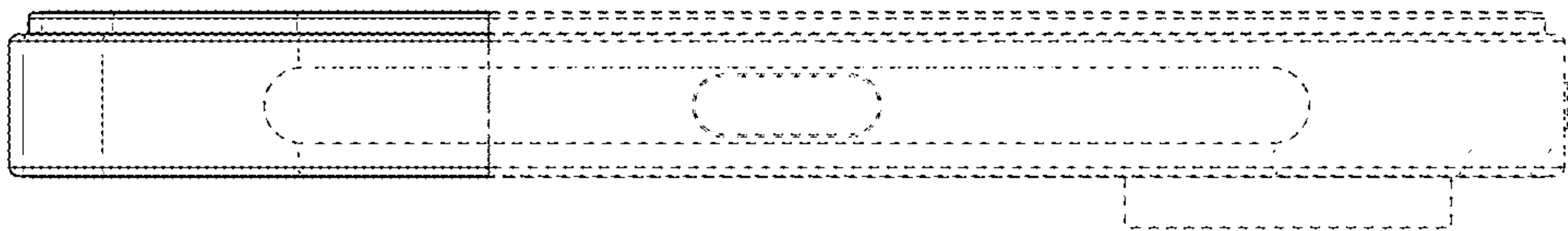

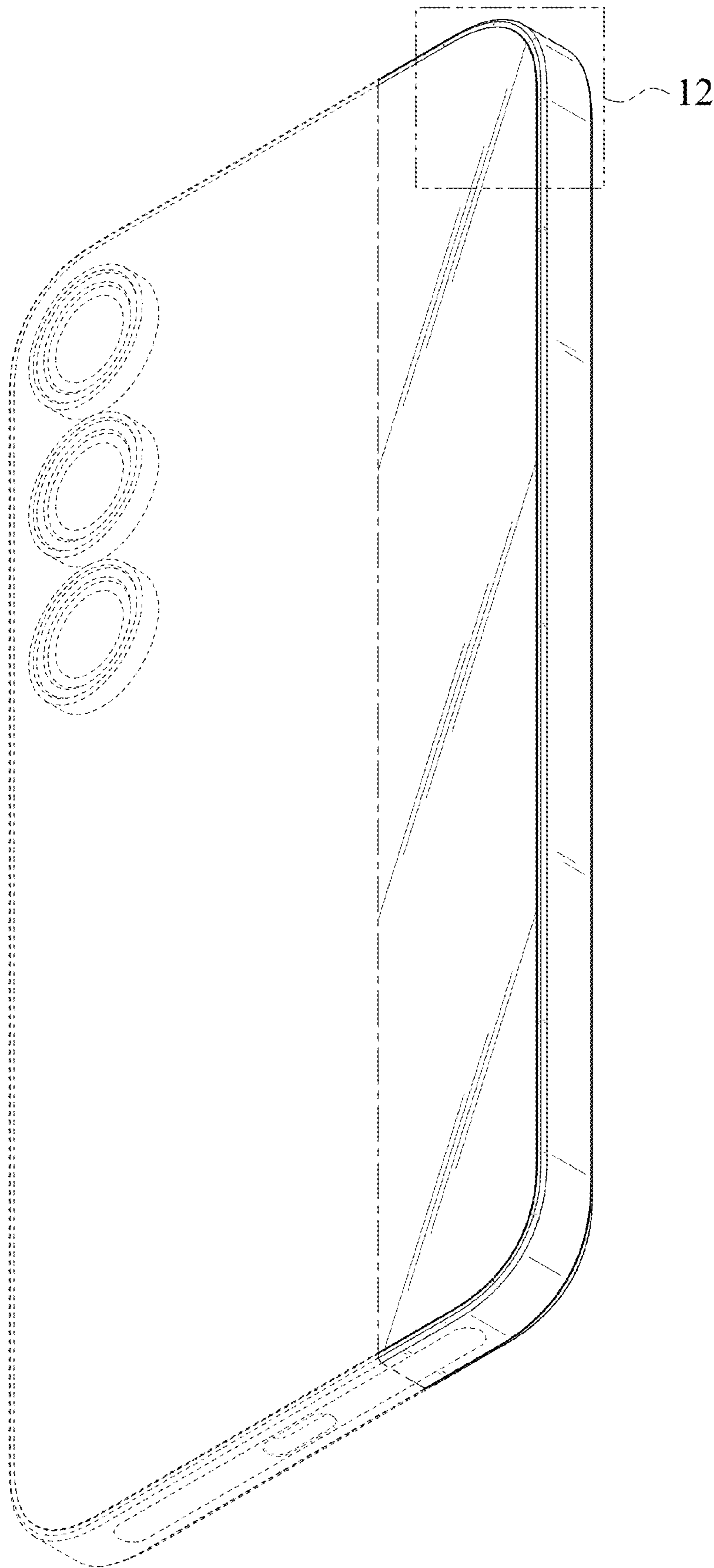

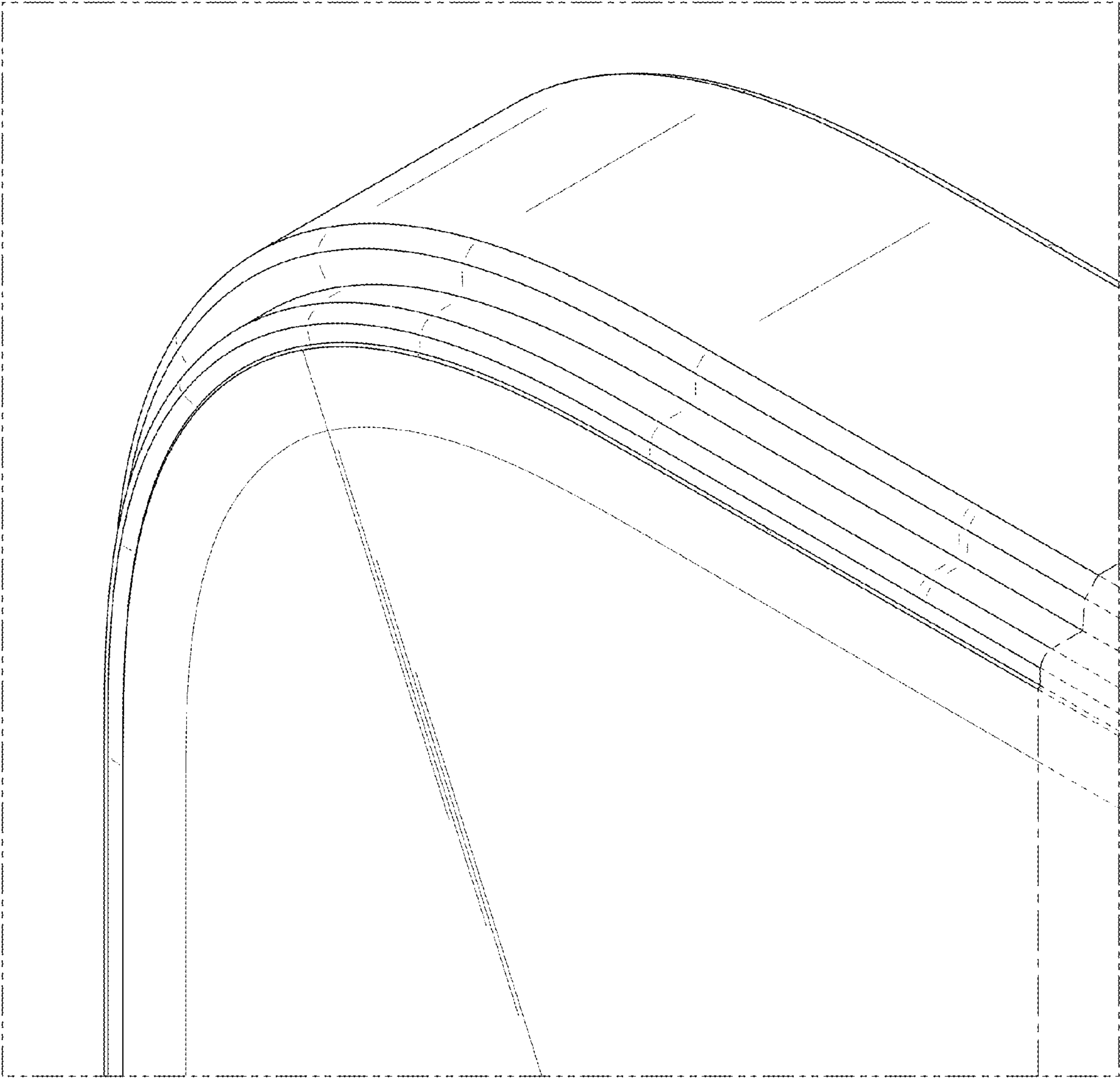

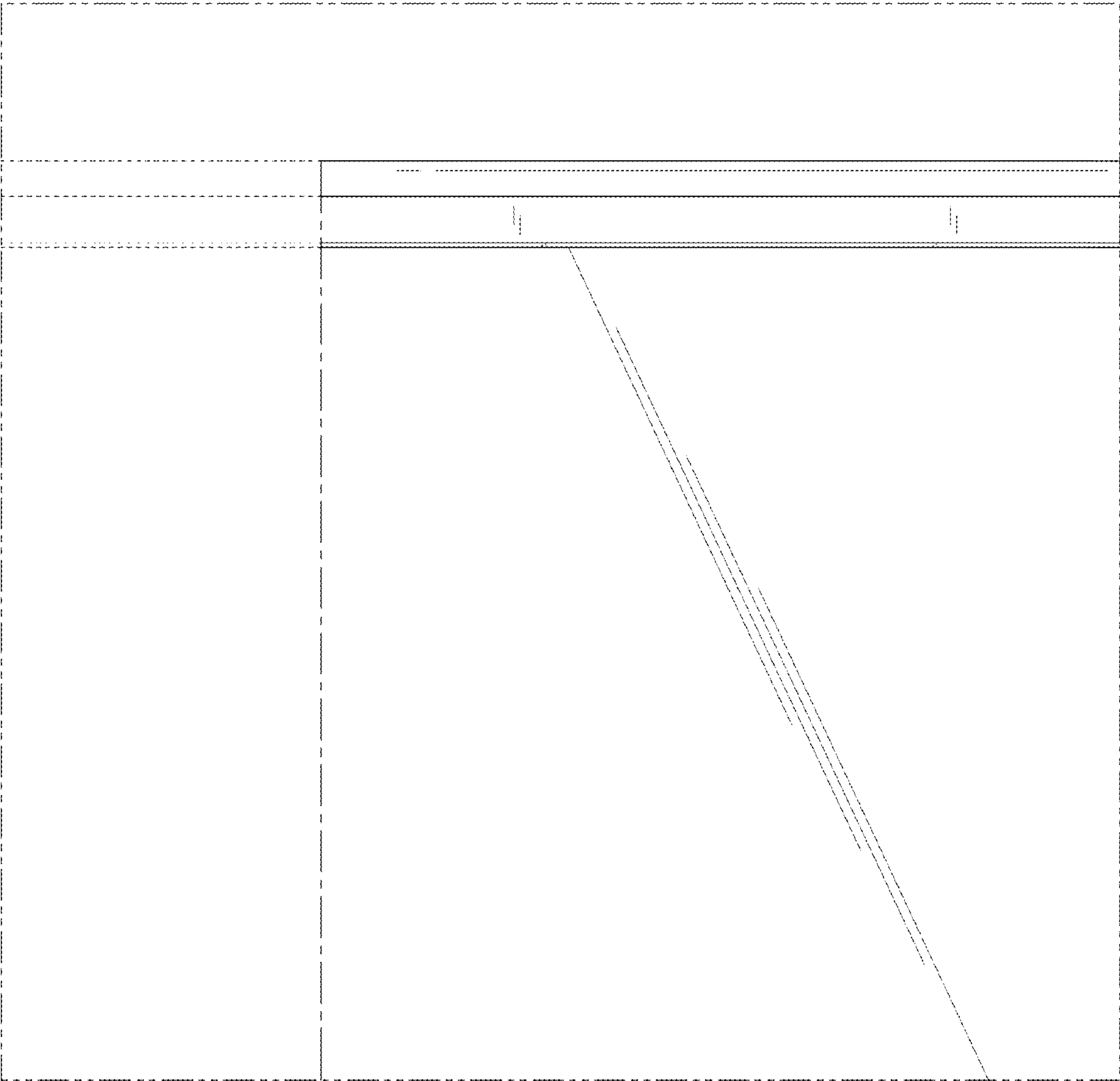

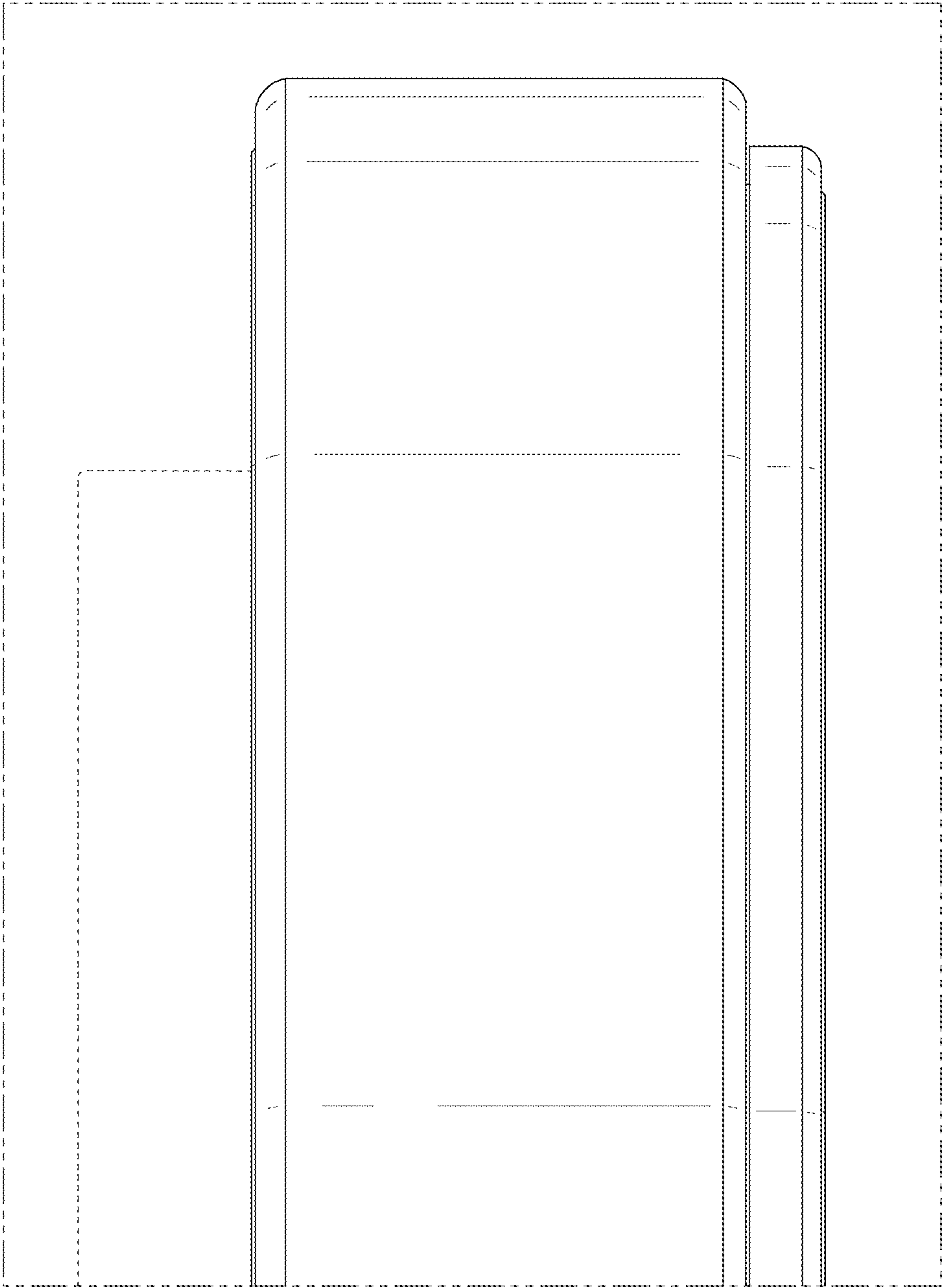
