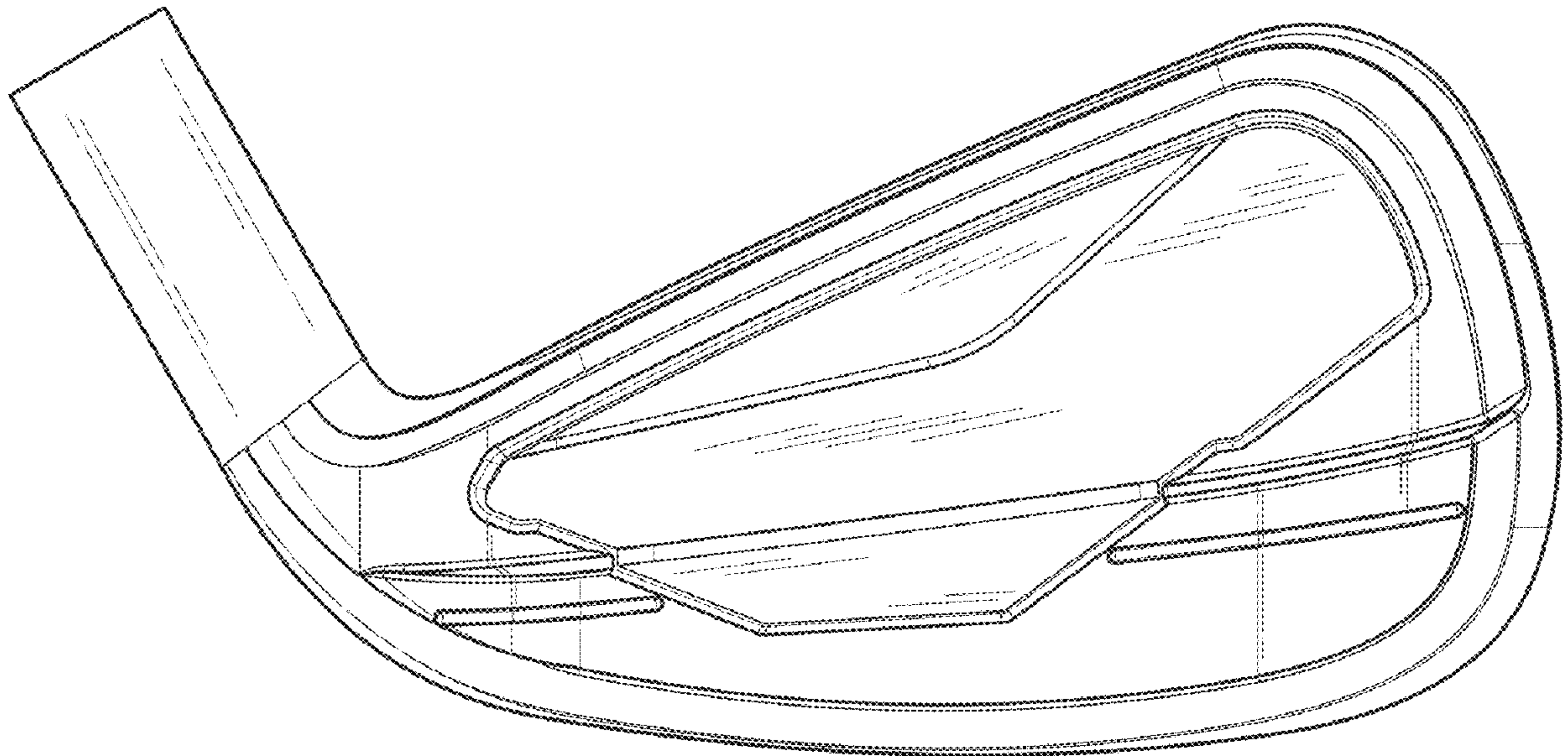
CLAIM

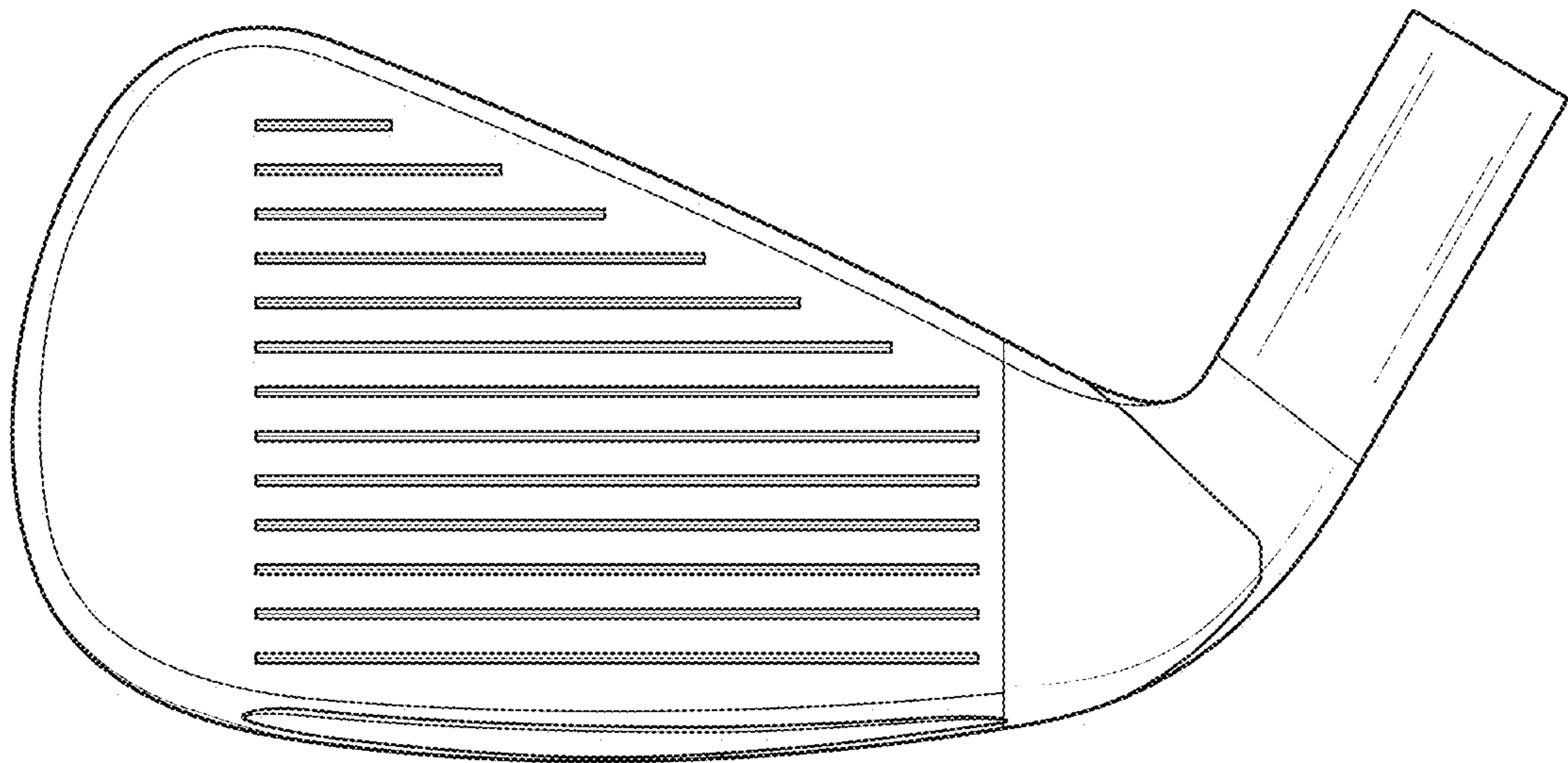

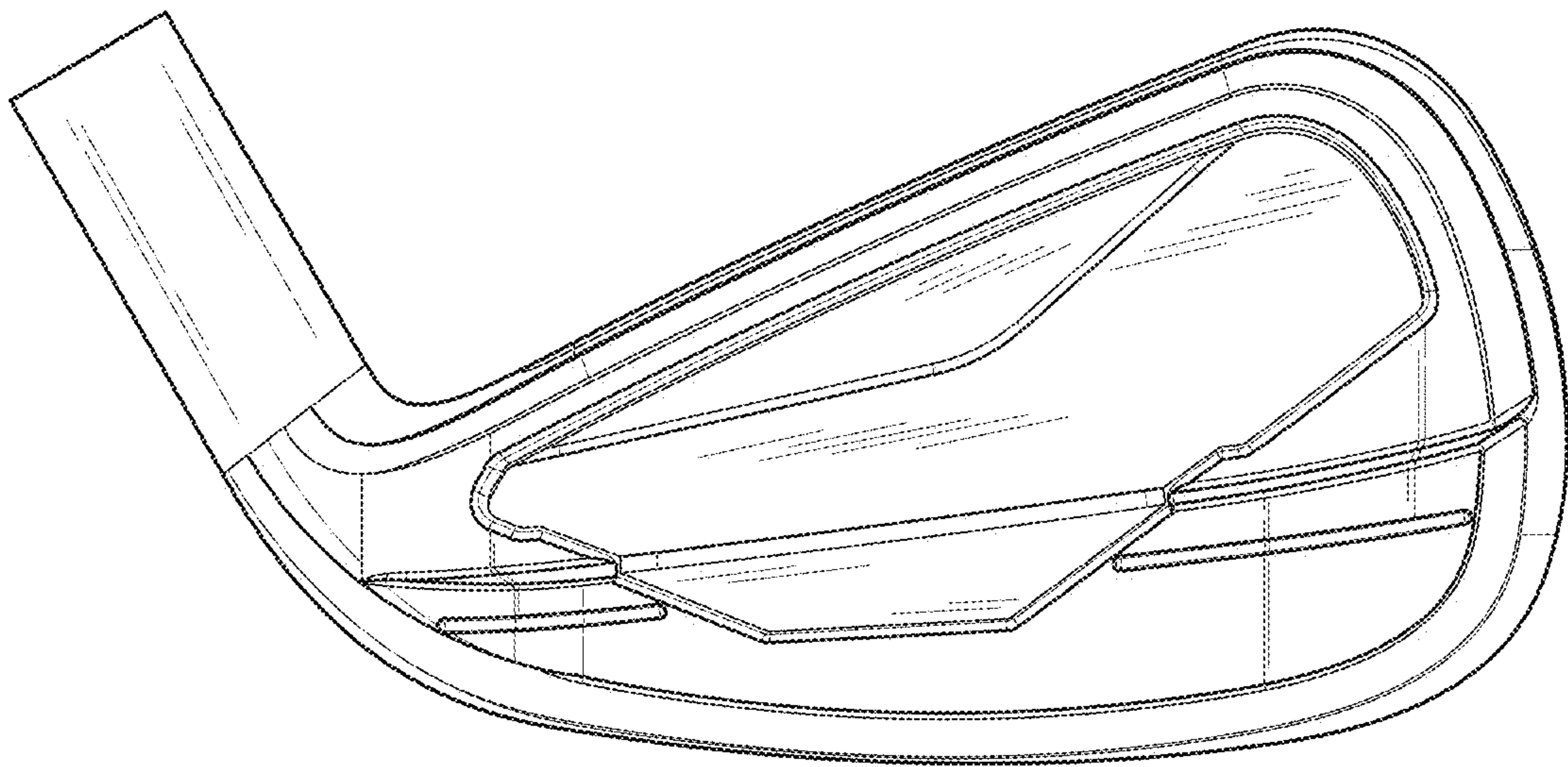

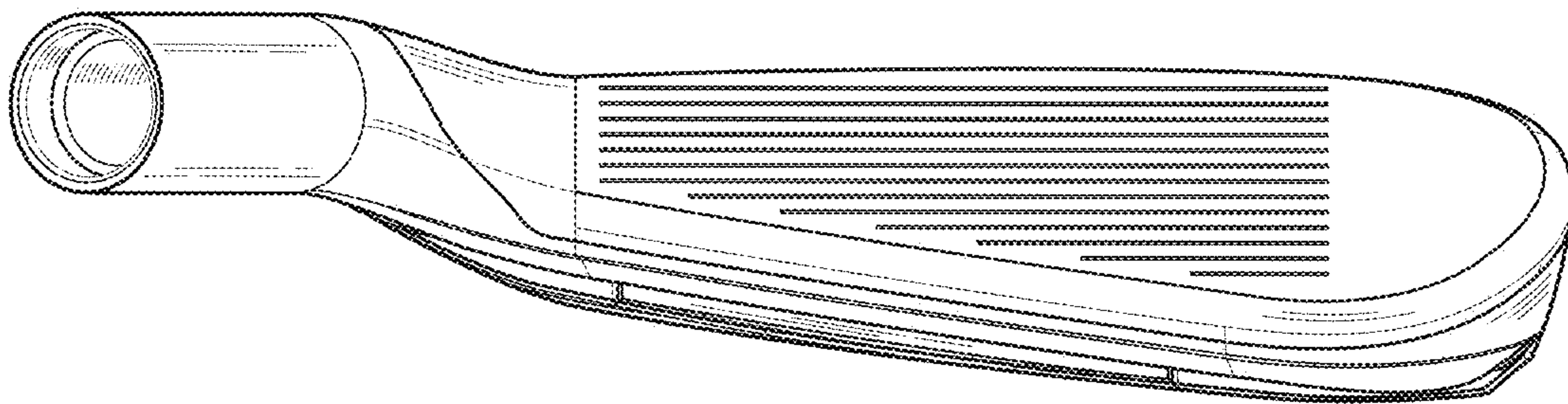

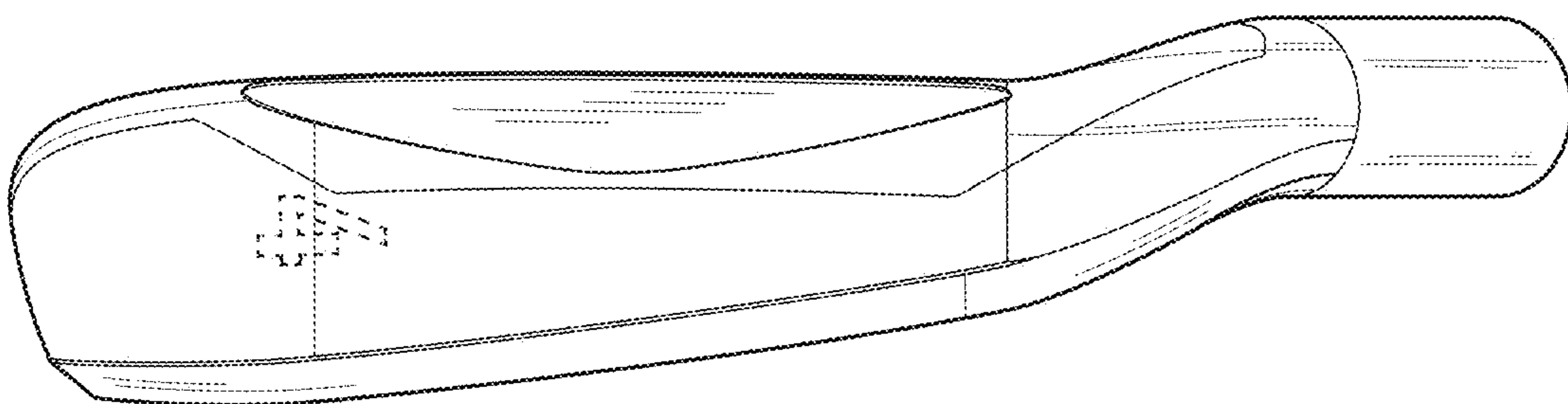

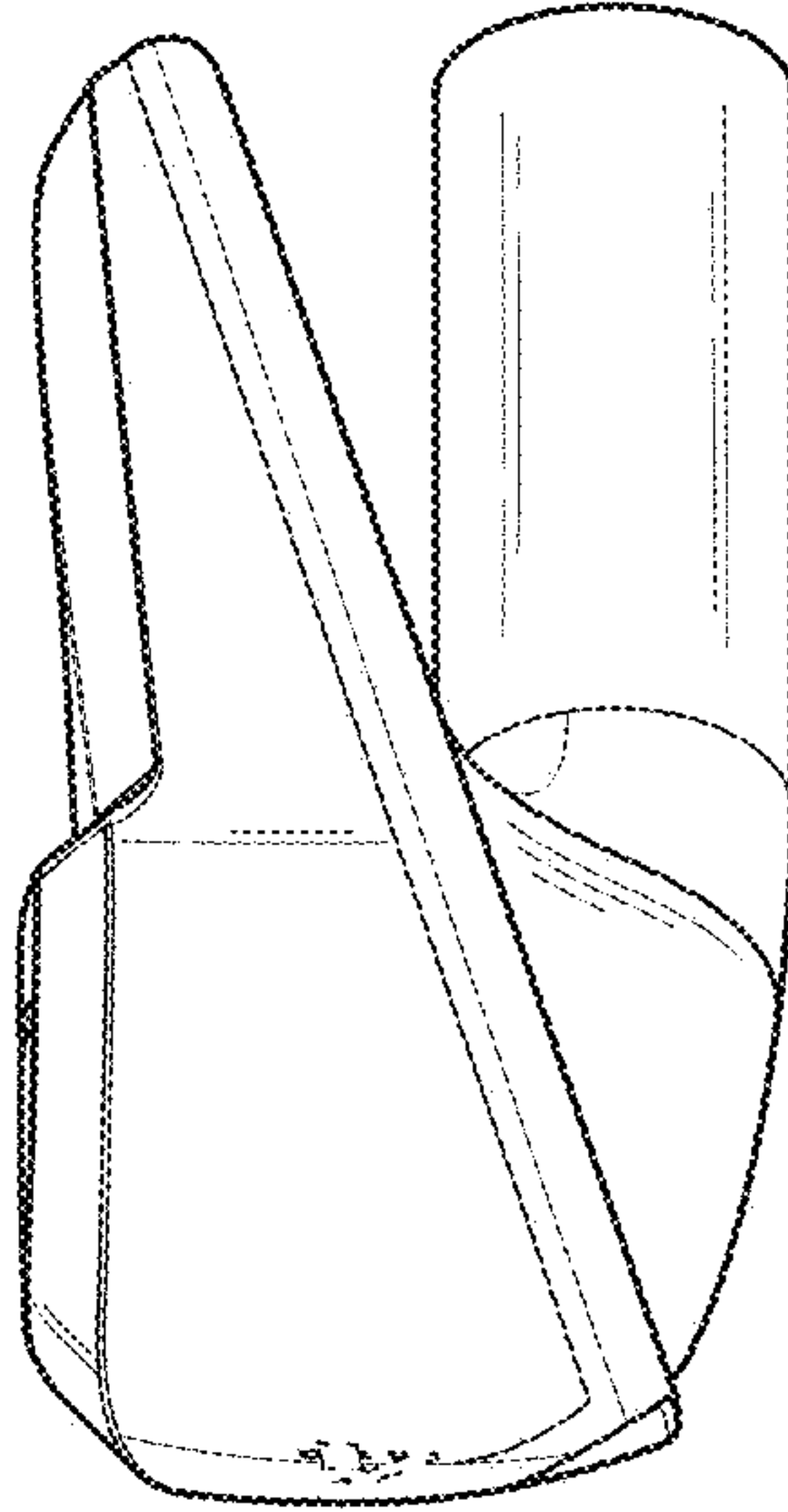

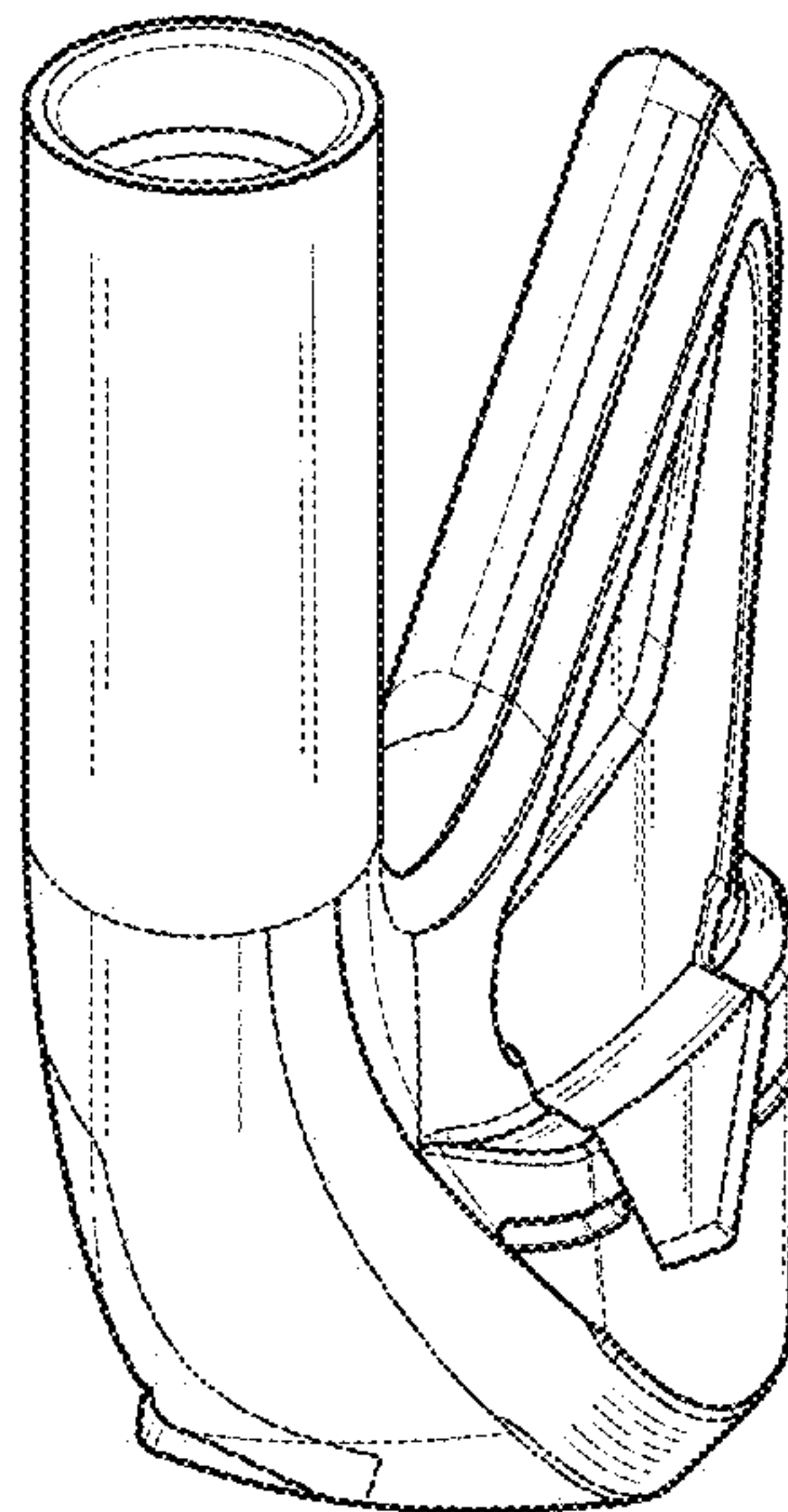

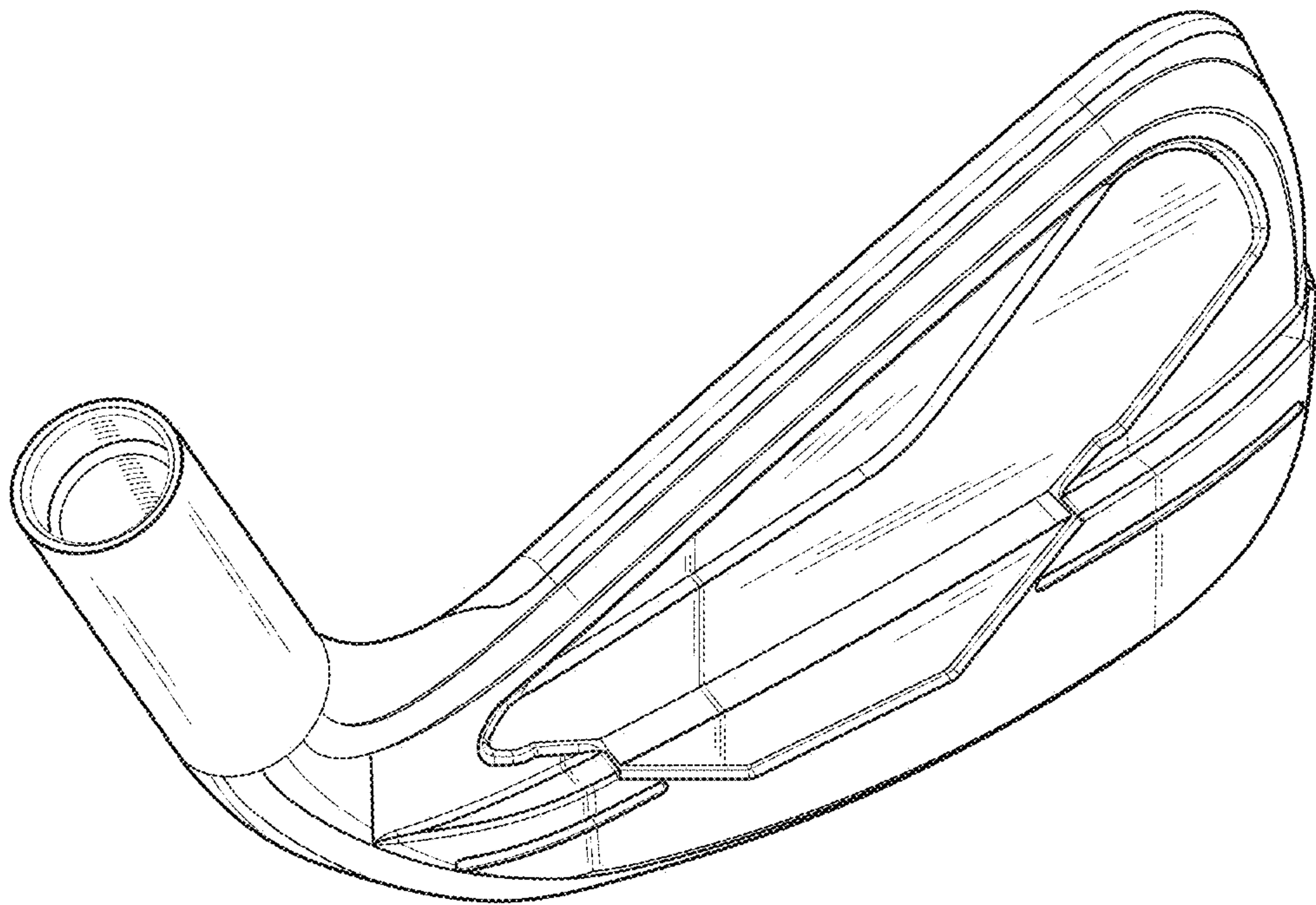
