CLAIM

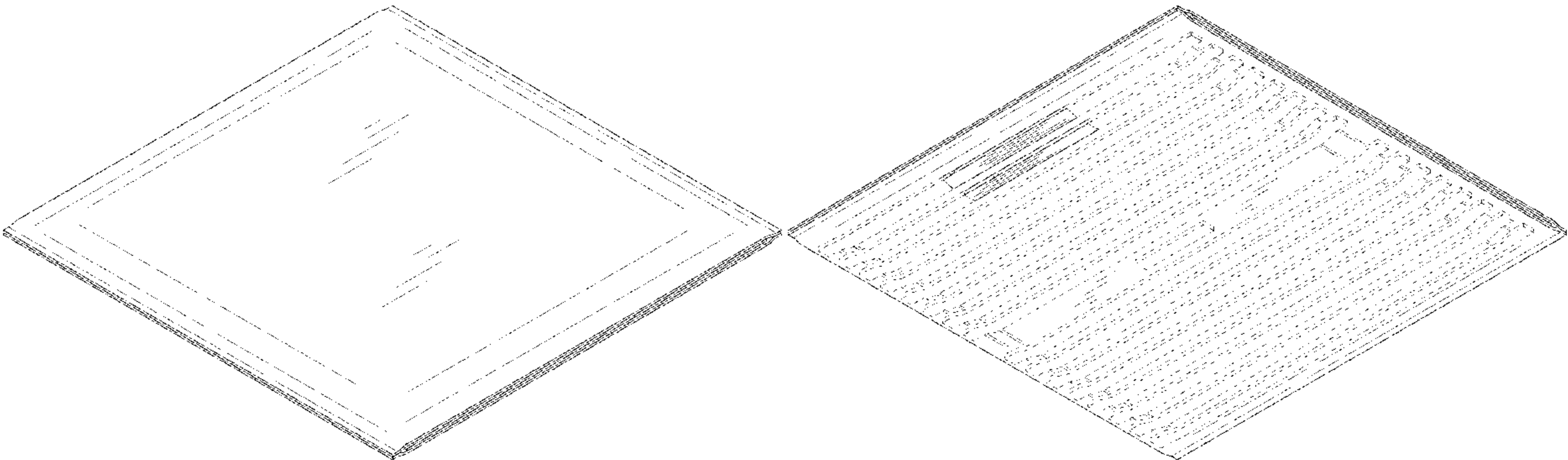
The ornamental design for an adhesive pad for pet urine absorption sheet as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an adhesive pad for pet urine absorption sheet of our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a right side view thereof; FIG. 8 is a left side view thereof; FIG. 9 is a perspective view thereof, shown in an environment of use; and, FIG. 10 is a perspective view thereof, shown in an environment of use.

The broken lines showing the adhesive pad for pet urine absorption sheet are included for the purpose of illustrating portions of the adhesive pad for pet urine absorption sheet and form no part of the claimed design. The additional broken lines shown in FIGS. 9 and 10 depict environmental subject matter only, and form no part of the claimed design. The alternate long and short dash lines depict the bounds of the claimed design and form no part thereof.

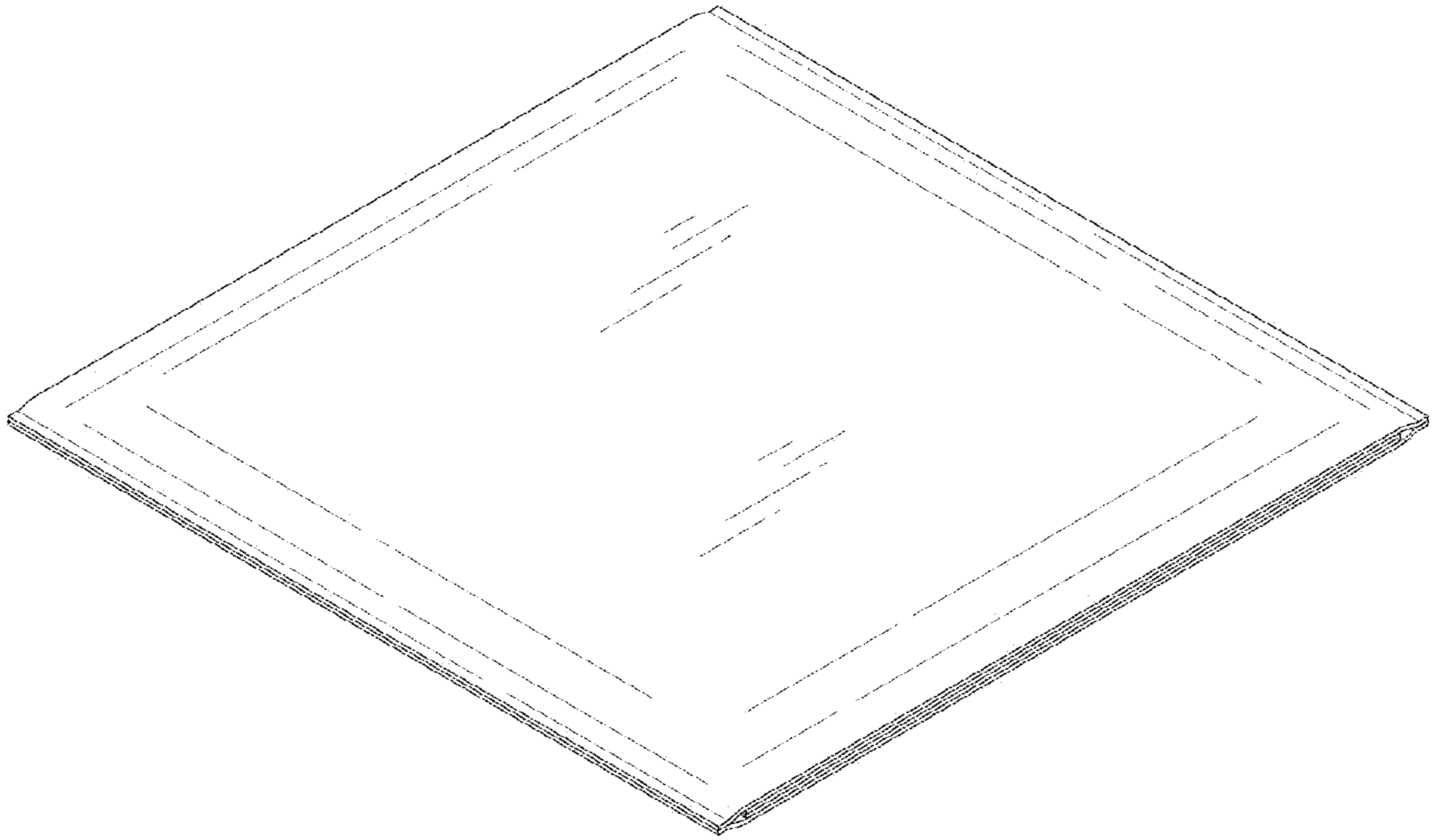

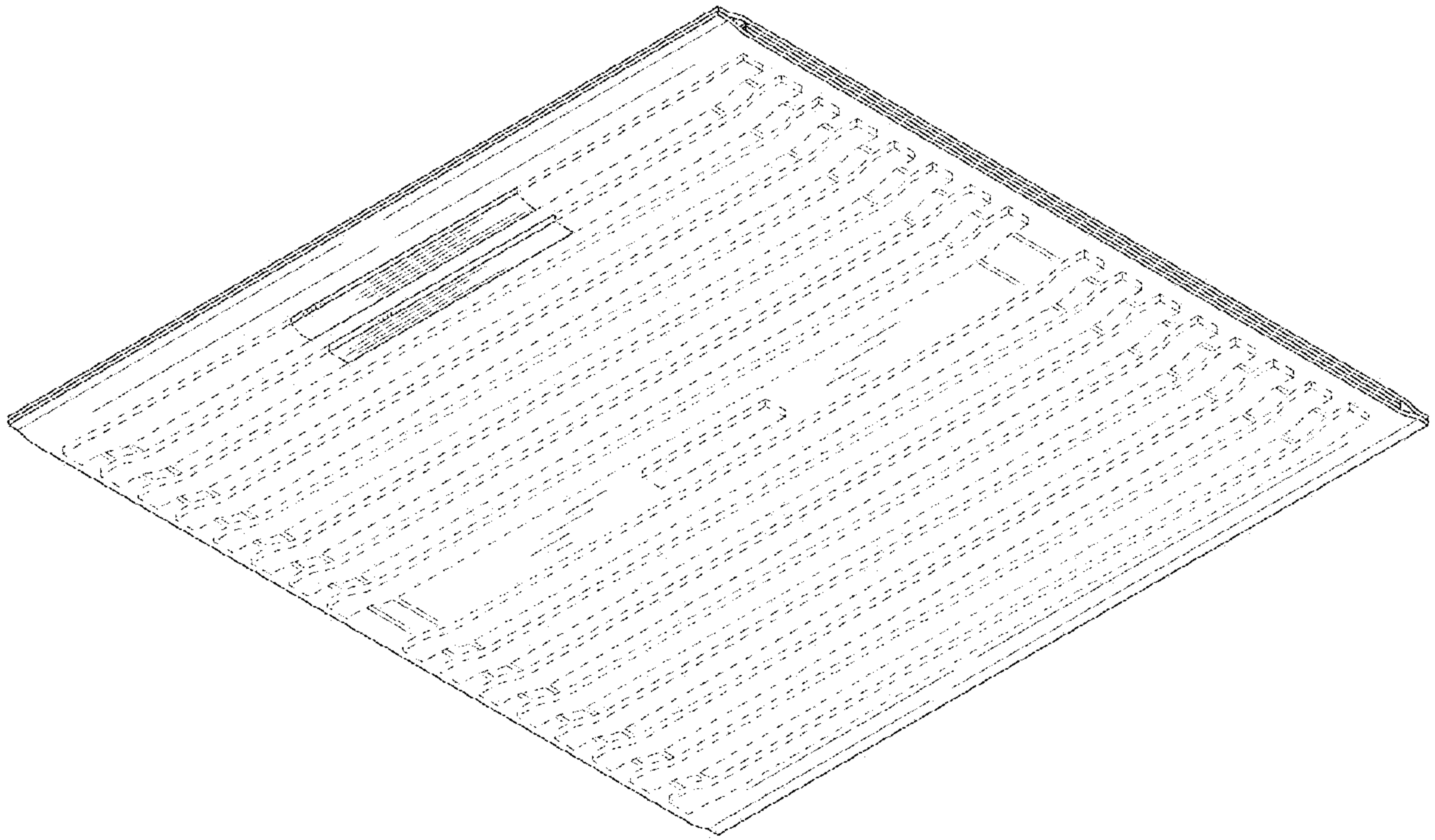

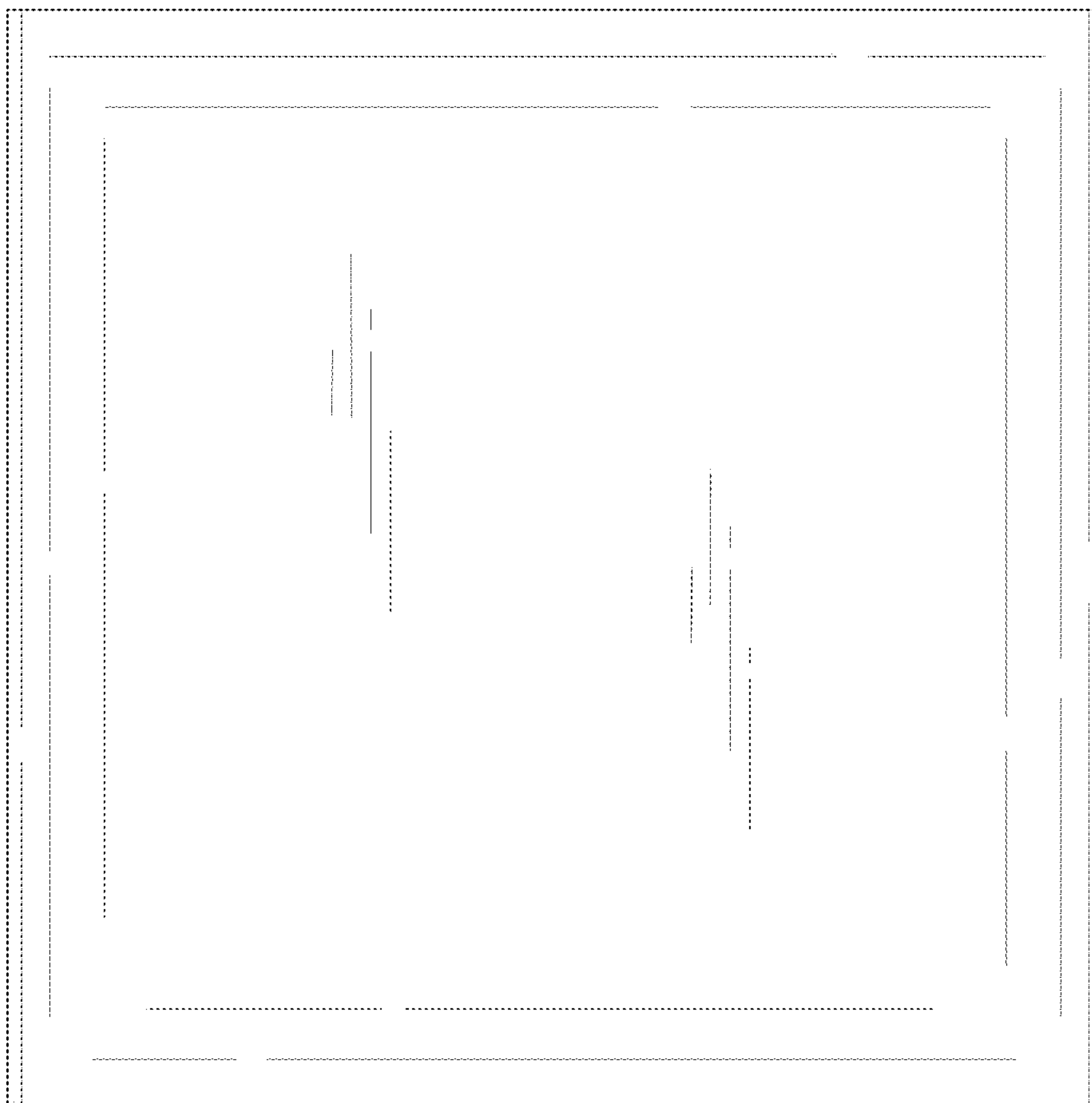

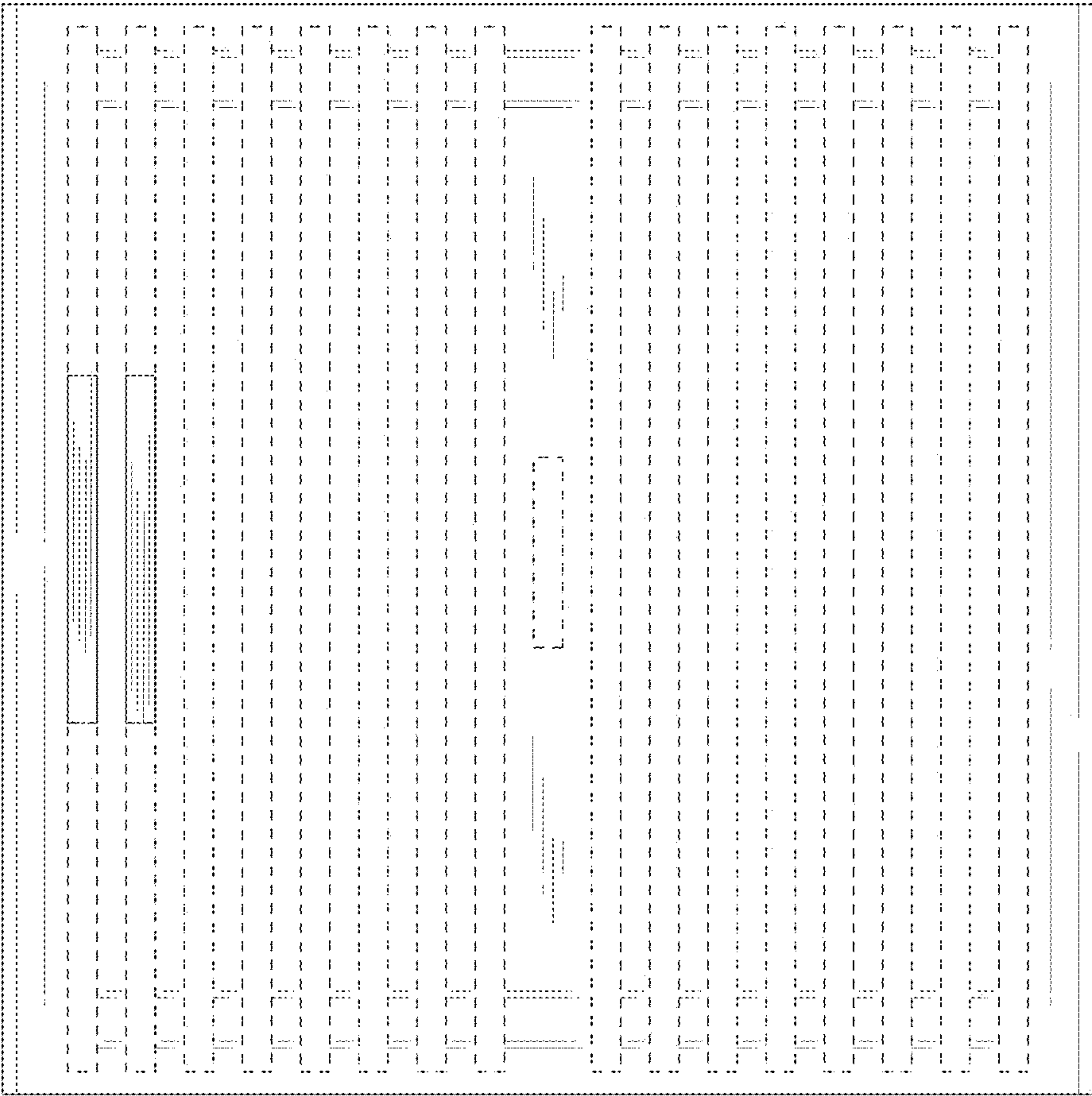

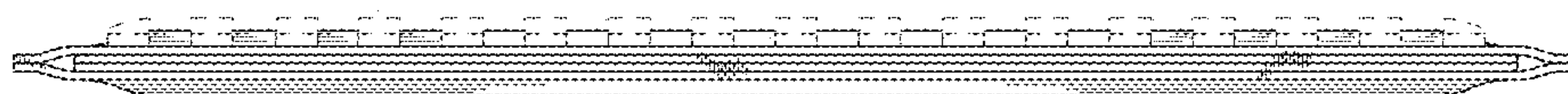

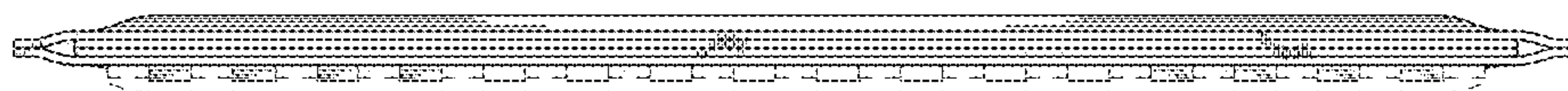

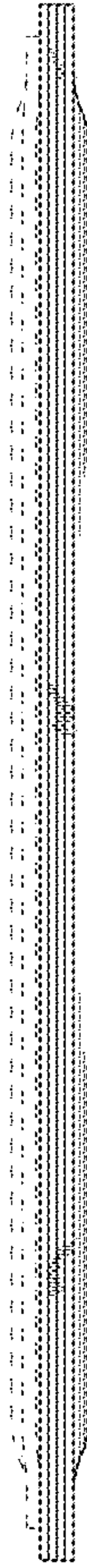

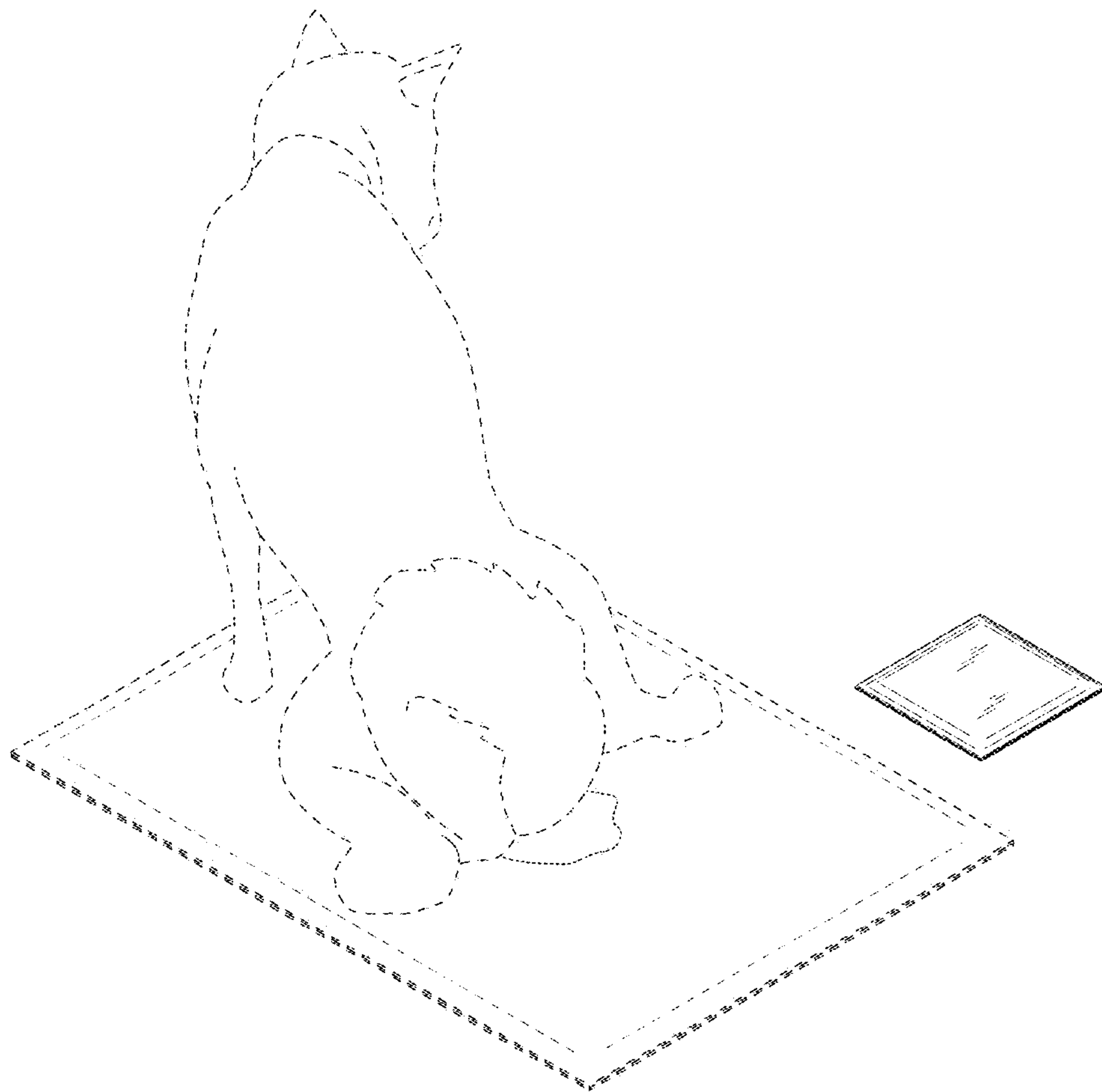

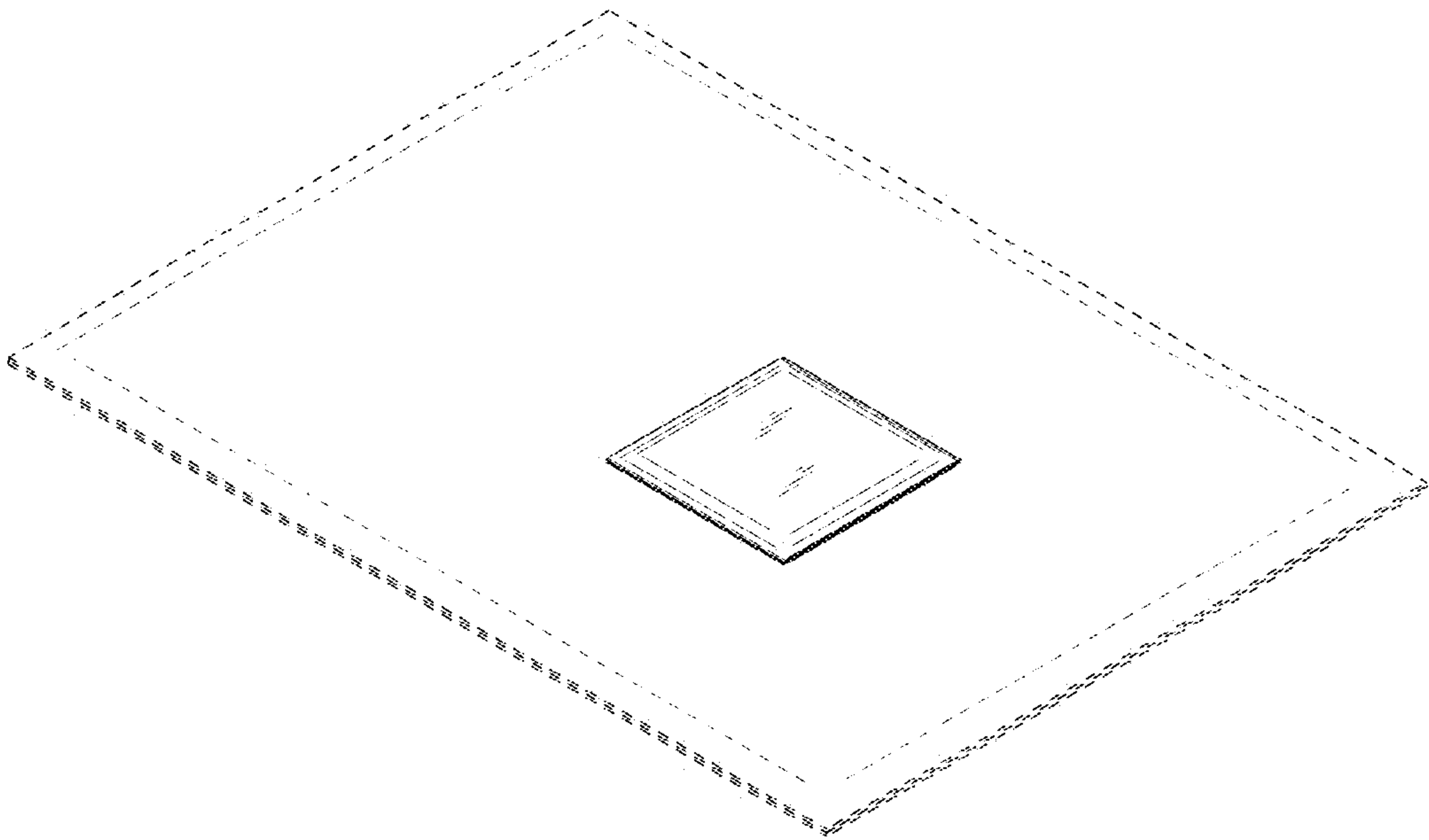
