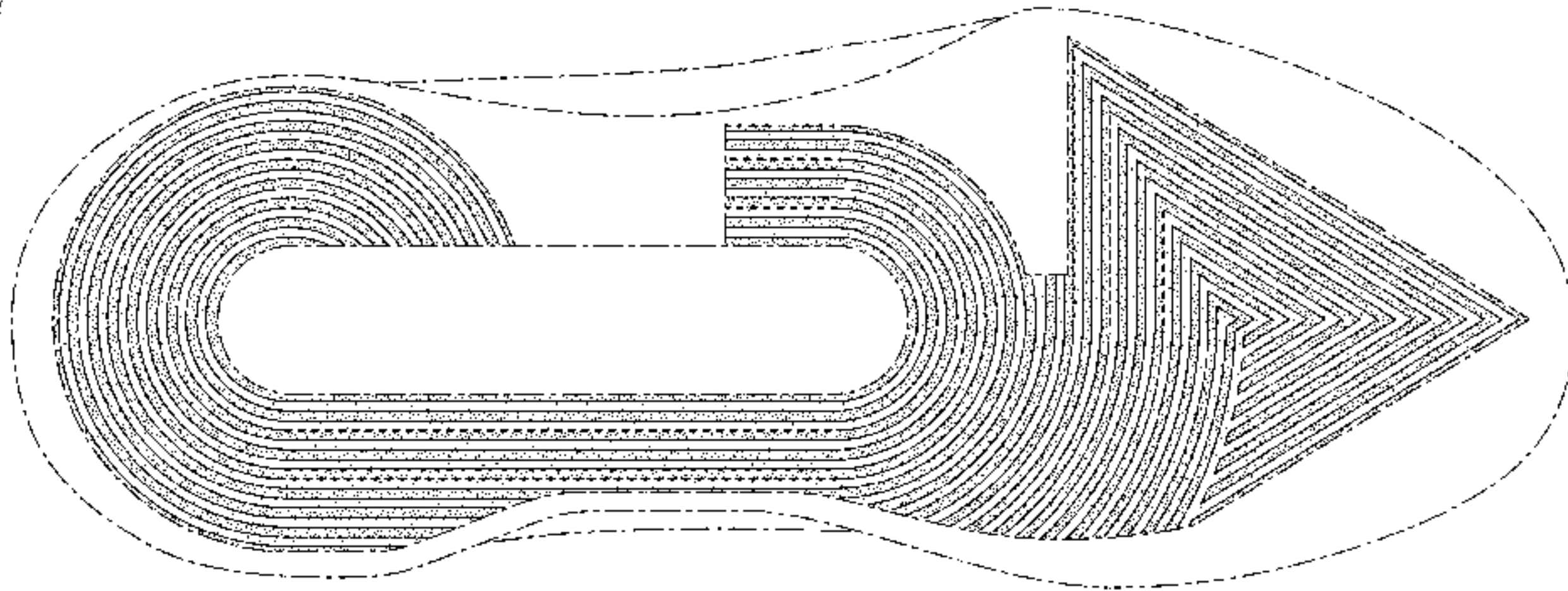
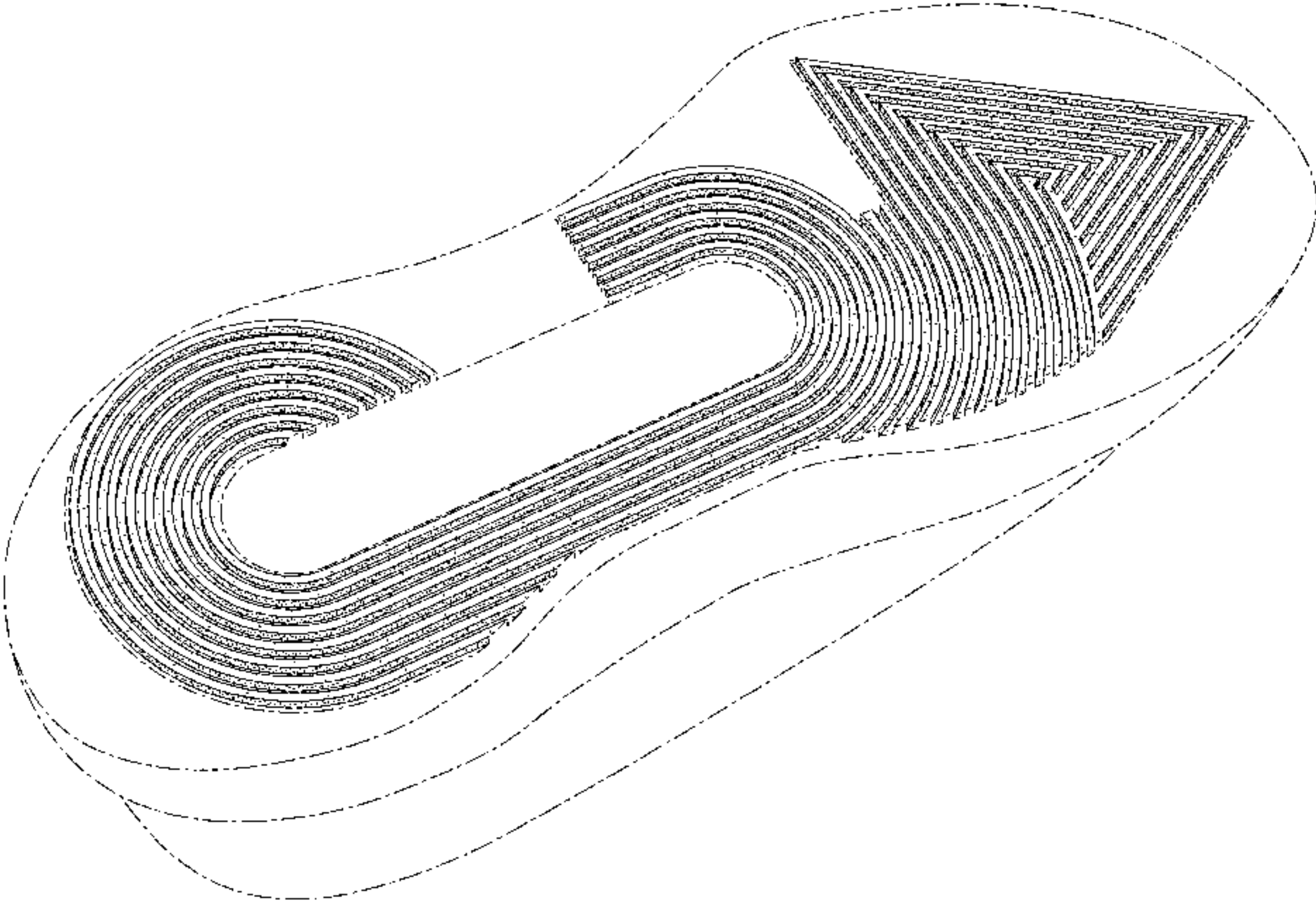
(57)CLAIM

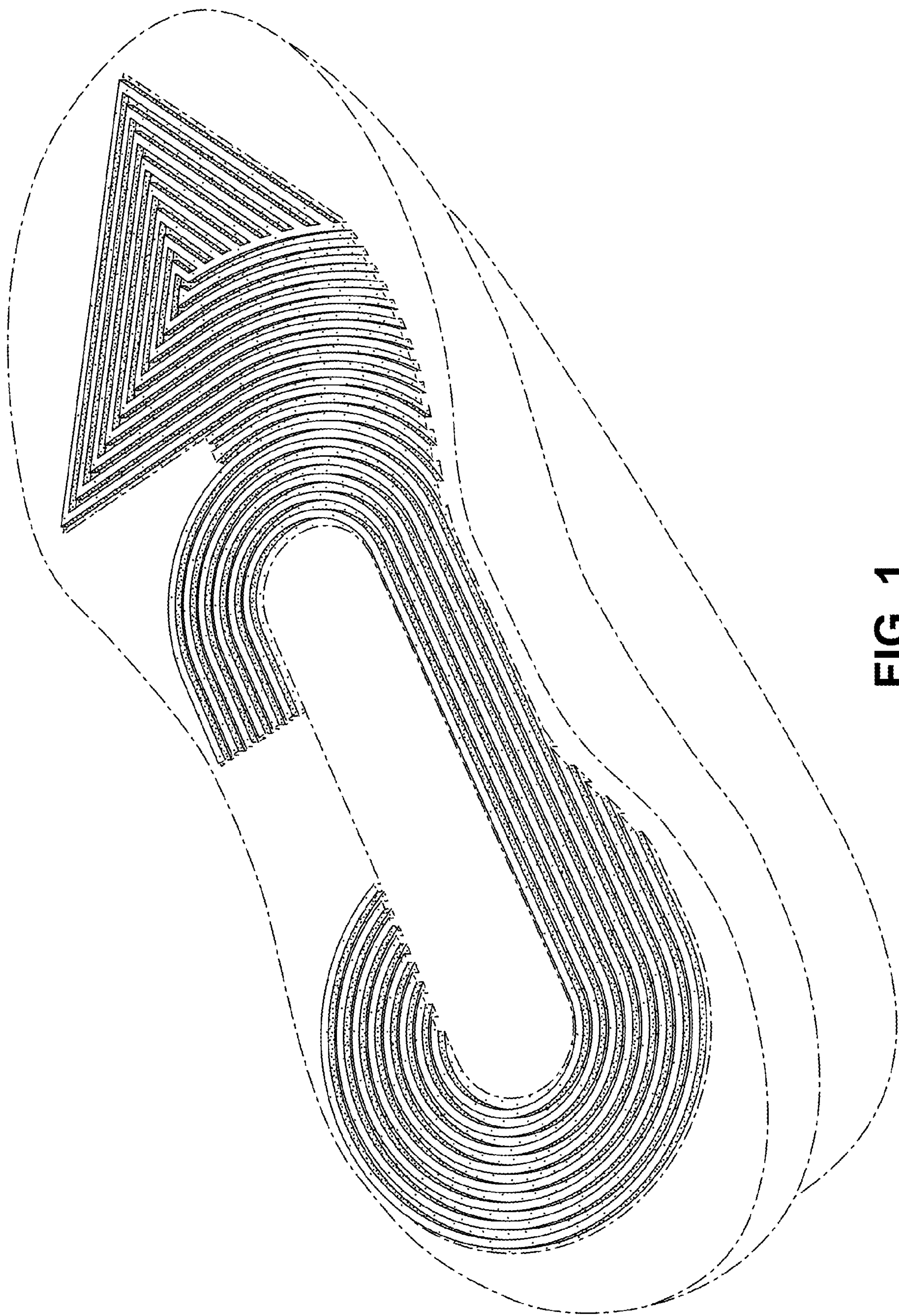

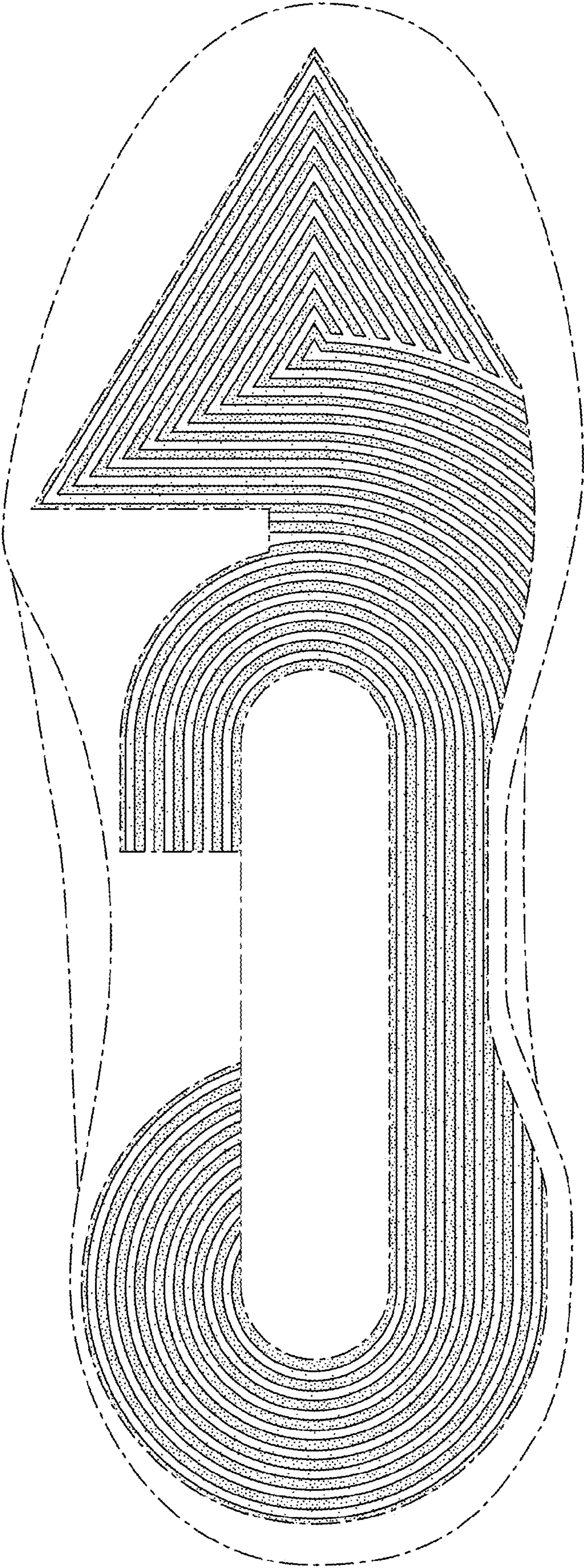

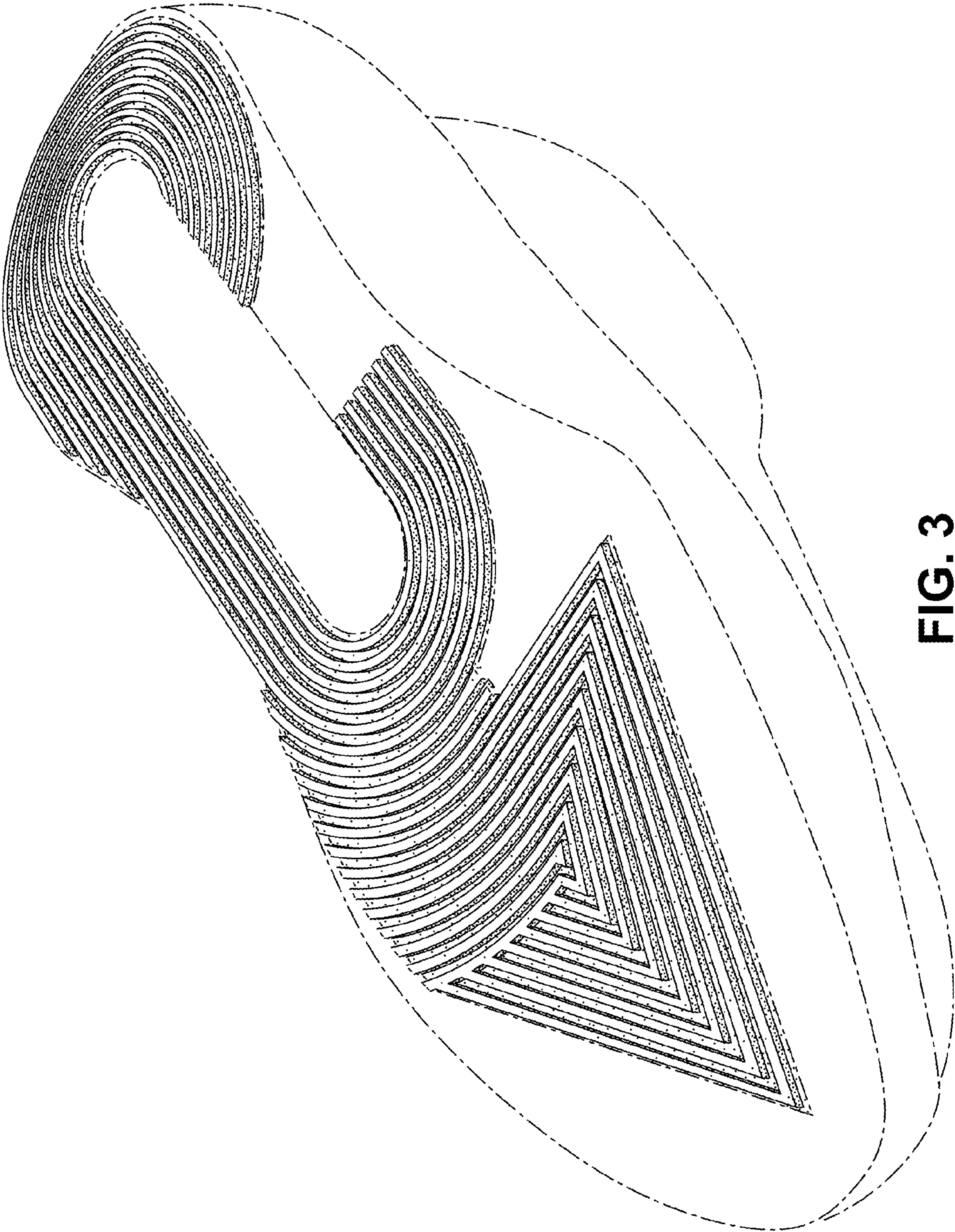
