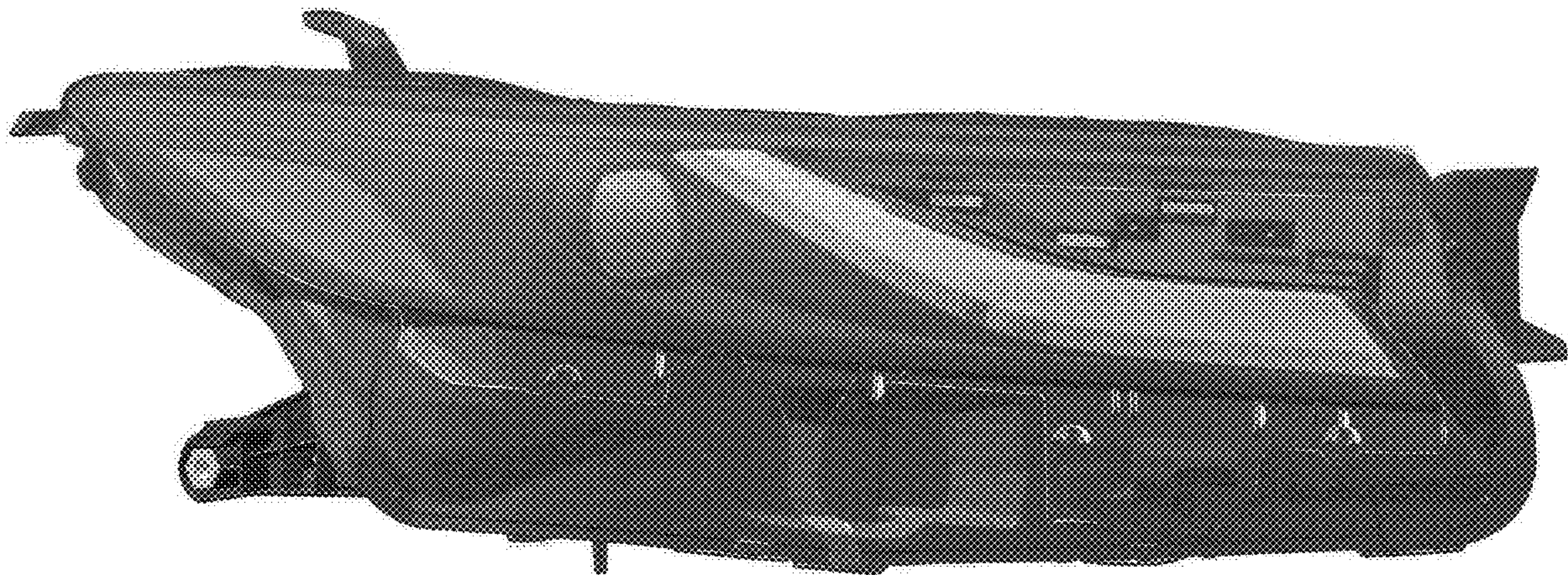
CLAIM

DESCRIPTION

FIG. 1 is a perspective view of a front combination lamp for a motor vehicle showing our new design;

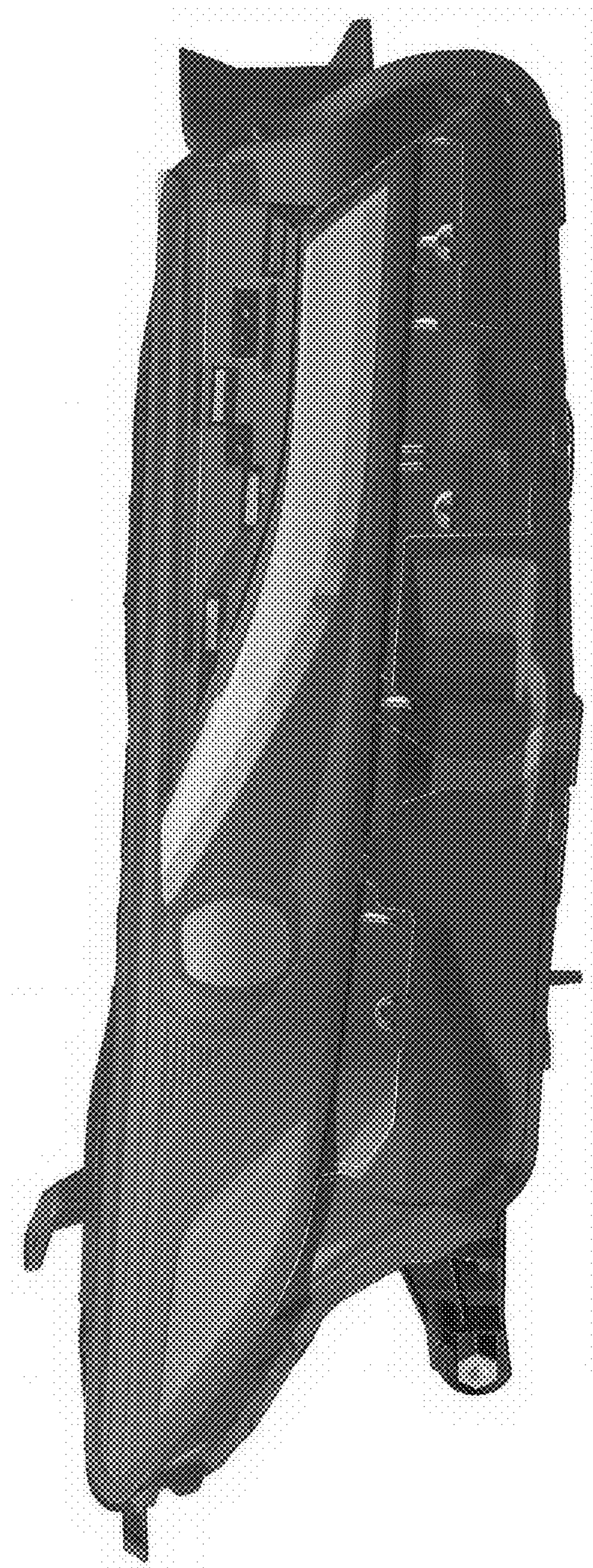

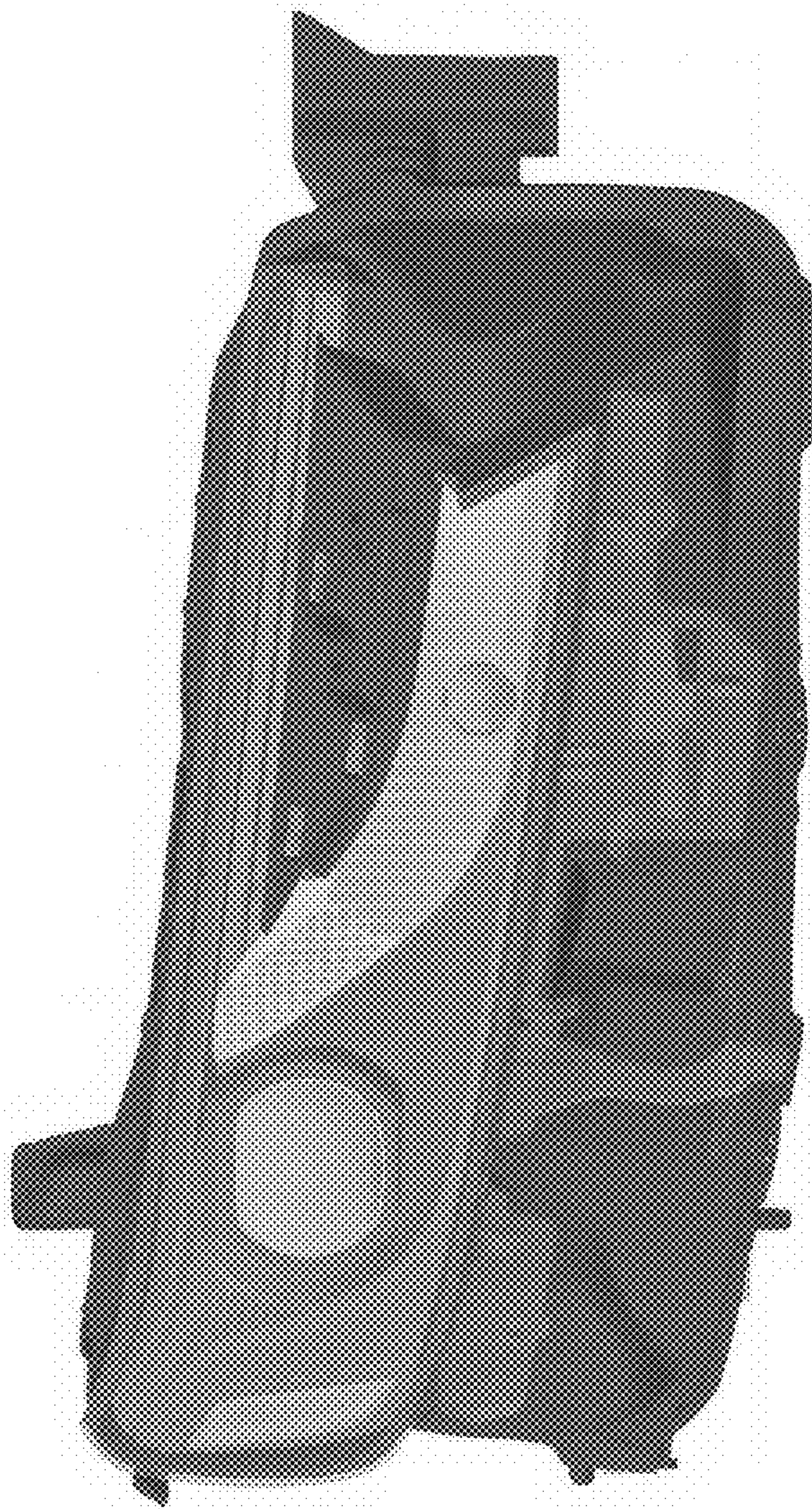

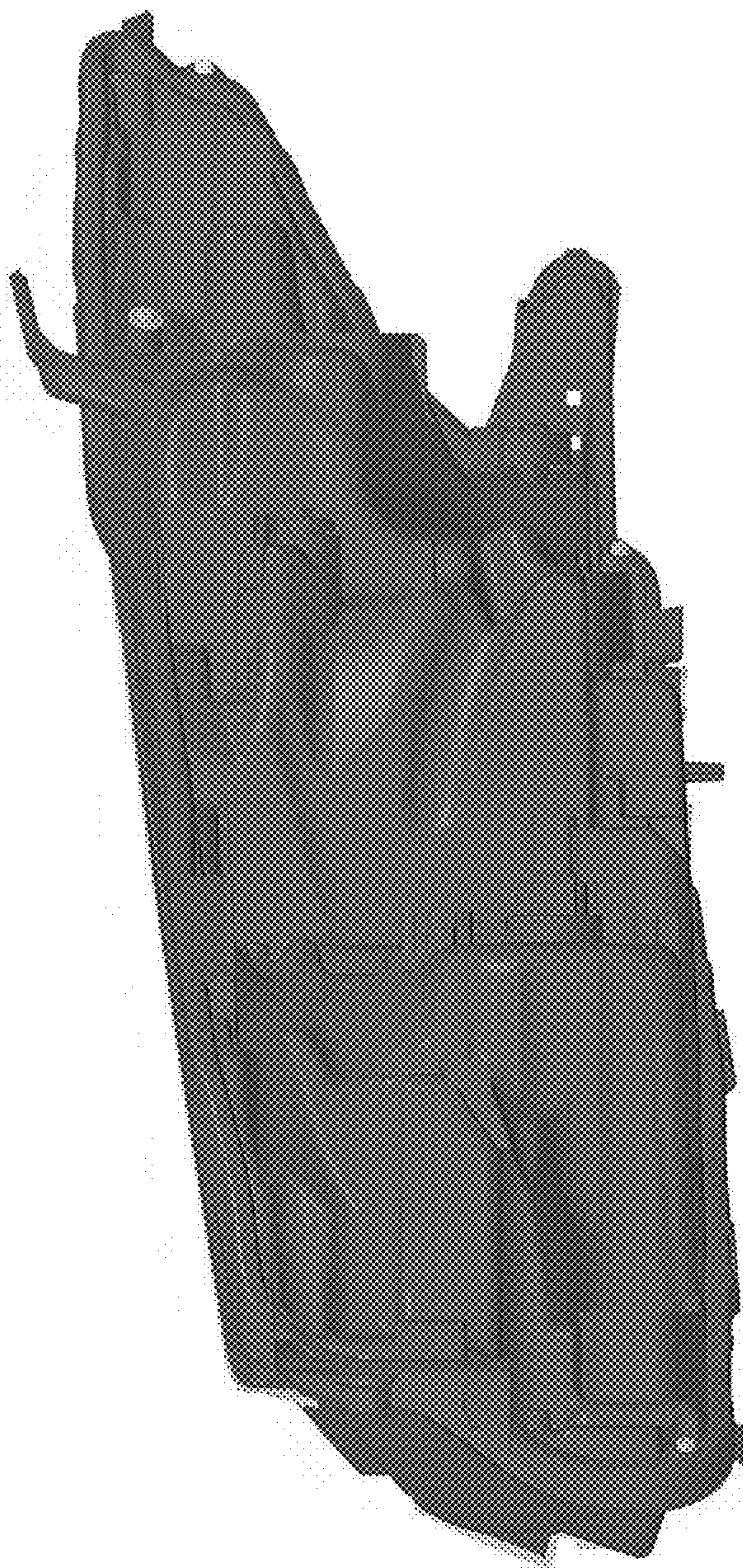

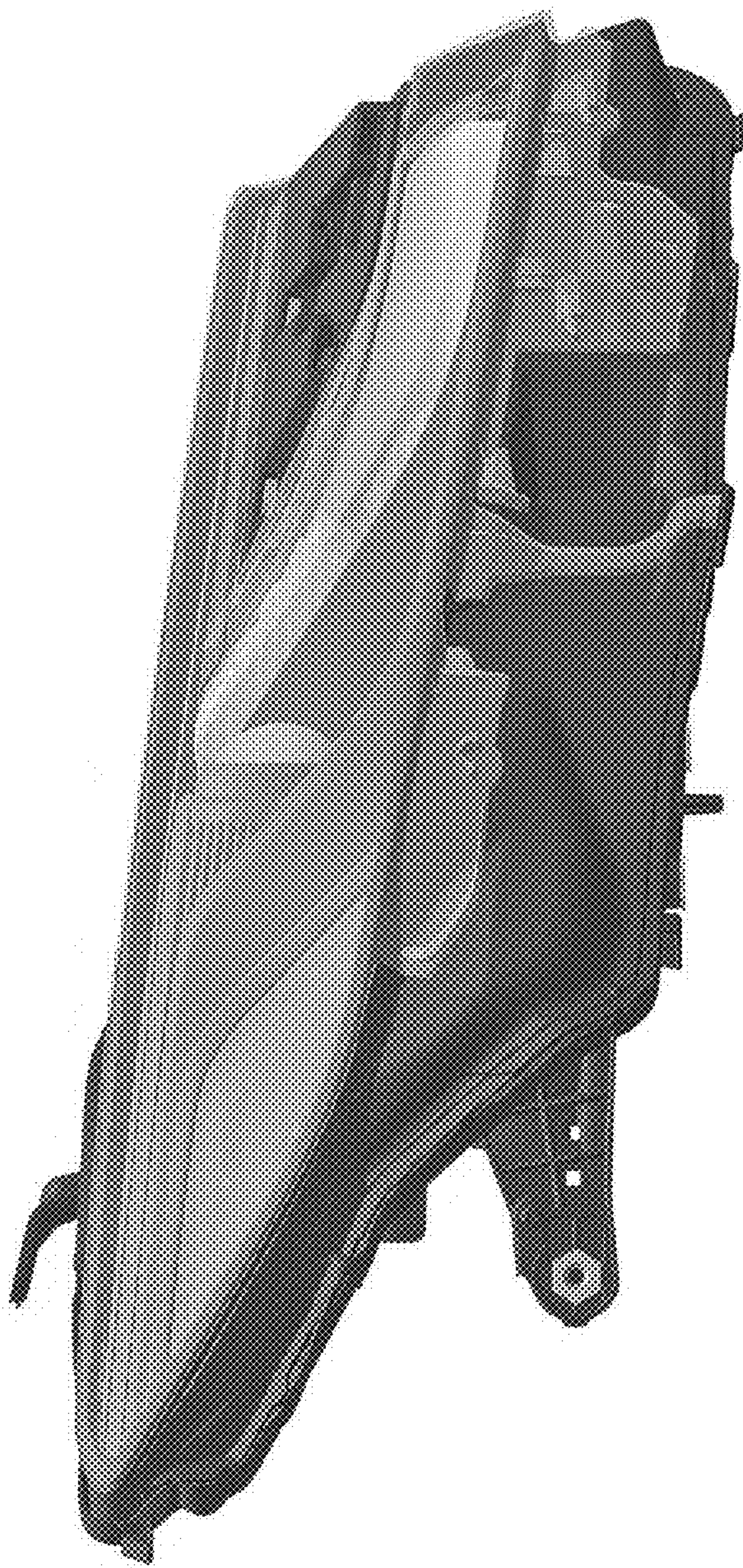

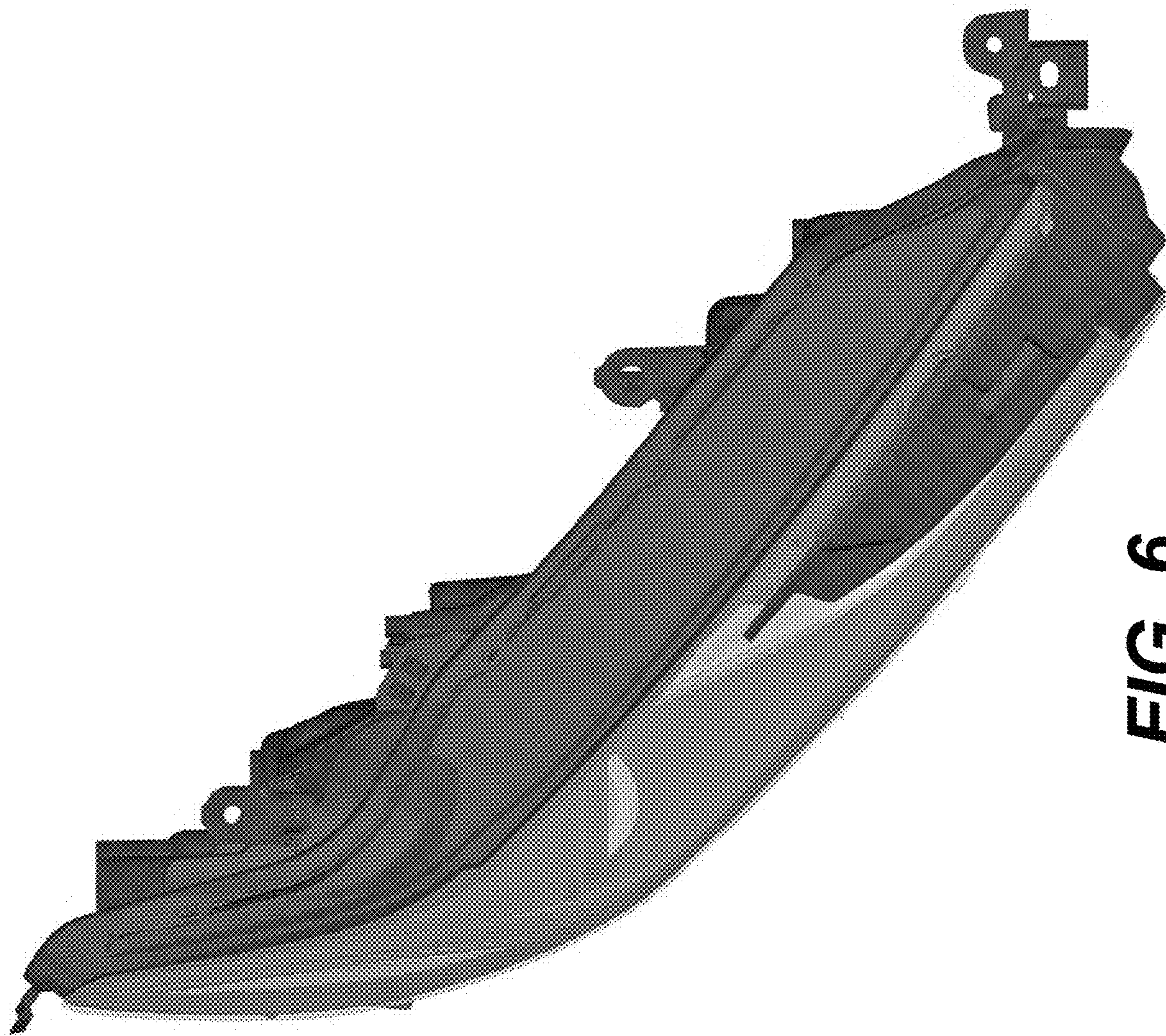

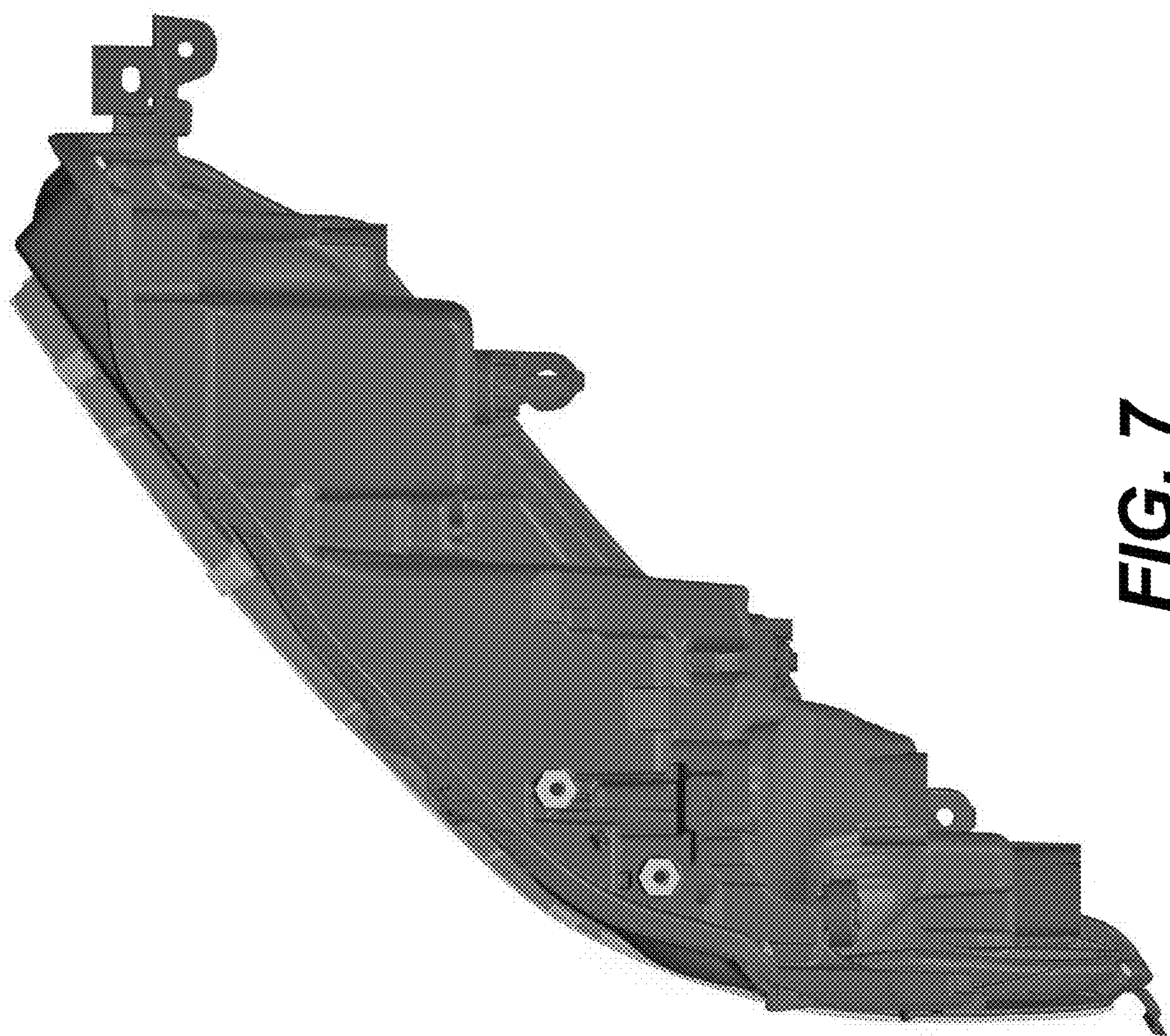
