The ornamental design for an automobile tire as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an automobile tire showing my design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof;

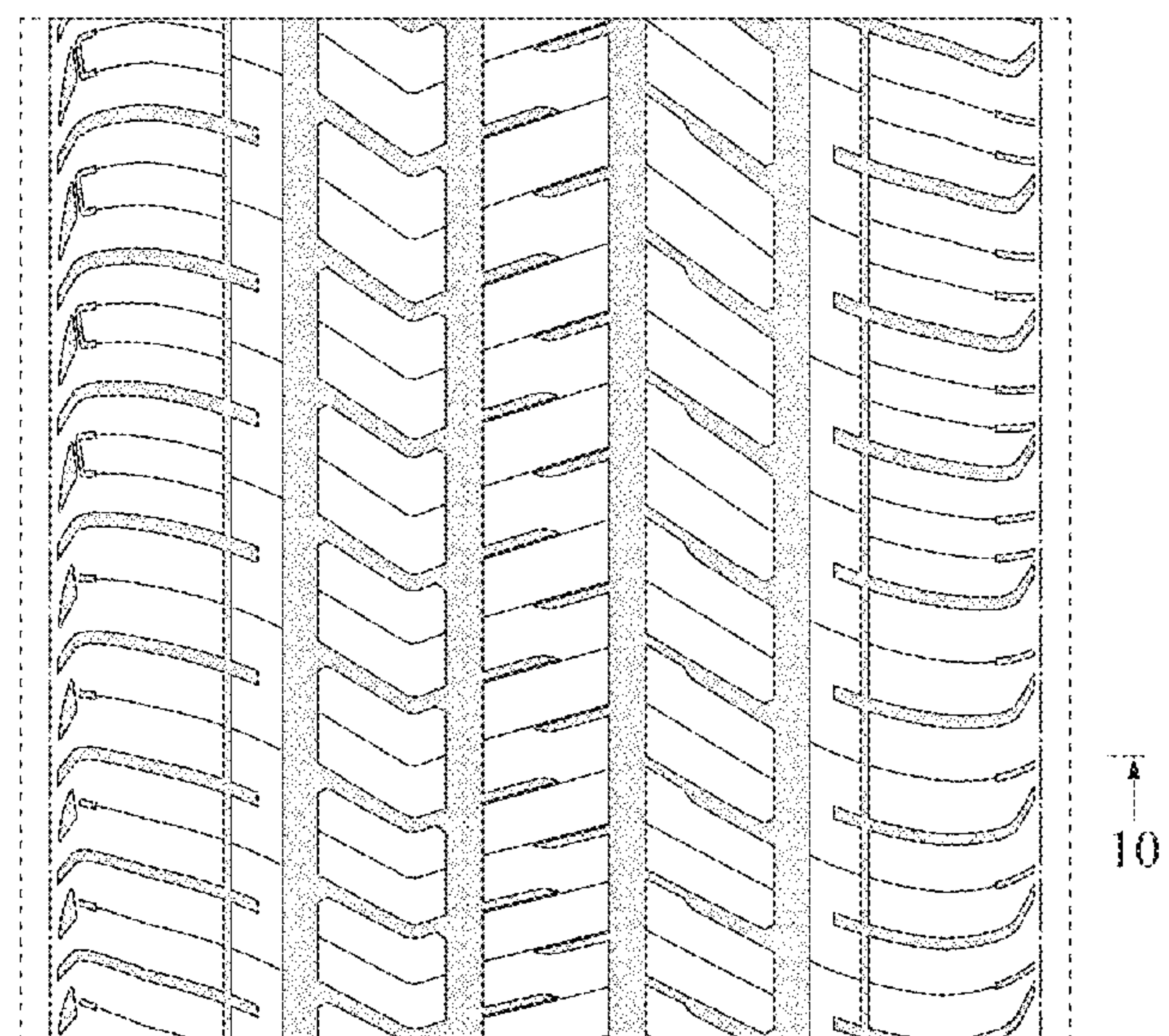
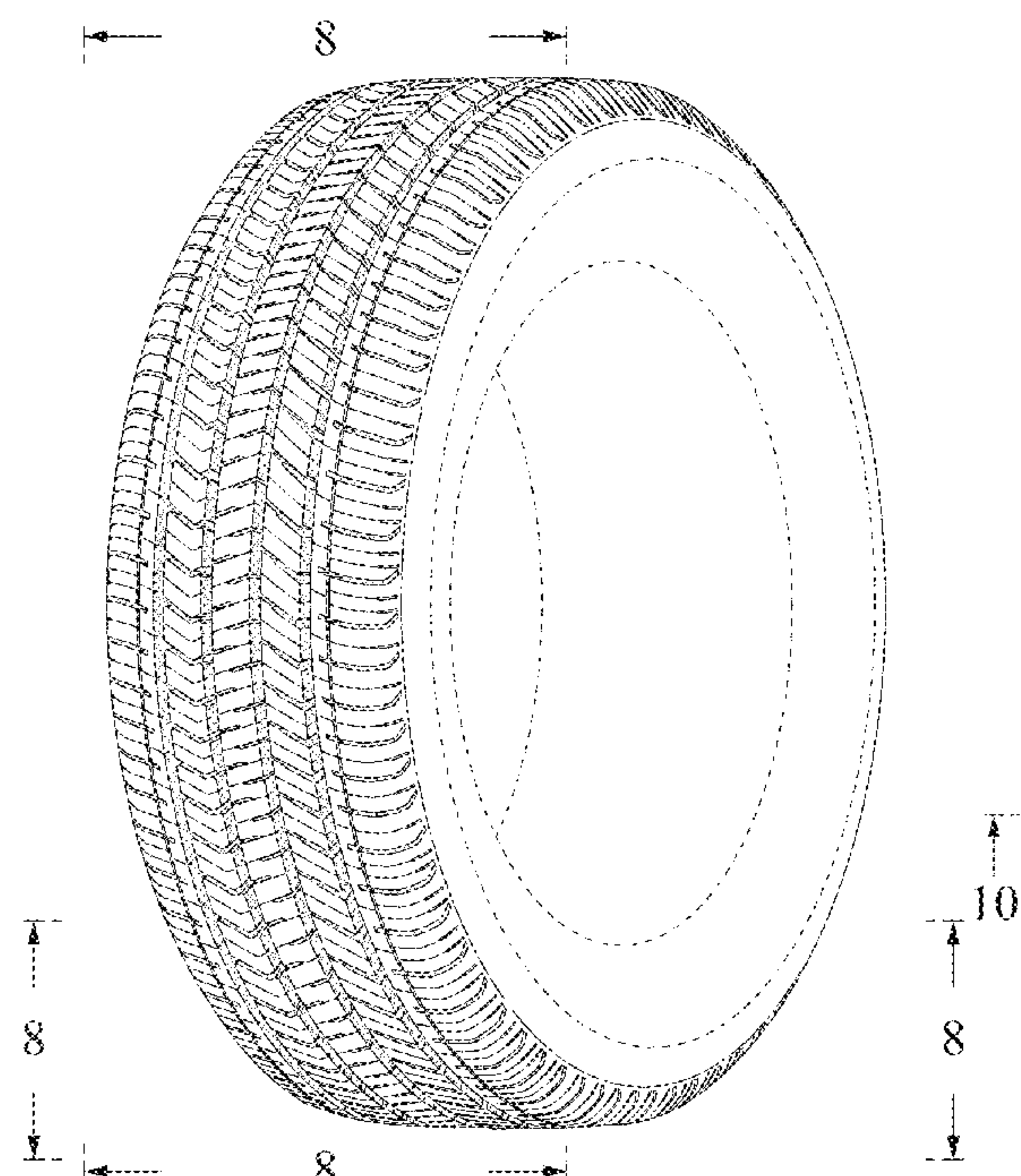

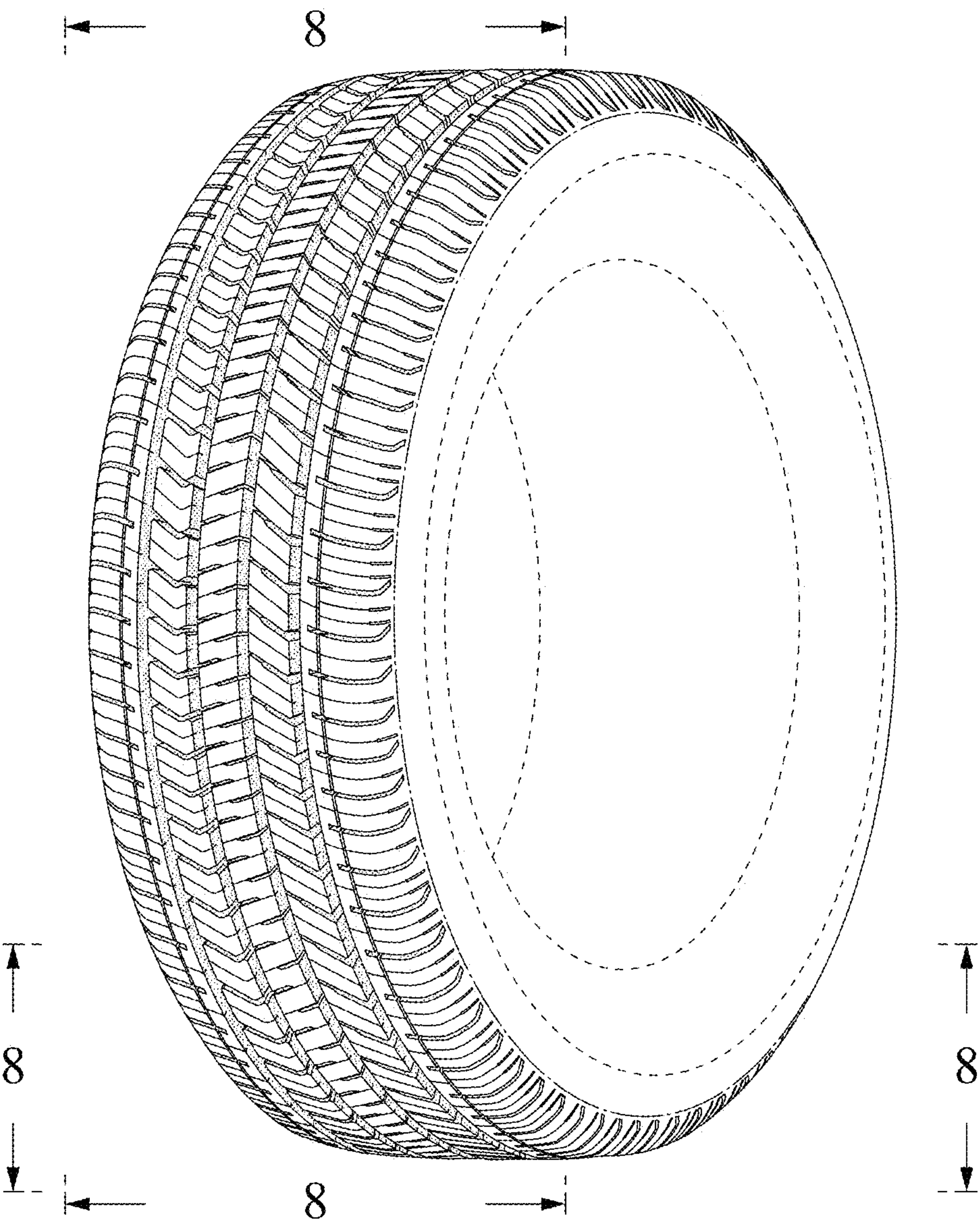

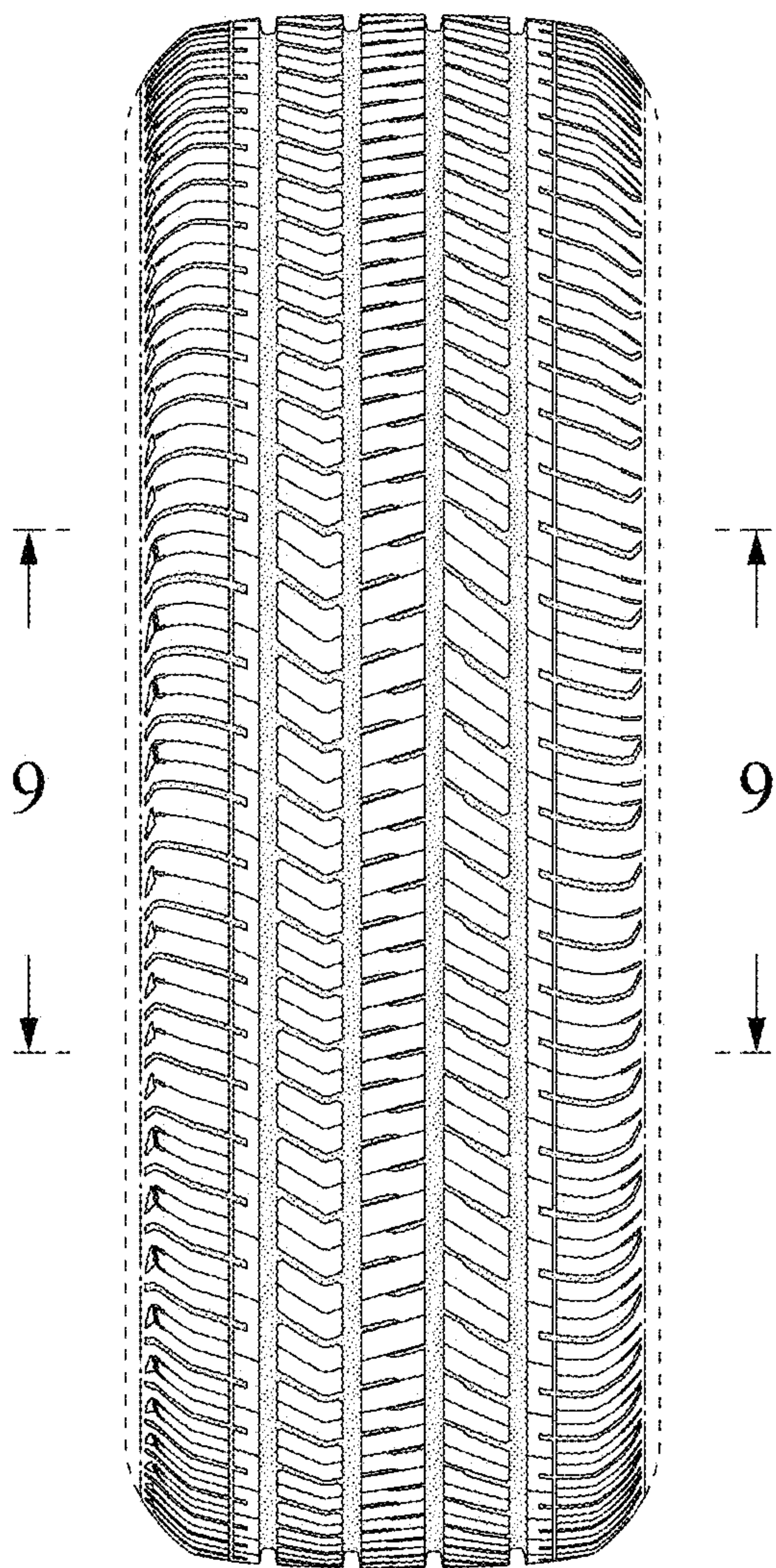

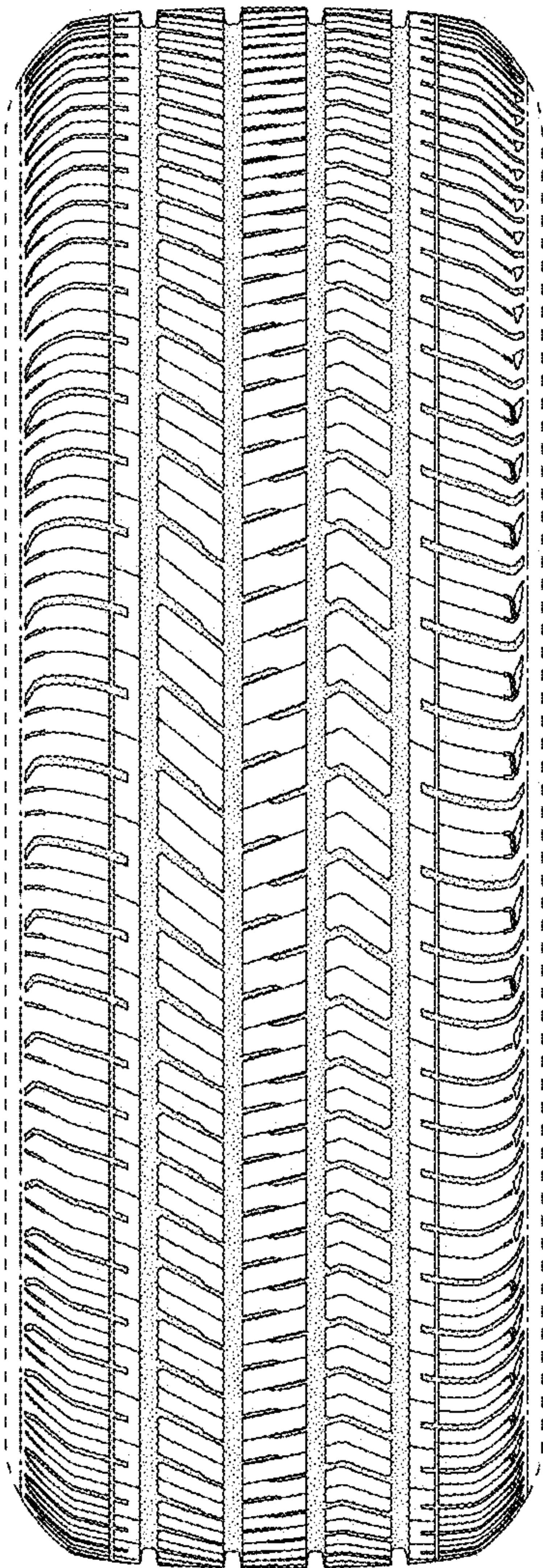

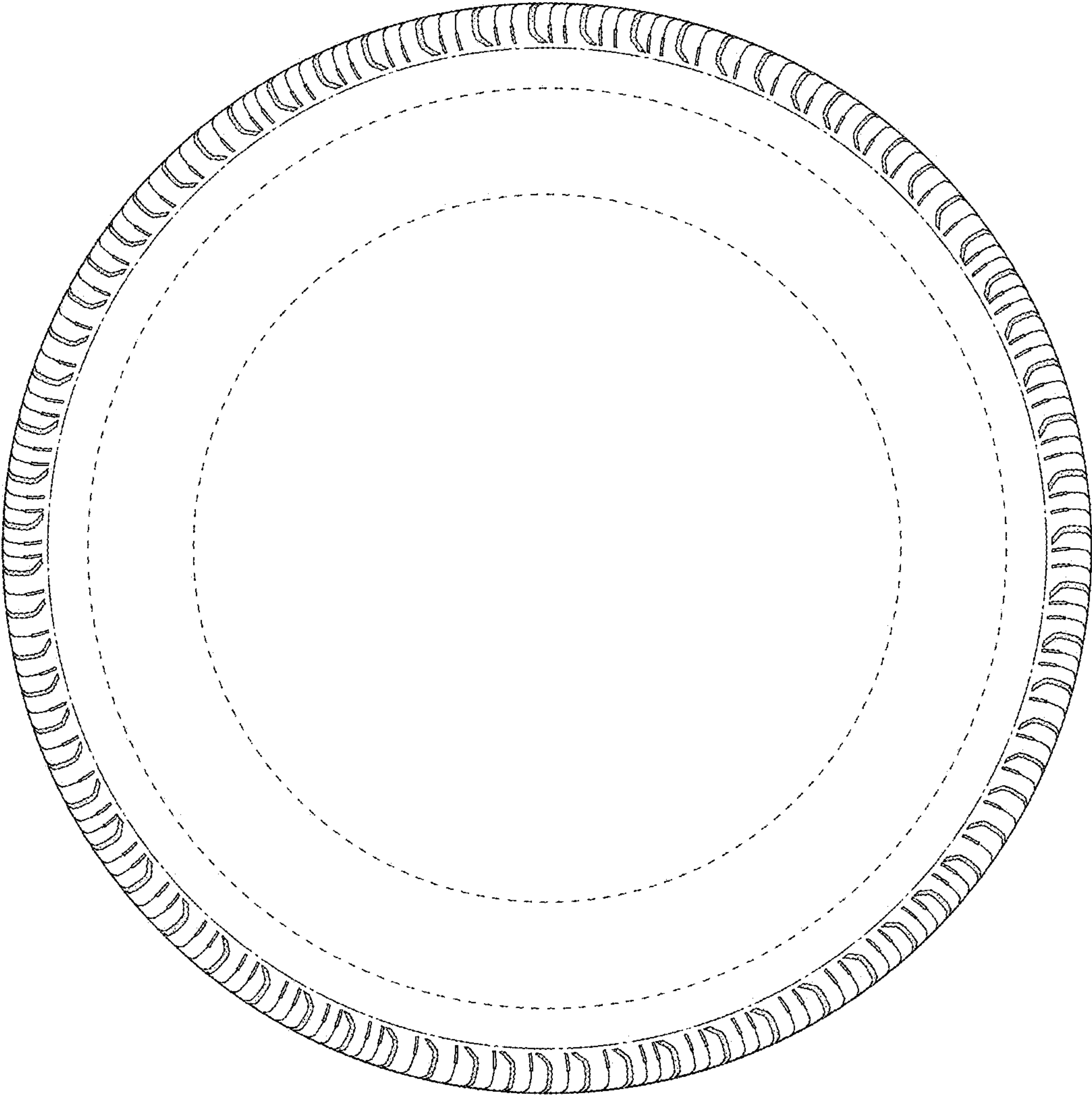

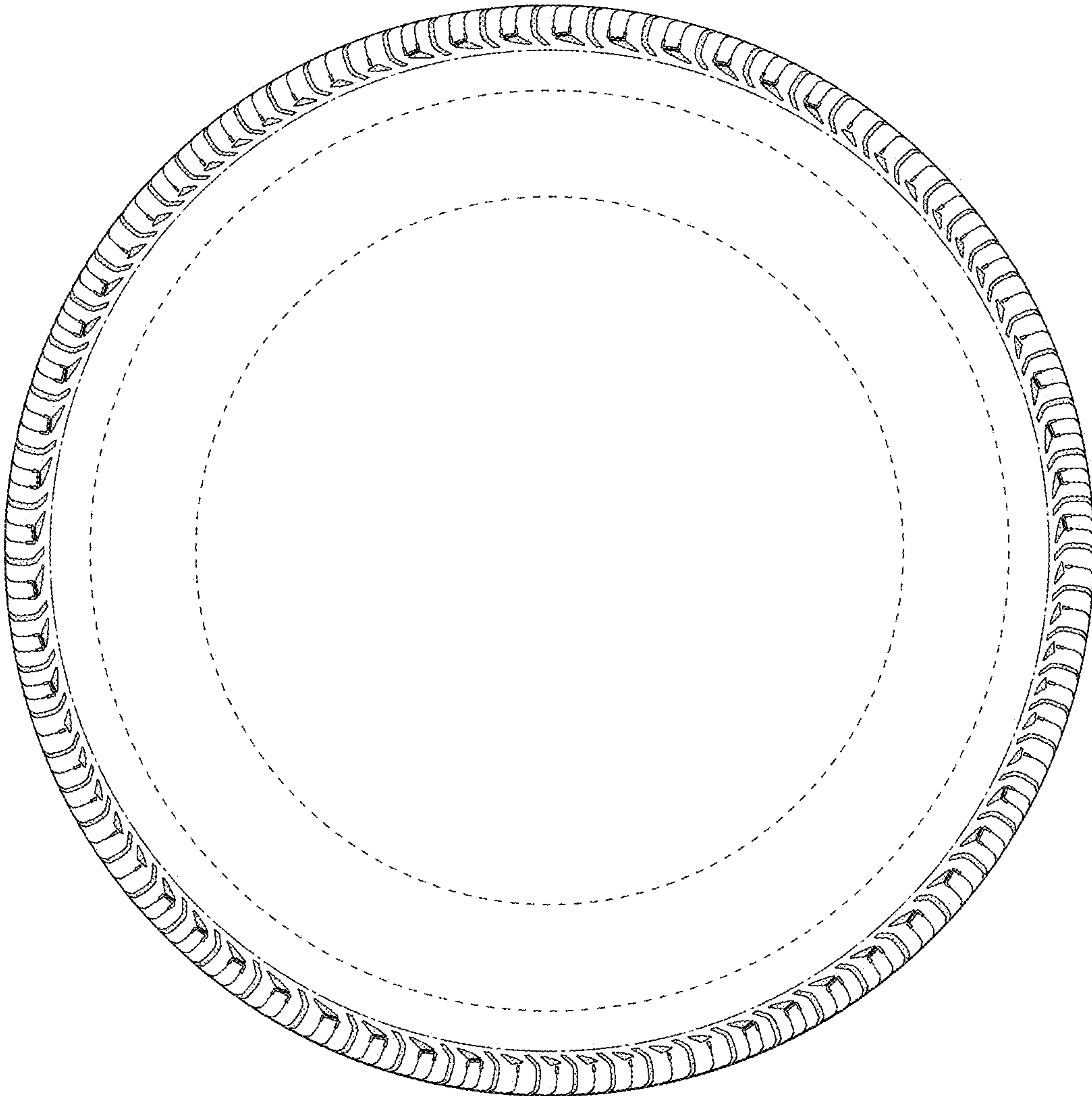

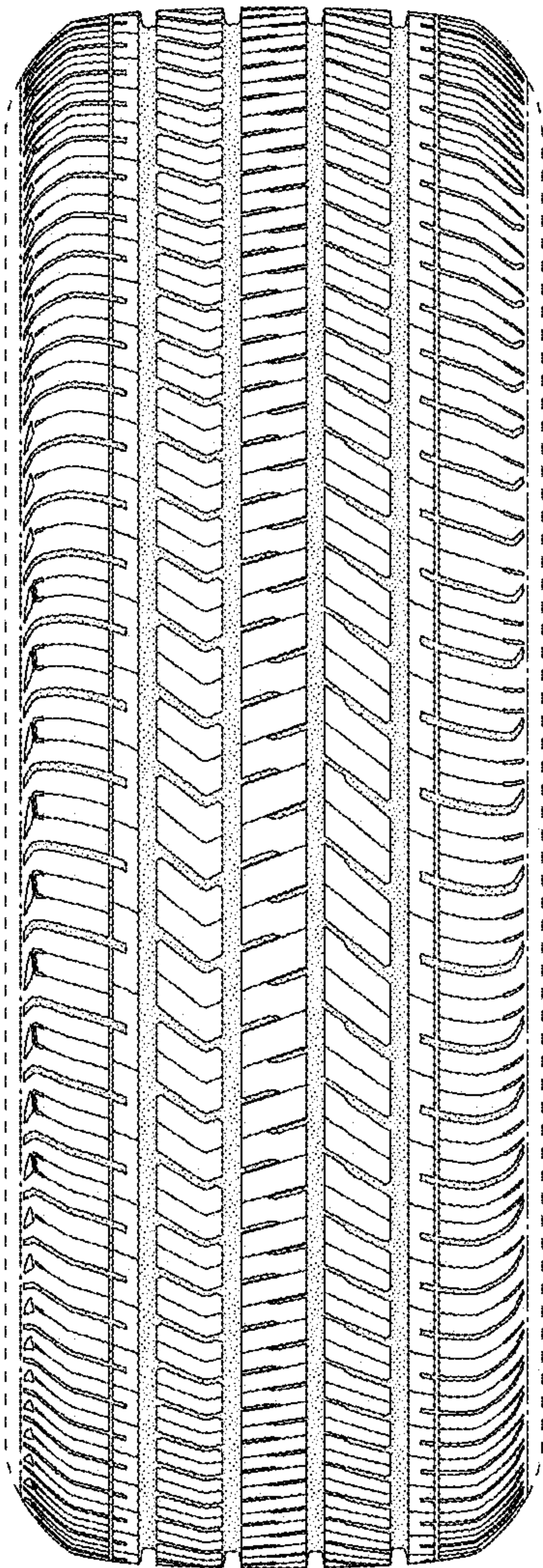

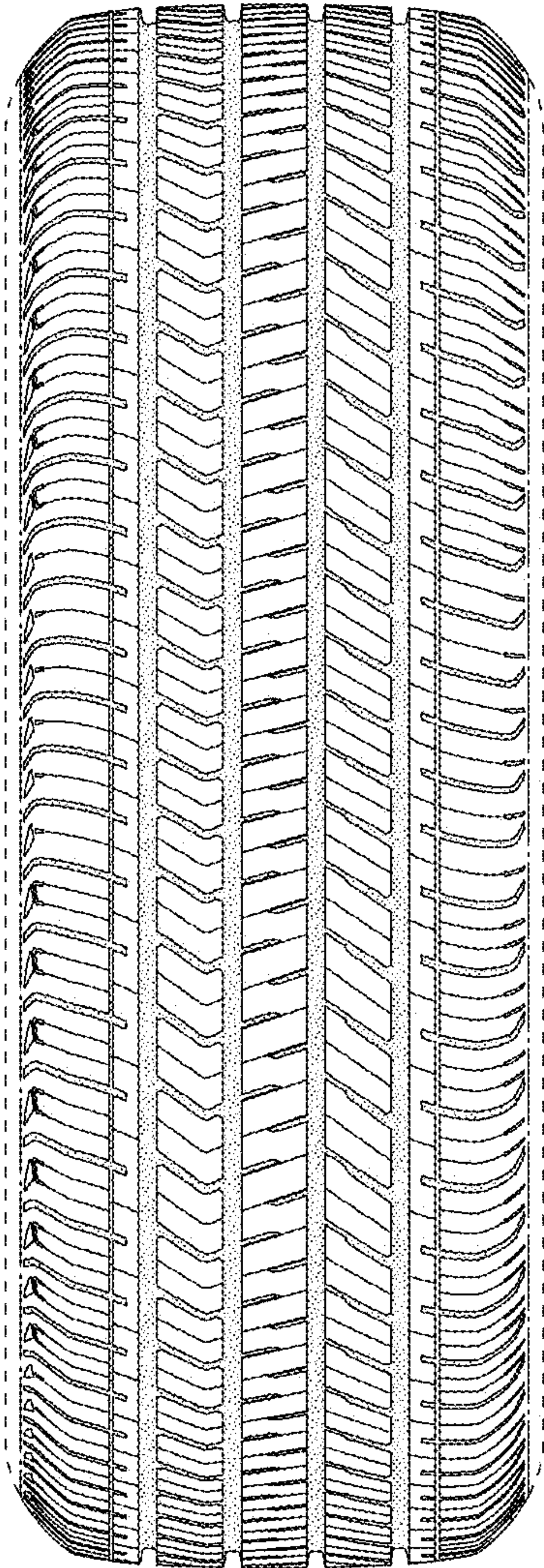

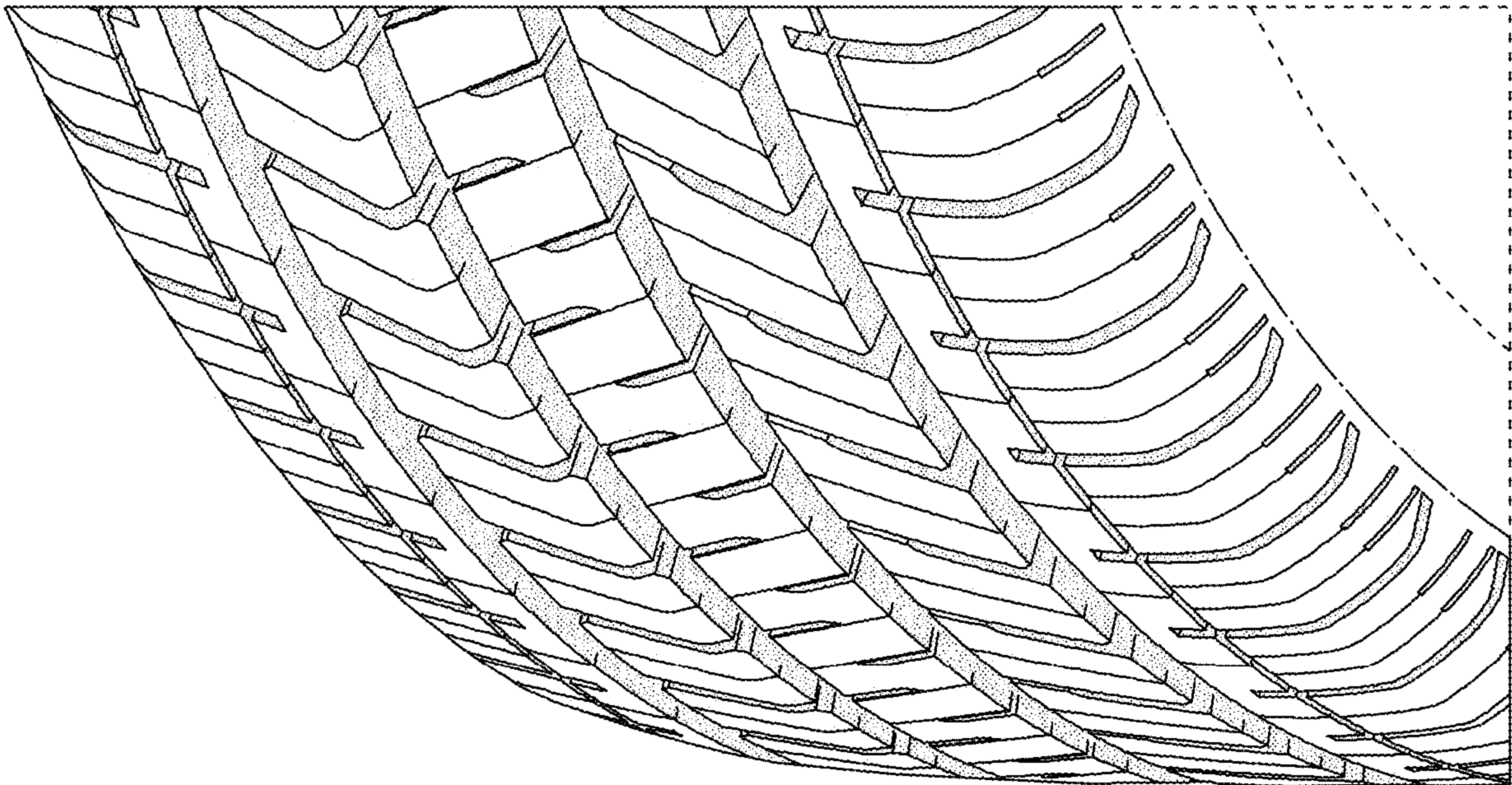

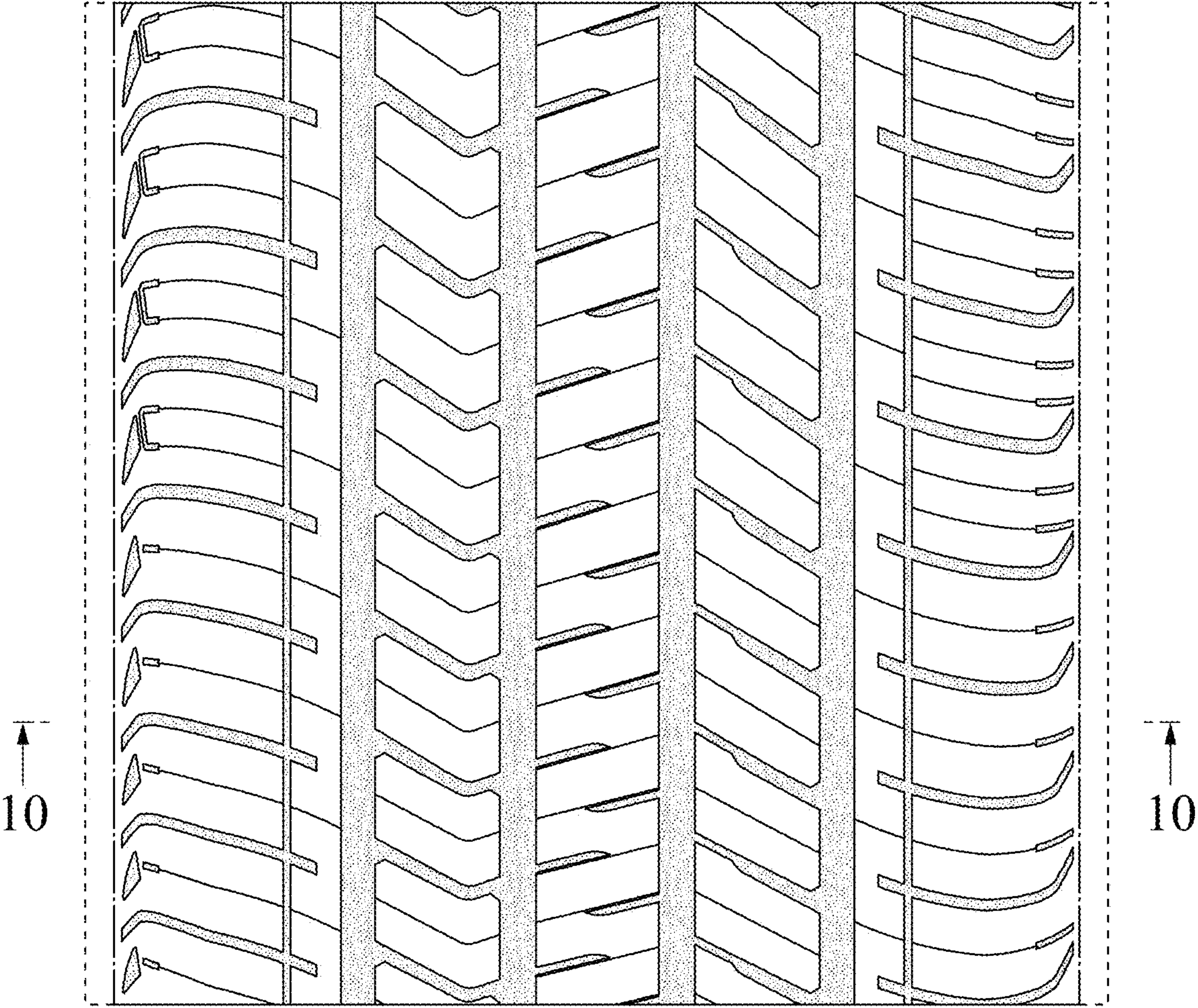
