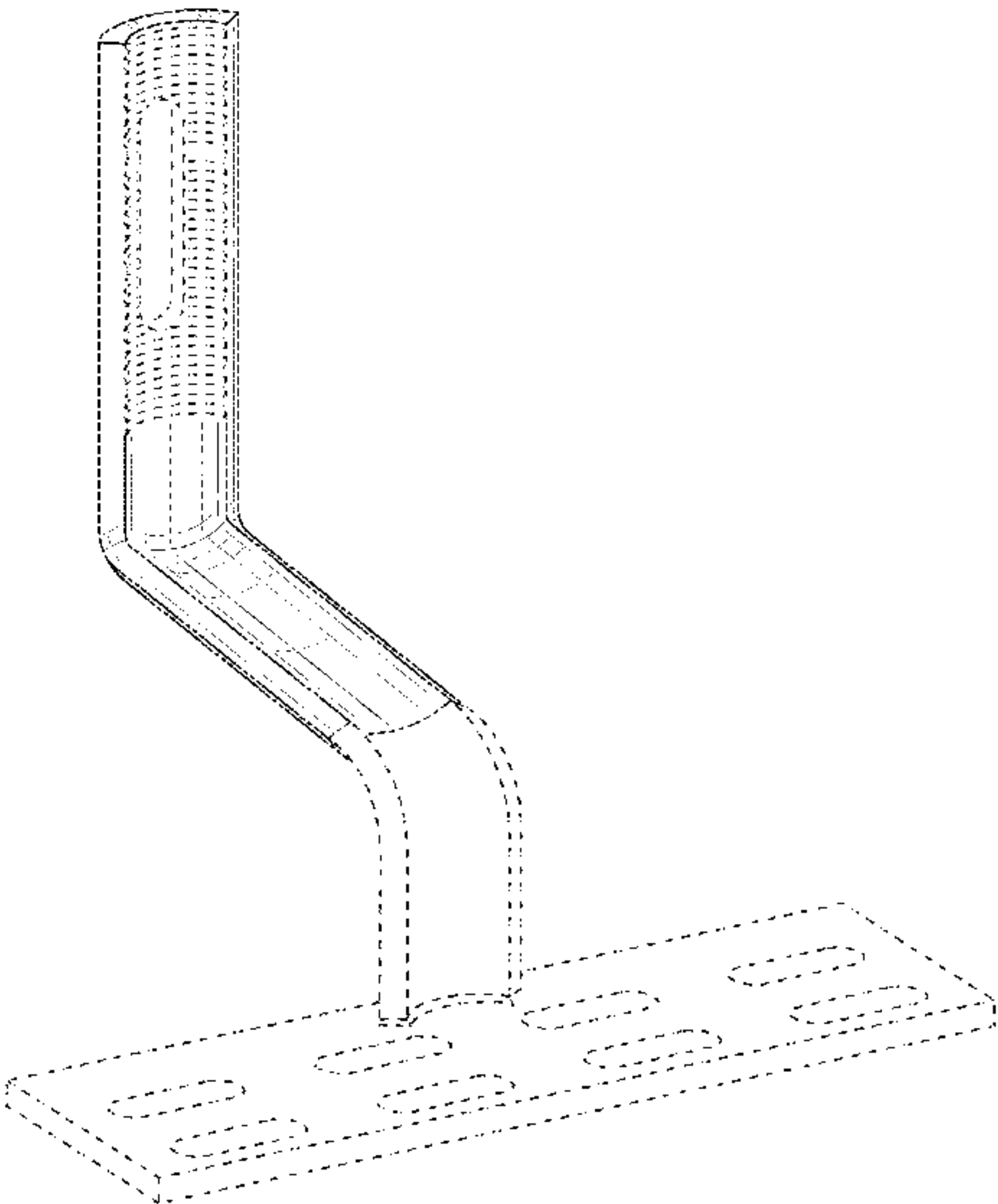
The ornamental design for a bracket, as shown and described.

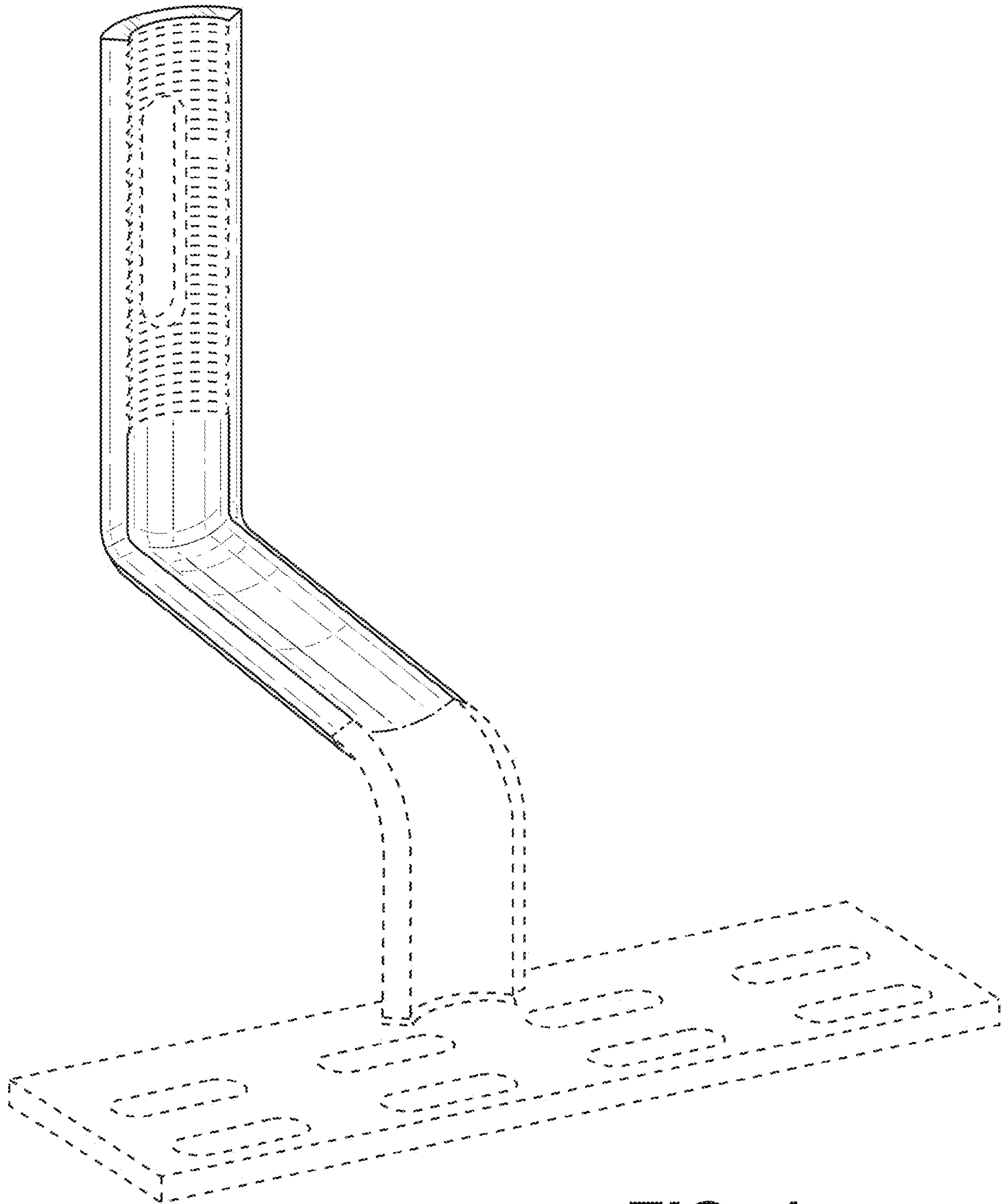

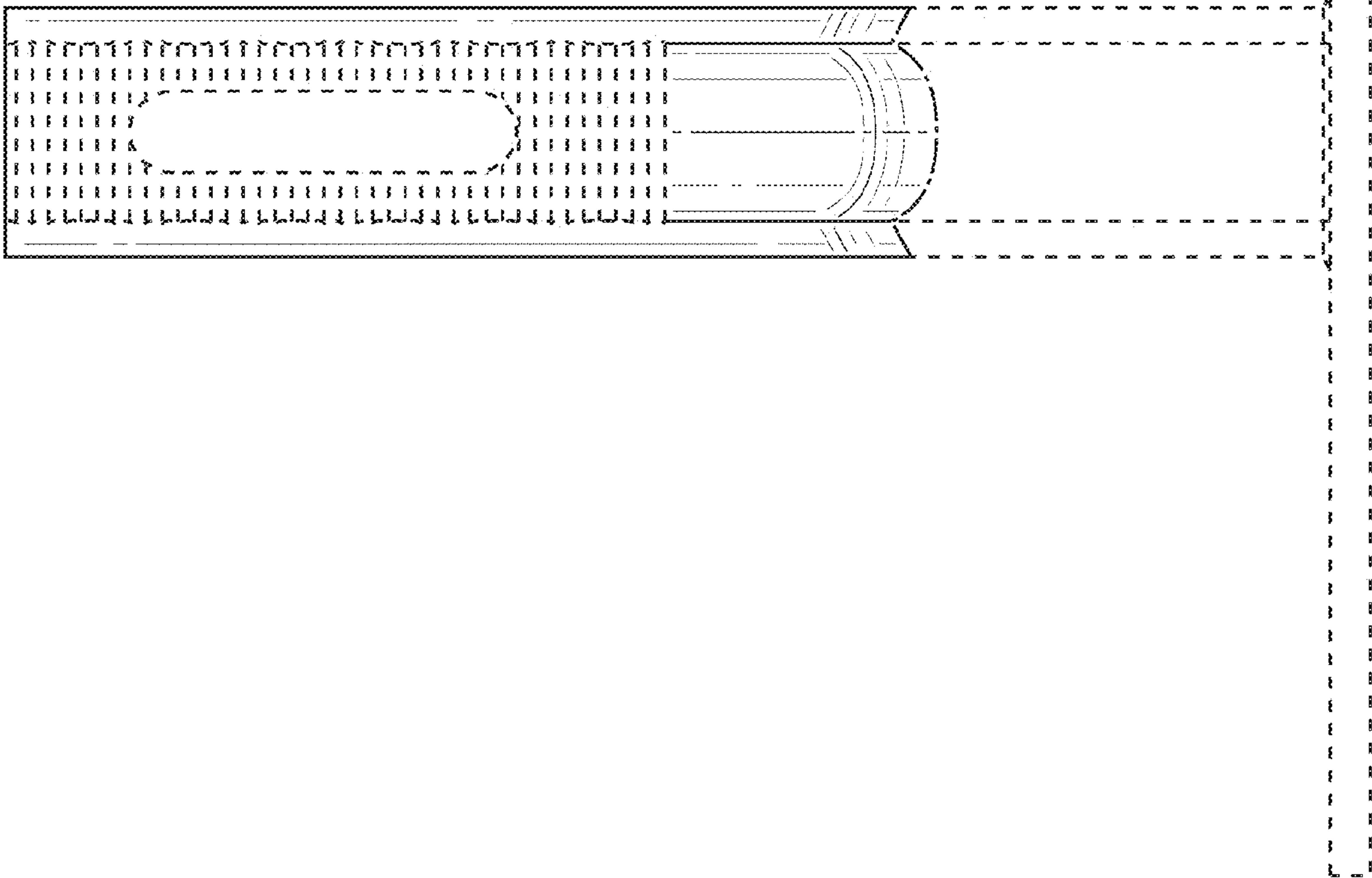

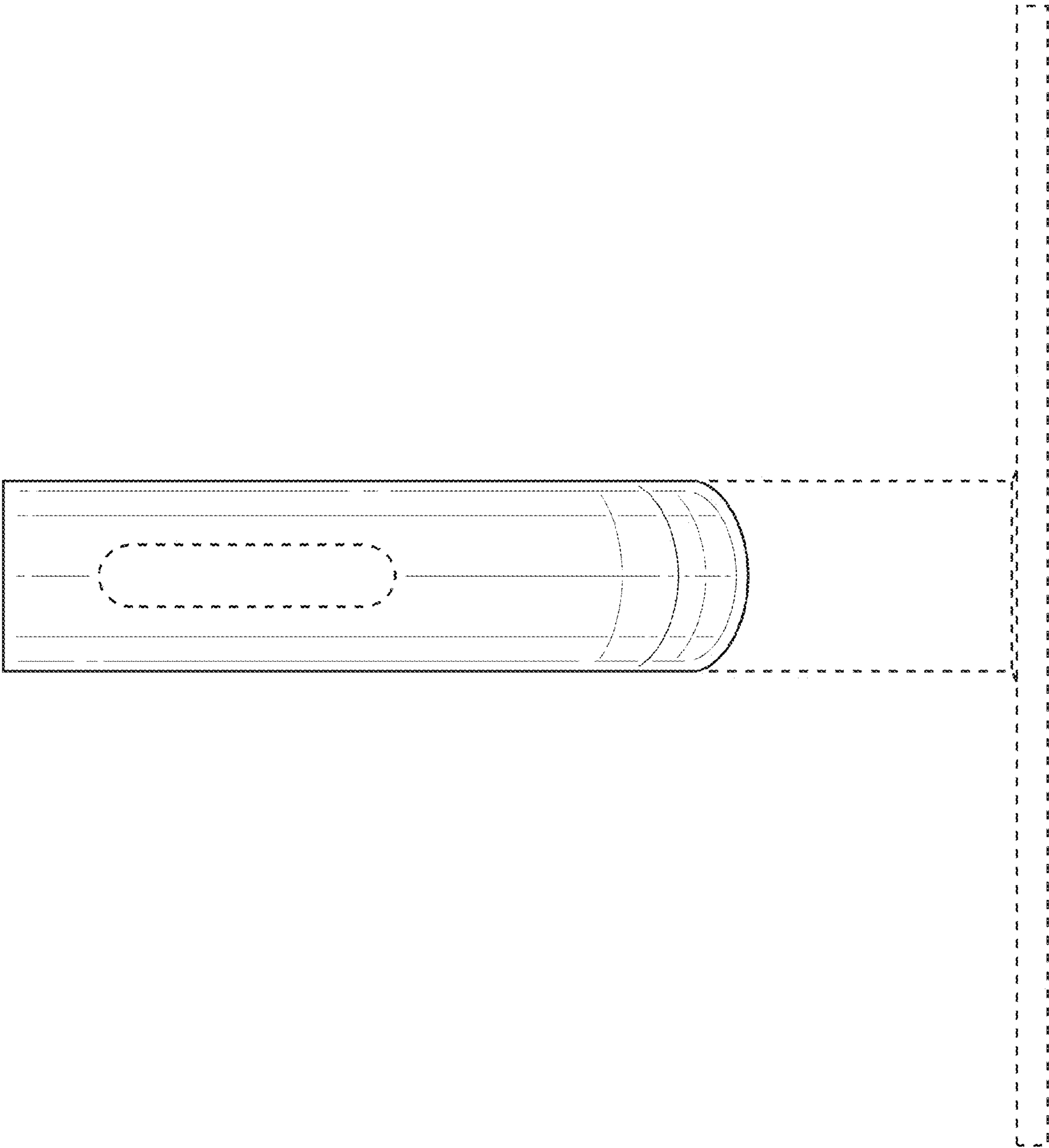
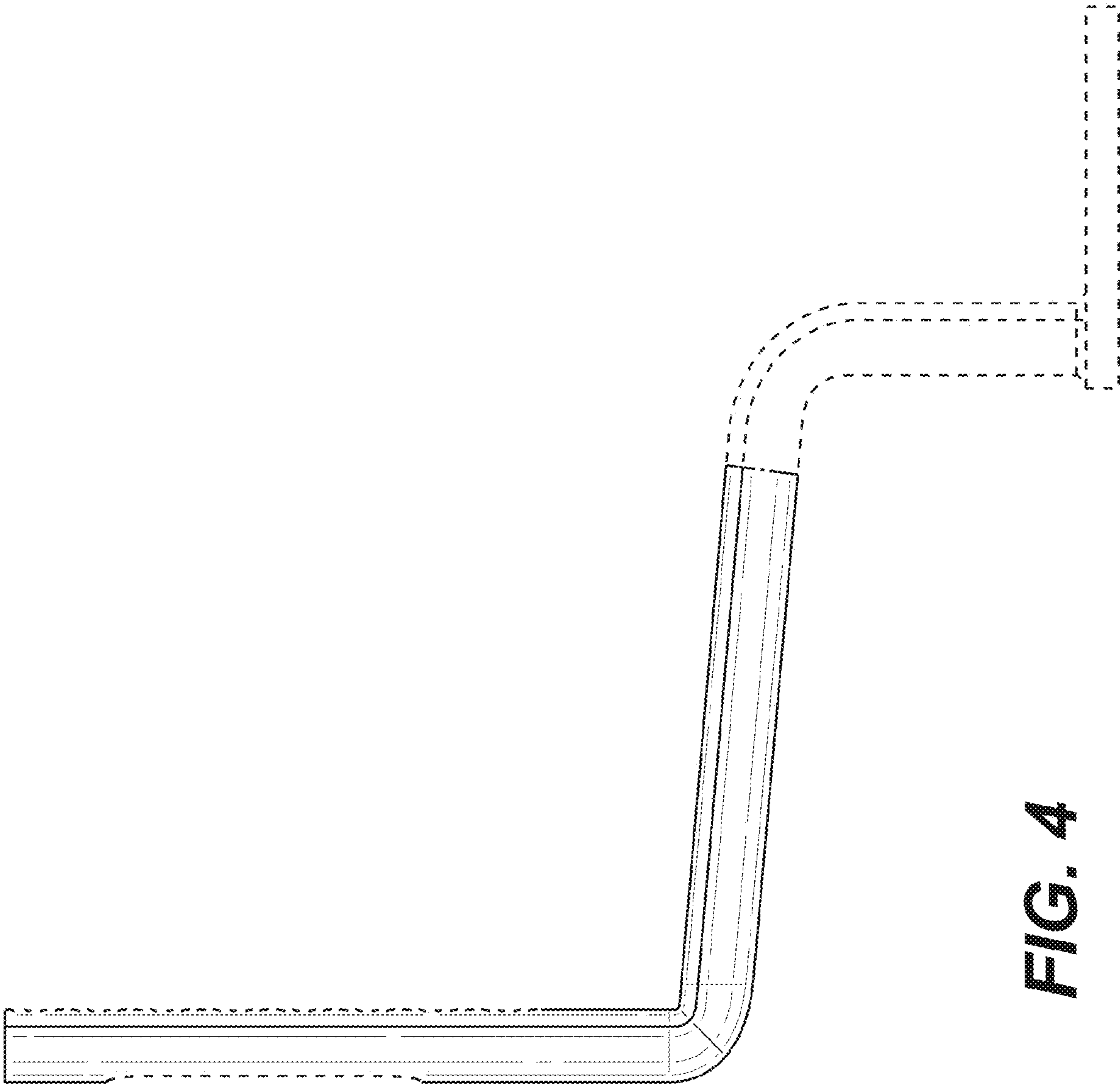
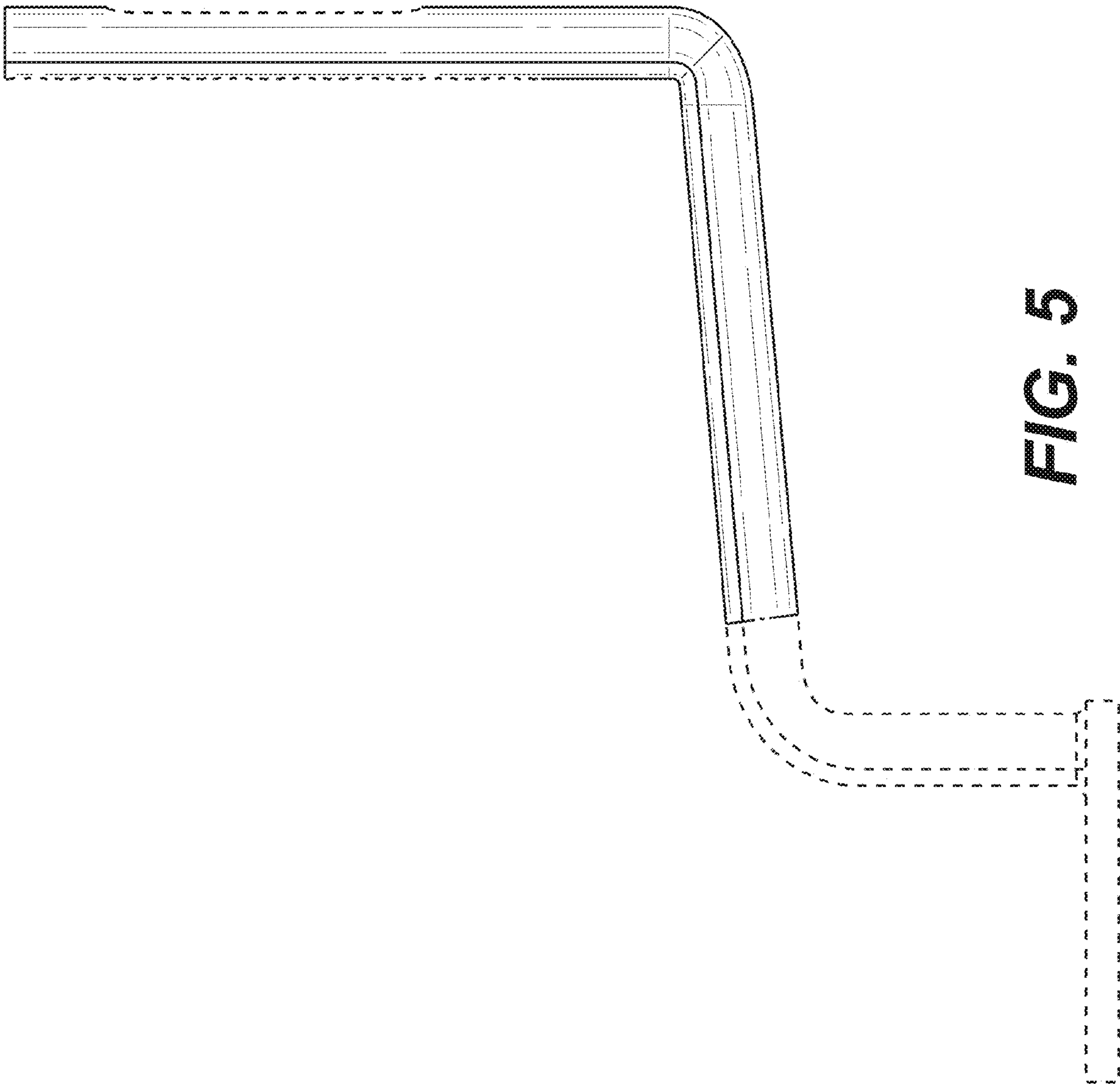

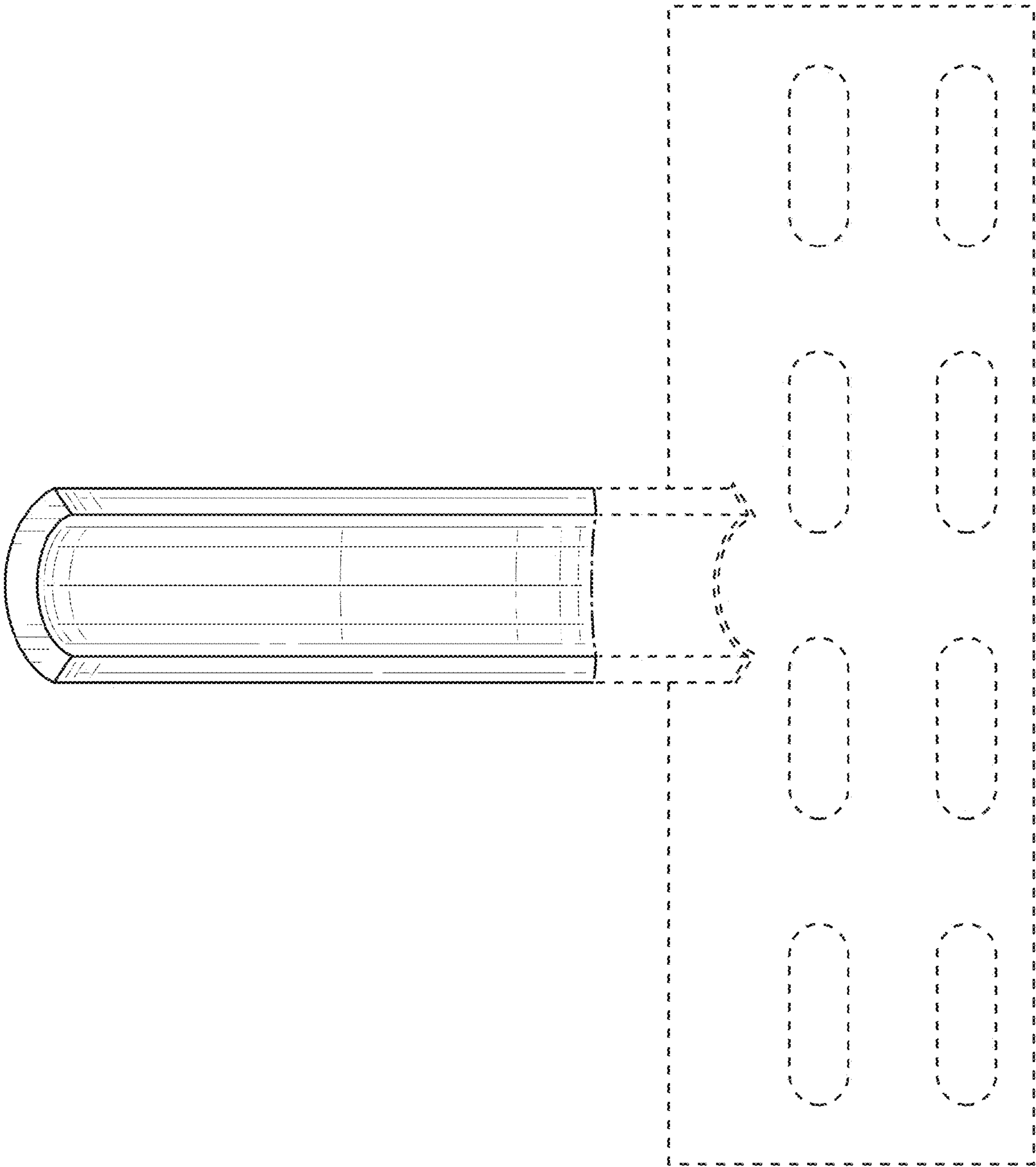
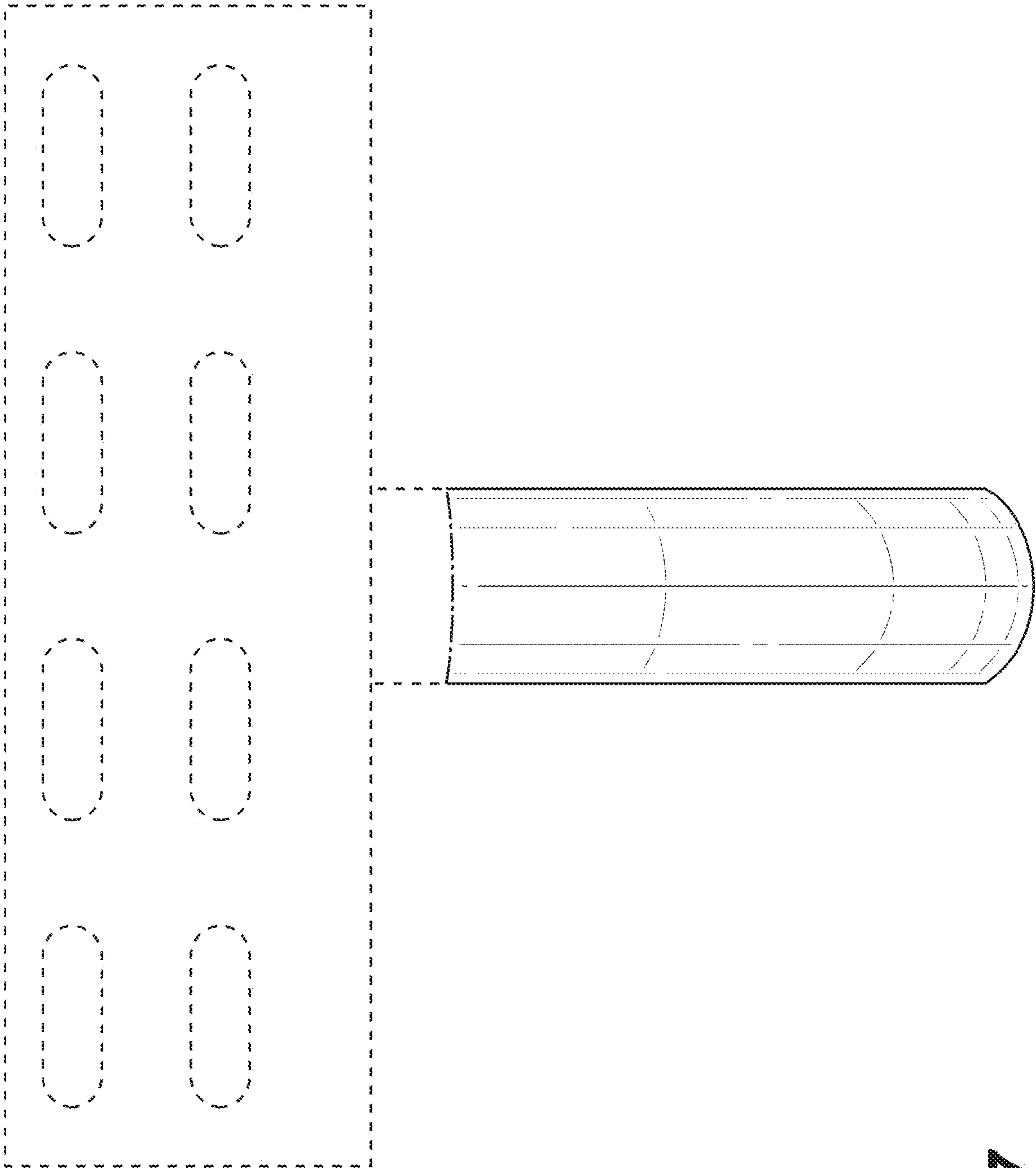
