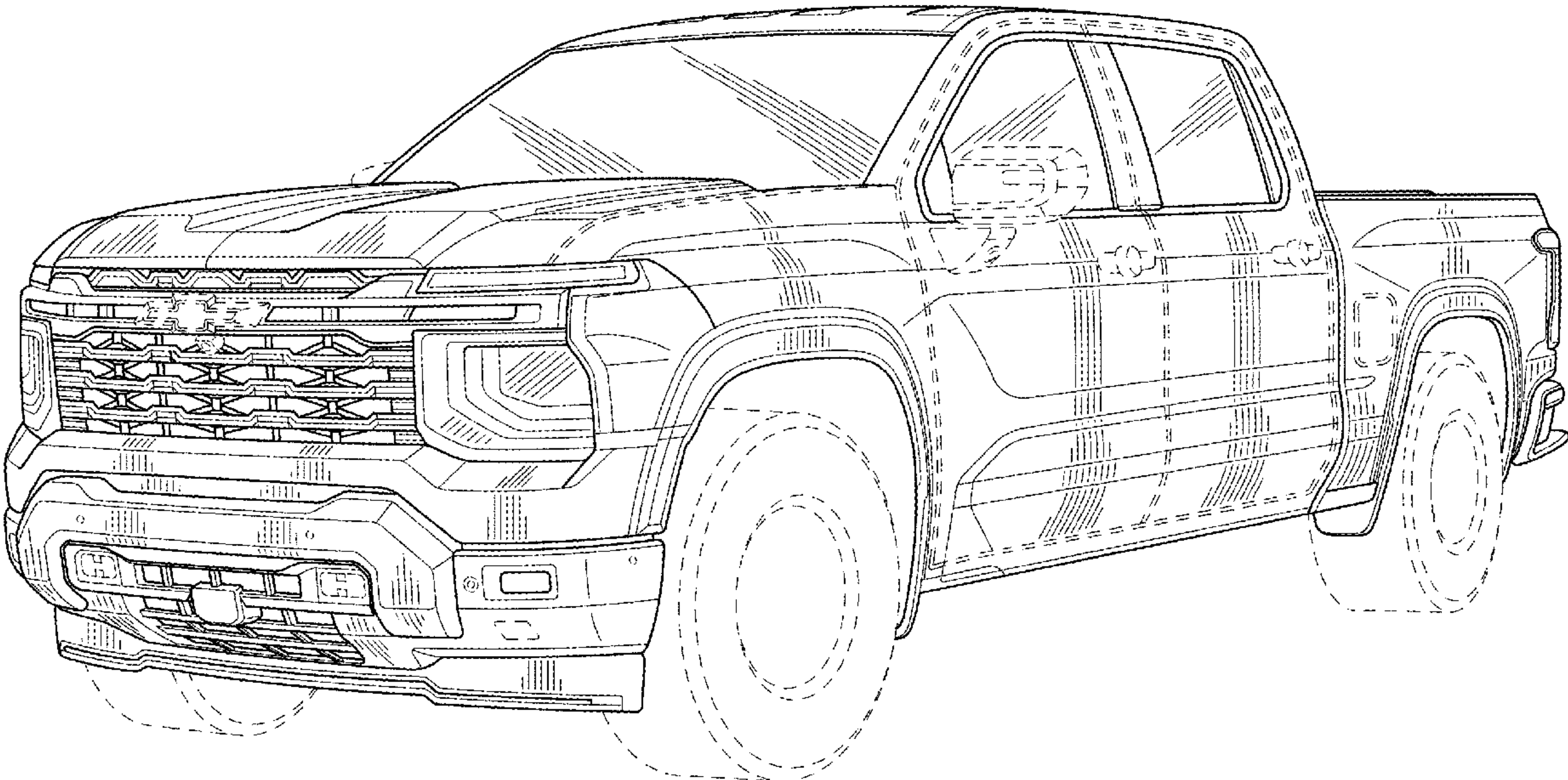
(57) **CLAIM**

The ornamental design for a vehicle, toy replica, and/or other replica, as shown and described.

DESCRIPTION

FIG. 1 is a front and left side perspective view of a vehicle, toy replica, and/or other replica showing my new design; FIG. 2 is a rear and left side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a rear elevation view thereof; and, FIG. 7 is a top plan view thereof. 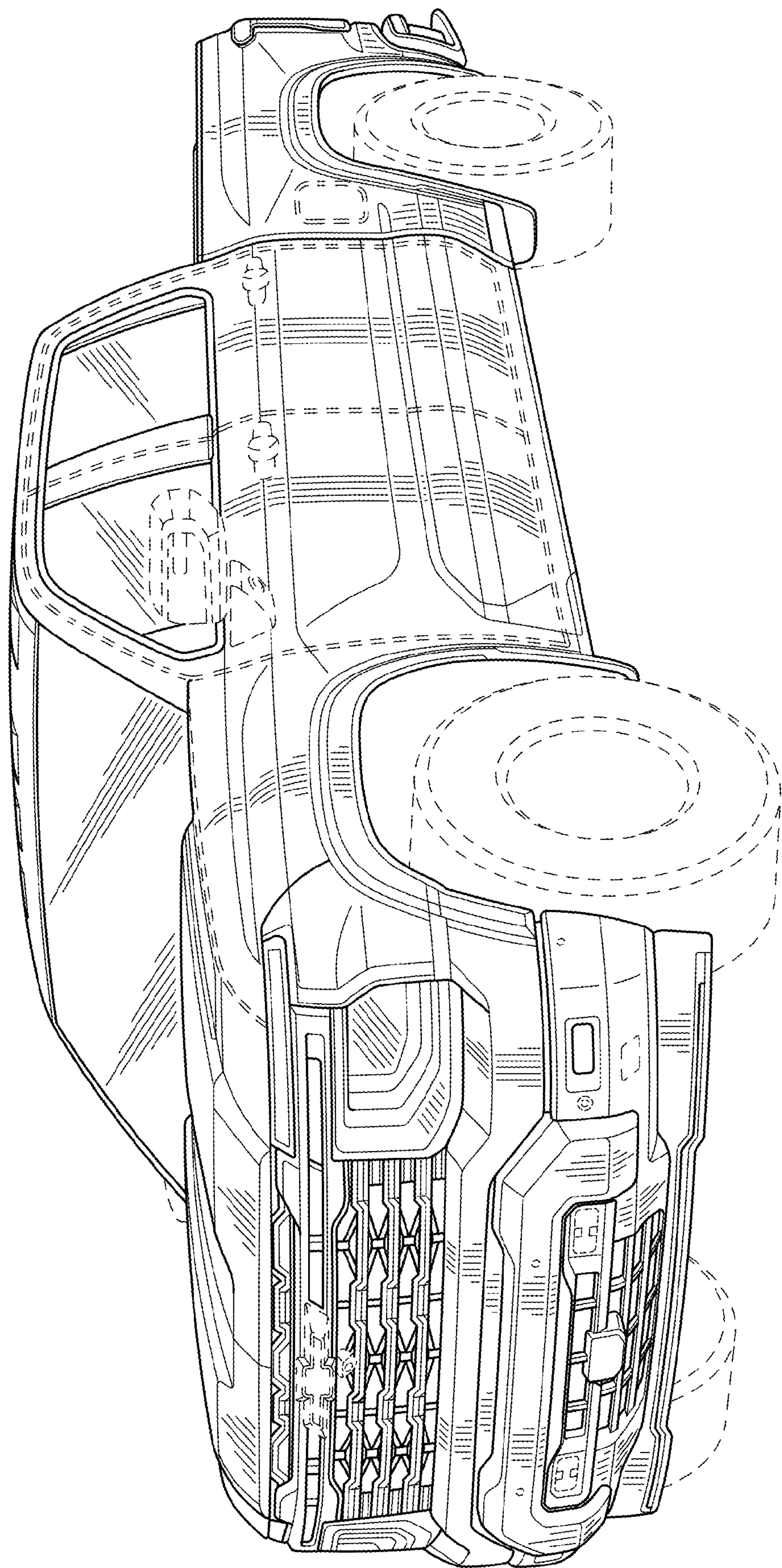

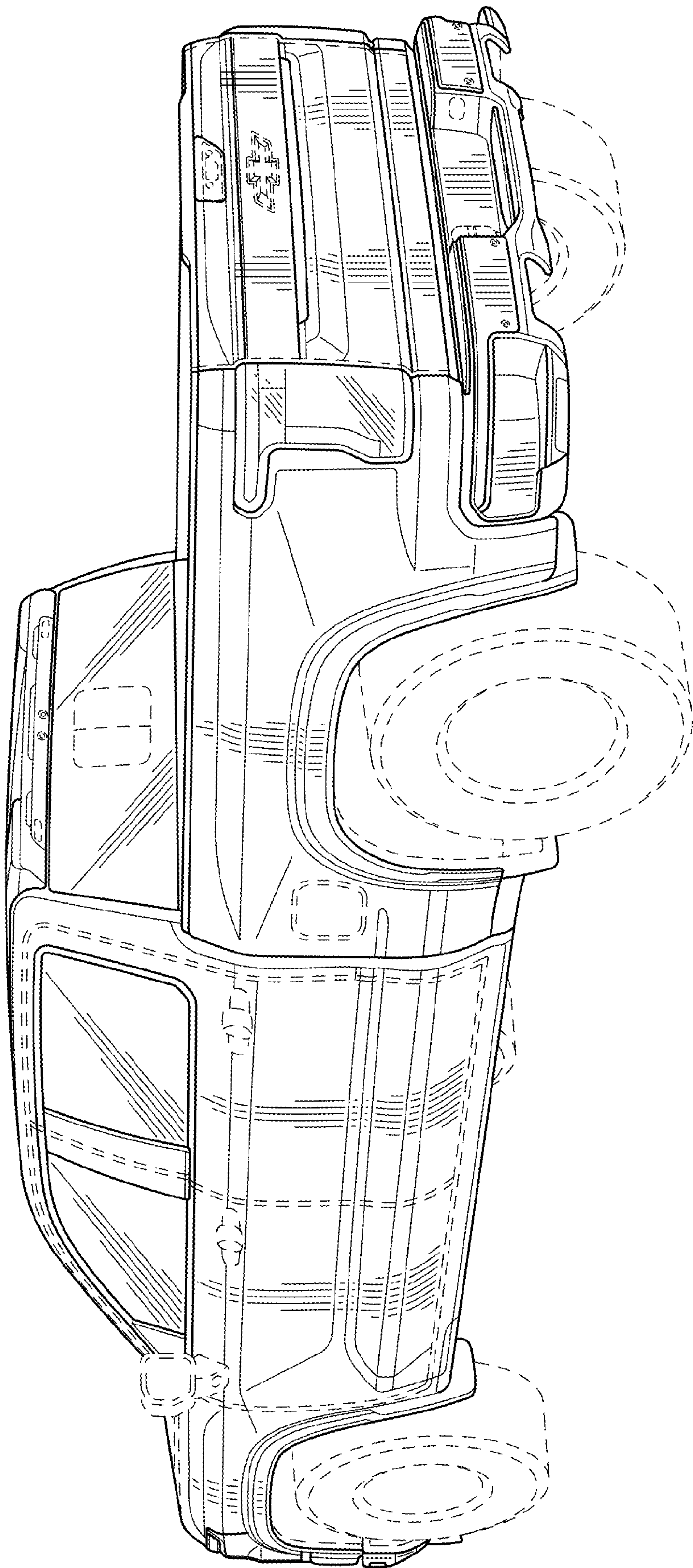

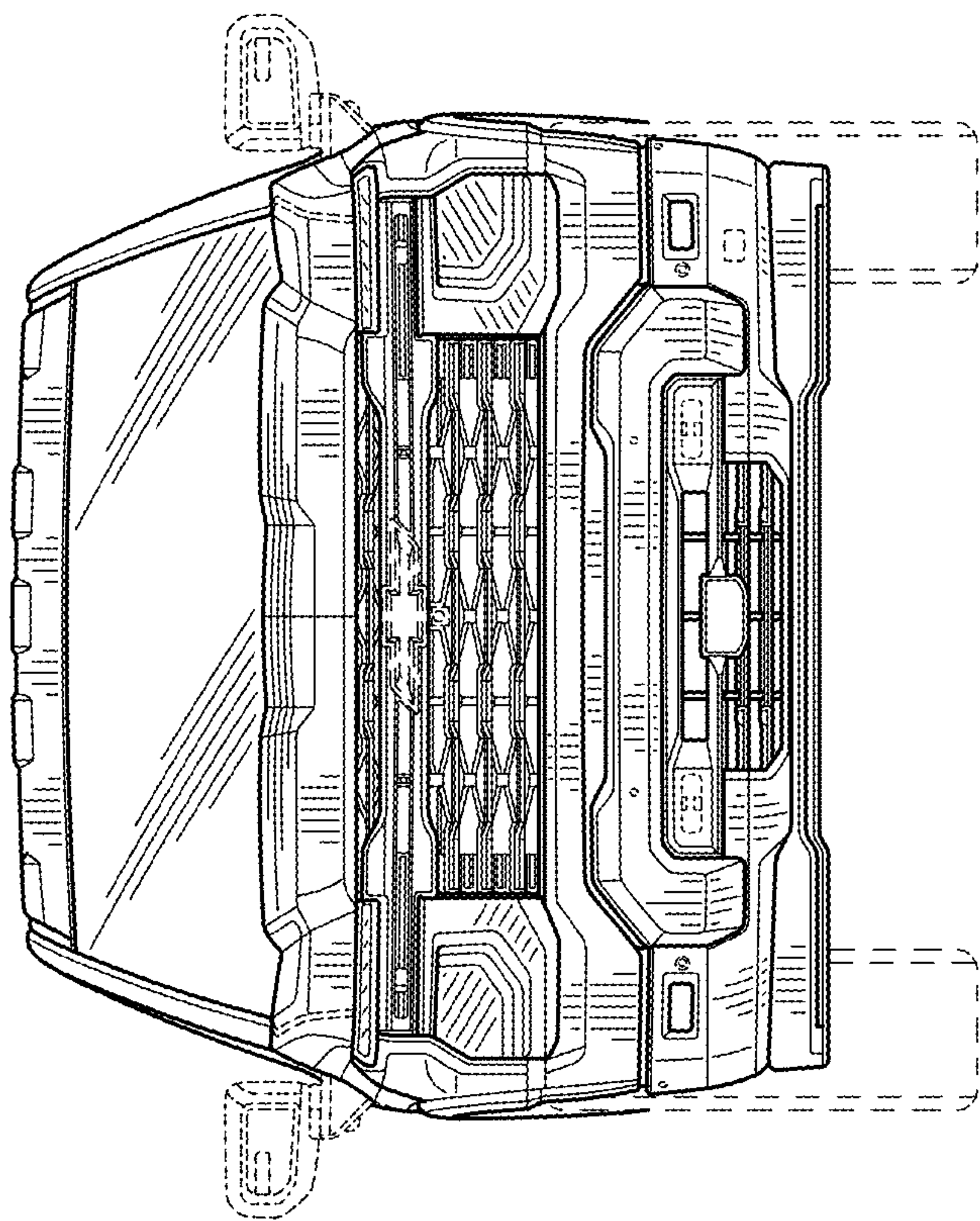

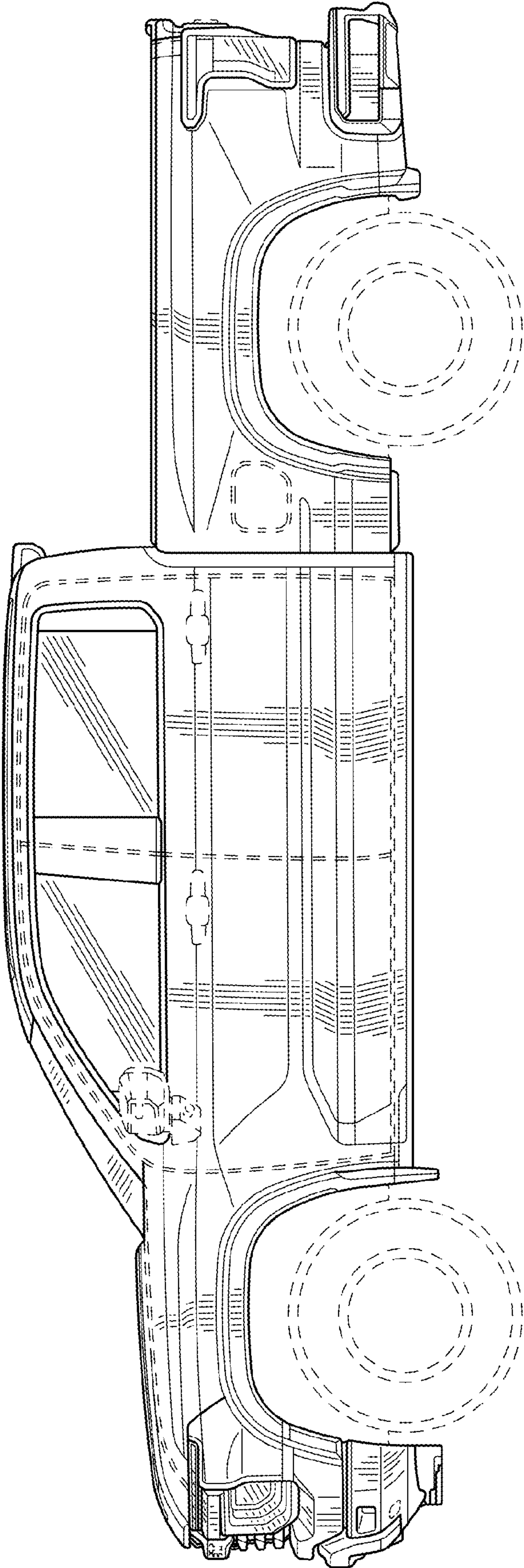

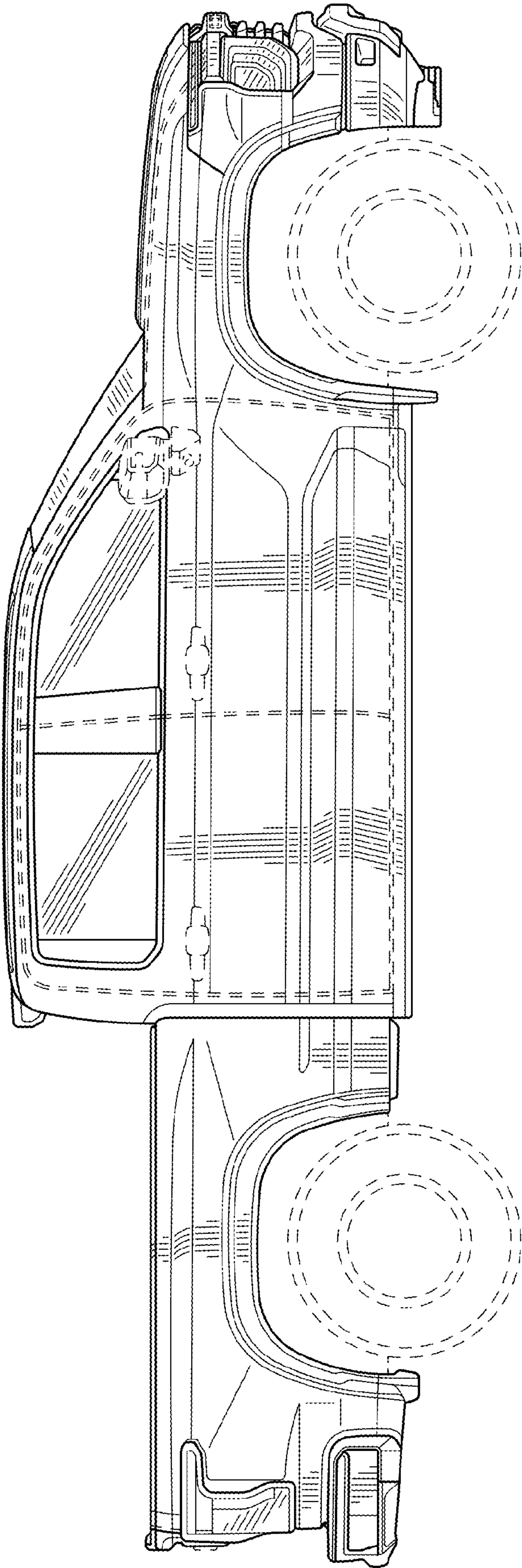

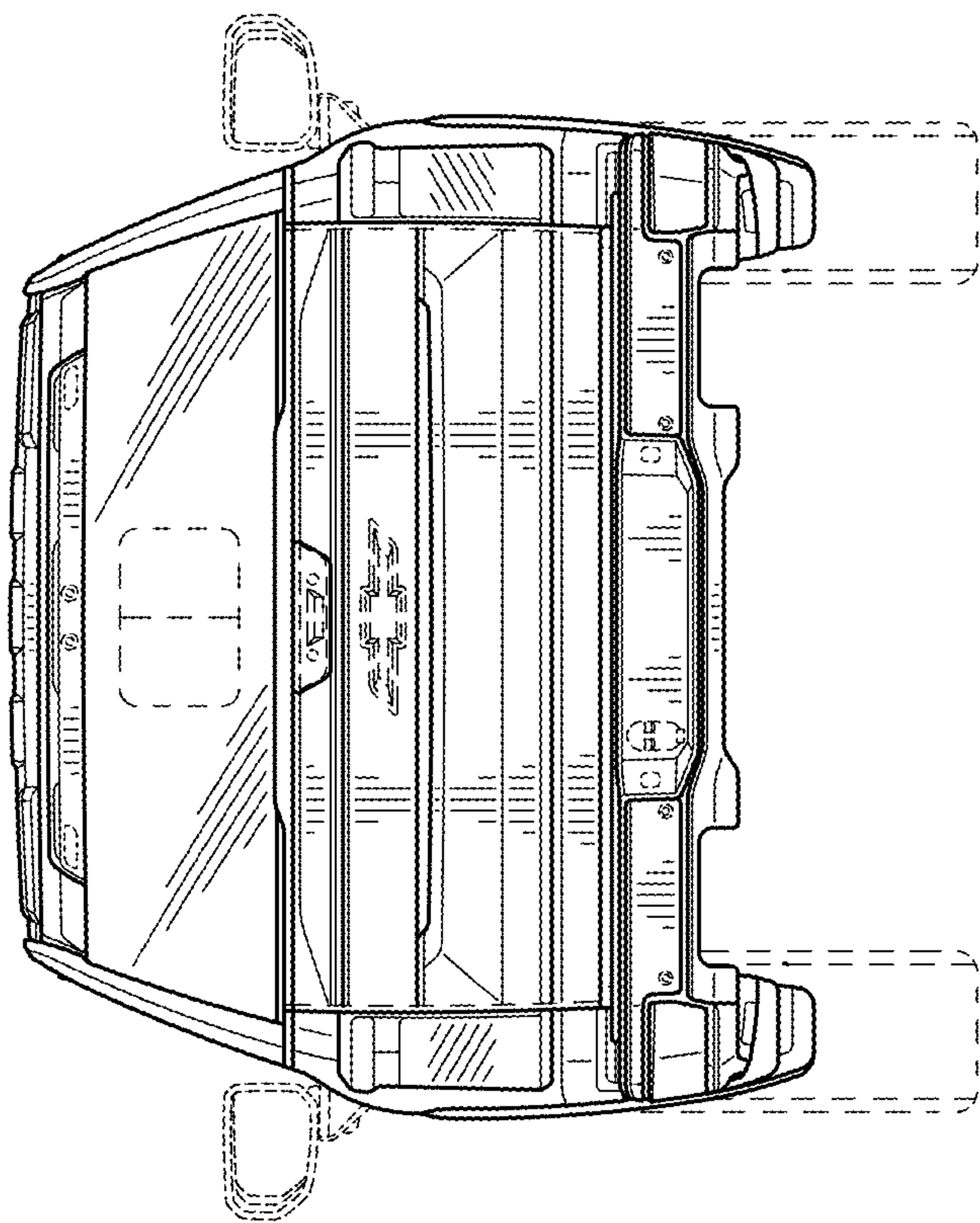

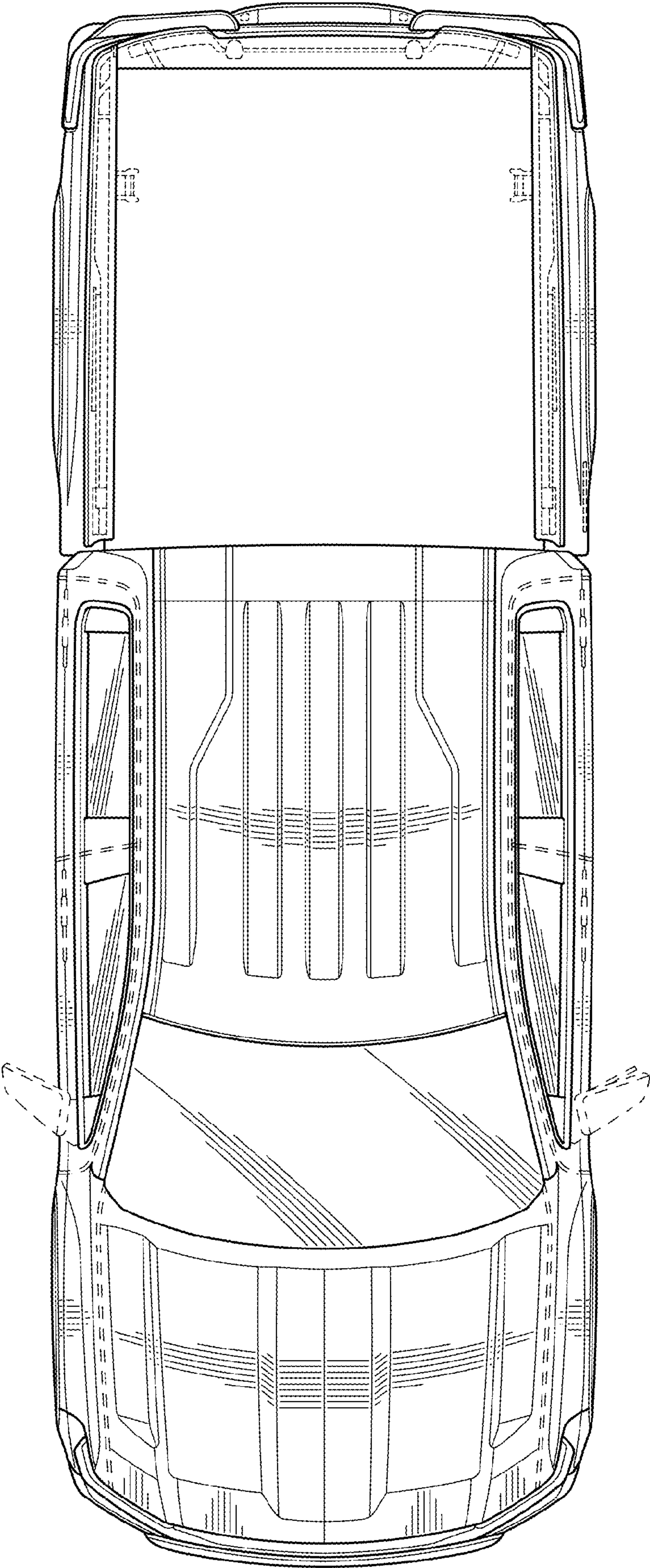
