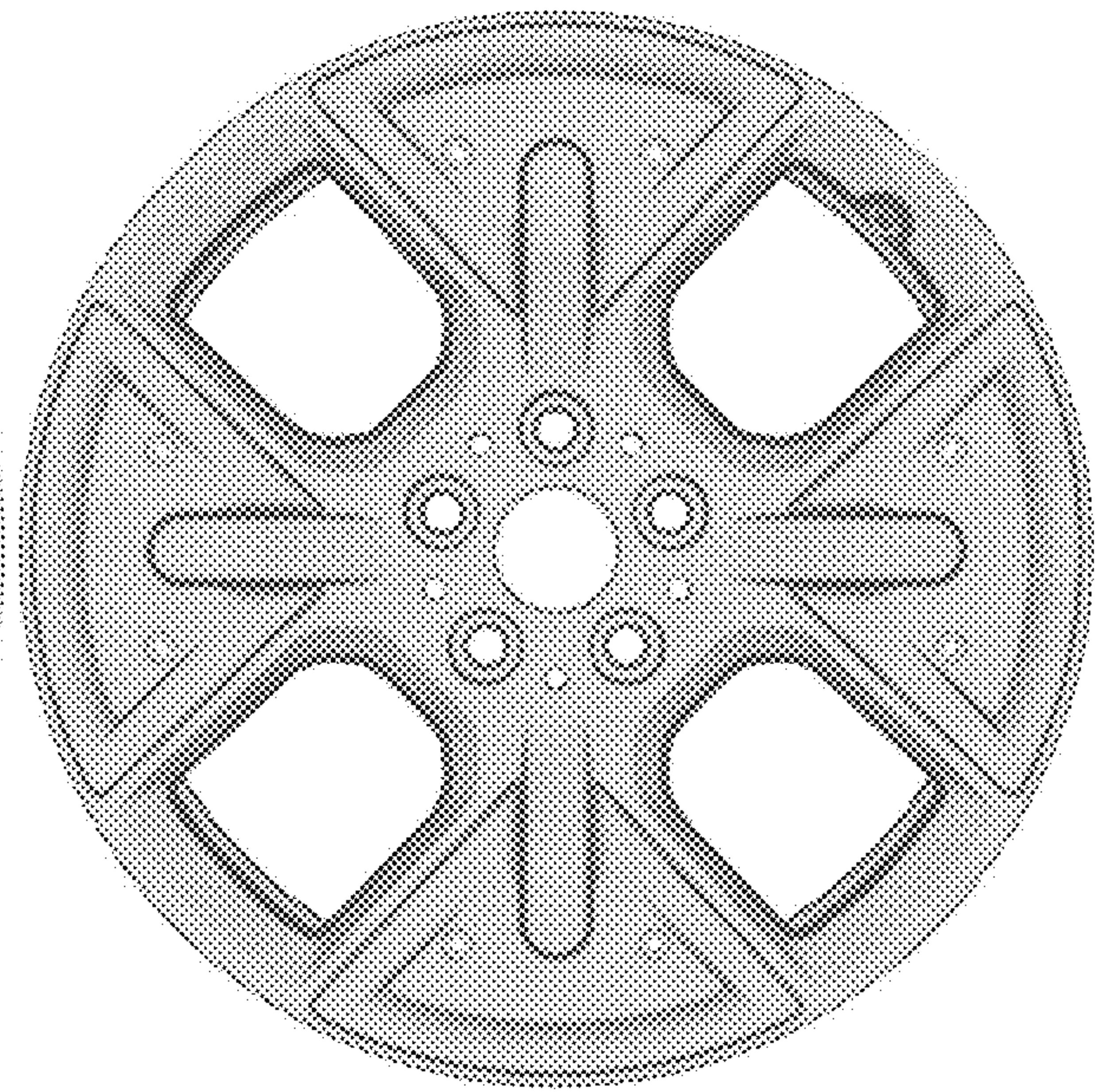
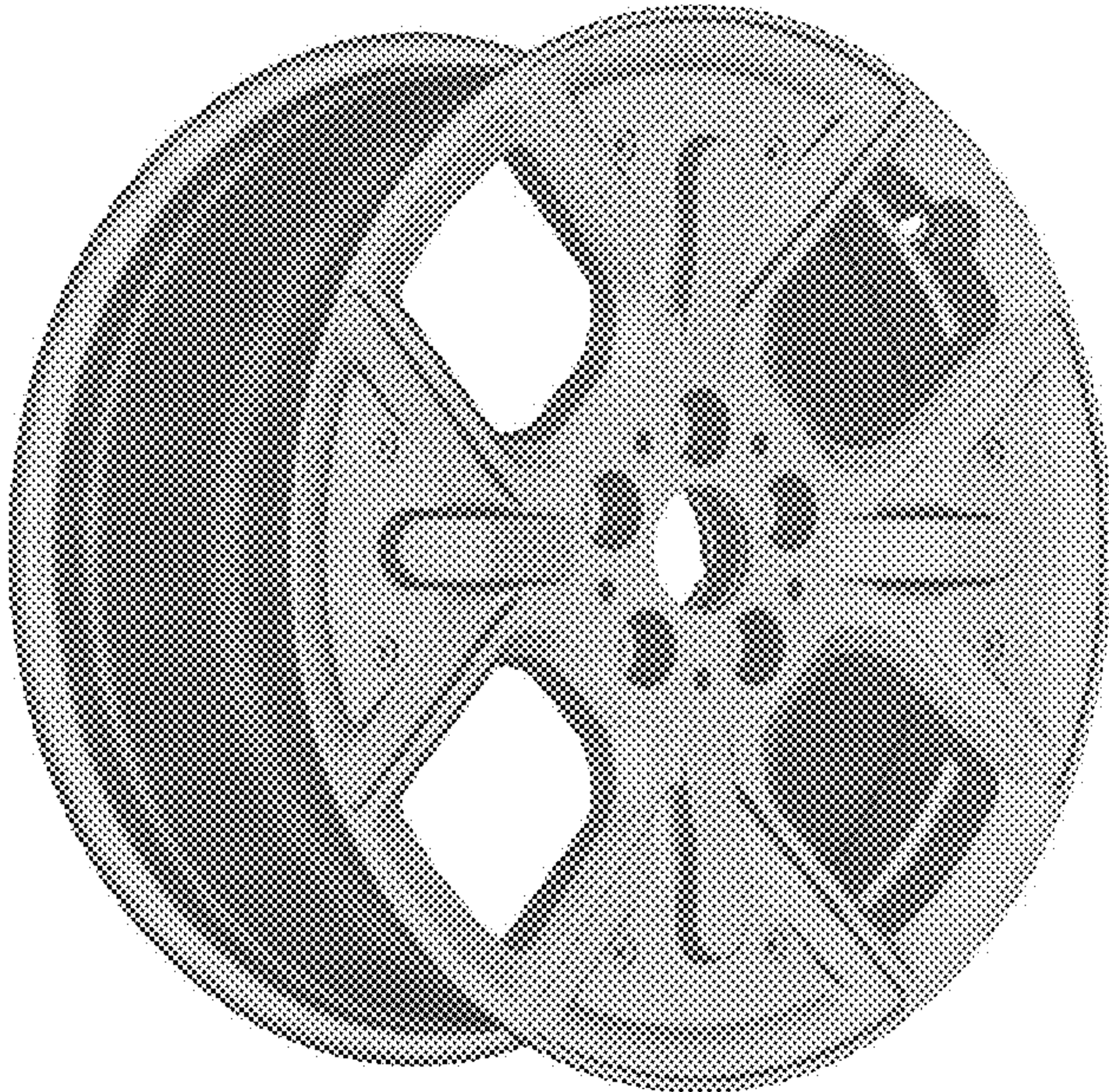
(57) CLAIM

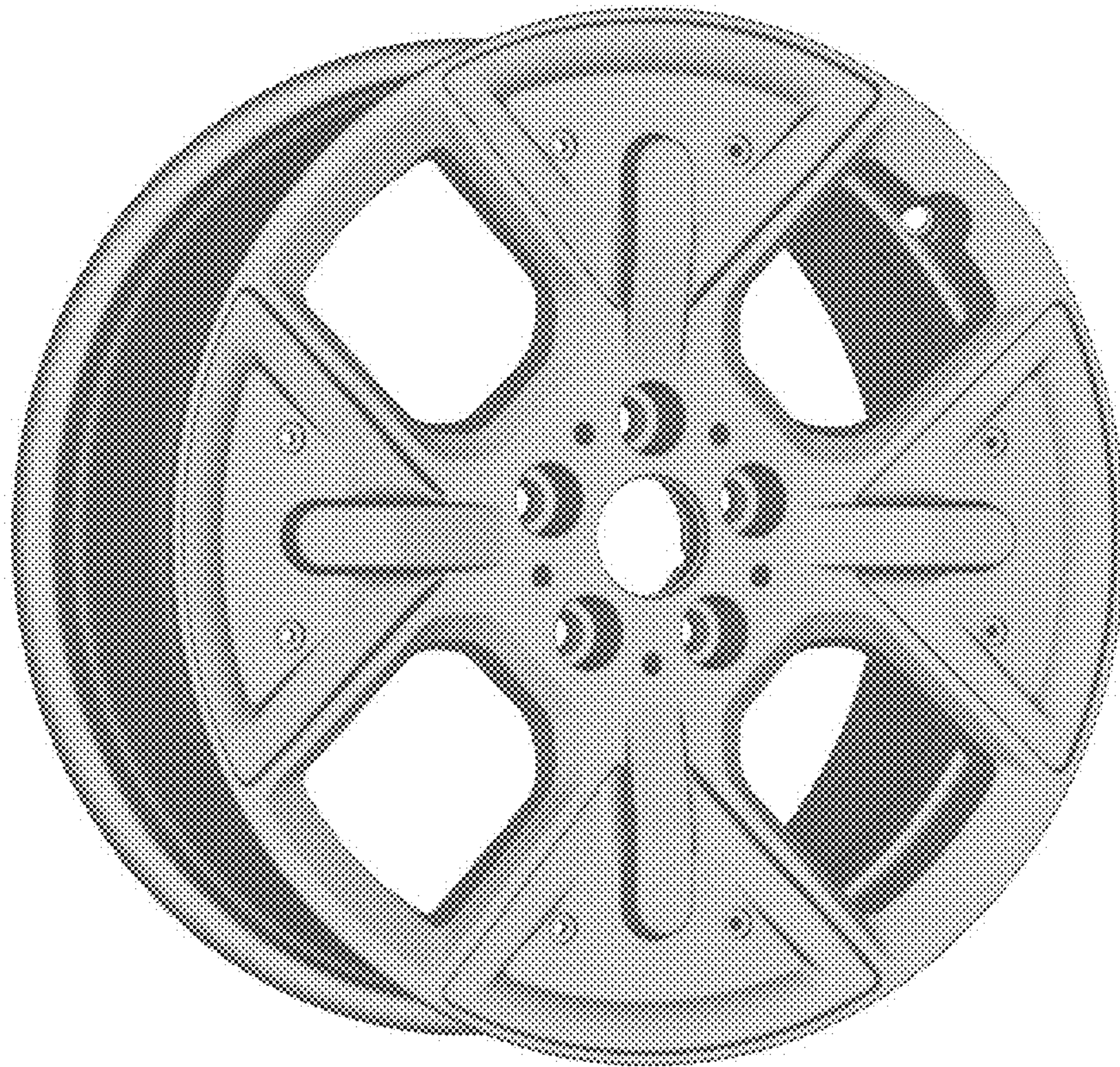

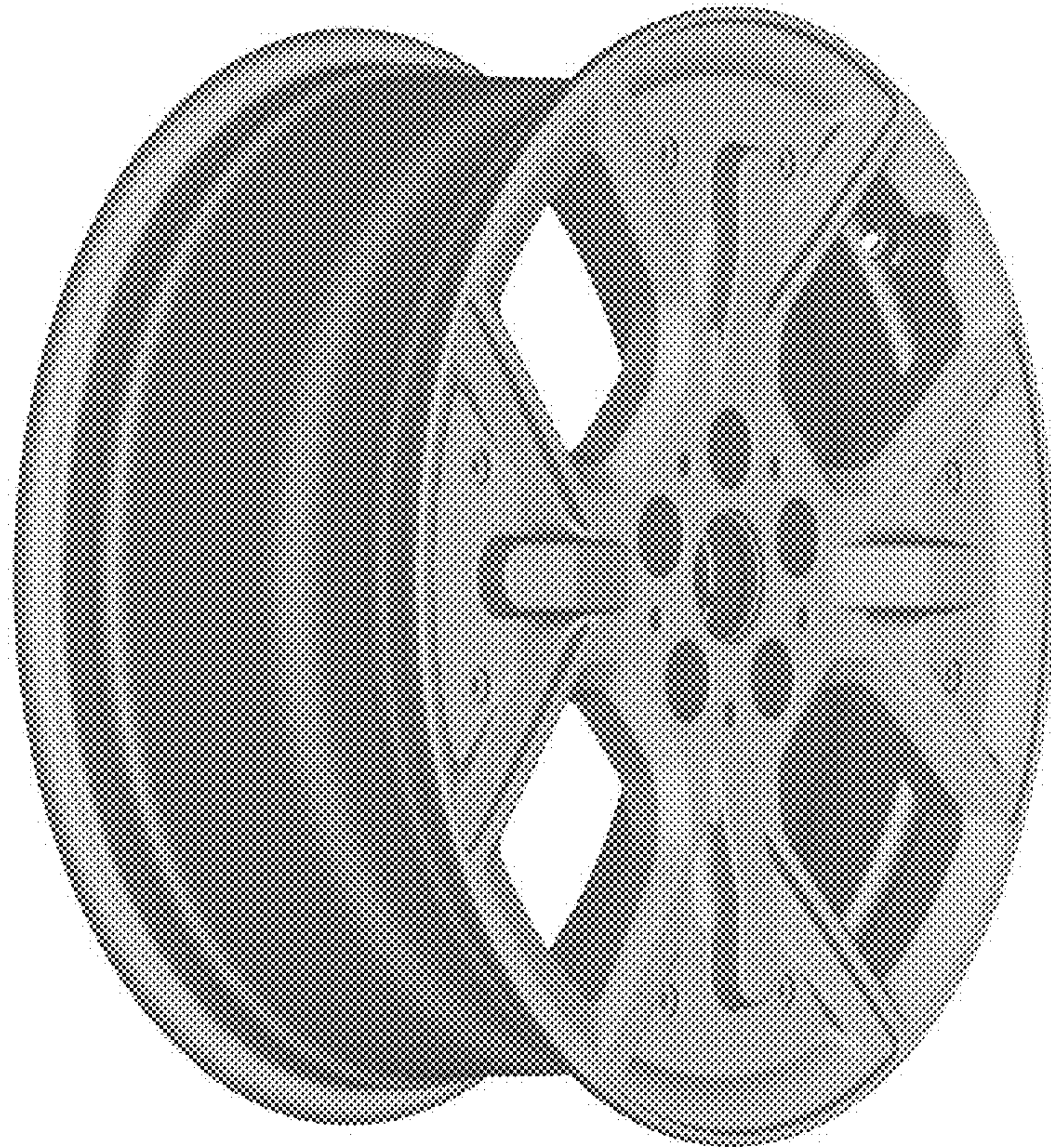

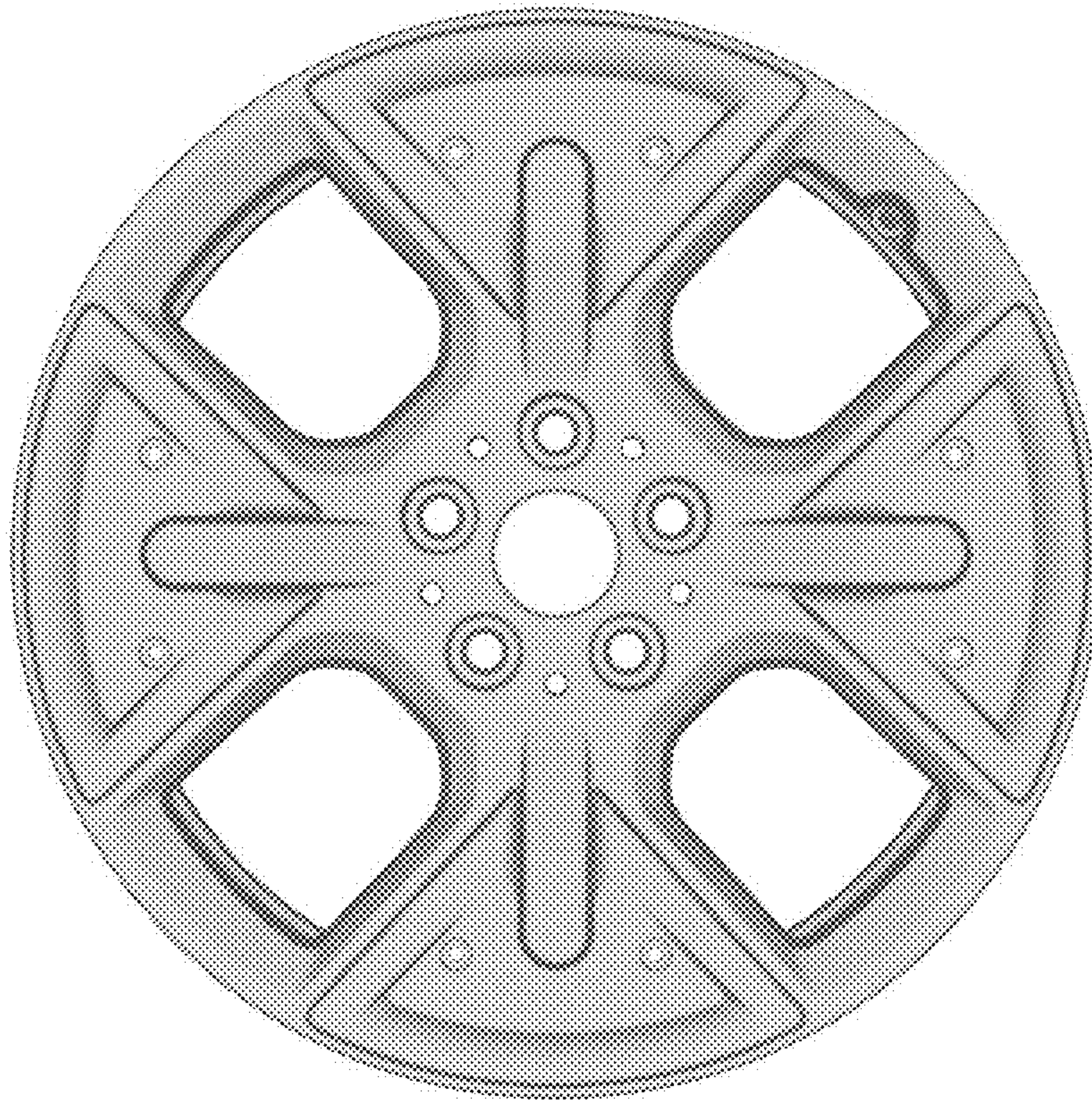

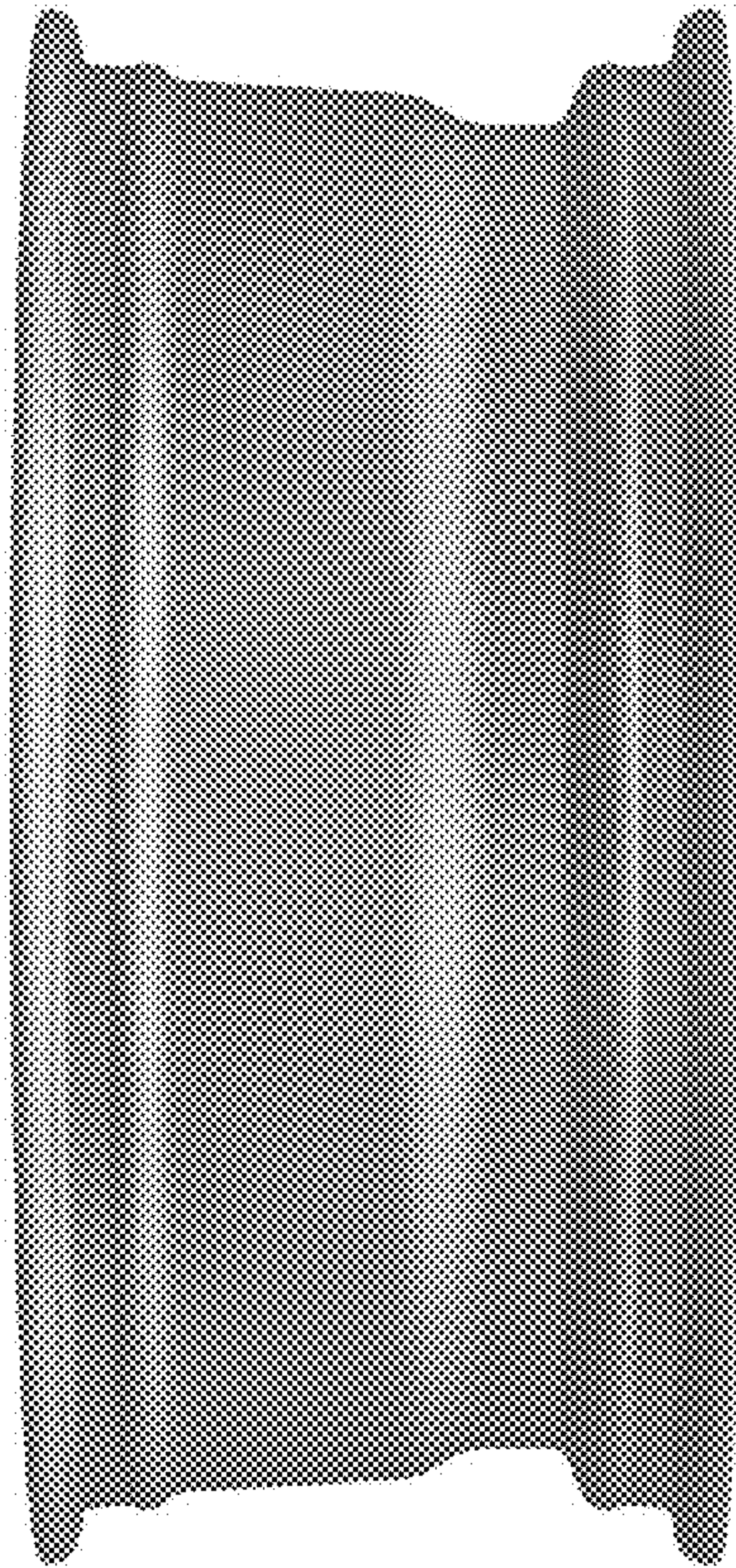
