(57) **CLAIM**

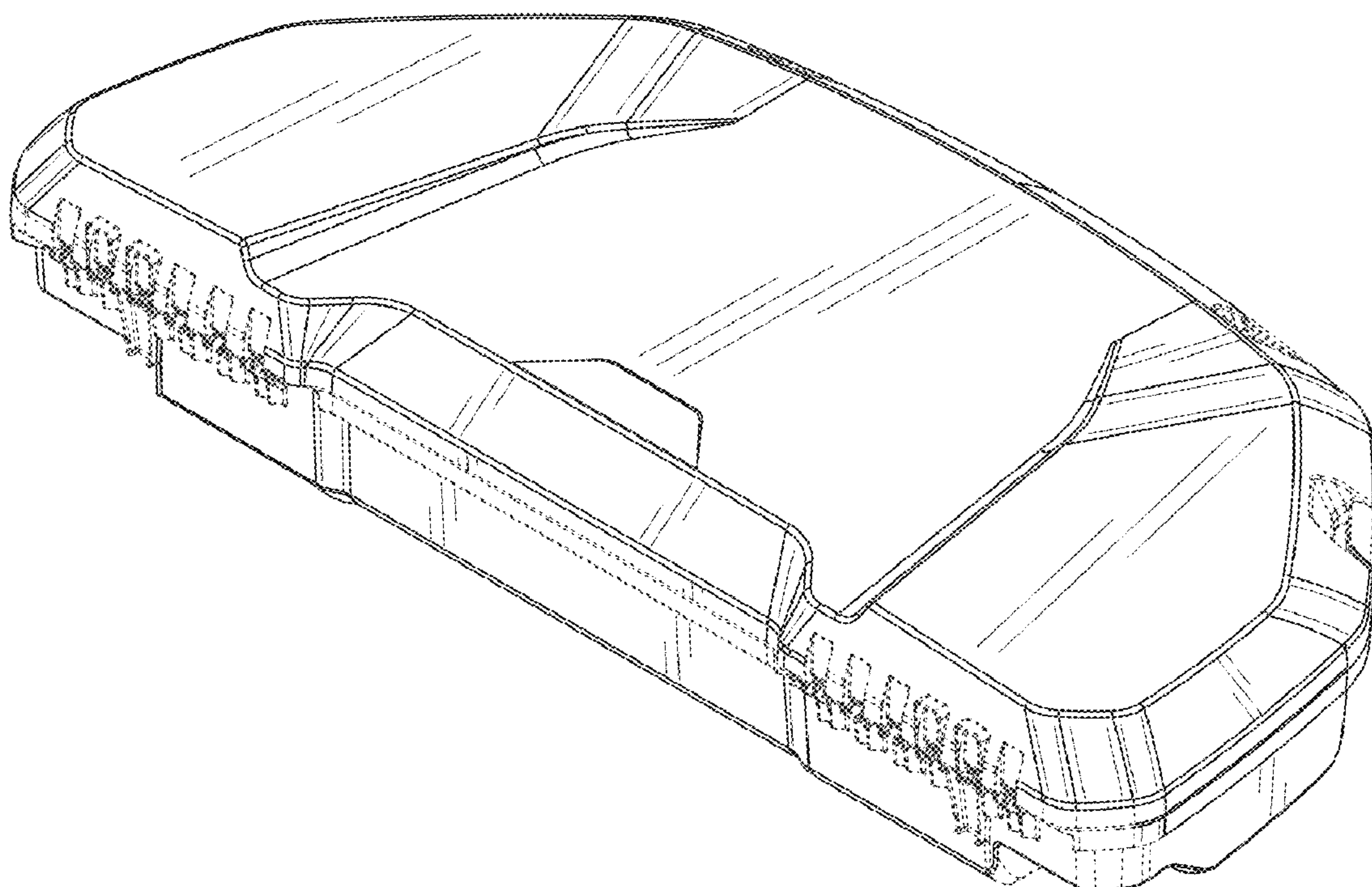
The ornamental design for a storage container for recre-
ational vehicle as shown and described.

DESCRIPTION

FIG. 1 is a rear, right side isometric view of a storage
container for recreational vehicle according to the design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof; and,
FIG. 6 is a left side elevation view thereof, the right side
being a mirror image thereof.

The broken lines illustrate portions of the storage container
for recreational vehicle which form no part of the claimed
design.

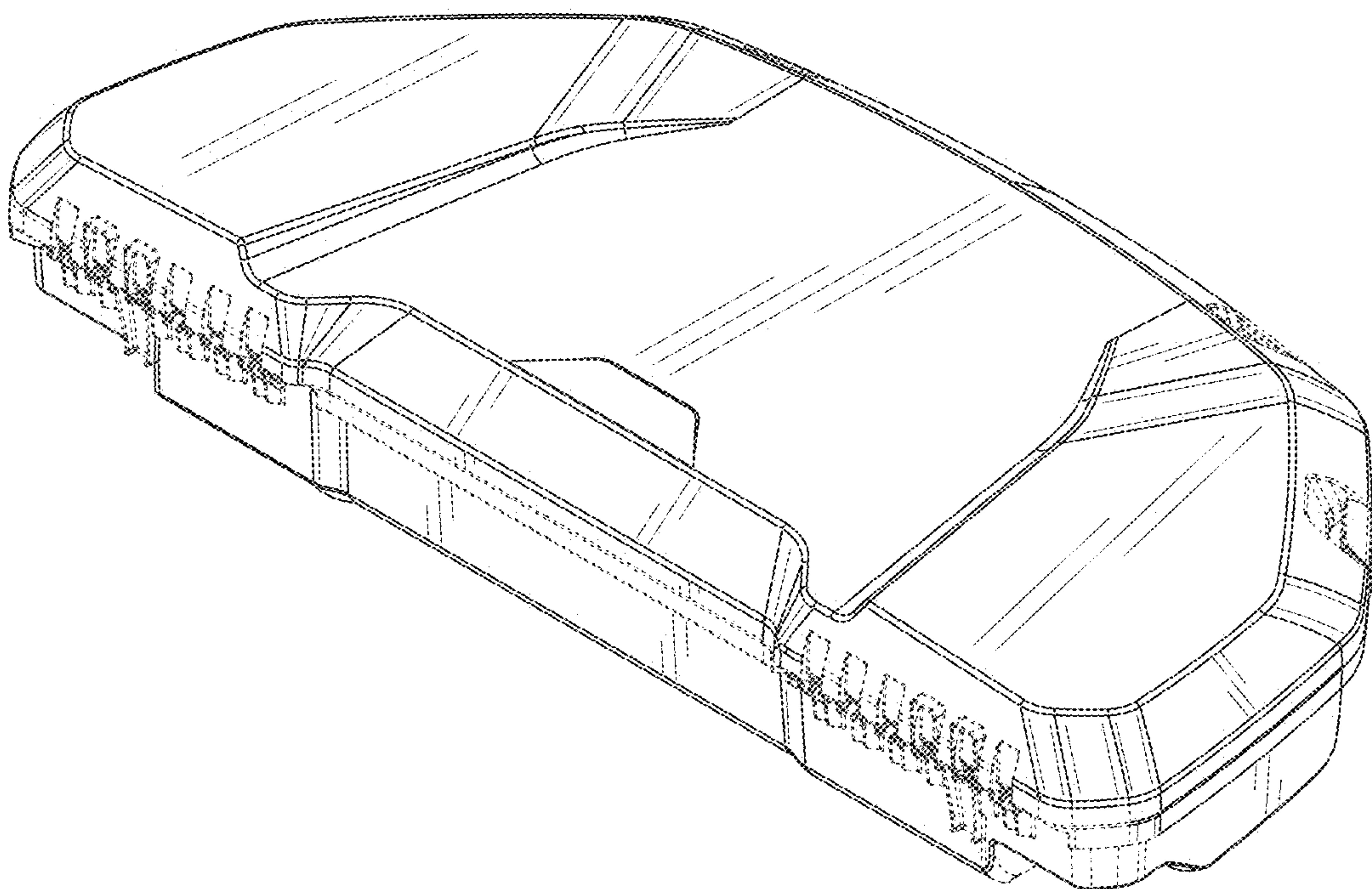

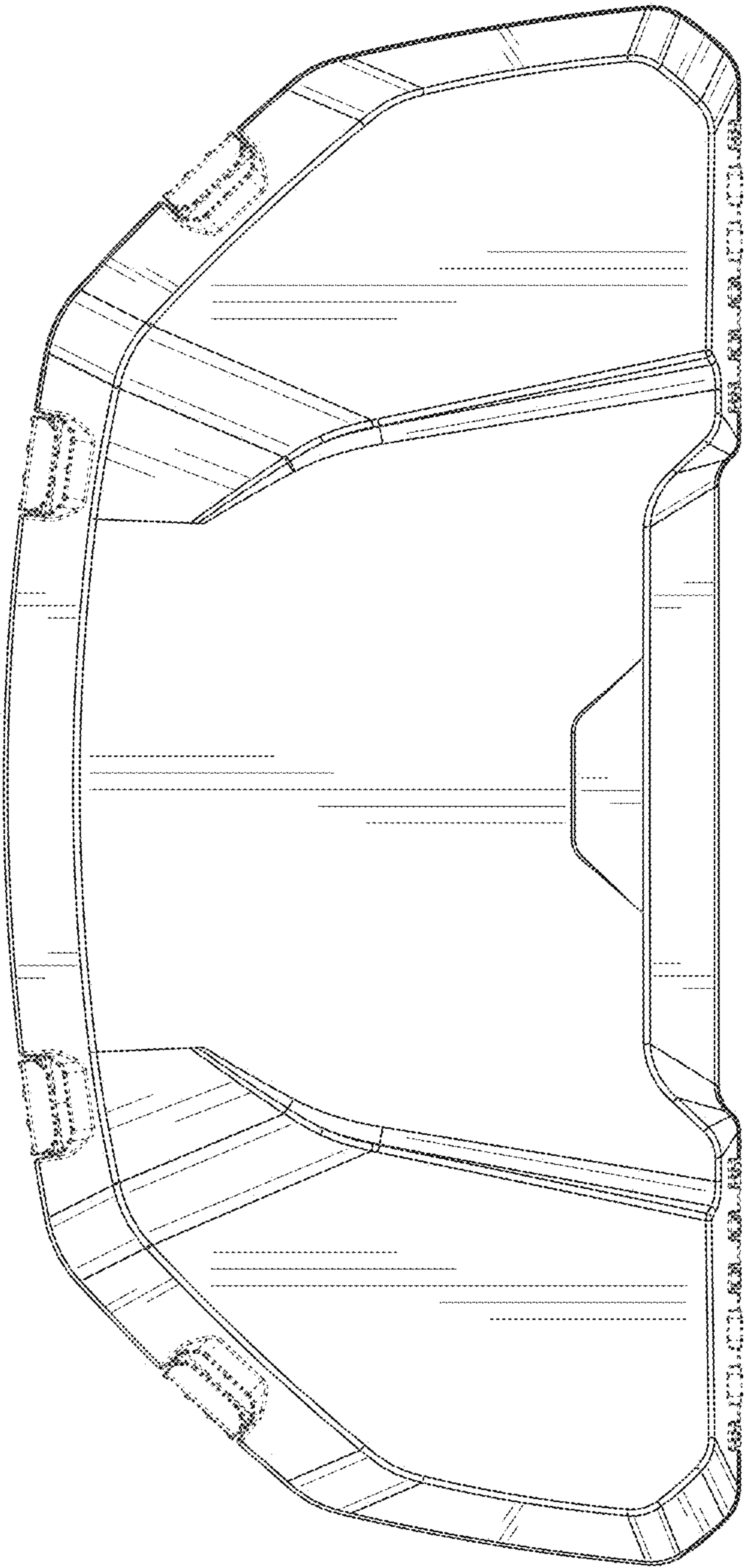

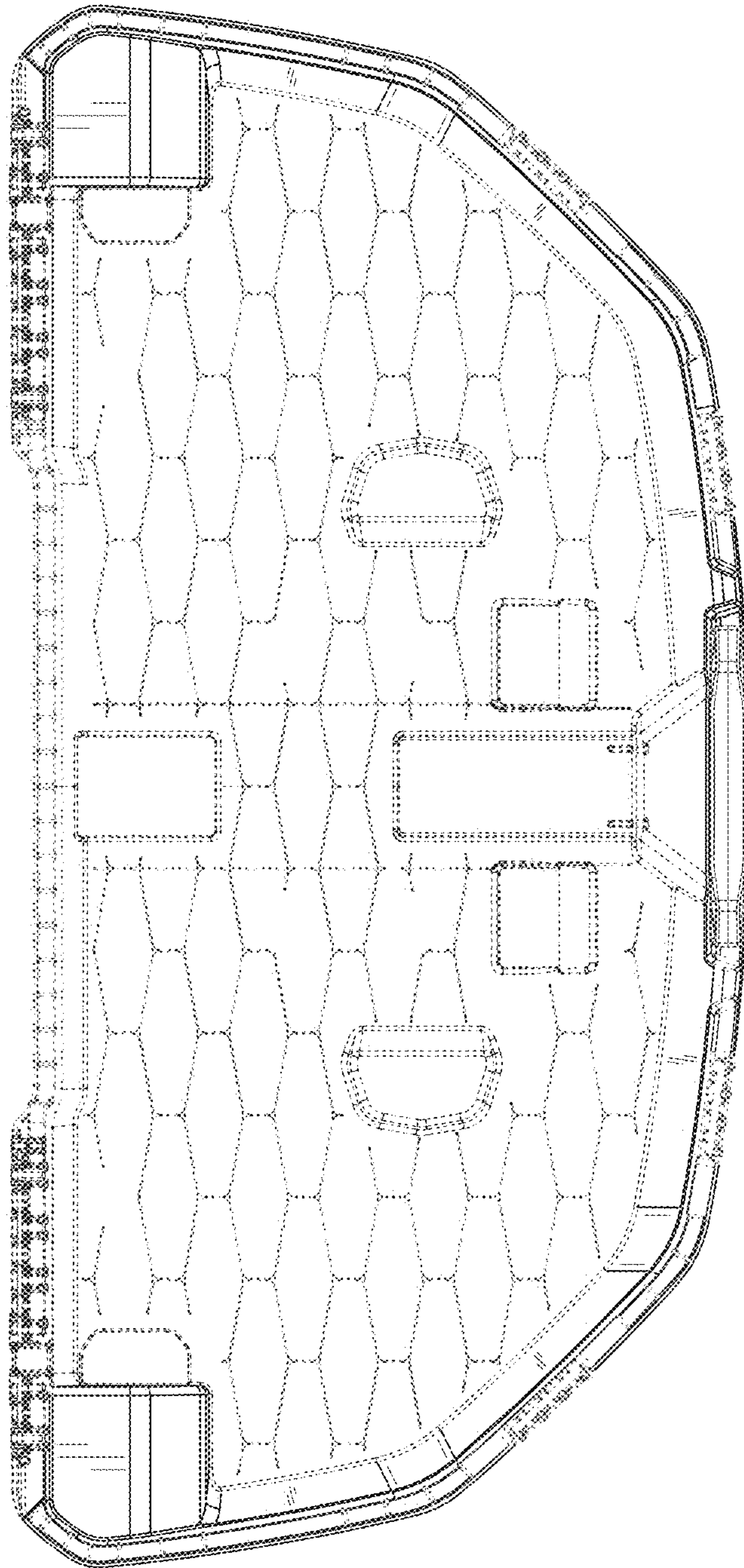

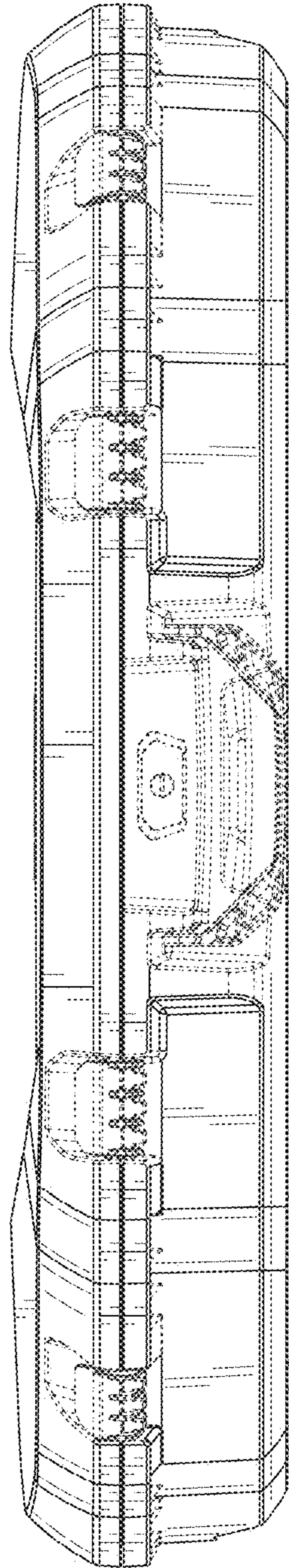

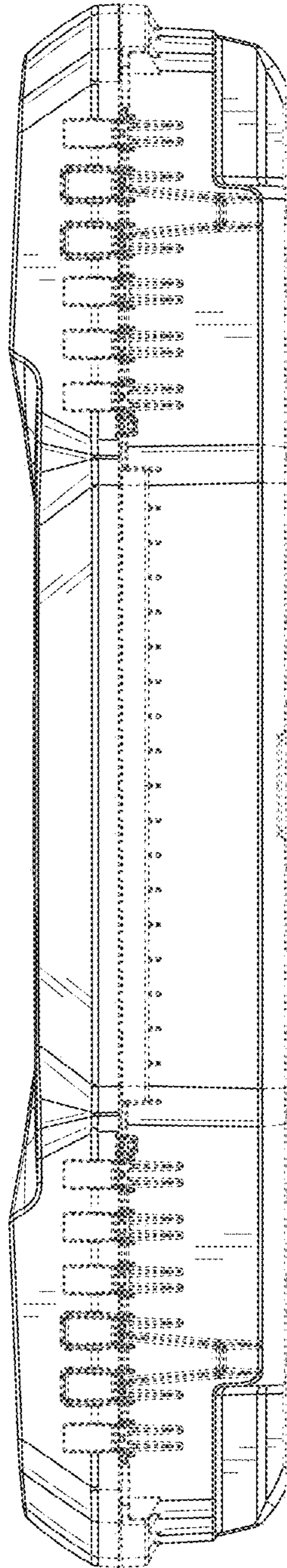

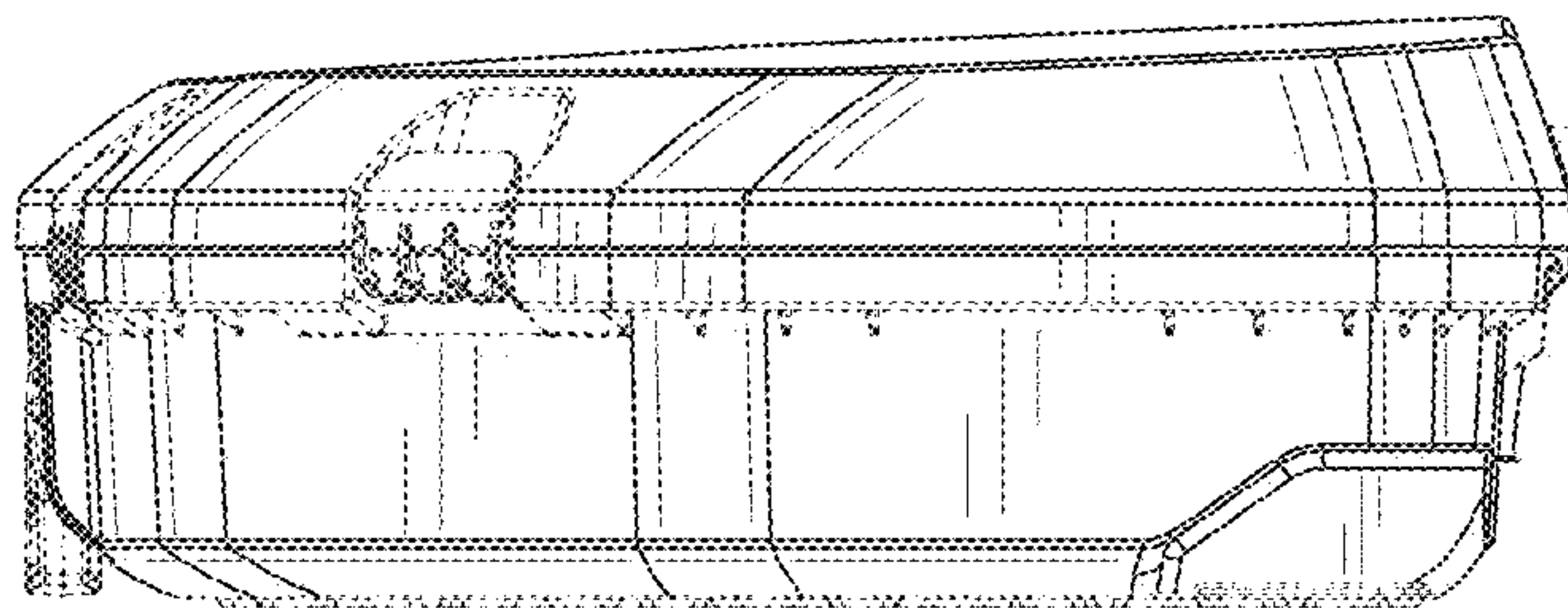
