DESCRIPTION

FIG. 1 is a front right perspective view of a gaming machine showing our new design;
FIG. 2 is a front left perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a left side view thereof; and,
FIG. 5 is a right side view thereof.
The uneven-length broken lines immediately adjacent to the top and bottom of the shaded areas define the bounds of the claimed design and form no part thereof. The even-length broken lines depicting the remainder of the gaming machine form no part of the claimed design.

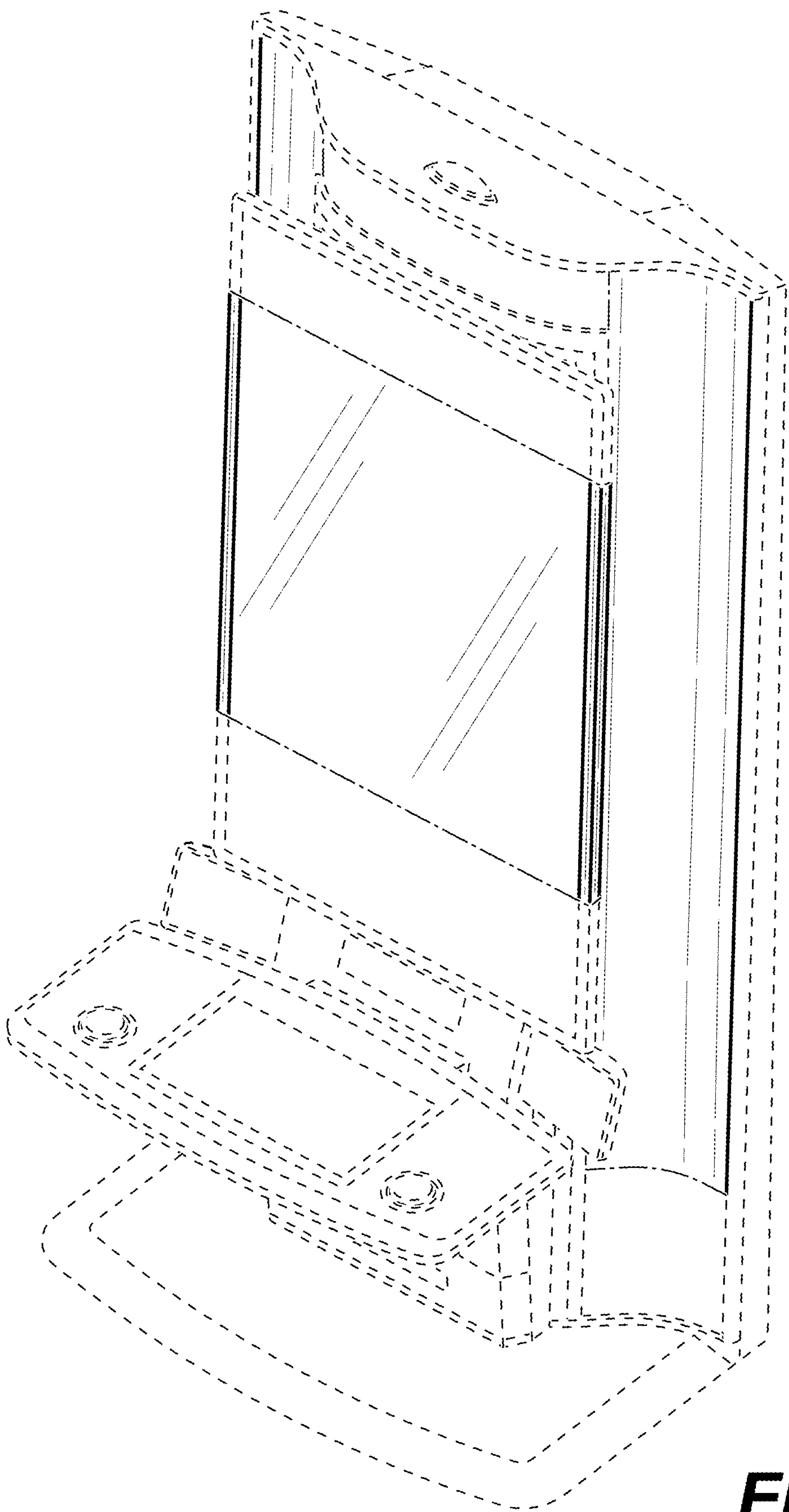

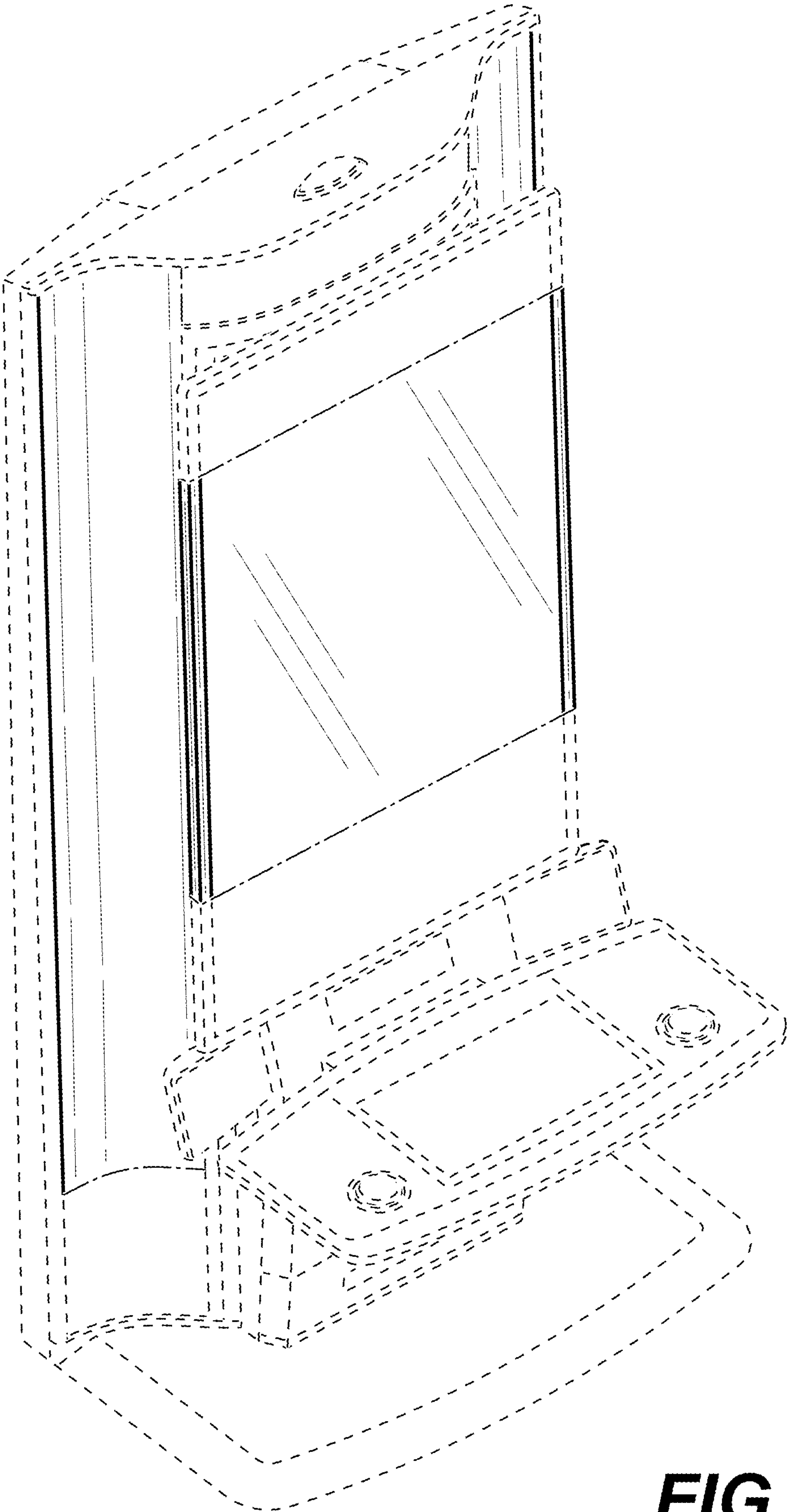

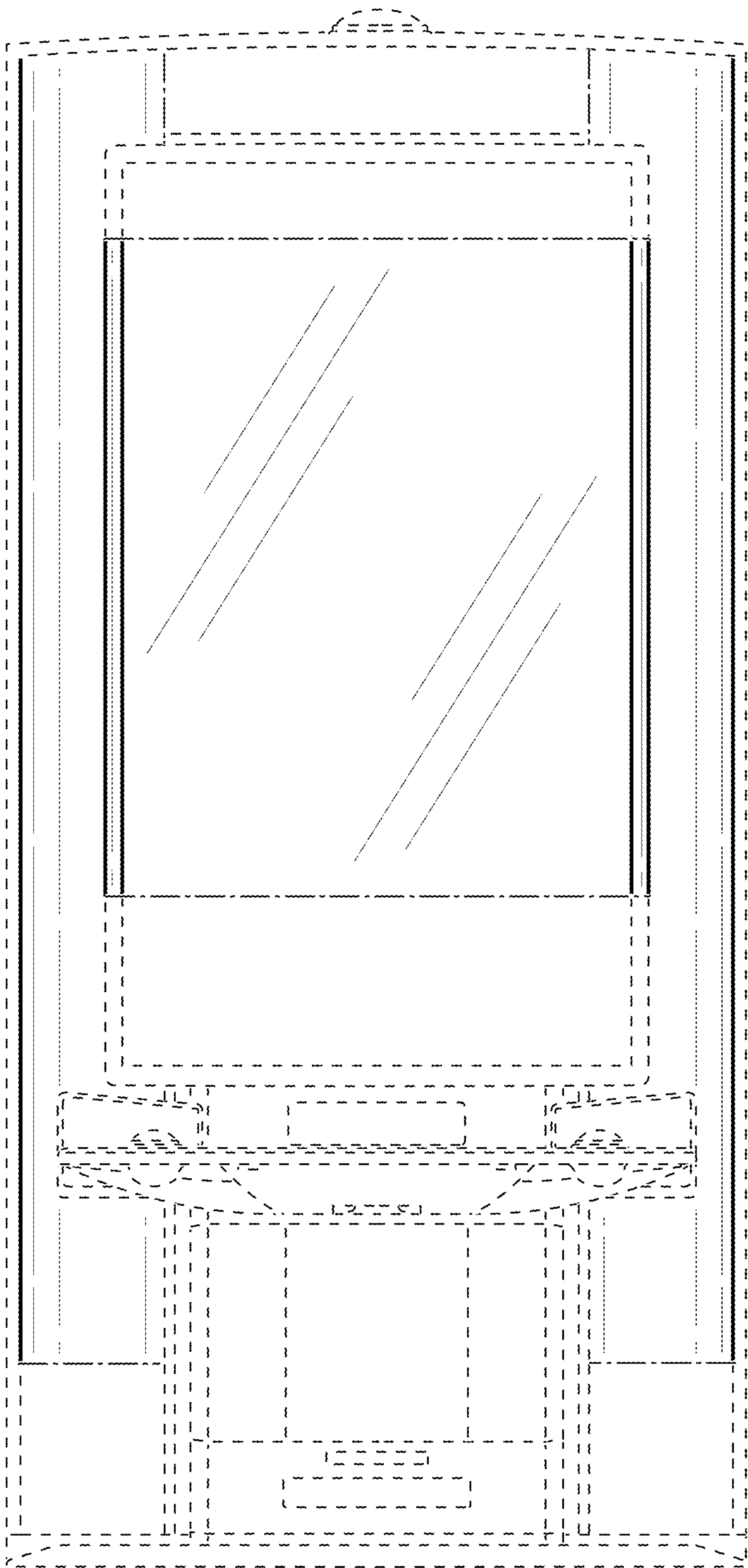

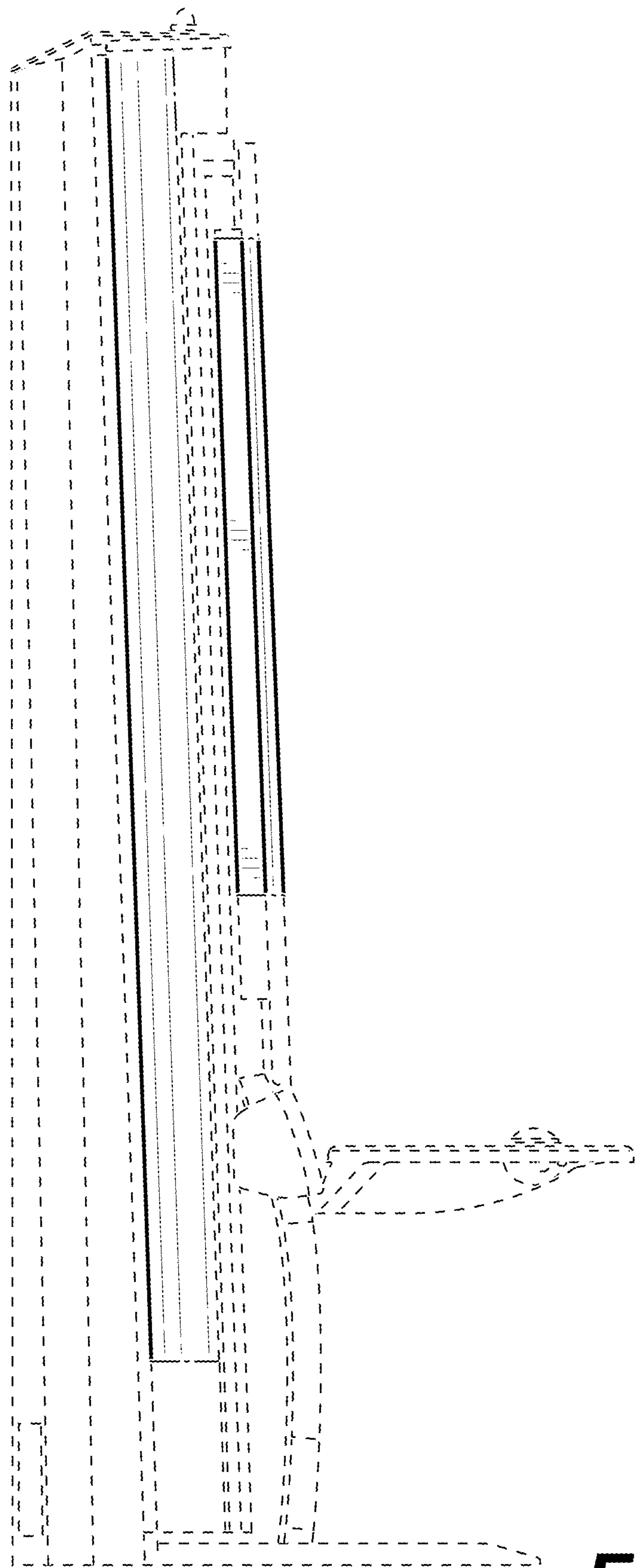

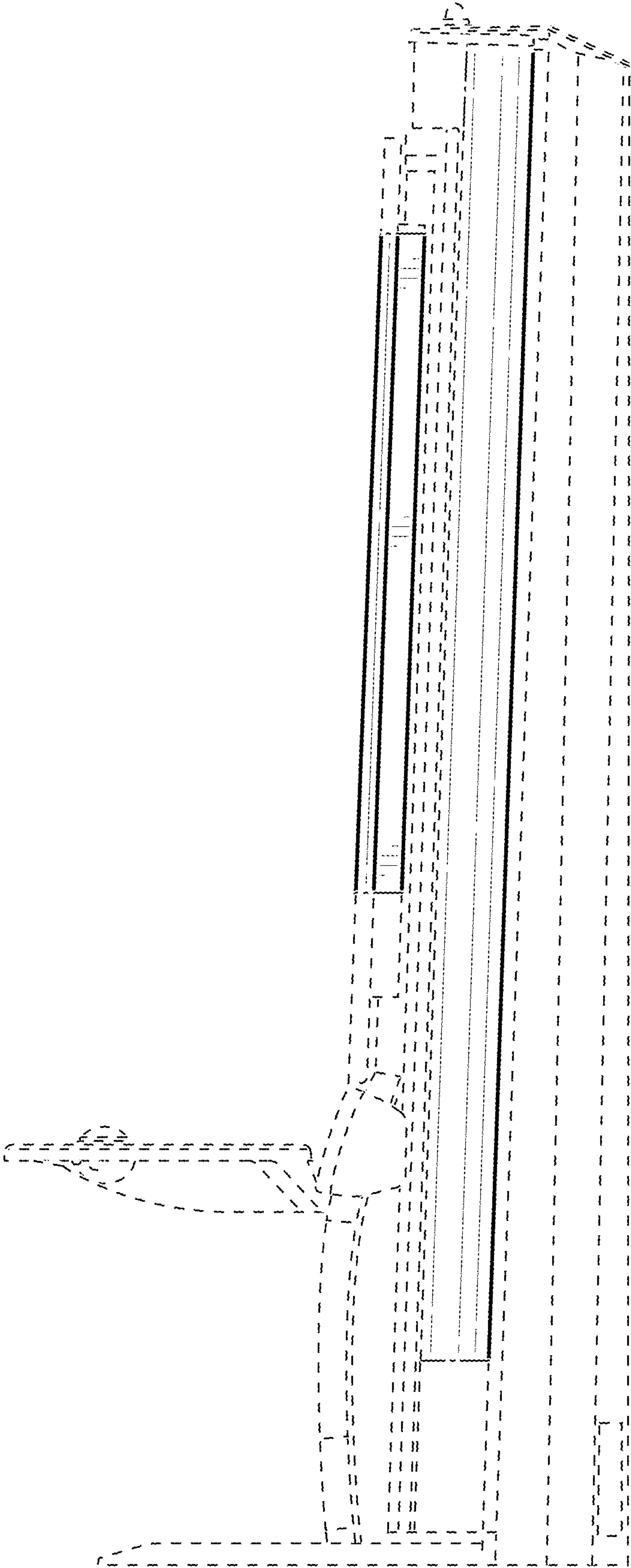
