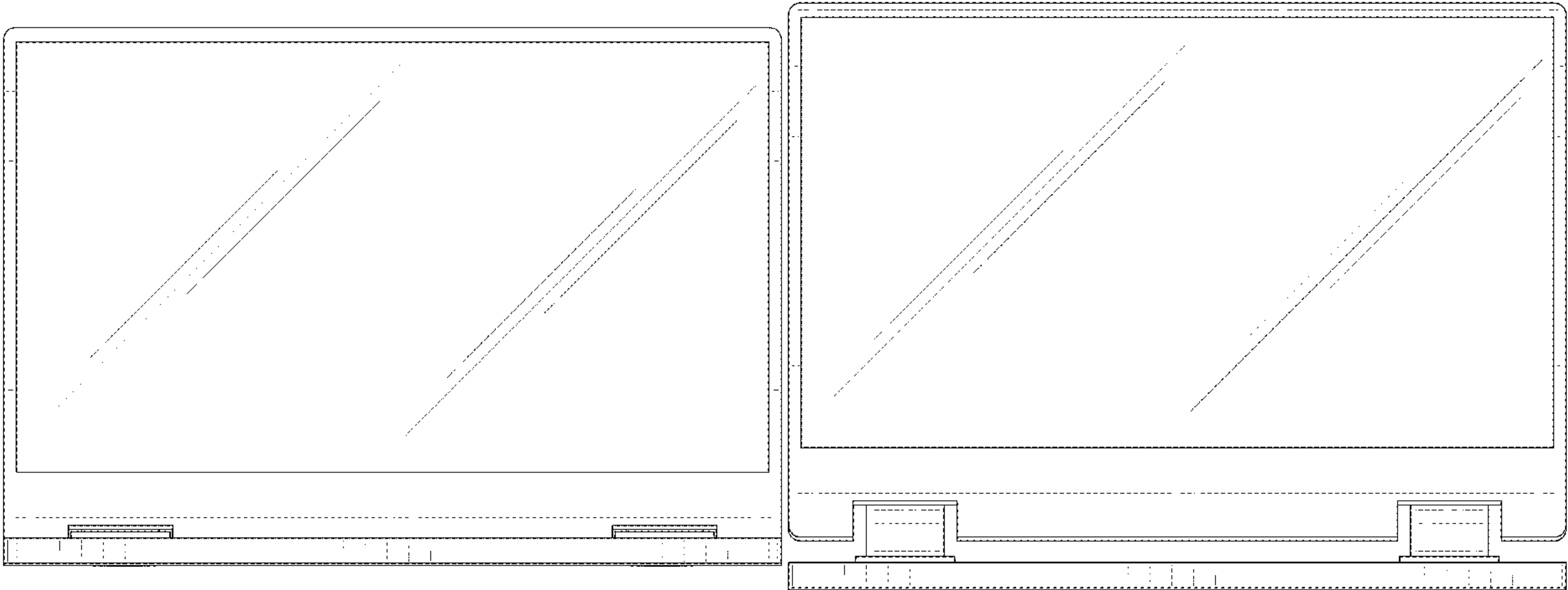
(57) CLAIM

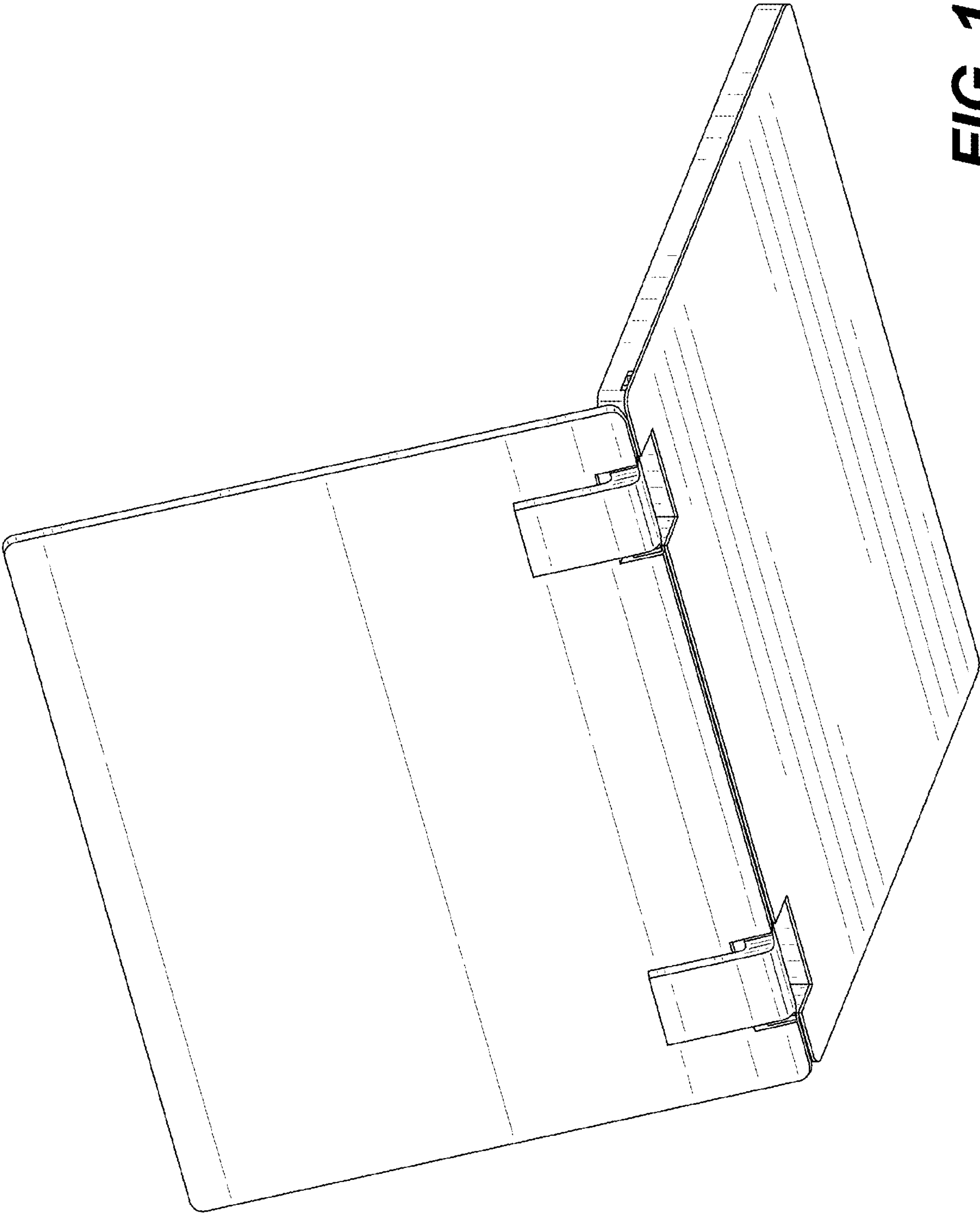

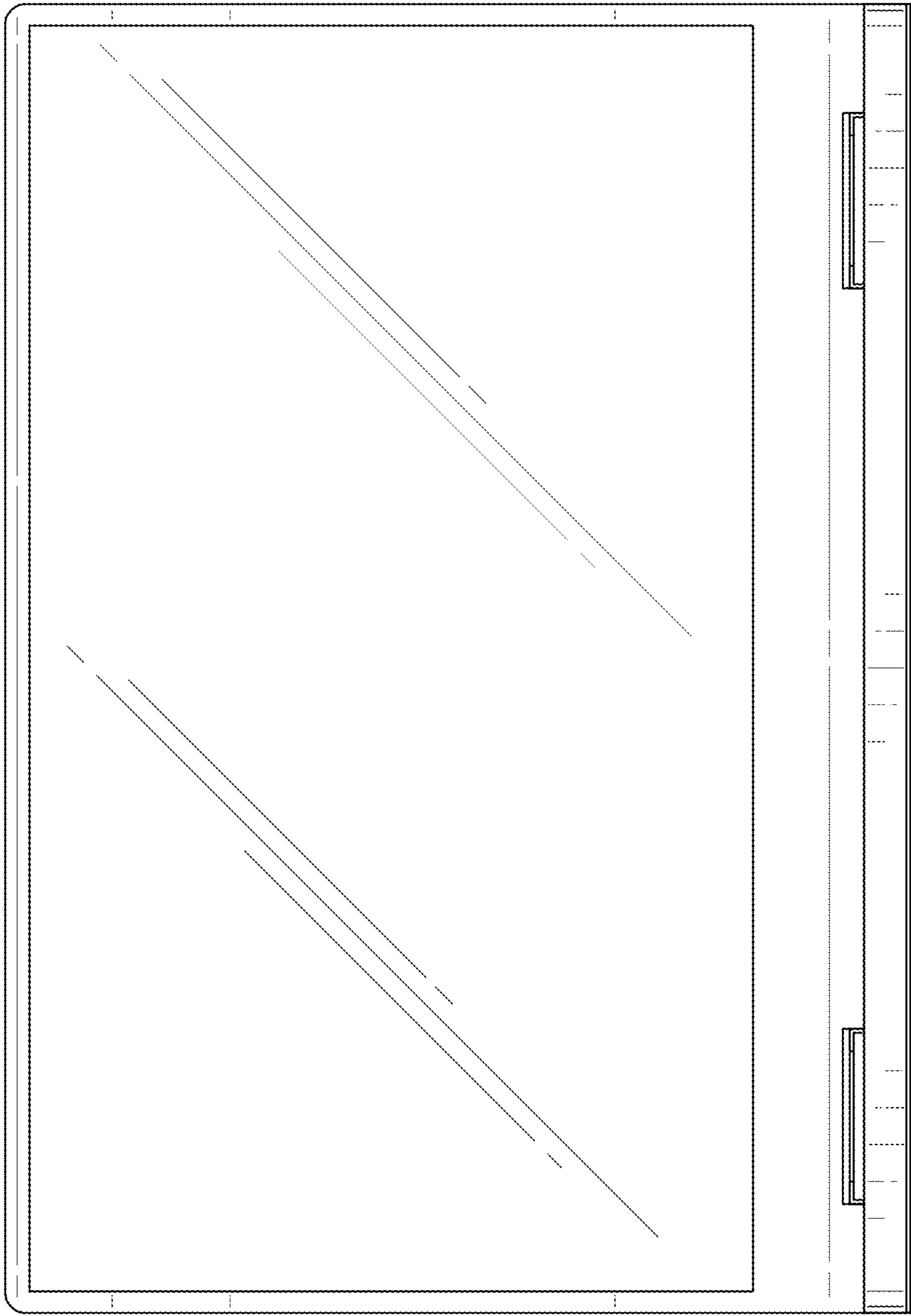

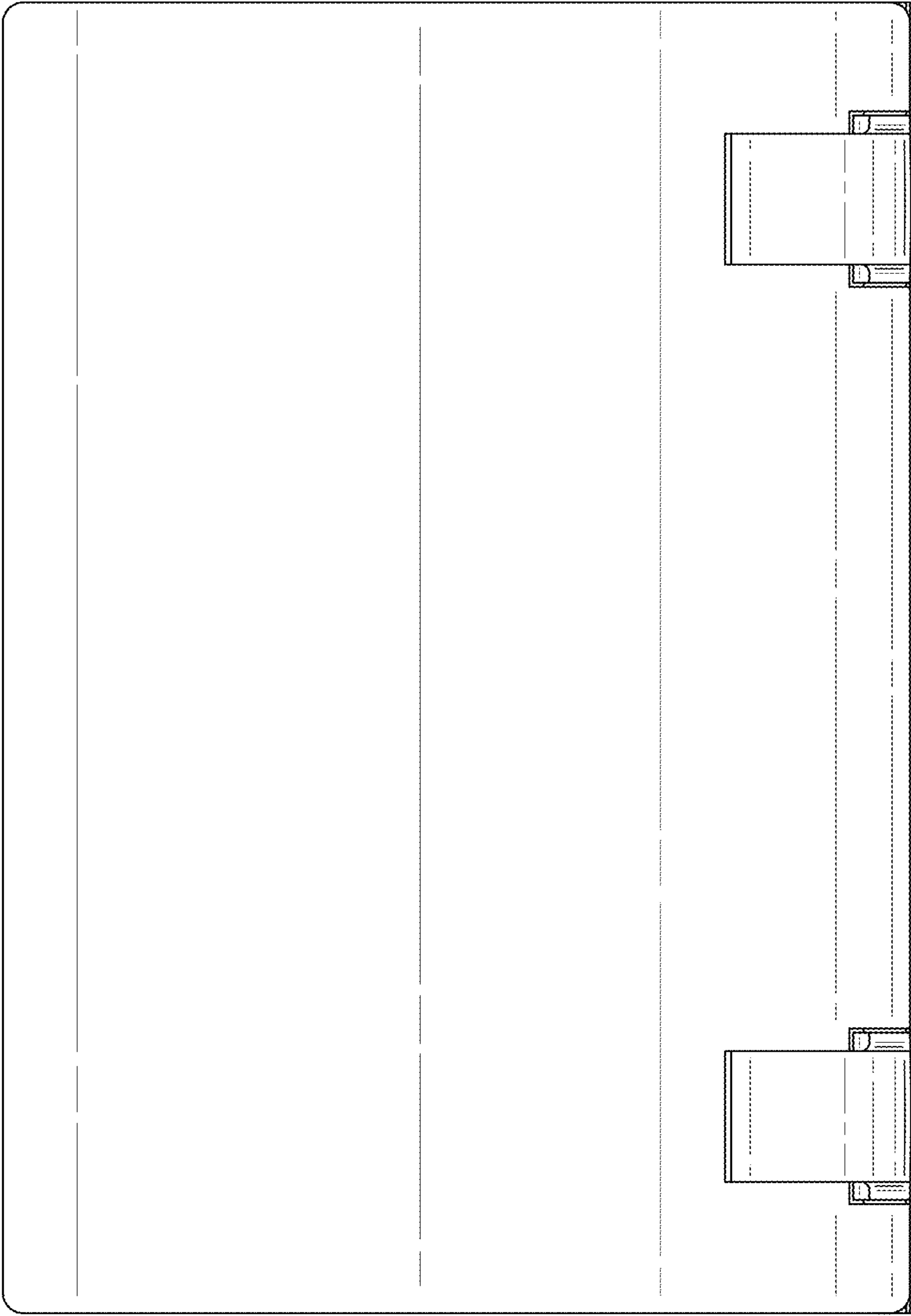

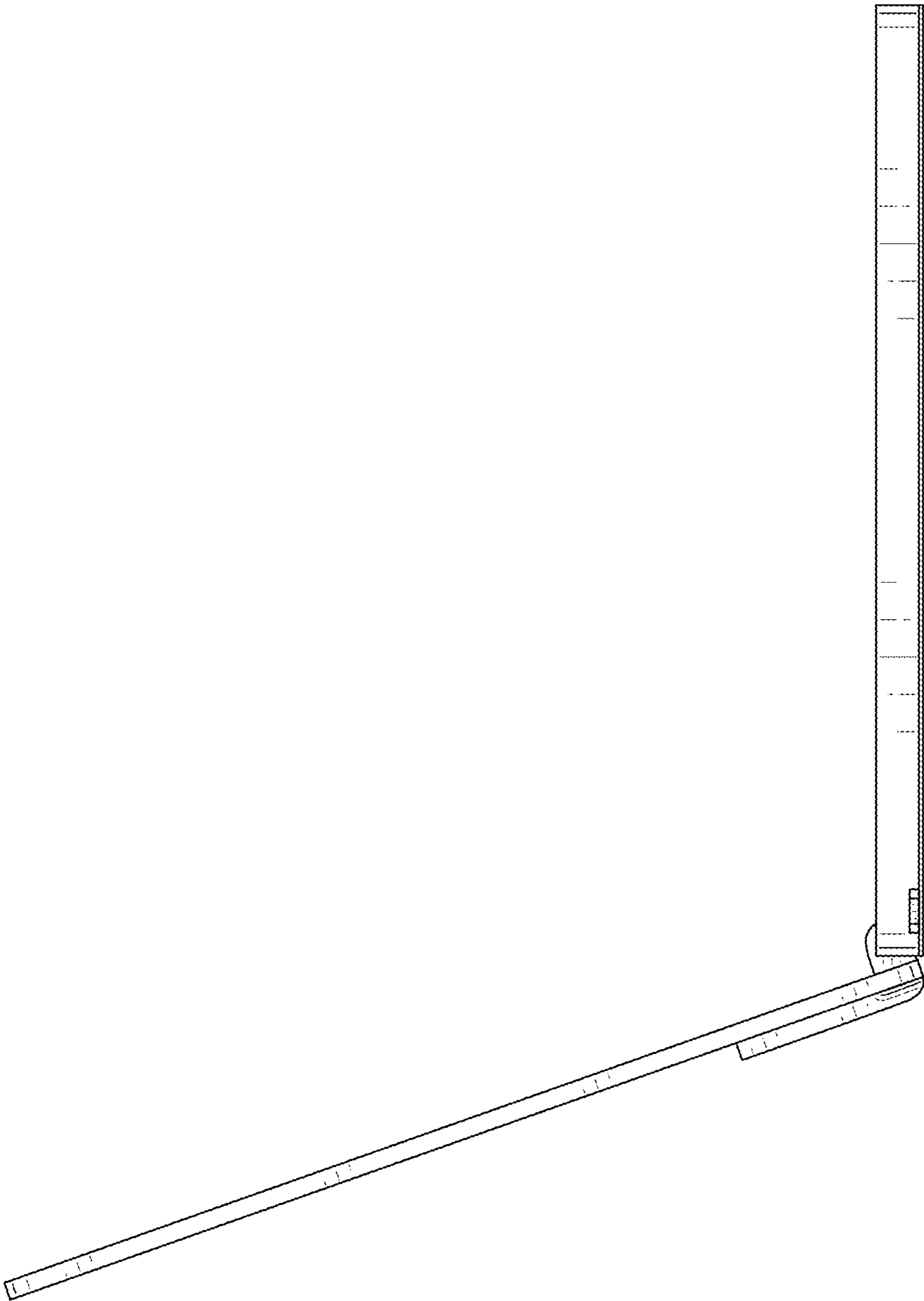

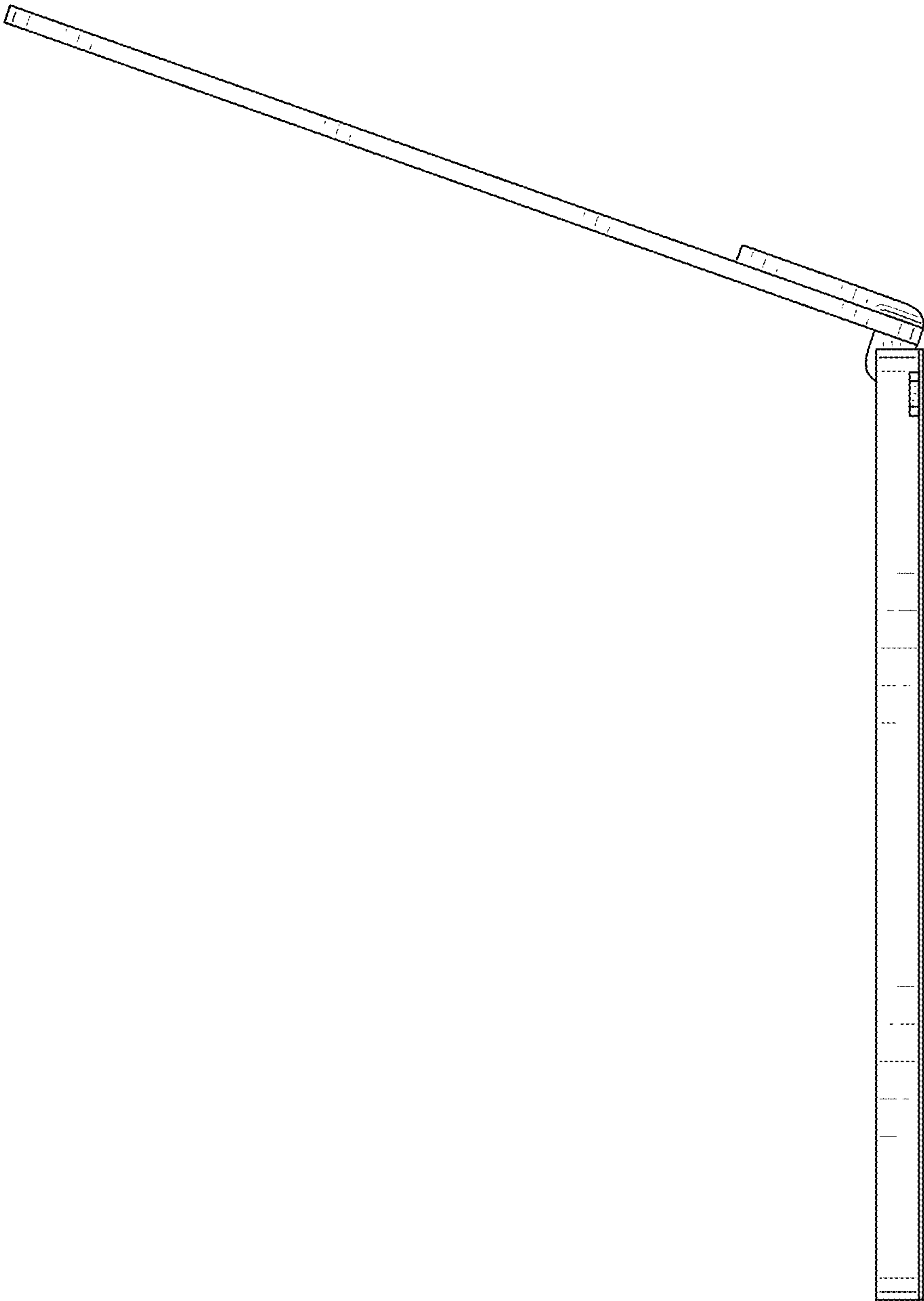

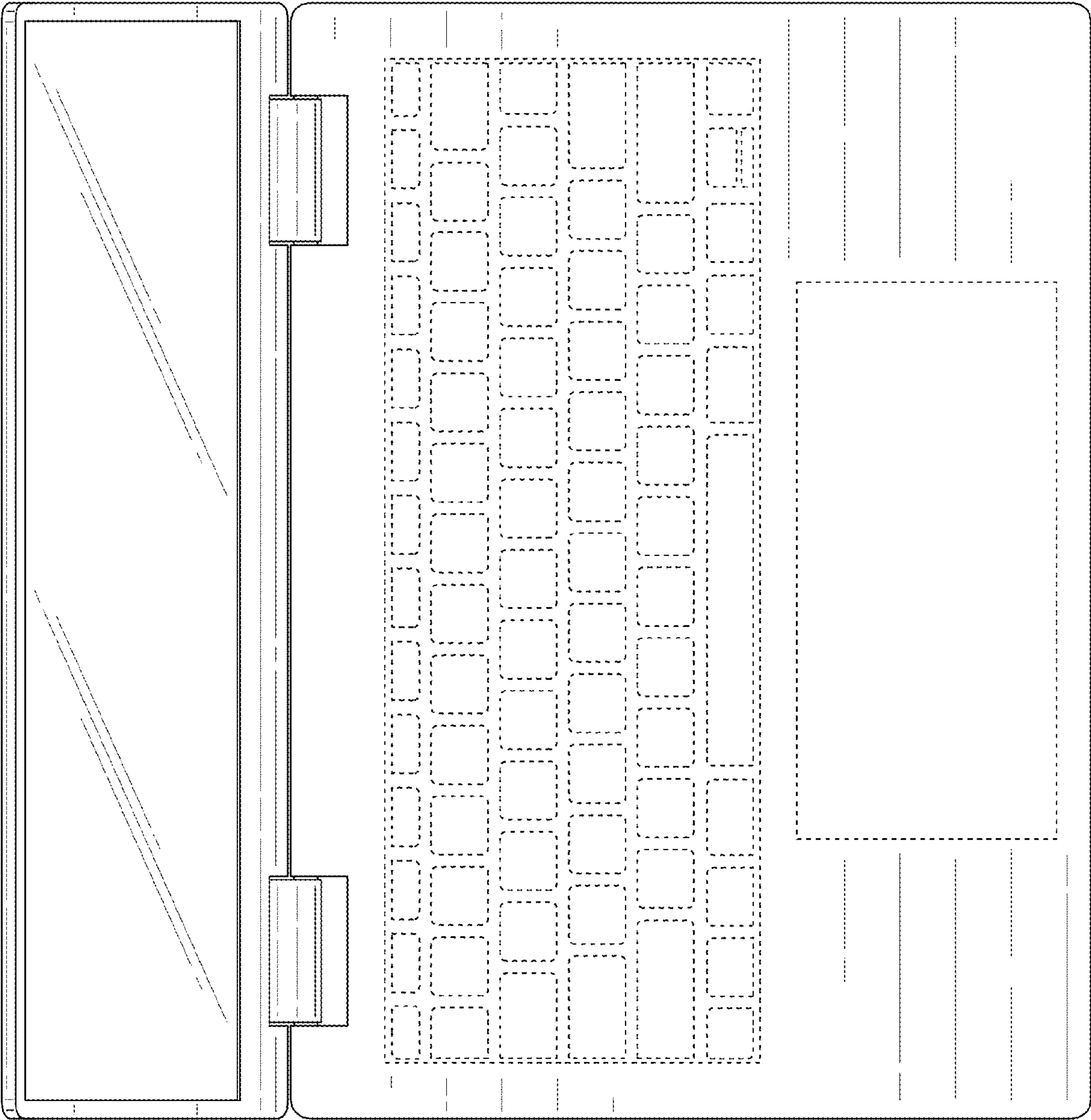
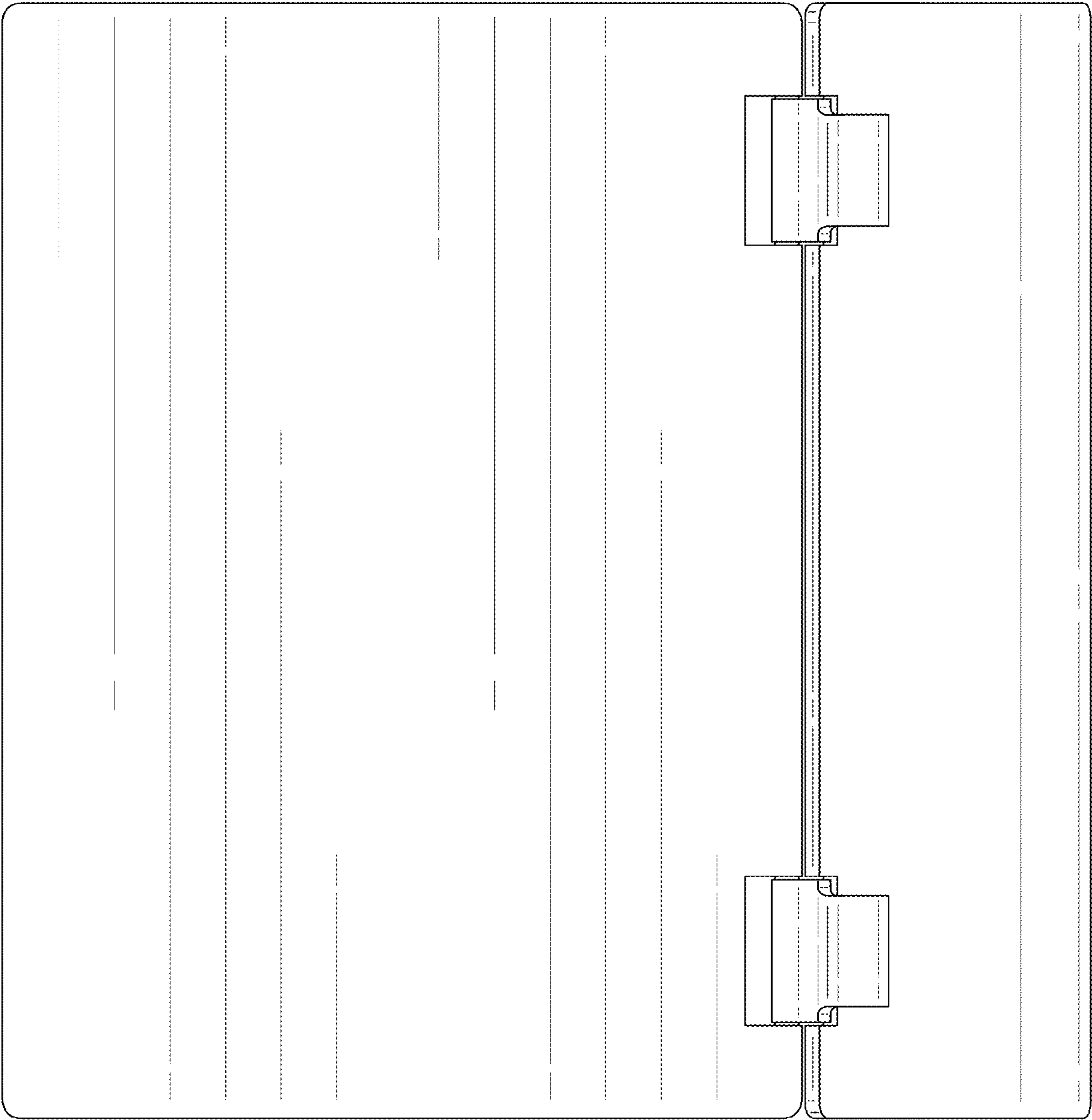

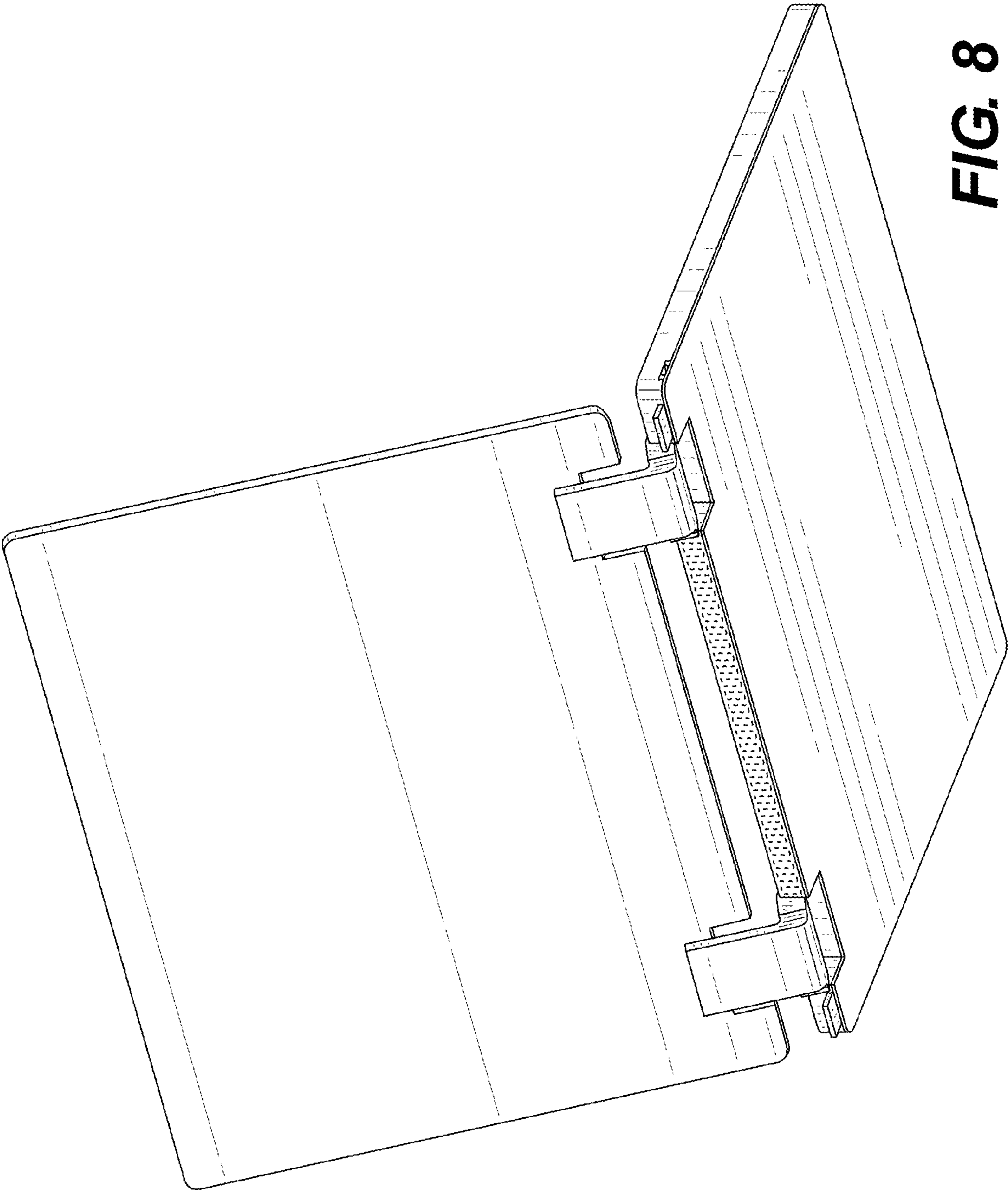

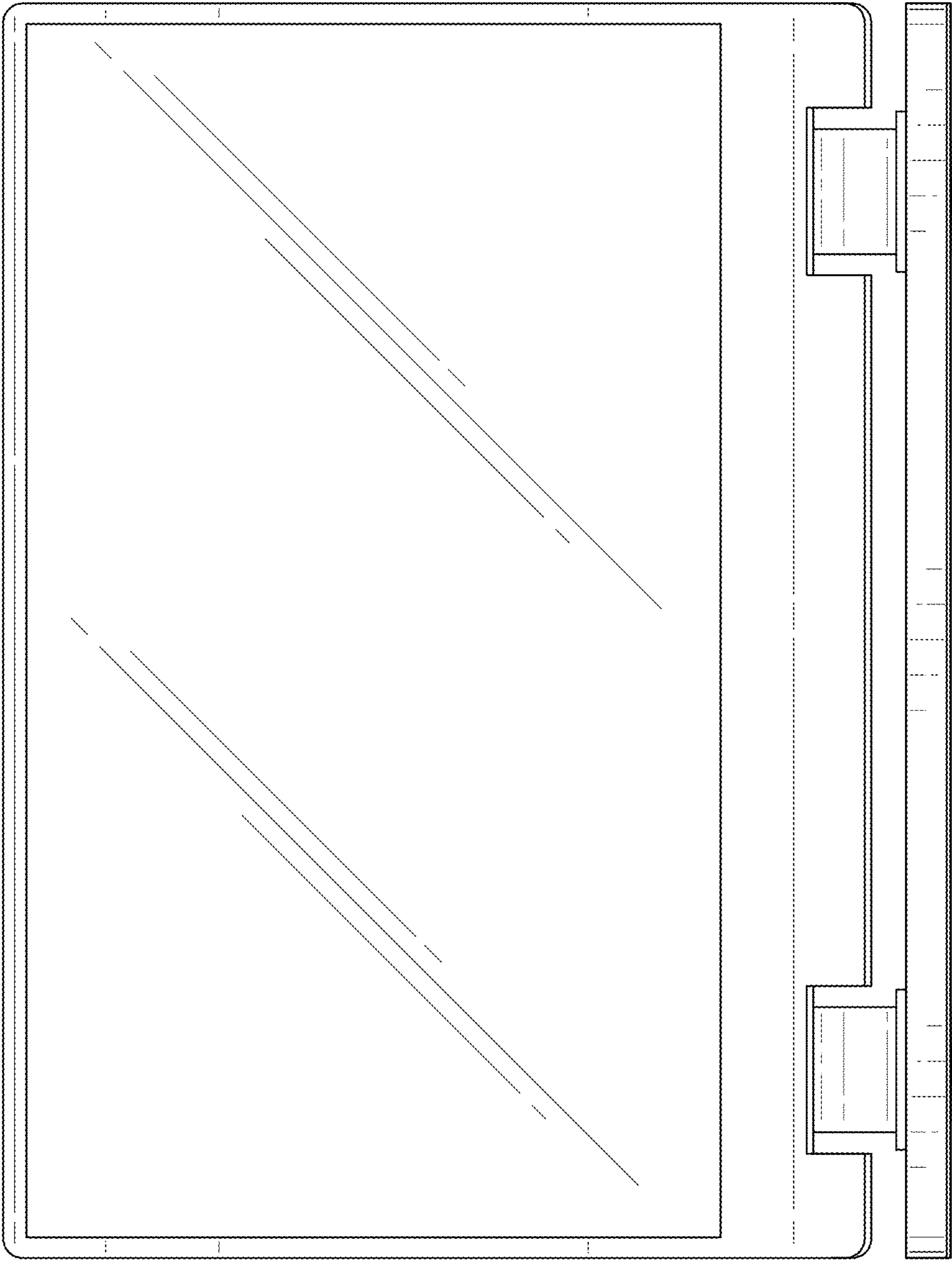

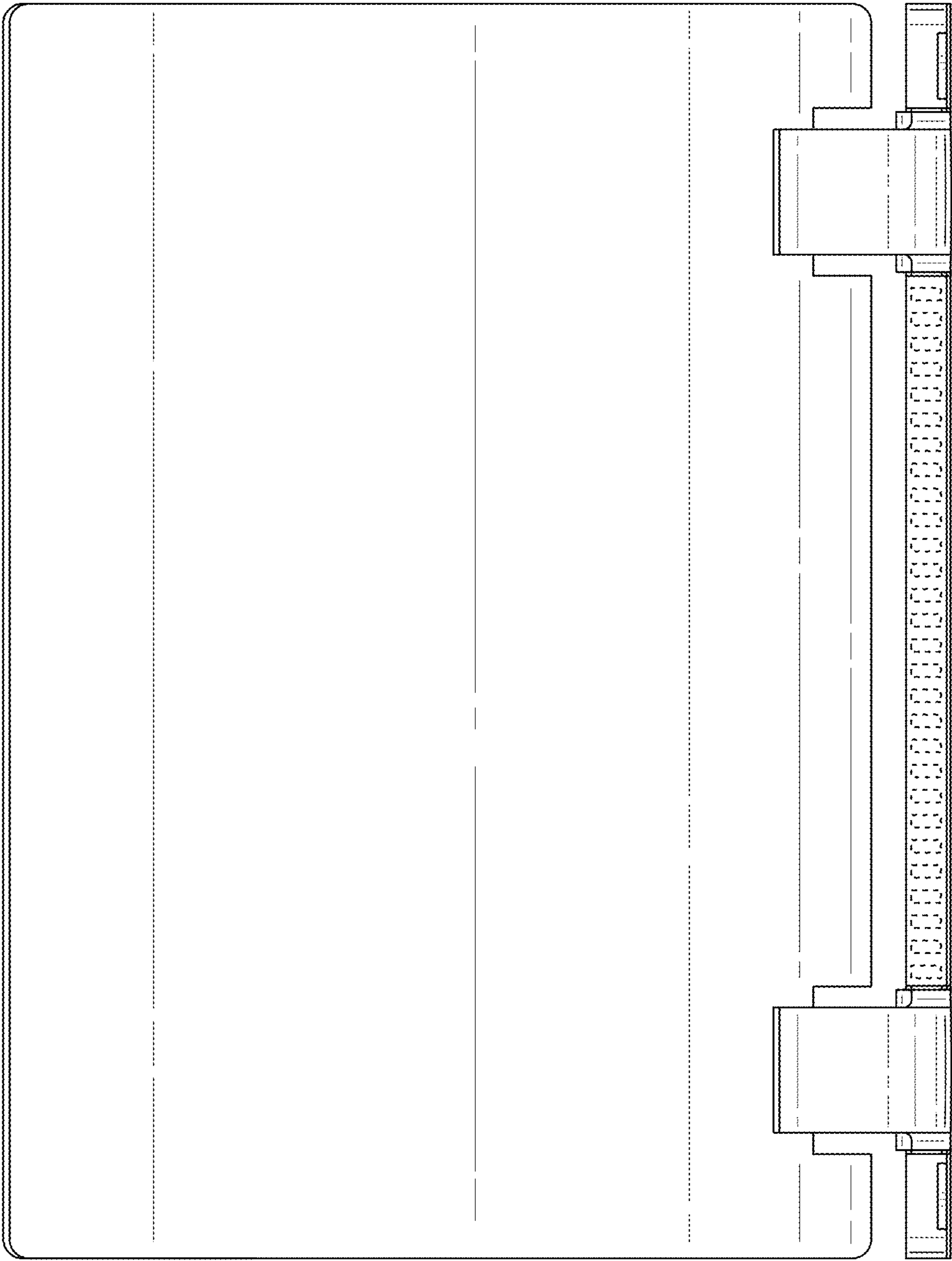

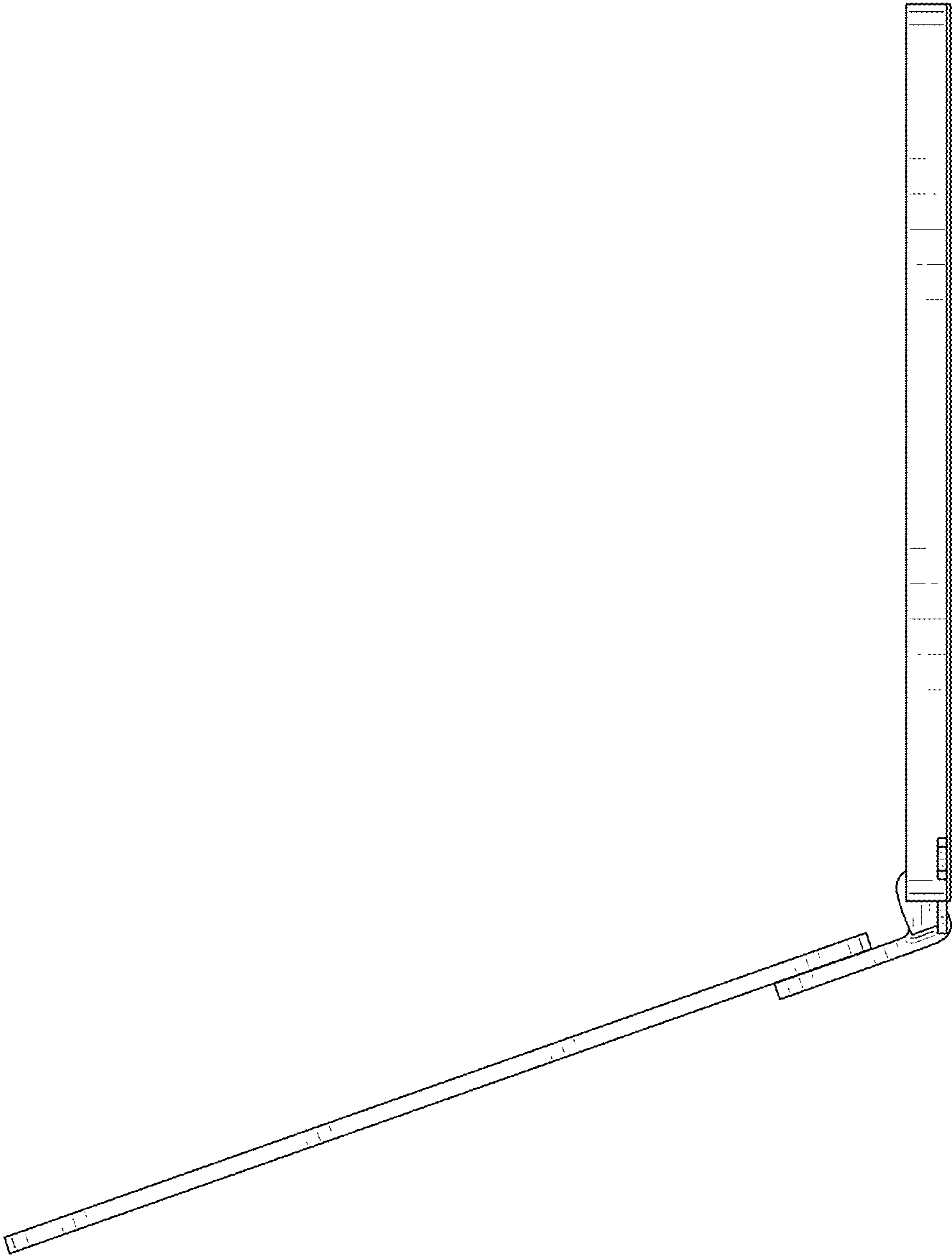

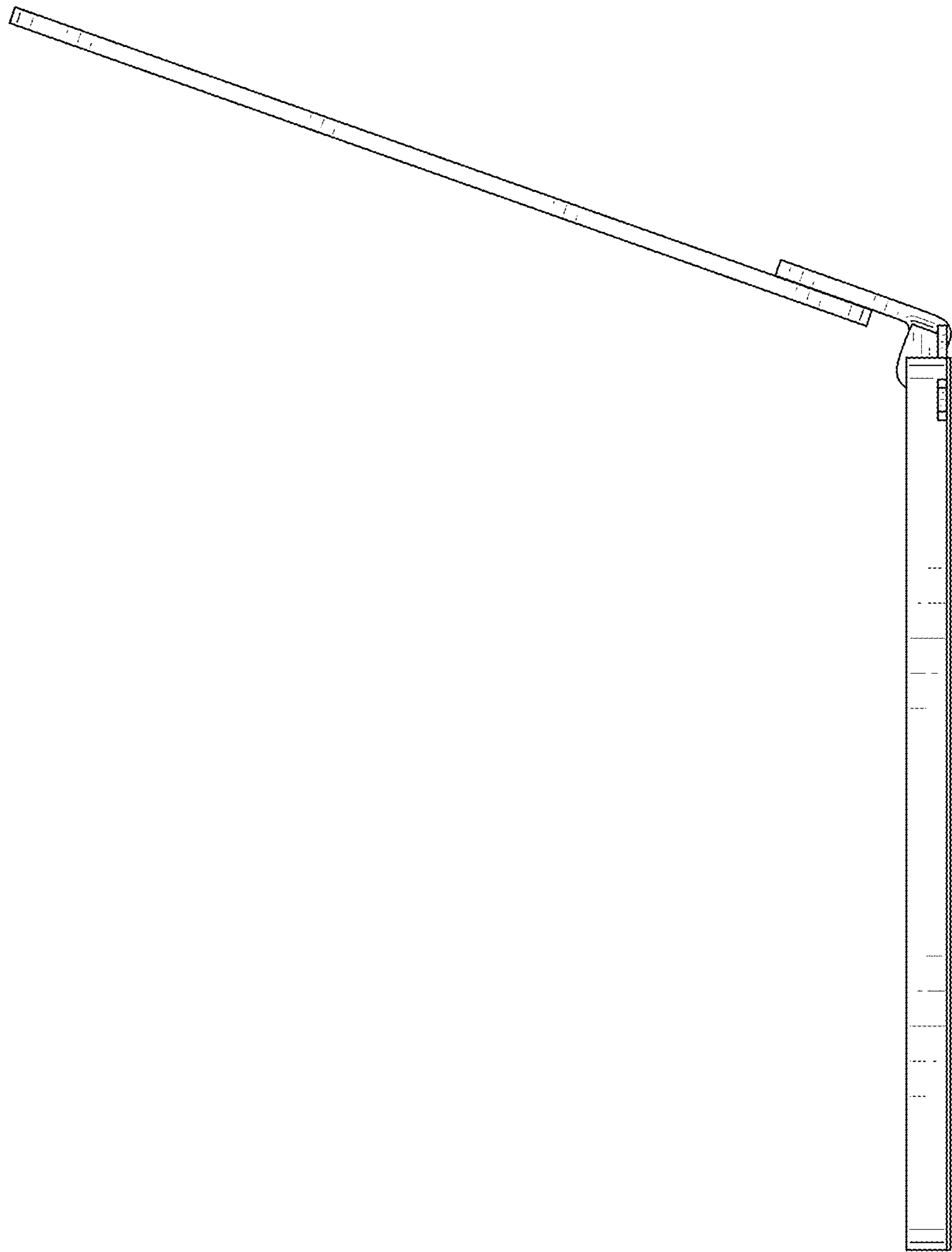

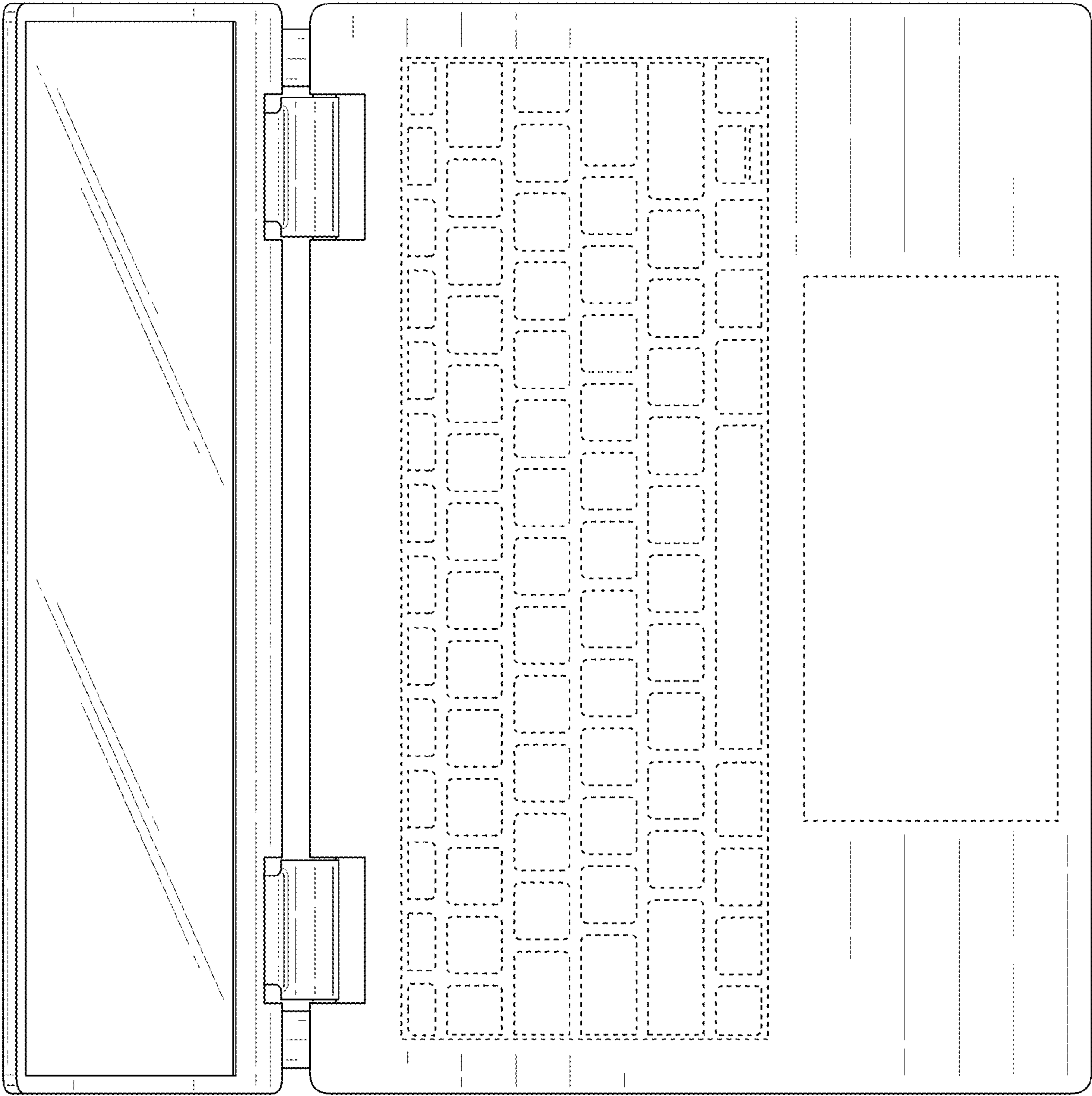
