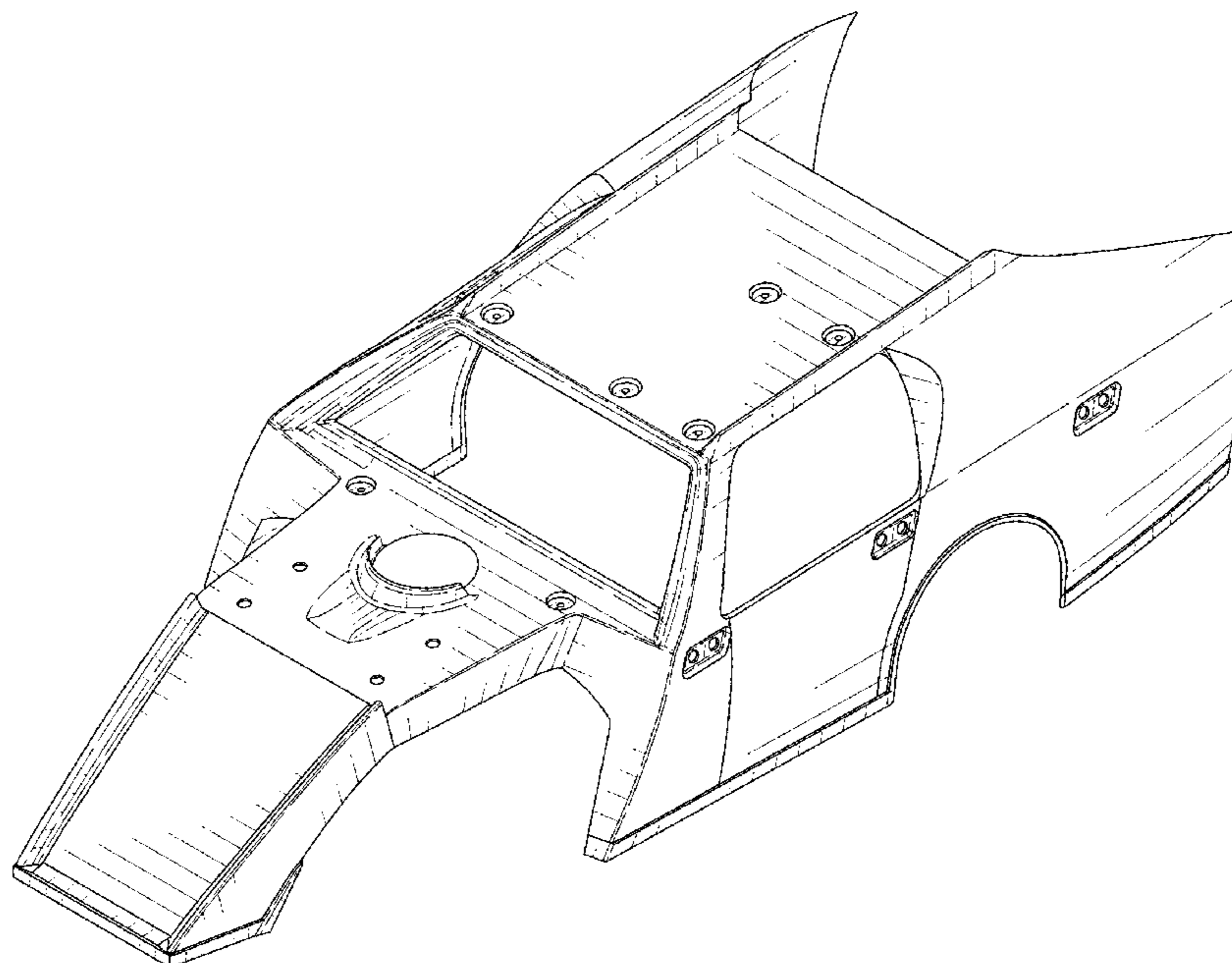
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an upper, left, front perspective view of a model vehicle body showing our new design;
FIG. 2 is an upper, right, rear perspective view thereof;
FIG. 3 is a lower, right, front perspective view thereof;
FIG. 4 is a lower, left, rear perspective view thereof;
FIG. 5 is a front elevation view thereof;

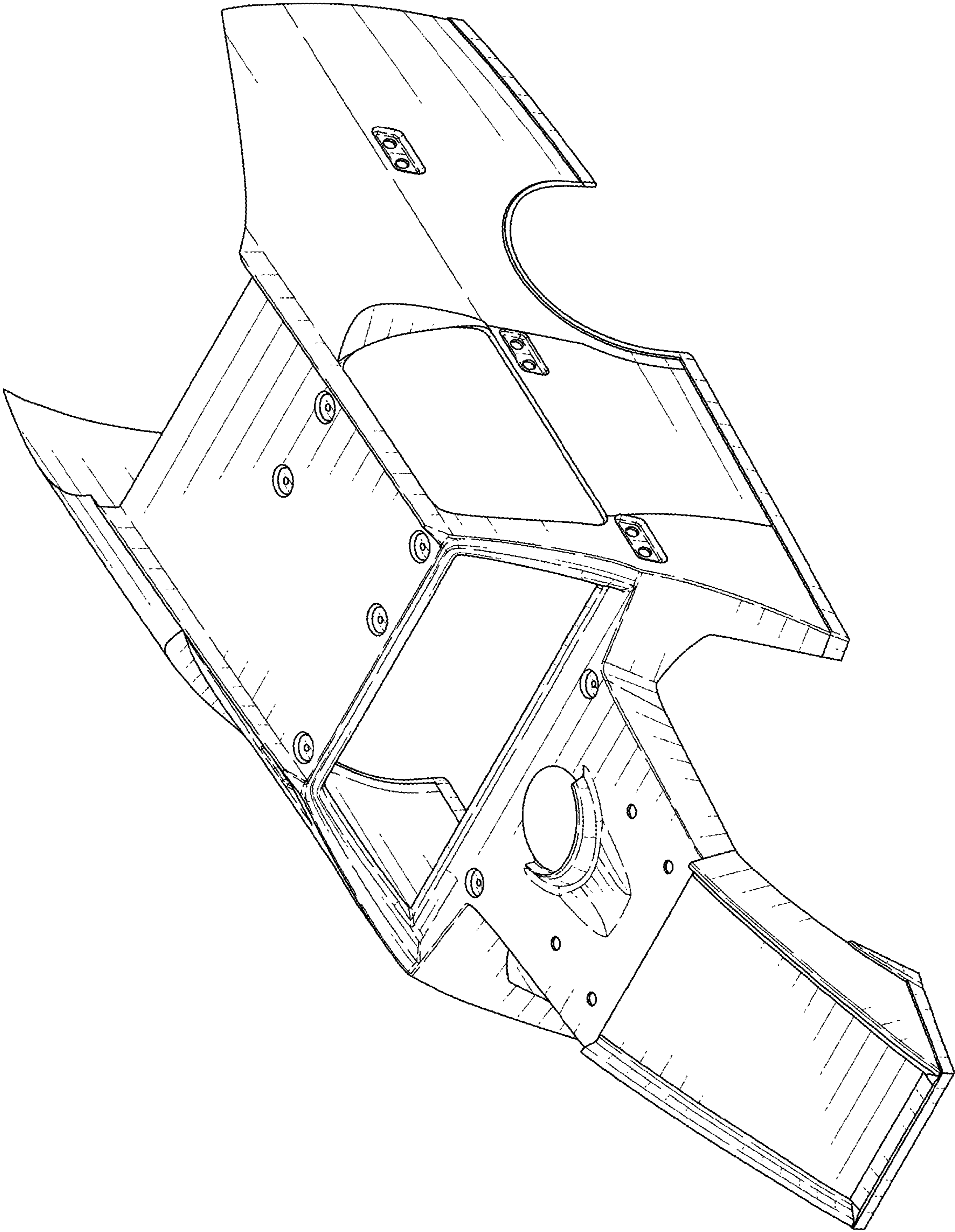

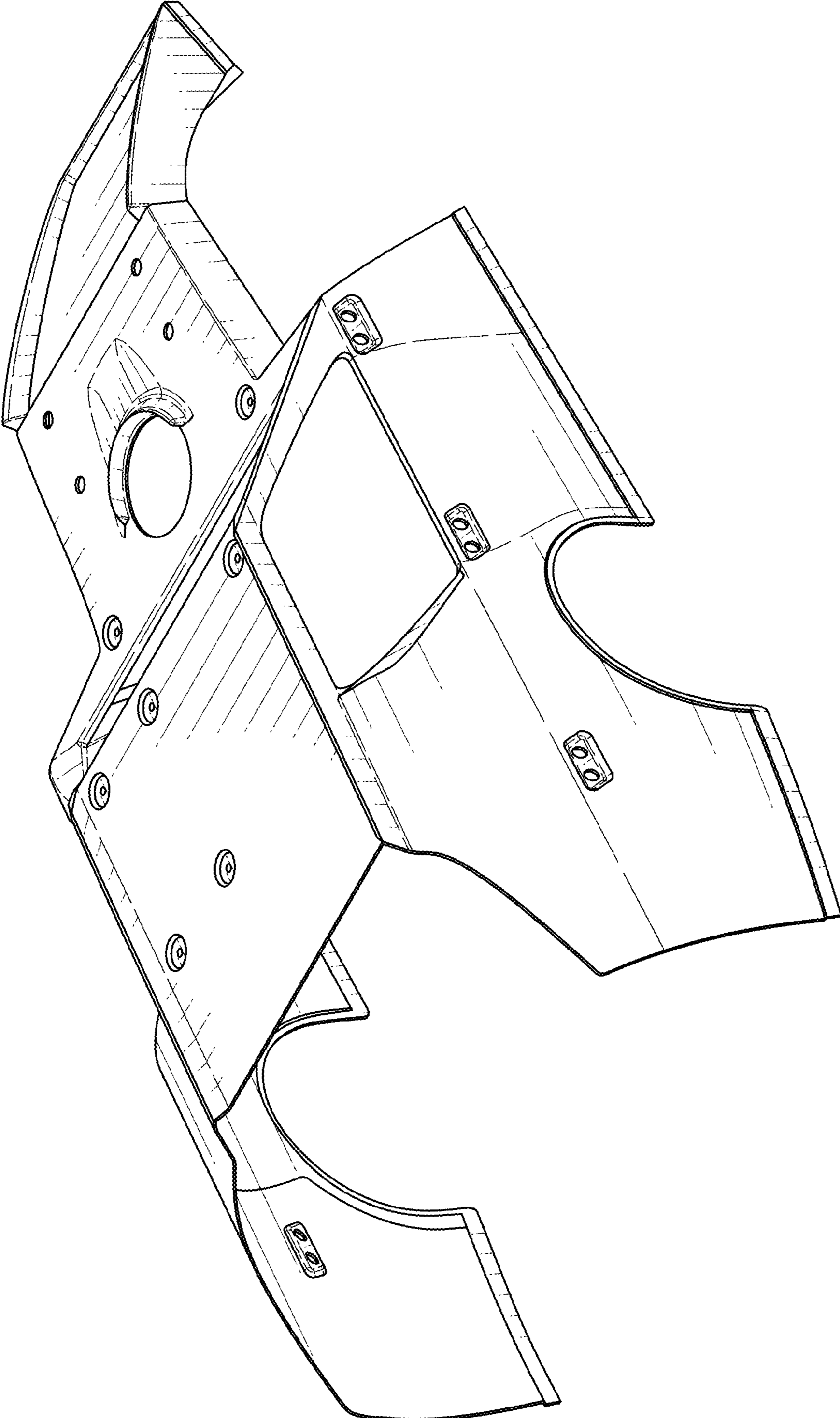

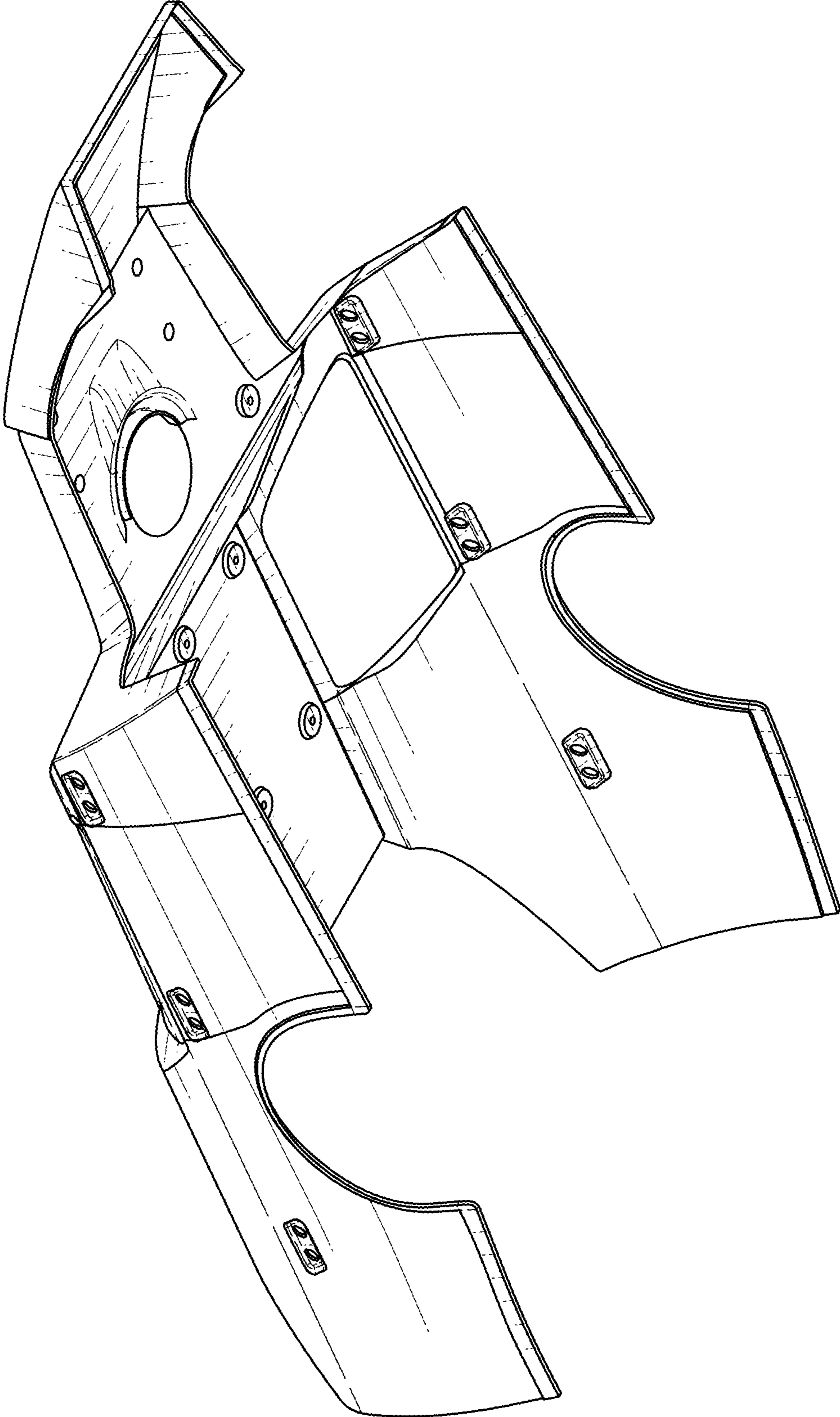

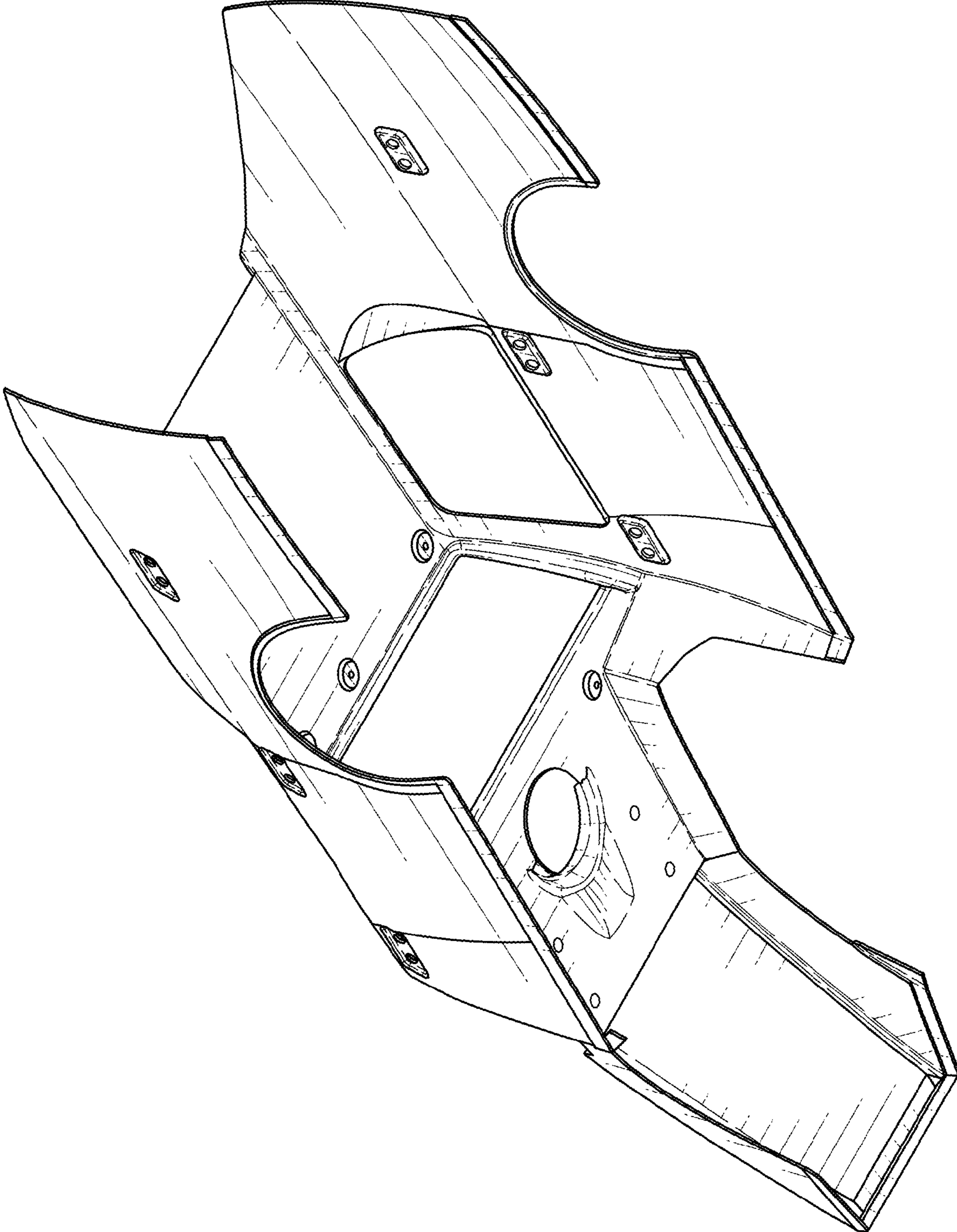

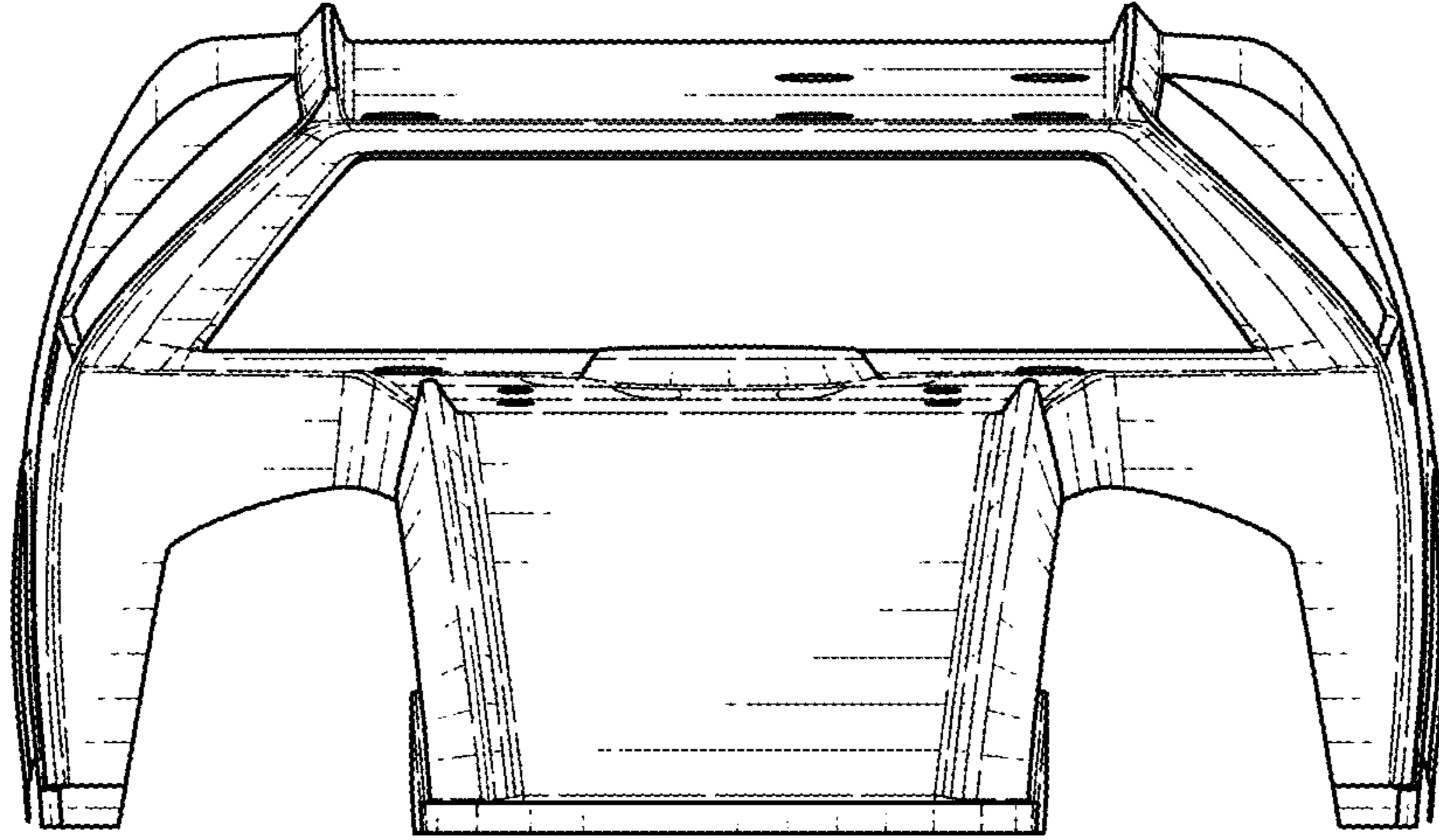

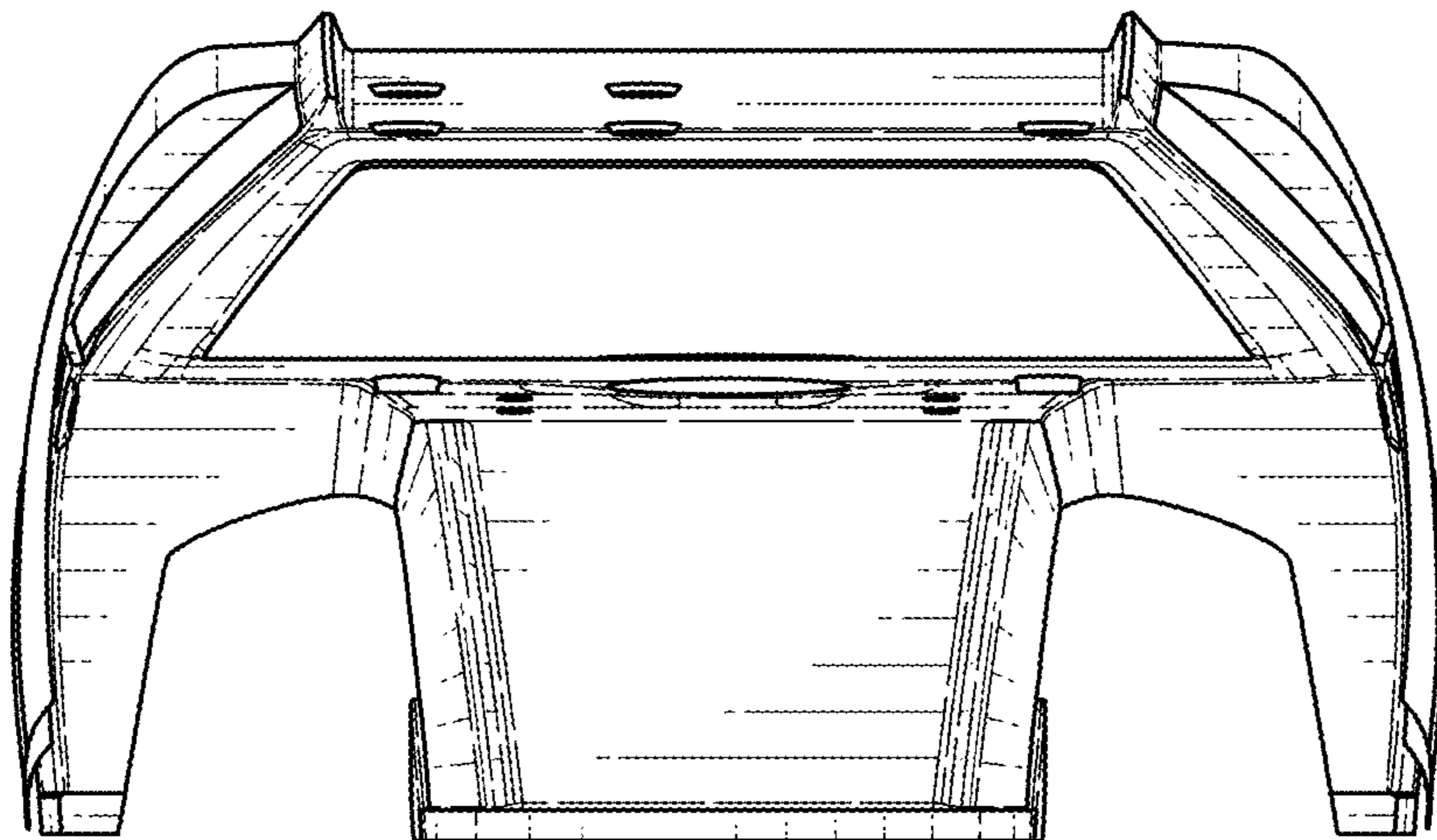

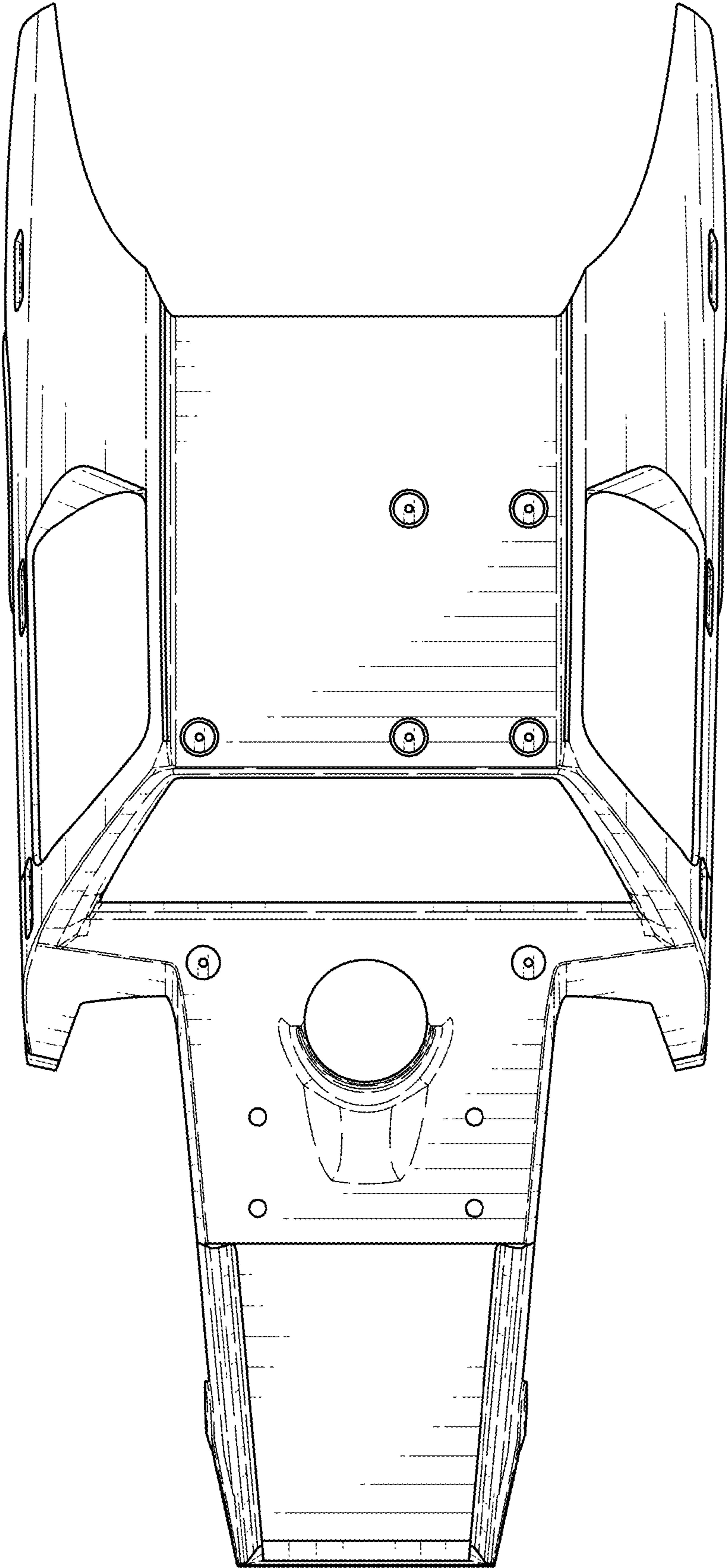

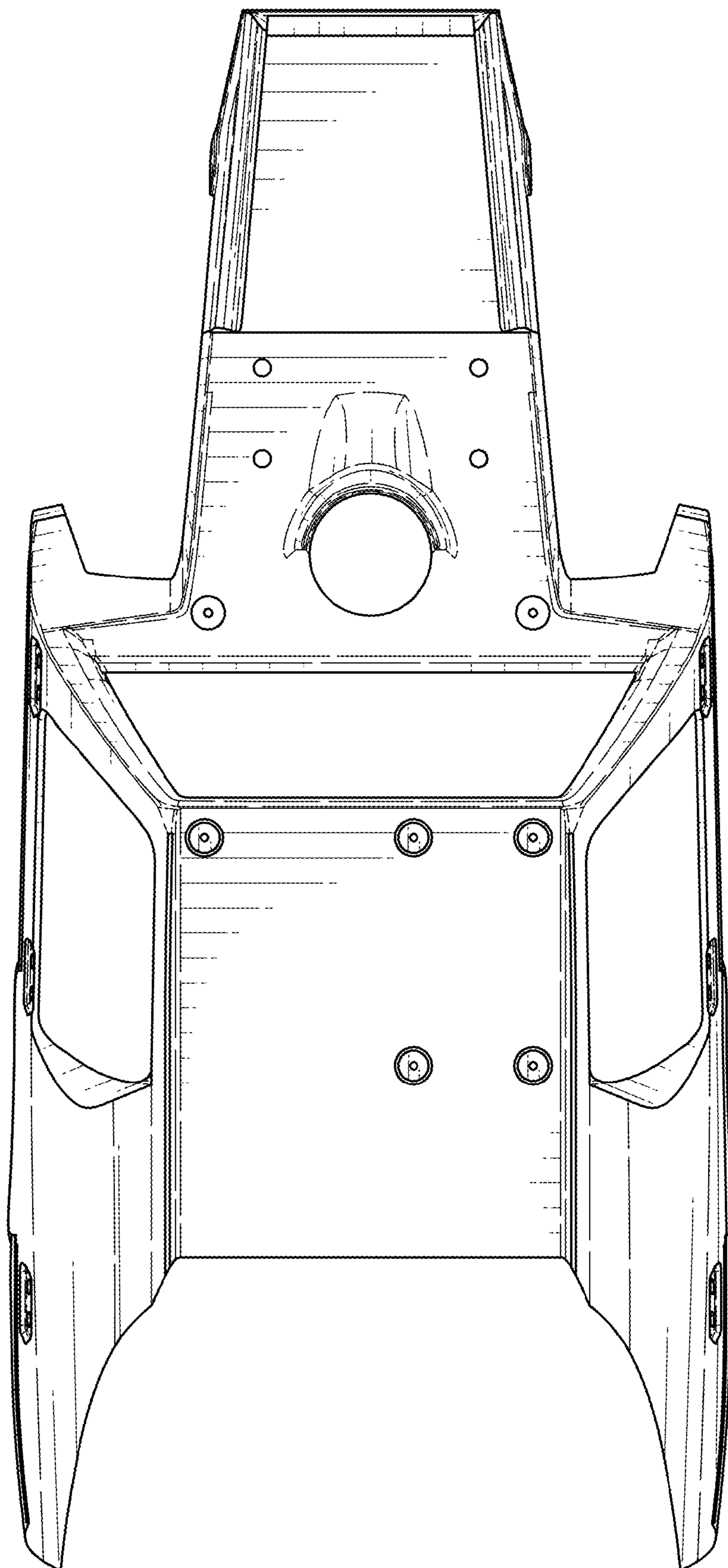

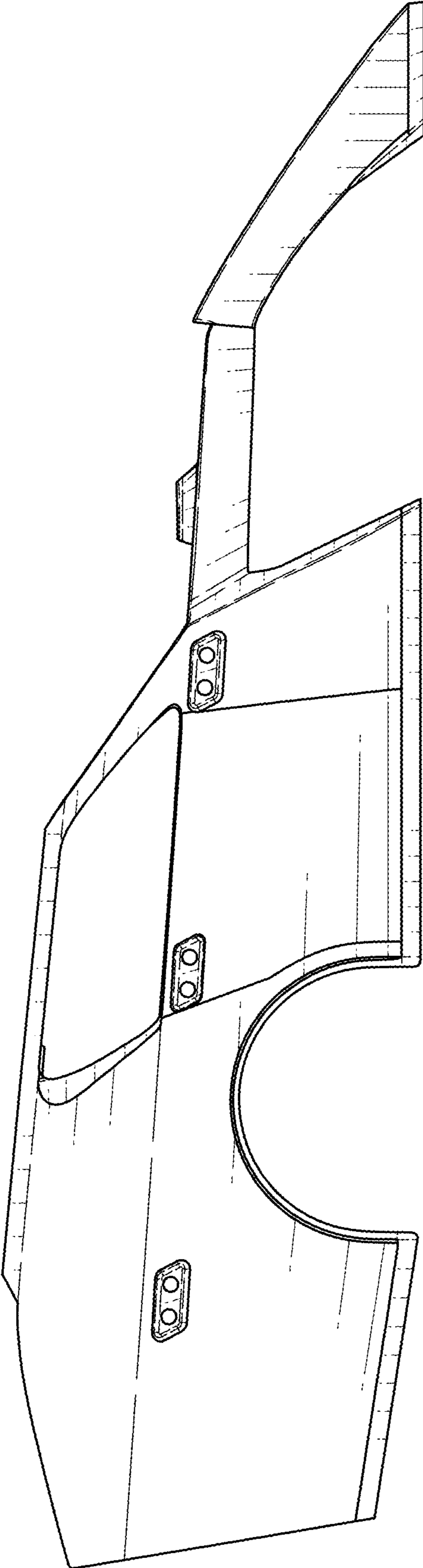

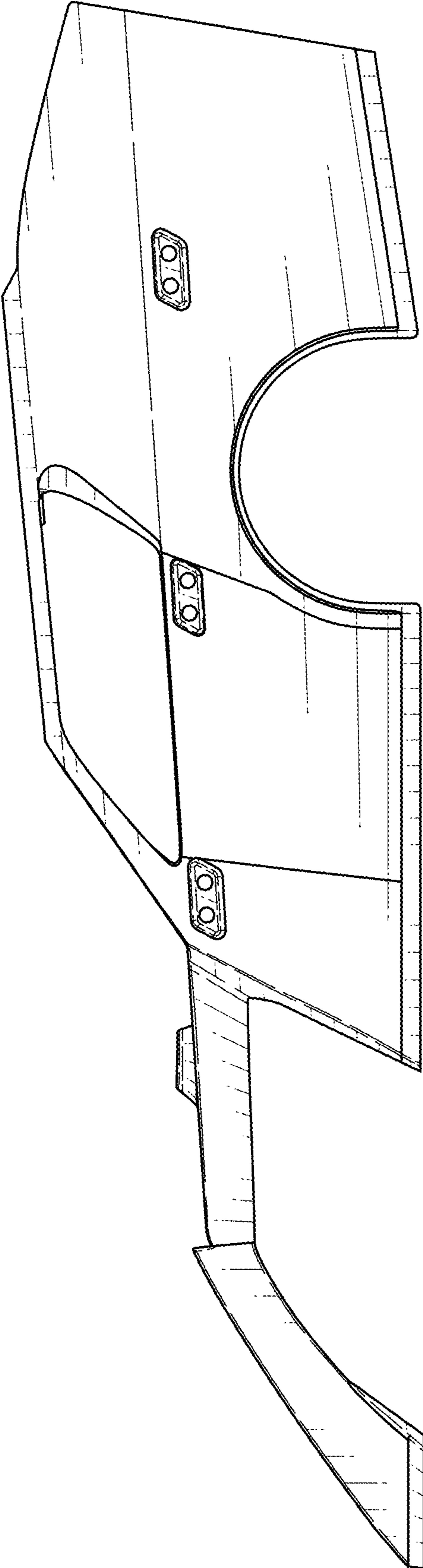
