[57] **CLAIM**

The ornamental design for a cylindrical display container for merchandise, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged perspective view of a cylindrical display container for merchandise showing my new design;

FIG. 2 is a top plan view of FIG. 1, the bottom being identical;

FIG. 3 is a front elevational view of FIG. 1;

FIG. 4 is a side elevational view taken from the right of FIG. 3;

FIG. 5 is a side elevational view taken from the left of FIG. 3;

FIG. 6 is a rear elevational view of FIG. 1;

FIG. 7 is a perspective view of a second embodiment of the design of FIG. 1;

FIG. 8 is a top plan view of FIG. 7;

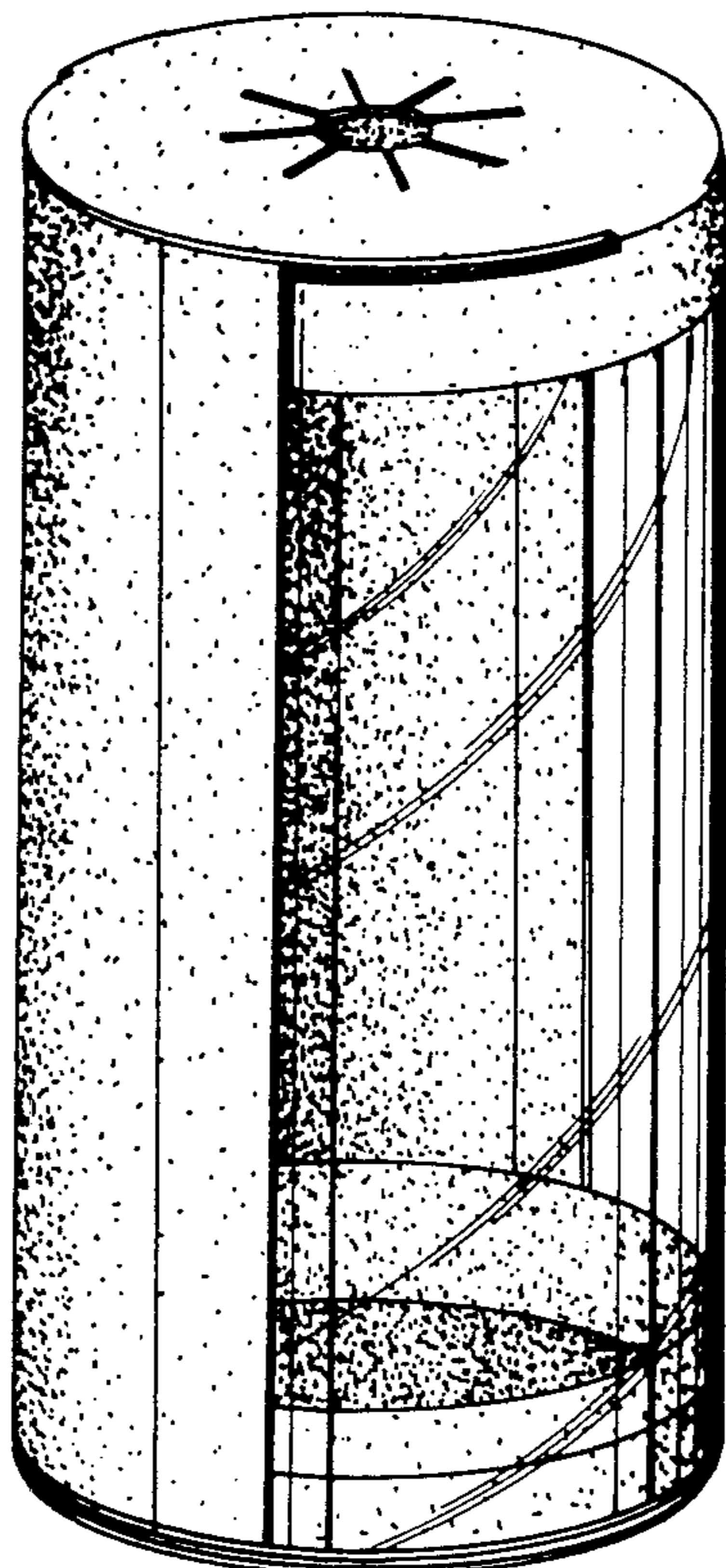
FIG. 9 is a bottom plan view of FIG. 7;

FIG. 13 is a rear elevational view of FIG. 7.



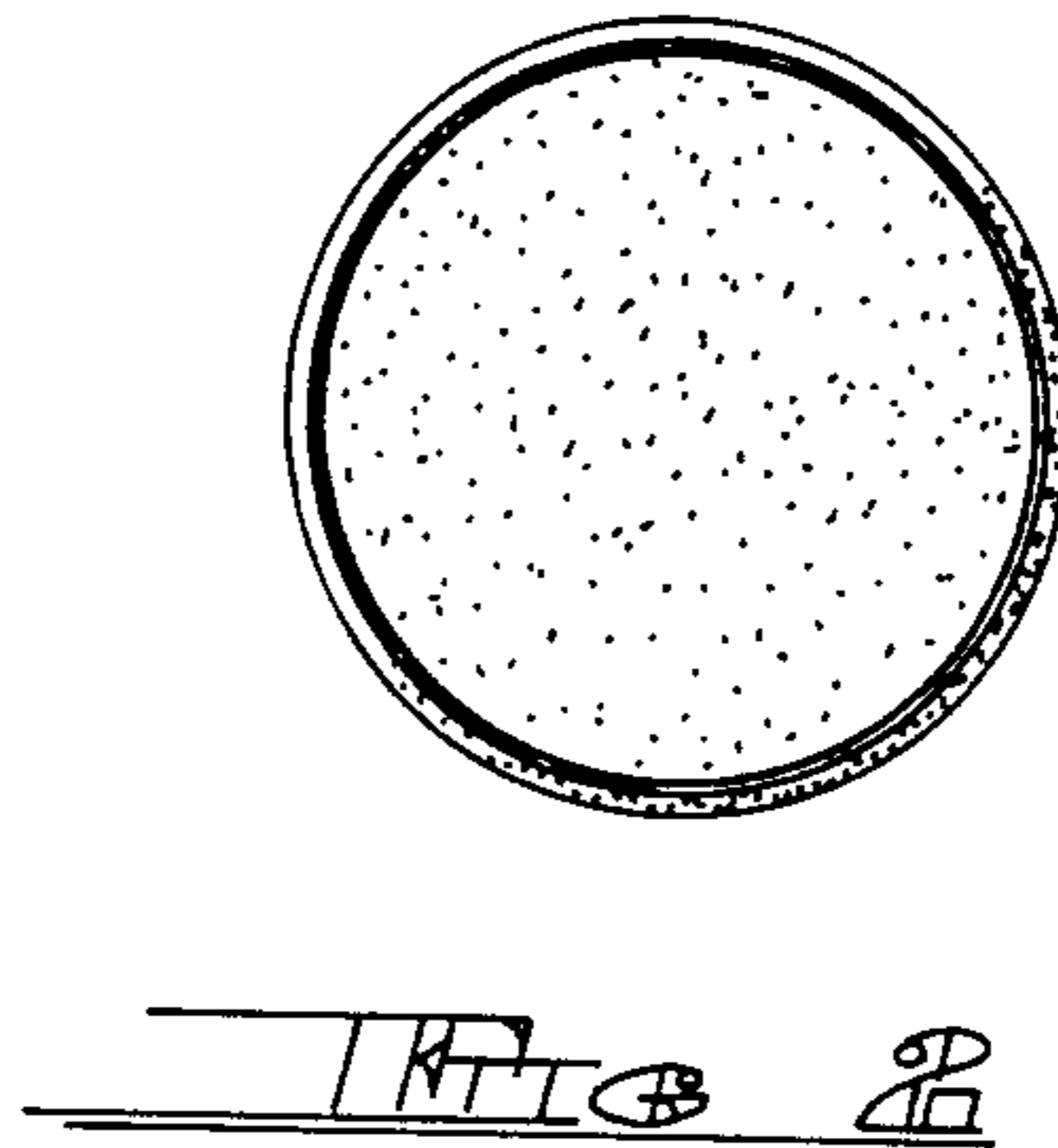
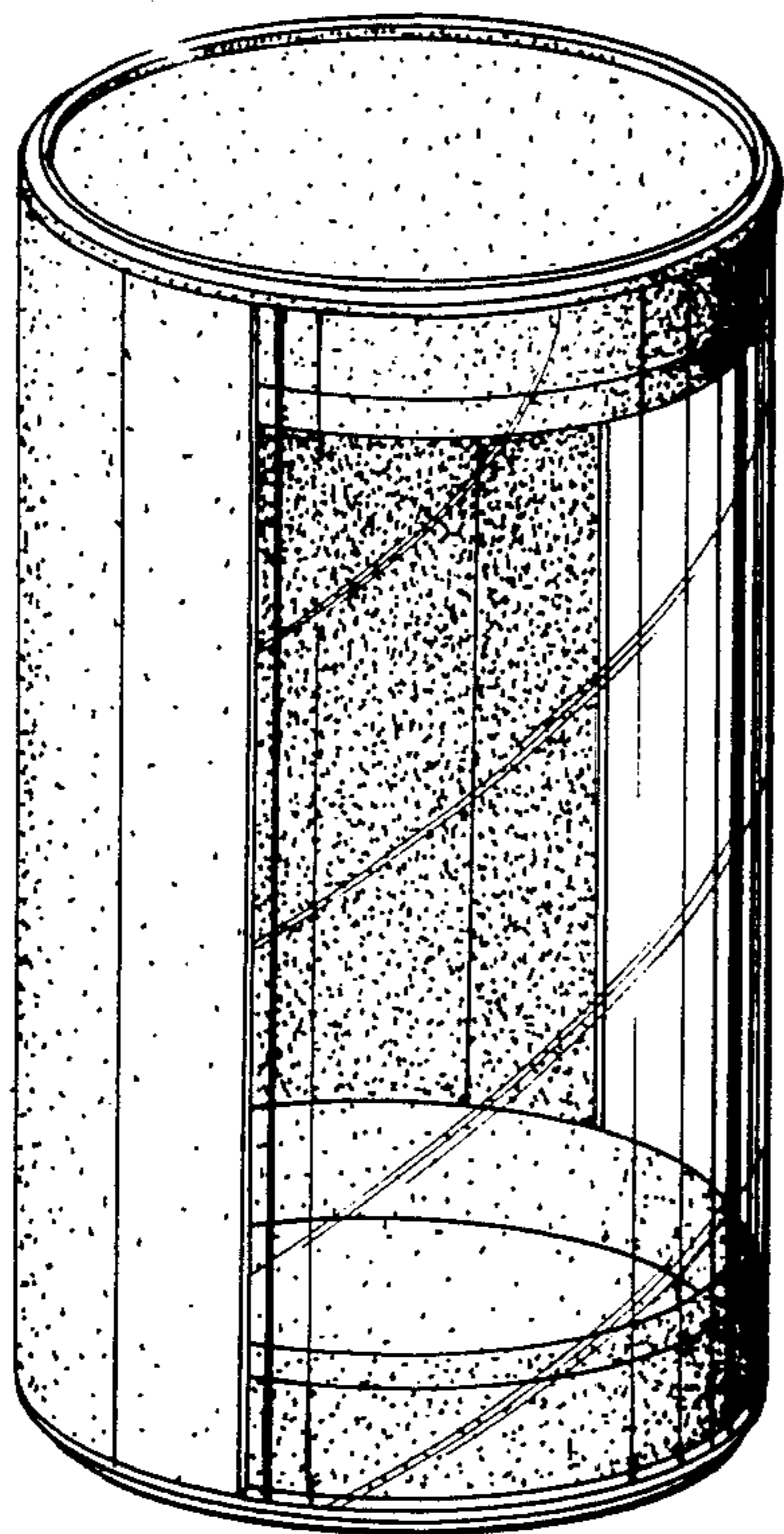

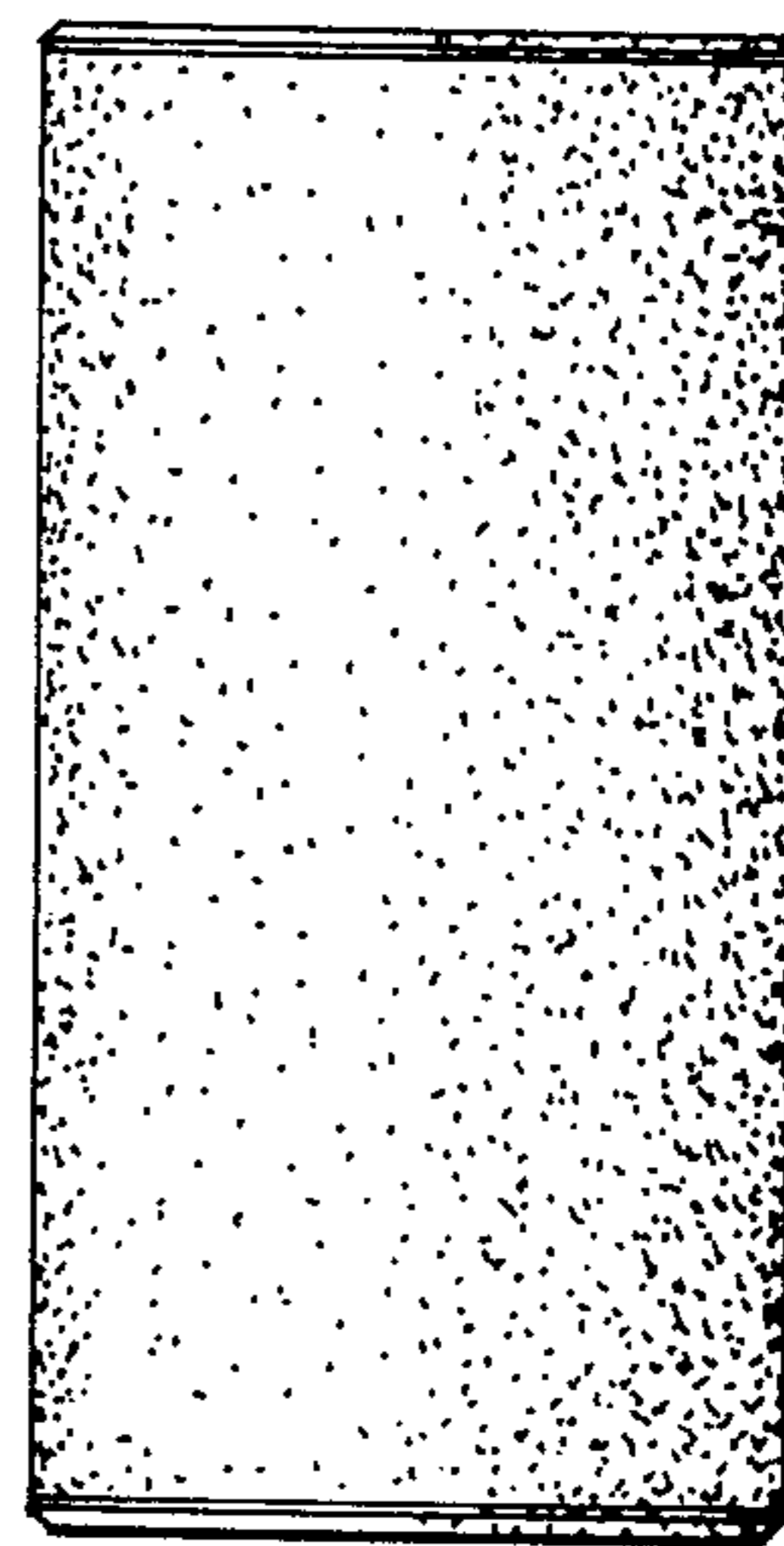
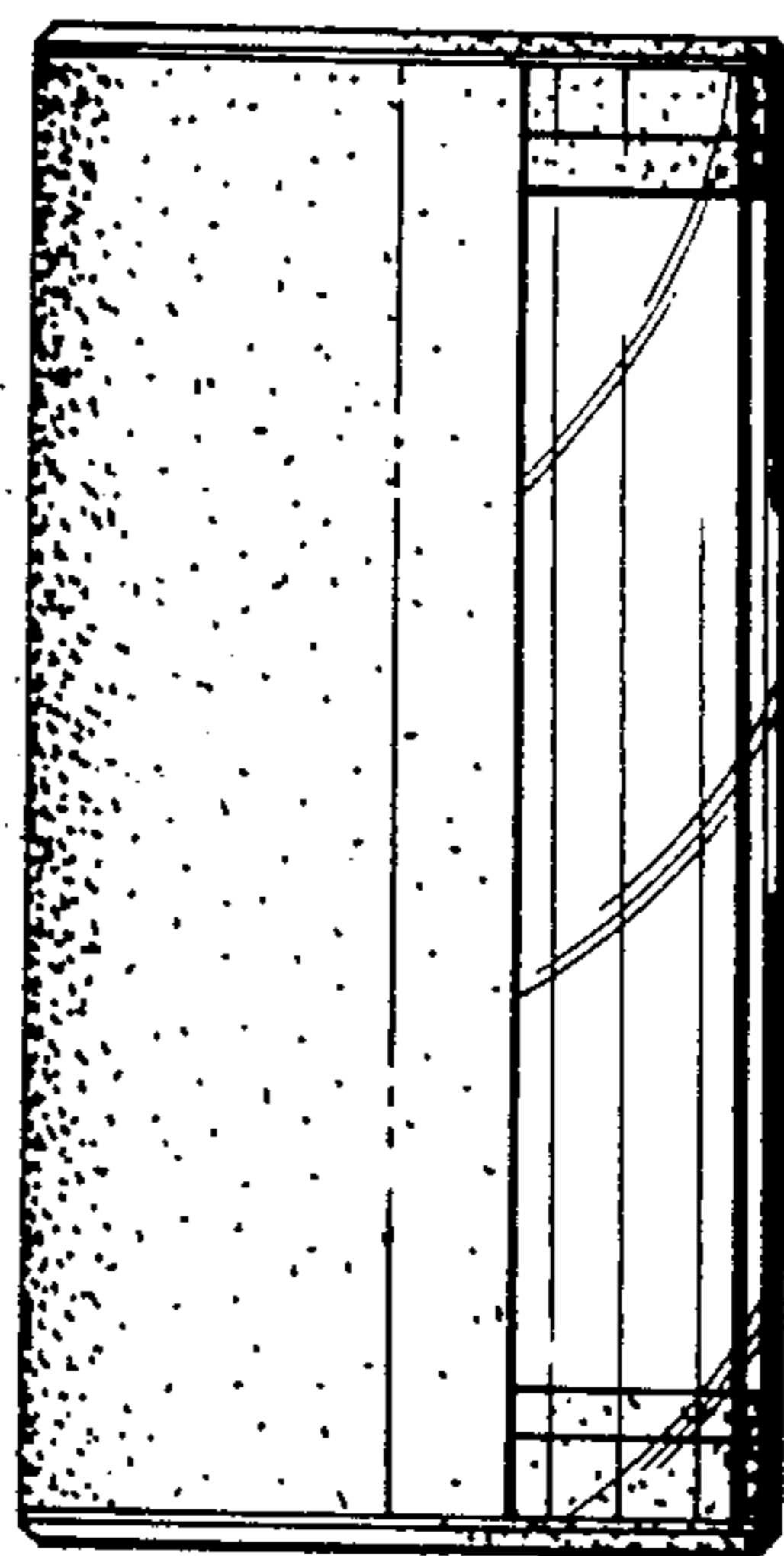
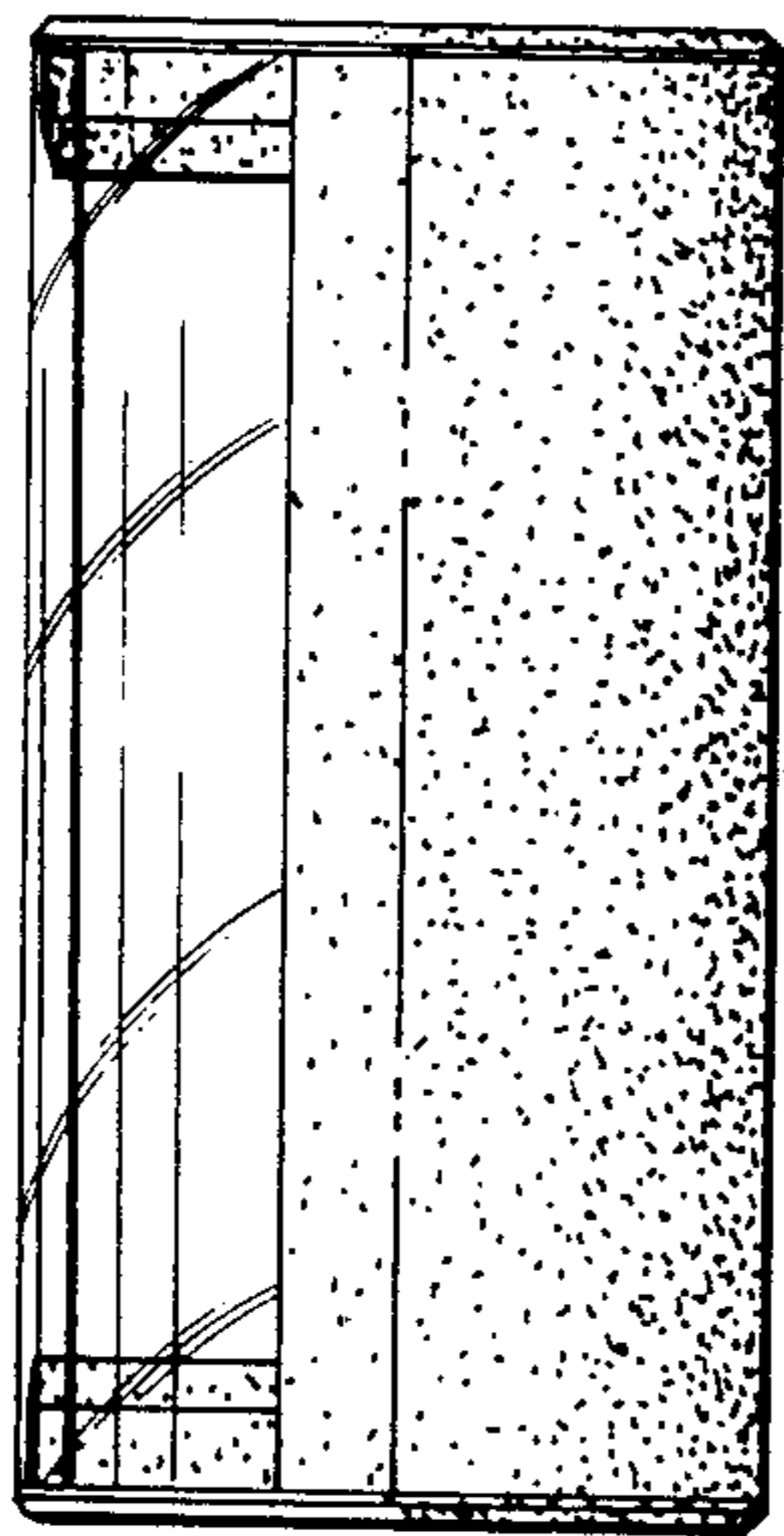
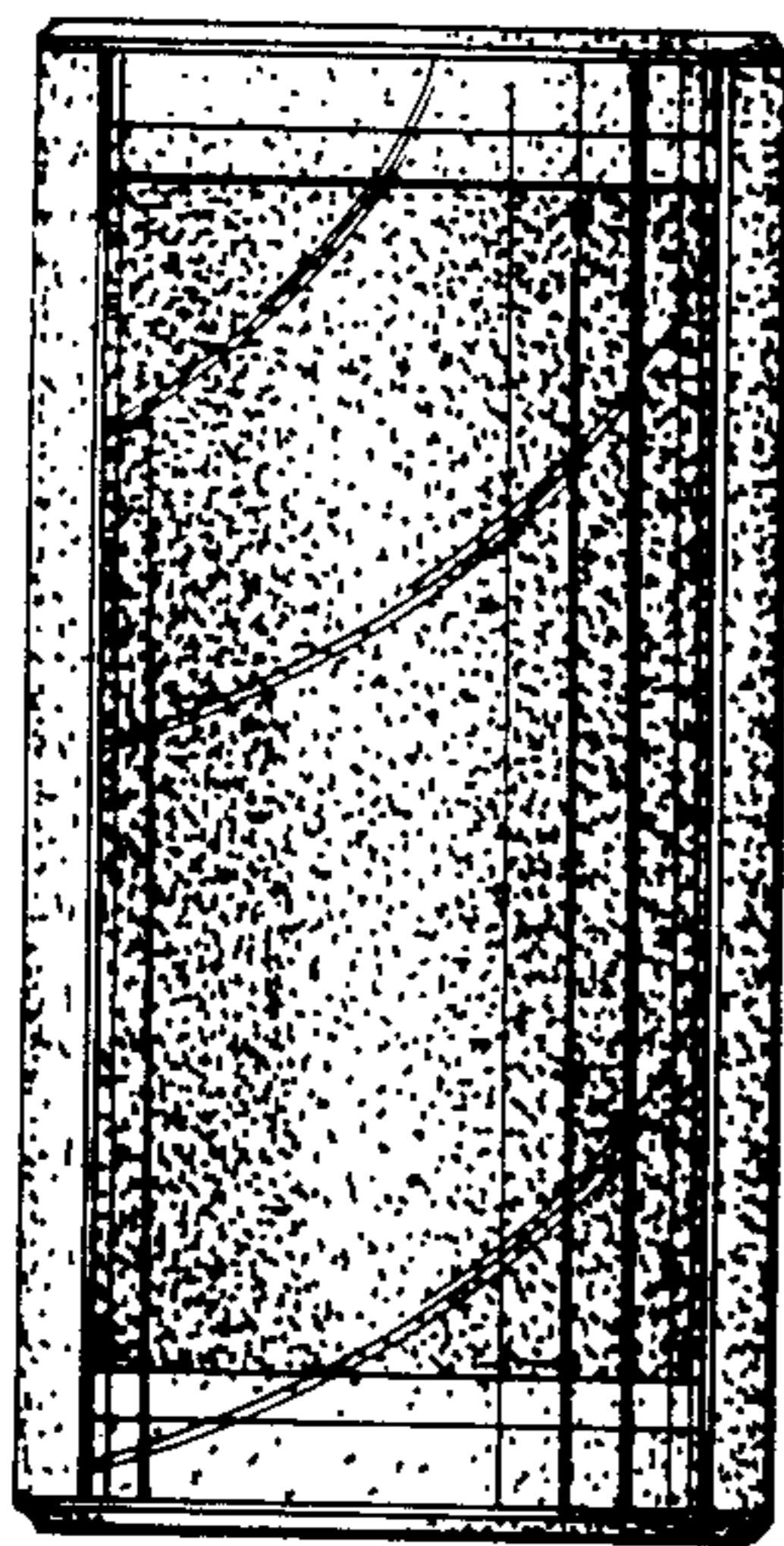

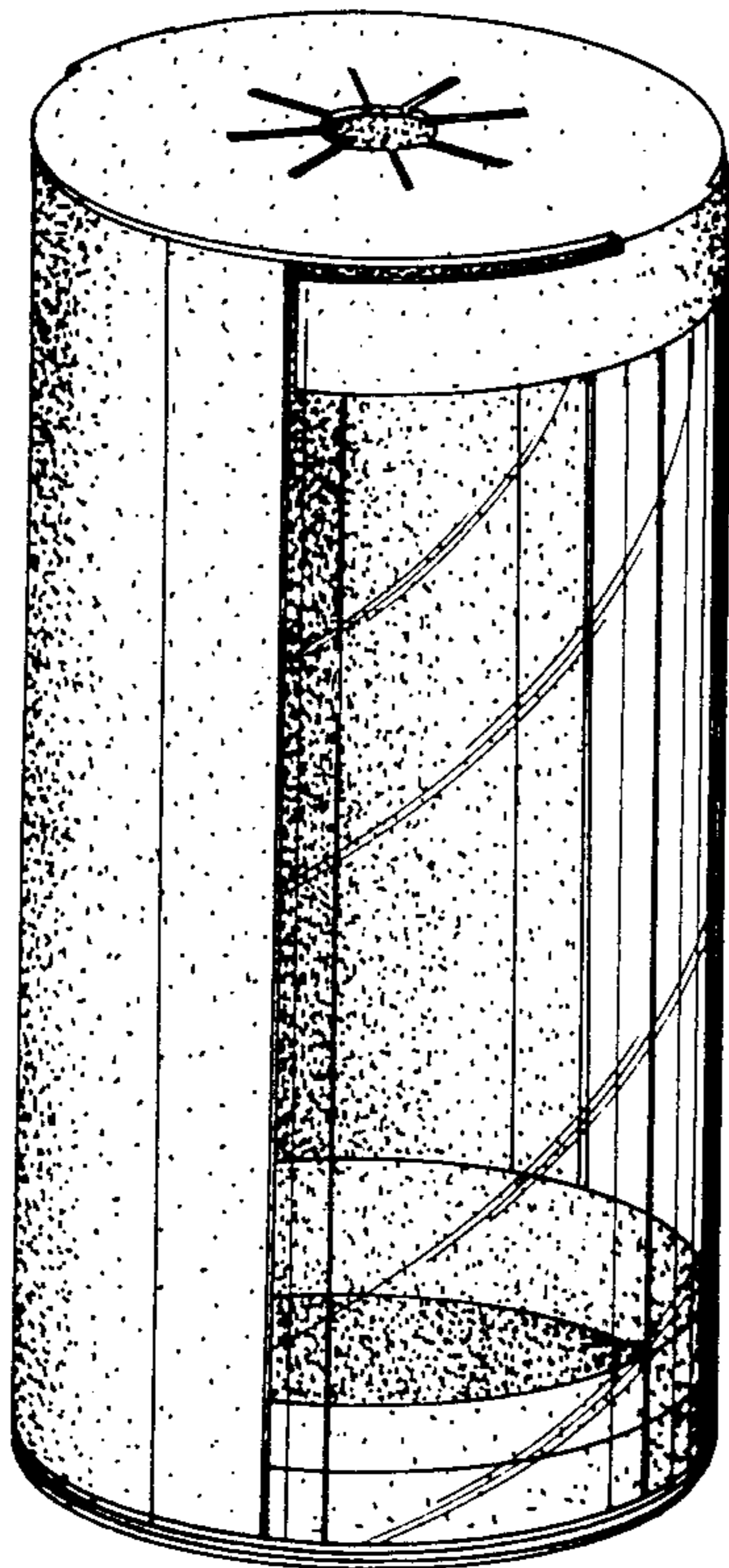

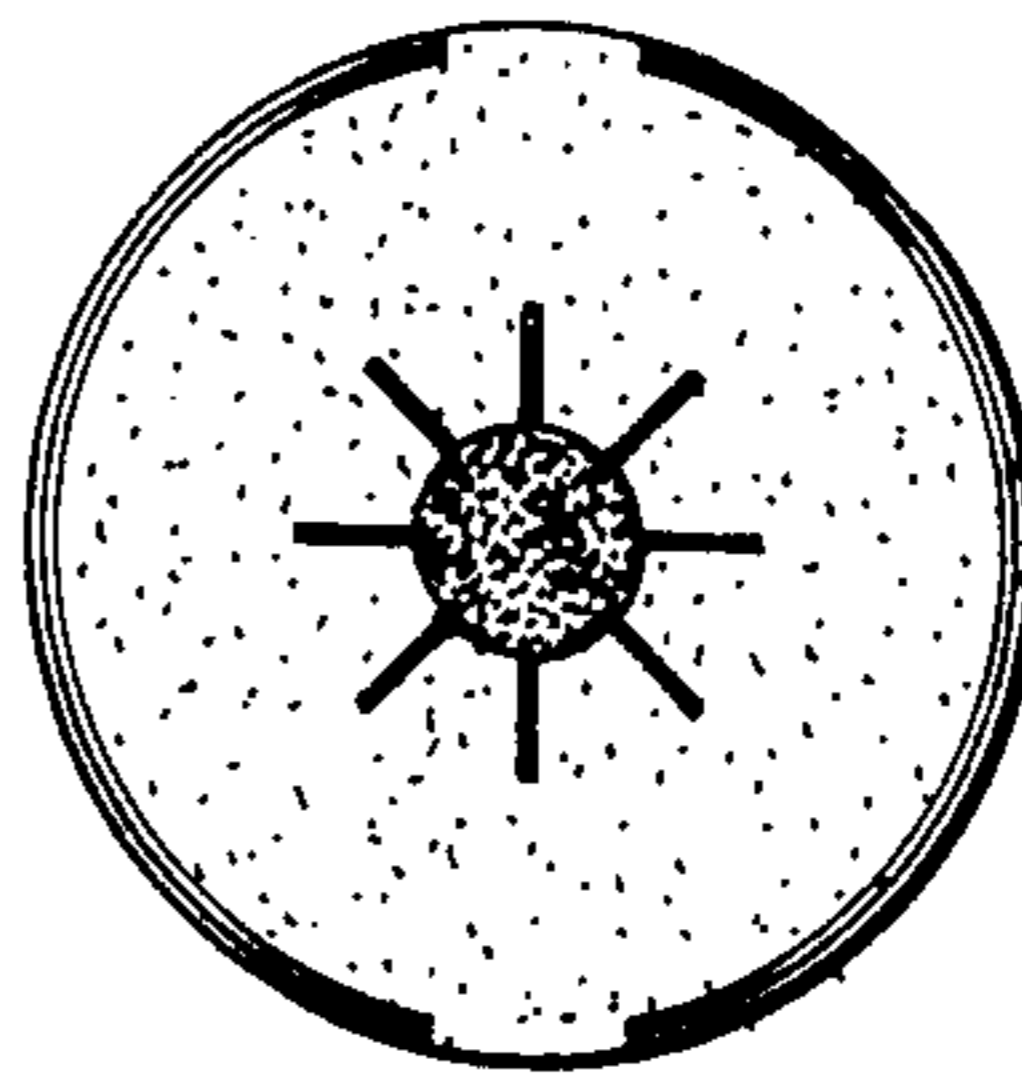

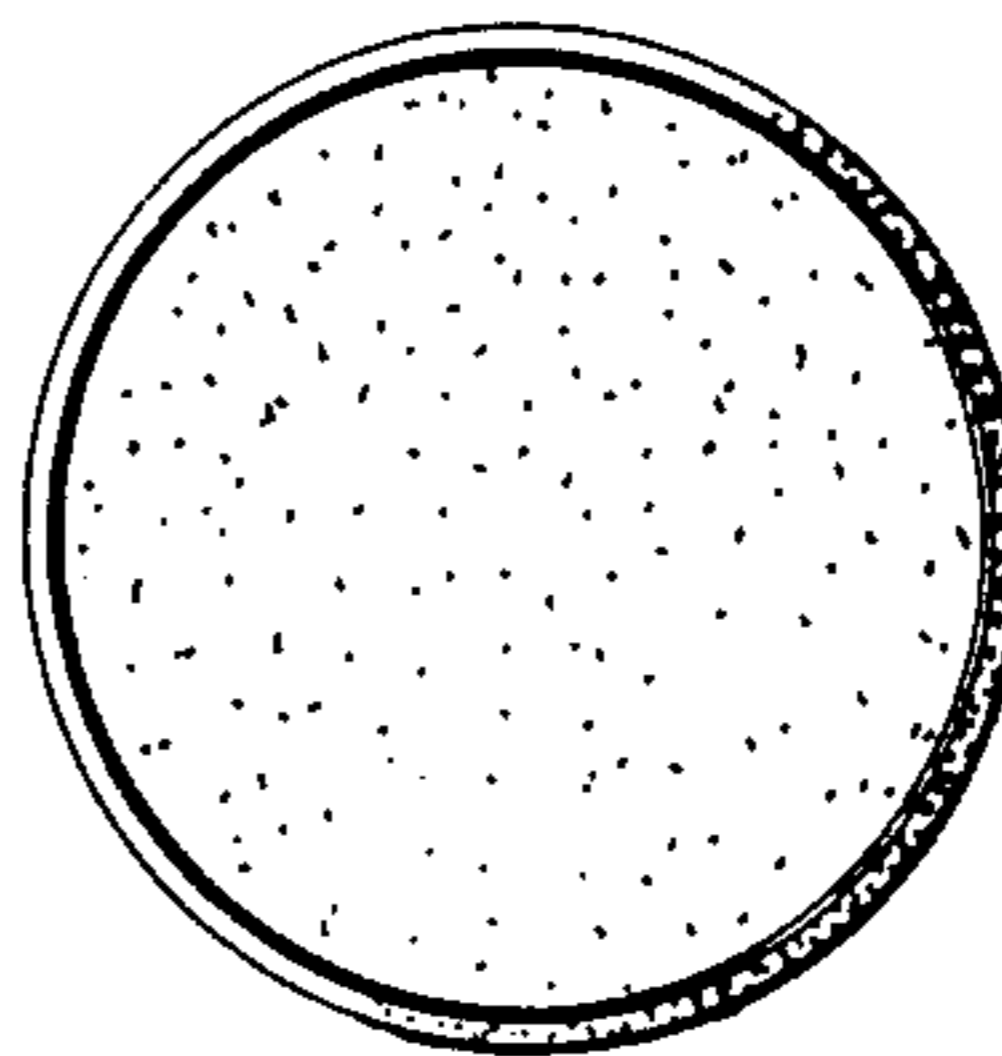

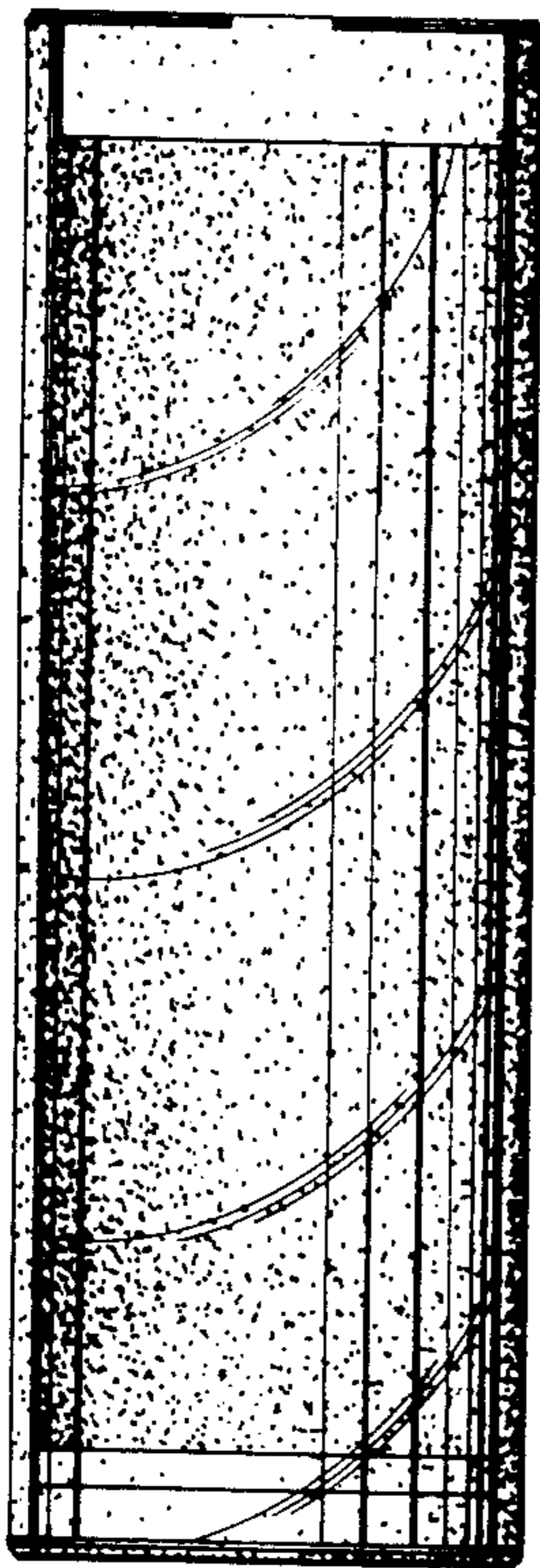

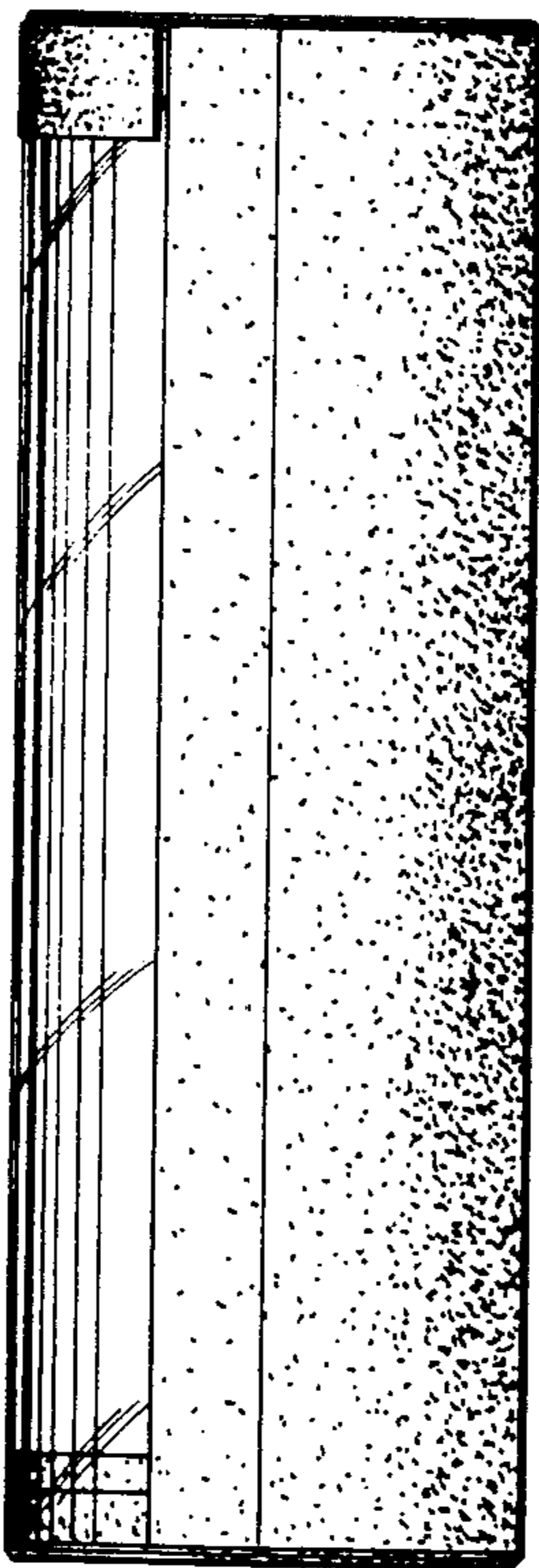

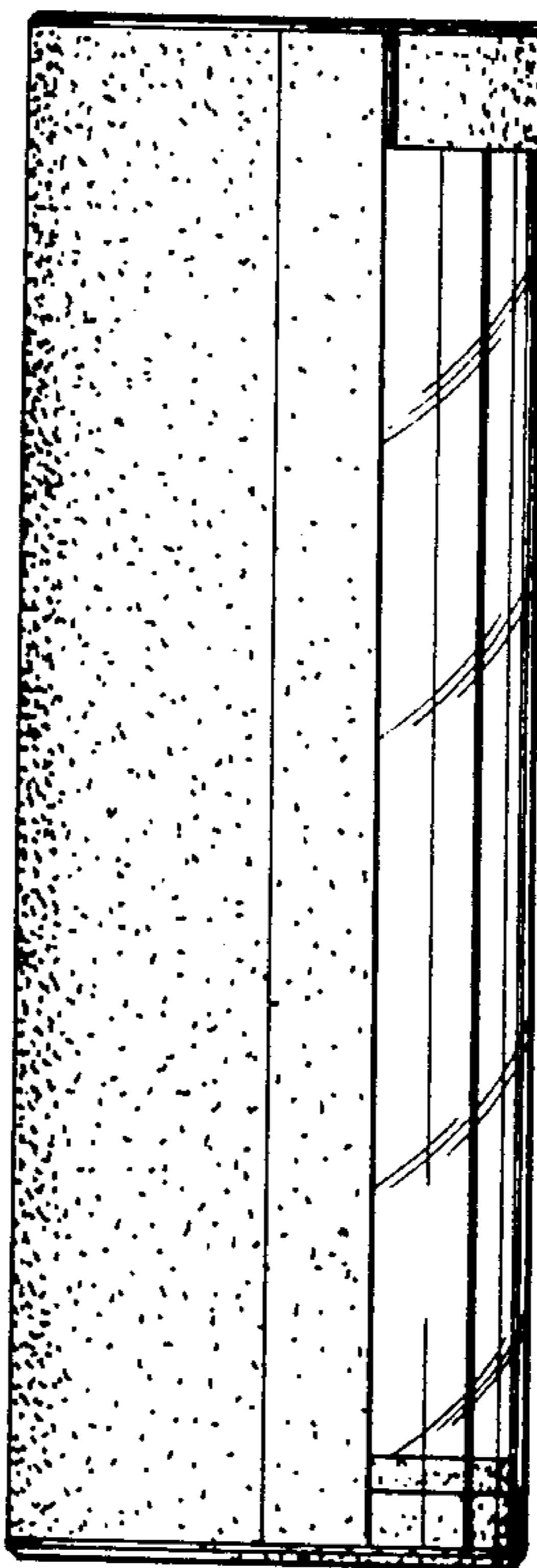

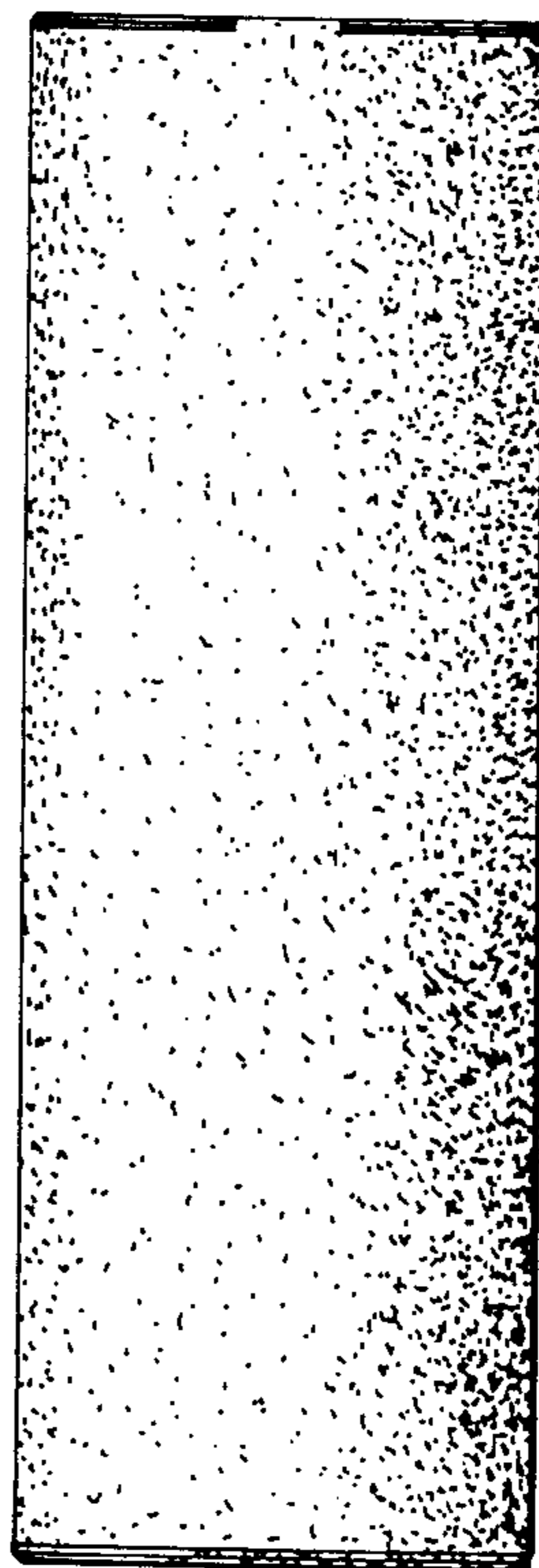
