[57] **CLAIM**

The ornamental design for an automobile wheel, substantially as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of the automobile wheel showing my new design;
 FIG. 2 is an end elevation view thereof;
 FIG. 3 is a side elevation view thereof taken from the side opposite to that of FIG. 1; and
 FIG. 4 is an enlarged cross sectional view thereof taken along the line 4-4 in FIG. 1
 FIG. 5 is a side elevation view of the automobile wheel showing a second embodiment of my new design;
 FIG. 6 is an end elevation view of FIG. 5;
 FIG. 7 is a side elevation view of the side opposite to that shown in FIG. 5; and
 FIG. 8 is an enlarged cross sectional view taken along the line 8-8 in FIG. 5.

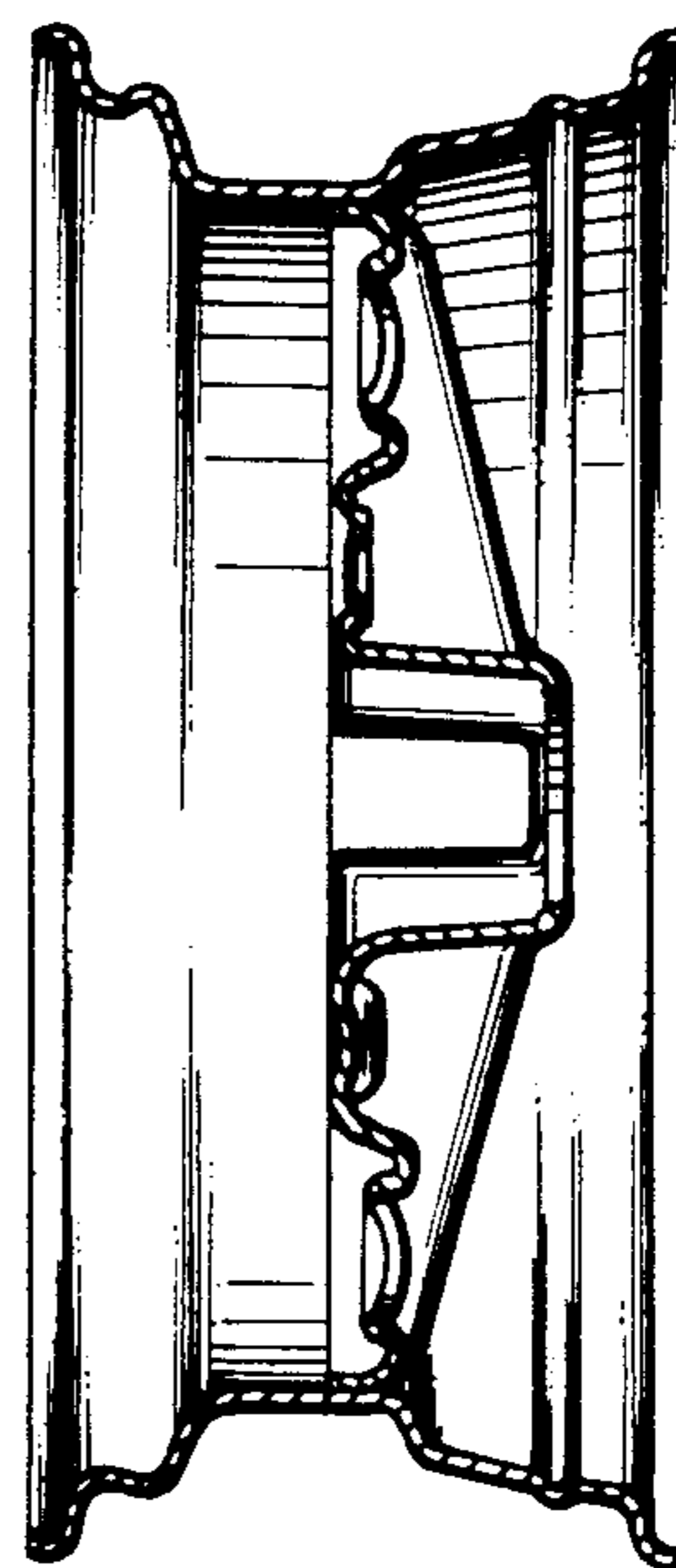
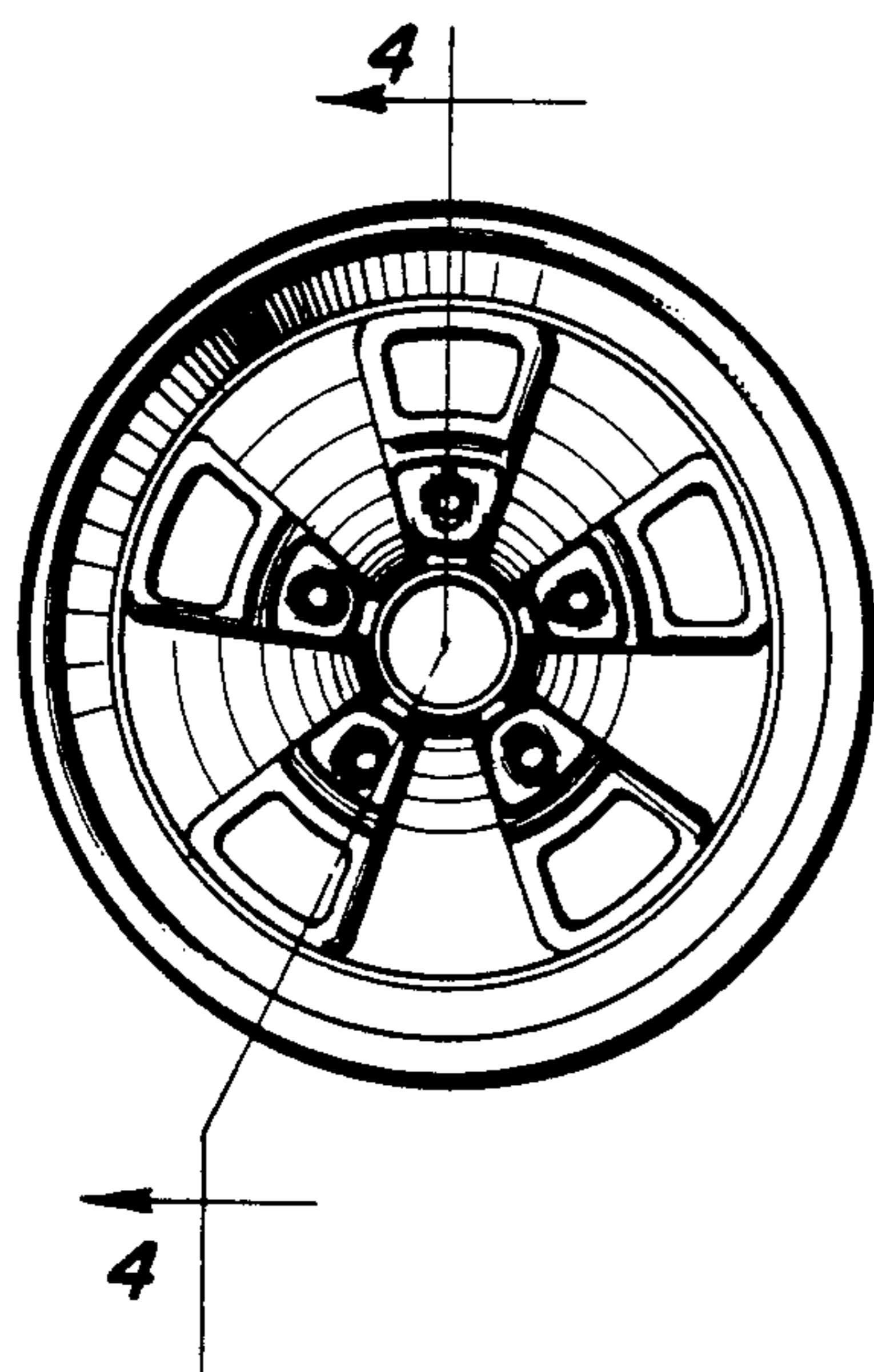

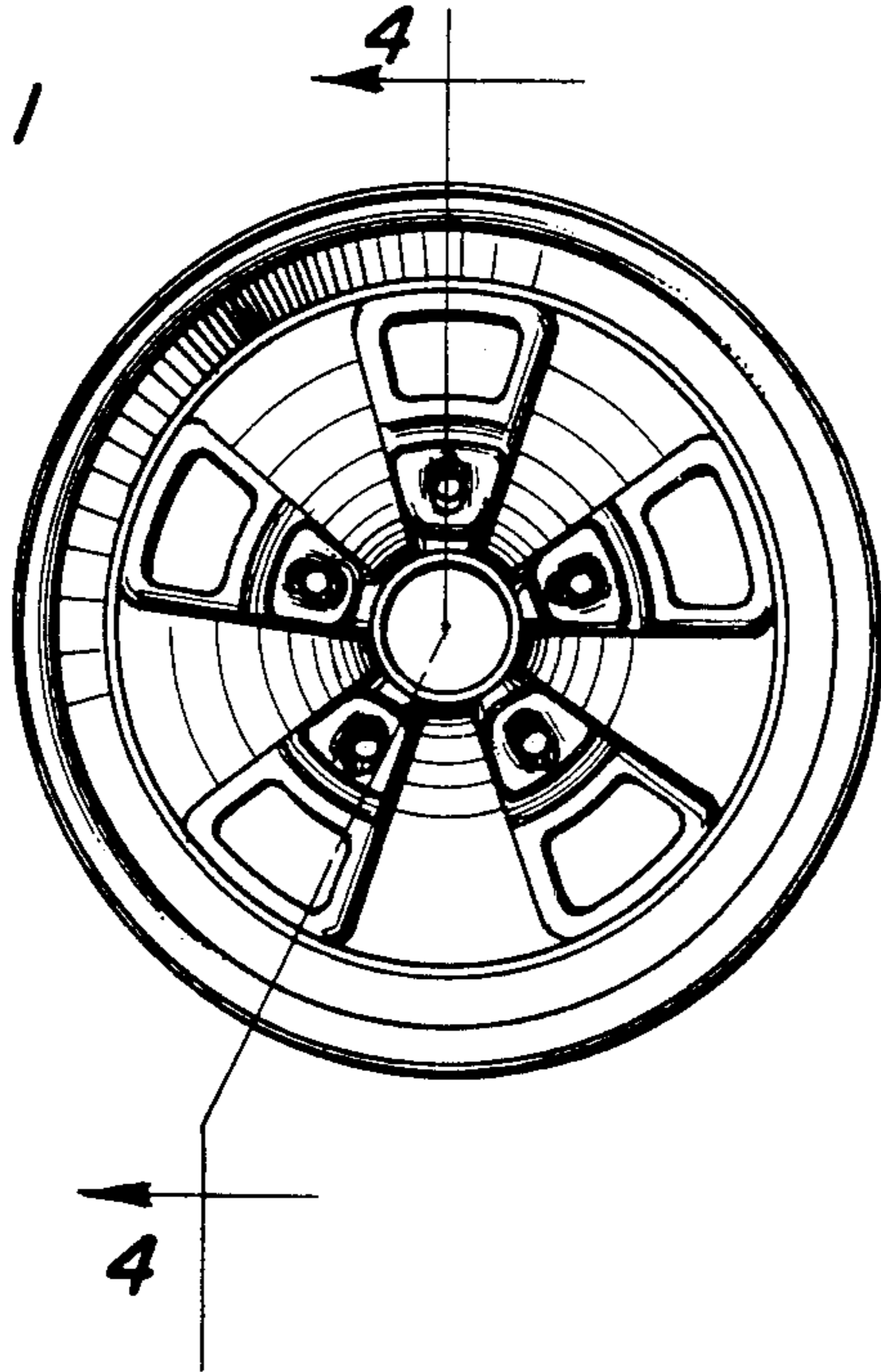

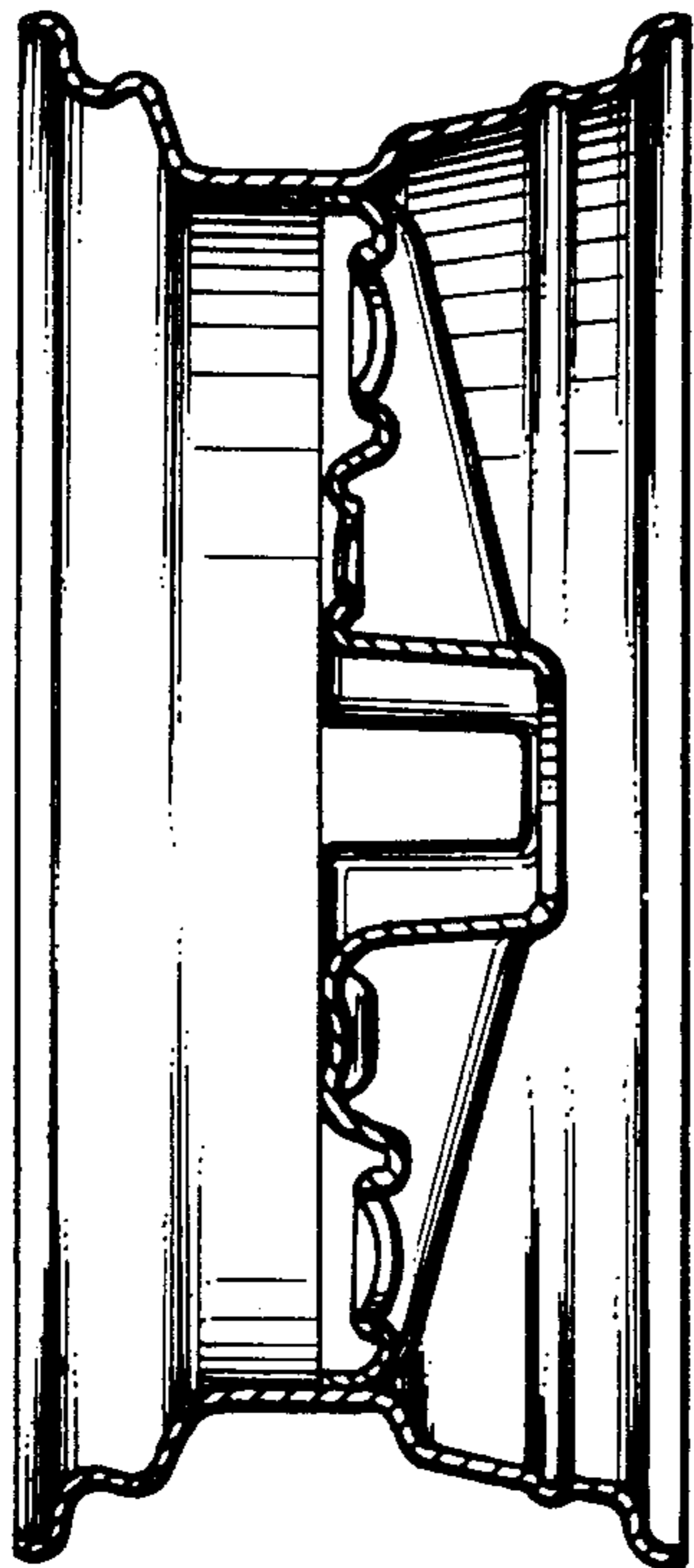
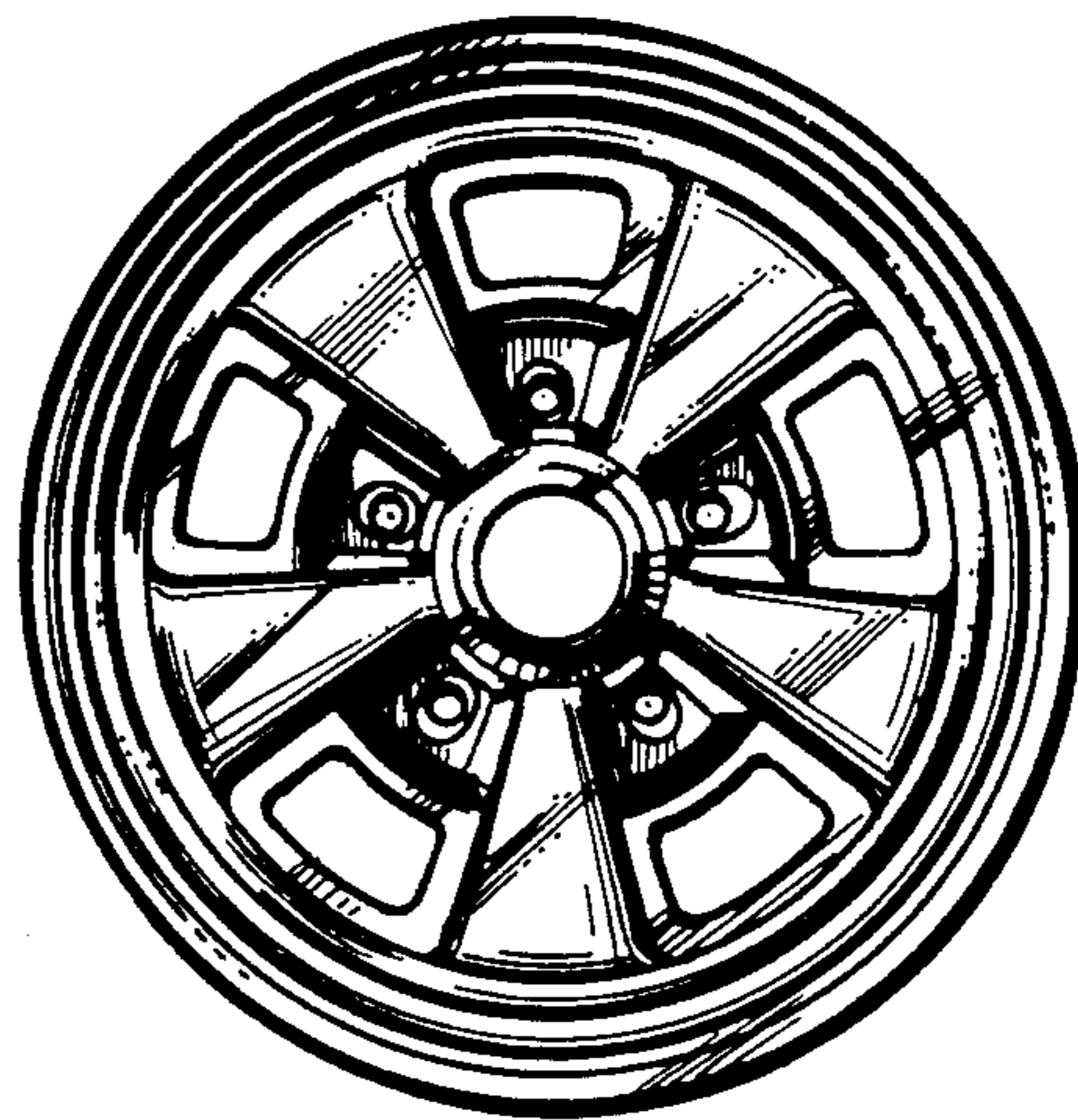

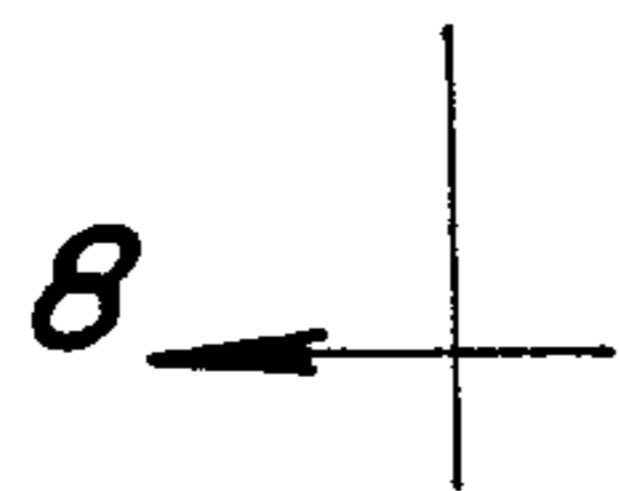
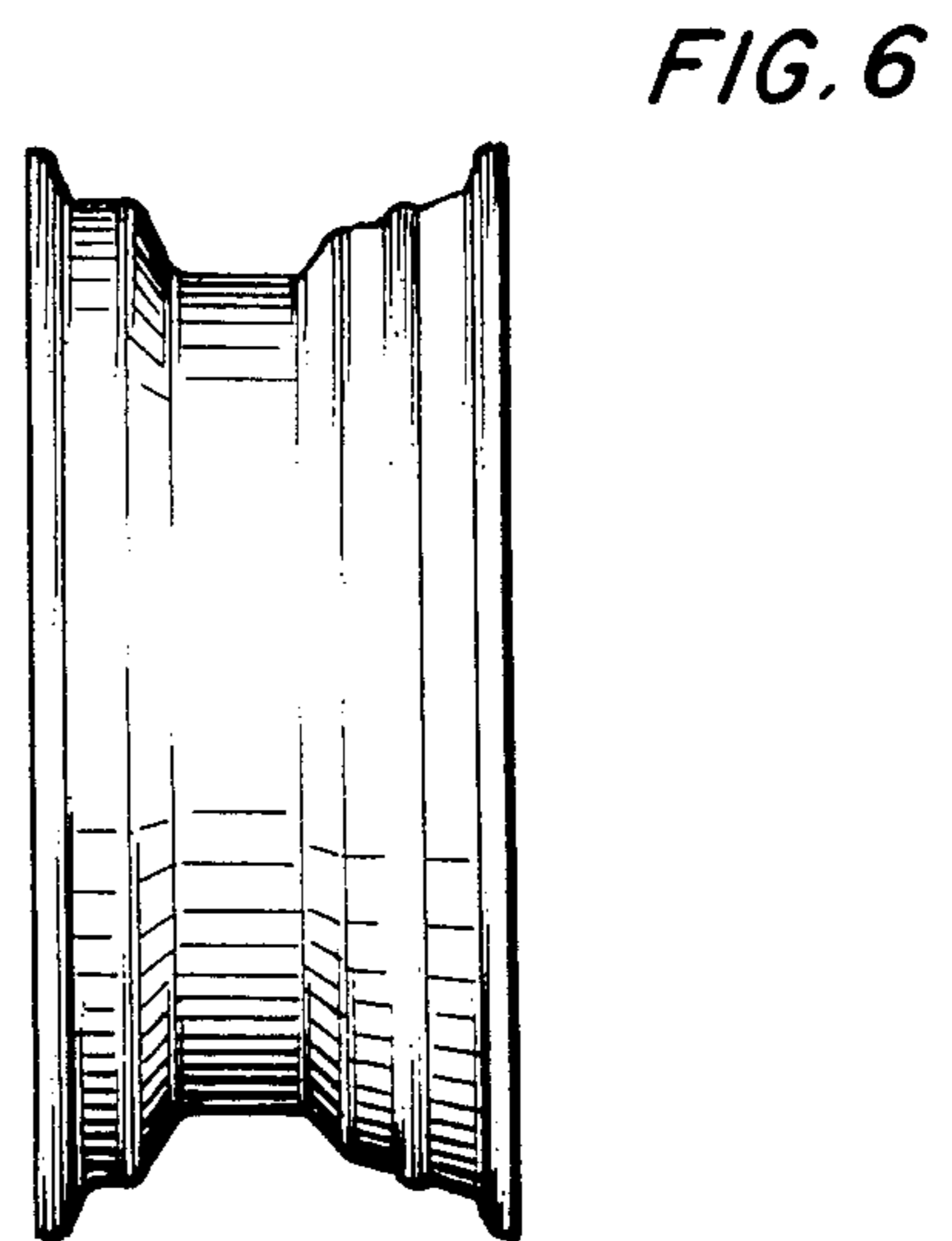
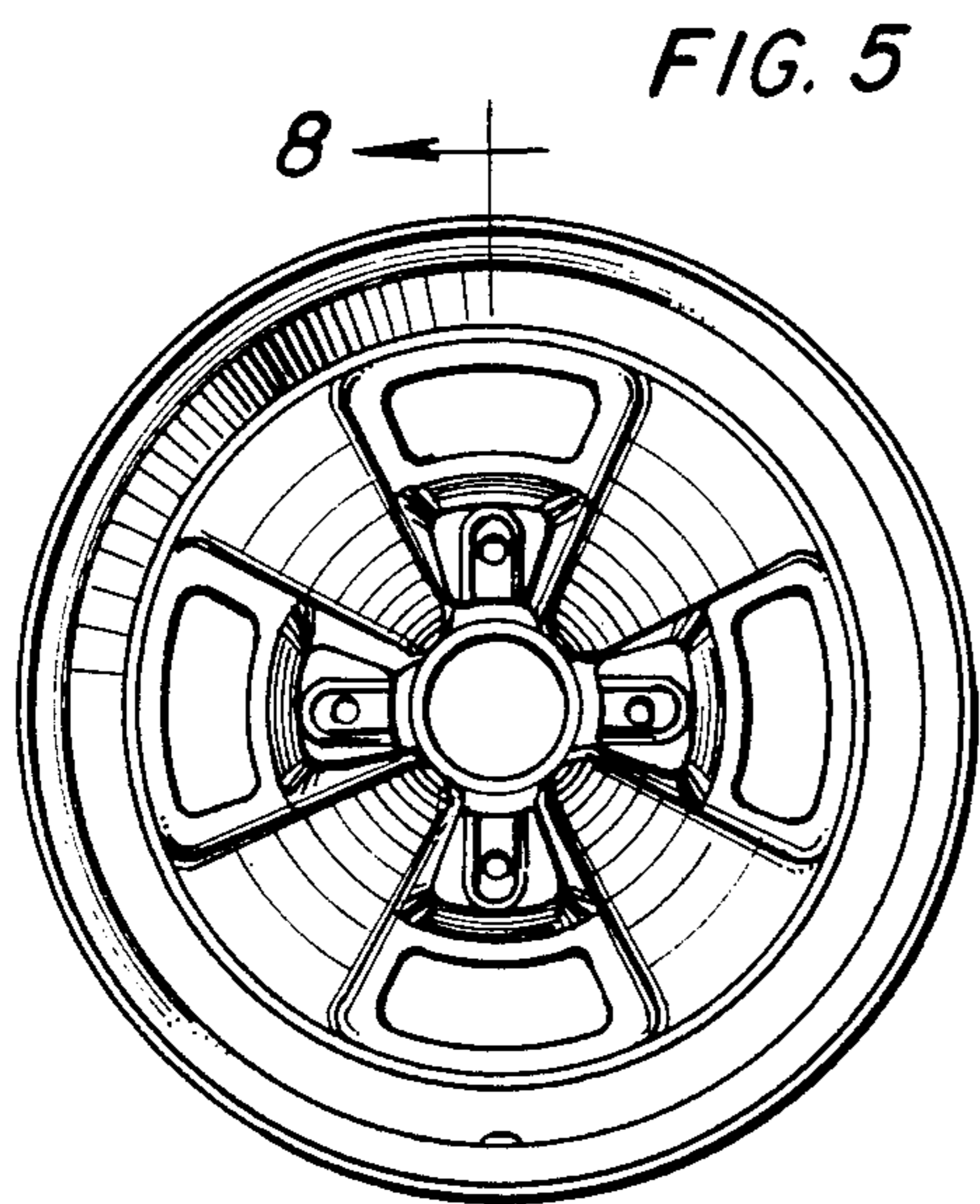

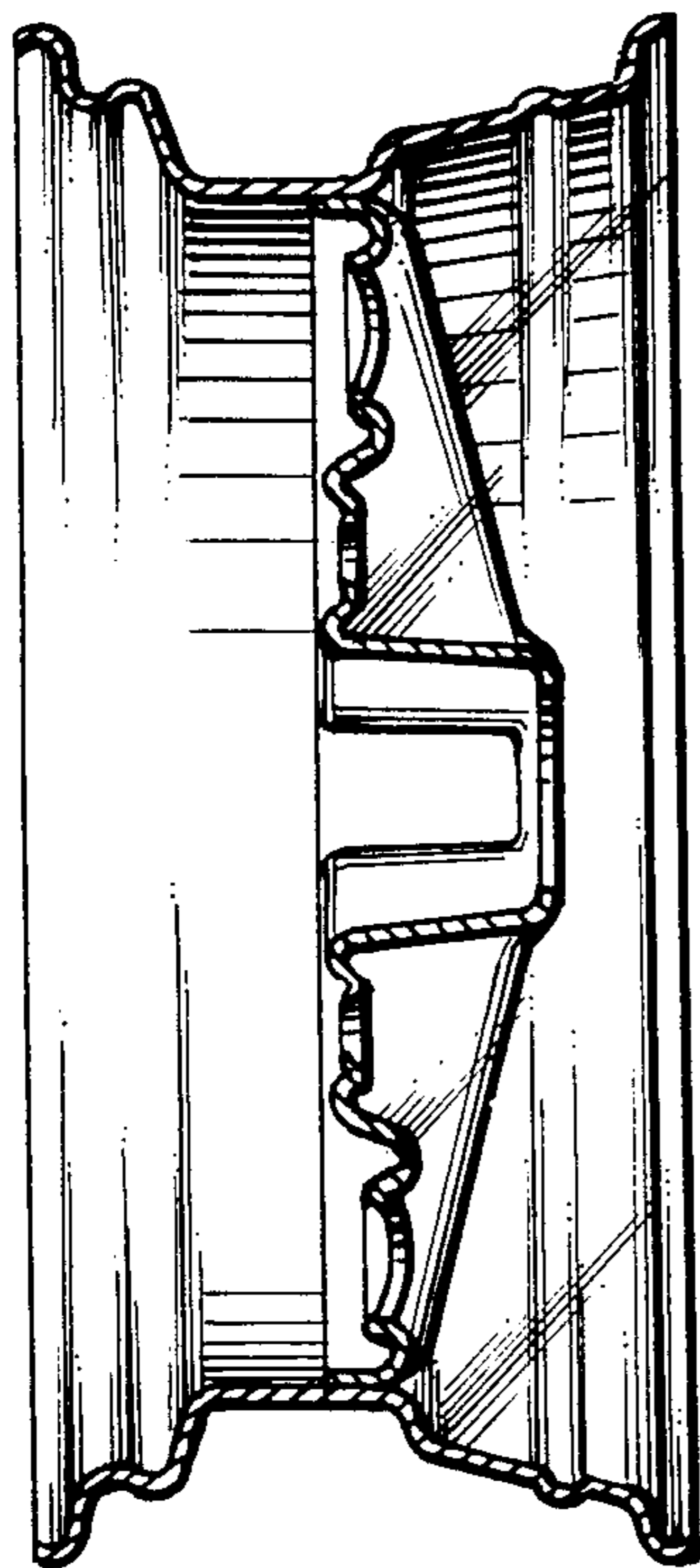
