[57] CLAIM

The ornamental design for a support stand for a portable calculator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of the support stand for a portable calculator showing my new design;

FIG. 2 is a front elevational view of the stand of FIG. 1;

FIG. 3 is a back elevational view of the stand of FIG. 1;

FIG. 4 is a side elevational view of the stand of FIG. 1, the side opposite the side shown in FIG. 4 being a mirror image thereof;

FIG. 5 is a top plan view of the stand of FIG. 1;

FIG. 6 is a bottom plan view of the stand of FIG. 1;

FIG. 7 is a perspective view of another embodiment of the support stand for a portable calculator according to my new design;

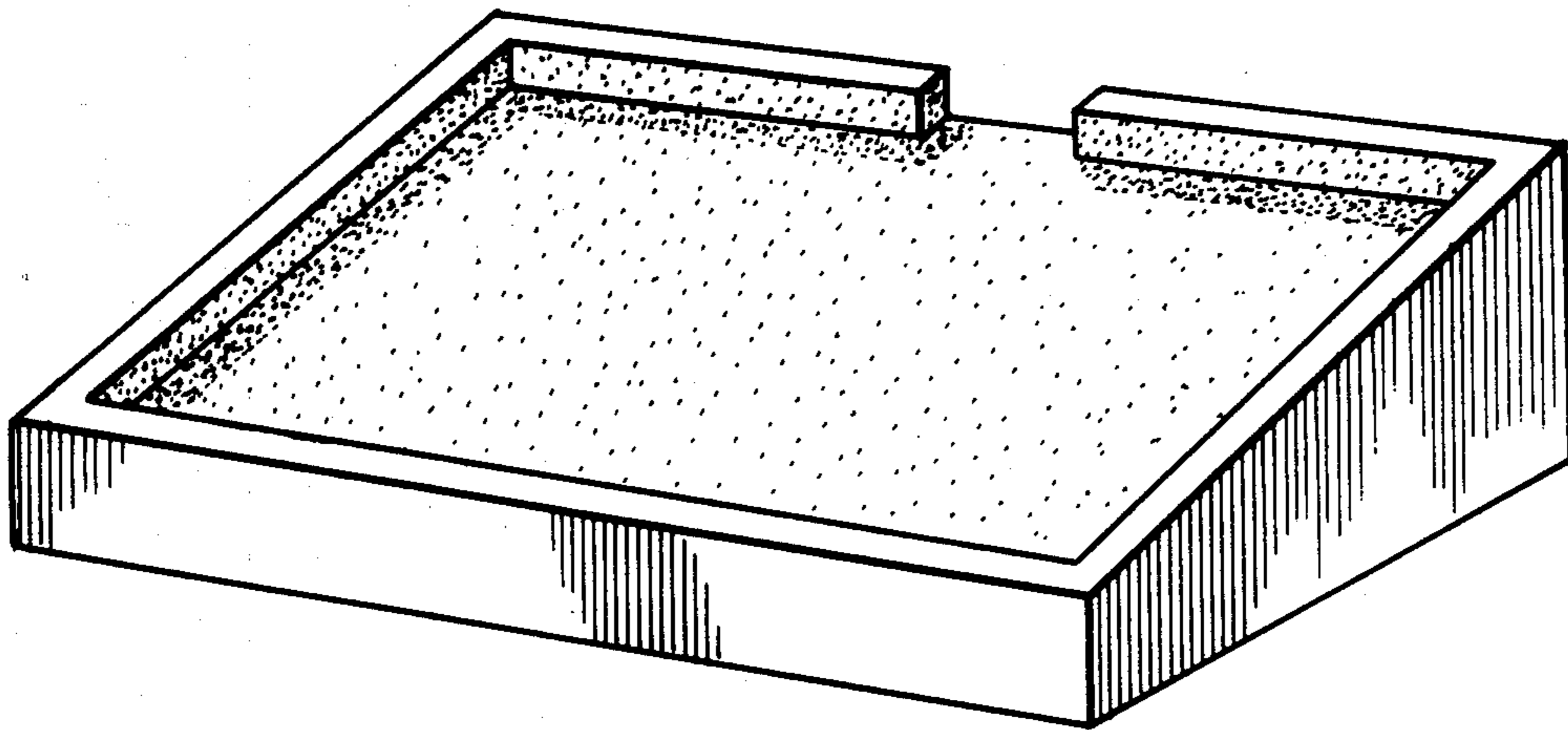
FIG. 8 is a front elevational view of the stand of FIG. 7;

FIG. 9 is a side elevational view of the stand of FIG. 7, the side opposite the side shown in FIG. 9 being the mirror image thereof;

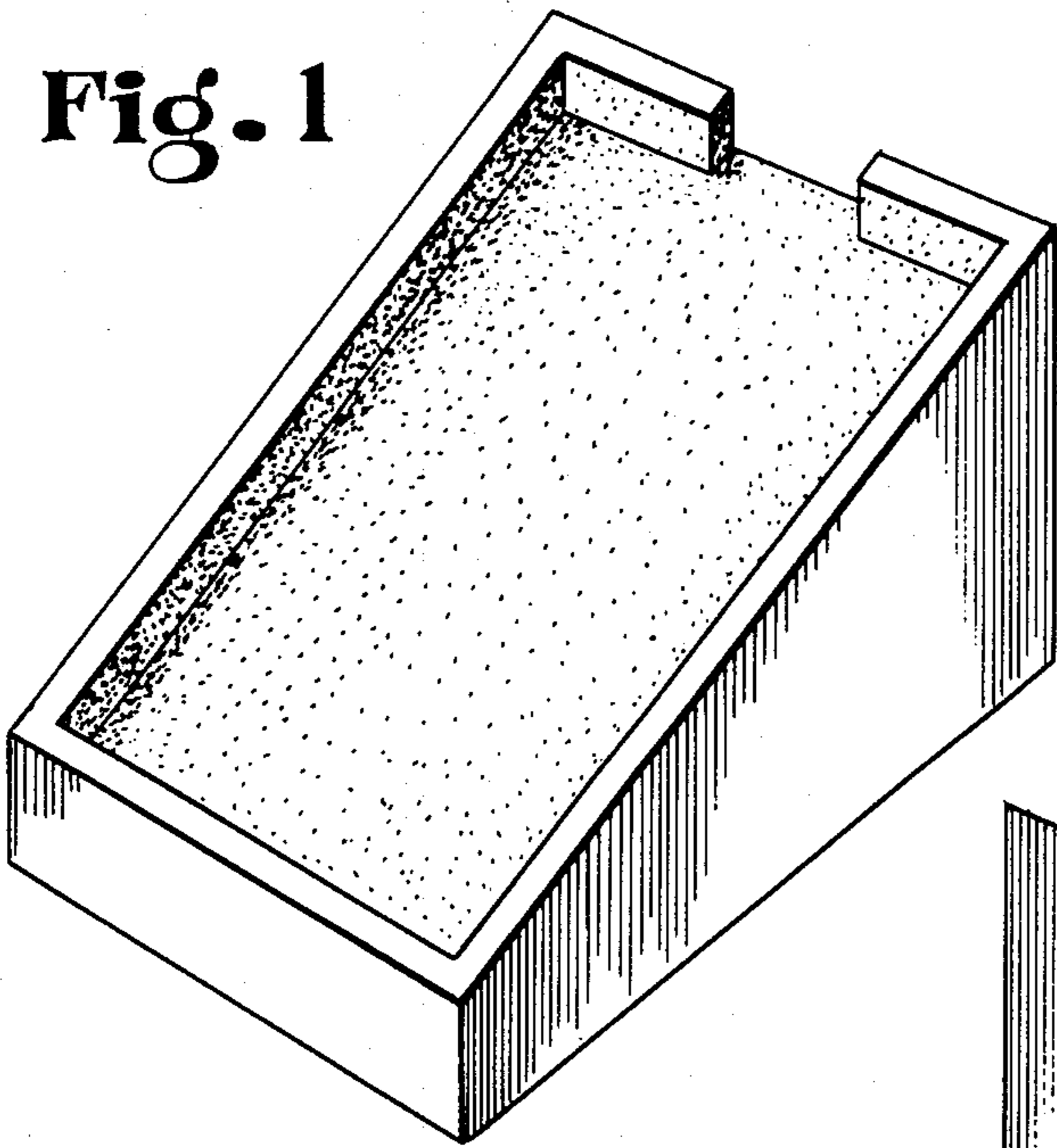
FIG. 10 is a back elevational view of the stand of FIG. 7;

FIG. 11 is a top plan view of the stand of FIG. 7; and

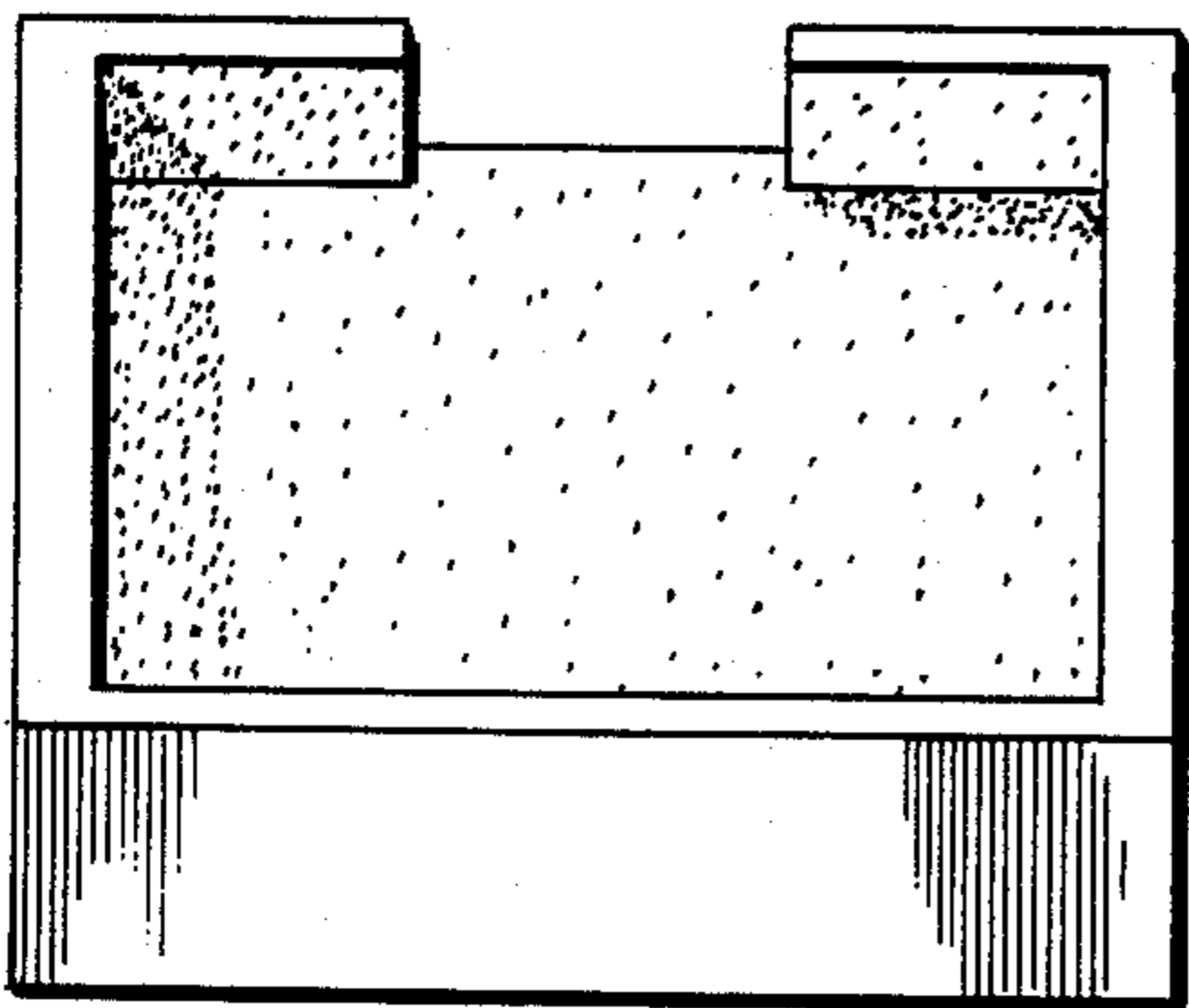
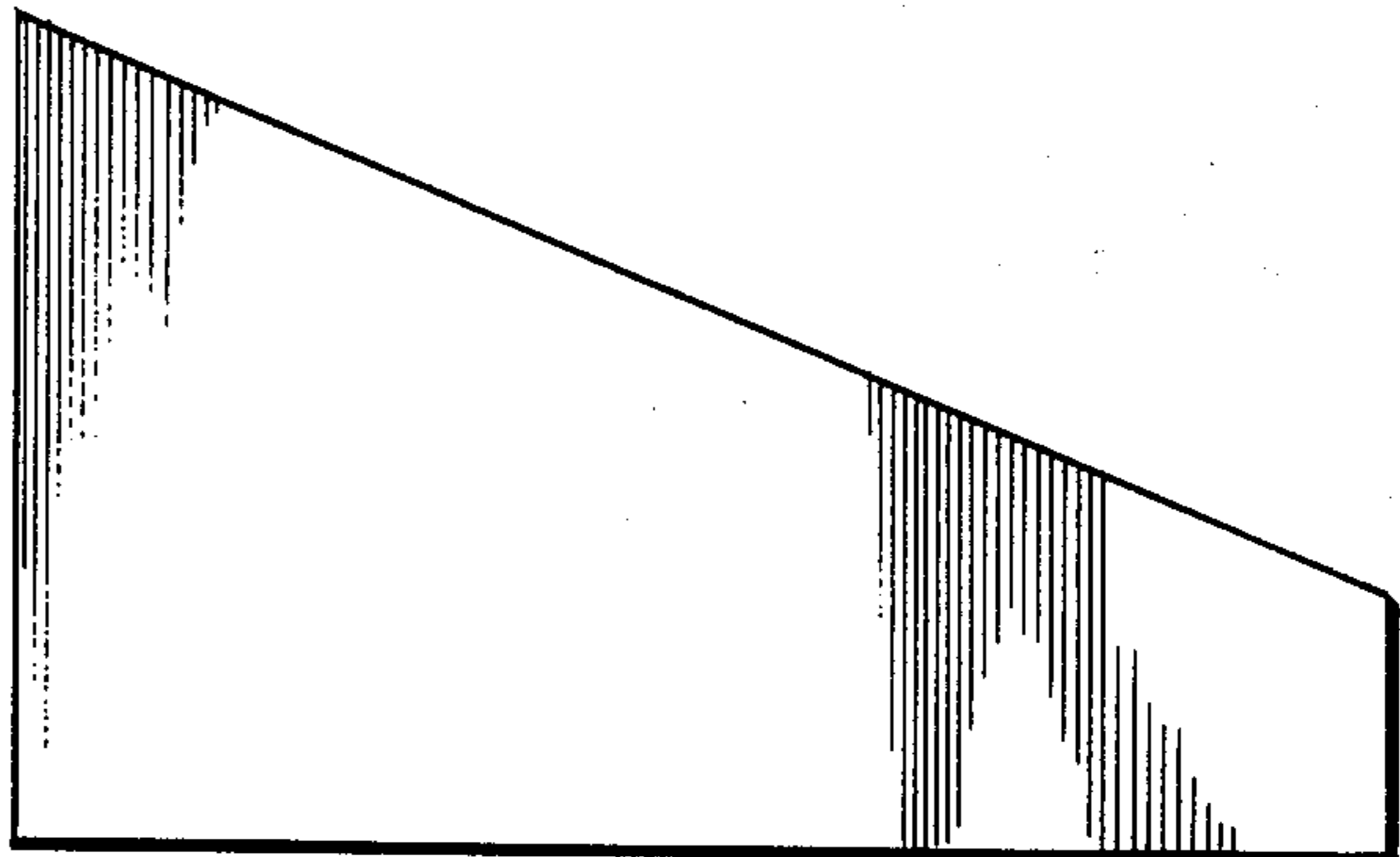
FIG. 12 is a bottom plan view of the stand of FIG. 7.



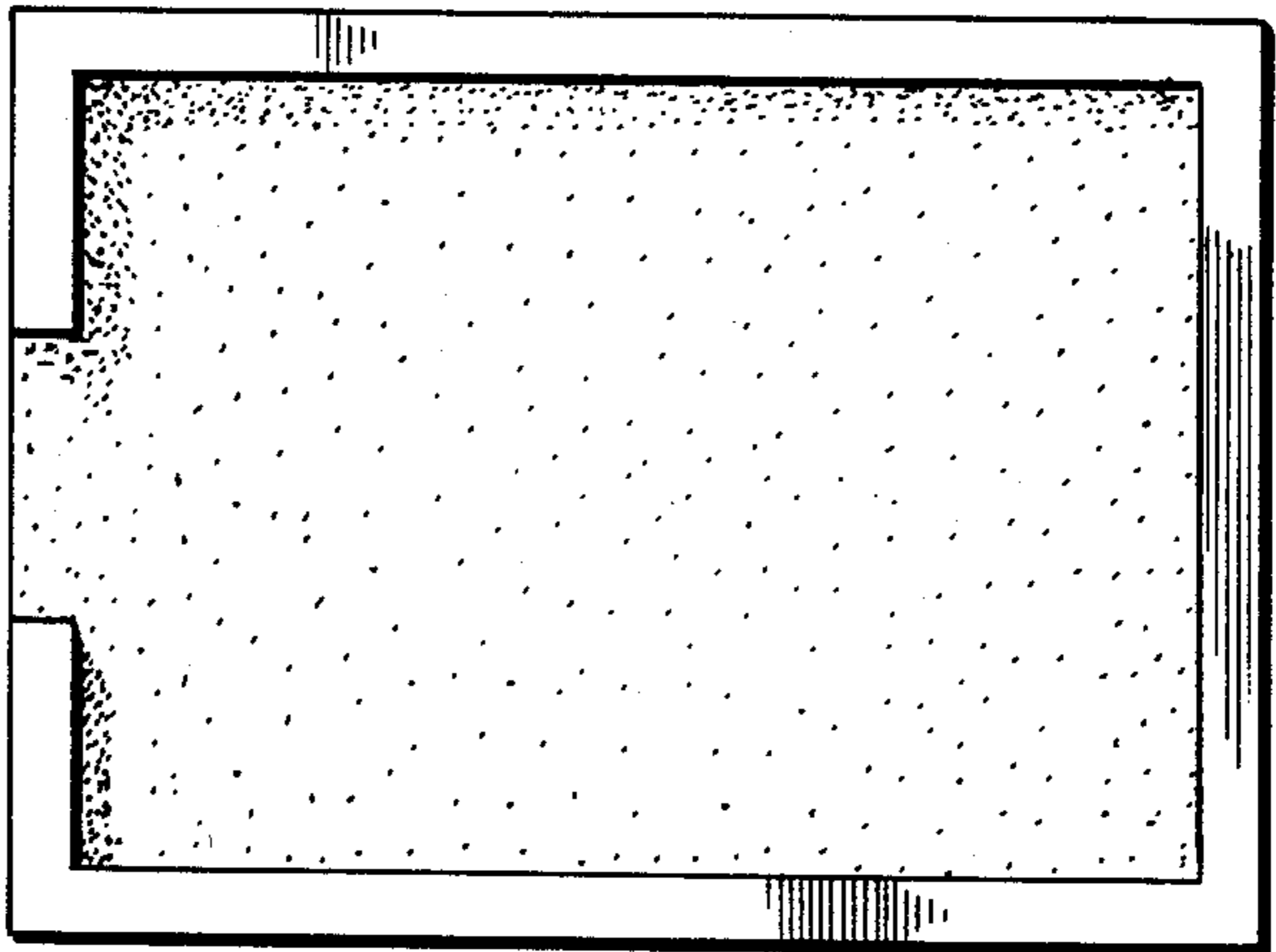

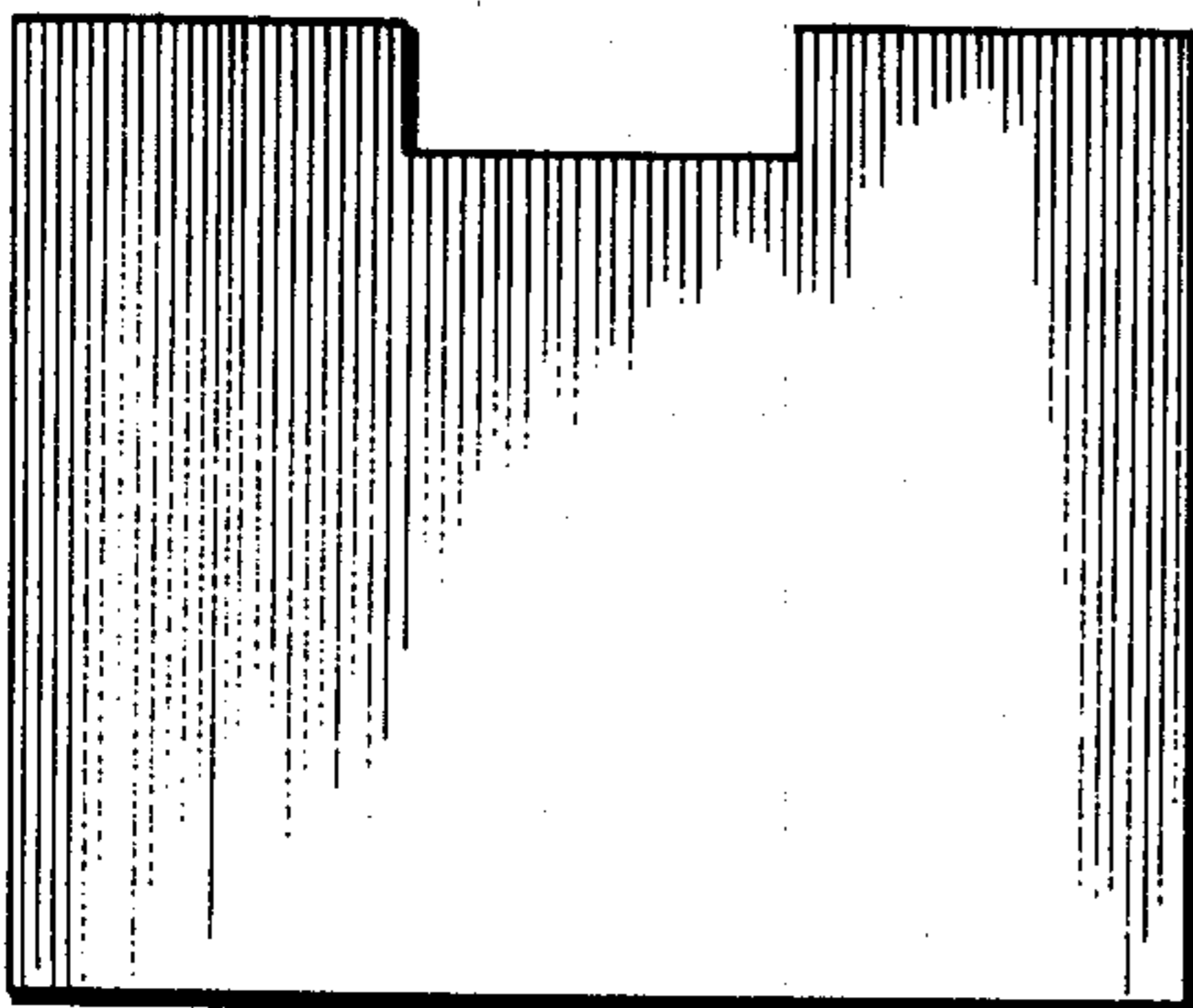

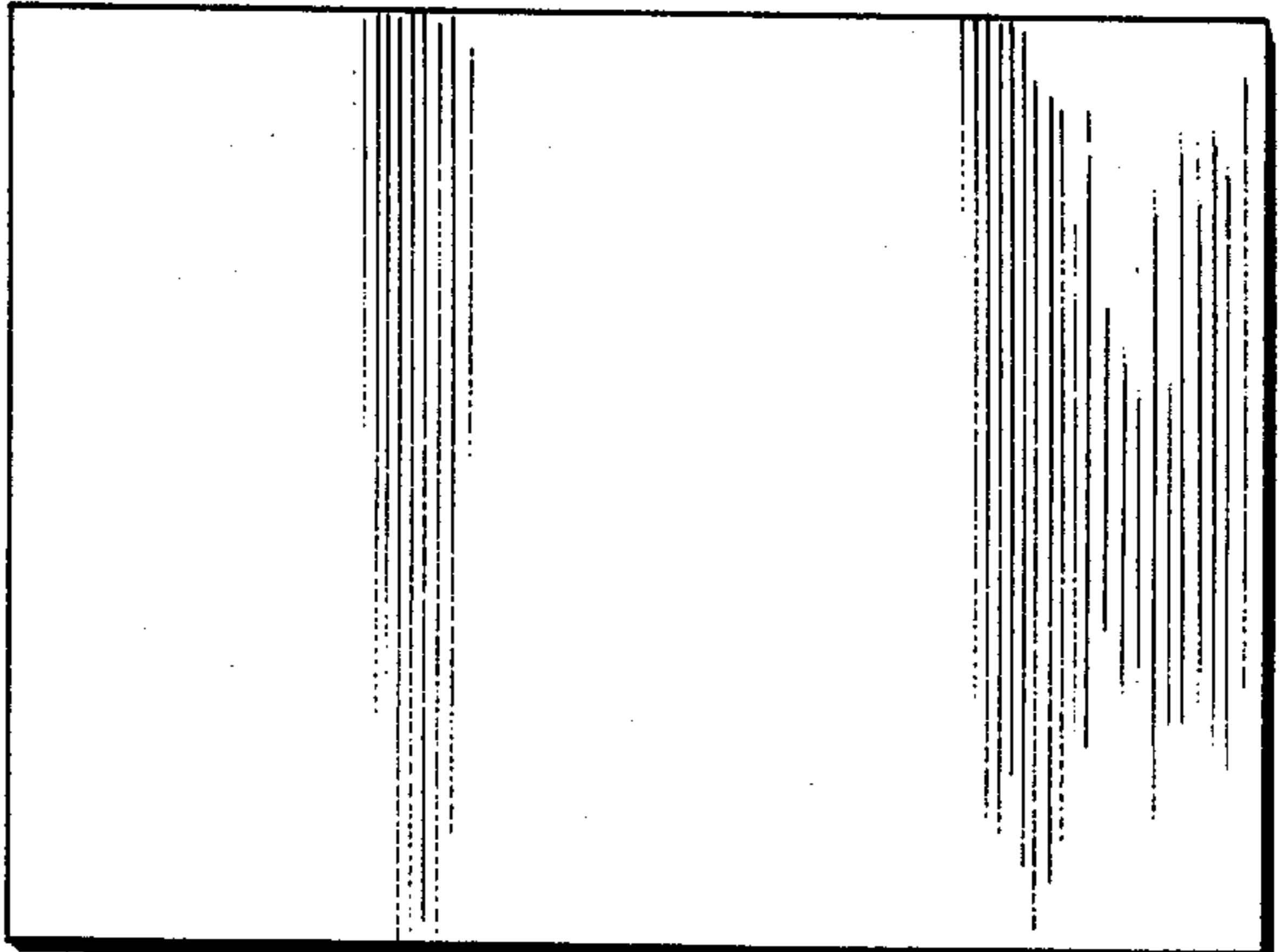

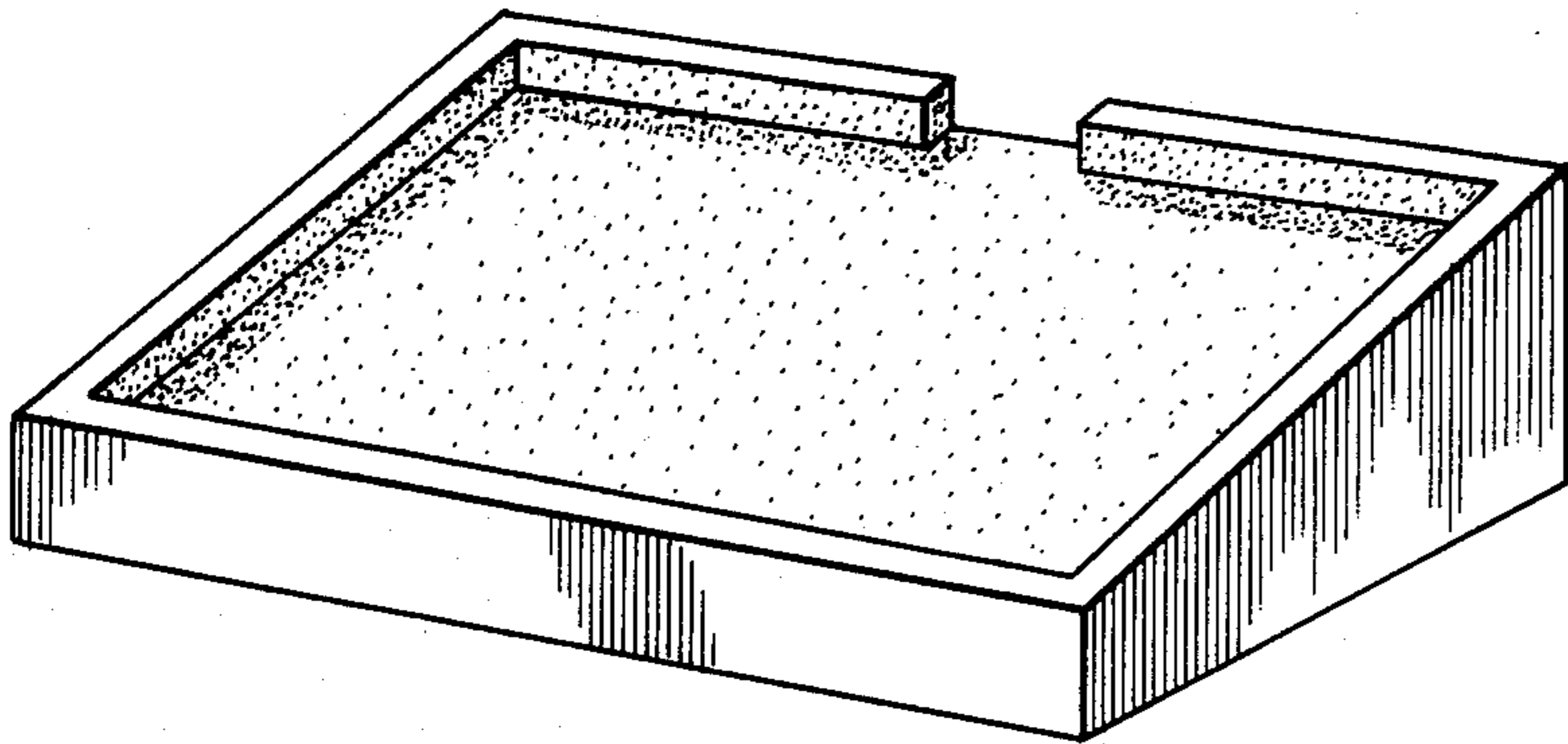

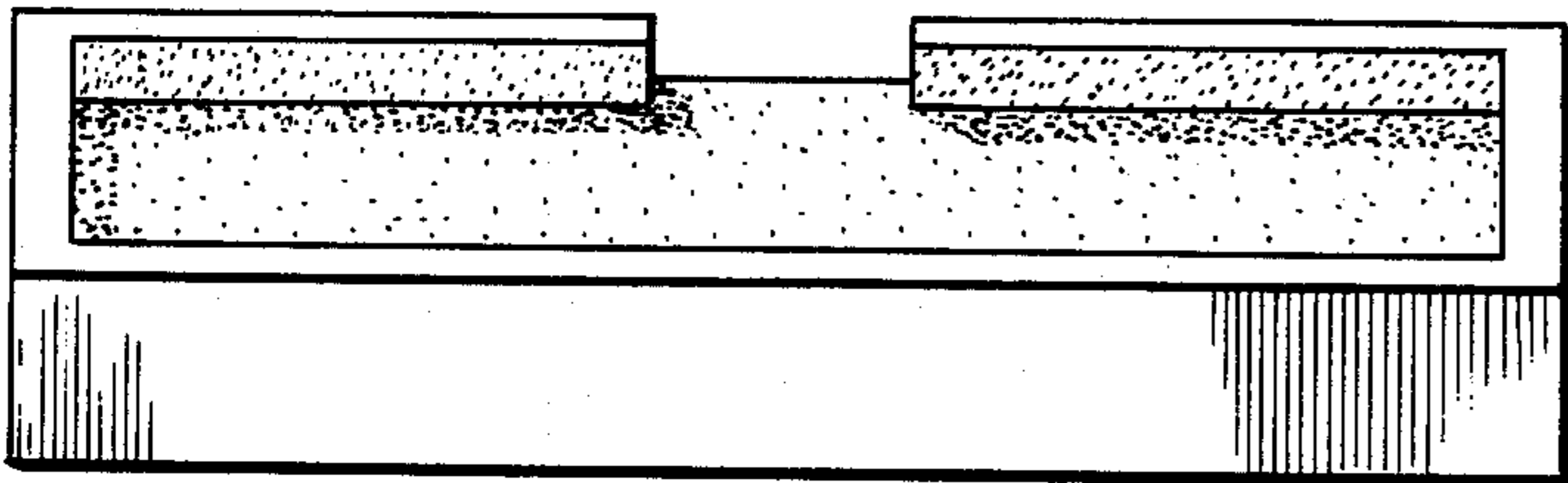

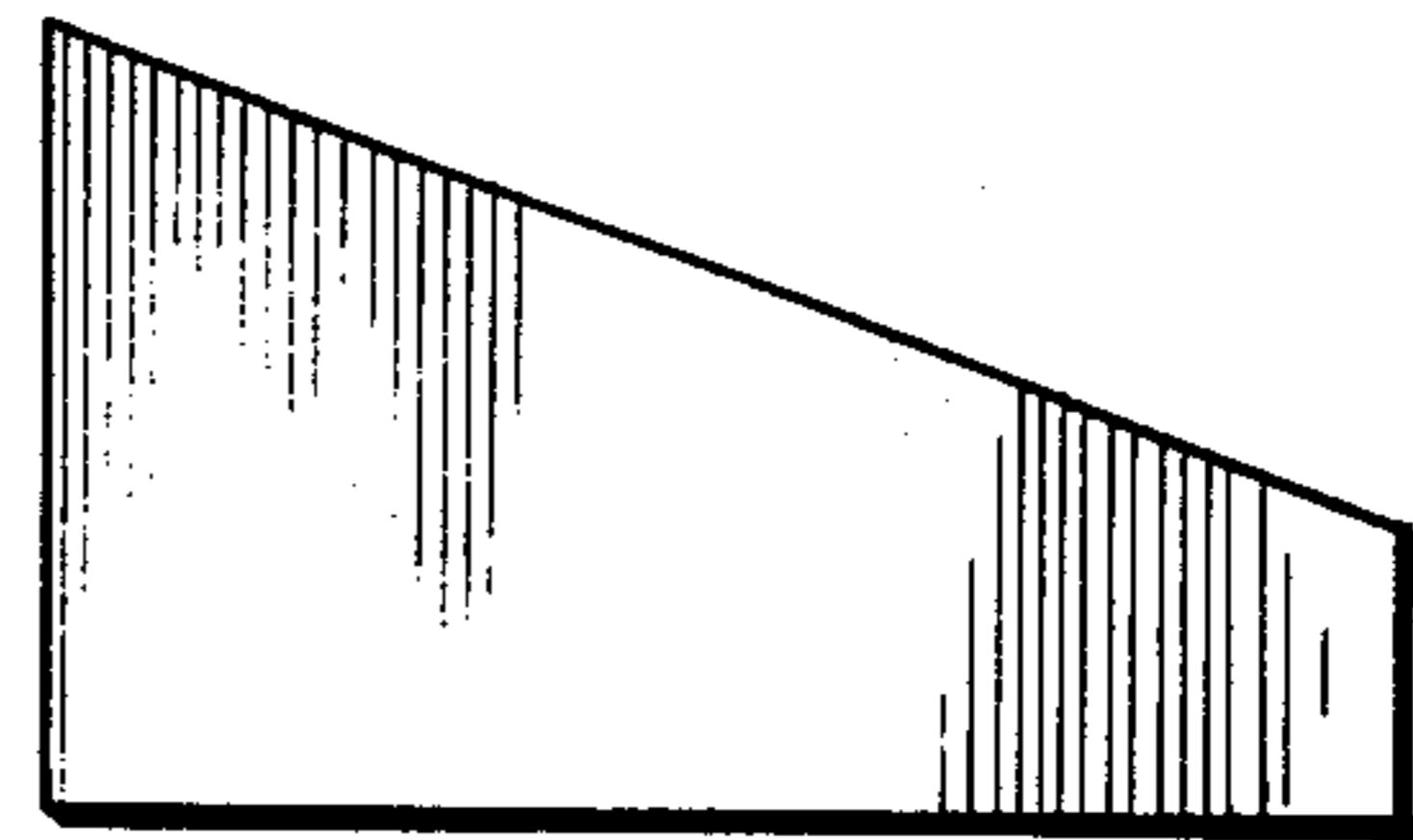

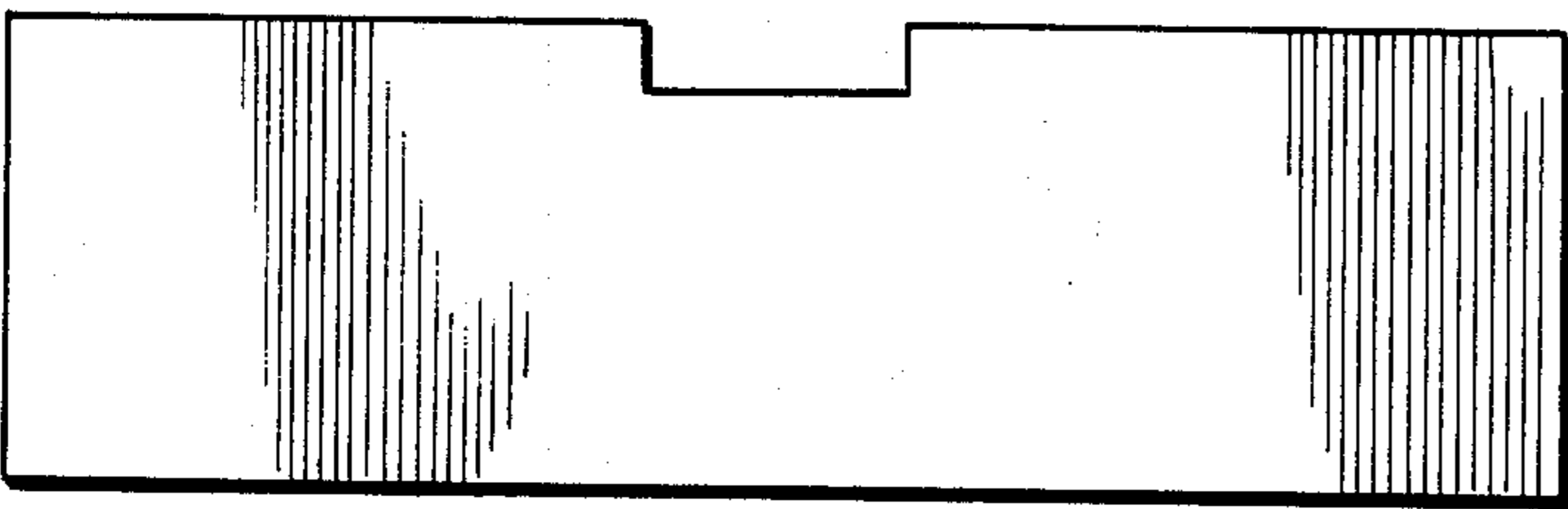

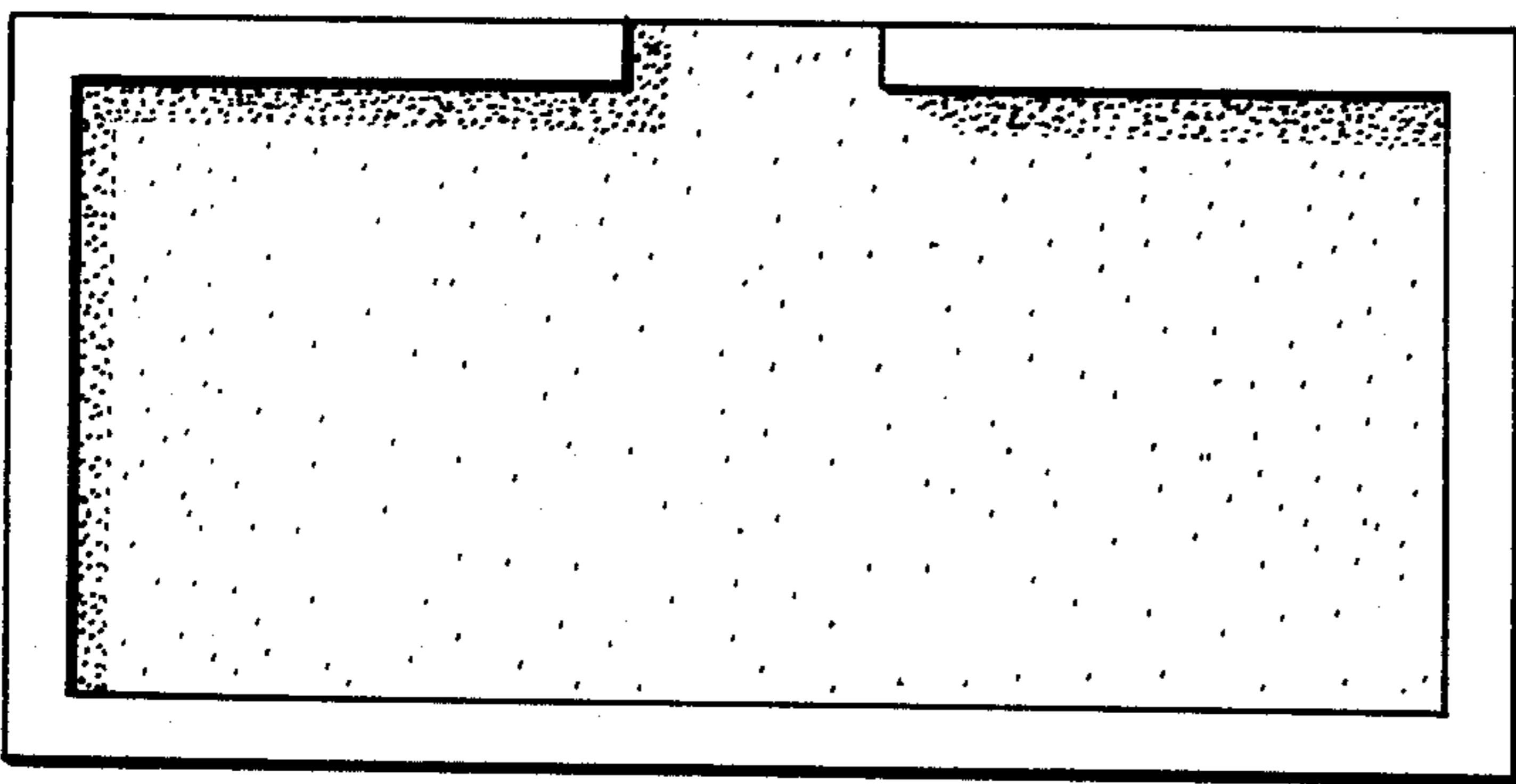

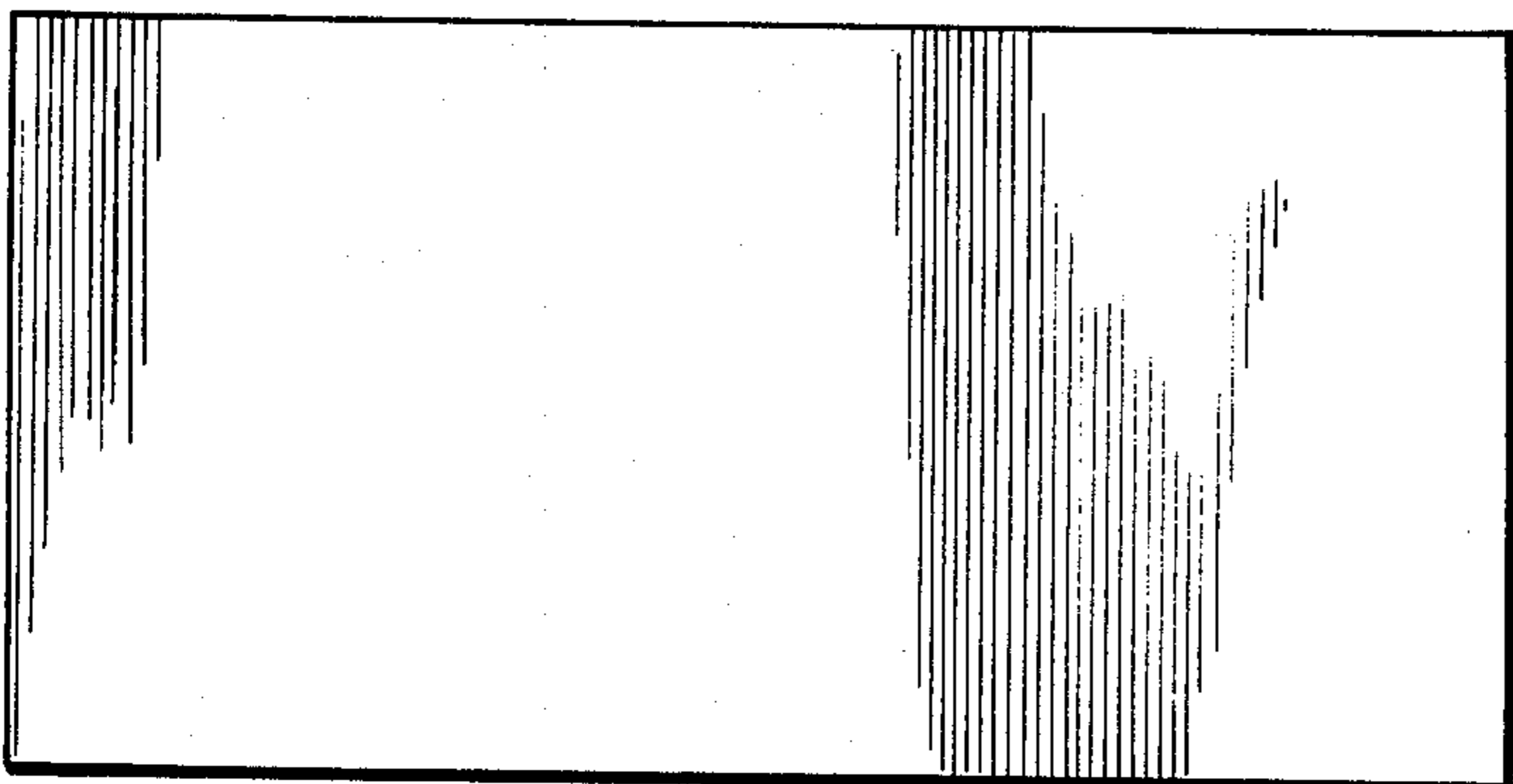
