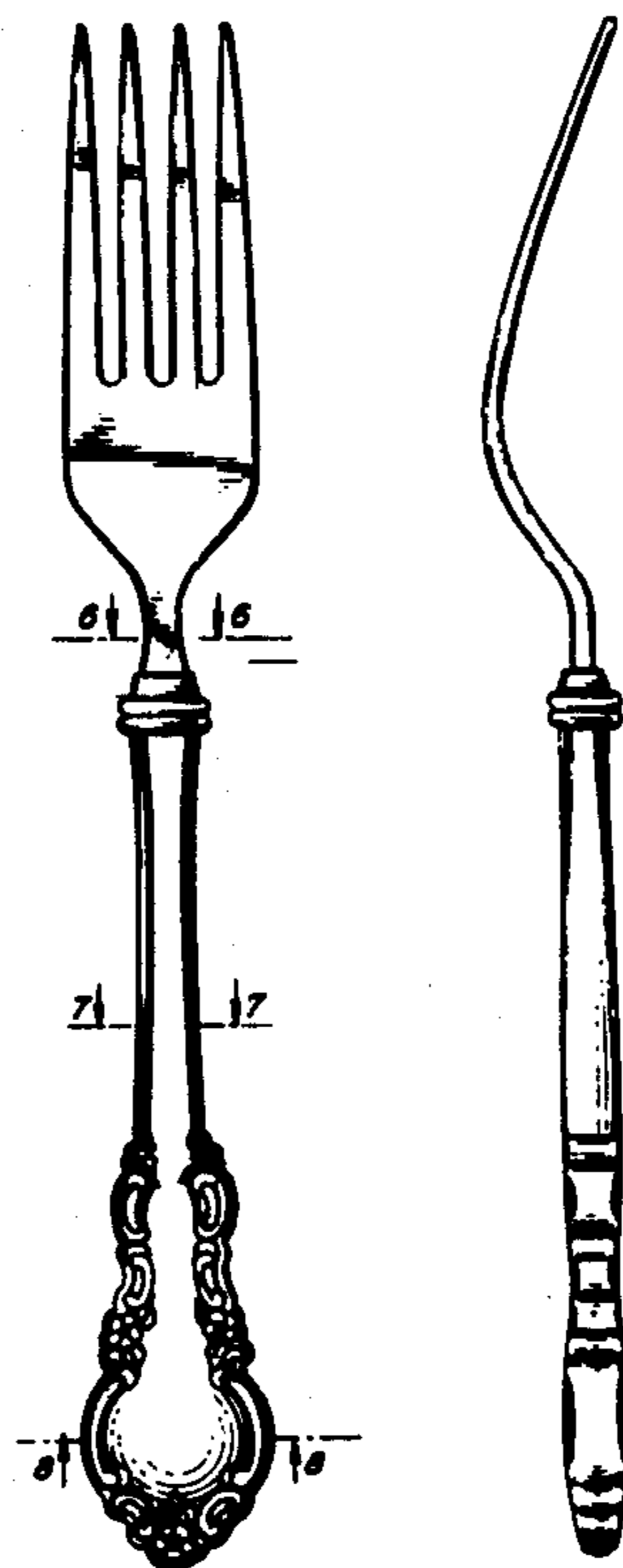

[57] CLAIM

The ornamental design for an article of flatware, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an article of flatware showing my new design as embodied in a fork; FIG. 2 is a side elevational view from the left of FIG. 1; FIG. 3 is a rear elevational view of FIG. 1; FIG. 4 is an end view from the top of FIG. 1; FIG. 5 is an end view from the bottom of FIG. 1; FIG. 6 is a cross-sectional view taken on line 6-6 of FIG. 1; FIG. 7 is a cross-sectional view on an enlarged scale taken on line 7-7 of FIG. 1; FIG. 8 is a cross-sectional view taken on line 8-8 of FIG. 1; FIG. 9 is a front elevational view of an article of flatware showing my new design as embodied in a knife; FIG. 10 is a side elevational view from the right of FIG. 9; FIG. 11 is an end view from the bottom of FIG. 9; FIG. 12 is an end view from the top of FIG. 9; FIG. 13 is a front elevational view of an article of flatware showing my new design as embodied in a spoon; FIG. 14 is a side elevational view from the left of FIG. 13; FIG. 15 is a rear elevational view of FIG. 13; FIG. 16 is an end view from the top of FIG. 13; FIG. 17 is an end view from the bottom of FIG. 13; FIG. 18 is a front elevational view of an article of flatware showing my new design as embodied in a gravy ladle; FIG. 19 is a side elevational view from the left of FIG. 18; FIG. 20 is a rear elevational view of FIG. 18; FIG. 21 is an end view from the top of FIG. 18; and FIG. 22 is an end view from the bottom of FIG. 18. The sides opposite the handle portions shown in FIGS. 2, 9, 10, 14 and 19 are mirror images of the respective shown sides. The distinguishing feature of my new design for an article of flatware resides in the handle configuration.



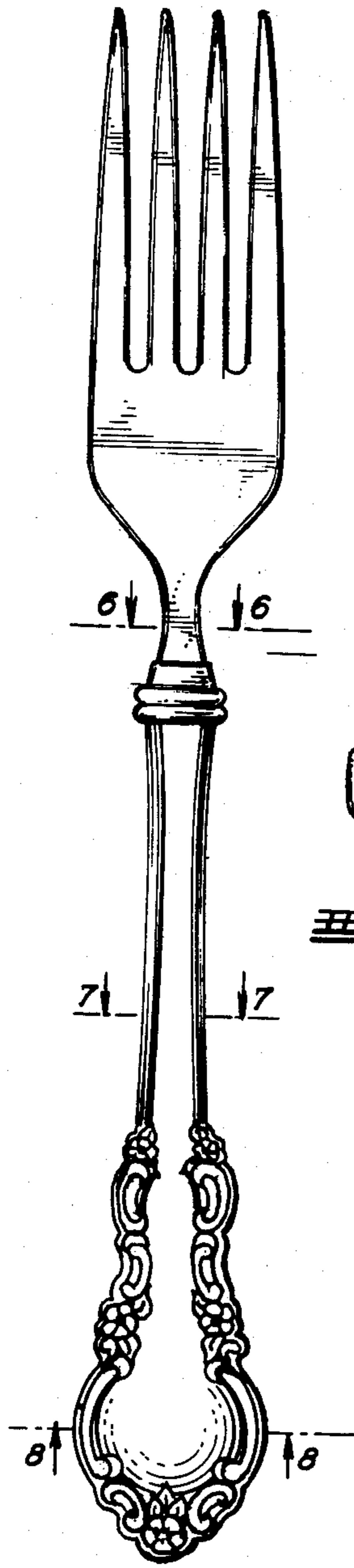

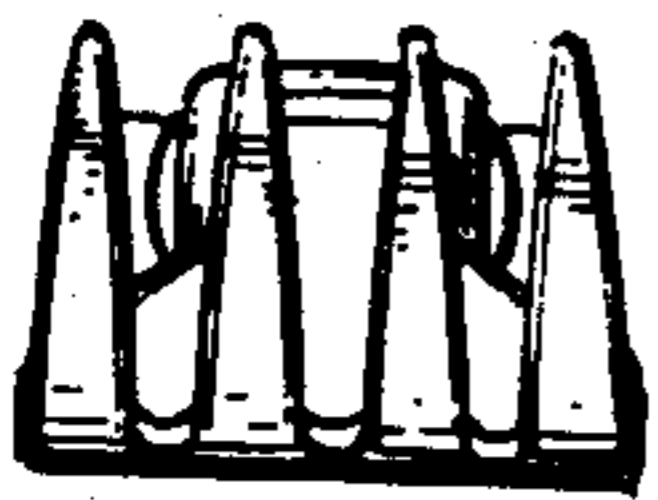

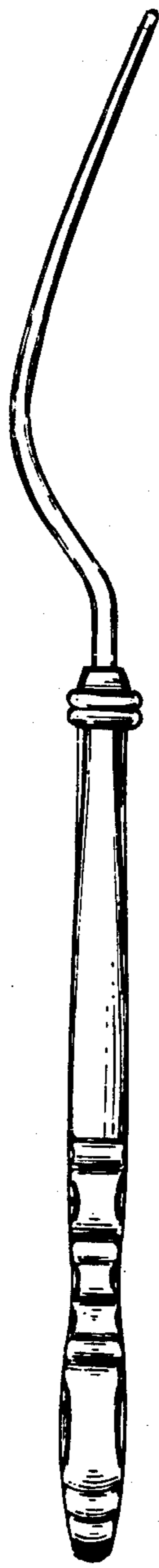

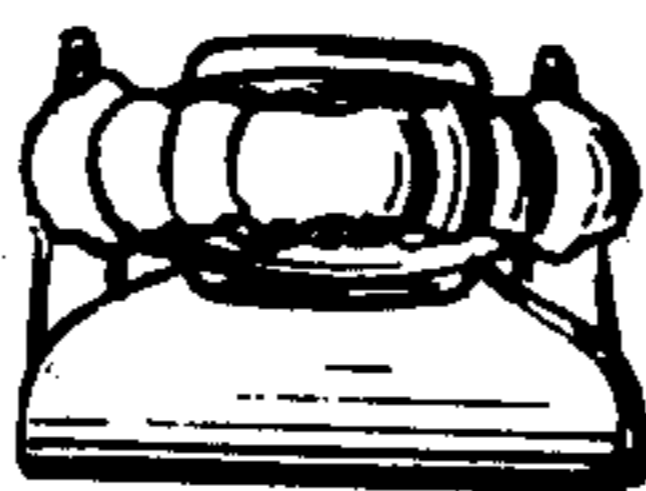

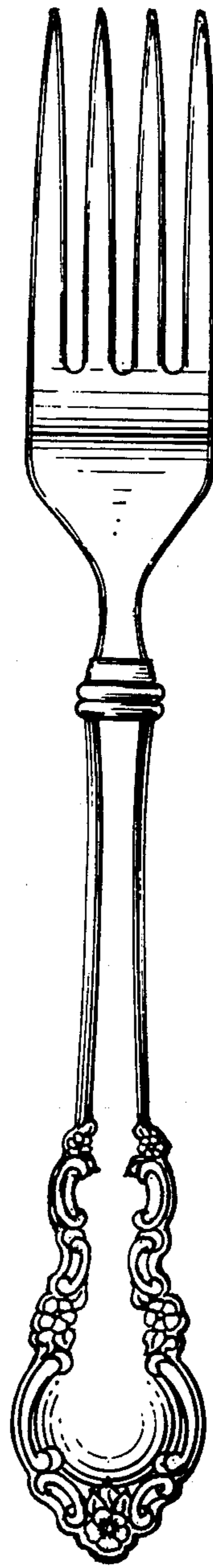

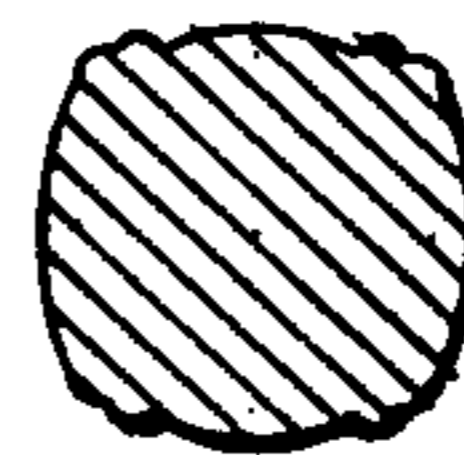

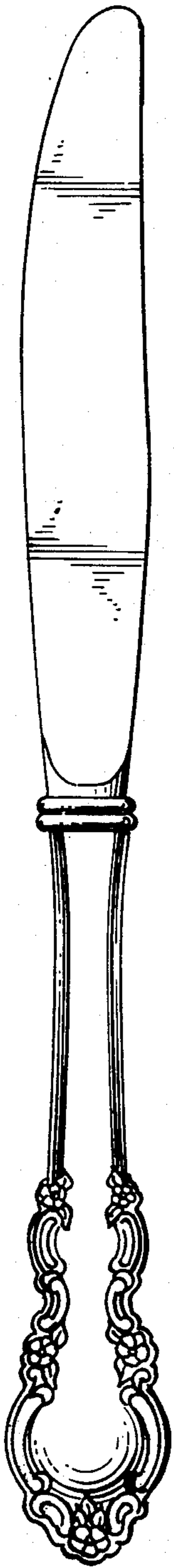

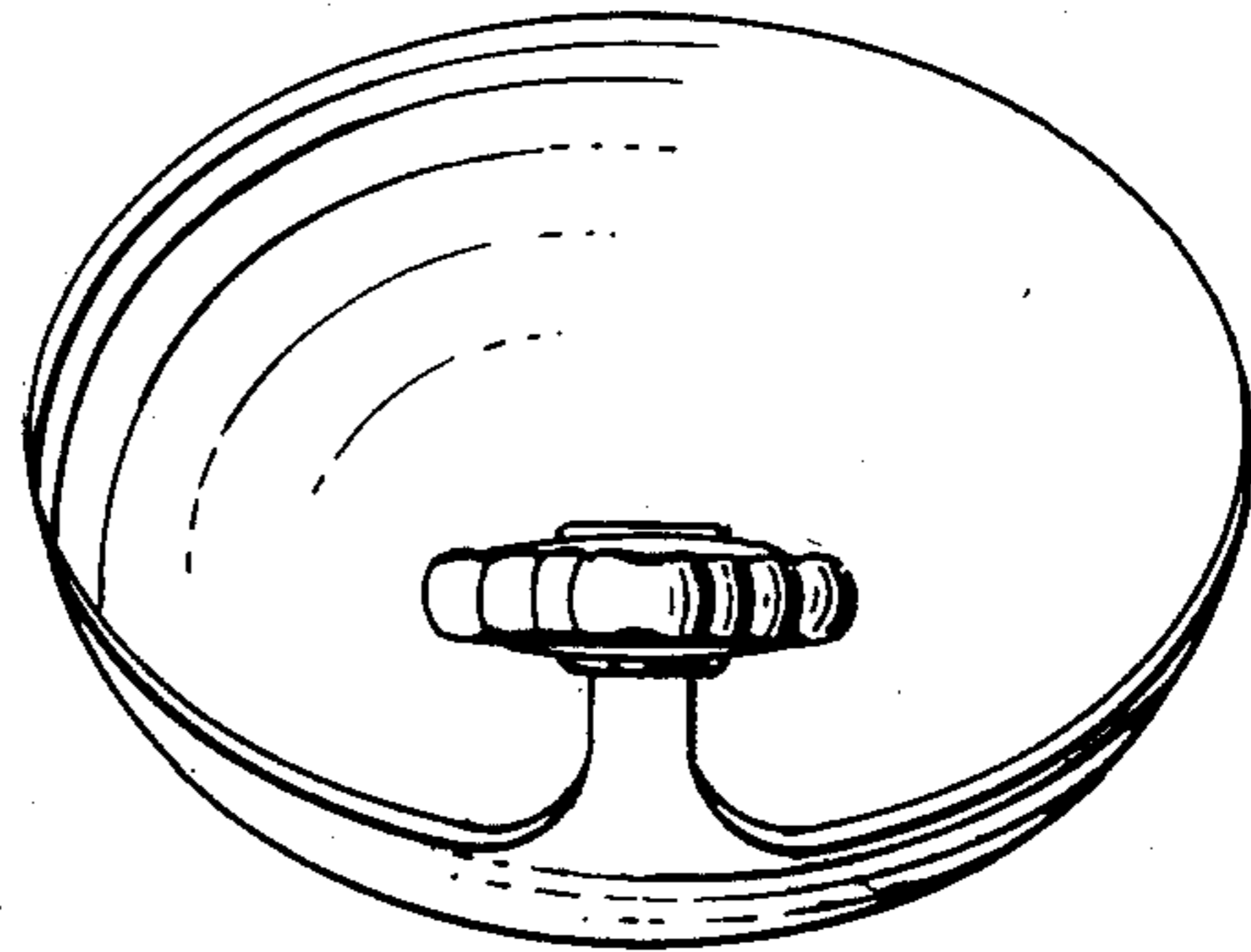

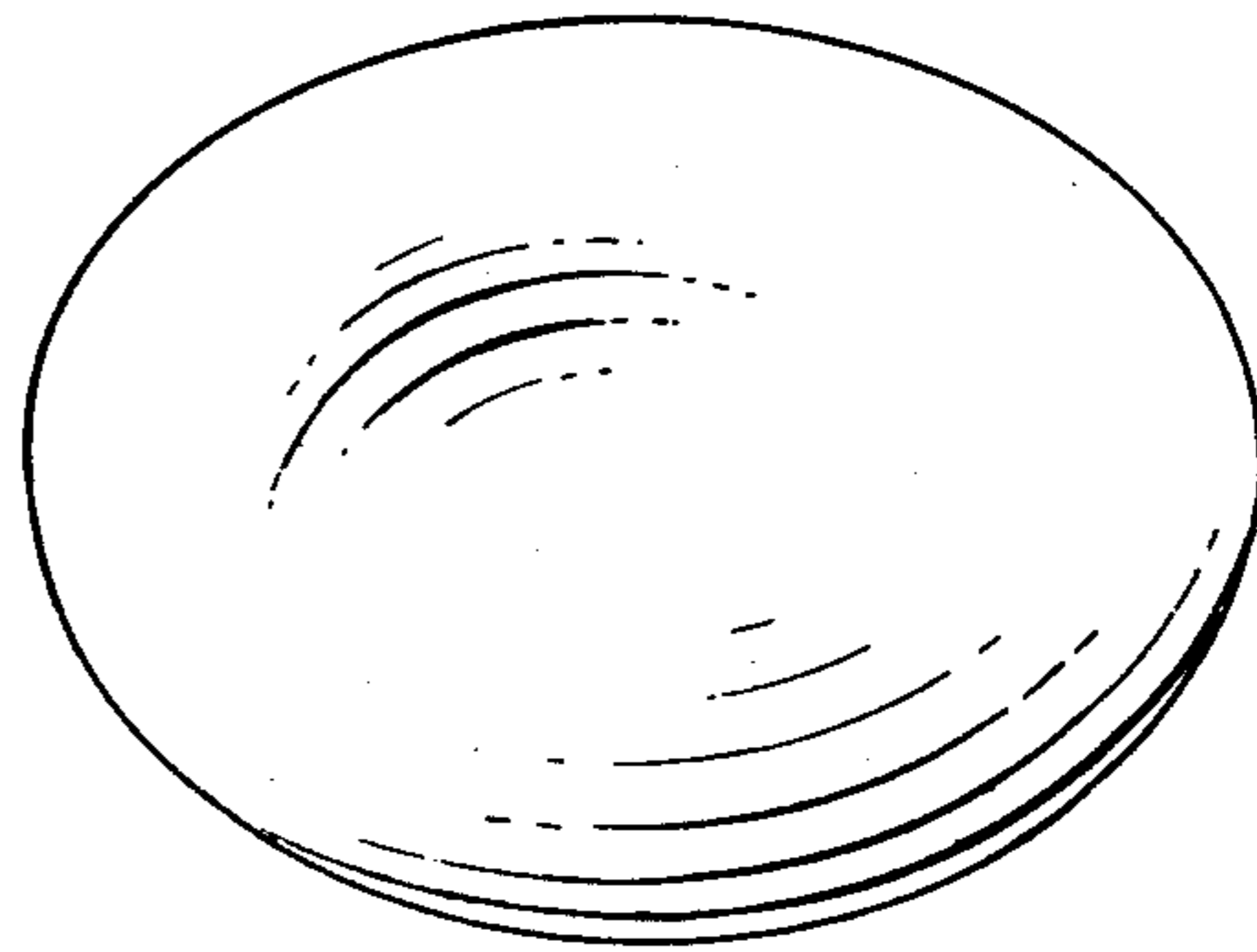

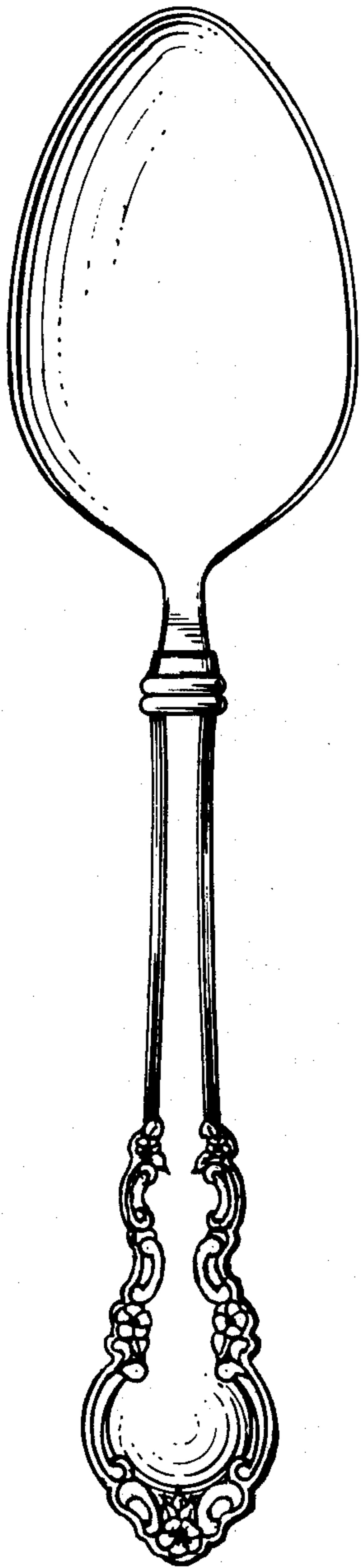

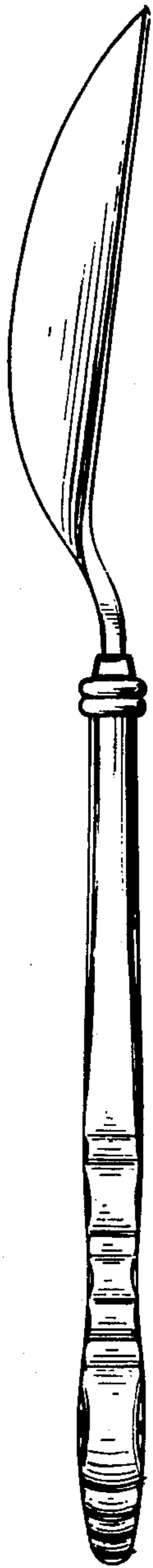

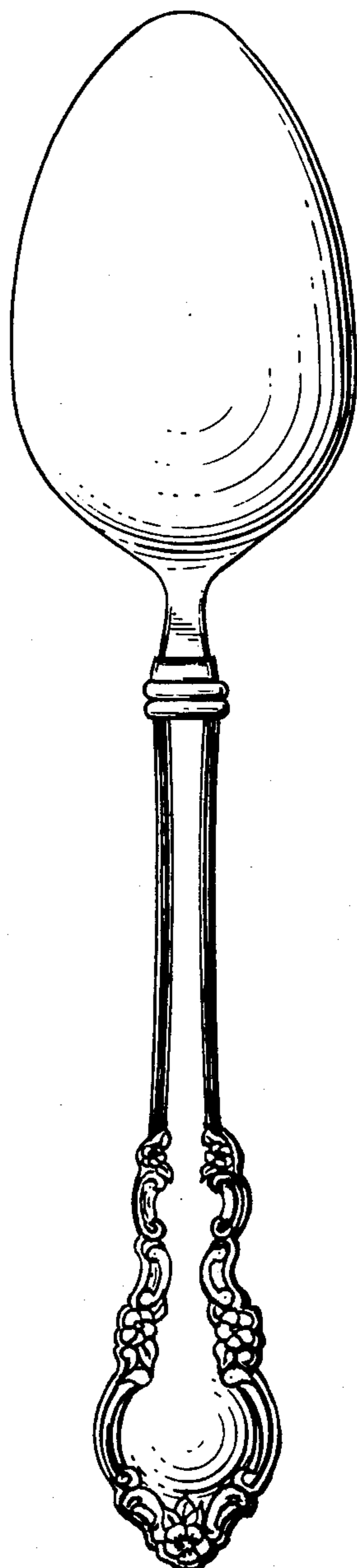

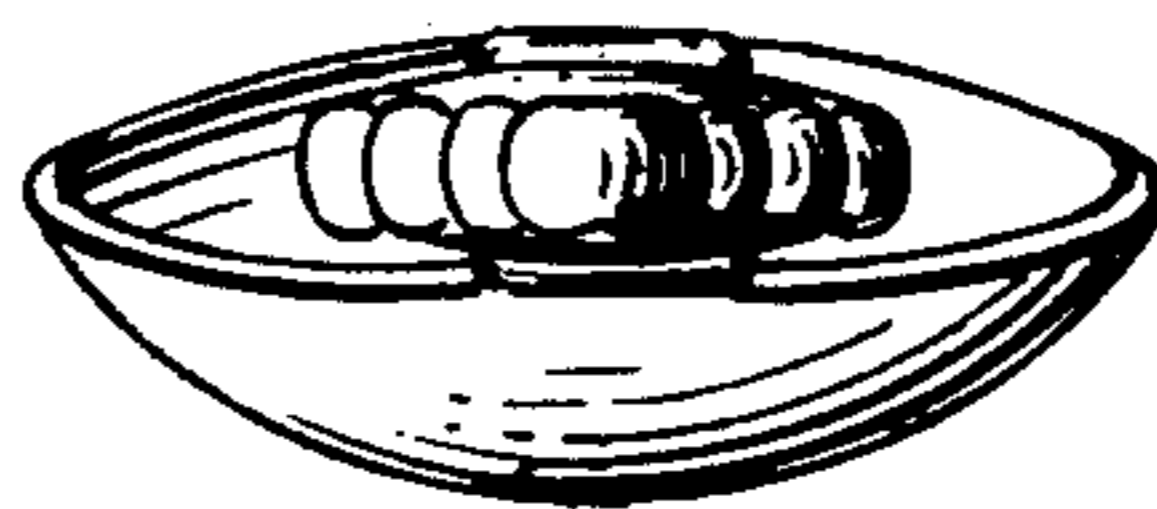

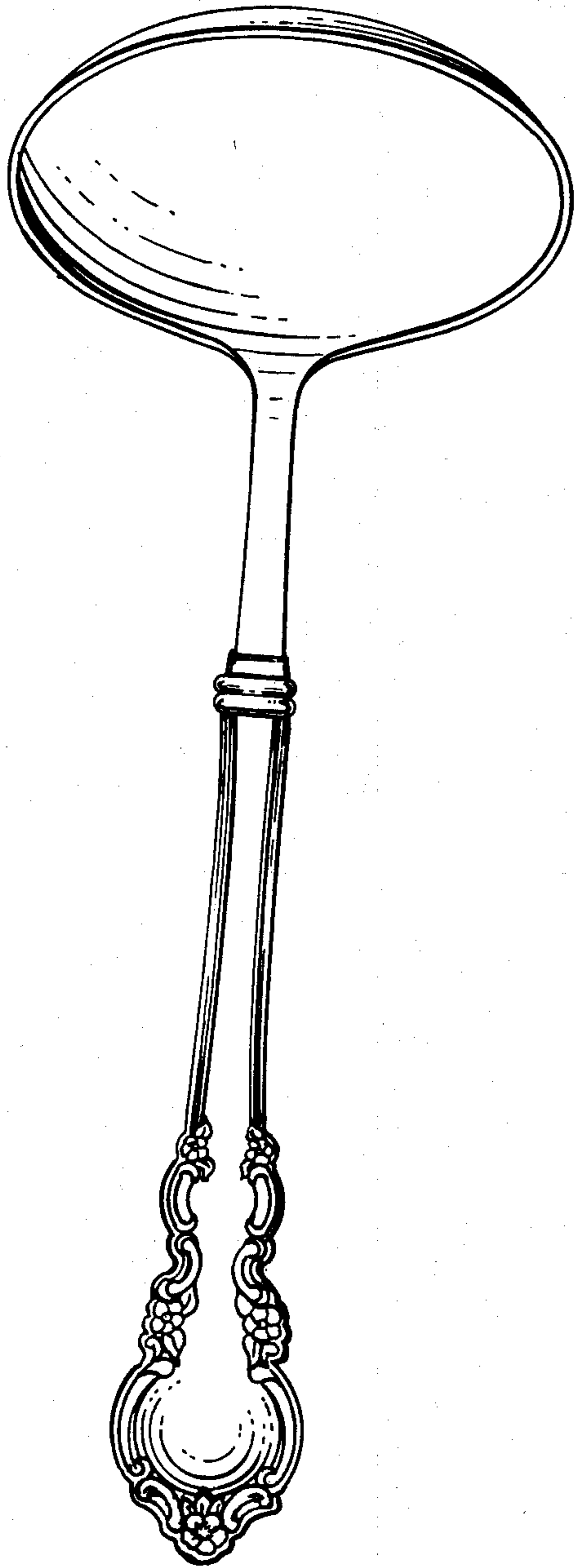

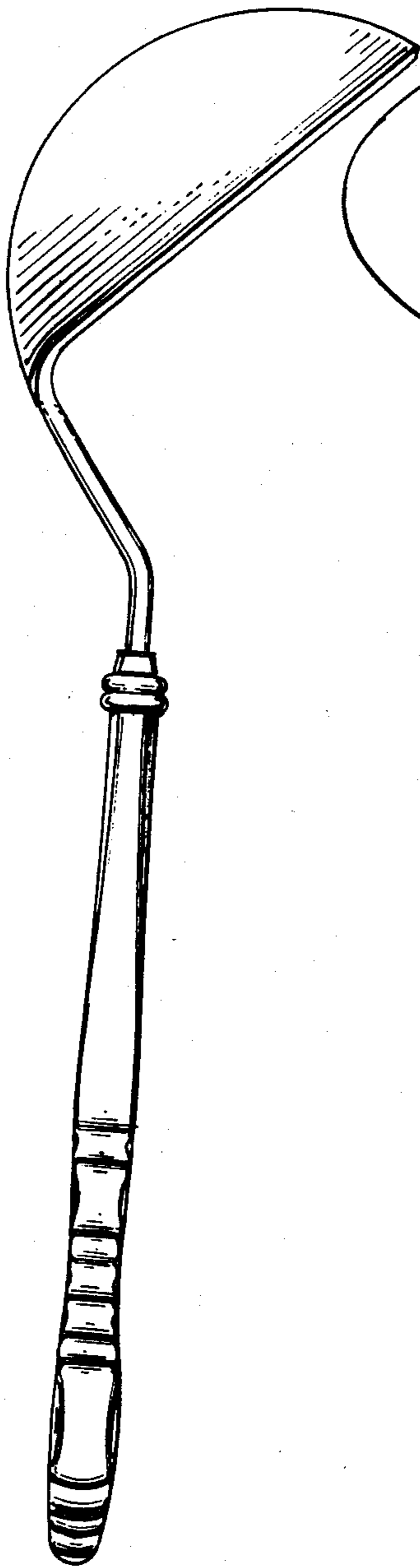

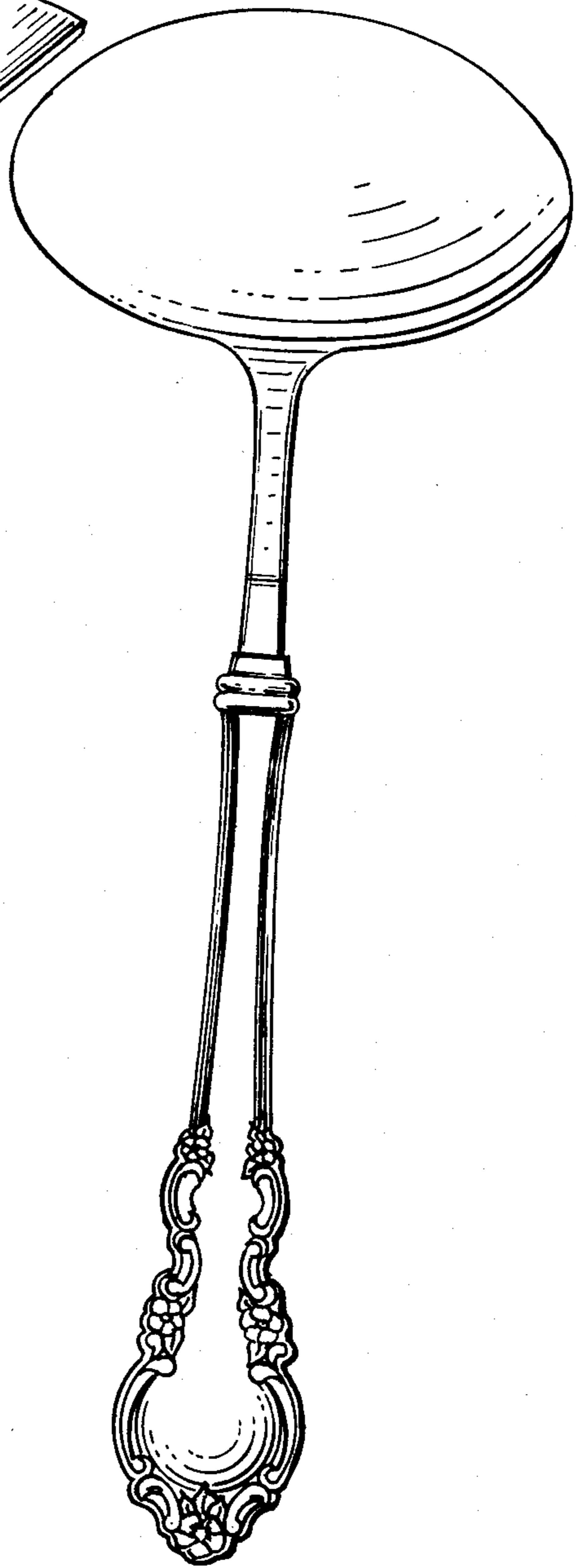
