The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a shoe showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a bottom plan view thereof;

FIG. 7 is a right side elevational view thereof;

FIG. 8 is a side perspective view thereof in an opened condition;

FIG. 9 is a top plan view of FIG. 8;

FIG. 10 is a left side elevational view of FIG. 8;

FIG. 11 is a front elevational view of FIG. 8;

FIG. 12 is a partial side elevational view of another embodiment of my new design of FIG. 1 wherein a pocket has been added thereto;

FIG. 13 is a partial side elevational view of yet another embodiment of my new design wherein rivets have been added thereto;

FIG. 14 is a side elevational view of yet another embodiment of my new design of FIG. 1, wherein corduroy material has been substituted for the denim material of FIGS. 1-13;

FIG. 15 is a partial side elevational view of yet another embodiment of my new design of FIG. 1, wherein suede material has been substituted for the denim of FIGS. 1-13;

FIGS. 1-13 are shaded to indicate denim material while FIG. 14 is shaded for corduroy and FIG. 15 for suede.

All other views of FIGS. 12-14 are substantially similar in configurations to those of FIGS. 1-11.

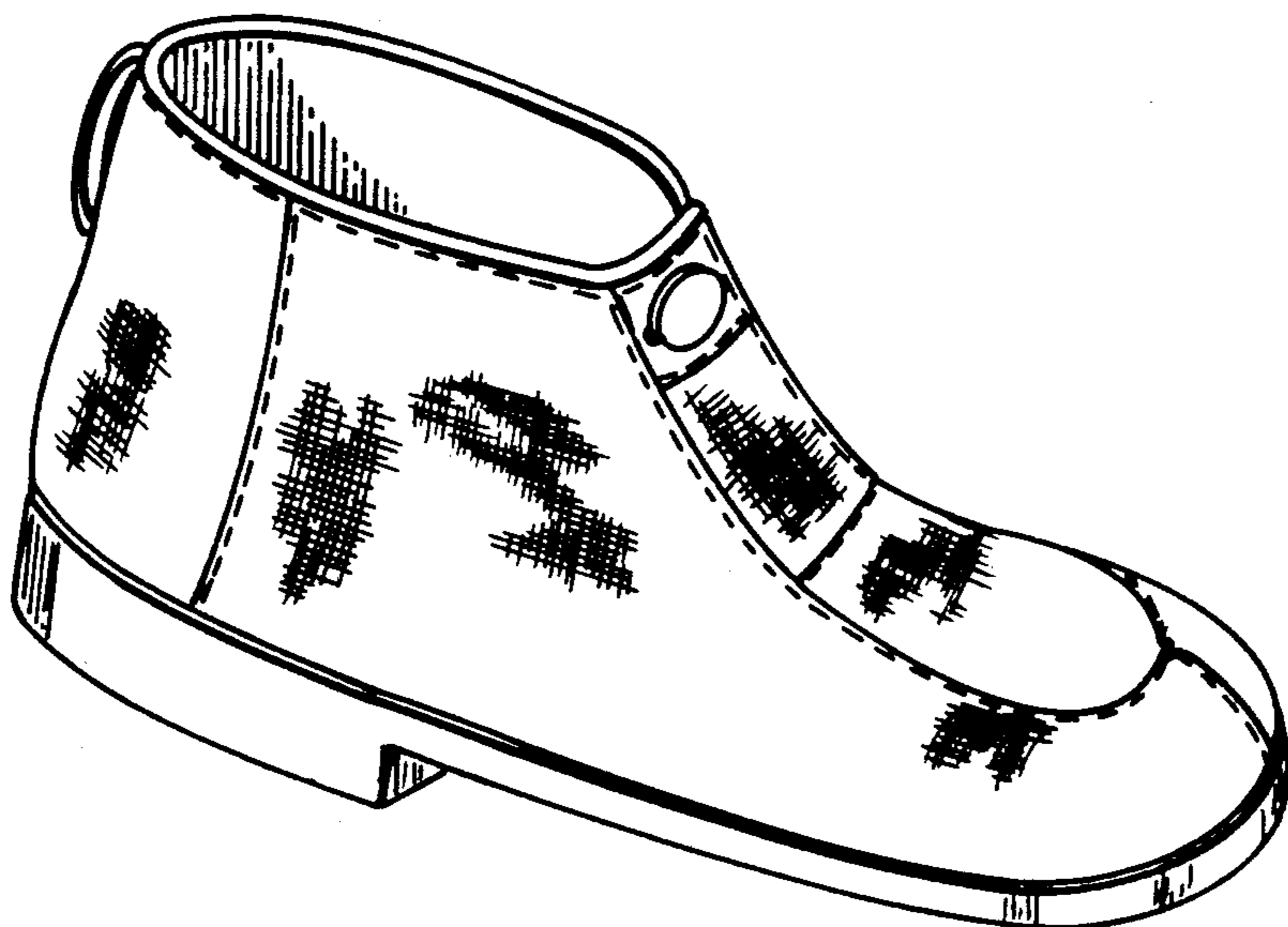

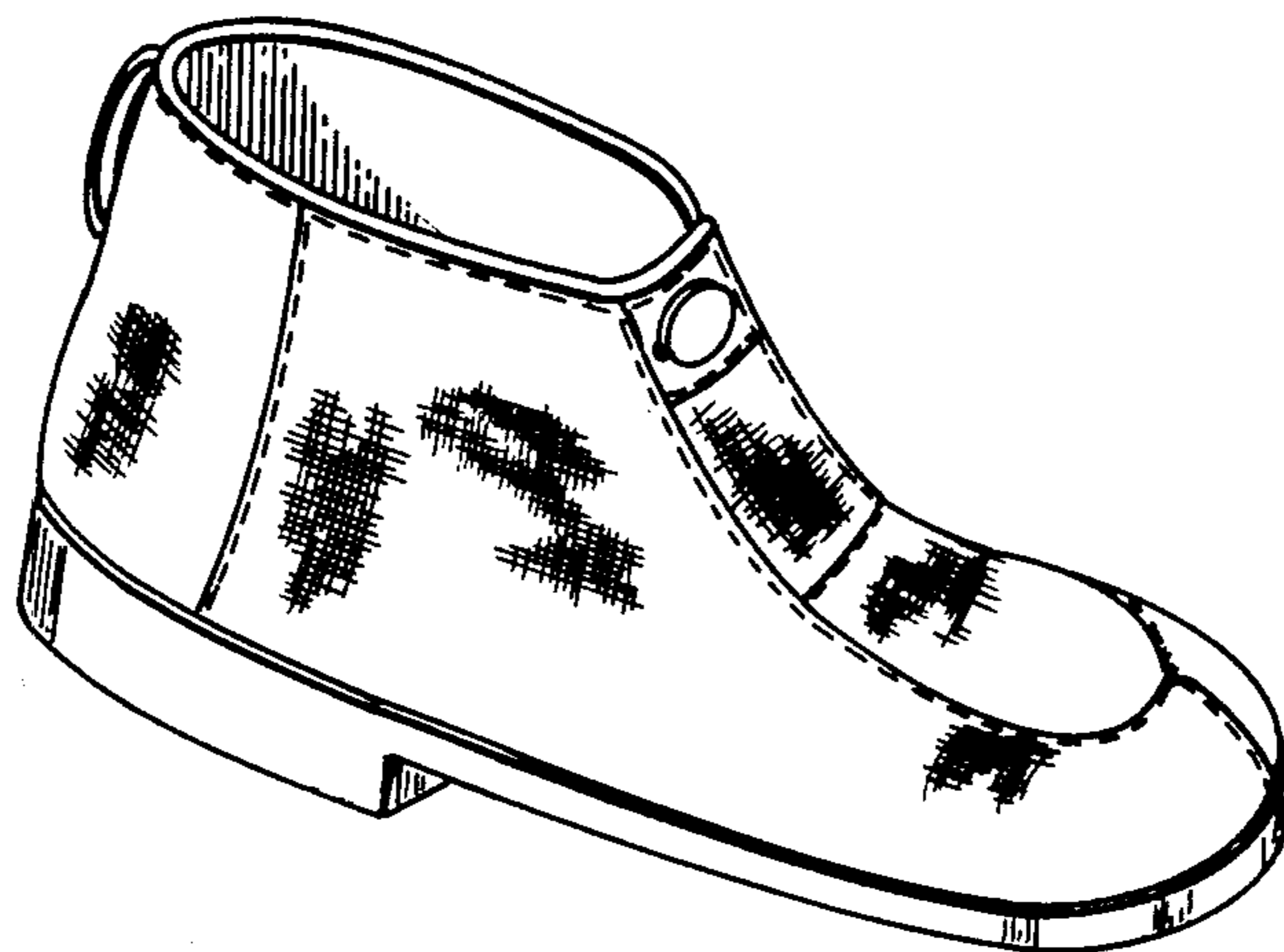

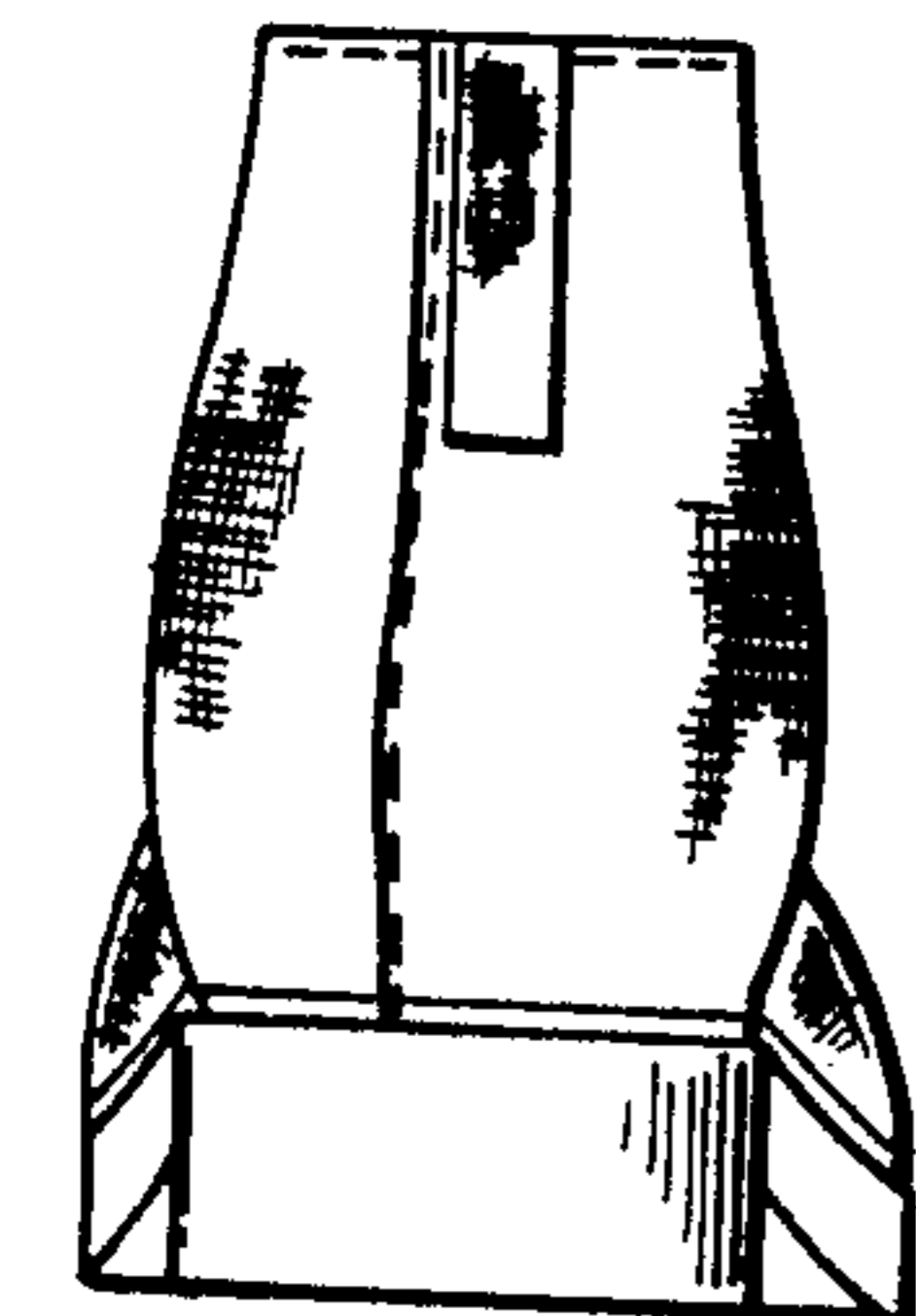
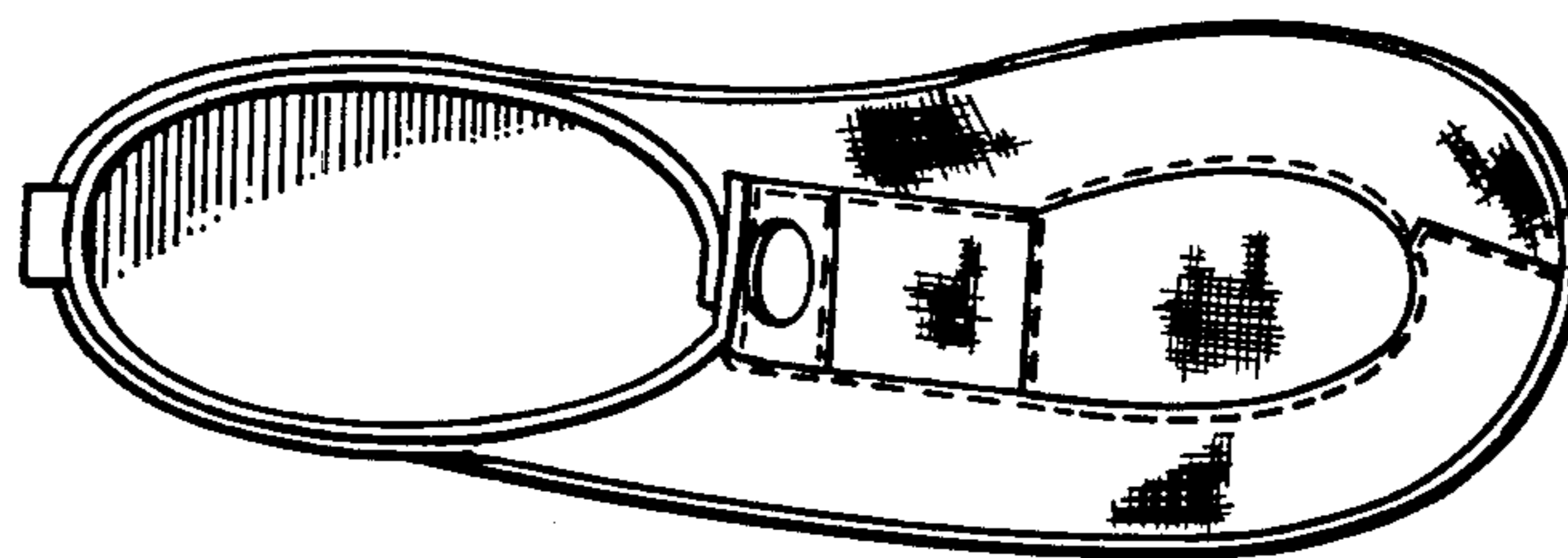

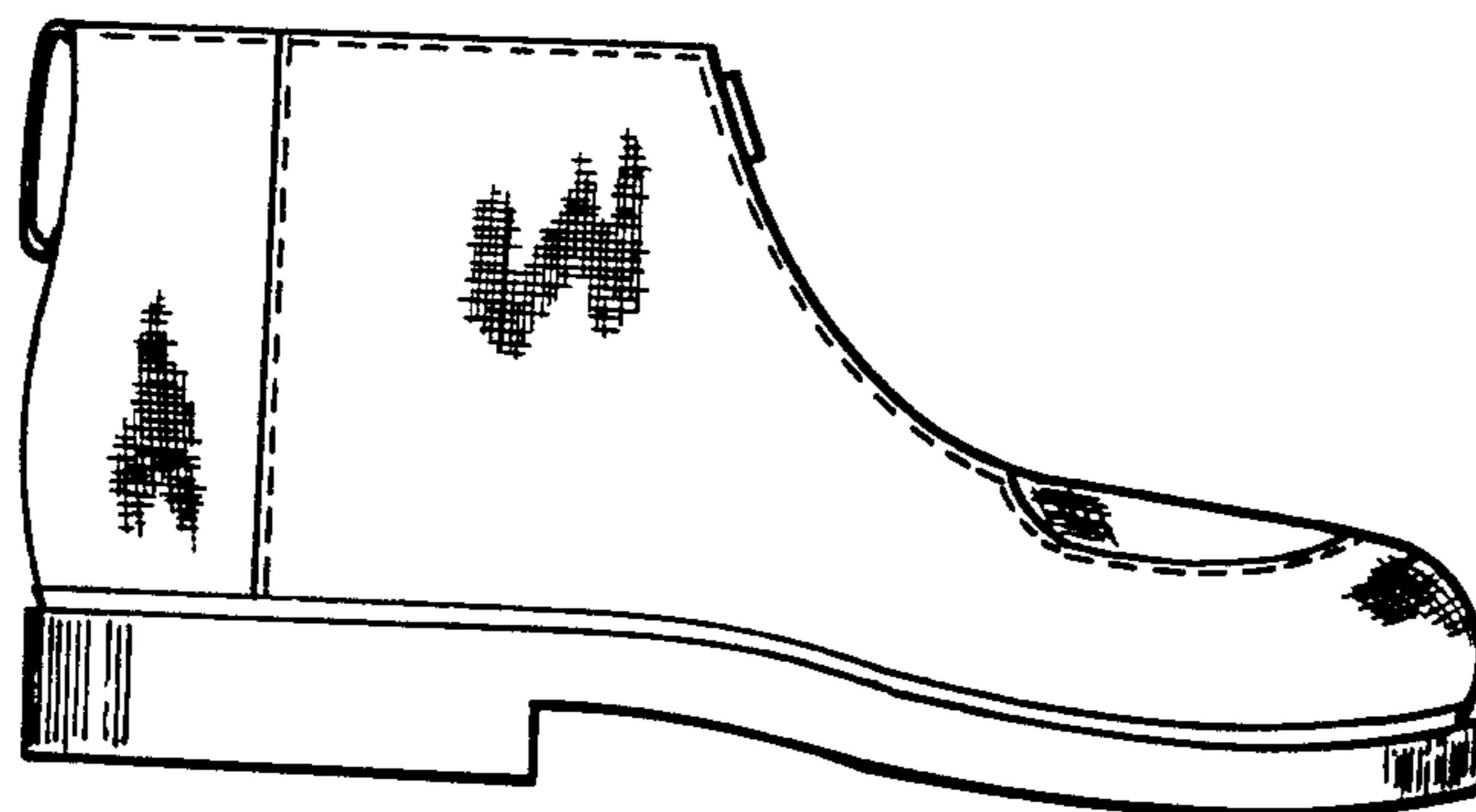

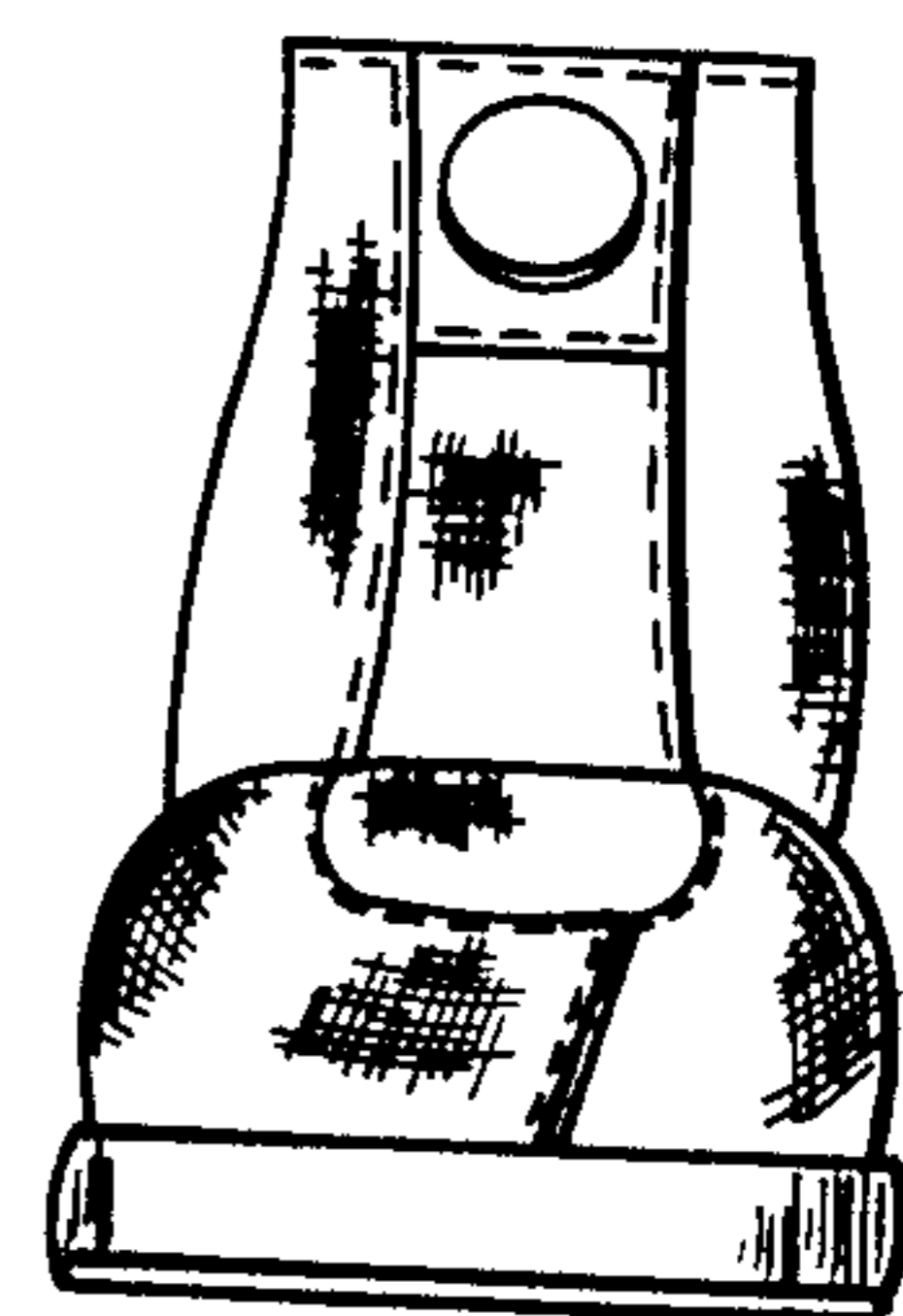

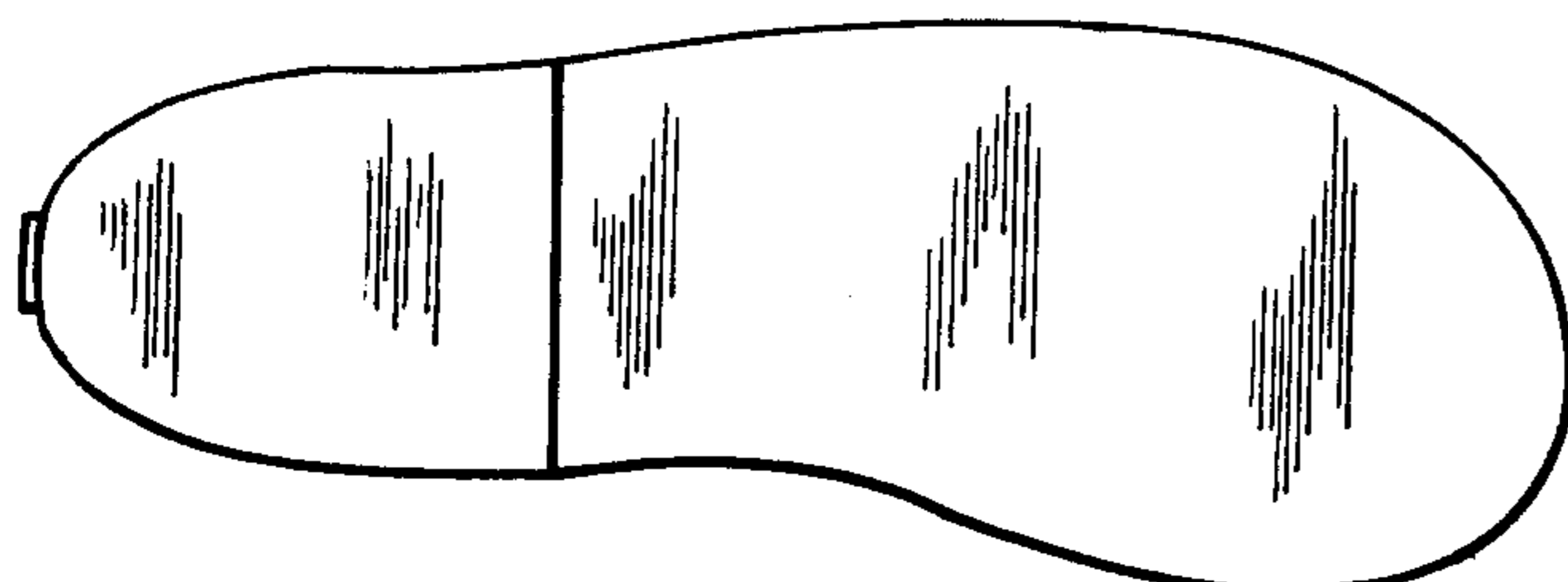

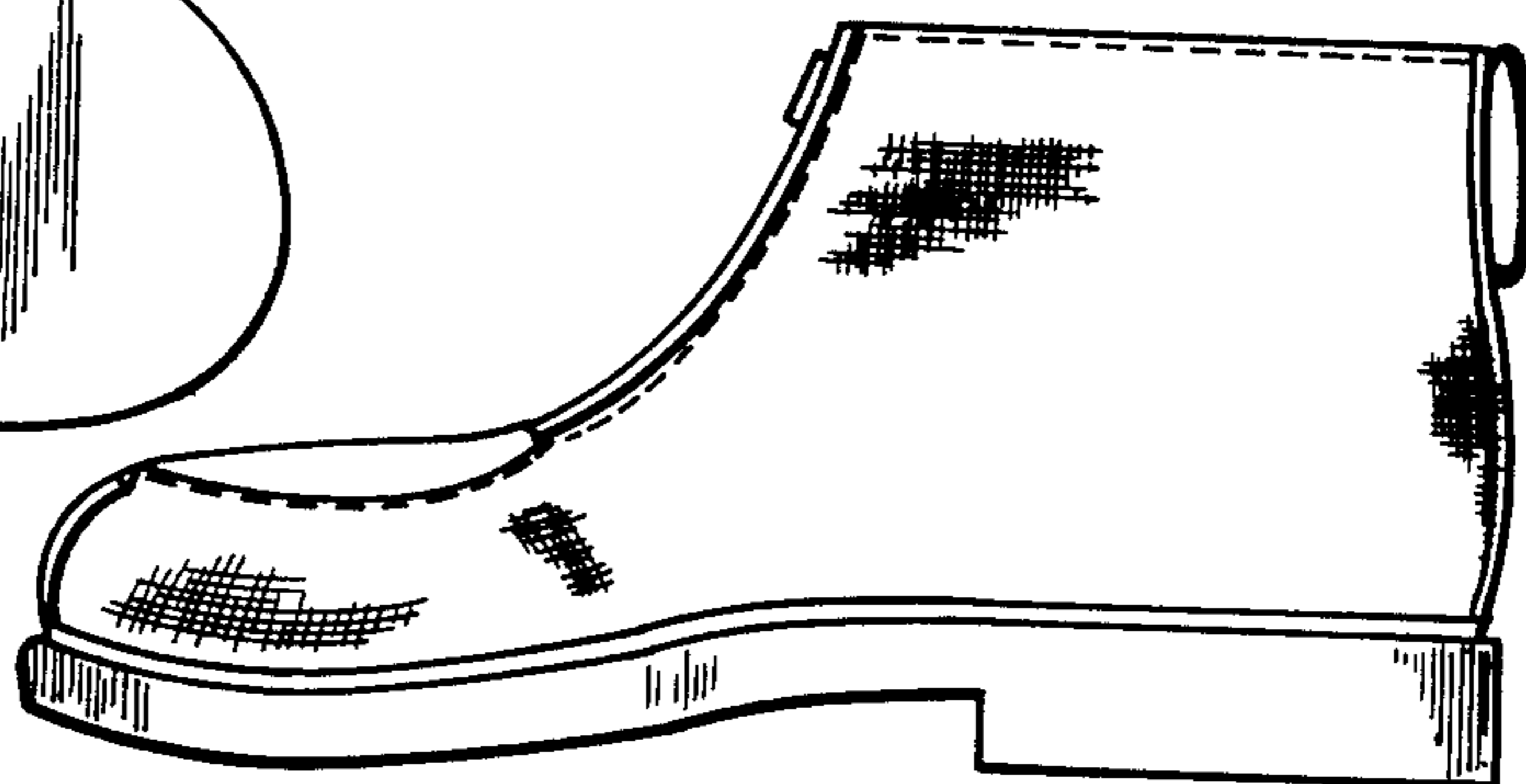

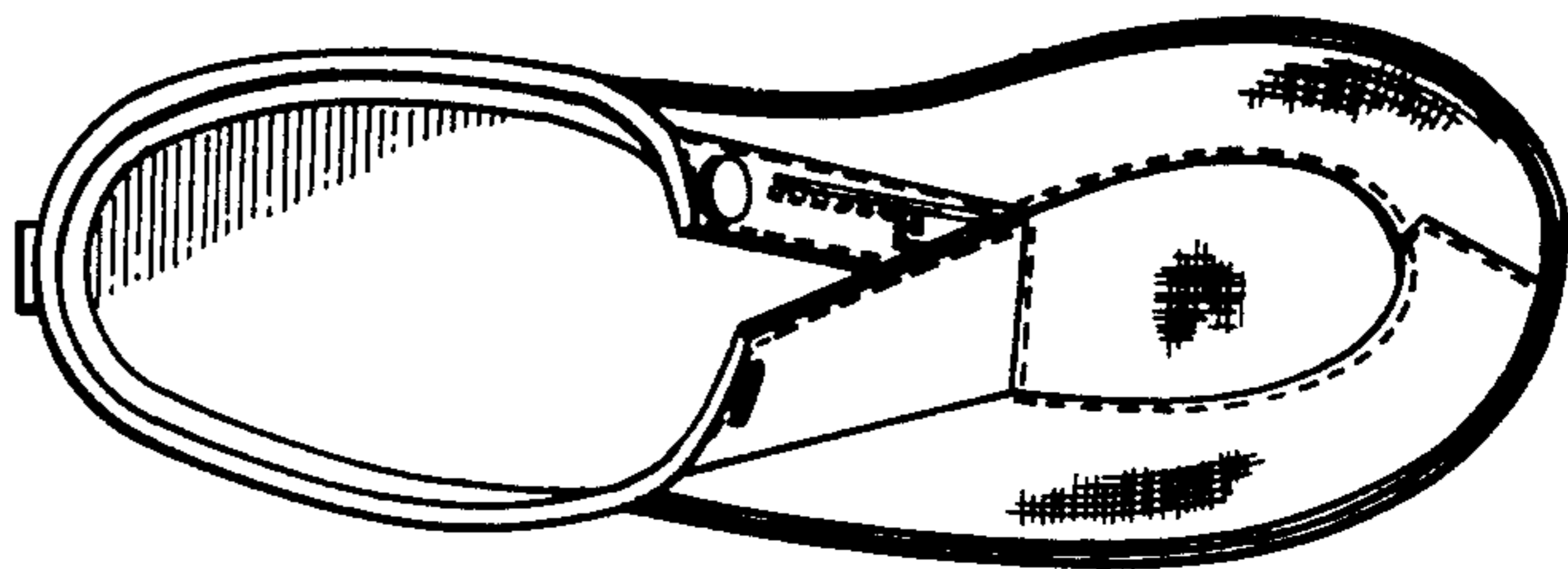

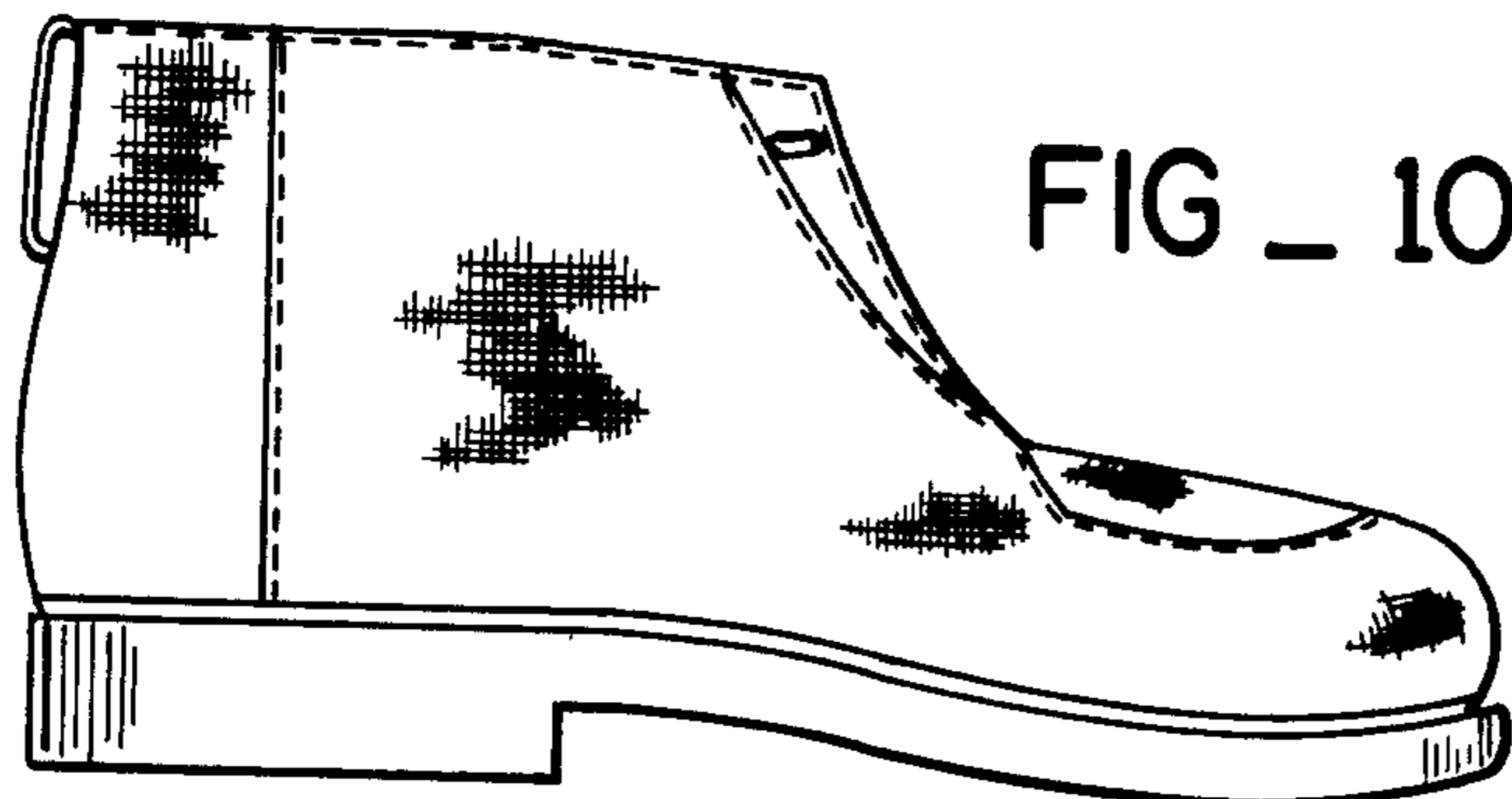

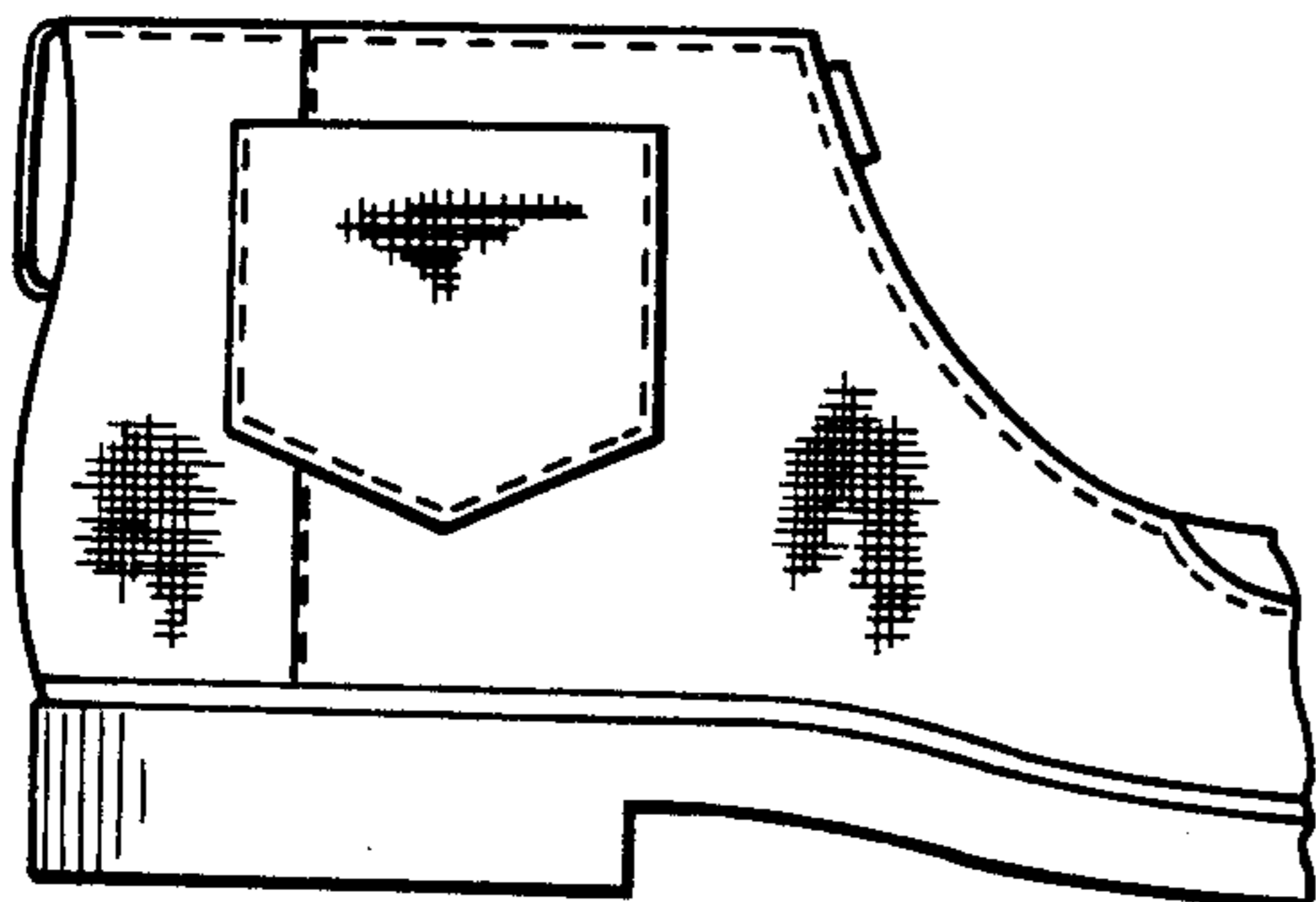
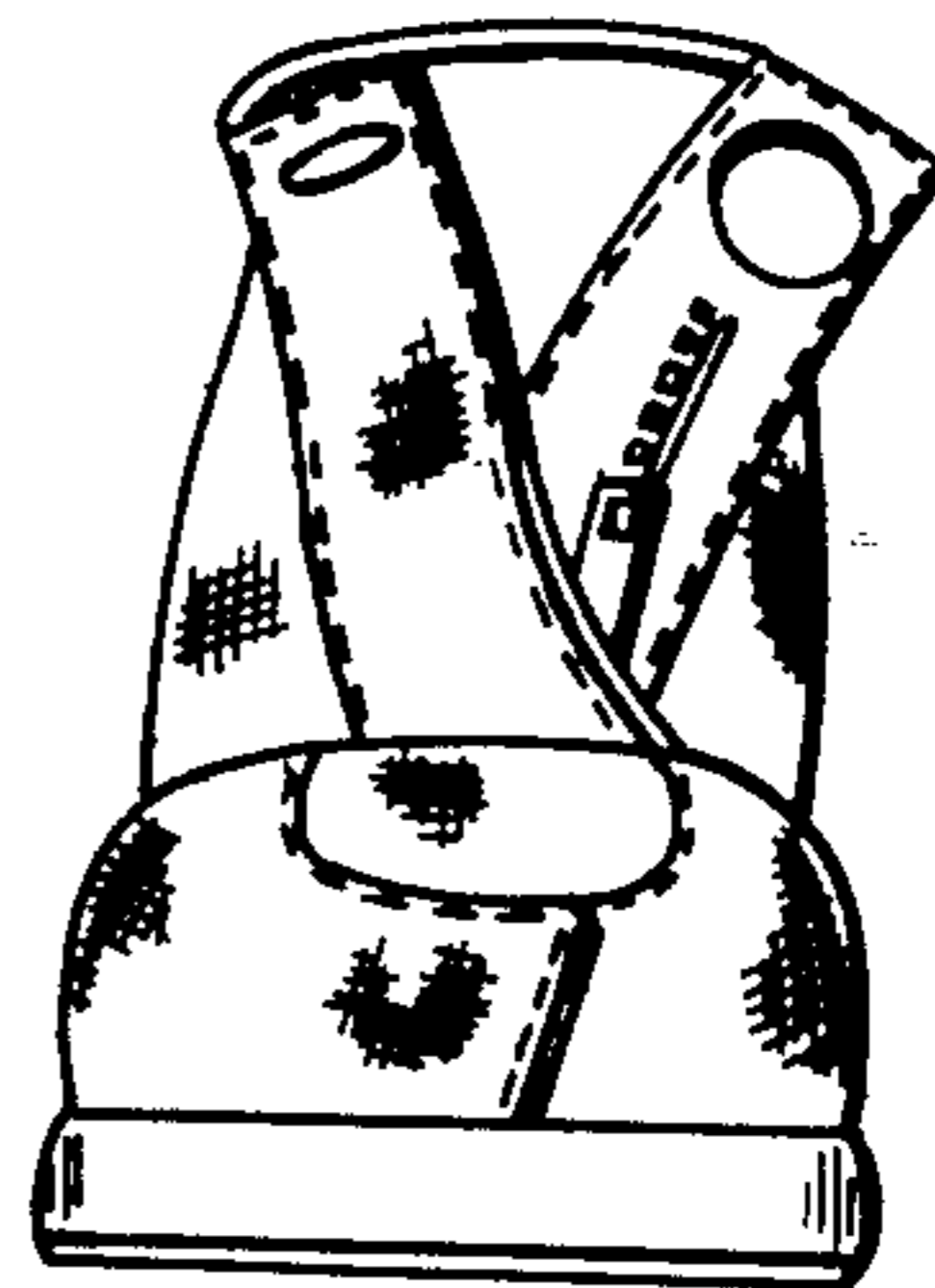

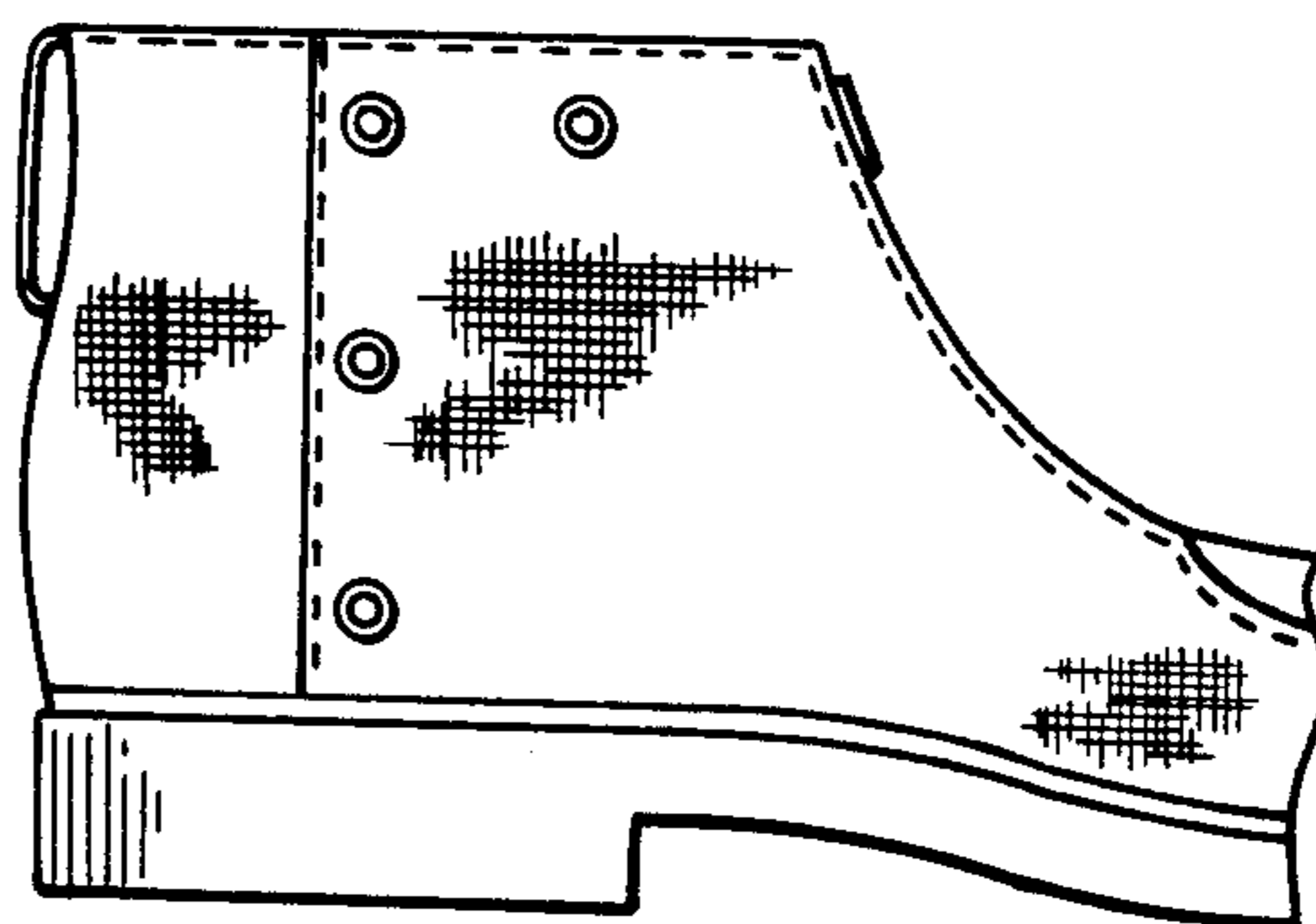

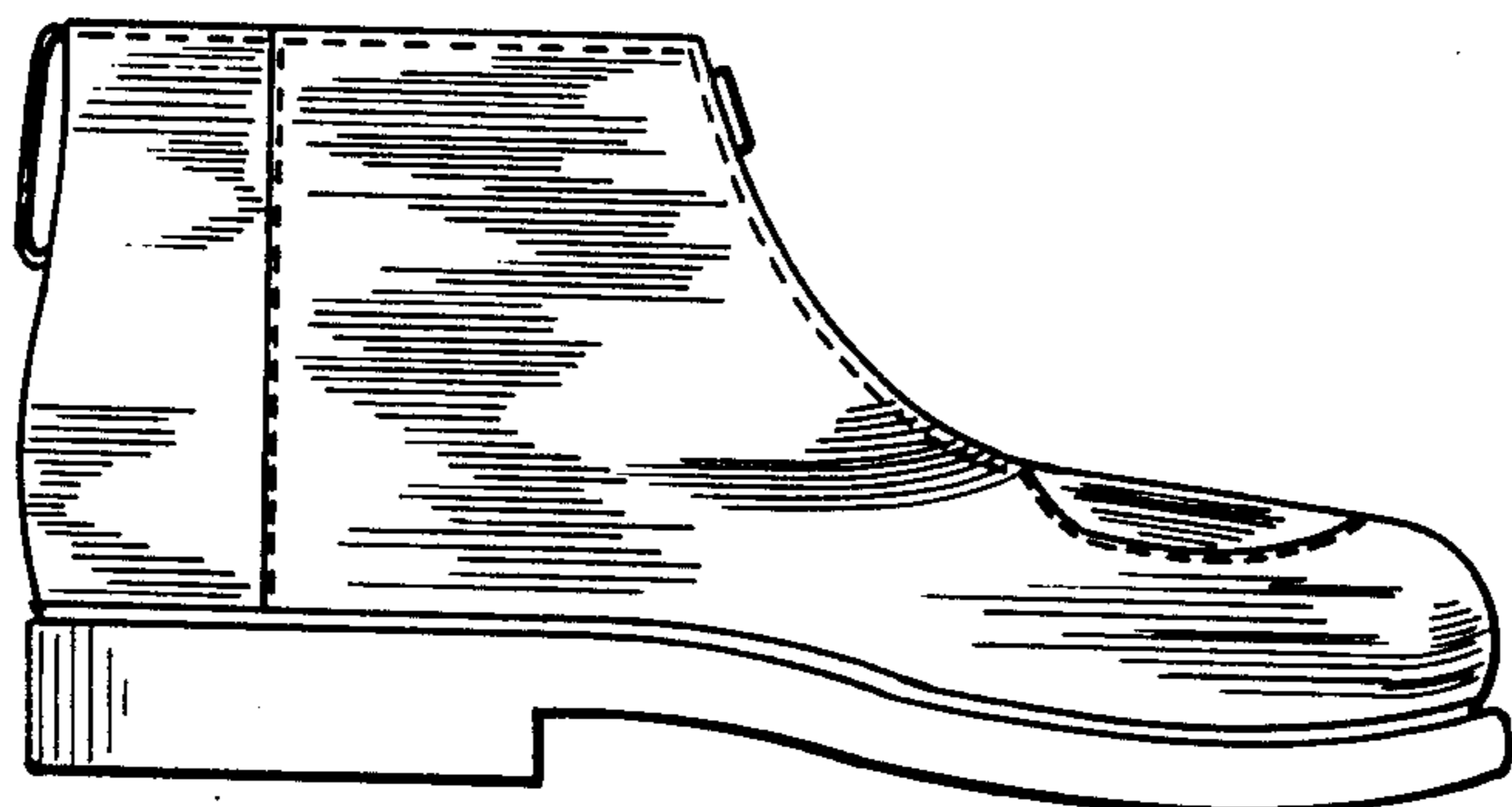

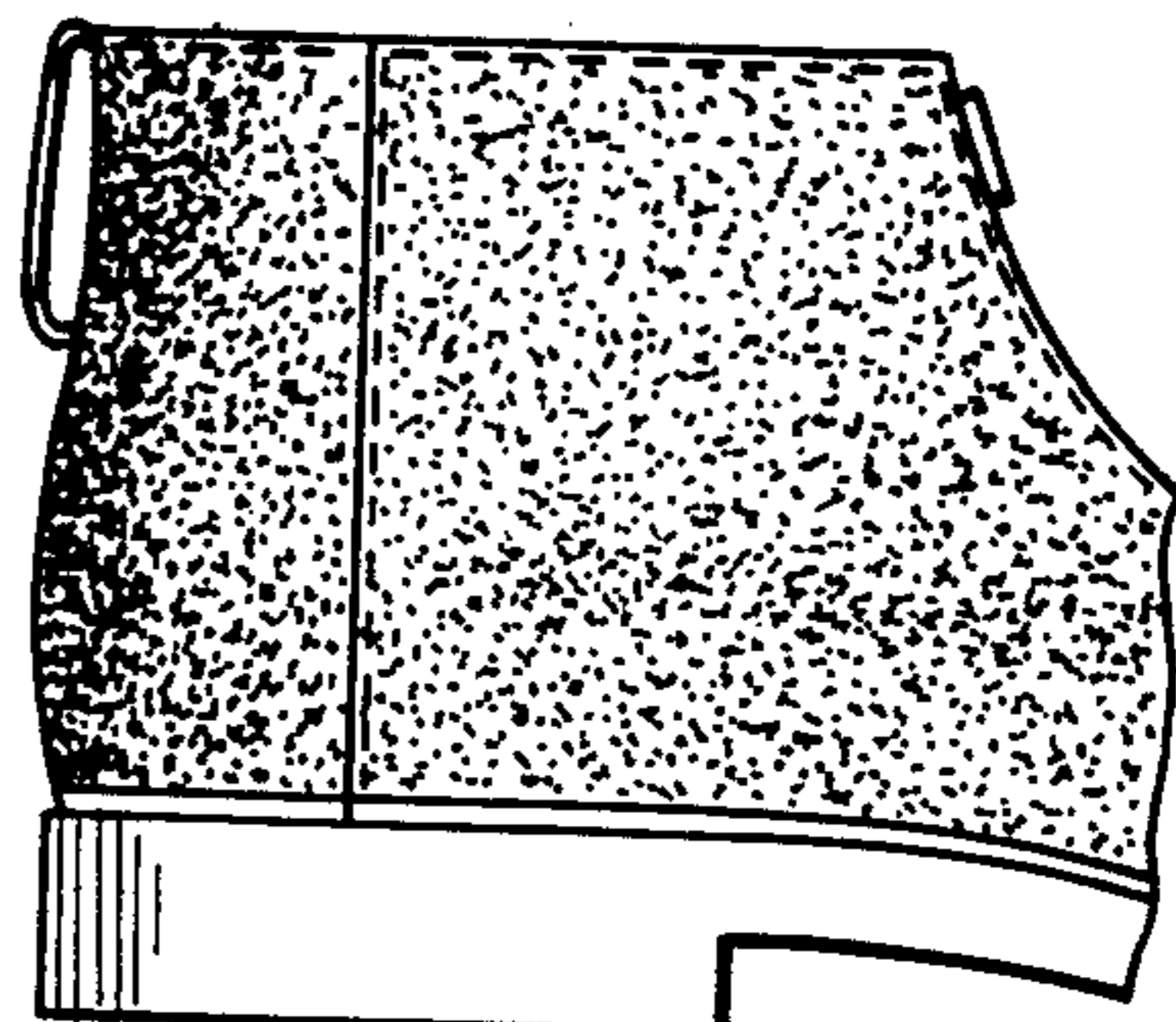
