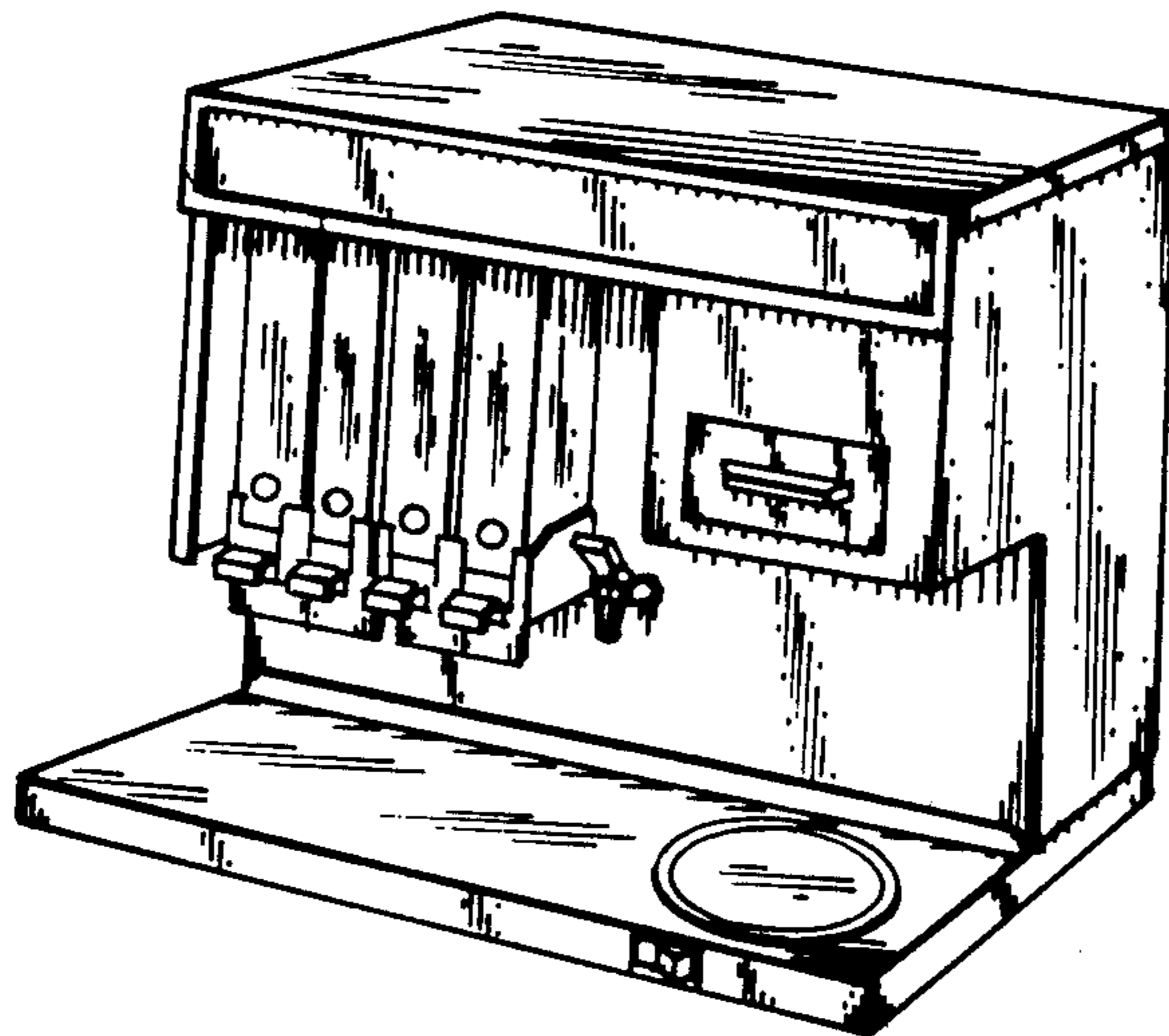

[57] CLAIM

The ornamental design for a beverage dispenser, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a beverage dispenser showing the new design;
 FIG. 2 is a top plan view;
 FIG. 3 is a front elevational view;
 FIG. 4 is a right side elevational view;
 FIG. 5 is a left side elevational view;
 FIG. 6 is a cross sectional view thereof taken along line 6-6 in FIG. 3;
 FIG. 7 is a front perspective view of a beverage dispenser showing a modified form of the new design; wherein six product dispensing cartridges are provided rather than four as in the first embodiment;
 FIG. 8 is a top plan view;
 FIG. 9 is a front elevational view;
 FIG. 10 is a right side elevational view;
 FIG. 11 is a left side elevational view;
 FIG. 12 is a cross sectional view of the unit shown in FIG. 7 taken along line 6-6 FIG. 3.



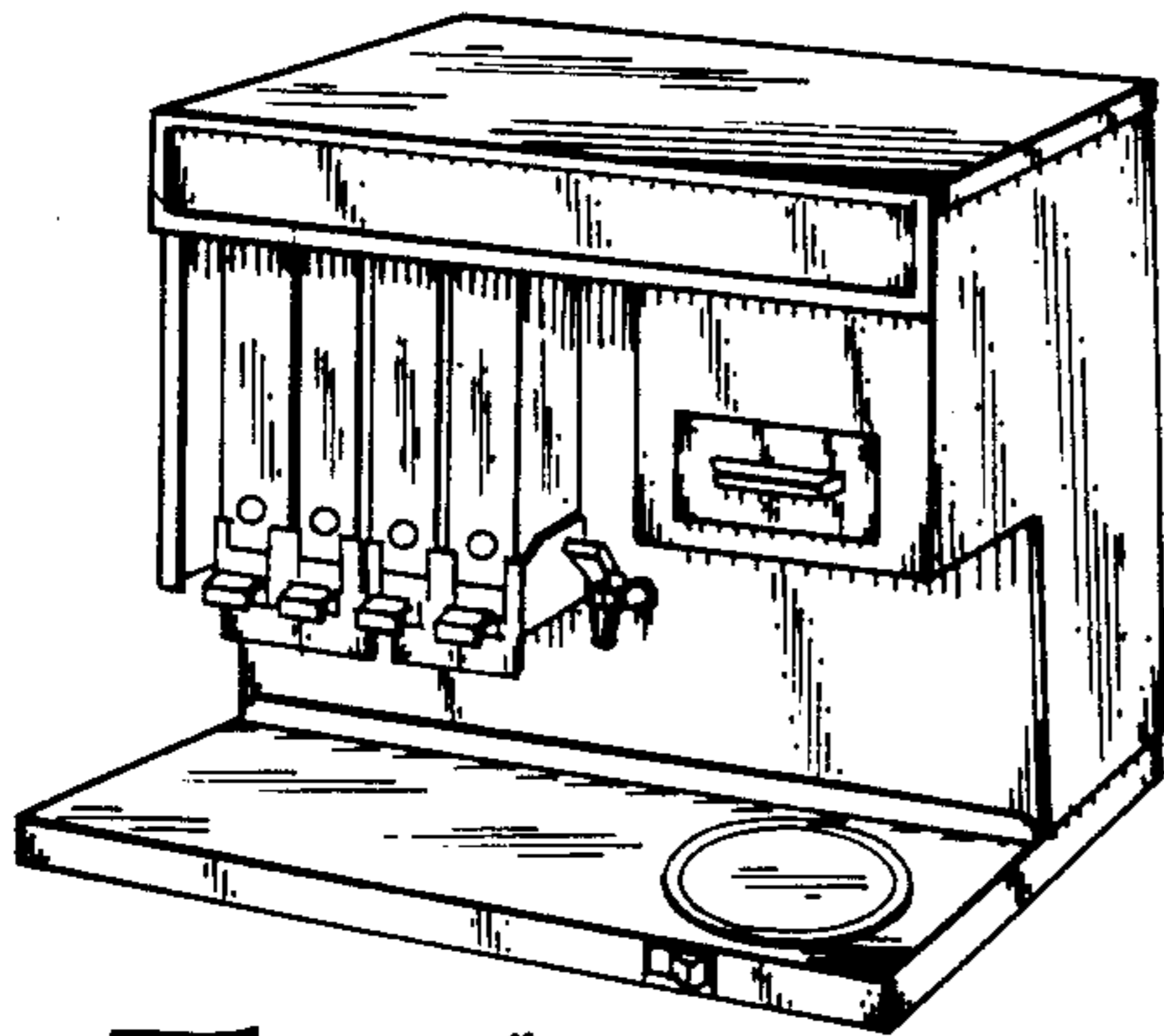

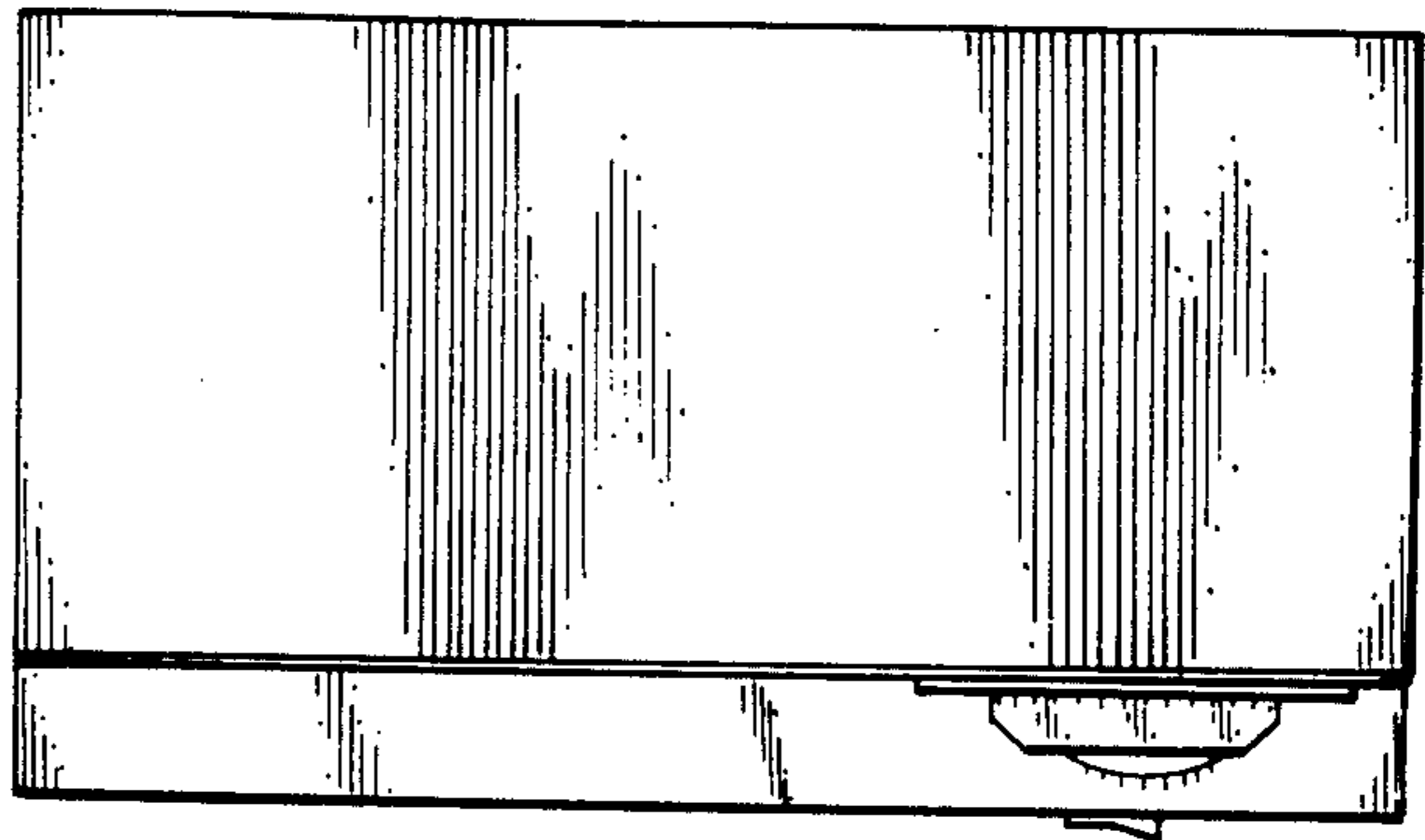

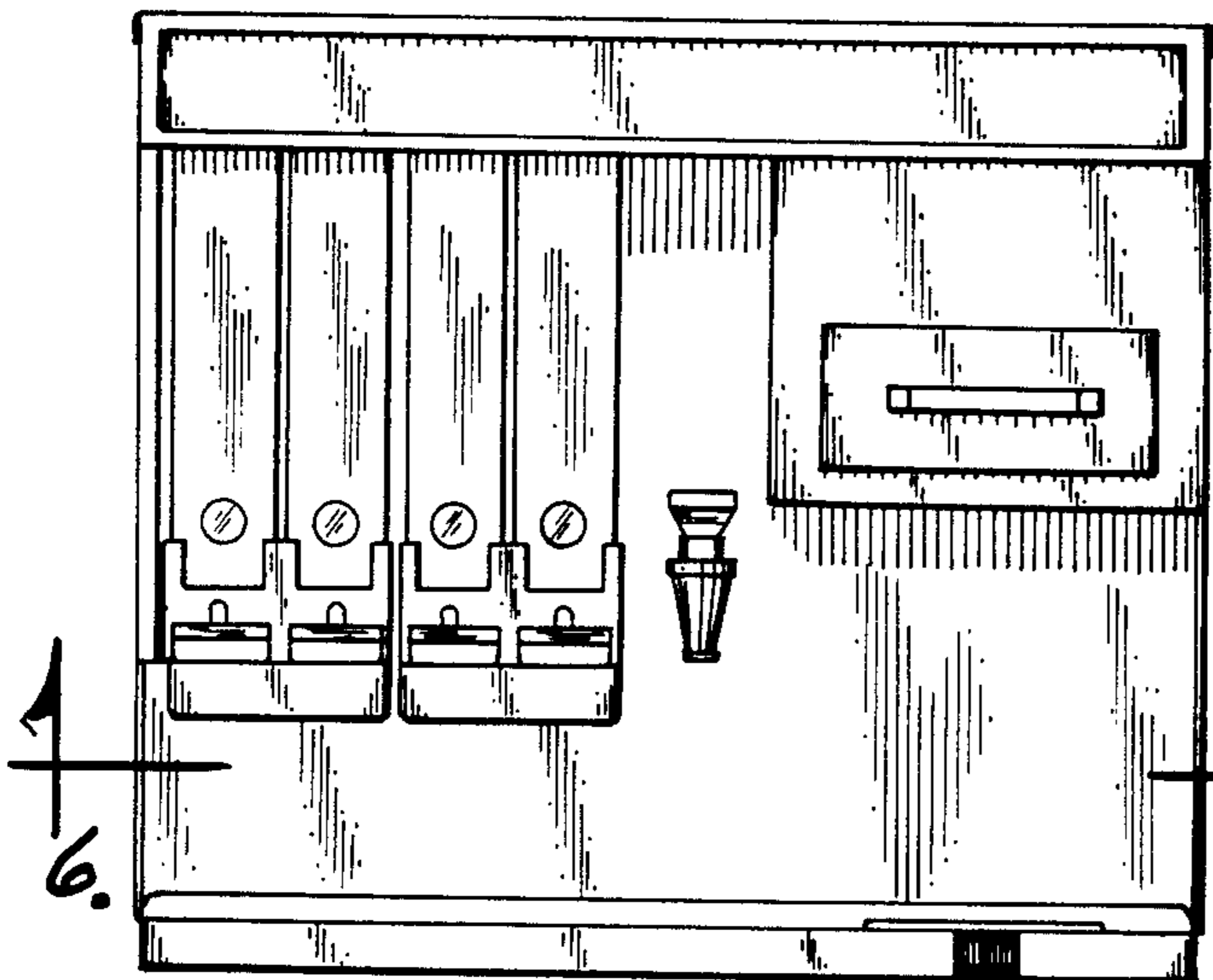

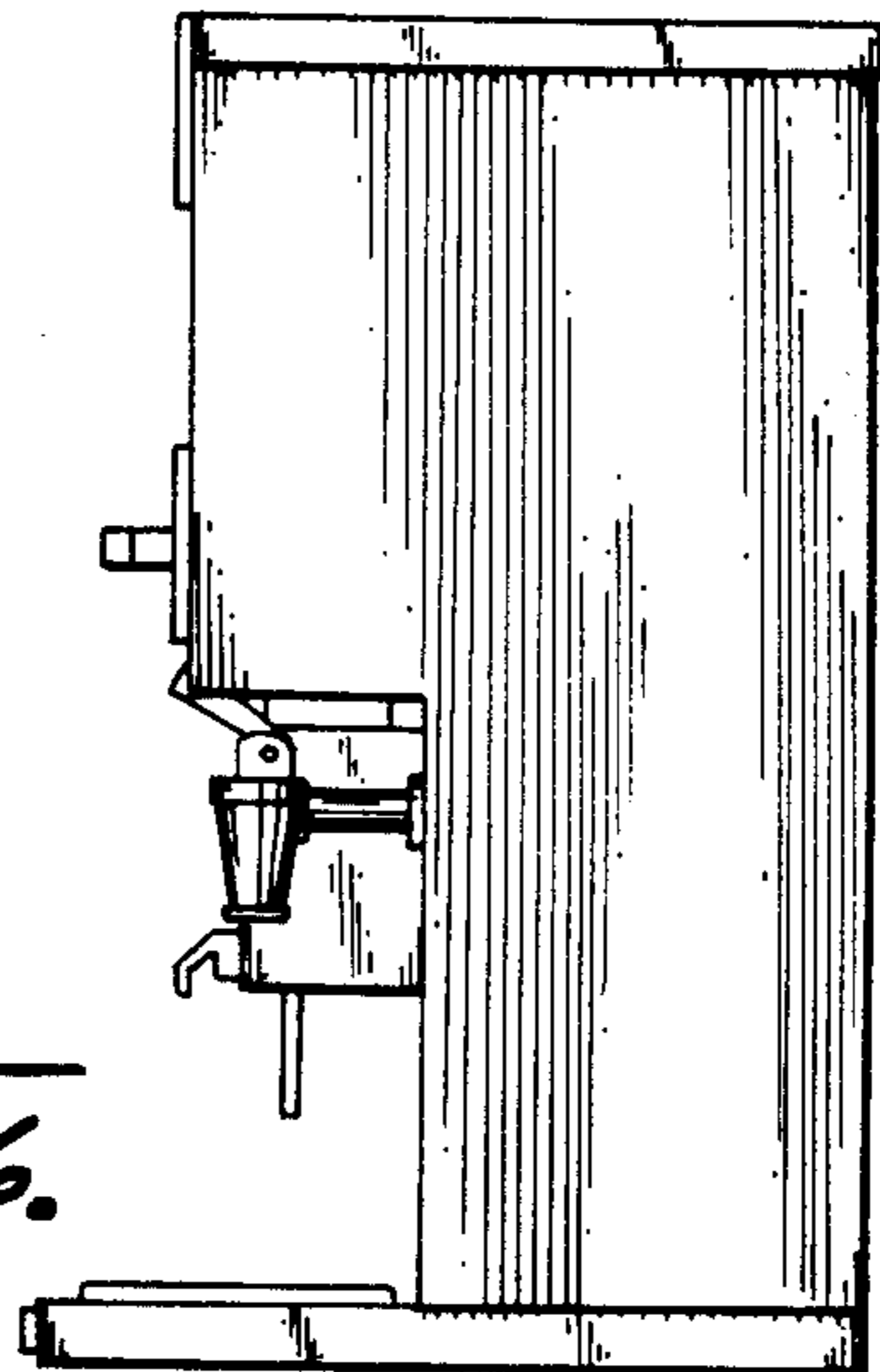

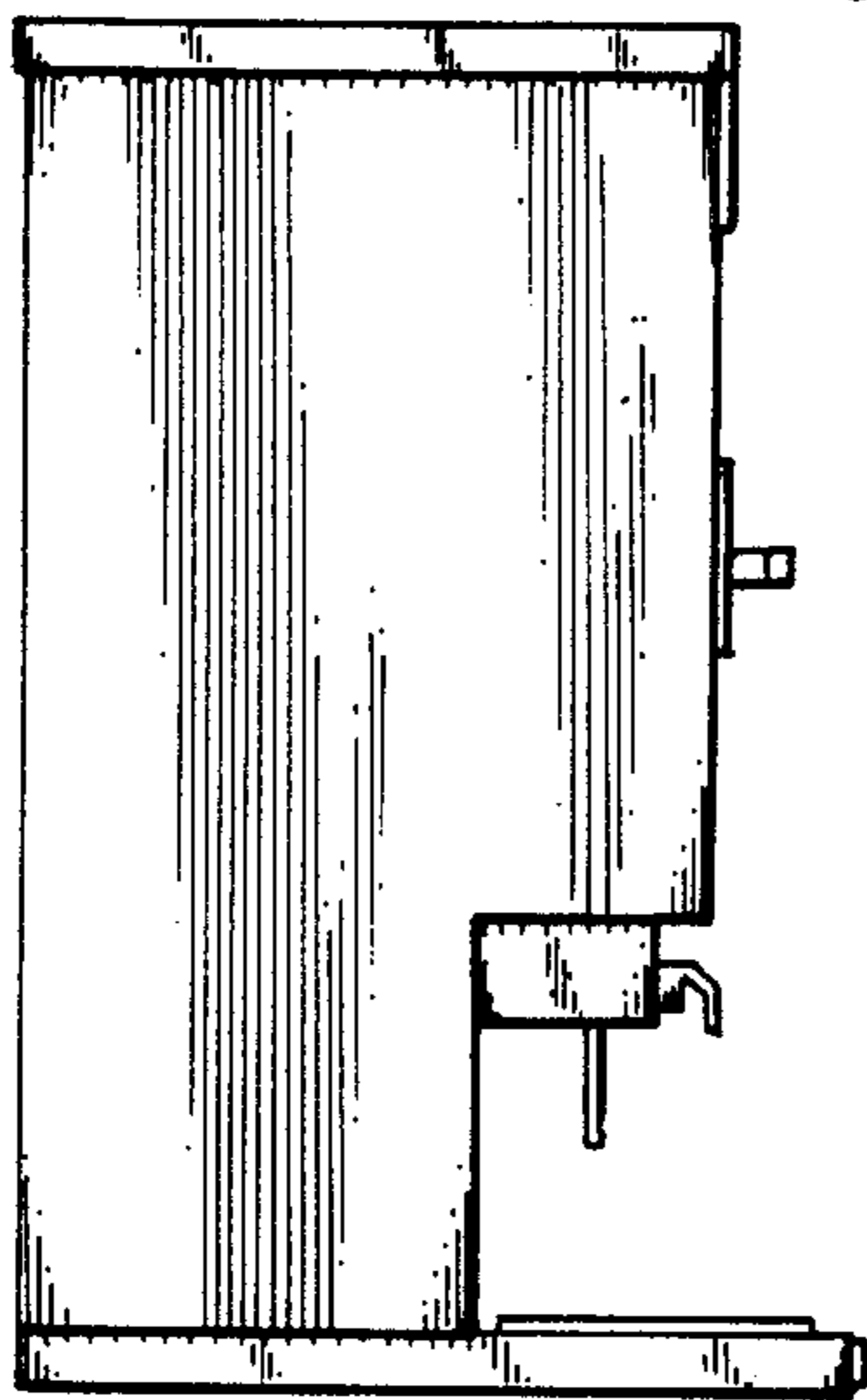

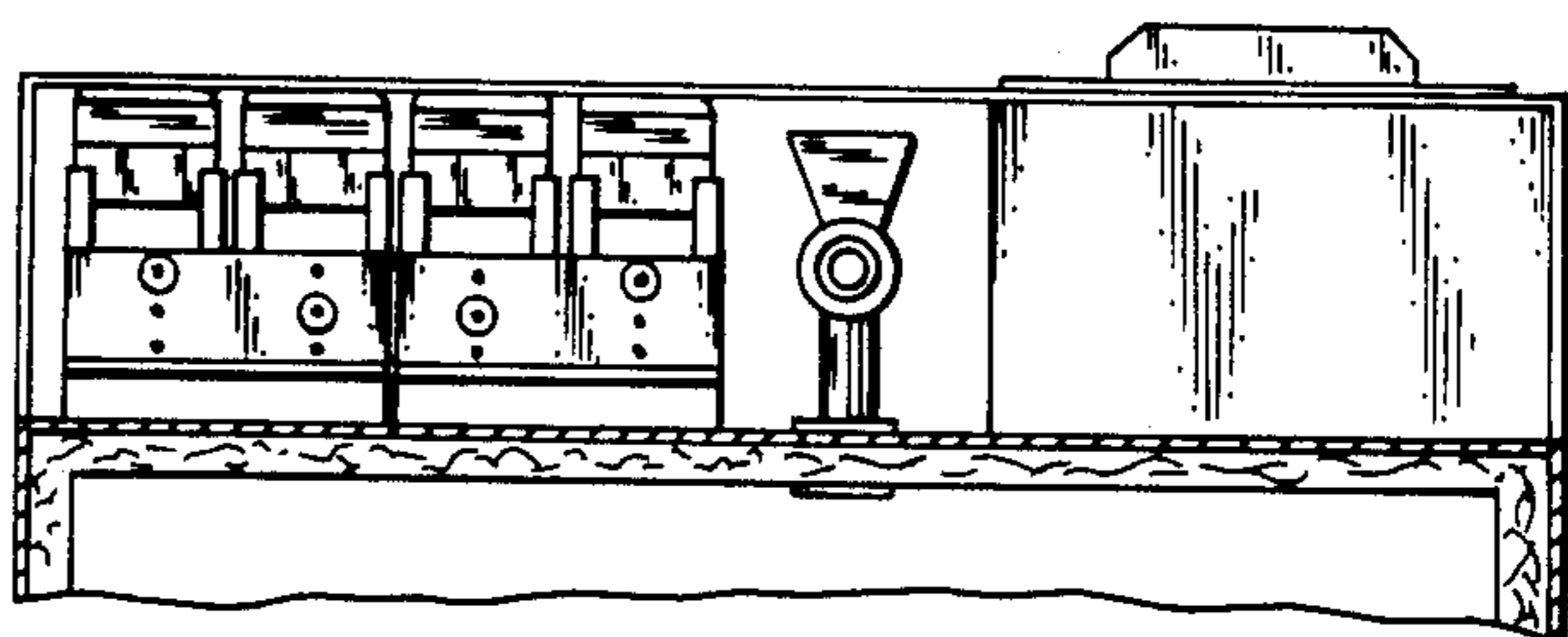

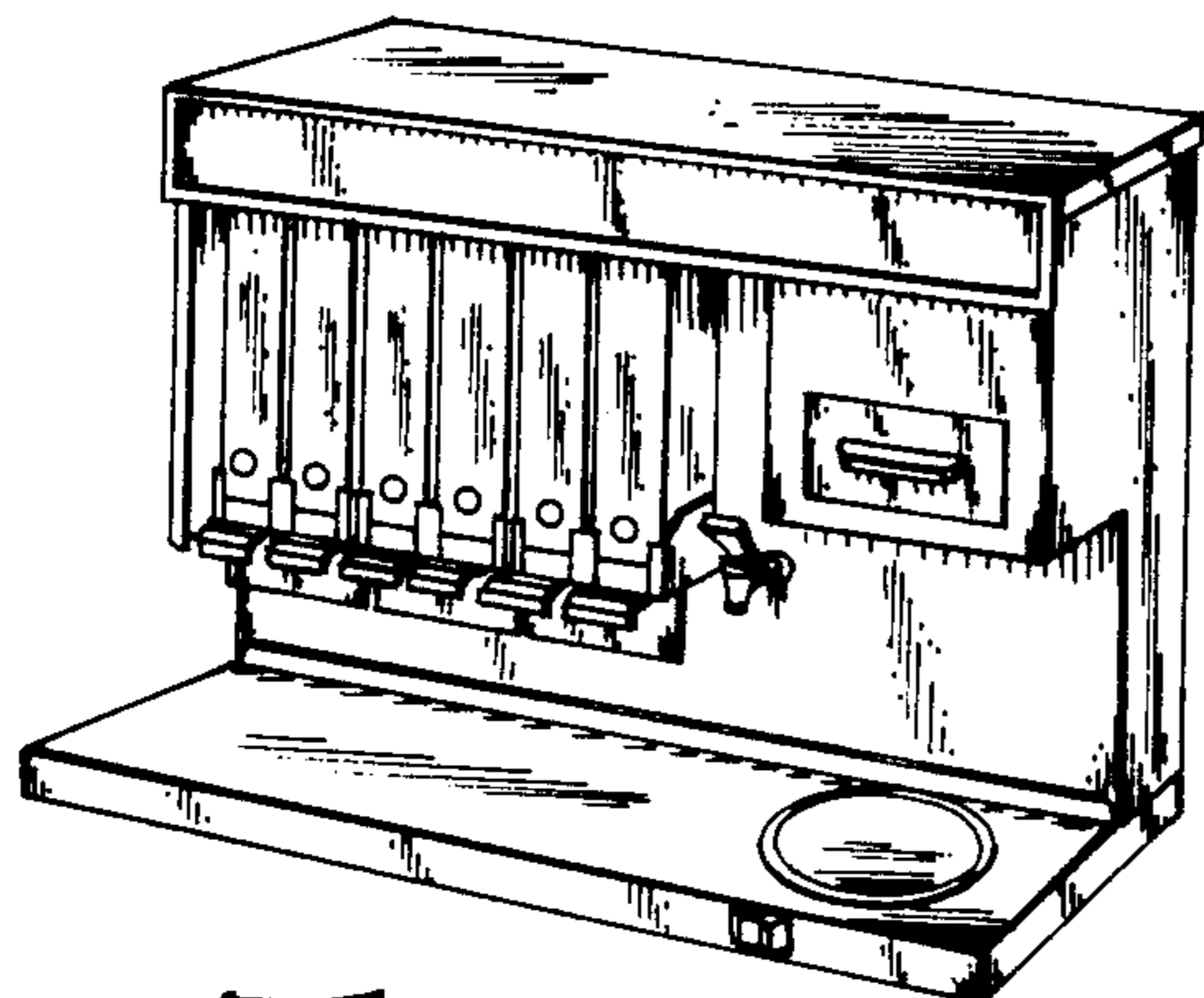

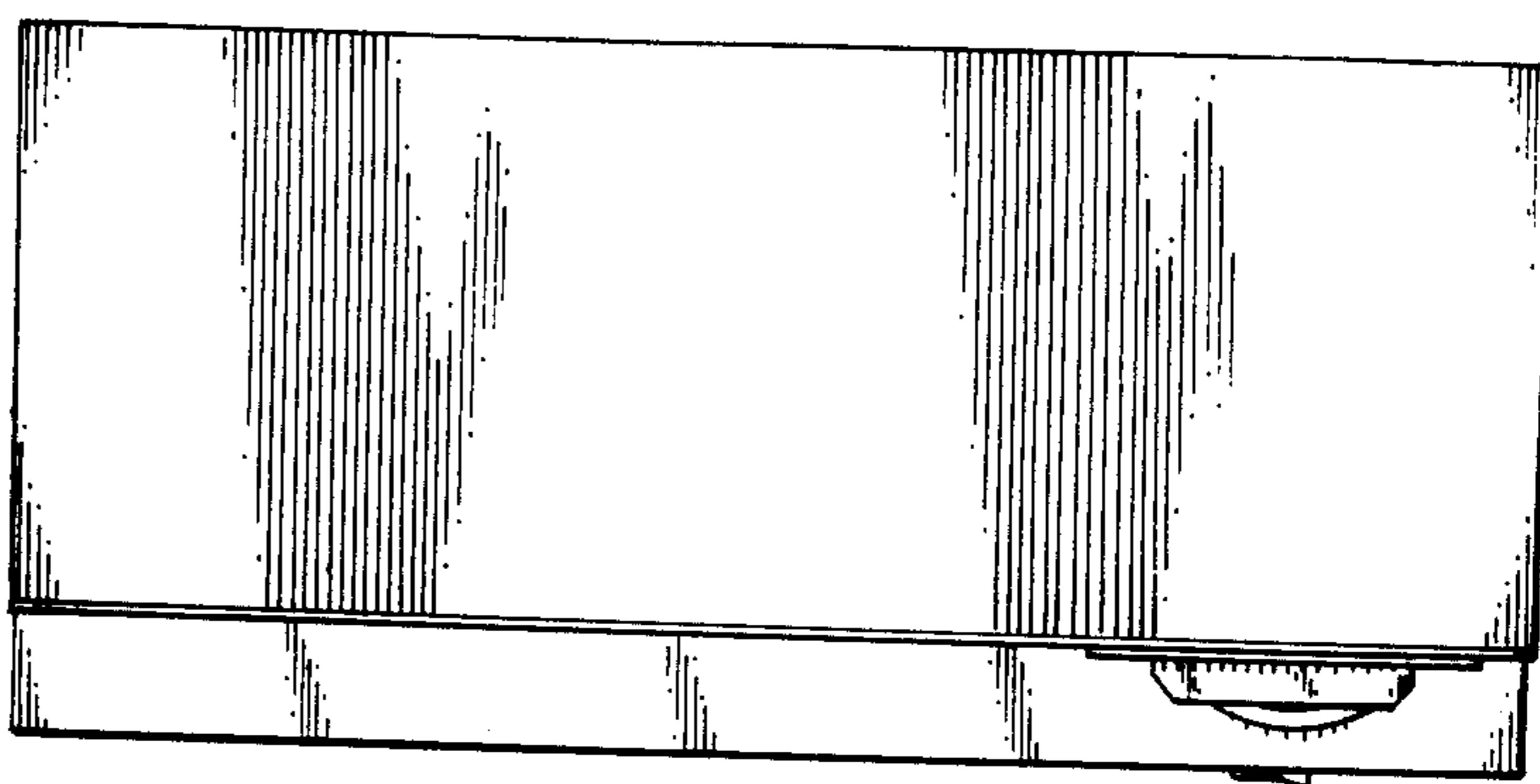

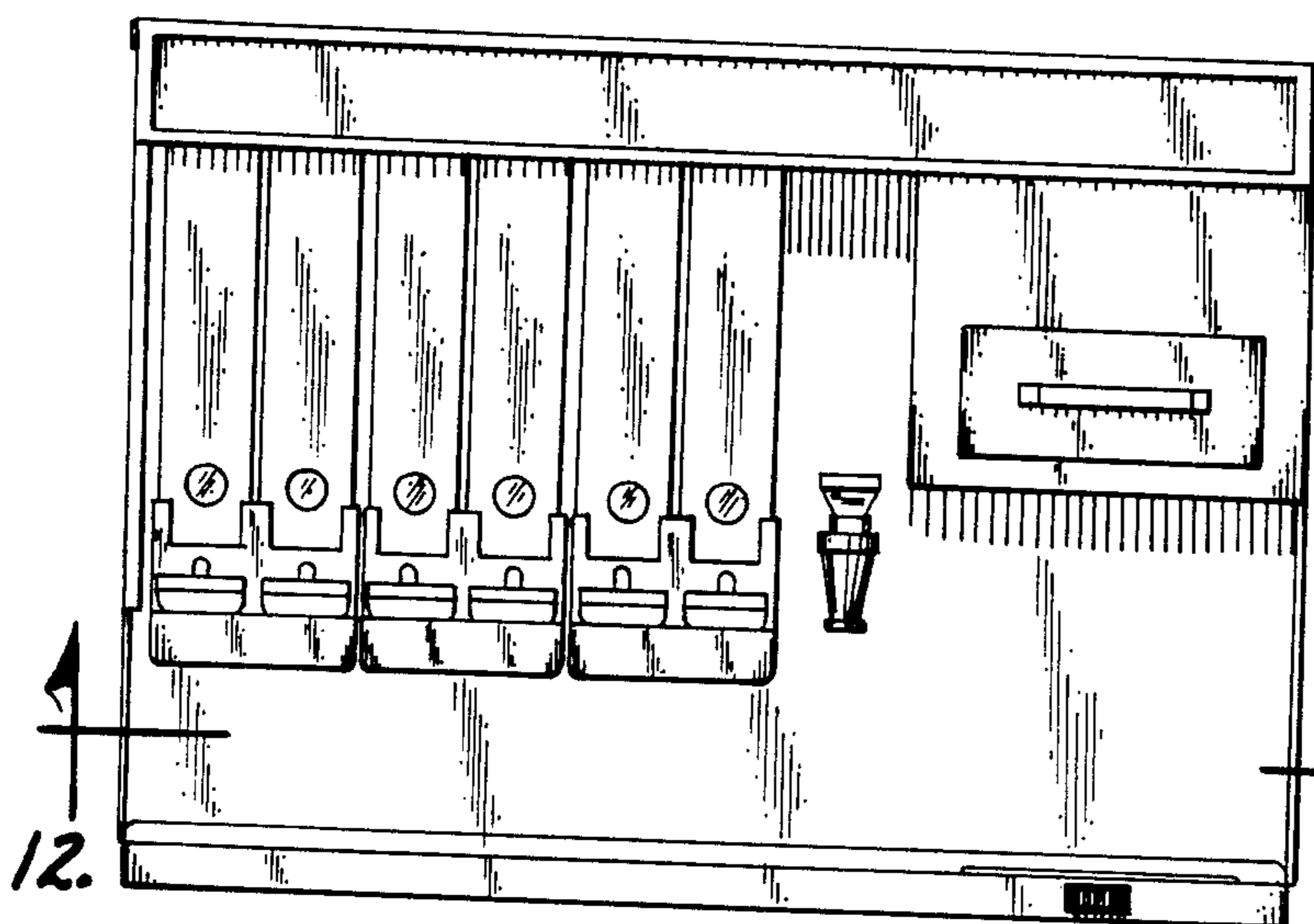

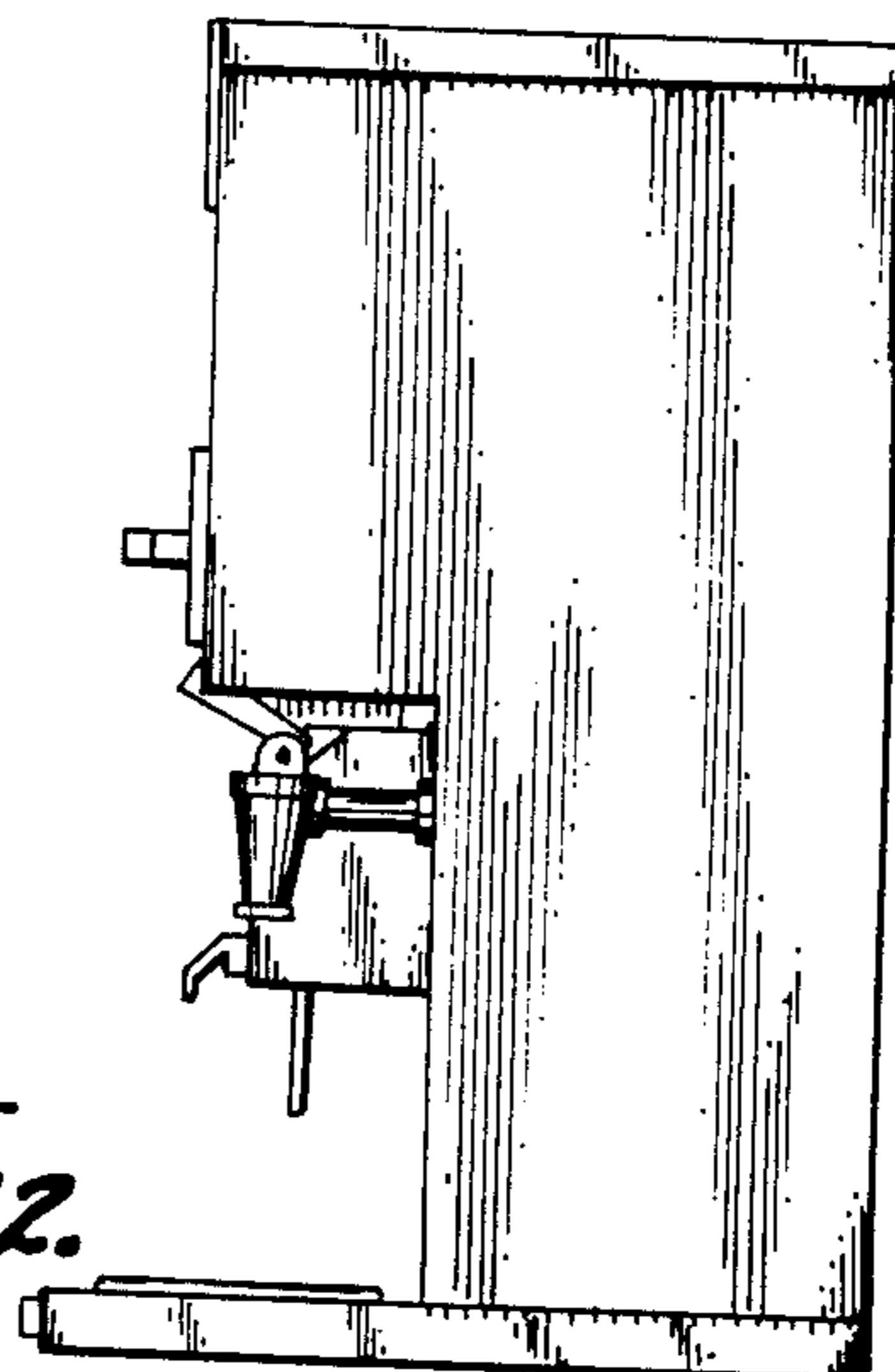

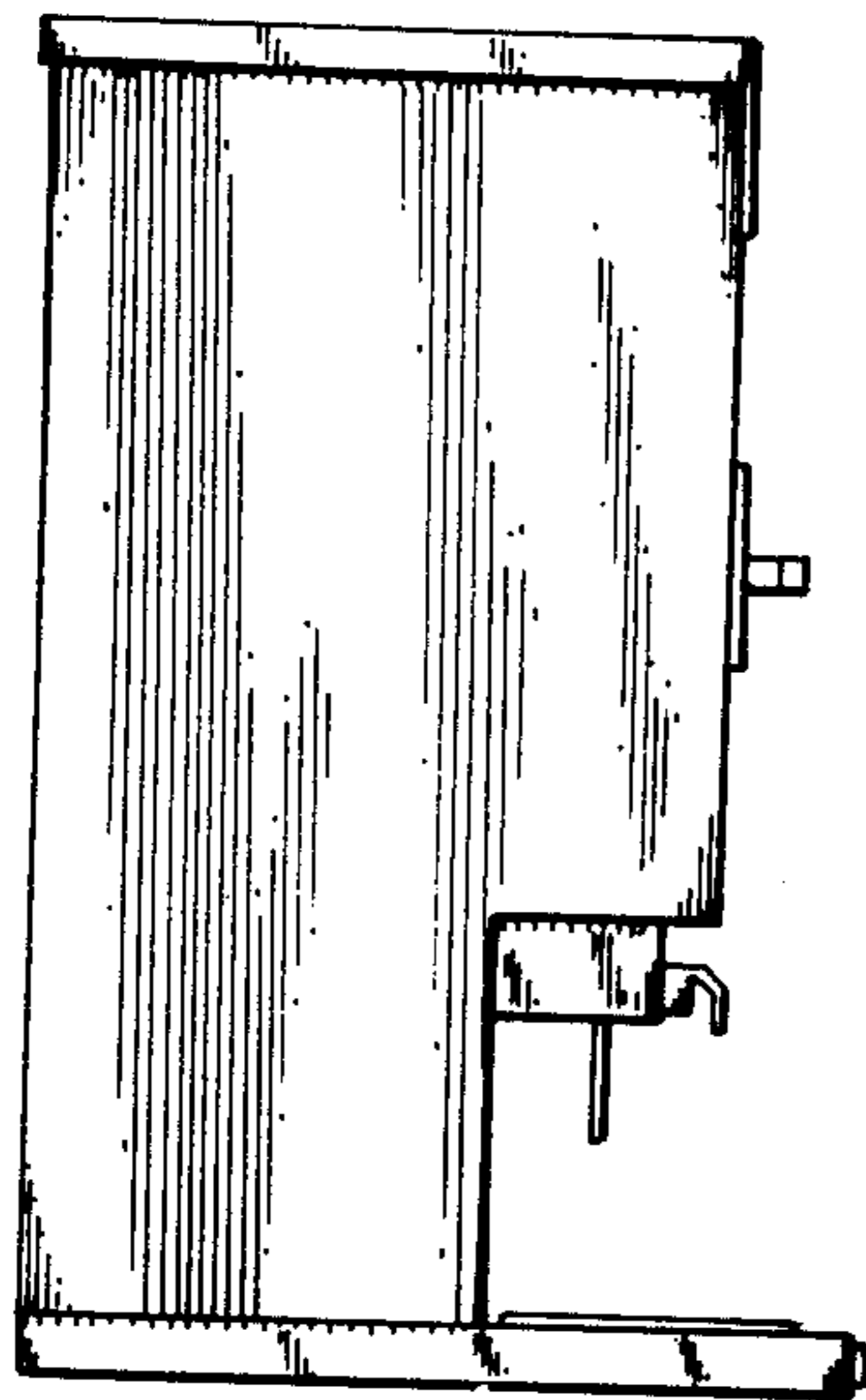

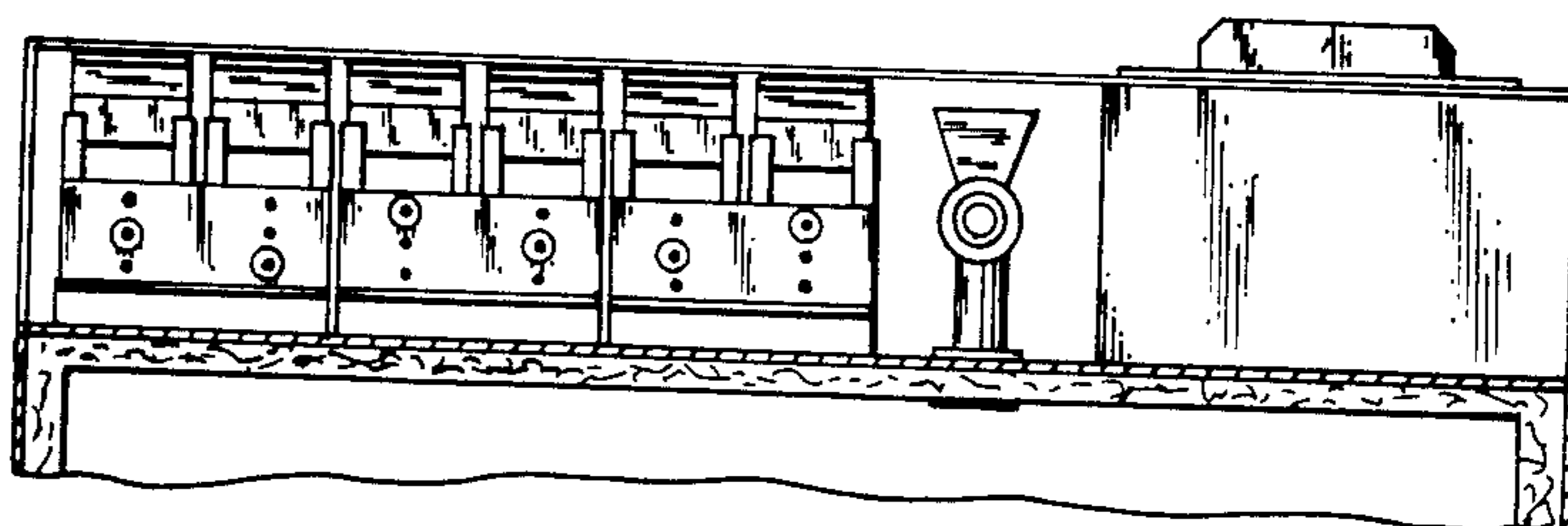
