FIG. 1 is a perspective view of cover for solenoid operated pilot valve showing our new design;

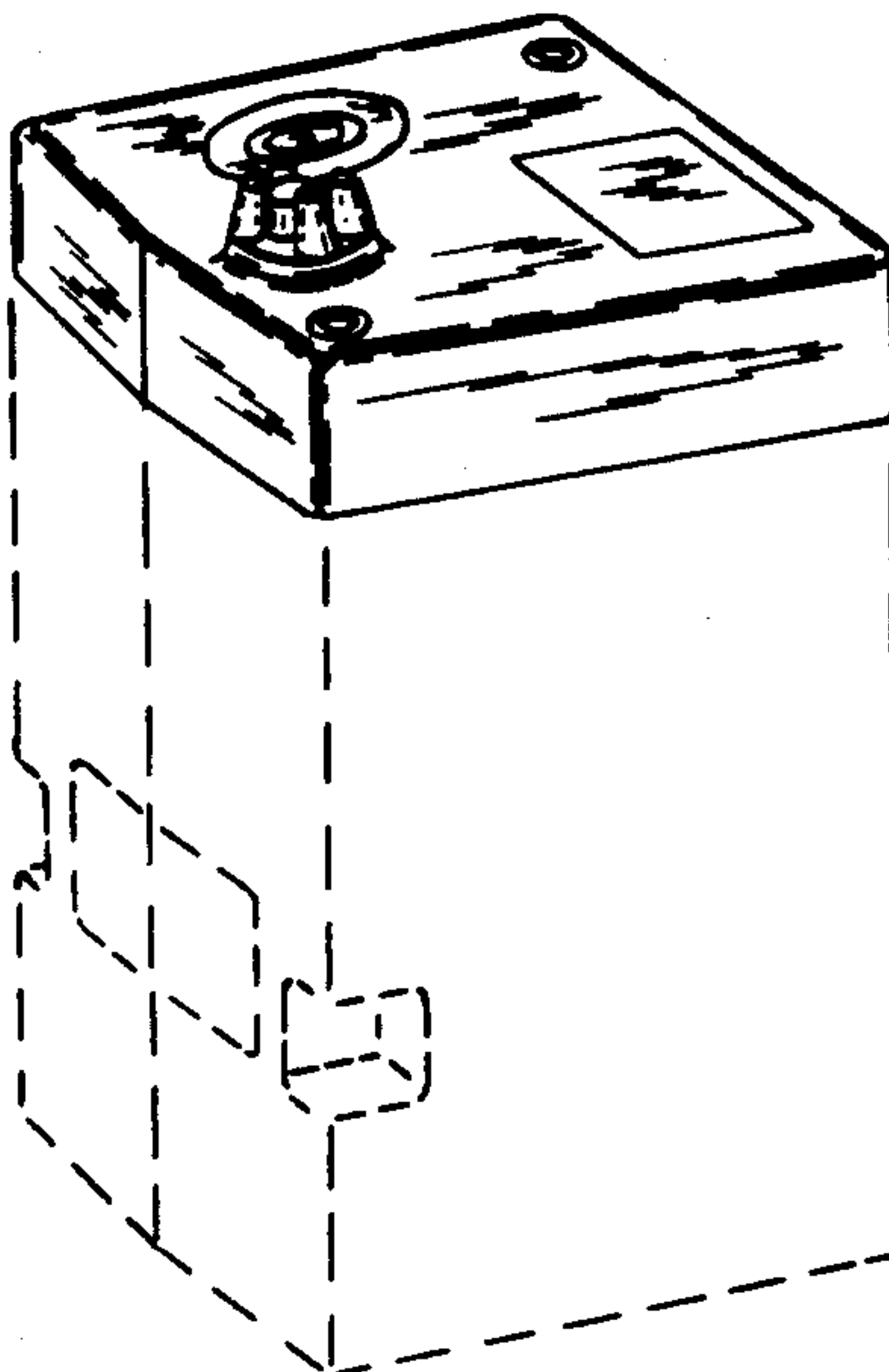
FIG. 2 is a front elevational view thereof on an enlarged scale;

The pilot valve is shown in broken lines for illustrative purposes only.



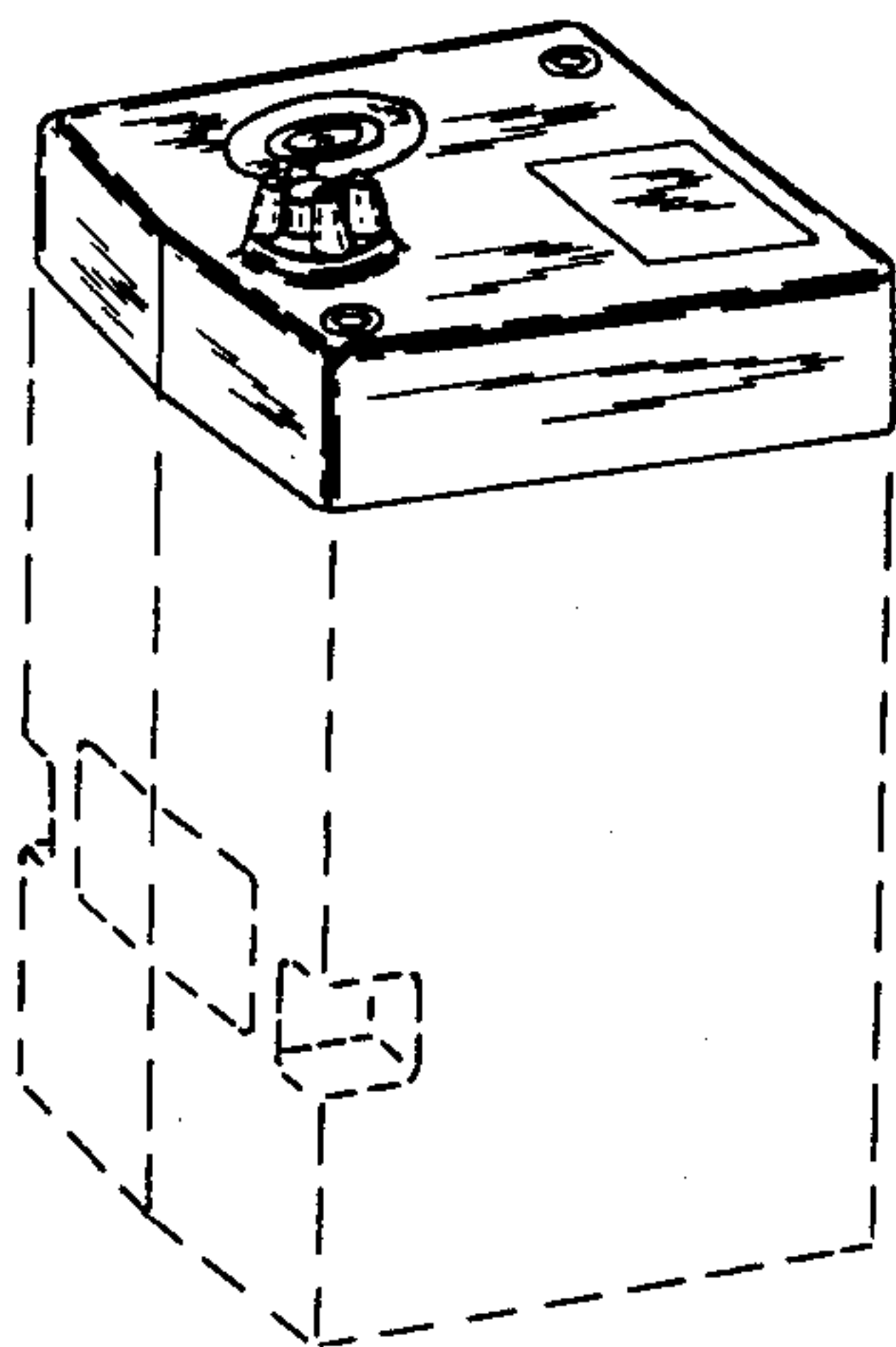

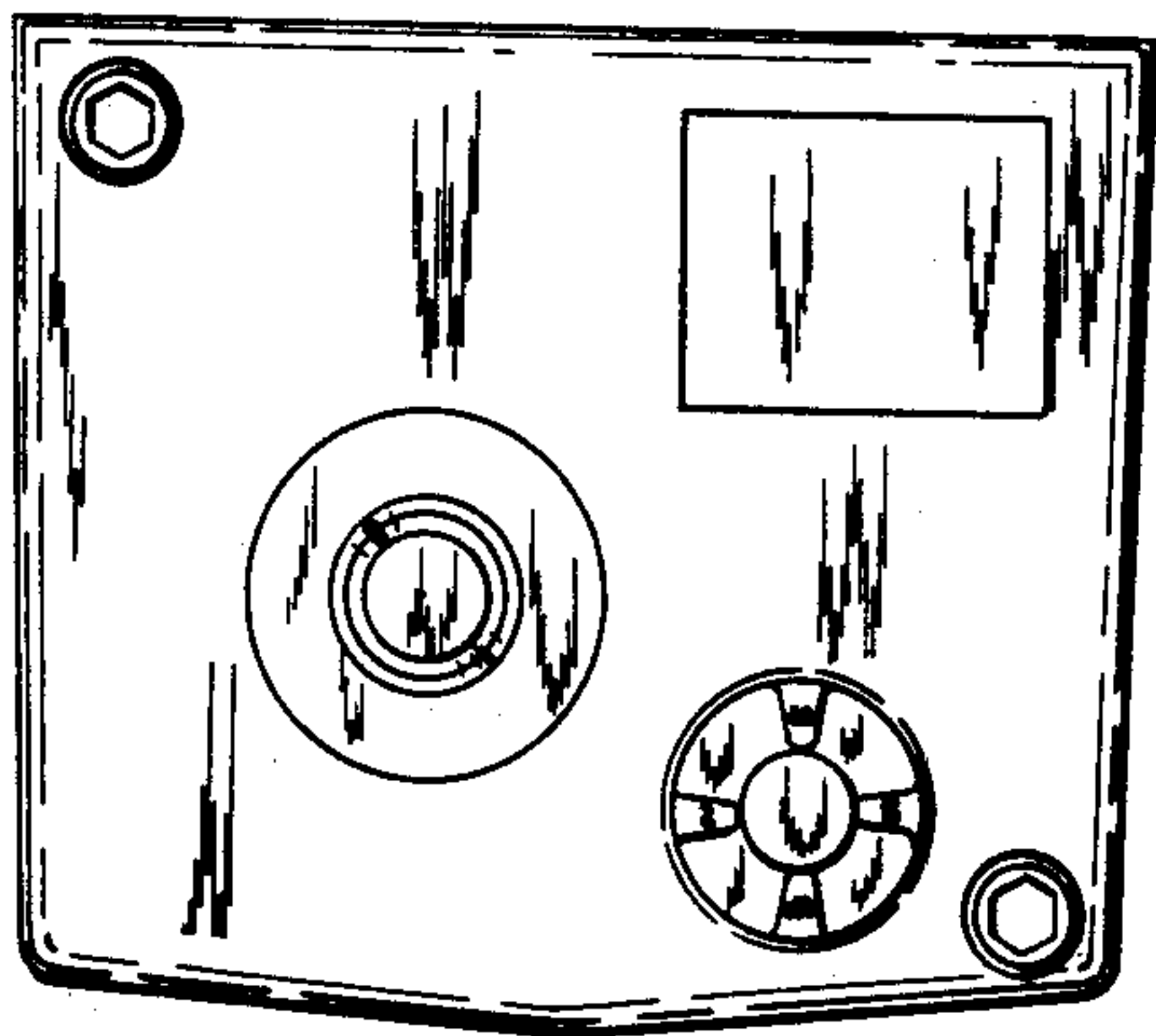

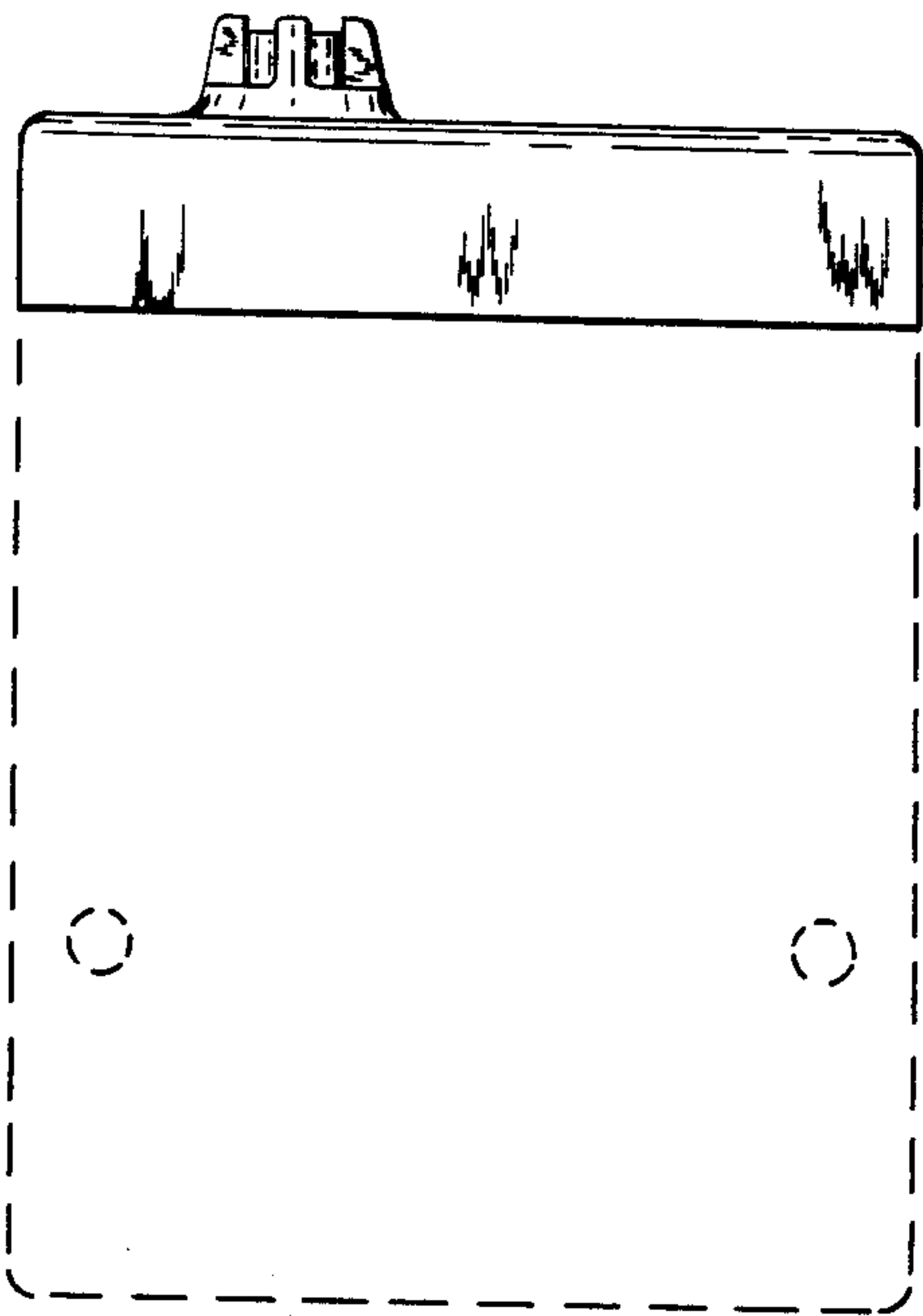

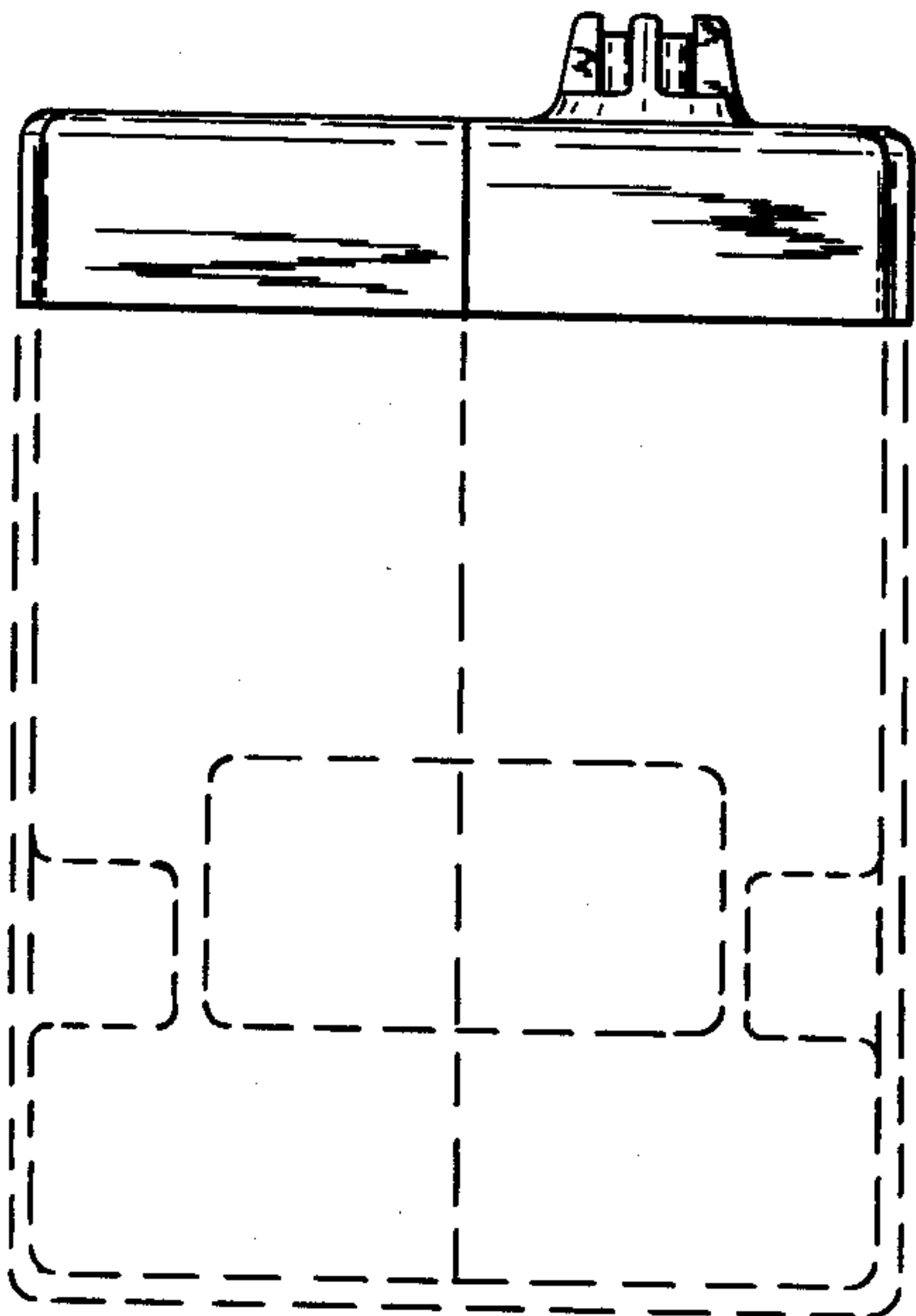

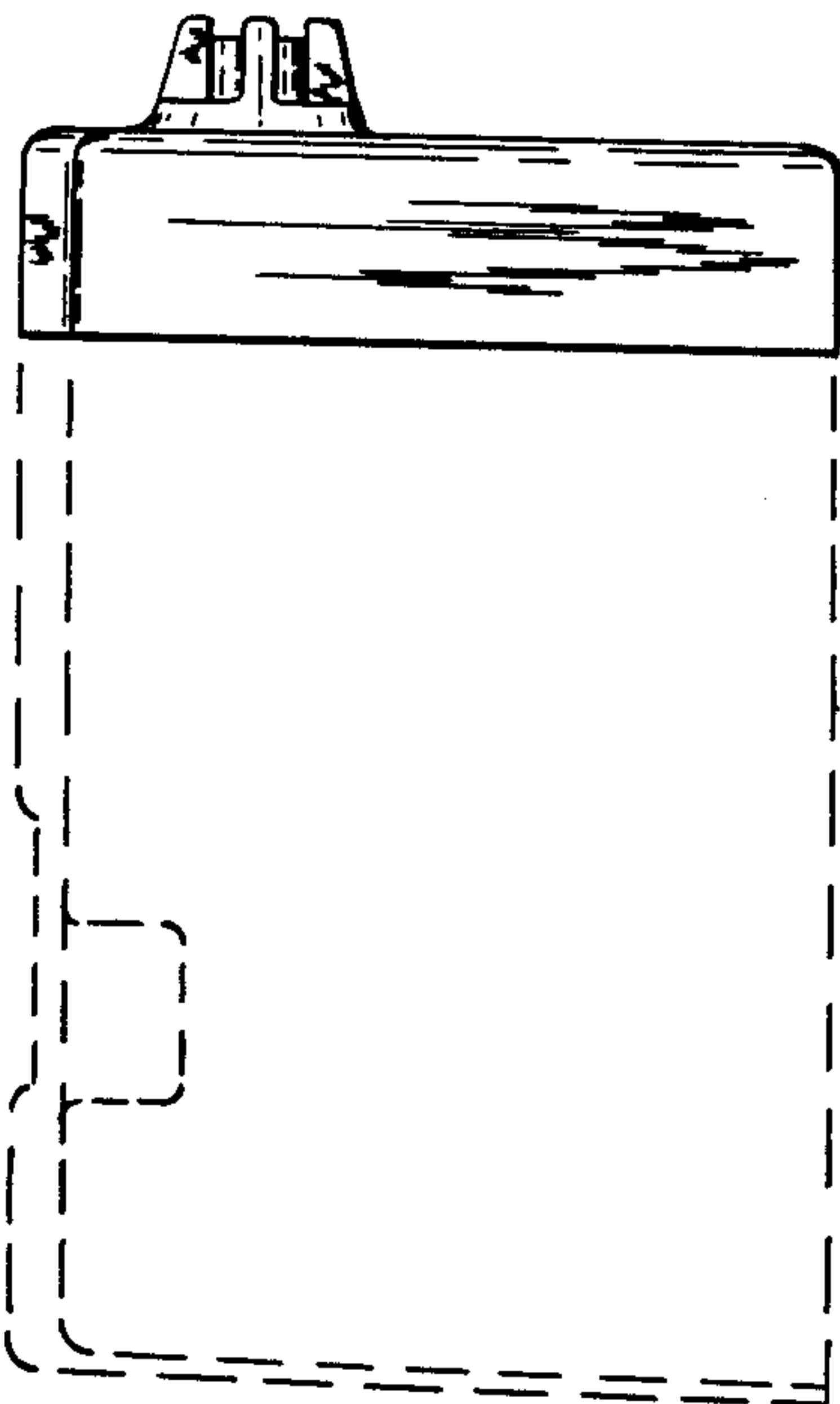
