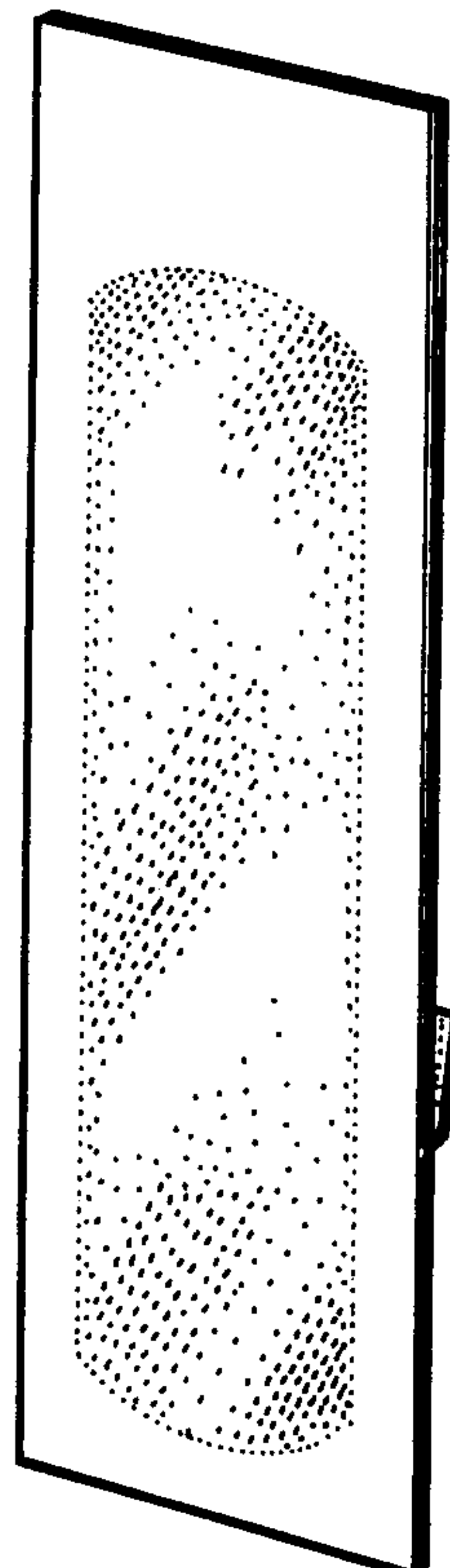
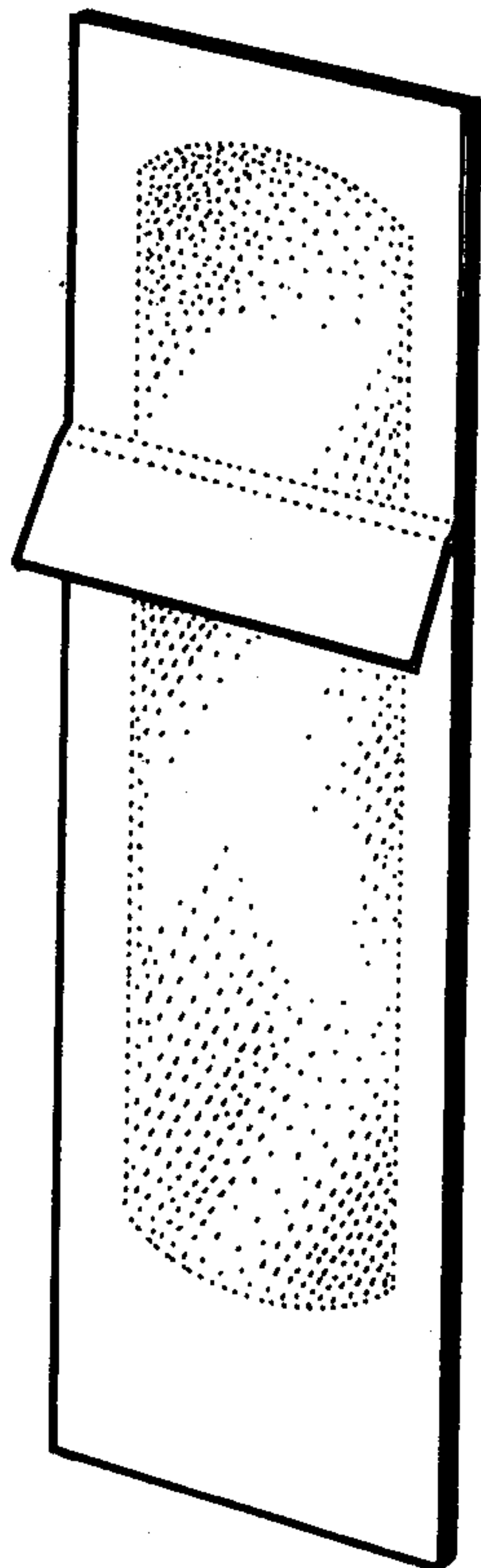

DESCRIPTION

 FIG. 18 is a rear perspective view thereof.



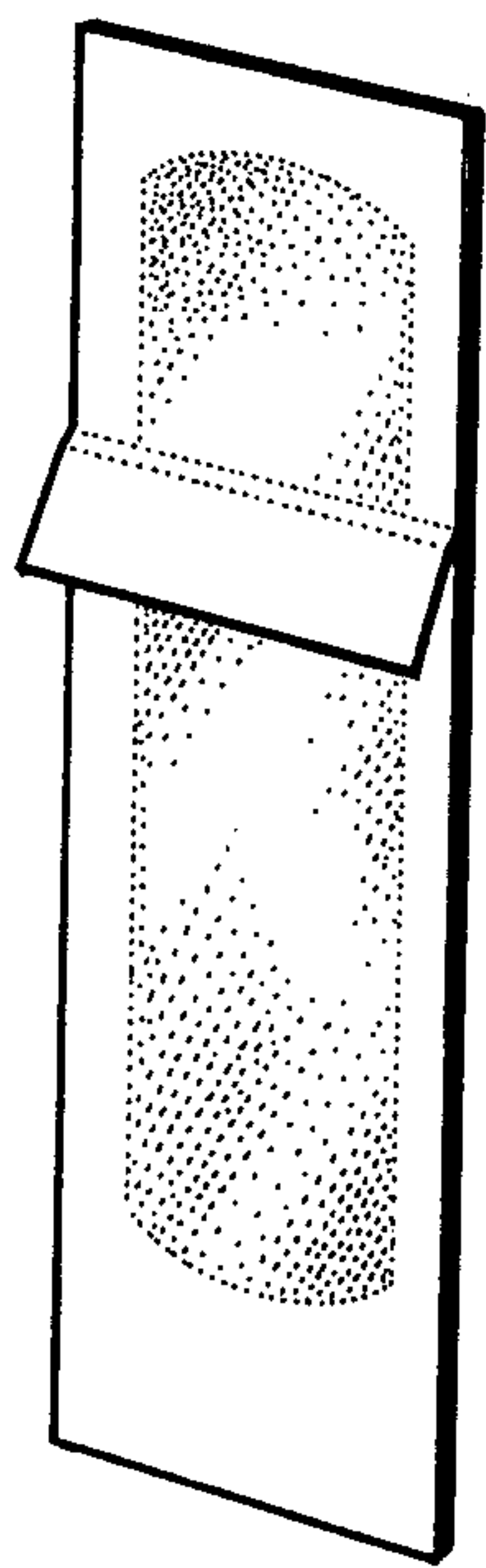

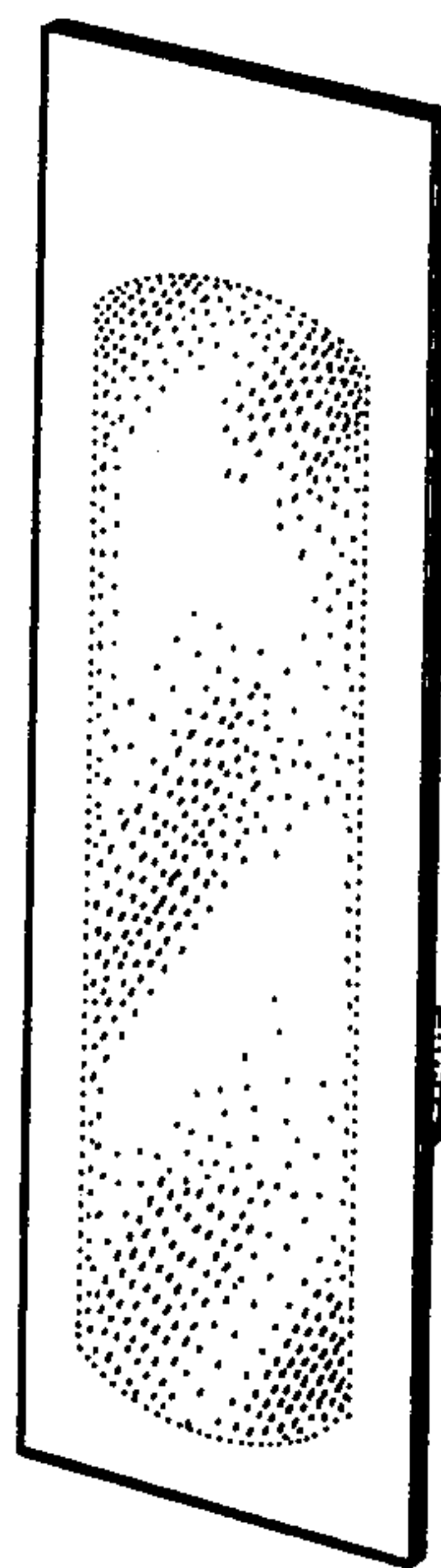

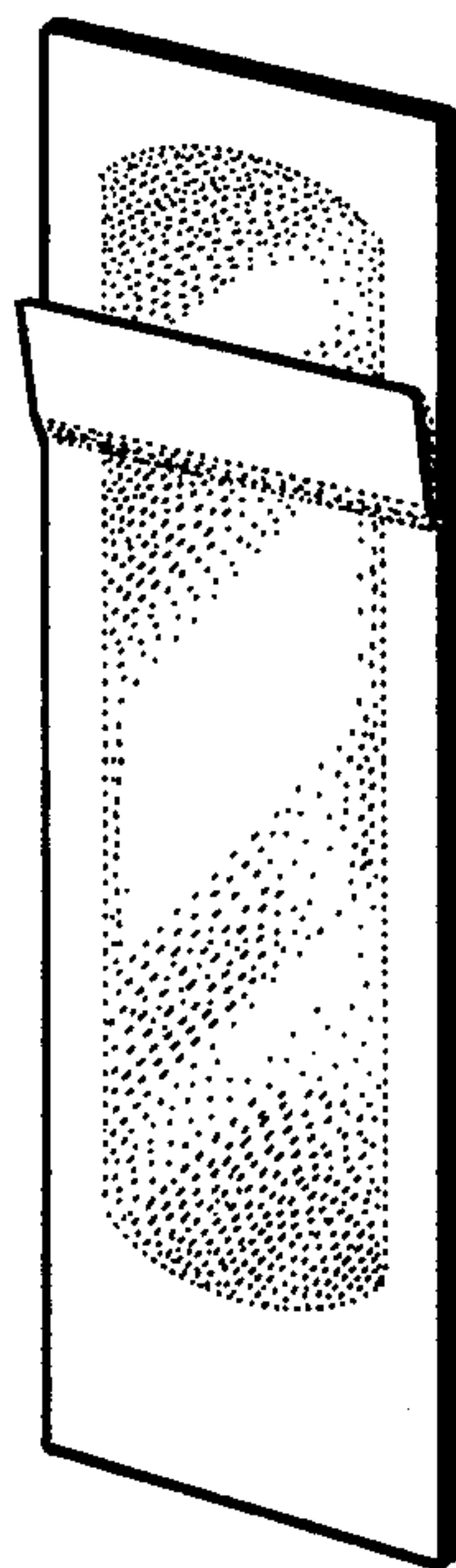

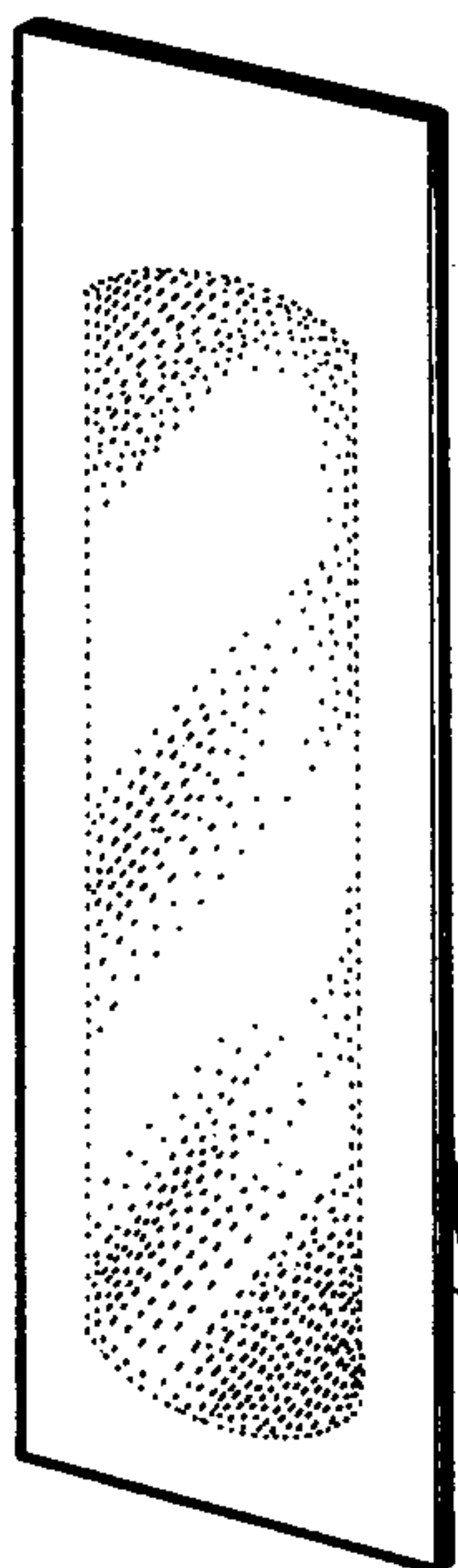

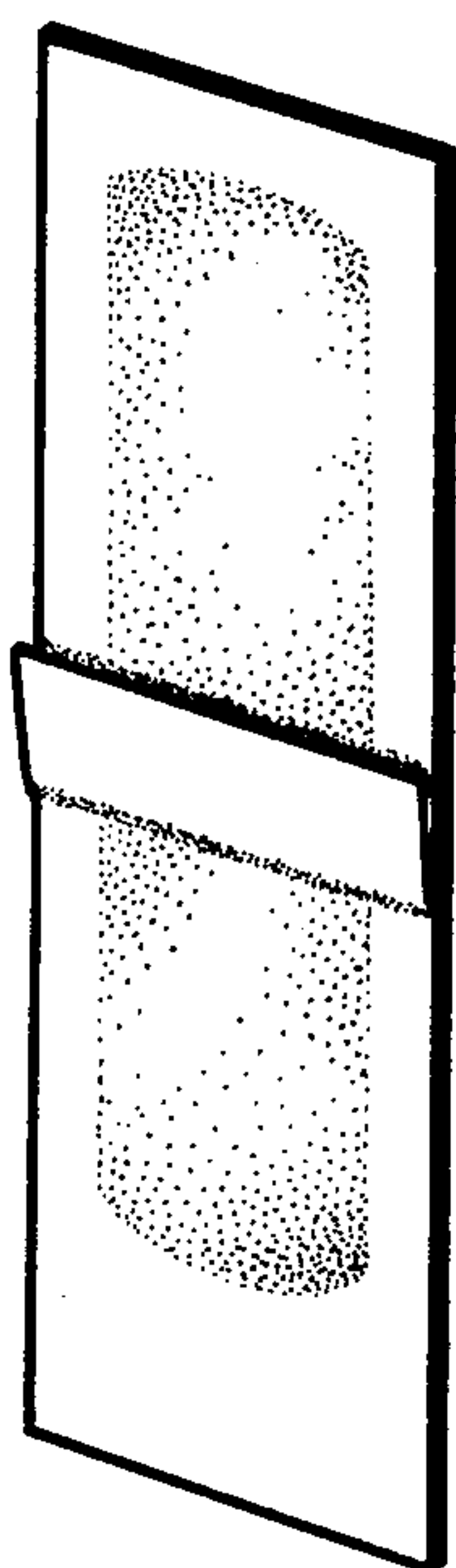

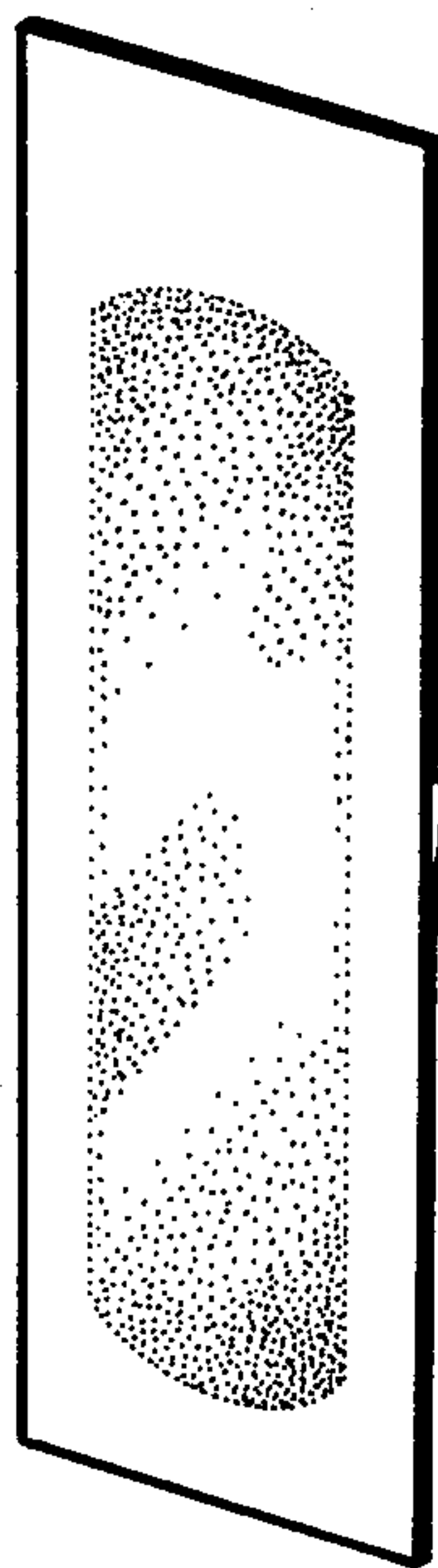

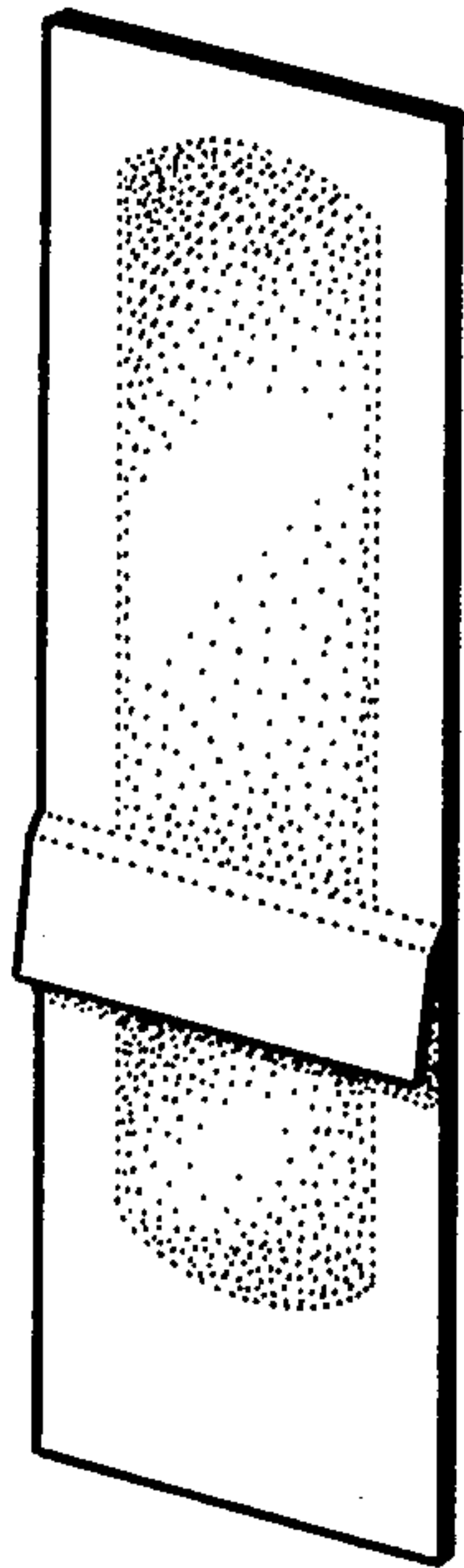

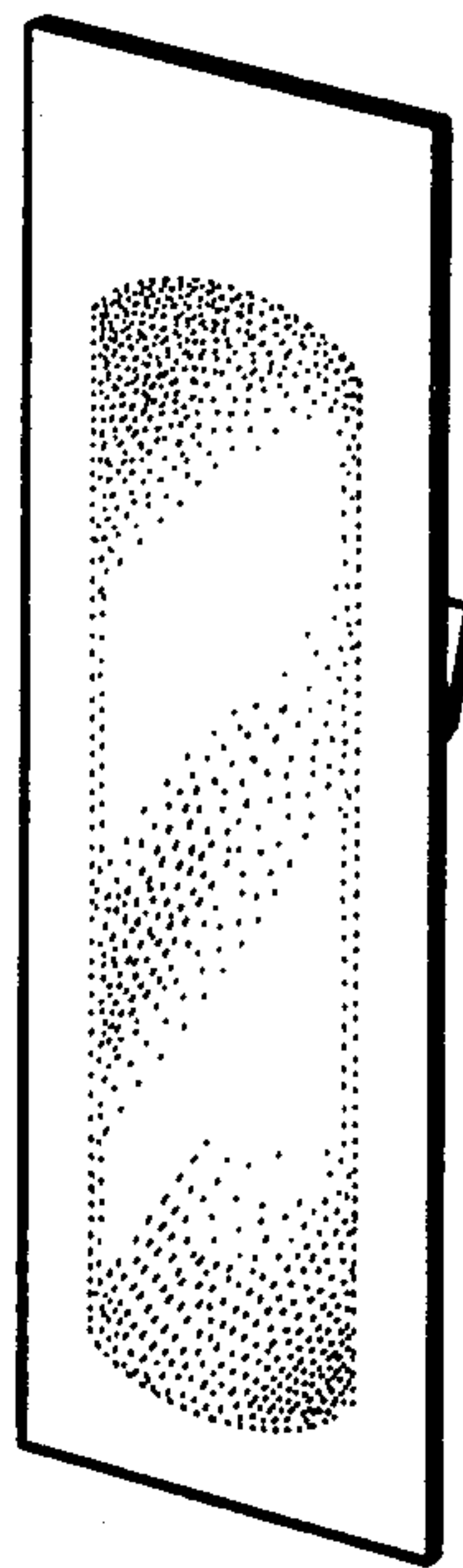

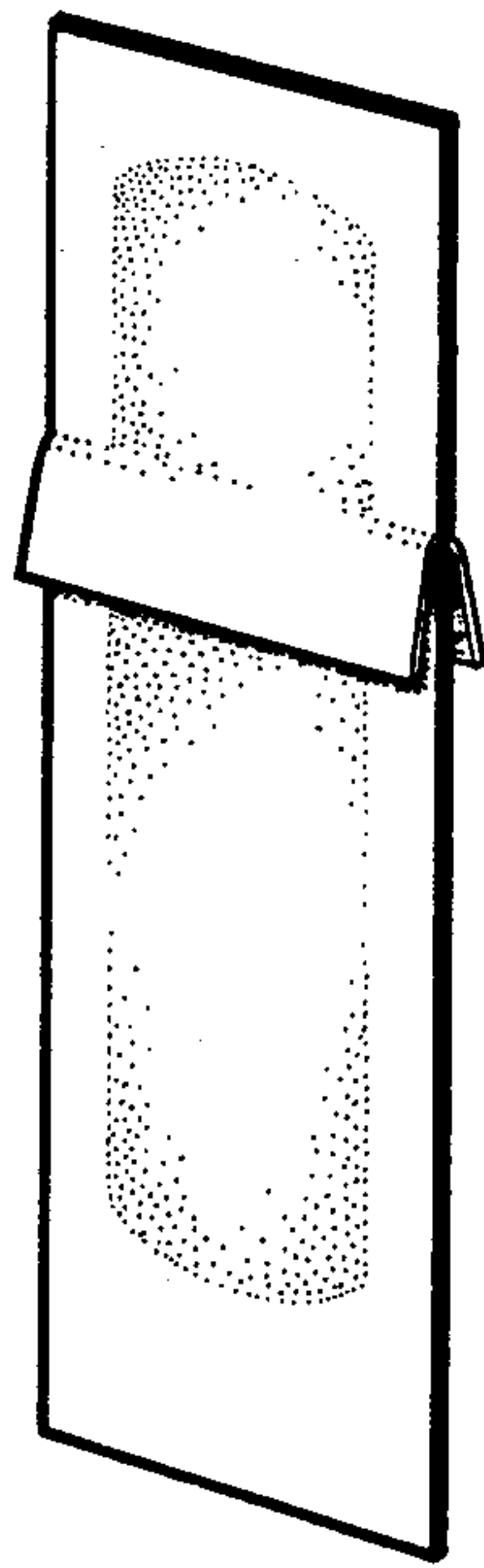

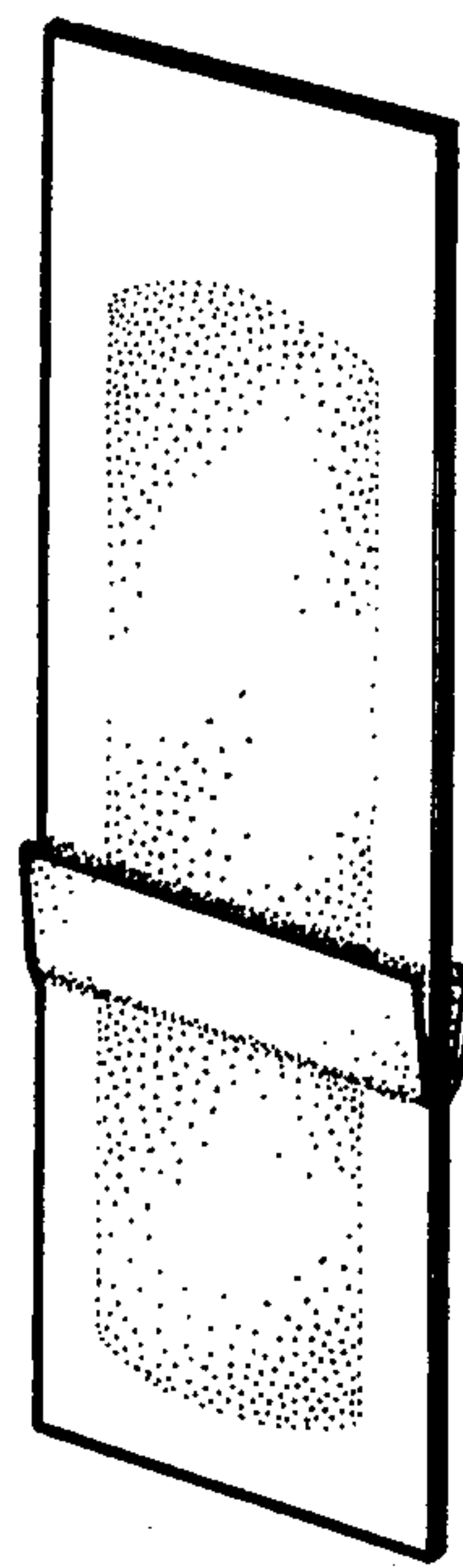

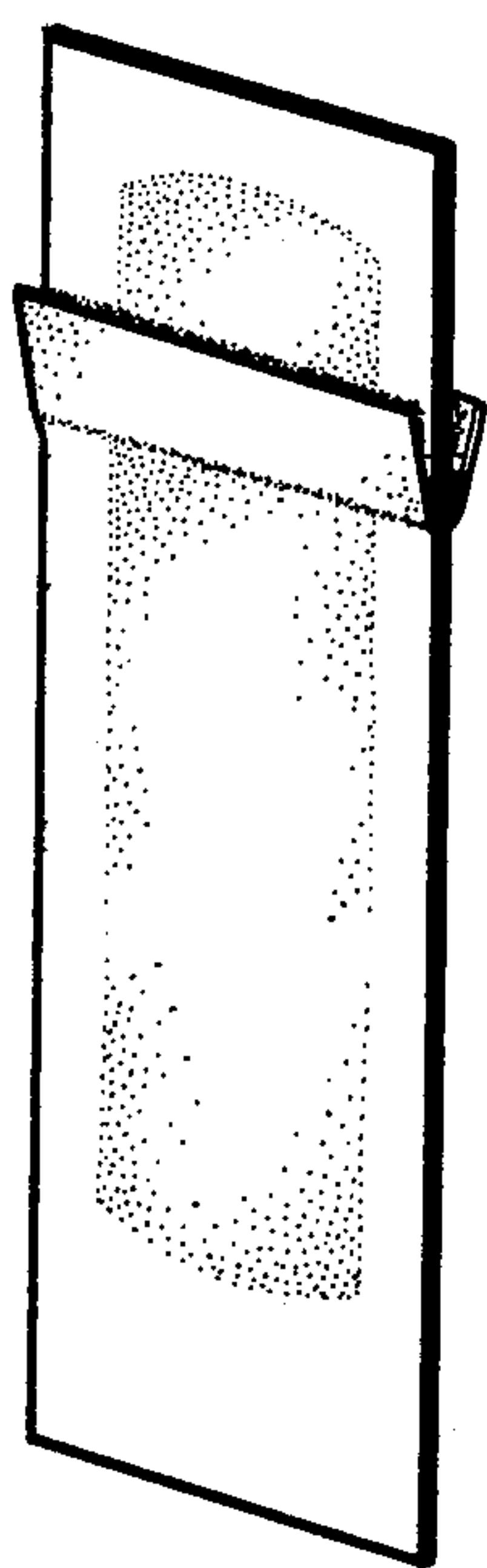

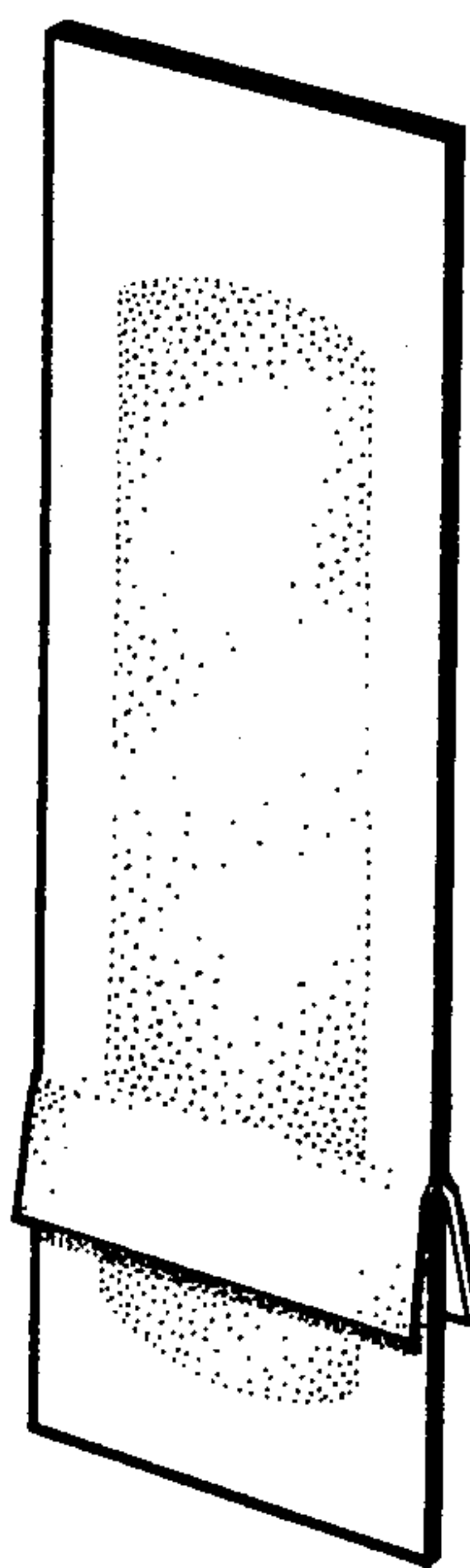

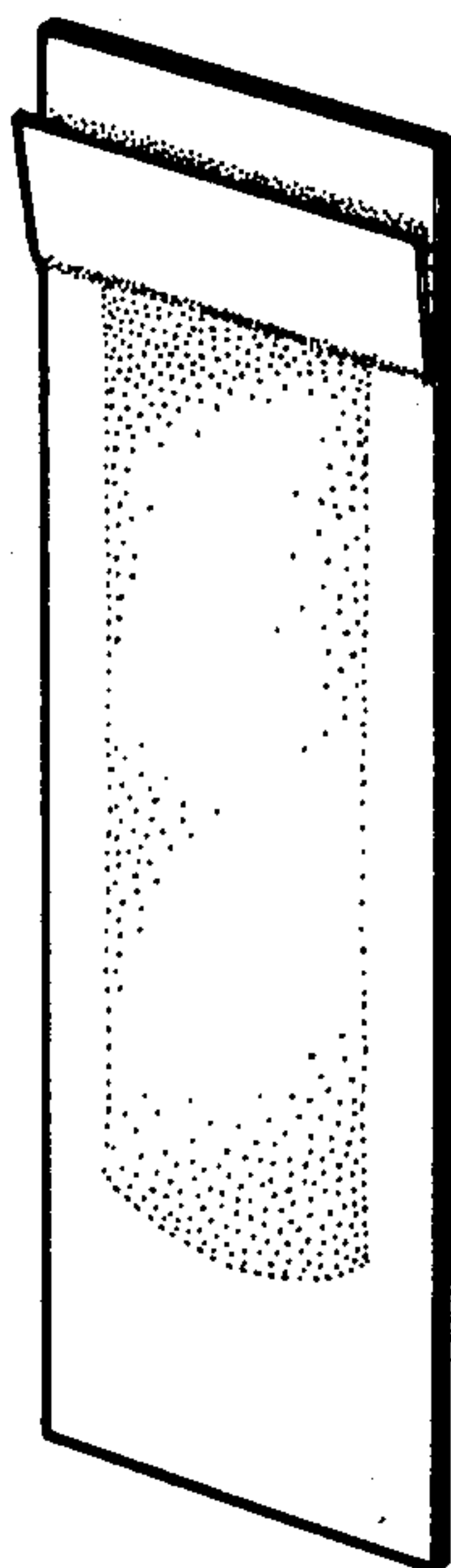

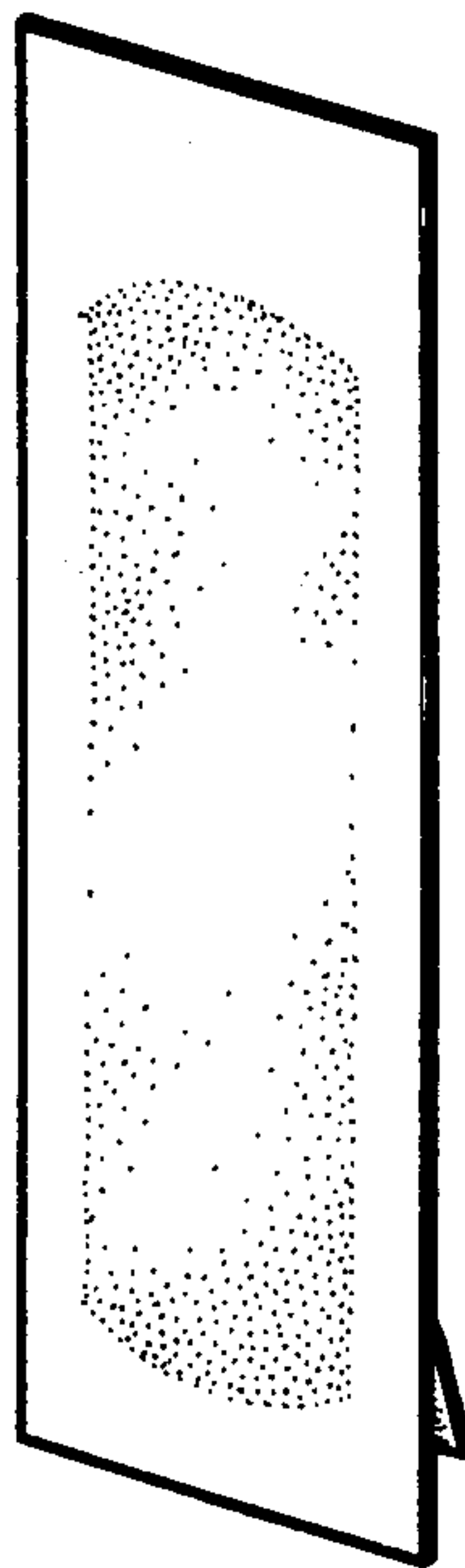

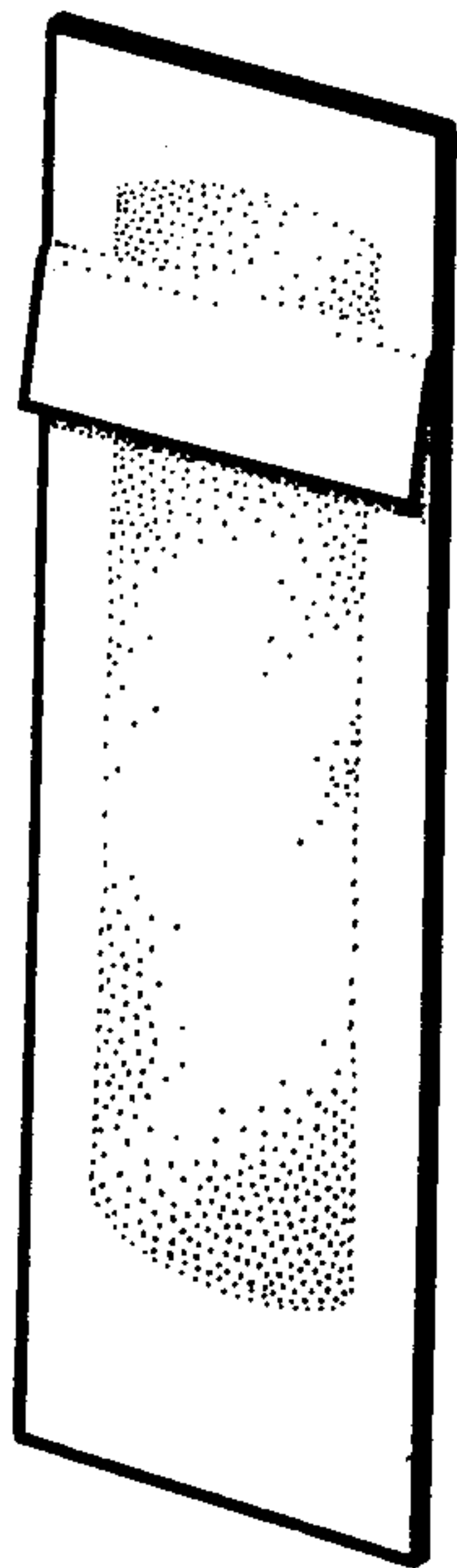

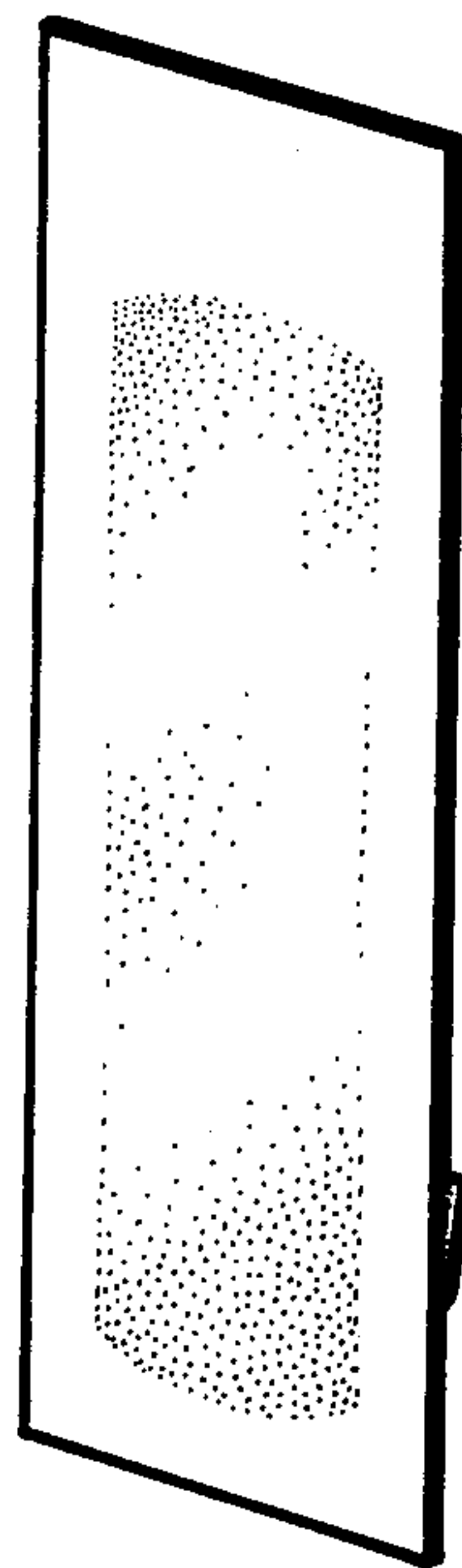

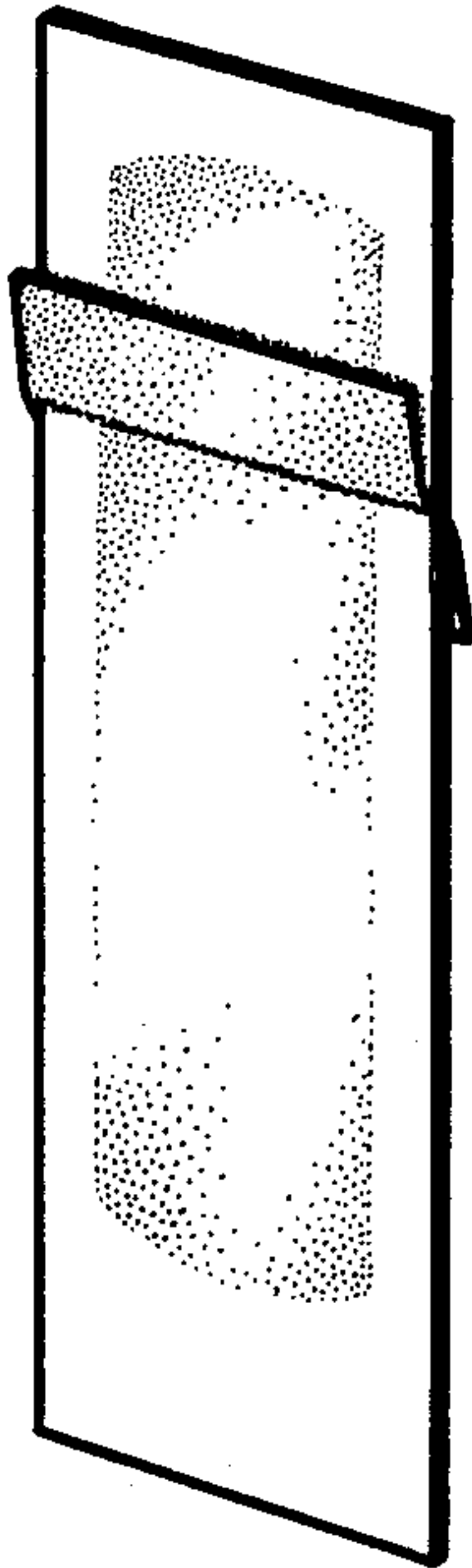
