image of its laterally opposite side;  
FIG. 8 is a bottom plan view of the rechargeable bat-  
tery pack illustrated in FIGS. 6 and 7;  
FIG. 9 is a left end elevation view of the rechargeable  
battery pack illustrated in FIGS. 6, 7 and 8; and  
FIG. 10 is a right end elevation view of the recharge-  
able battery pack illustrated in FIGS. 6, 7, 8 and 9.

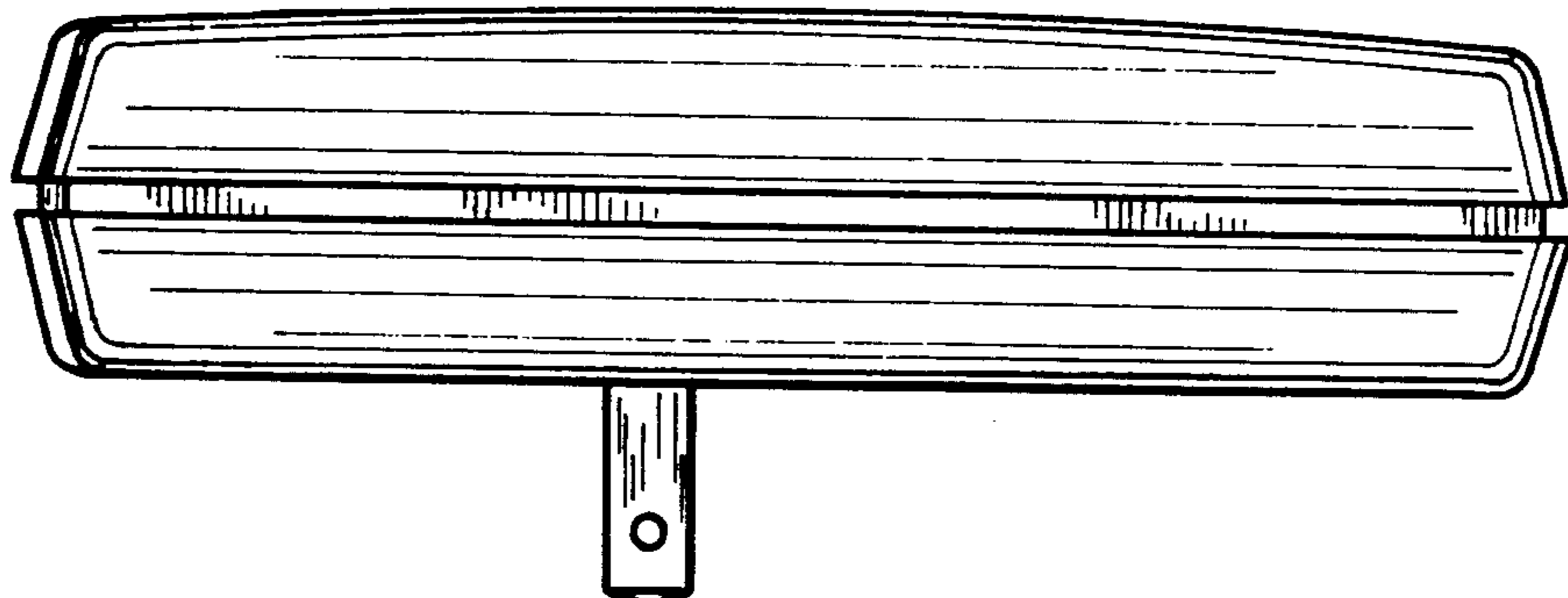
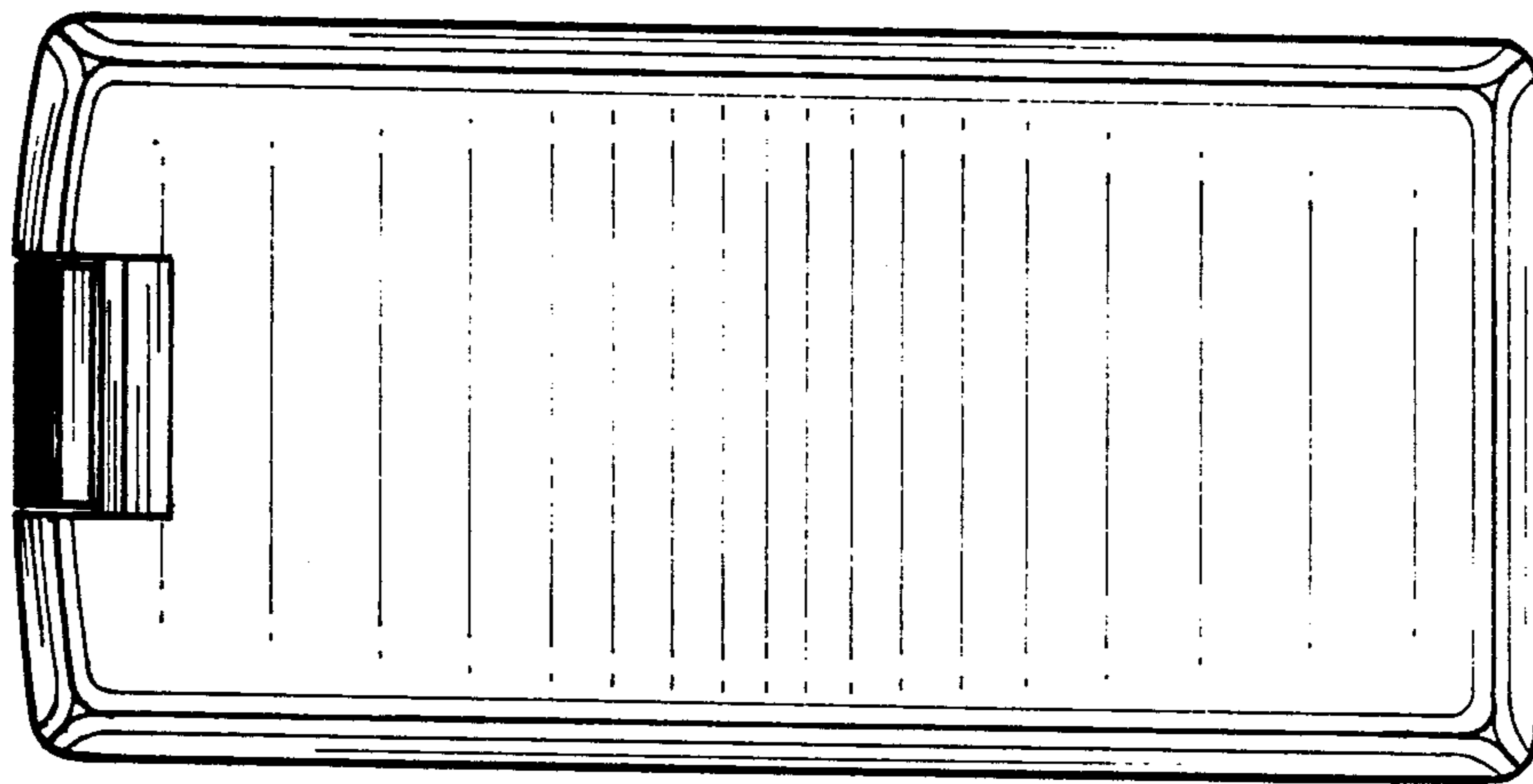

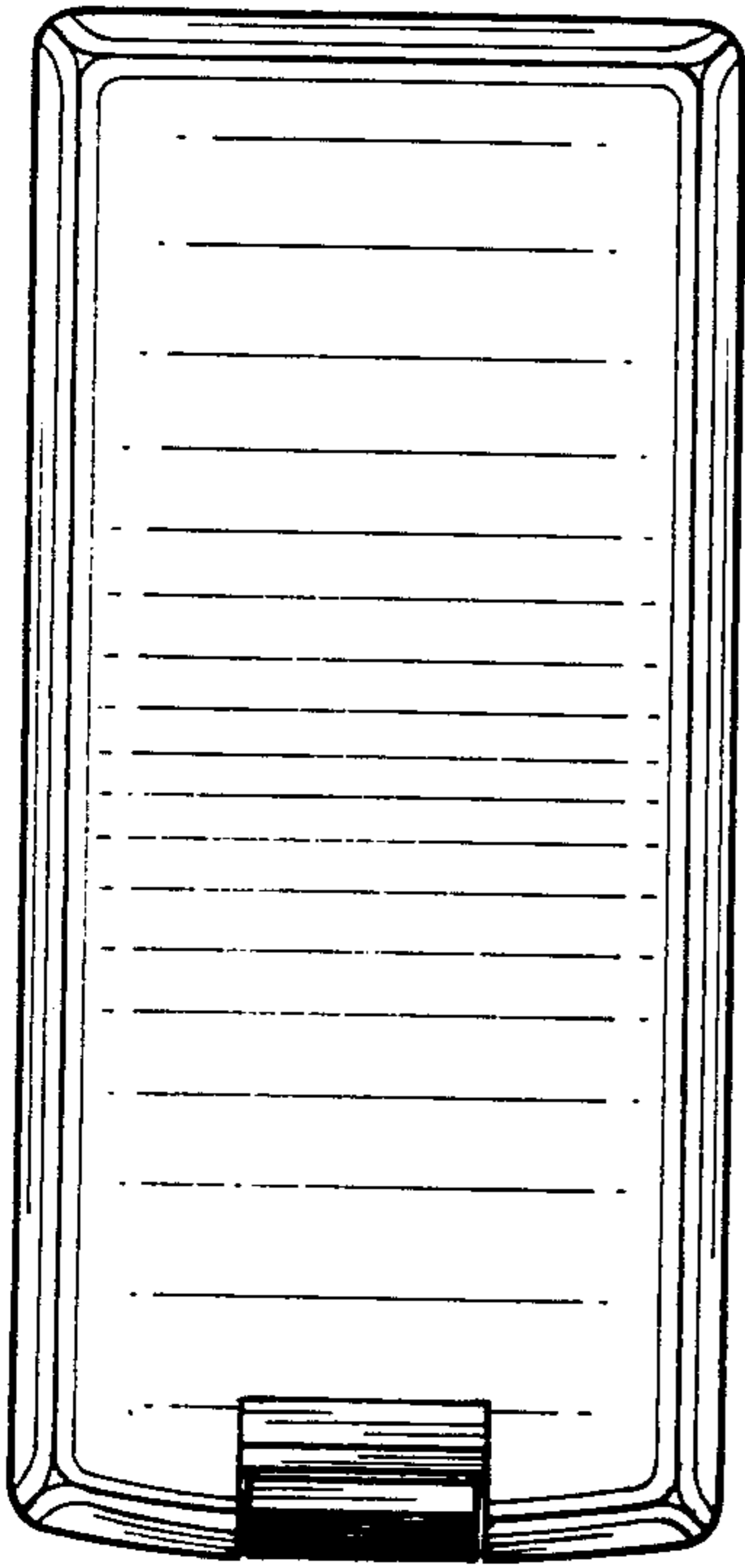

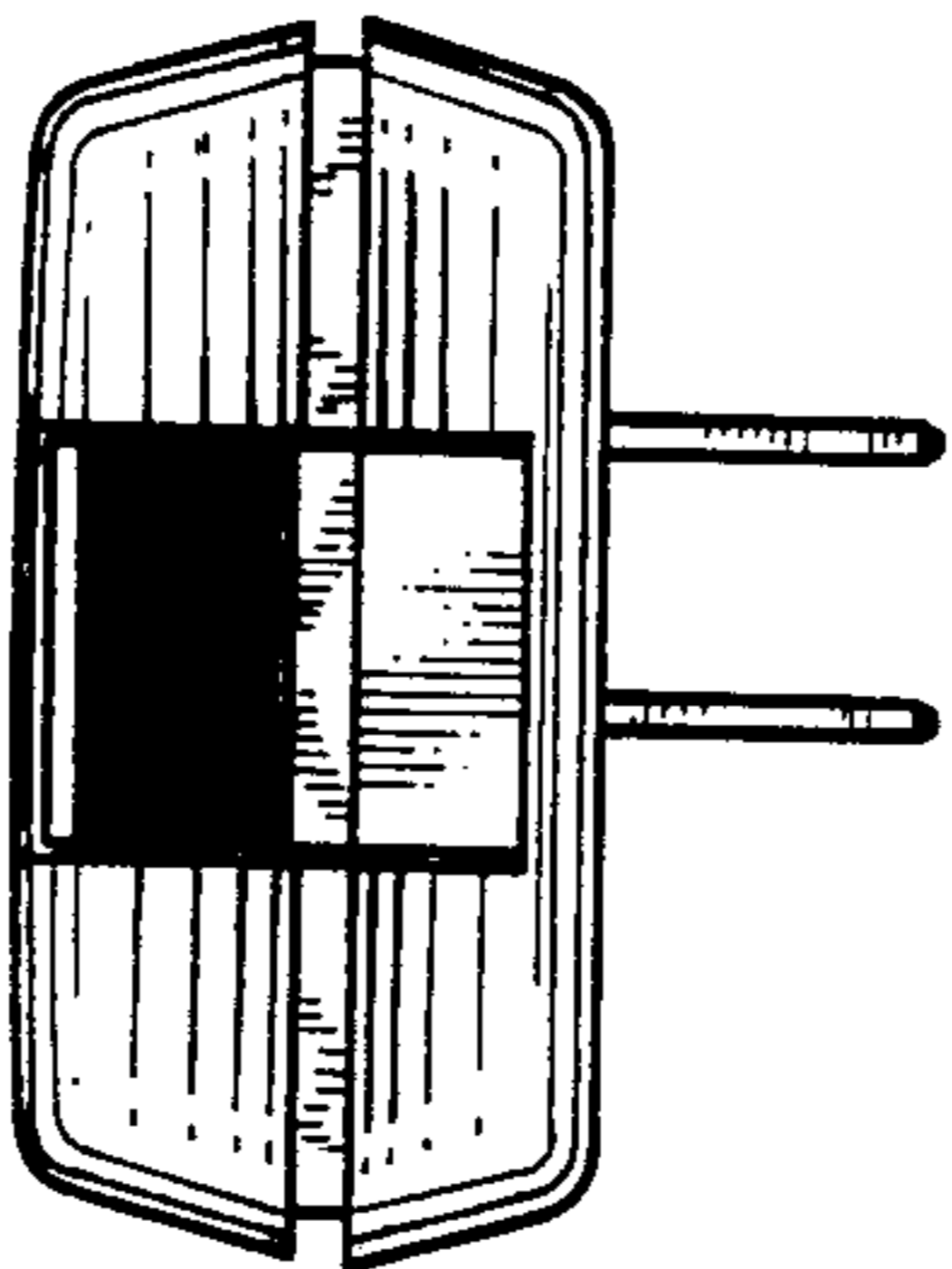

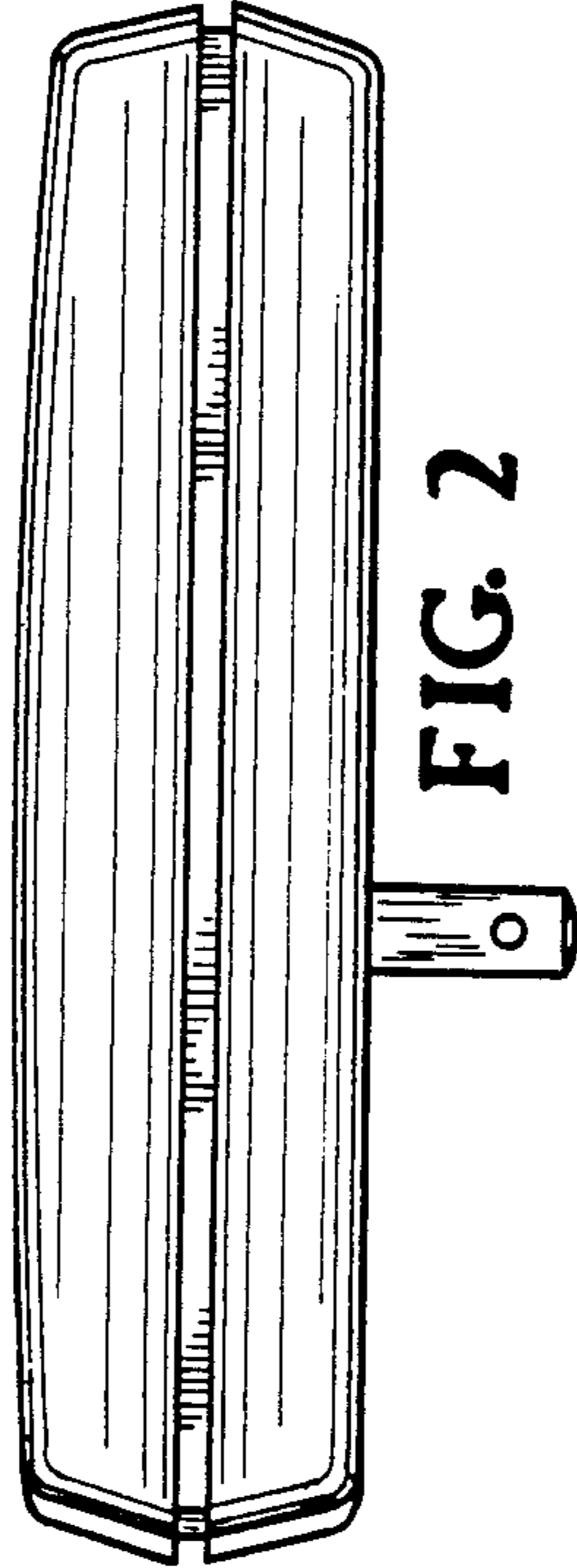

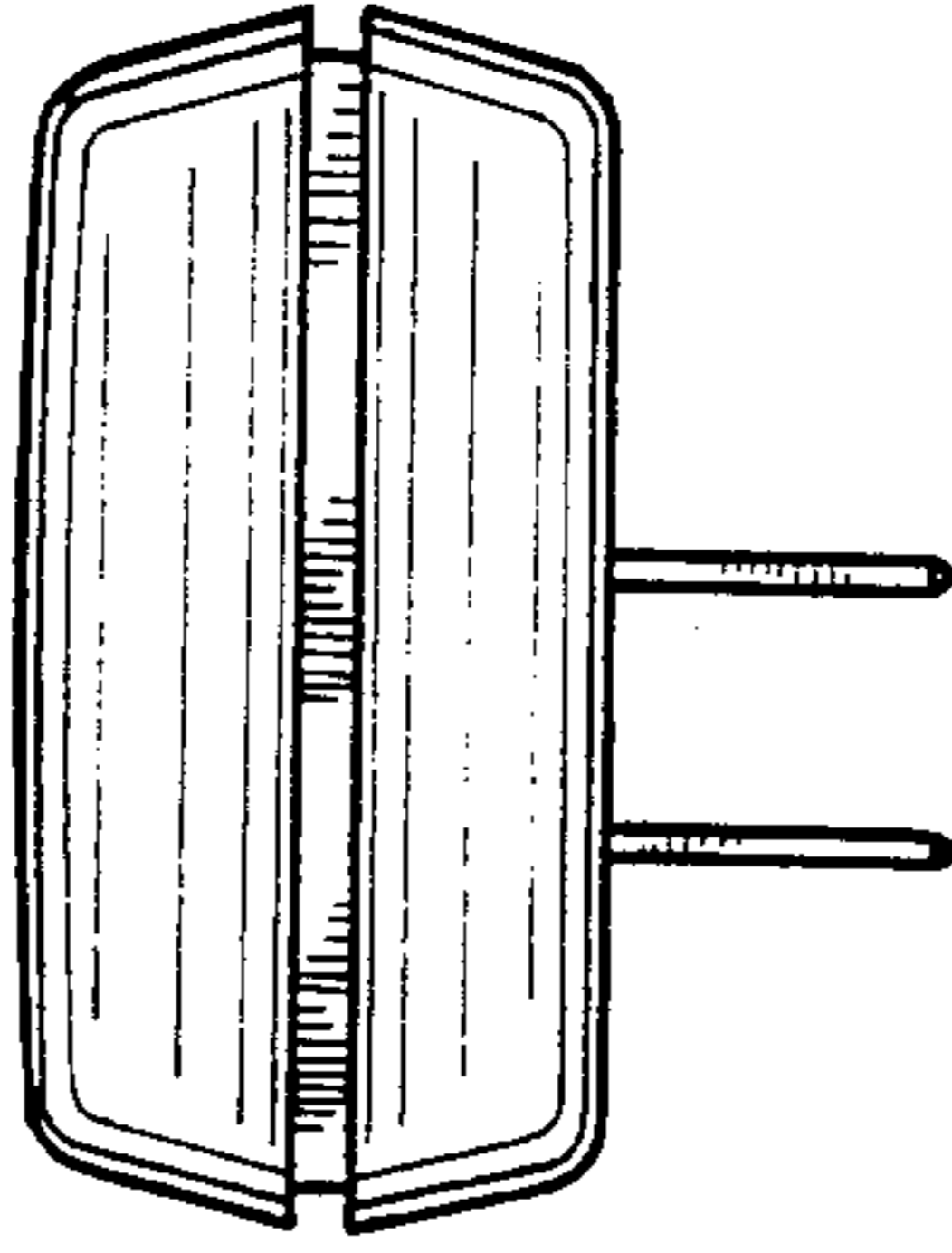

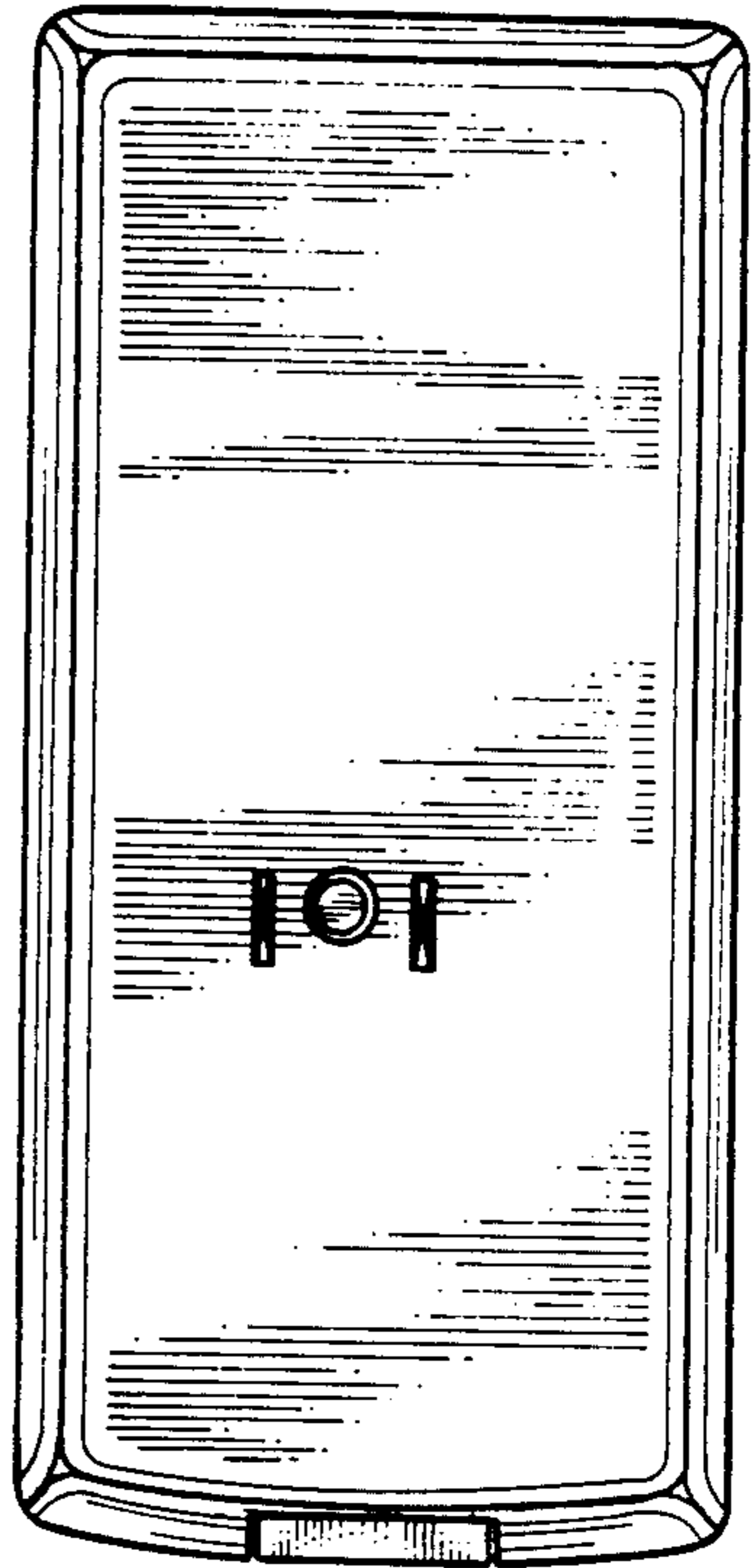

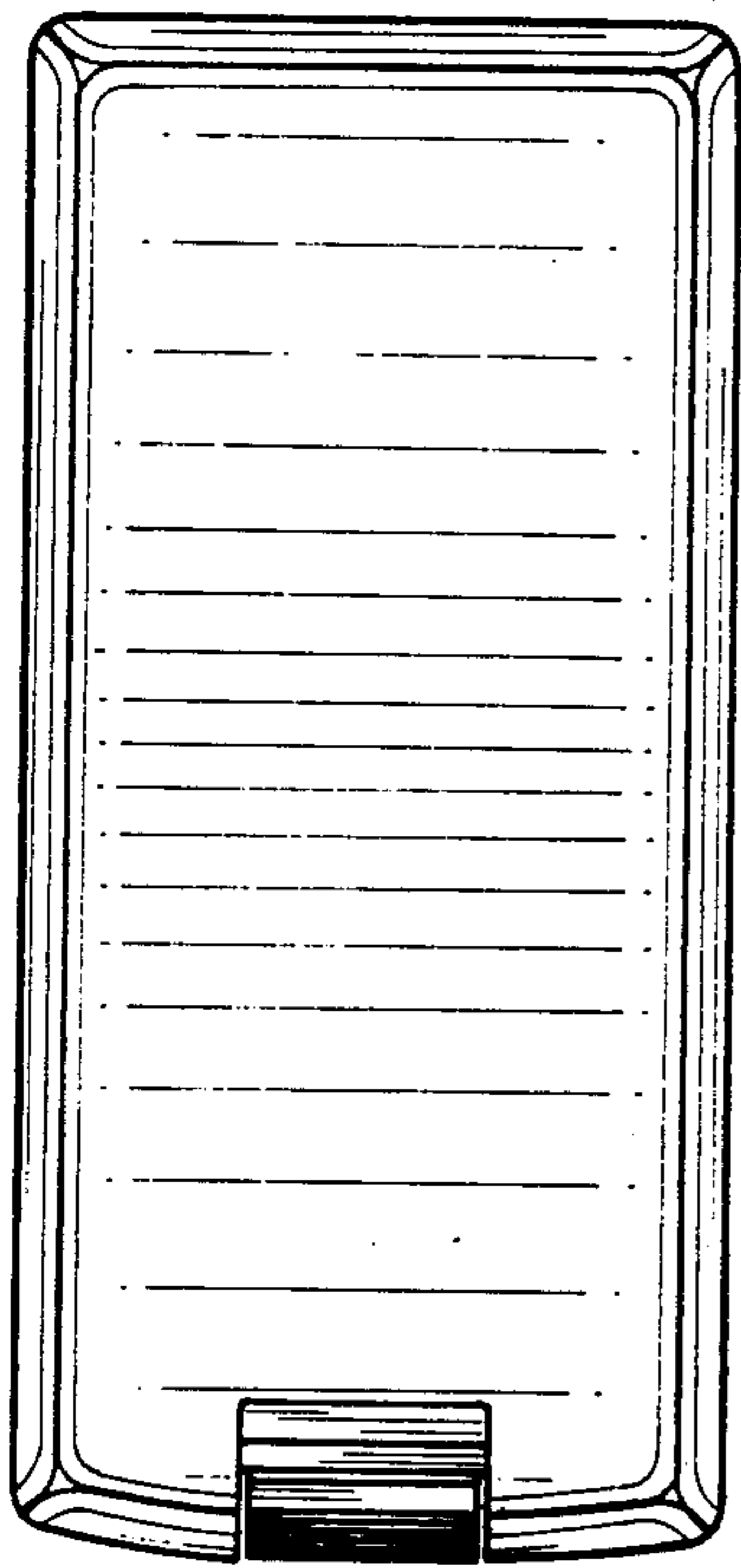

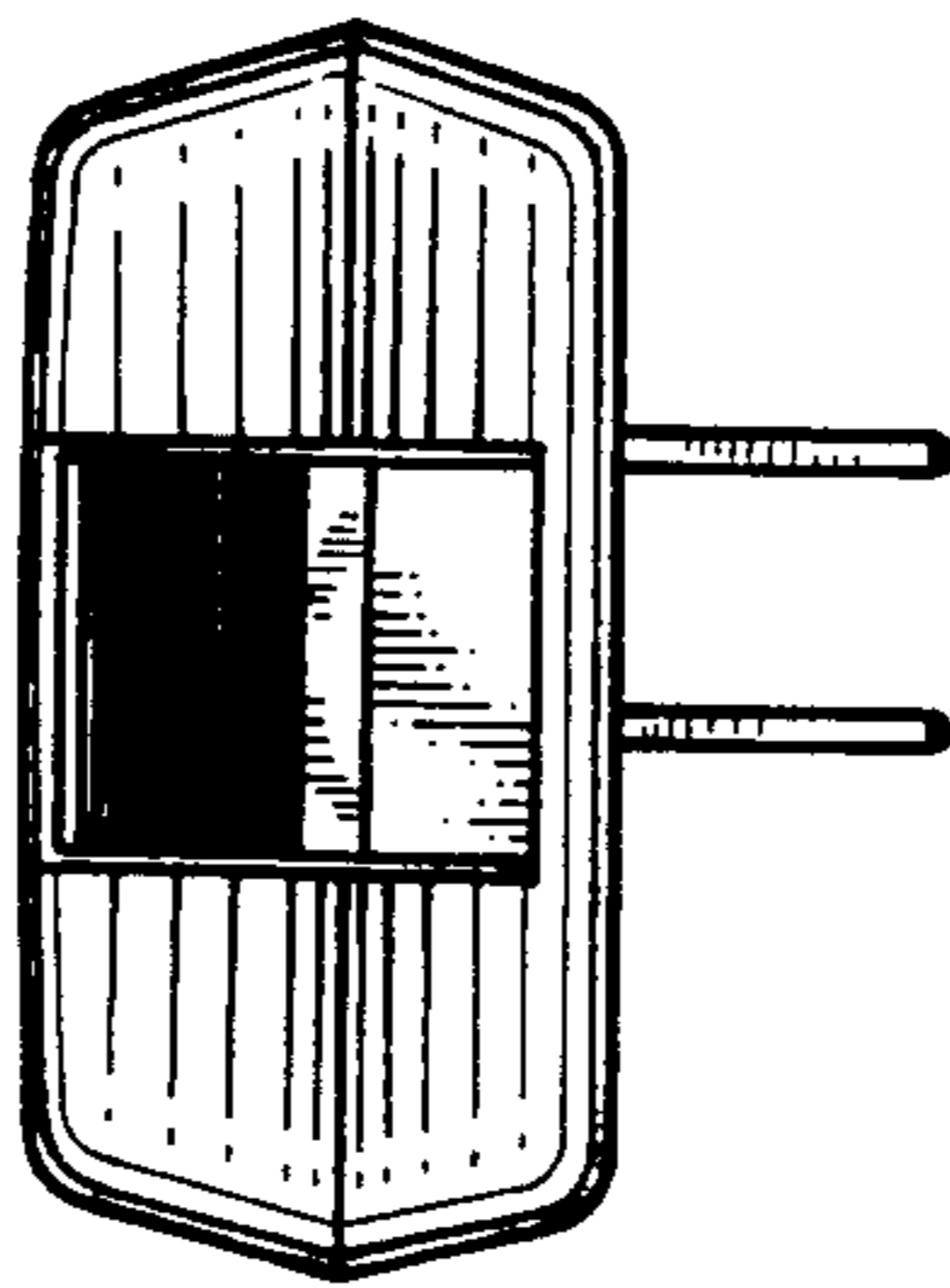

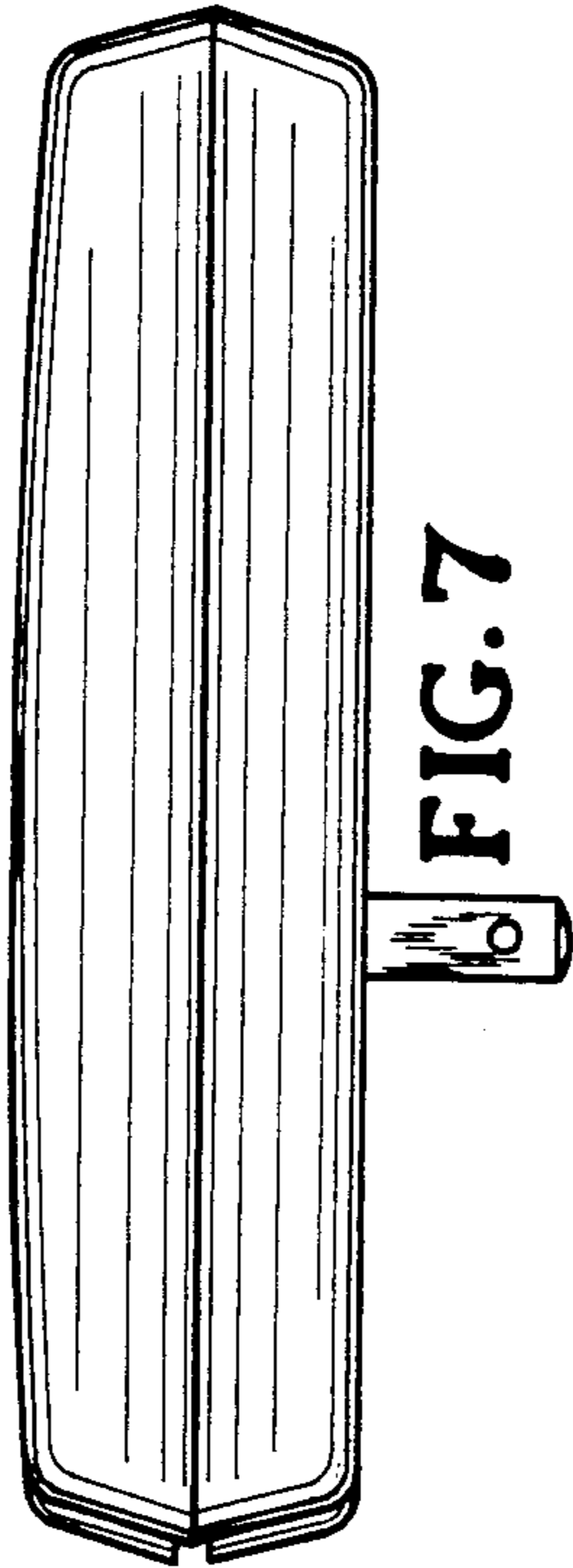

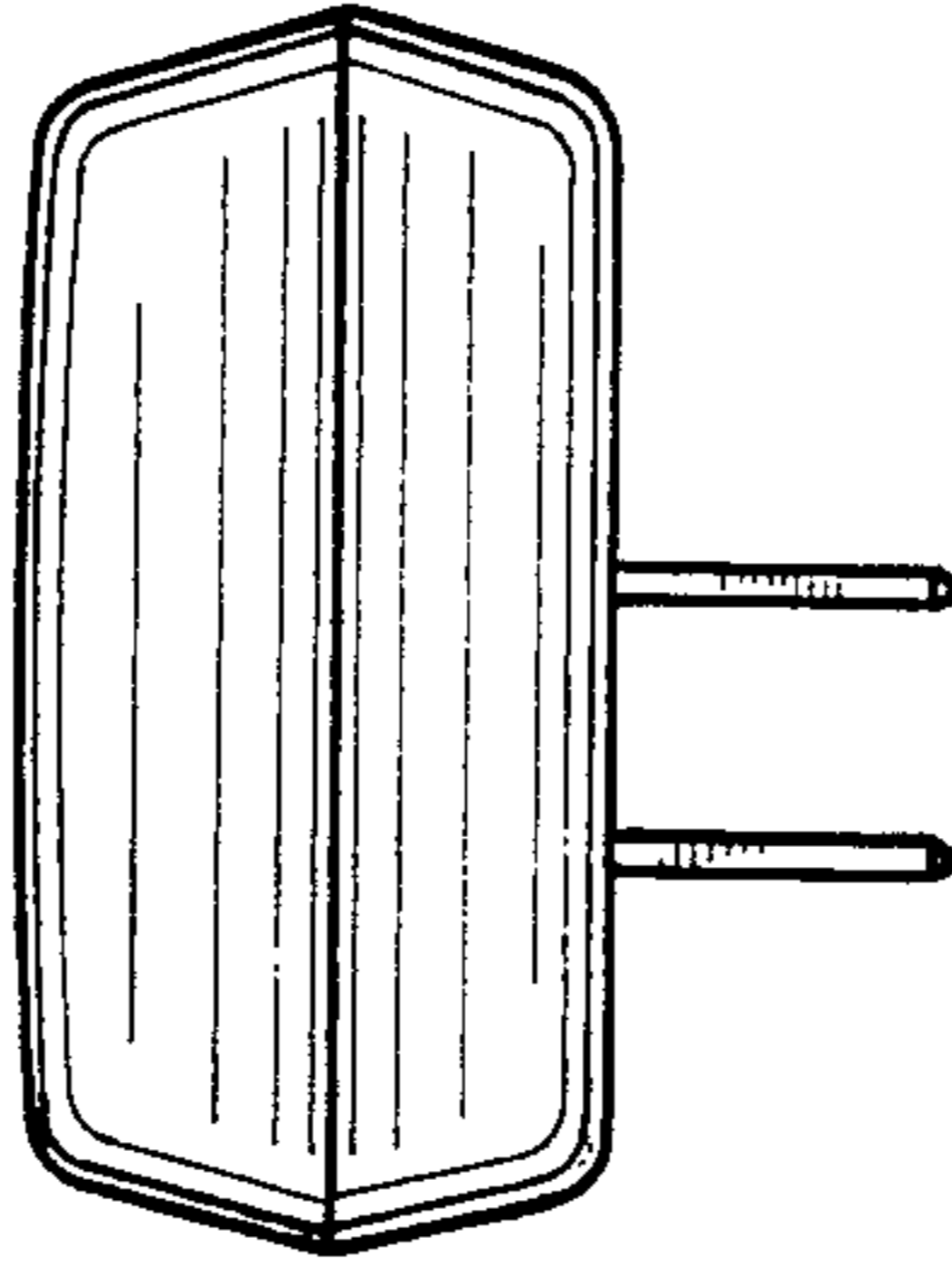

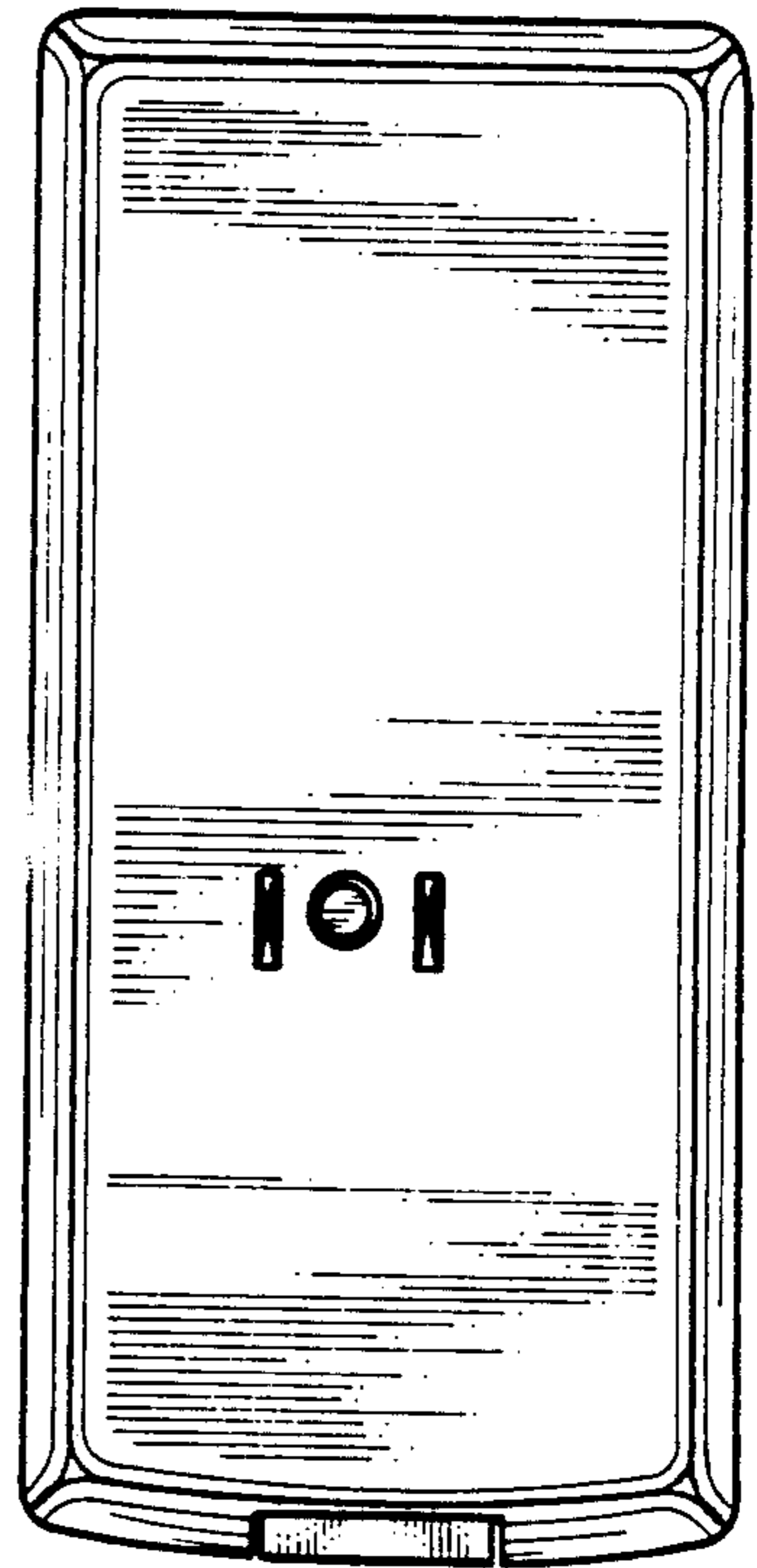
