DESCRIPTION

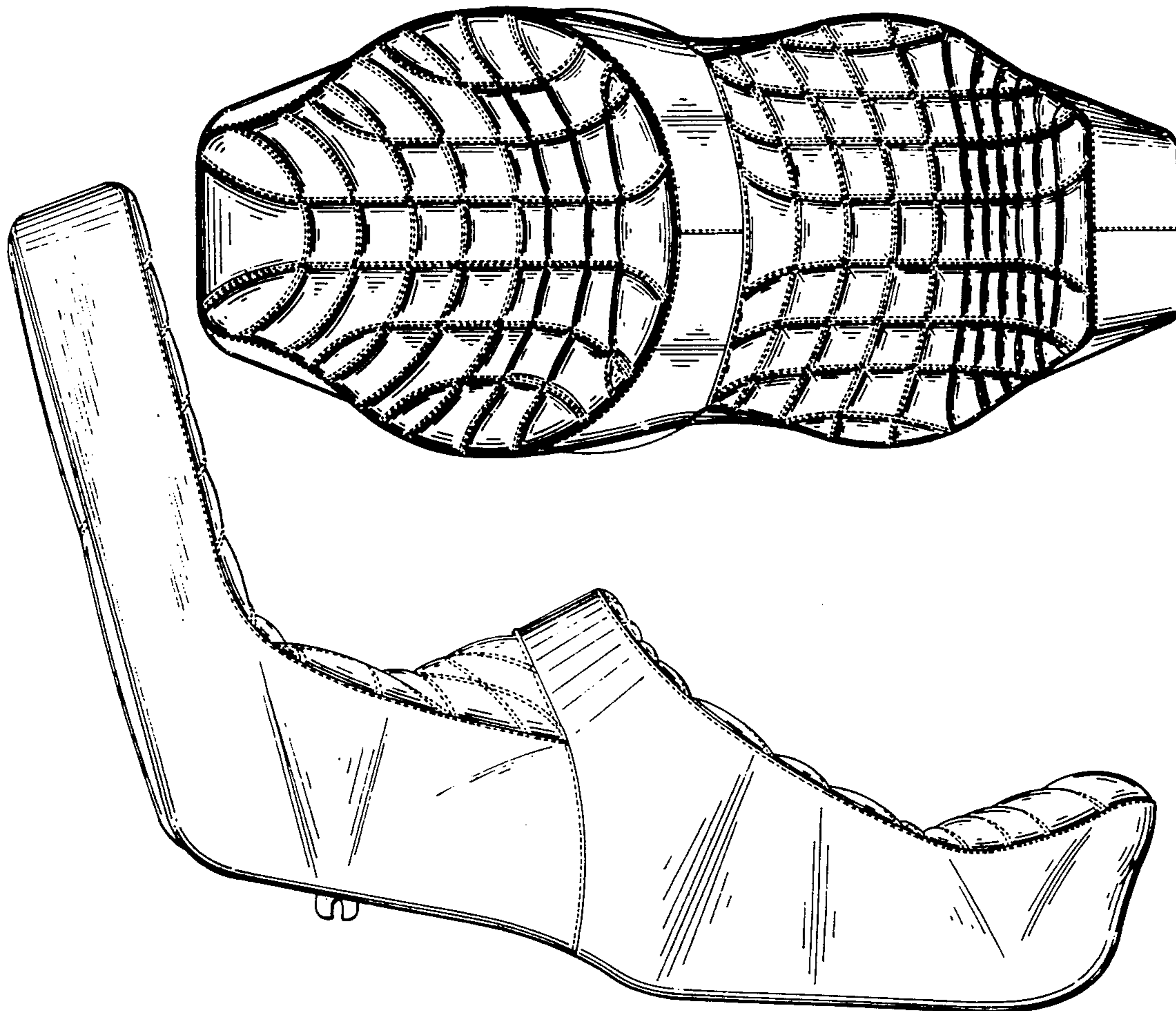
FIG. 1 is a side elevational view of a motorcycle seat showing my new design, the opposite side elevational view being a mirror image thereof;

FIG. 5 is a rear elevational view thereof.



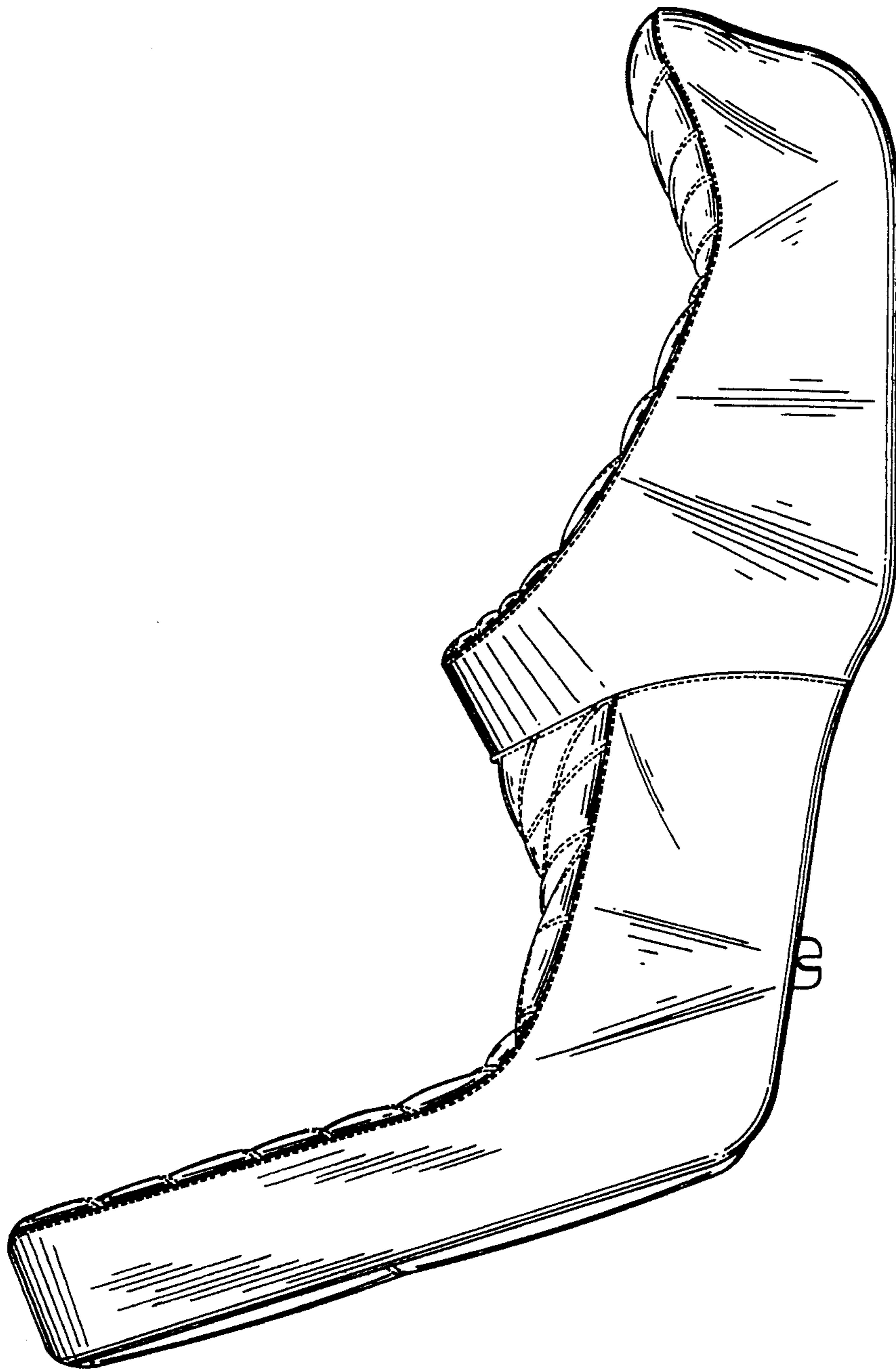

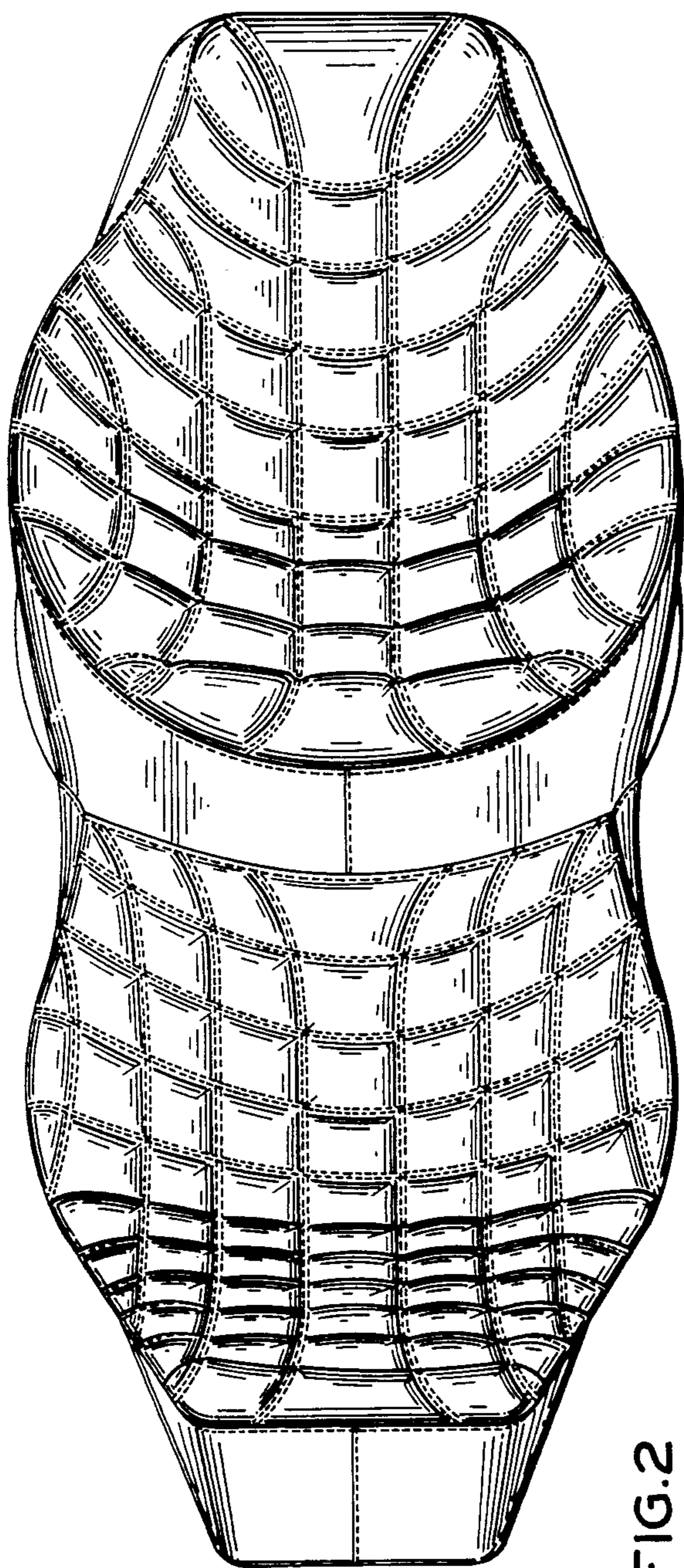

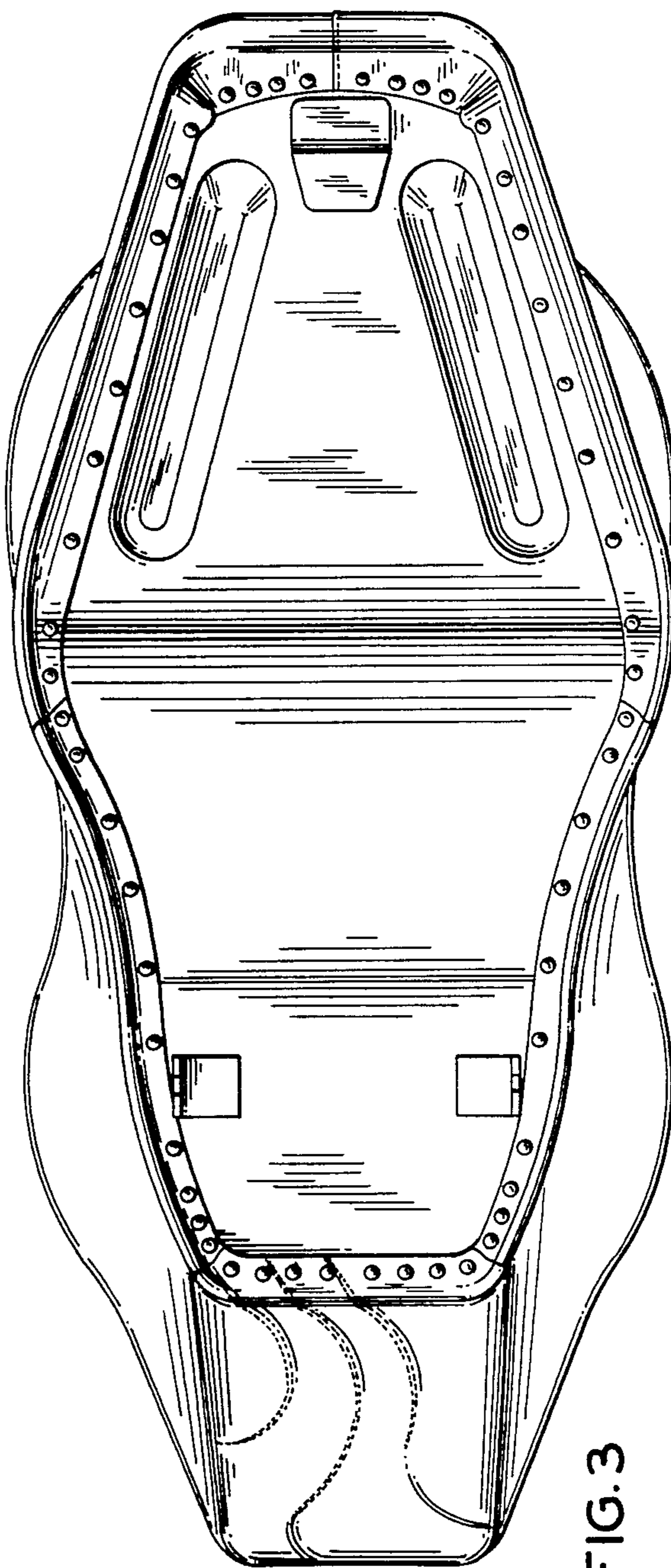

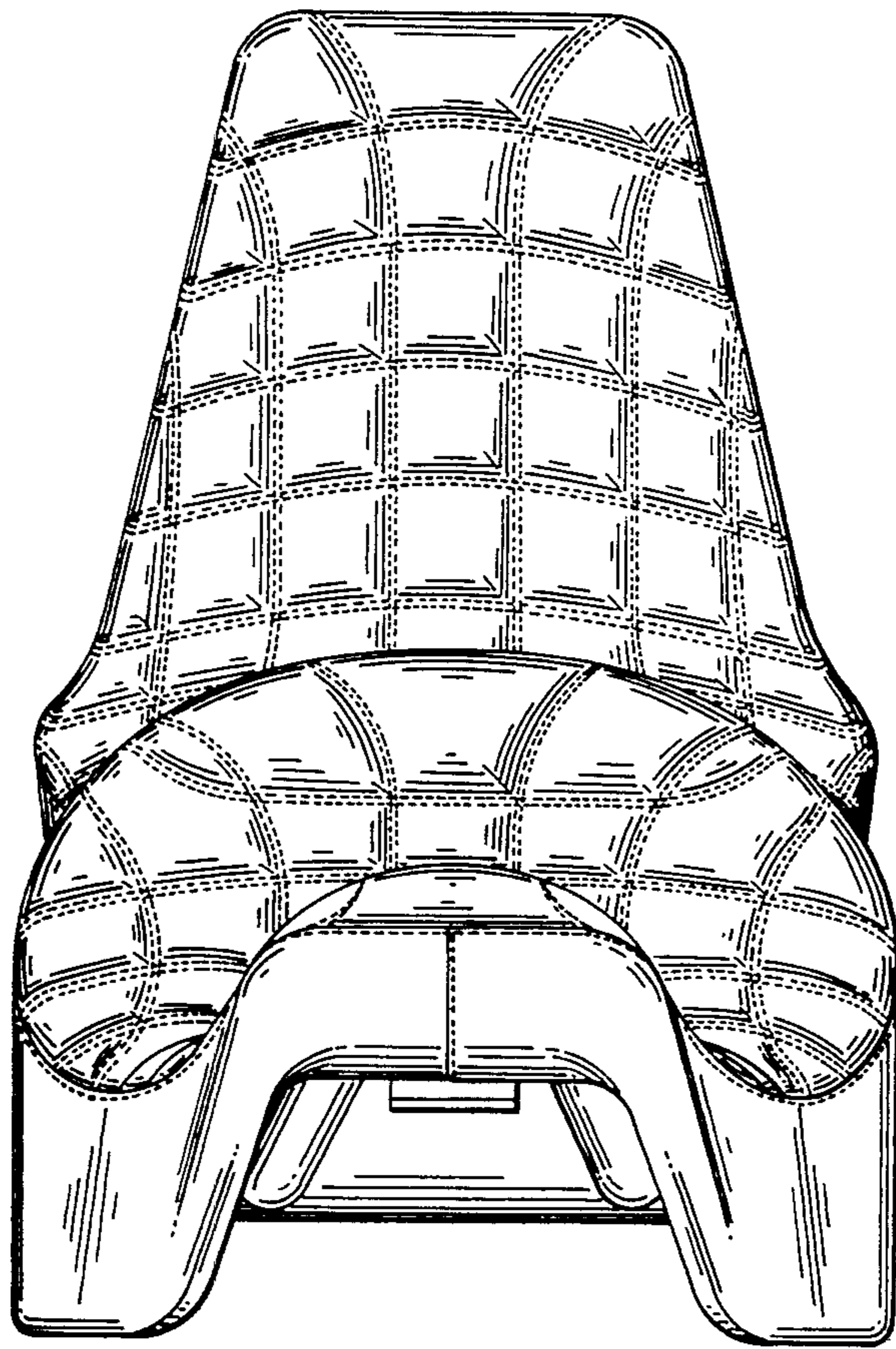

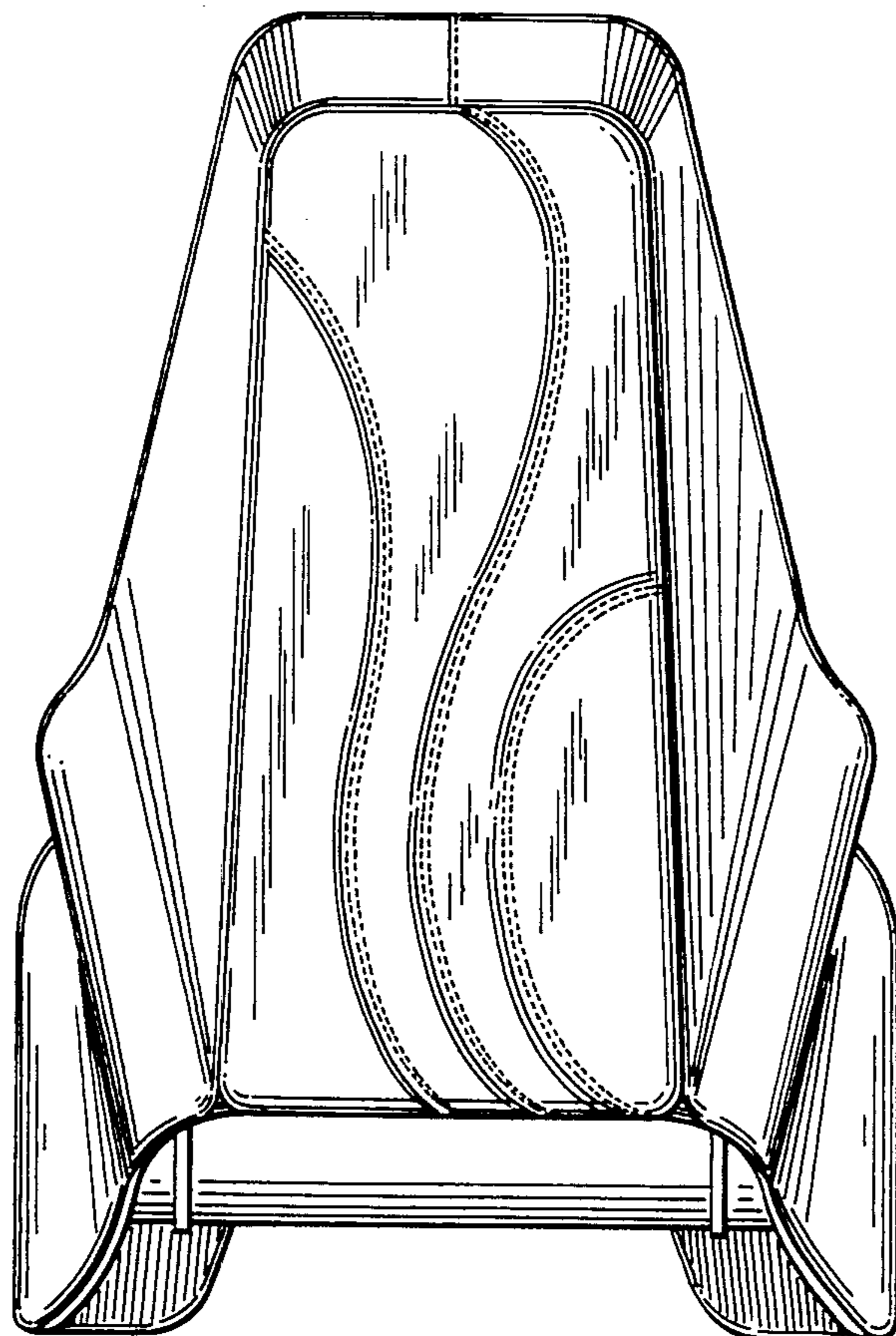
