### CLAIM

The ornamental design for a top for a camping vehicle, as shown and described.

#### **DESCRIPTION**

FIG. 1 is a side elevational view of a top for a camping vehicle showing my new design; the opposite side being a mirror image thereof:

FIG. 16 is a top plan view of FIG. 13;


FIG. 17 is a side elevational view of a top for a camping vehicle showing a fifth embodiment of my new design; the opposite side being a mirror image thereof;


FIG. 18 is a front elevational view of FIG. 17;




















