FIG. 1 is a front elevational view of a card file showing my new design;

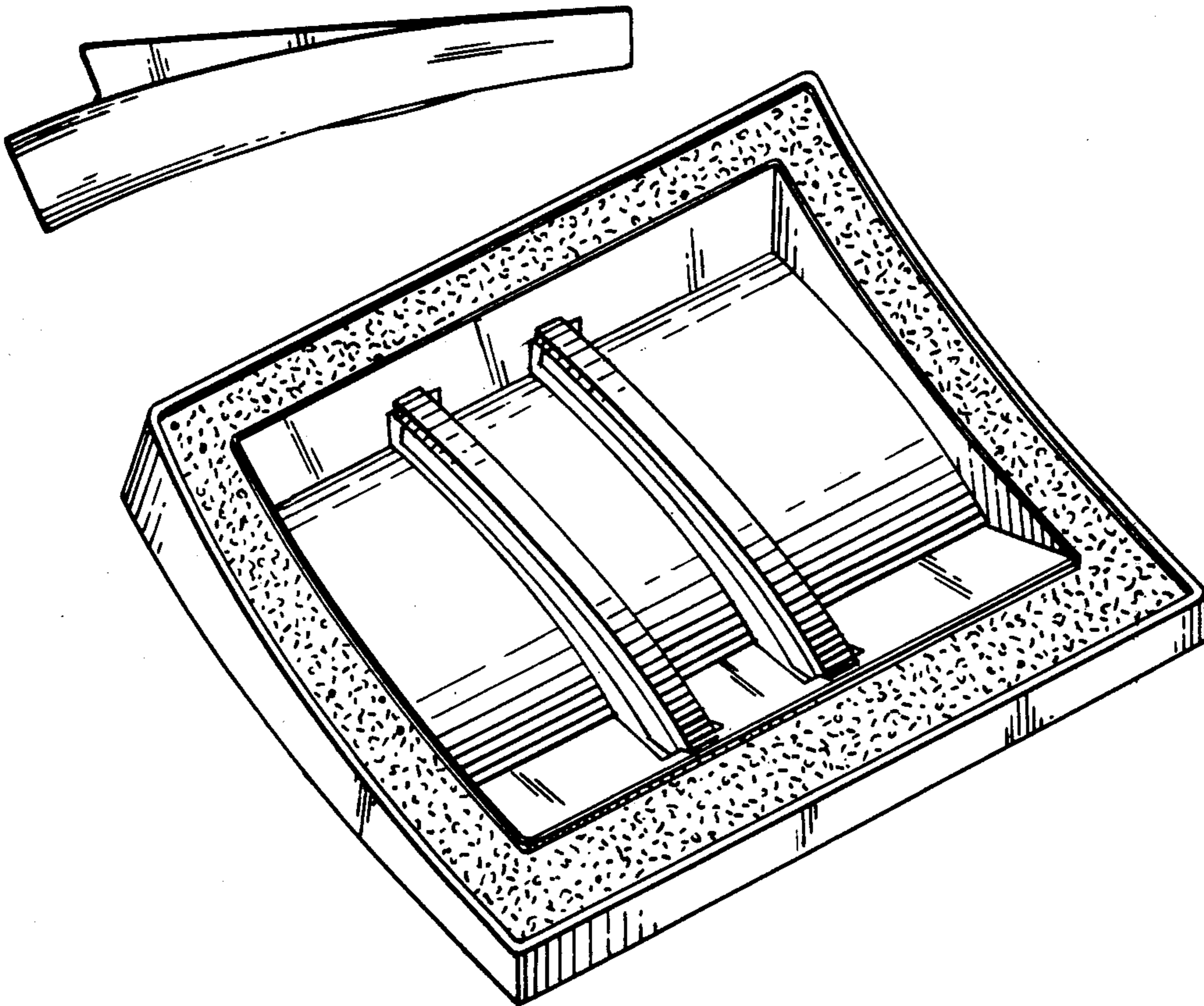
FIG. 2 is a rear elevational view thereof;

FIG. 6 is a perspective view of the card file.



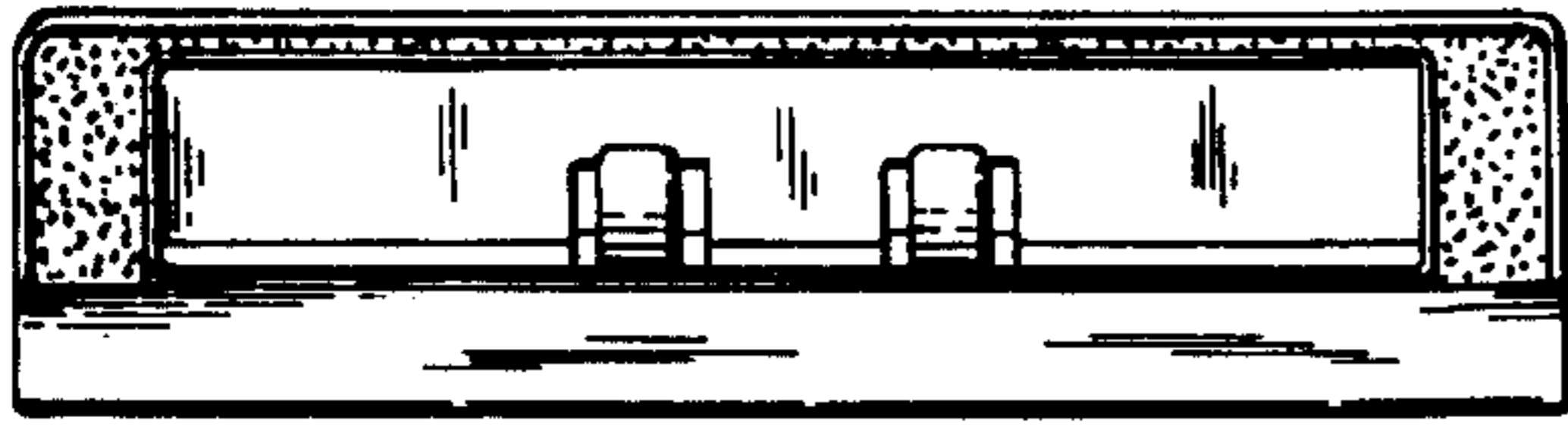

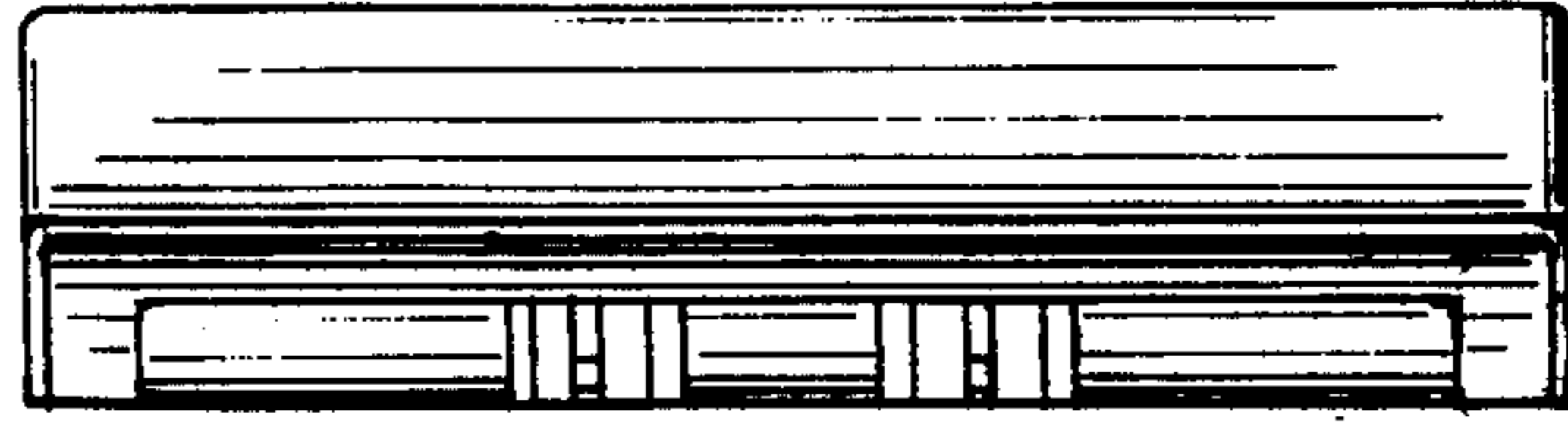

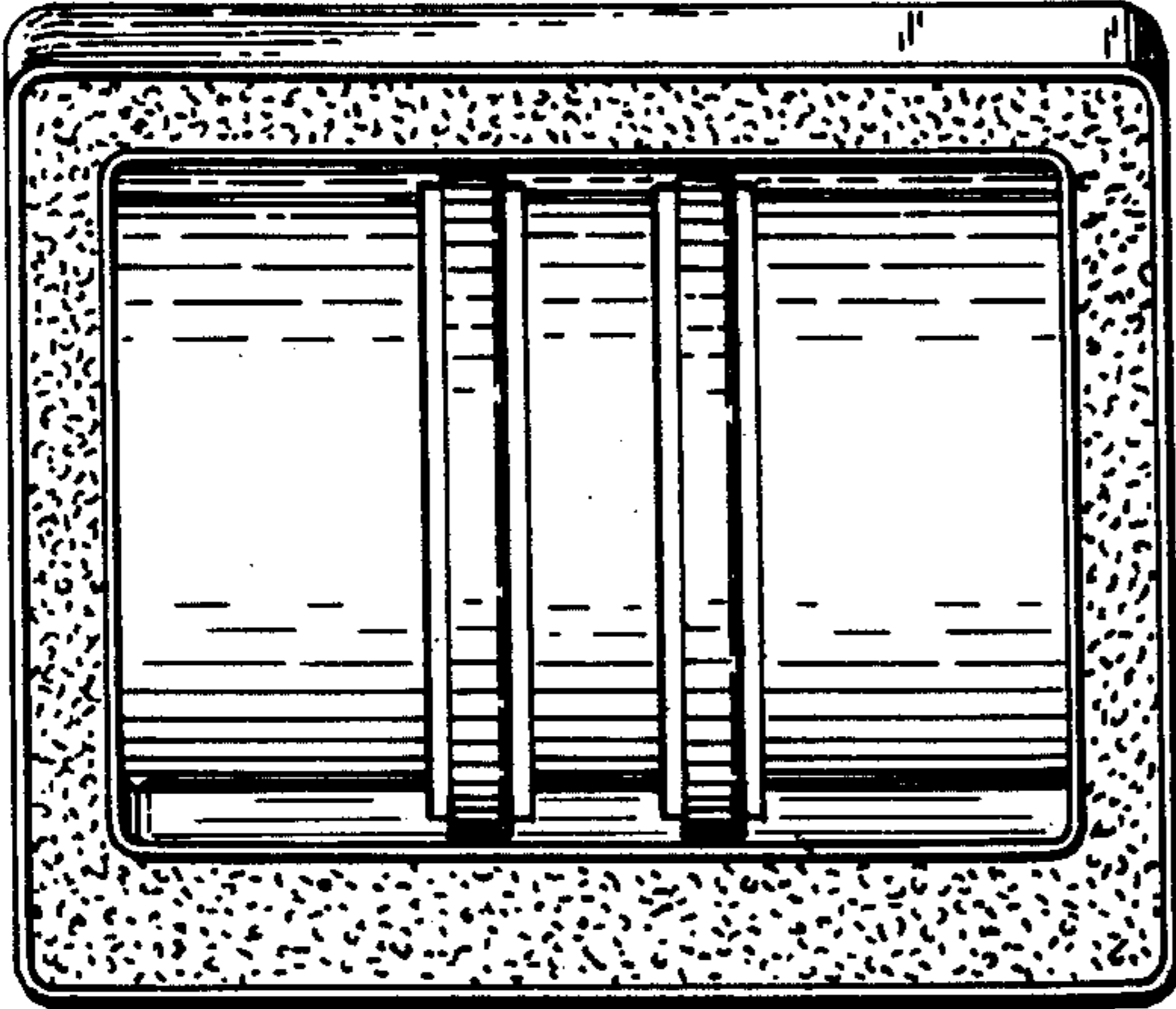

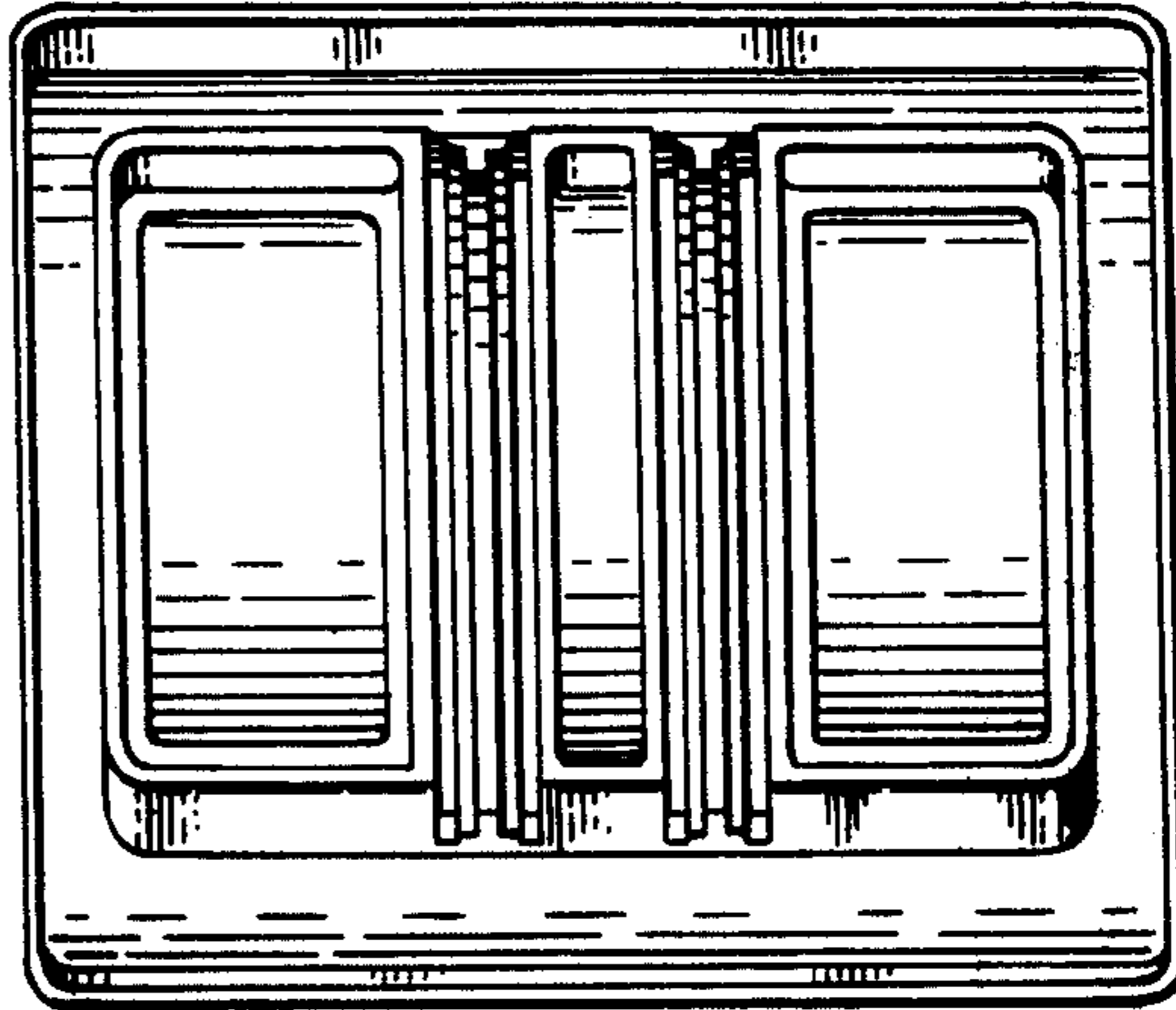

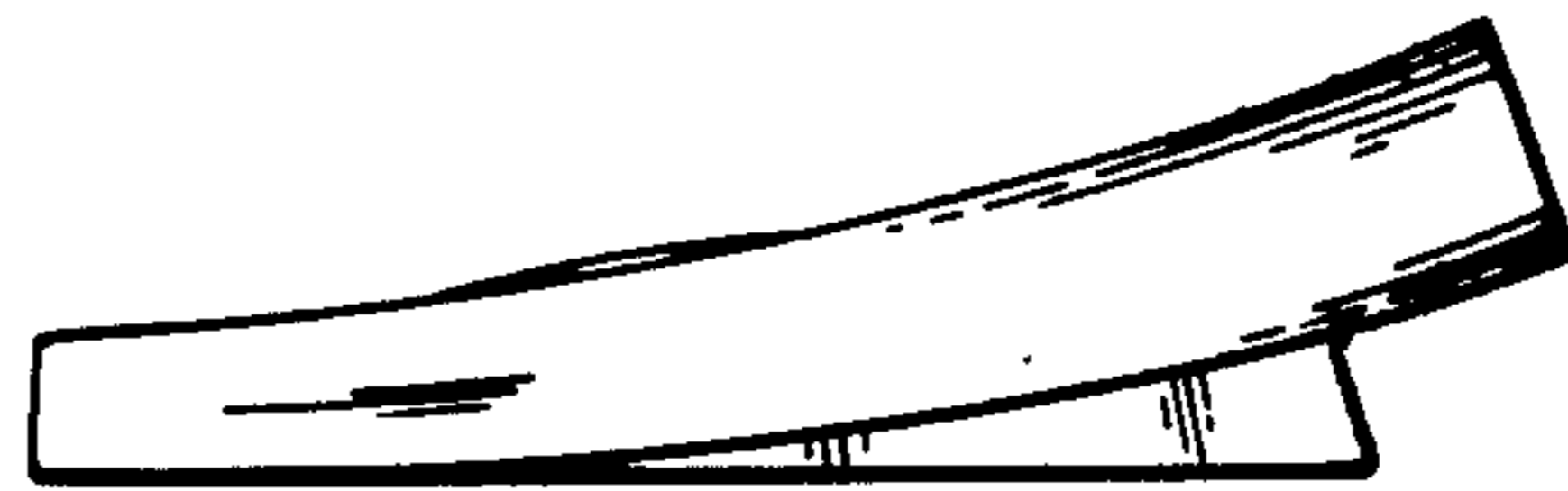

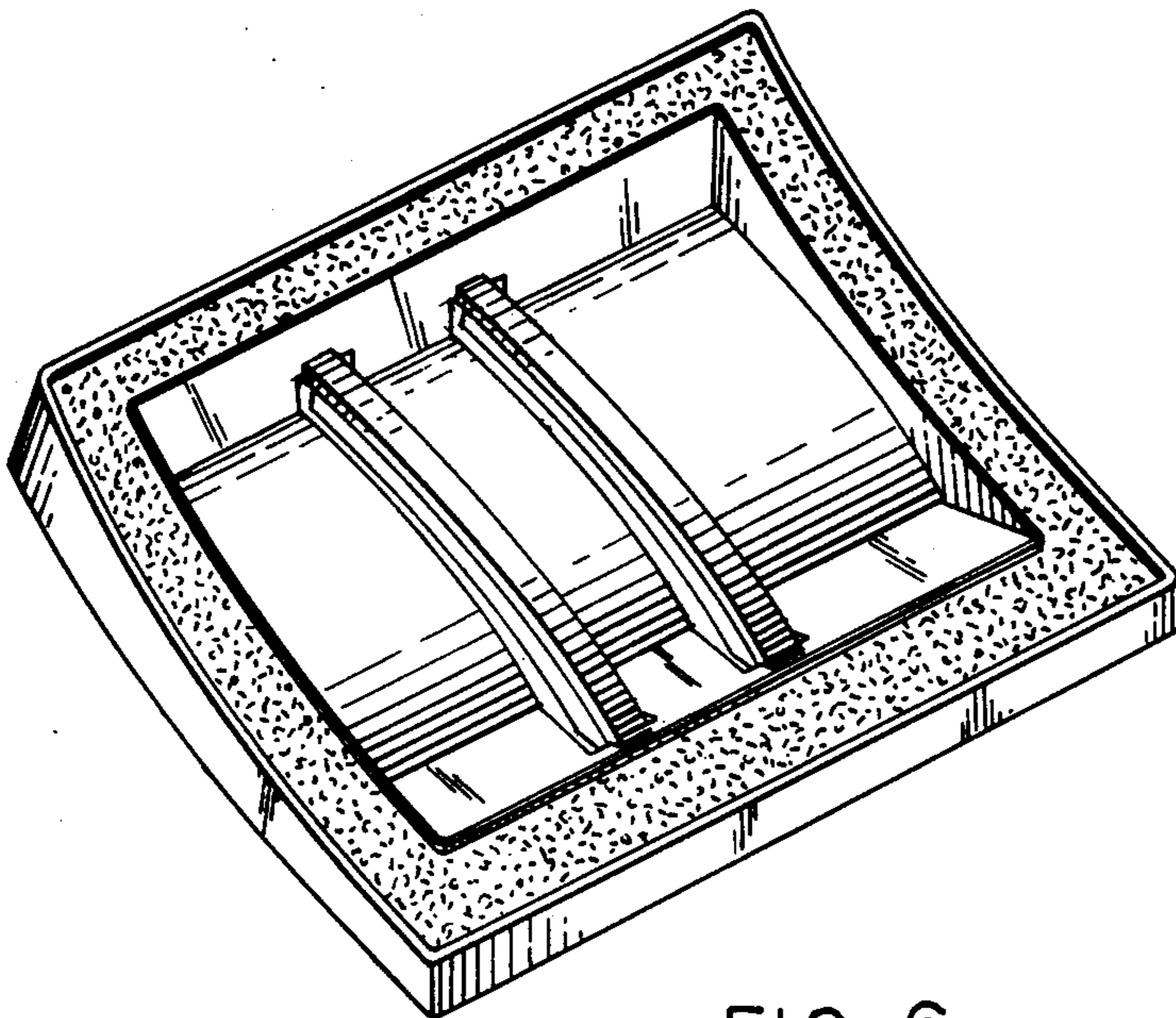
