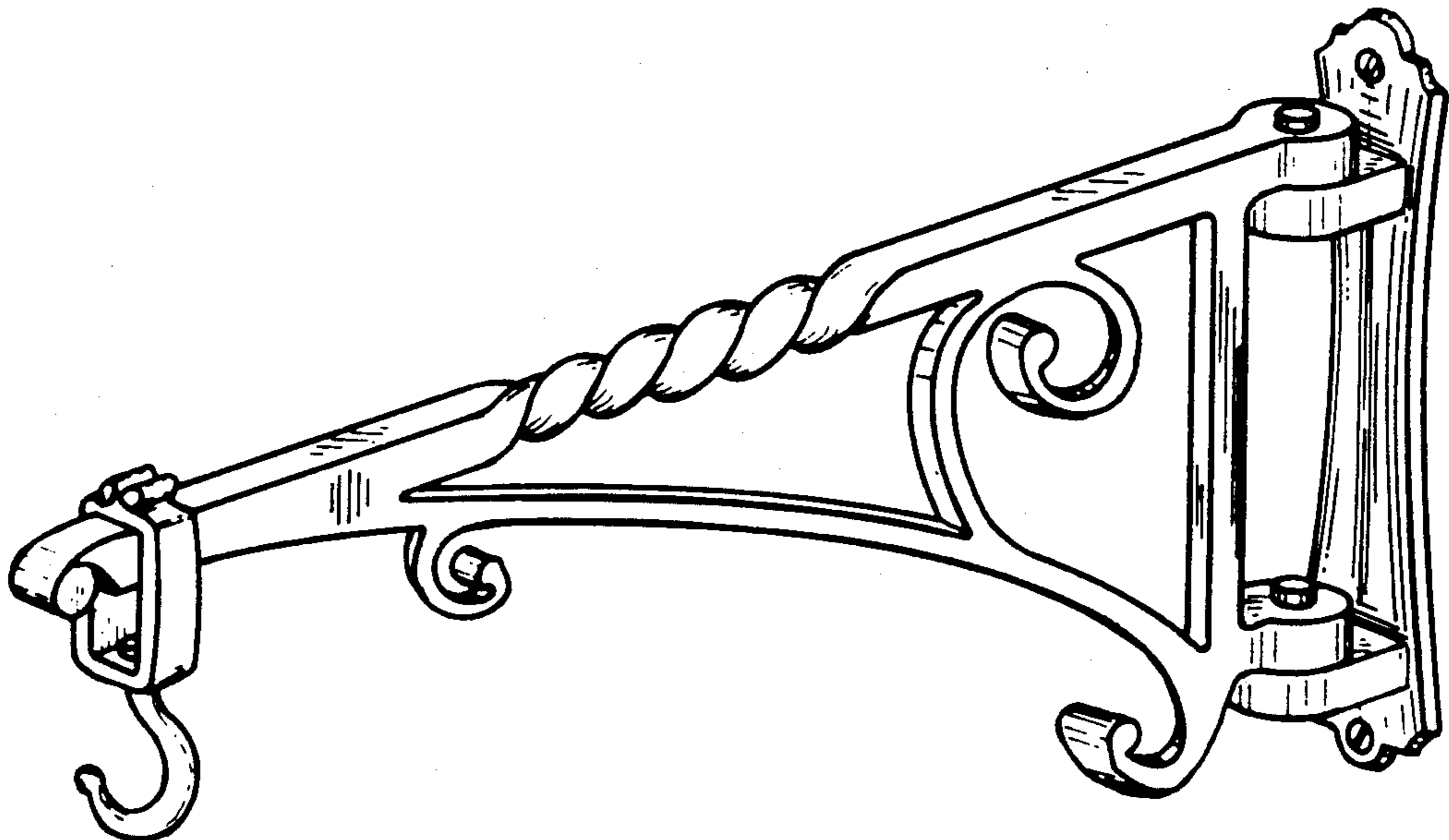

[57] **CLAIM**

The ornamental design for a wall mounted bracket assembly, substantially as shown and described.

DESCRIPTION

FIG. 1 is a reduced perspective view of a wall mounted bracket assembly showing my new design;
 FIG. 2 is a reduced side view of a second embodiment of the design of FIG. 1, the only difference being the reversal of the projecting arm;
 FIG. 3 is a rear view of FIG. 1;
 FIG. 4 is a side view of the mounting plate, shown separately for ease of illustration;
 FIG. 5 is a front view of FIG. 4;
 FIG. 6 is a top view of FIG. 4;
 FIG. 7 is a sectional view taken on line 7—7 of FIG. 4;
 FIG. 8 is a bottom view of FIG. 4;
 FIG. 9 is a top view of FIG. 1, the hook being omitted for convenience of illustration;
 FIG. 10 is a side view of FIG. 9;
 FIG. 11 is a partial side view of a third embodiment of the design of FIG. 1, the only difference being the configuration of the termination of the projecting arm;
 FIG. 12 is a bottom view of FIG. 9;
 FIG. 13 is a front view of the projecting arm shown separately for ease of illustration;
 FIG. 14 is a rear view of FIG. 13;
 FIG. 15 is an enlarged side view of the hook, also shown separately for ease of illustration;
 FIG. 16 is a front view of FIG. 15;
 FIG. 17 is a rear view of FIG. 15;
 FIG. 18 is a top view of FIG. 15;
 FIG. 19 is a bottom view of FIG. 15;
 FIG. 20 is a sectional view taken on line 20—20 of FIG. 15.



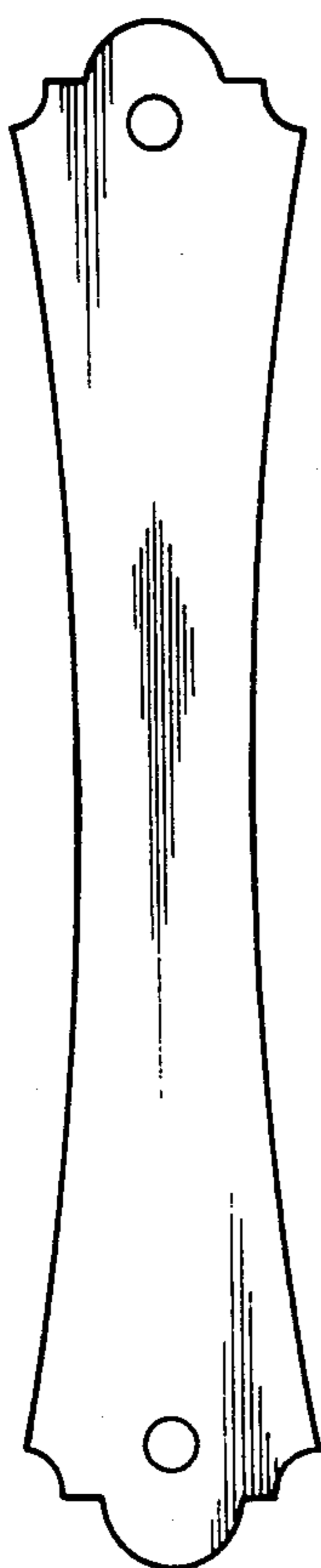
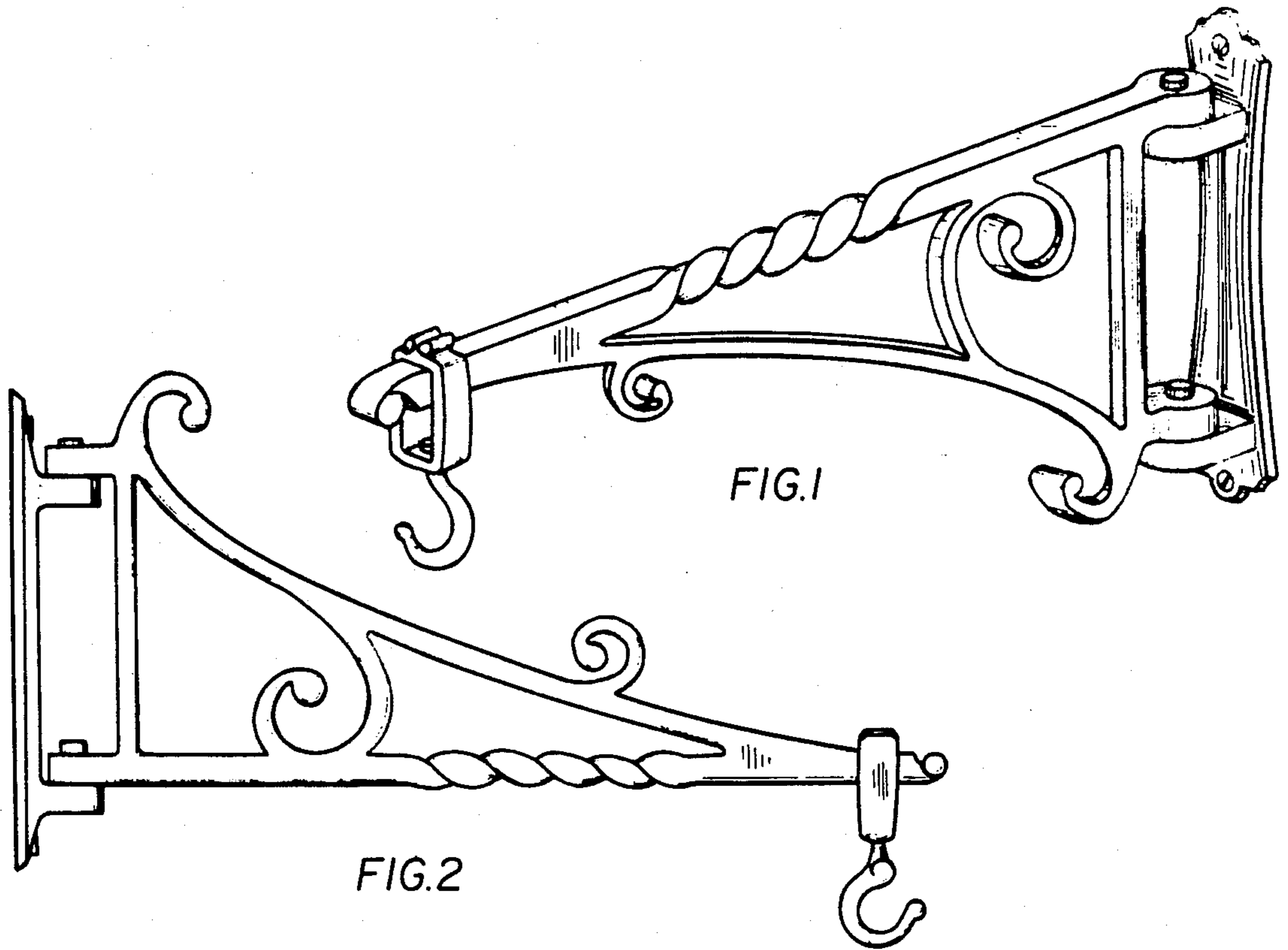

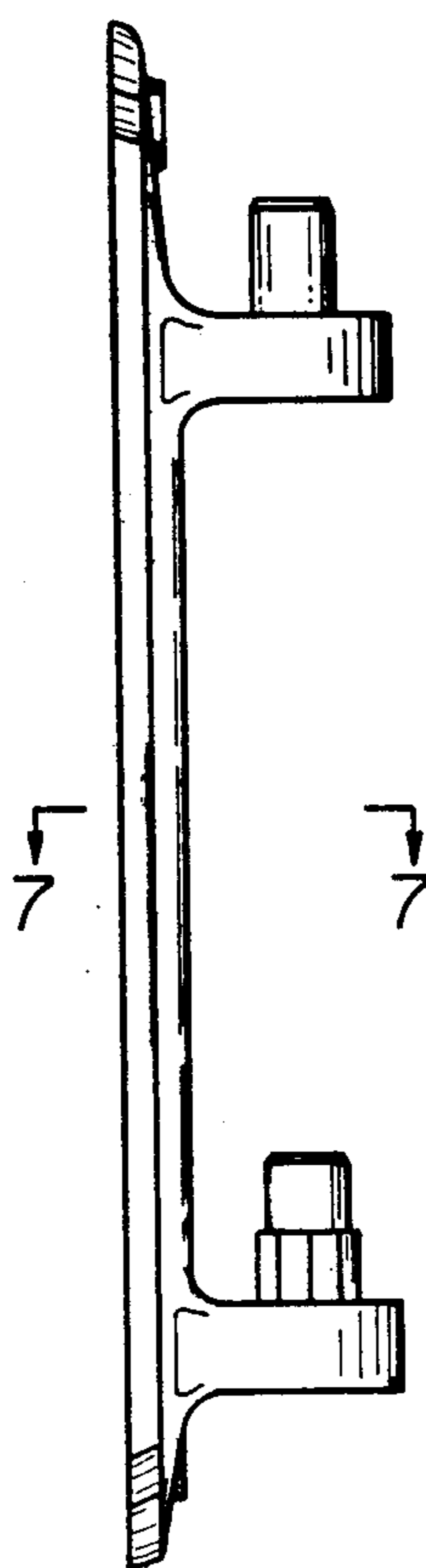

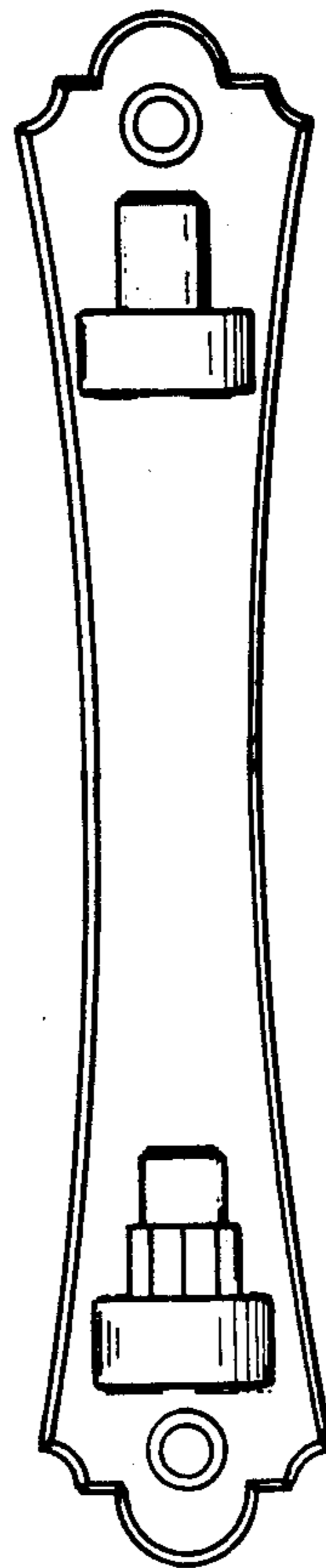

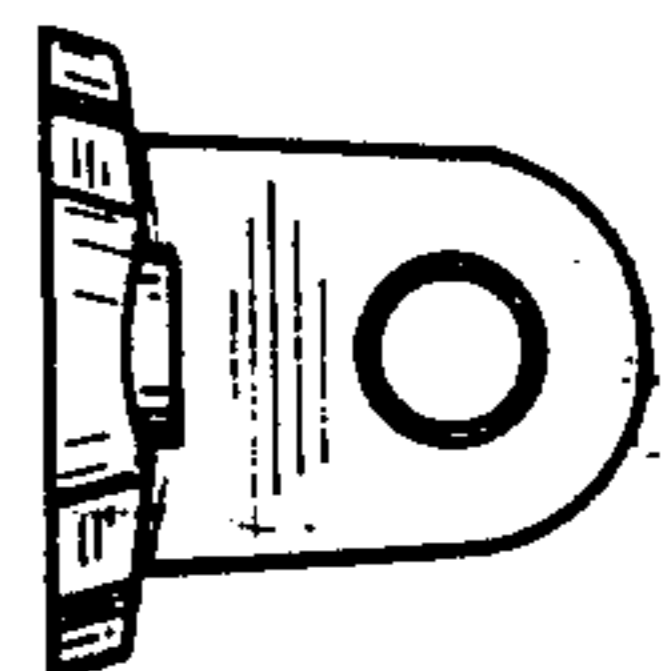

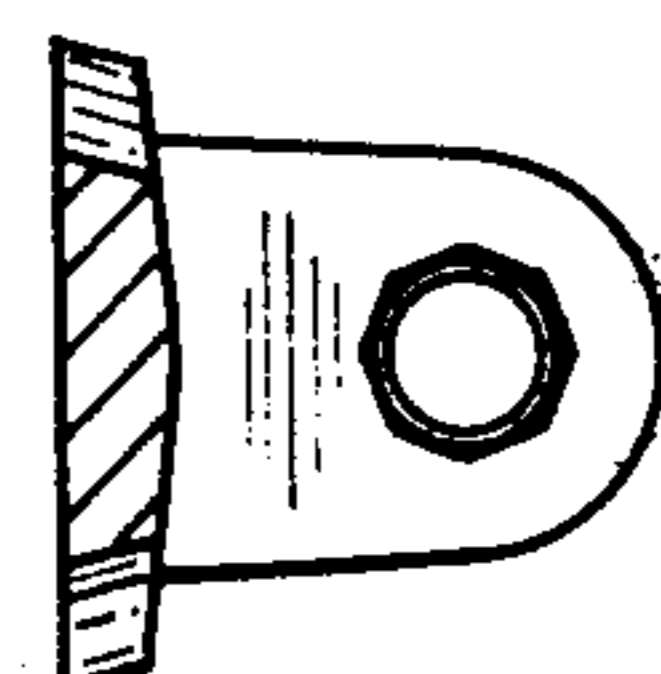

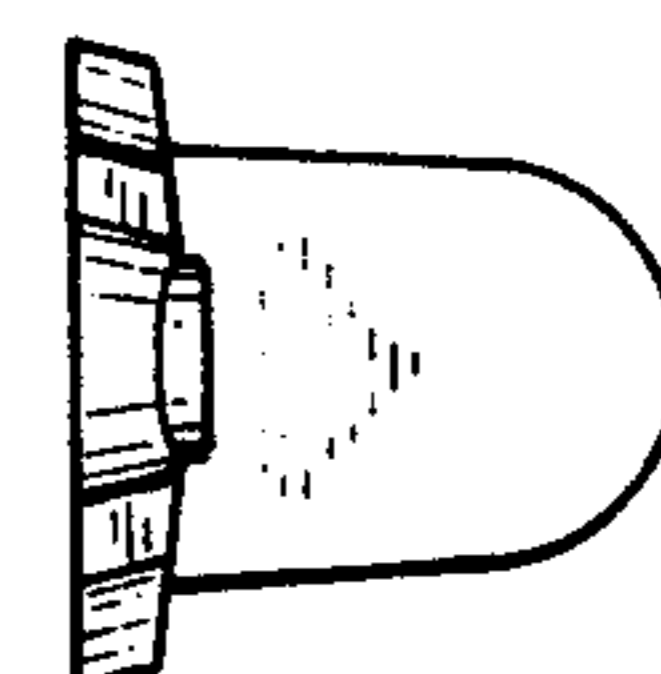

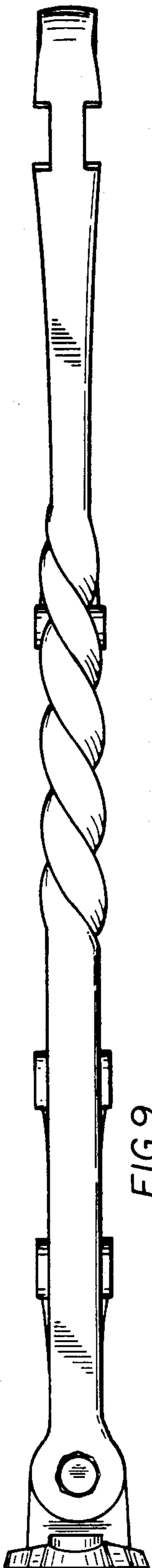

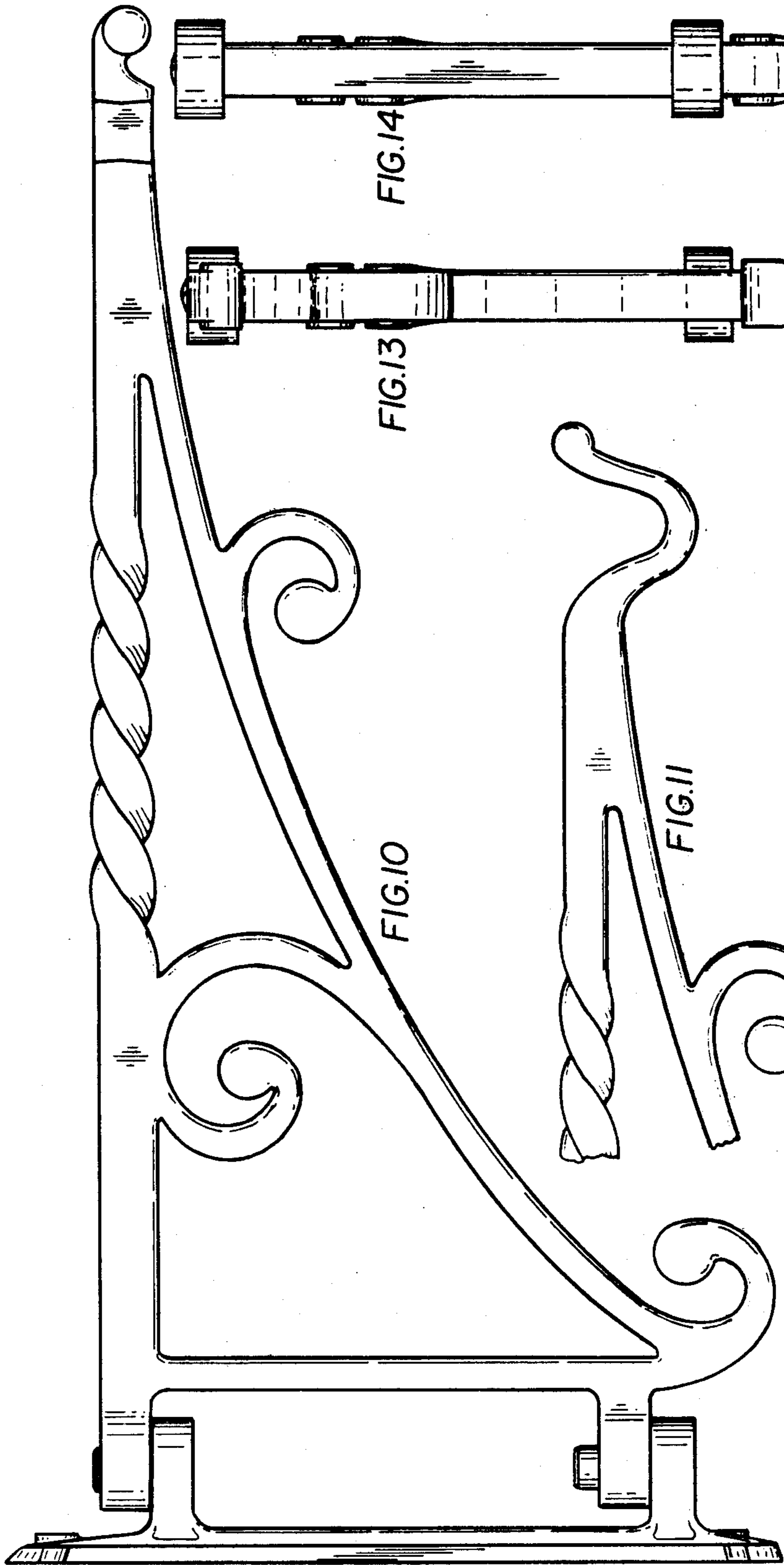

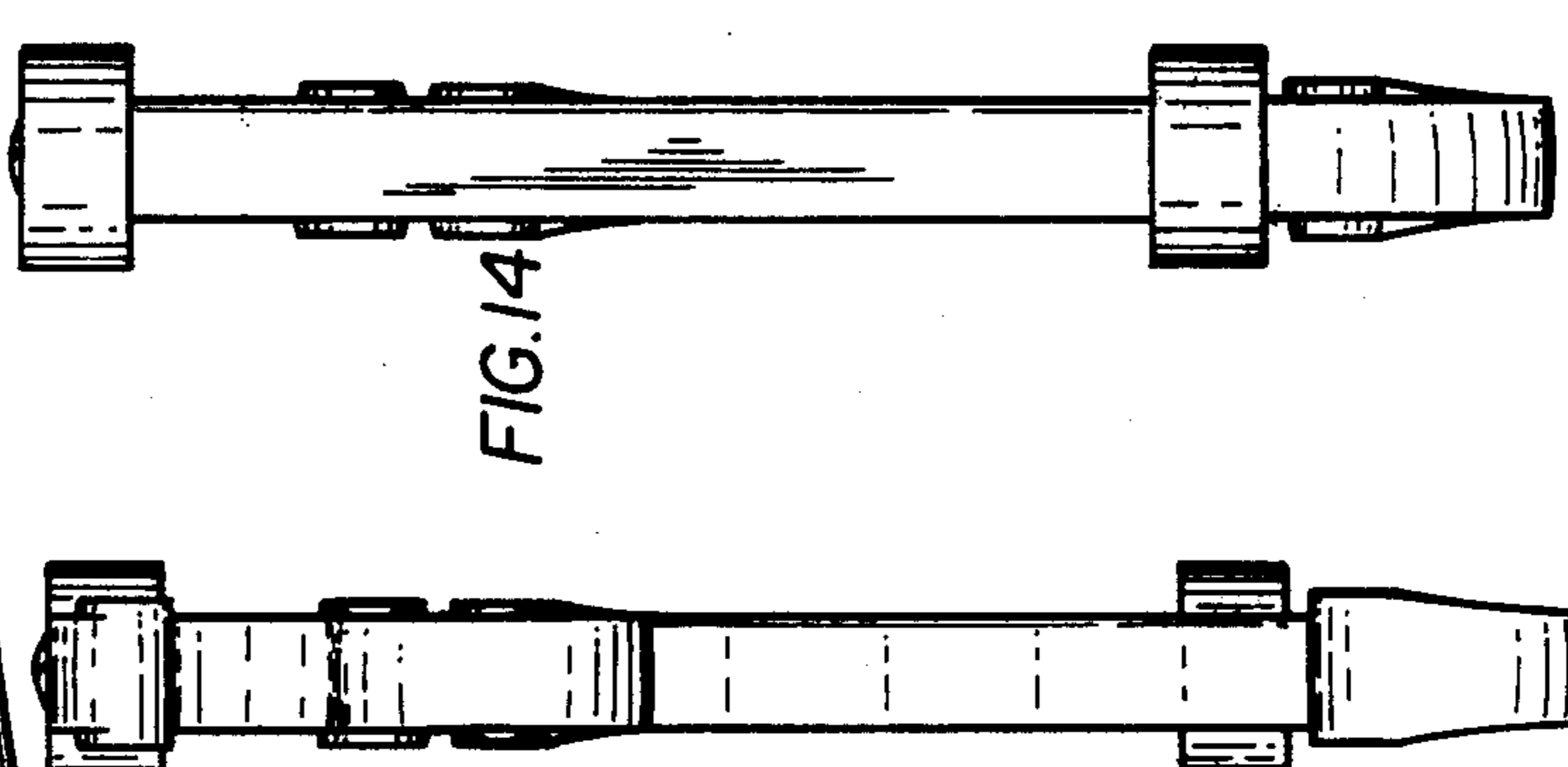

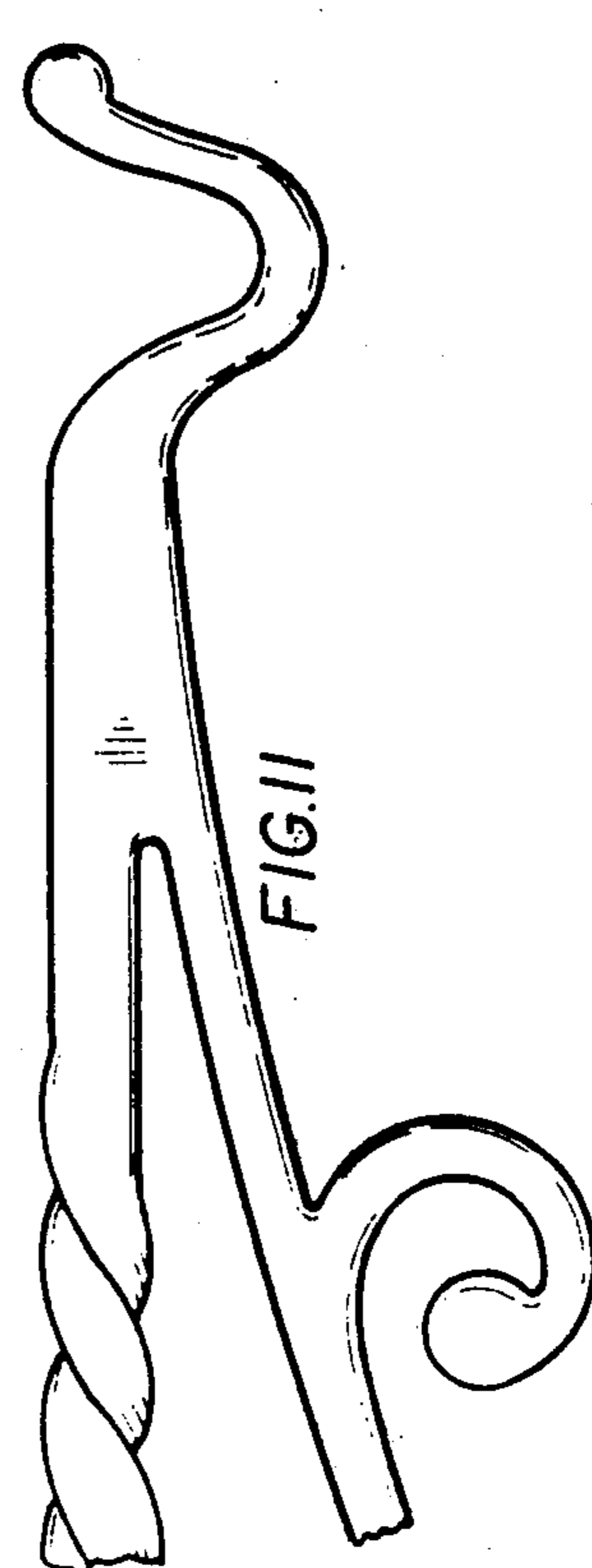

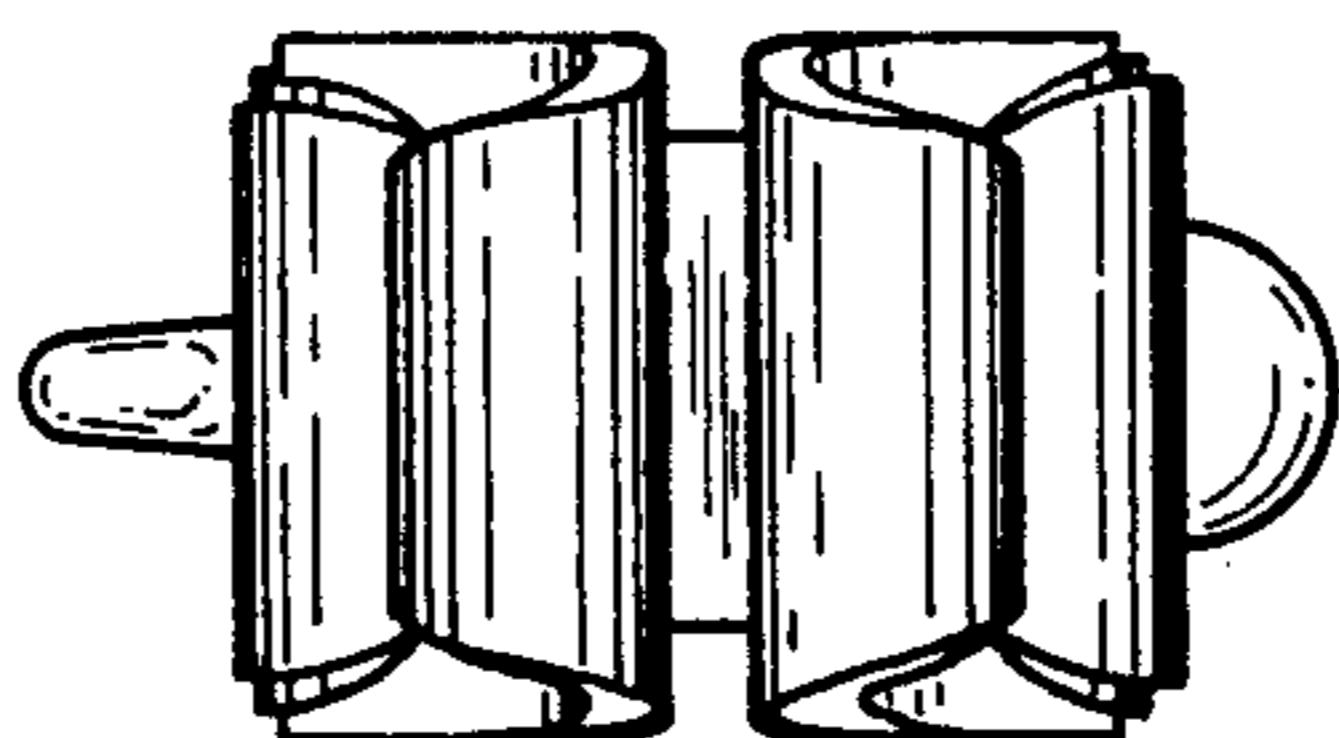

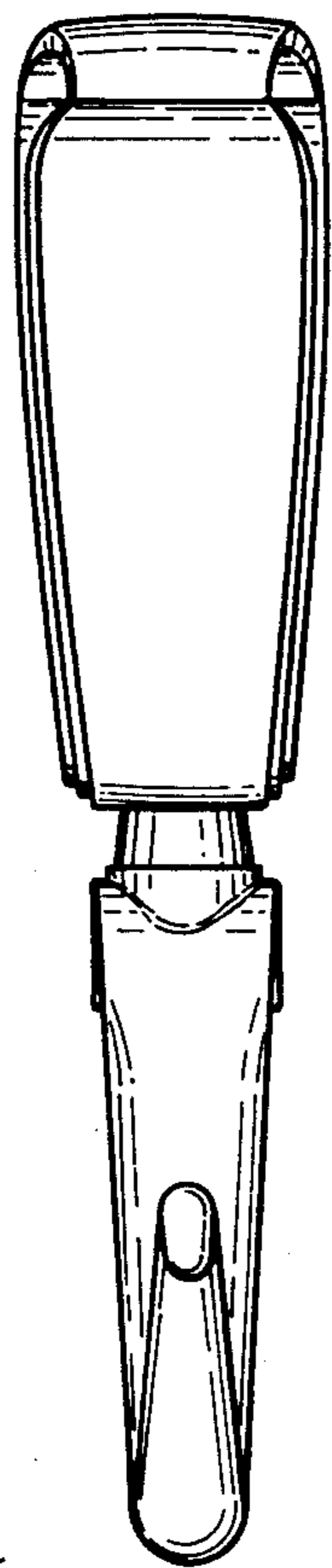

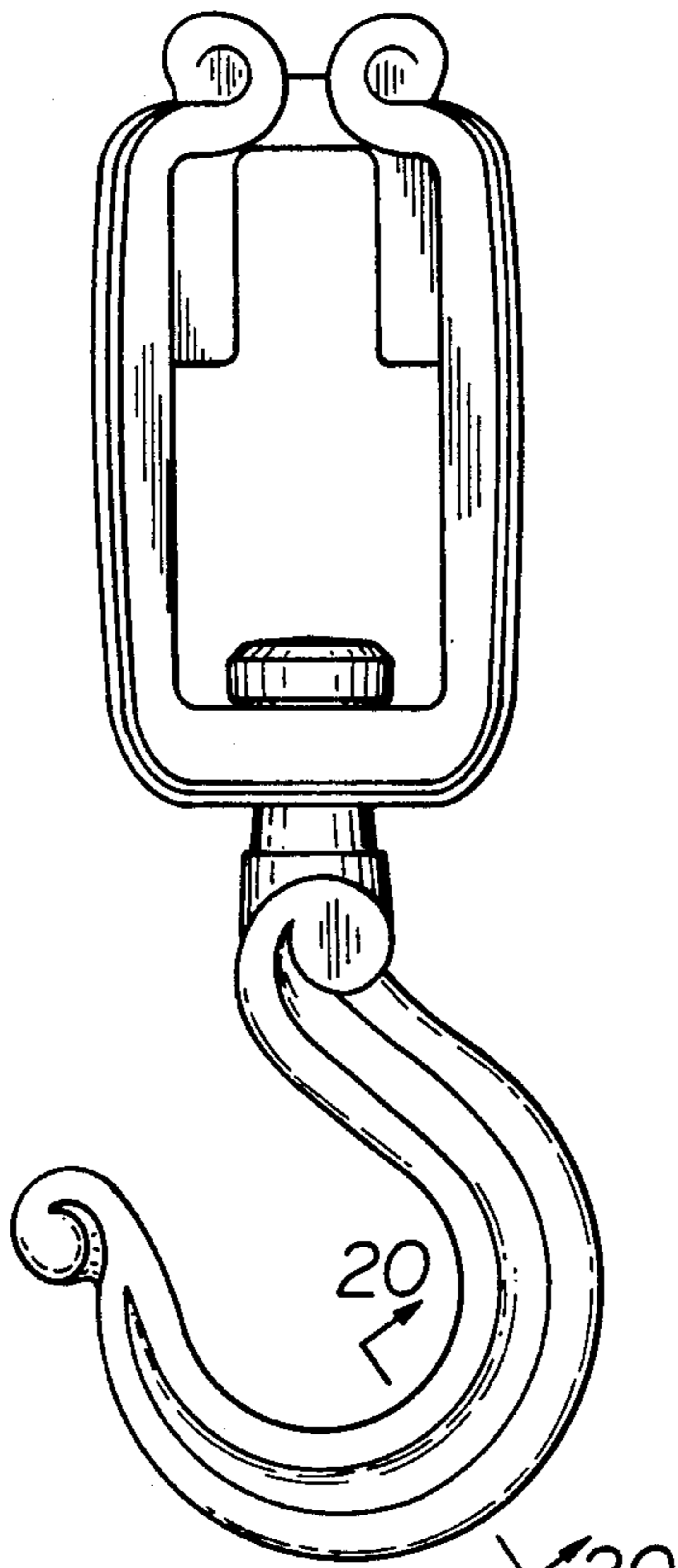

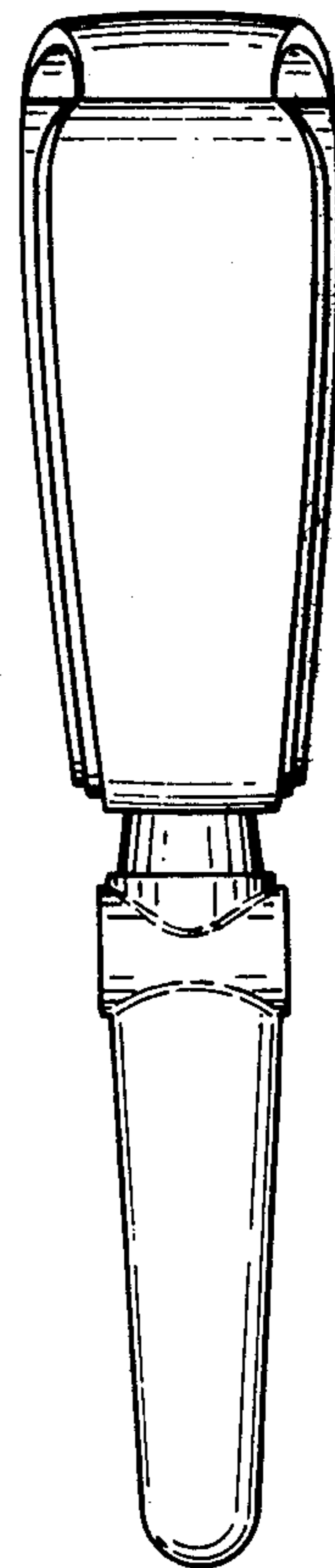

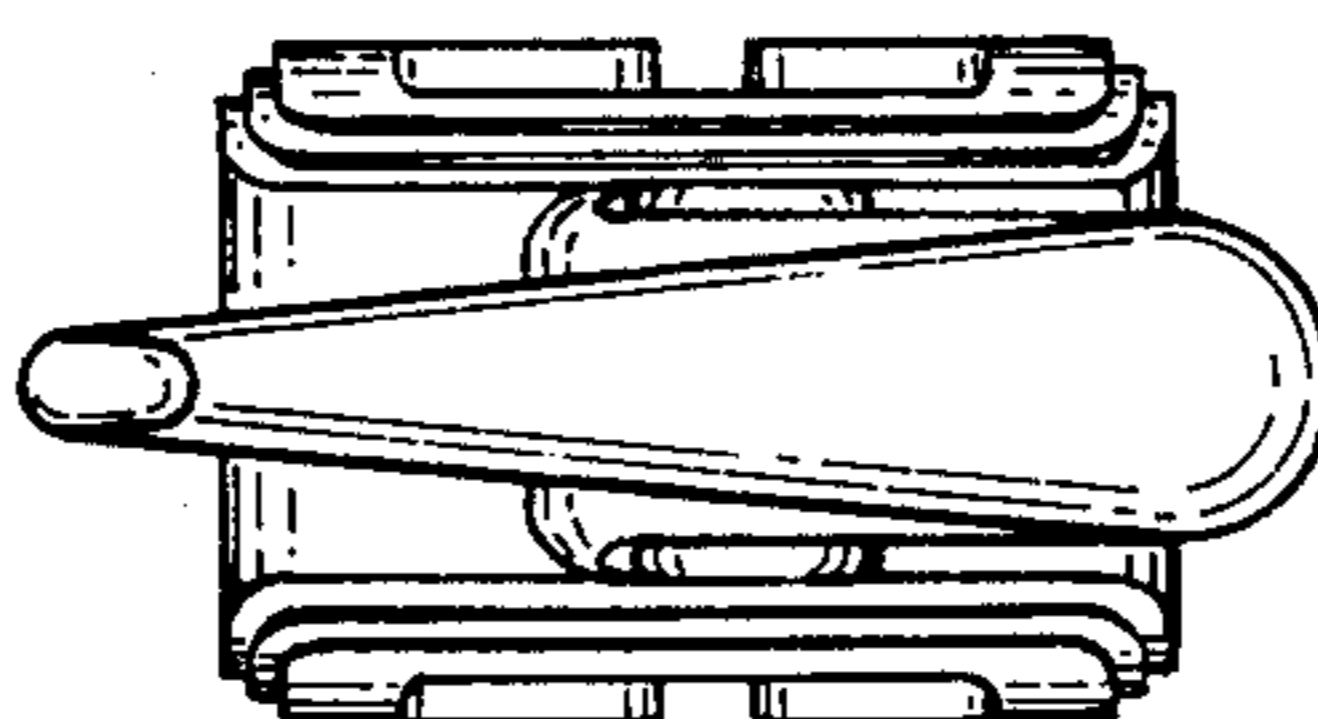
