[57] CLAIM

The ornamental design for a combined gun and acces-

sory cabinet or similar article, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of our combined gun and accessory cabinet or similar article in a closed condition showing our new design;

FIG. 2 is another perspective view of our combined gun and accessory cabinet or similar article in an opened condition;

FIG. 3 is a front perspective view thereof but on a larger scale;

FIG. 4 is a front perspective view of a second embodiment of our combined gun and accessory cabinet or similar article, as shown in FIG. 1;

FIG. 5 is a sectional view taken along line 5—5 of FIG. 4, but on a reduced scale;

FIG. 6 is another sectional view taken along line 6—6 of FIG. 4, but also on a reduced scale;

FIG. 7 is a perspective view of a third embodiment of our combined gun and accessory cabinet or similar article as shown in FIG. 1;

FIG. 8 is a front perspective view of the third embodiment shown in FIG. 7 but on a larger scale;

FIG. 9 is another front perspective view of the third embodiment shown in FIG. 7, but in a different rotative position;

FIG. 10 is a sectional view taken along the line 10—10 of FIG. 9, but on a reduced scale;

FIG. 11 is another sectional view taken along line 11—11 of FIG. 9 but also on a reduced scale;

FIG. 12 is a fifth embodiment of our combined gun and accessory cabinet or similar article, as shown in FIG. 1;

FIG. 13 is a front perspective view of the fourth embodiment of our design shown in FIG. 12 but on a larger scale; and

FIG. 14 is a front perspective view of a sixth embodiment of our combined gun and accessory cabinet or similar article shown in FIG. 1.

The rear and the one side of a combined gun and accessory cabinet or similar article not shown in the drawings are substantially plain and unornamented.

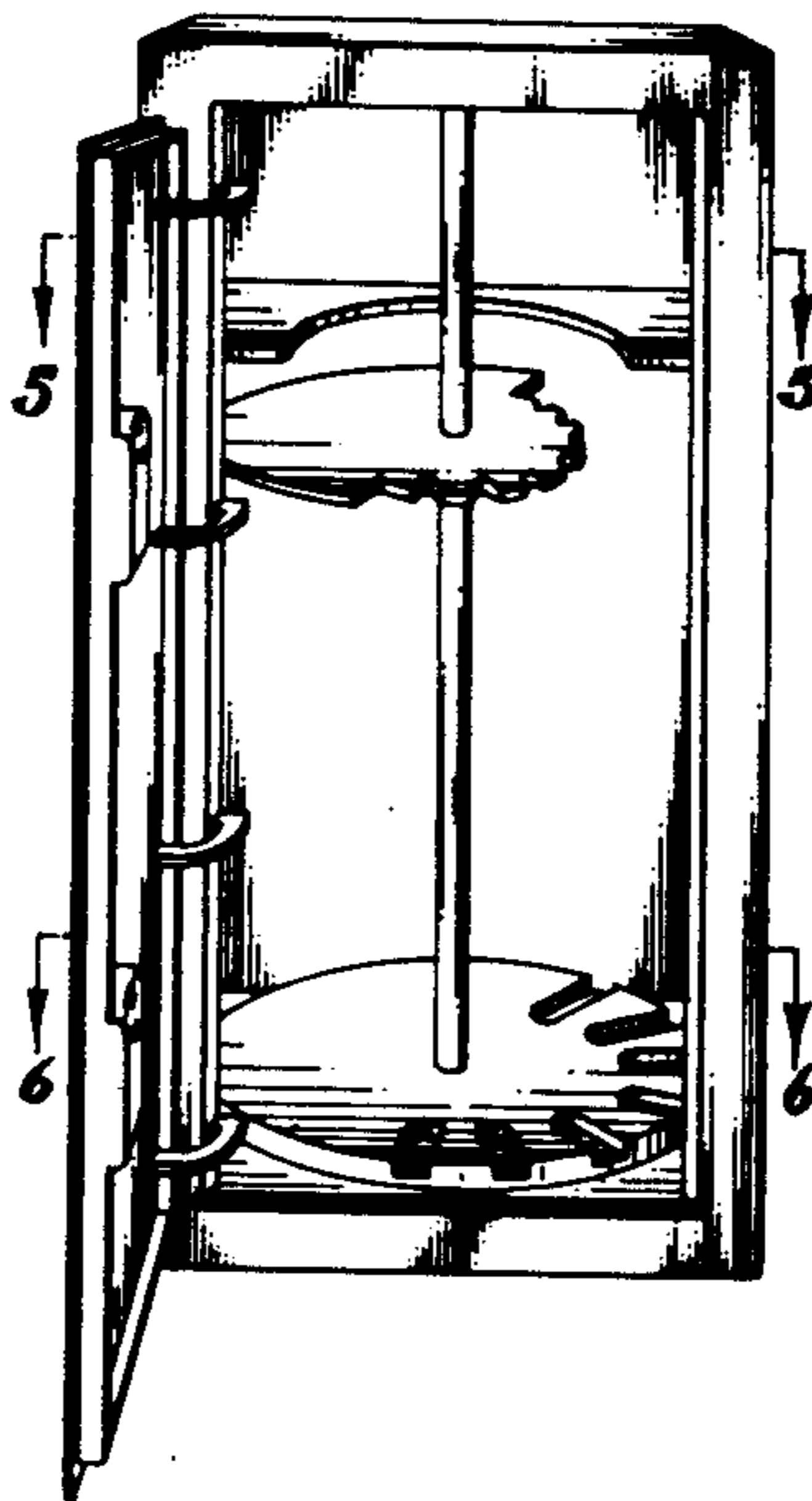

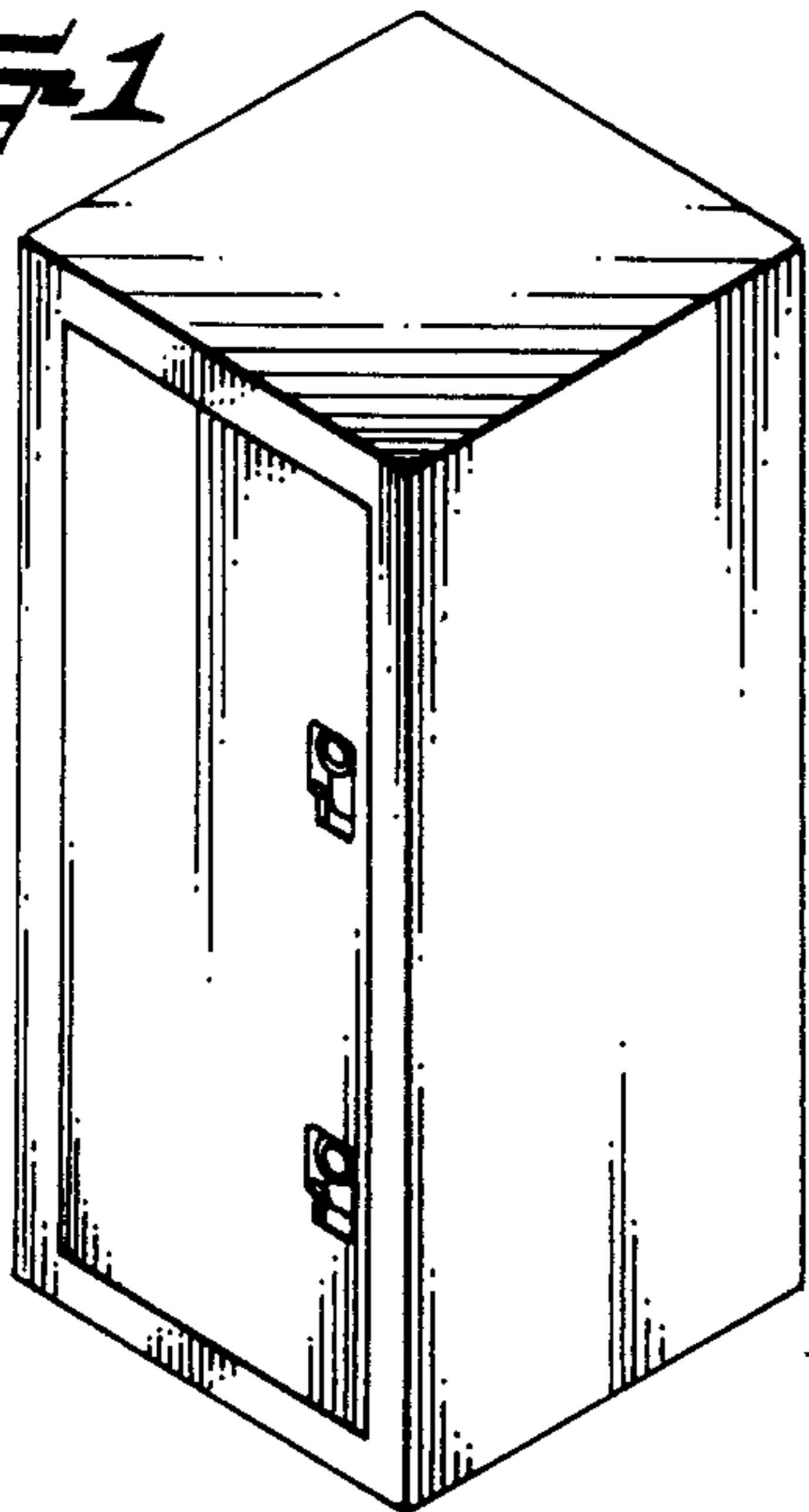

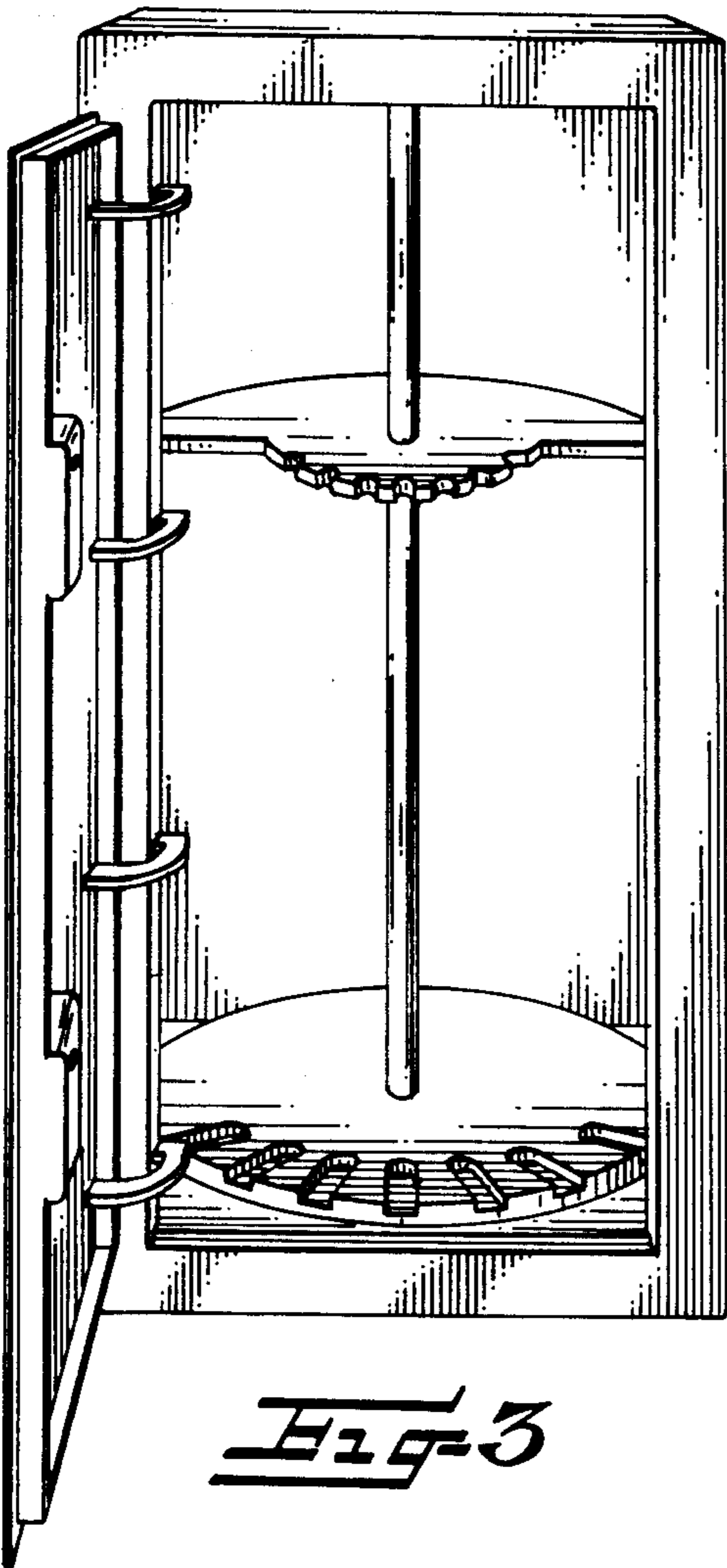
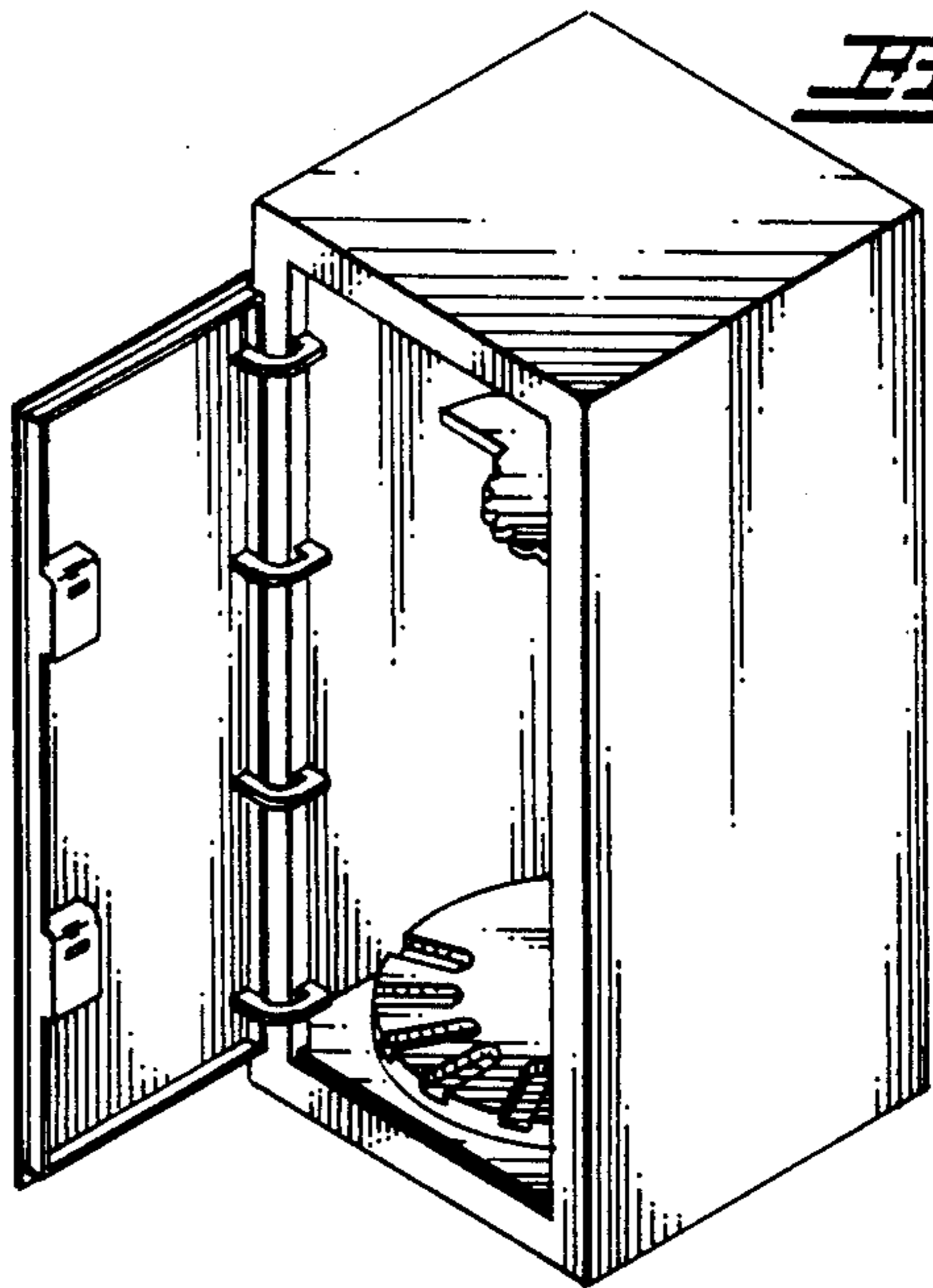

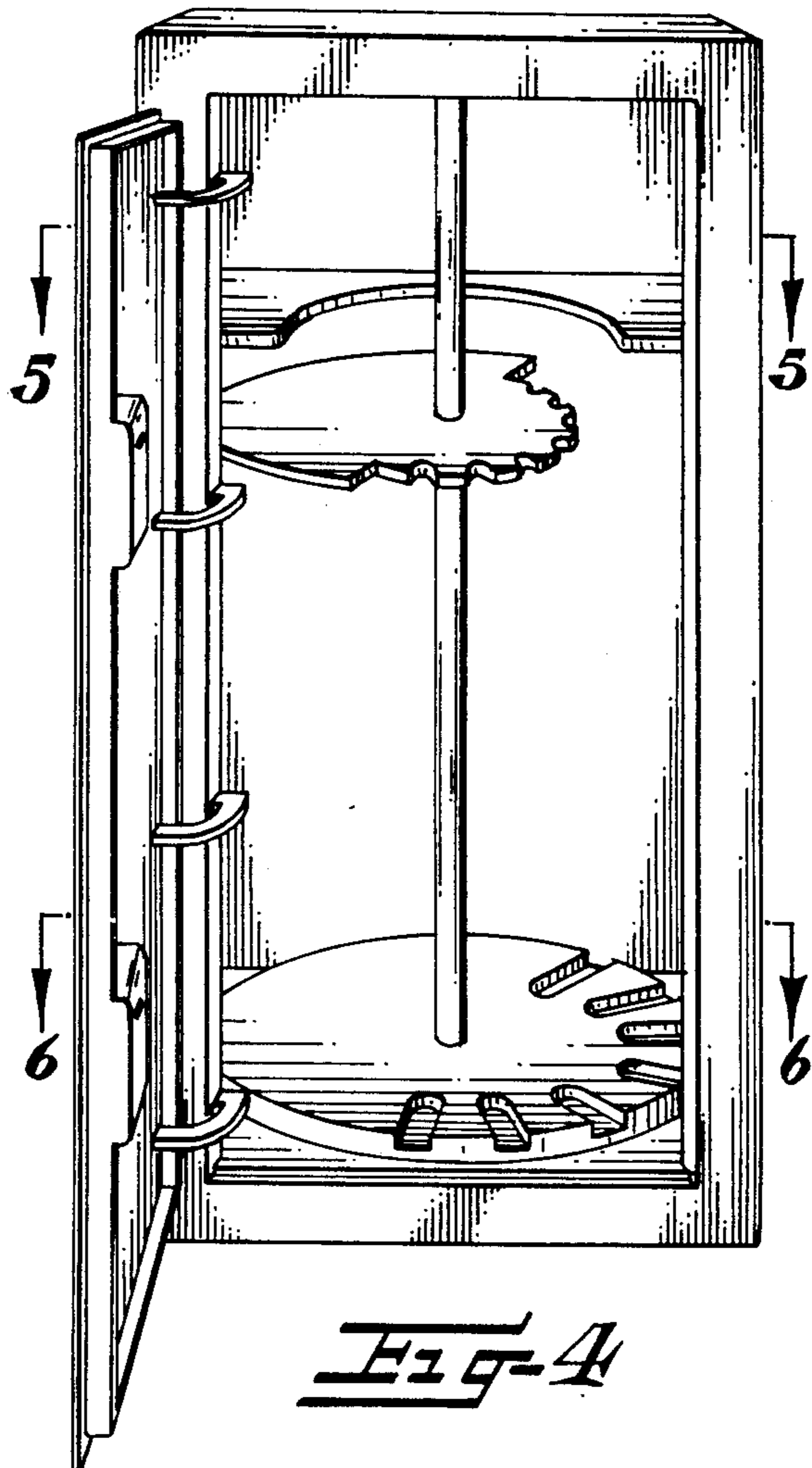

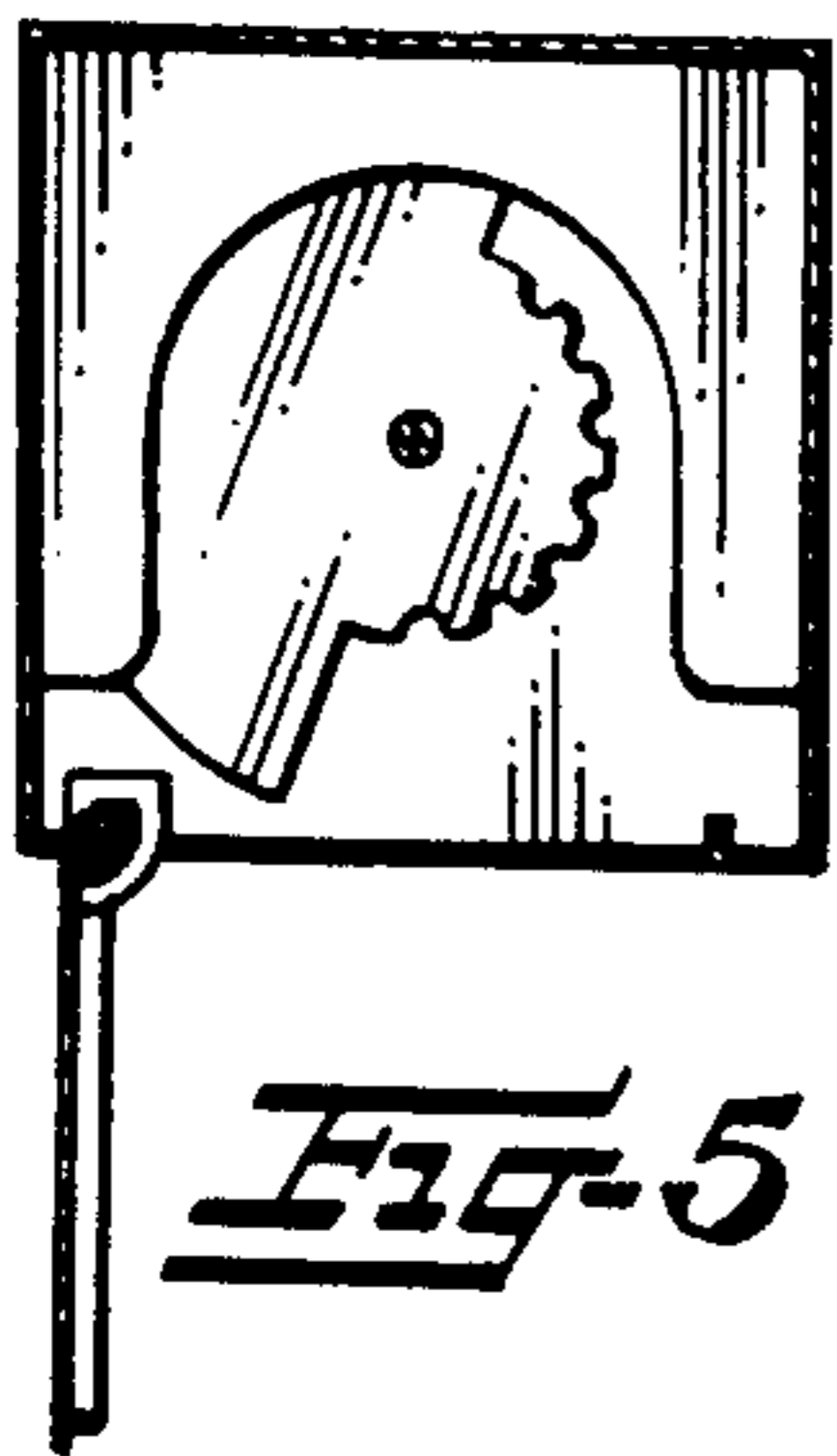

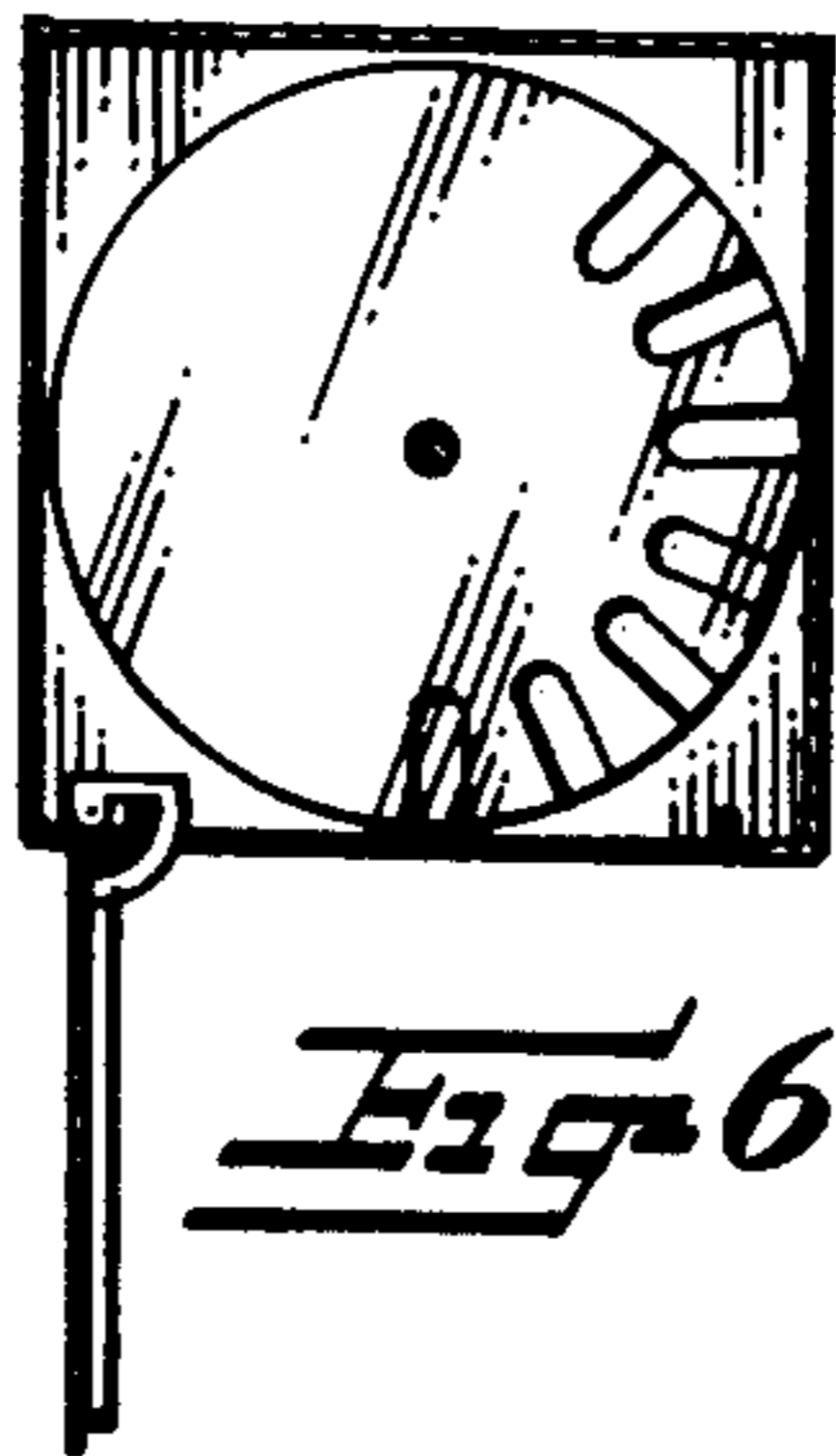

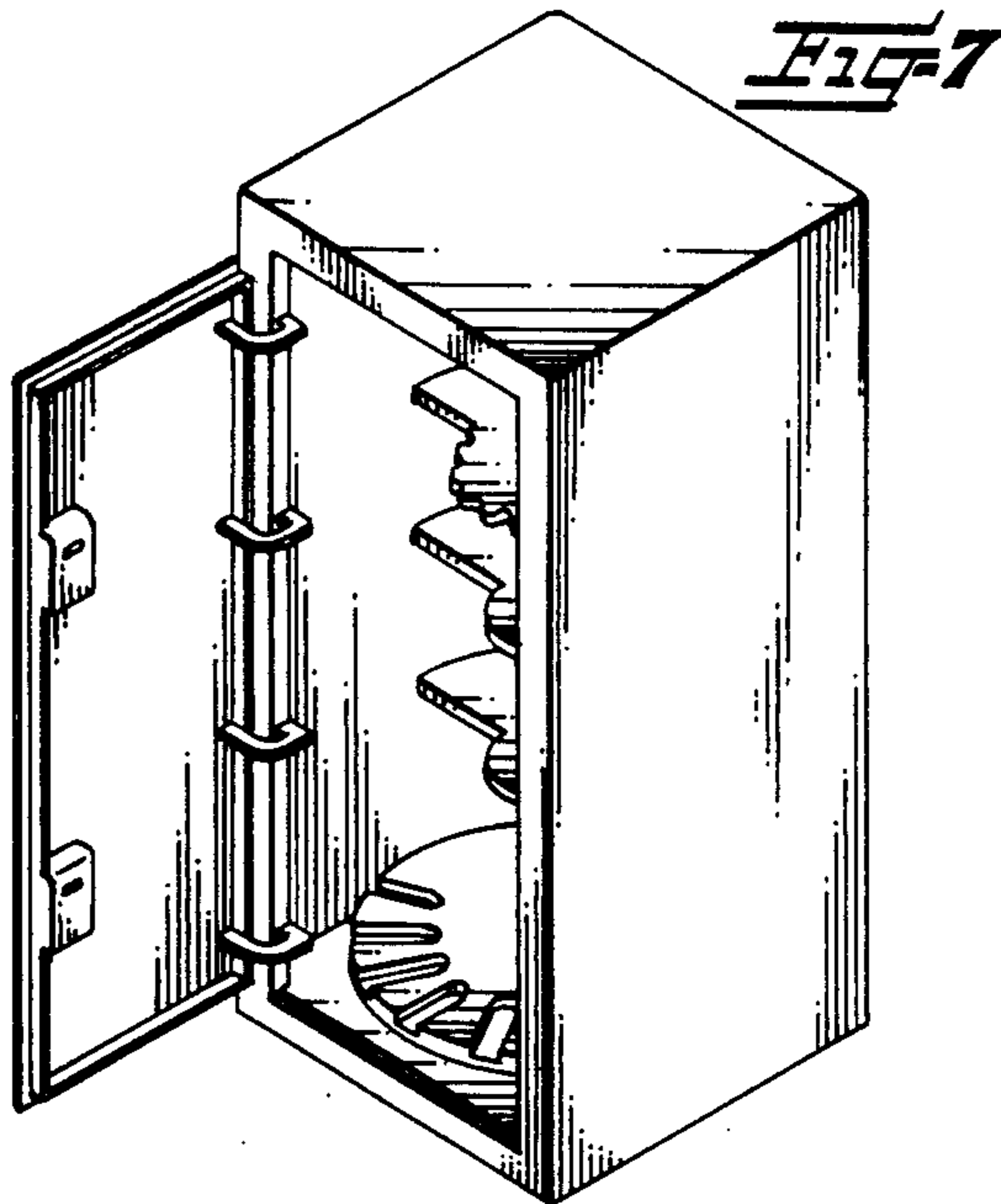

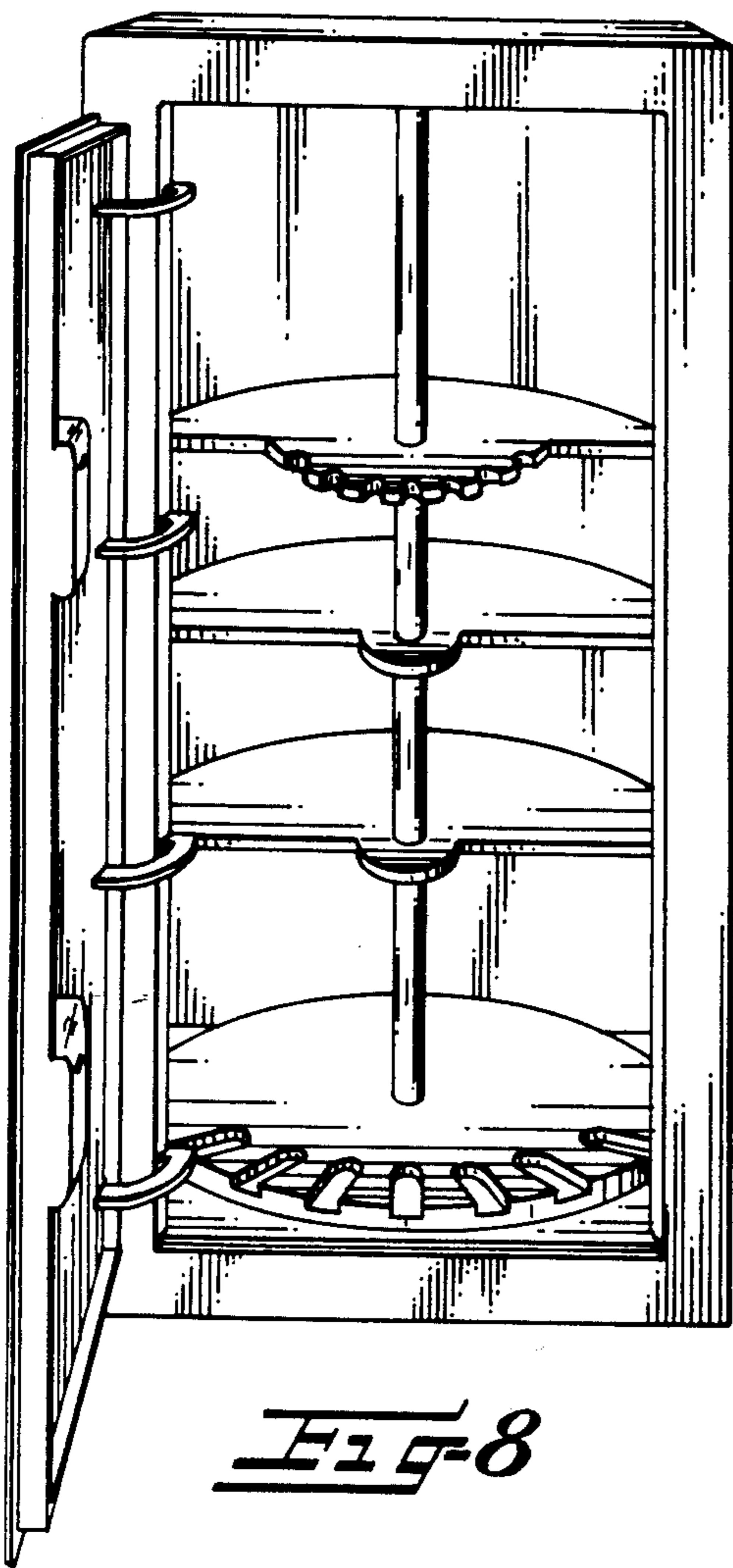

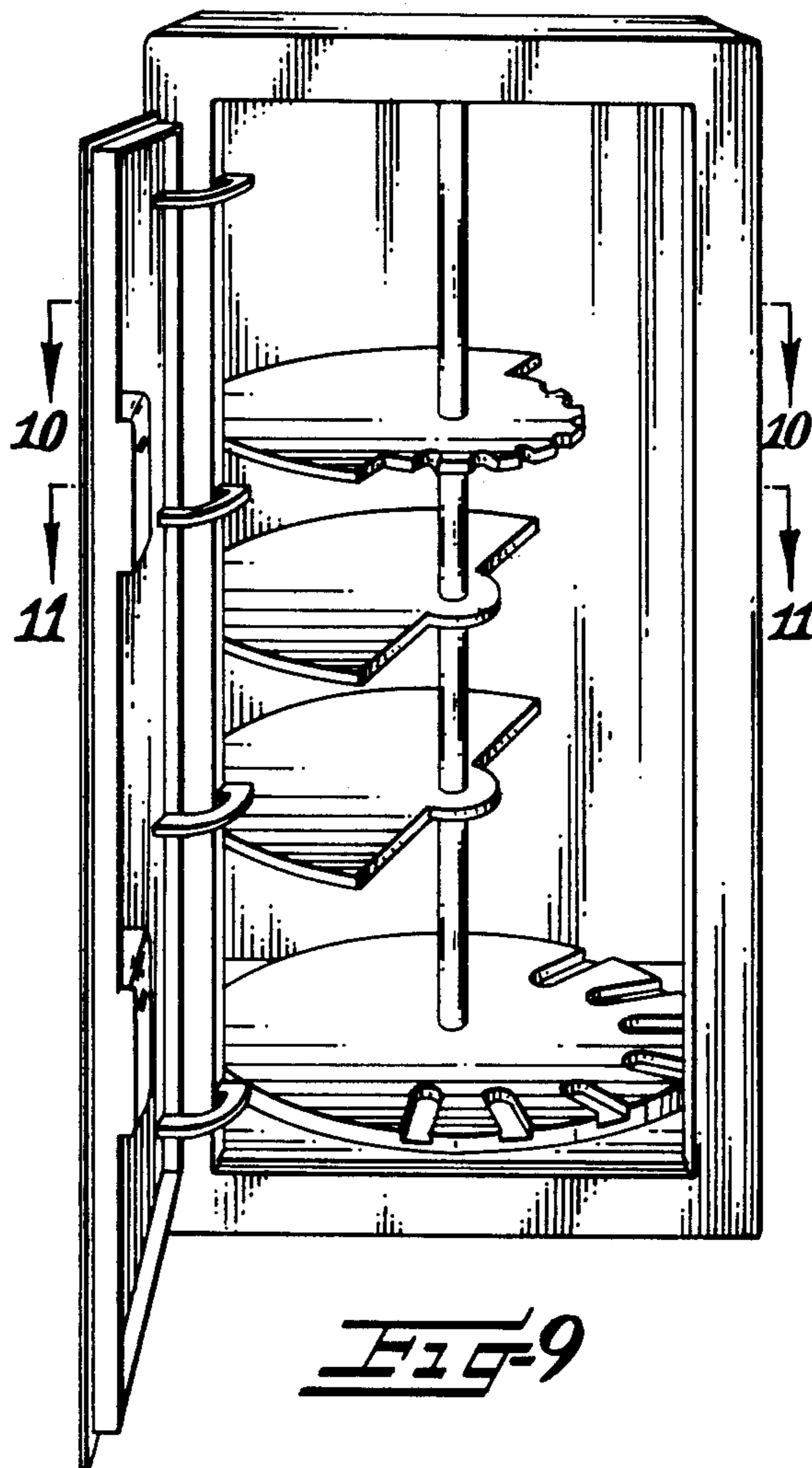
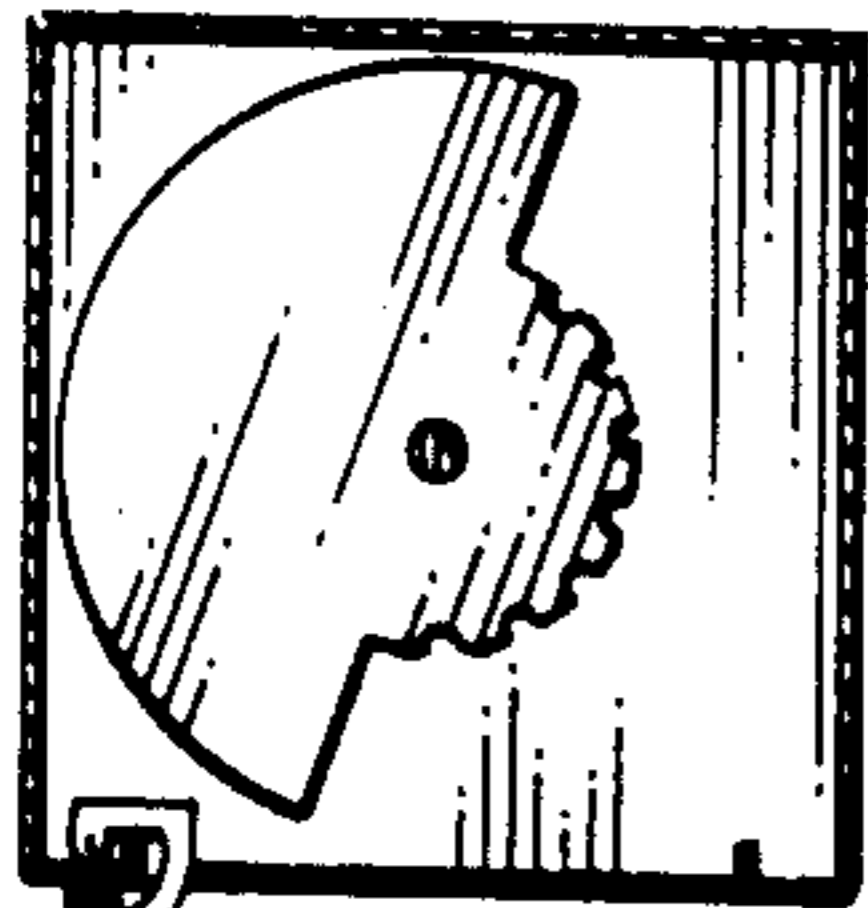
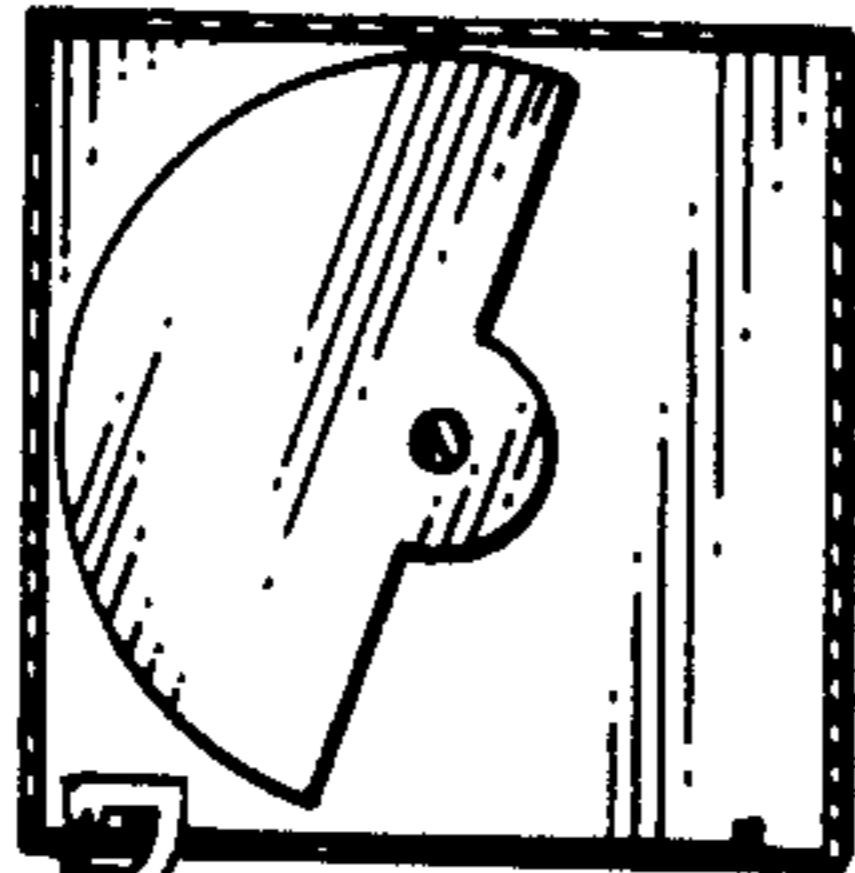


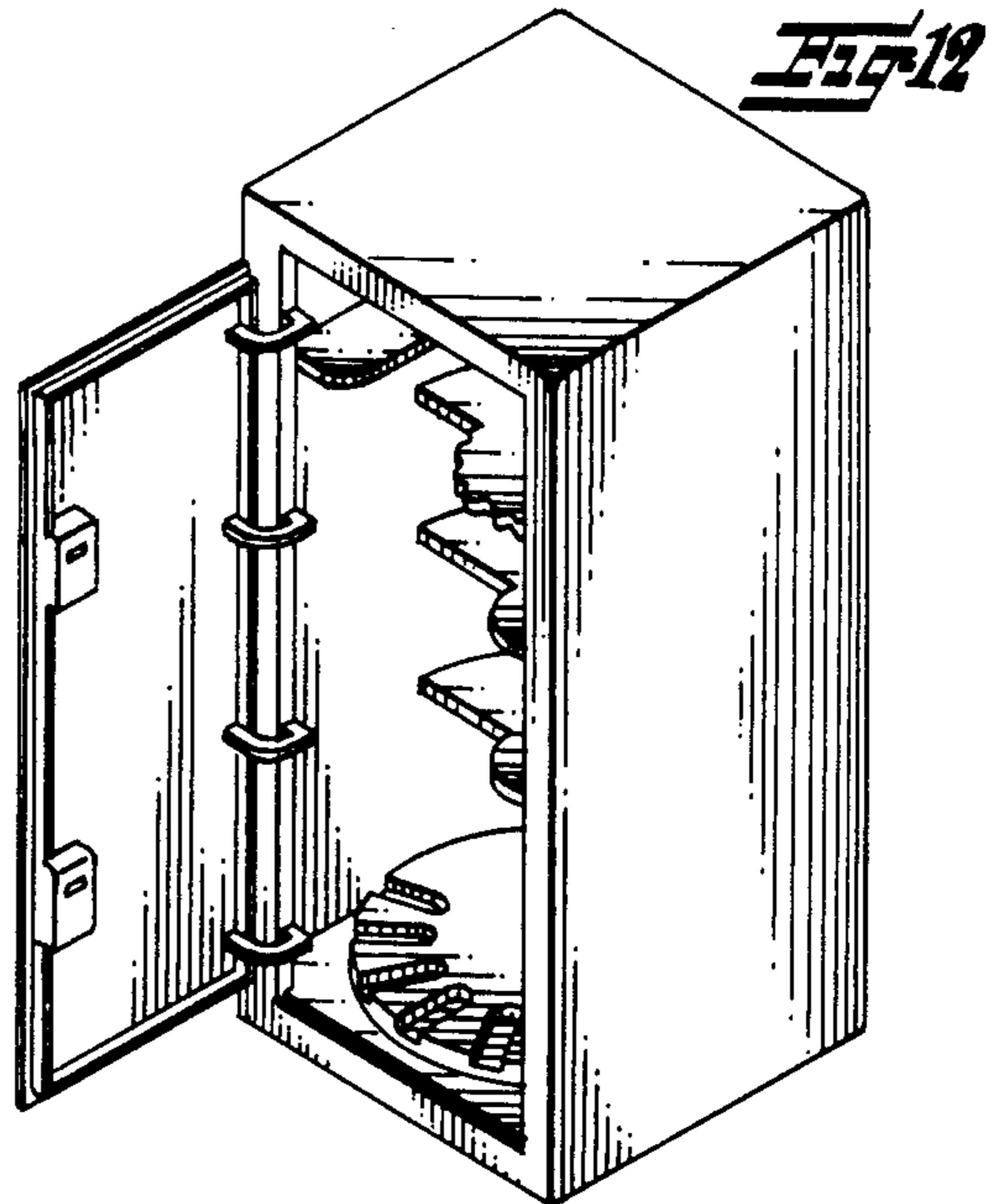

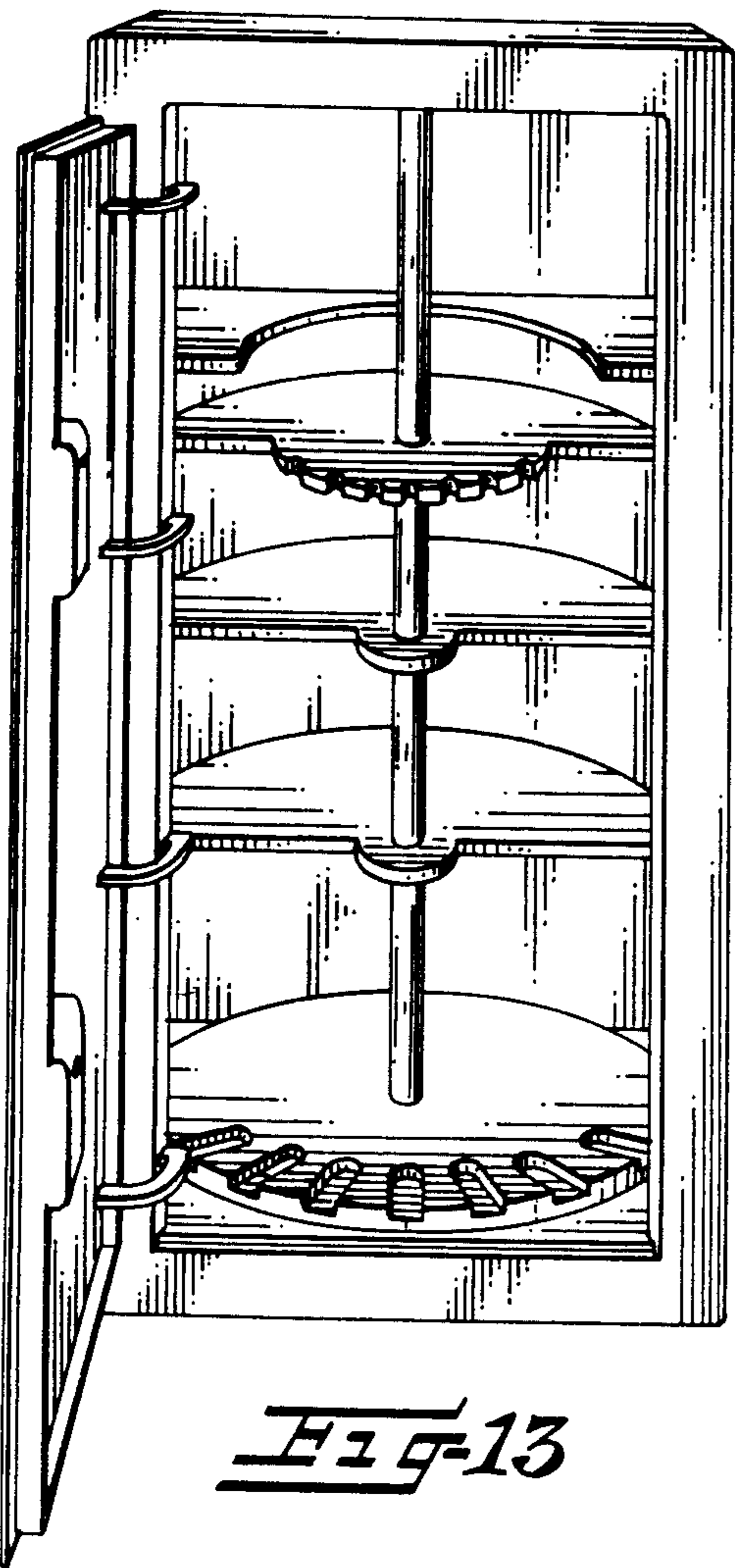

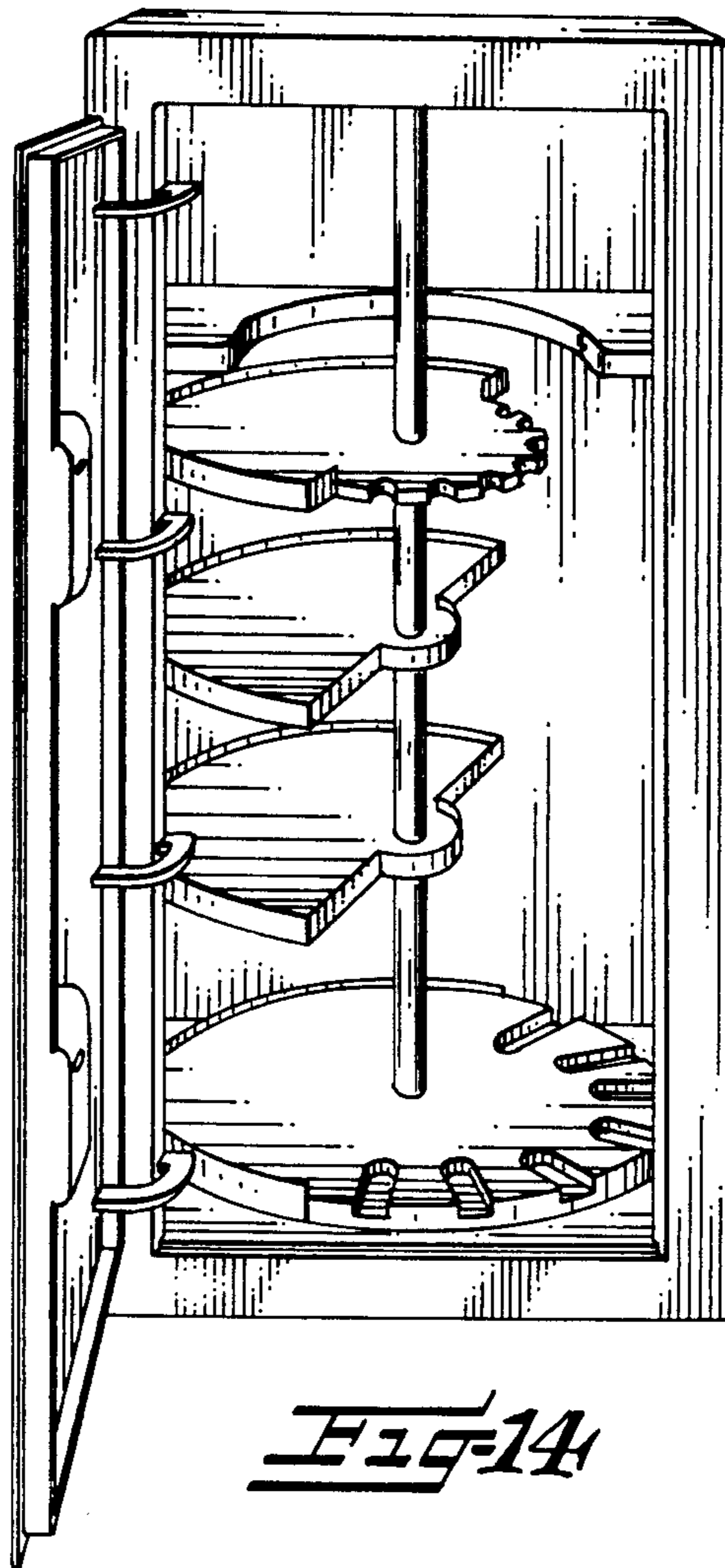
