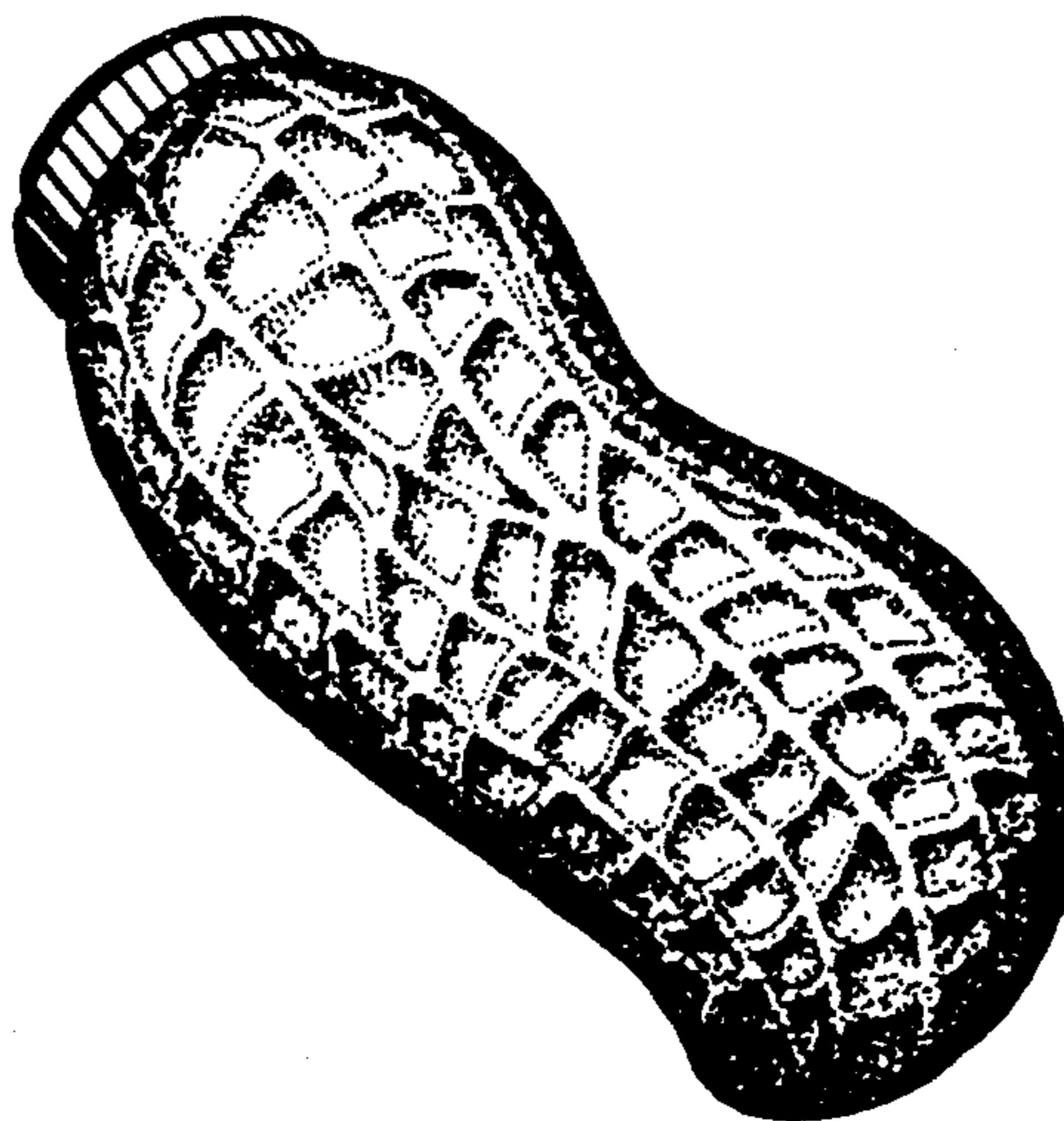

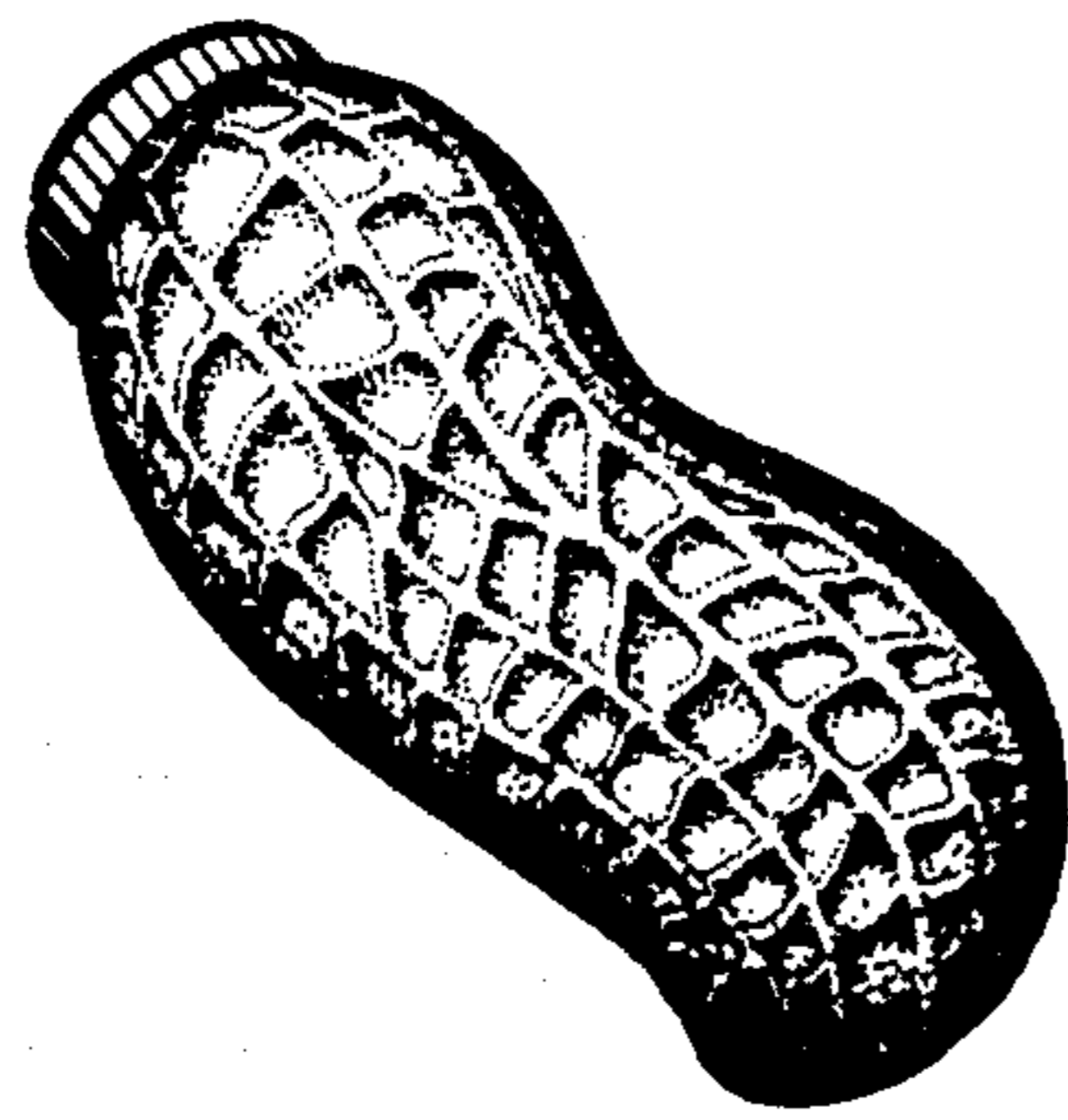
[57] CLAIM

The ornamental design for a shoelace tassel, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a shoelace tassel showing my new design;  
 FIG. 2 is a left end elevational view thereof;  
 FIG. 3 is a right end elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a right side elevational view thereof;  
 FIG. 8 is a left end elevational view thereof with the lace connector omitted for ease of illustration;  
 FIG. 9 is a perspective view of the lace connector with the tassel socket omitted for ease of illustration;  
 FIG. 10 is a side elevational view of the lace connector of FIG. 9 with the tassel socket omitted for ease of illustration;  
 FIG. 11 is a left end elevational view of the lace connector of FIG. 10 with the tassel socket omitted for ease of illustration;  
 FIG. 12 is a right end elevational view of the lace connector of FIG. 10 with the tassel socket omitted for ease of illustration;  
 FIG. 13 is a top plan view of the lace connector of FIG. 10, with the tassel socket omitted for ease of illustration, the bottom plan view being identical thereto.





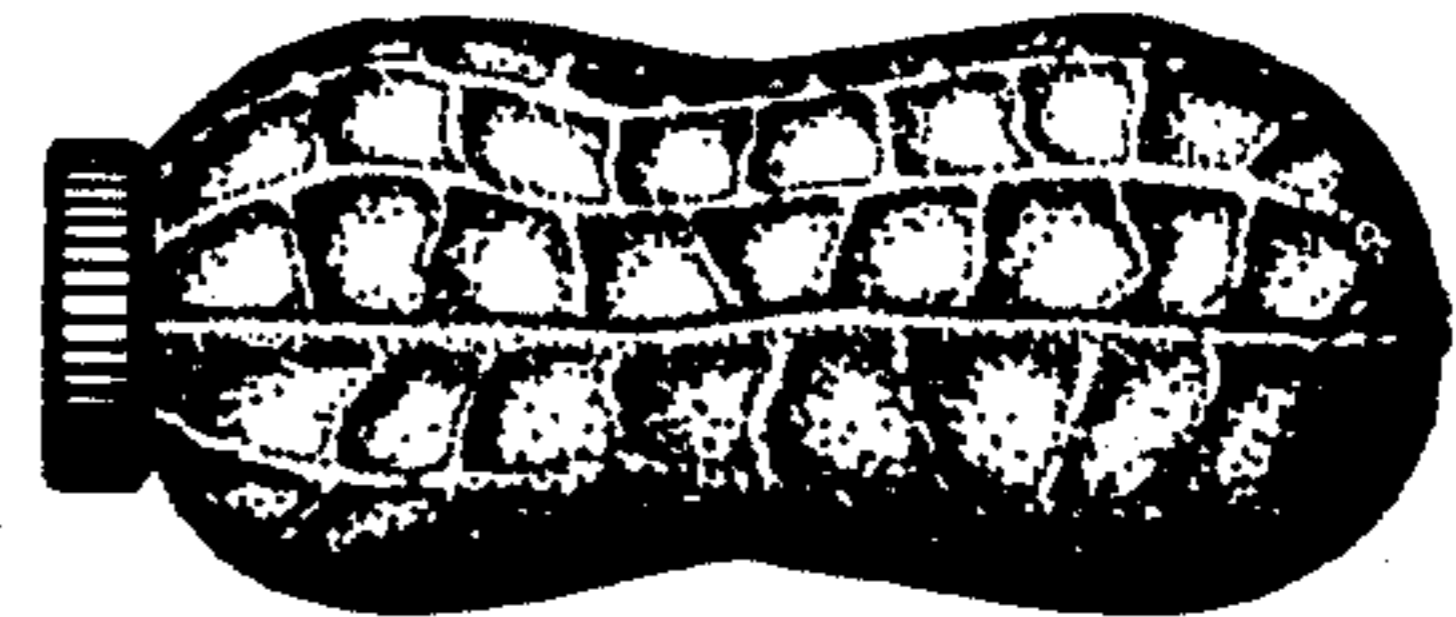

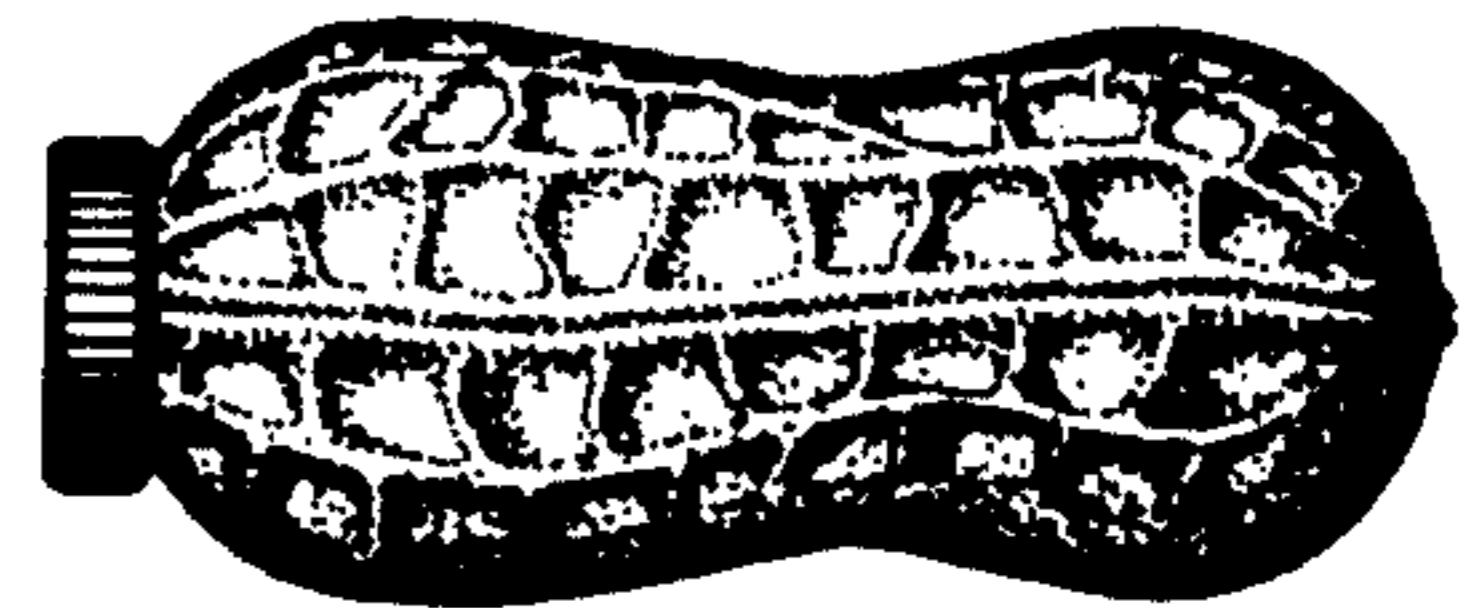

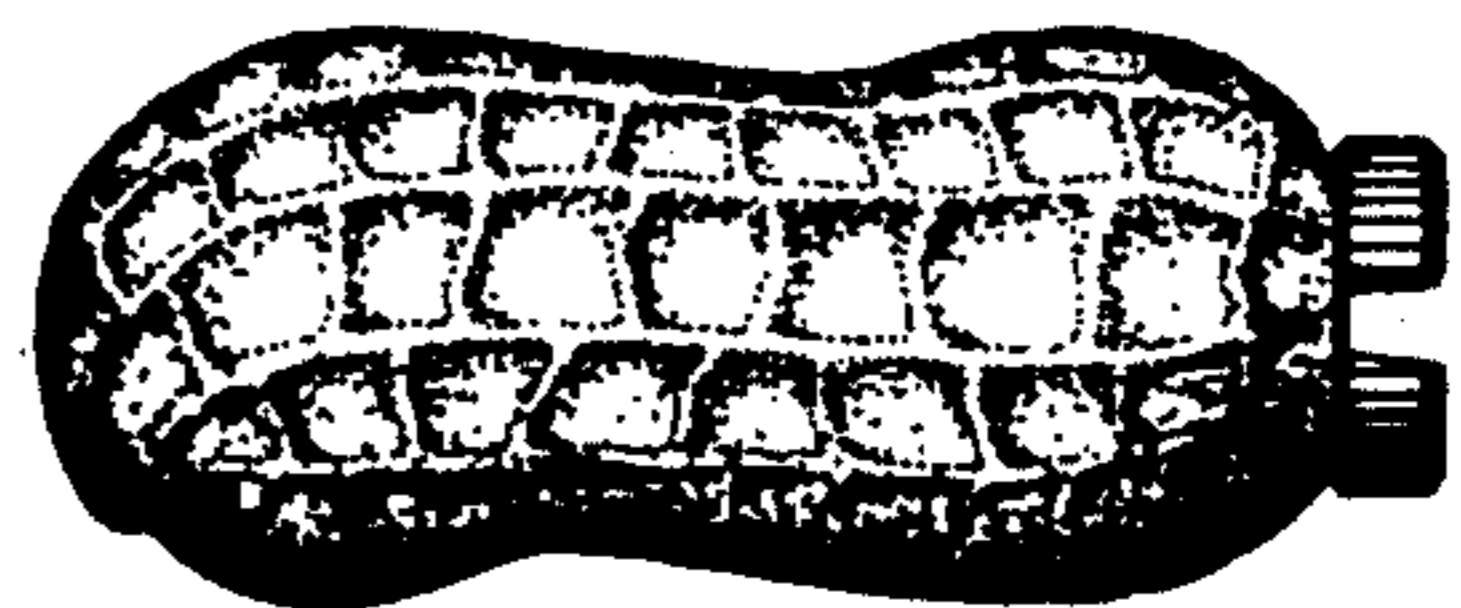

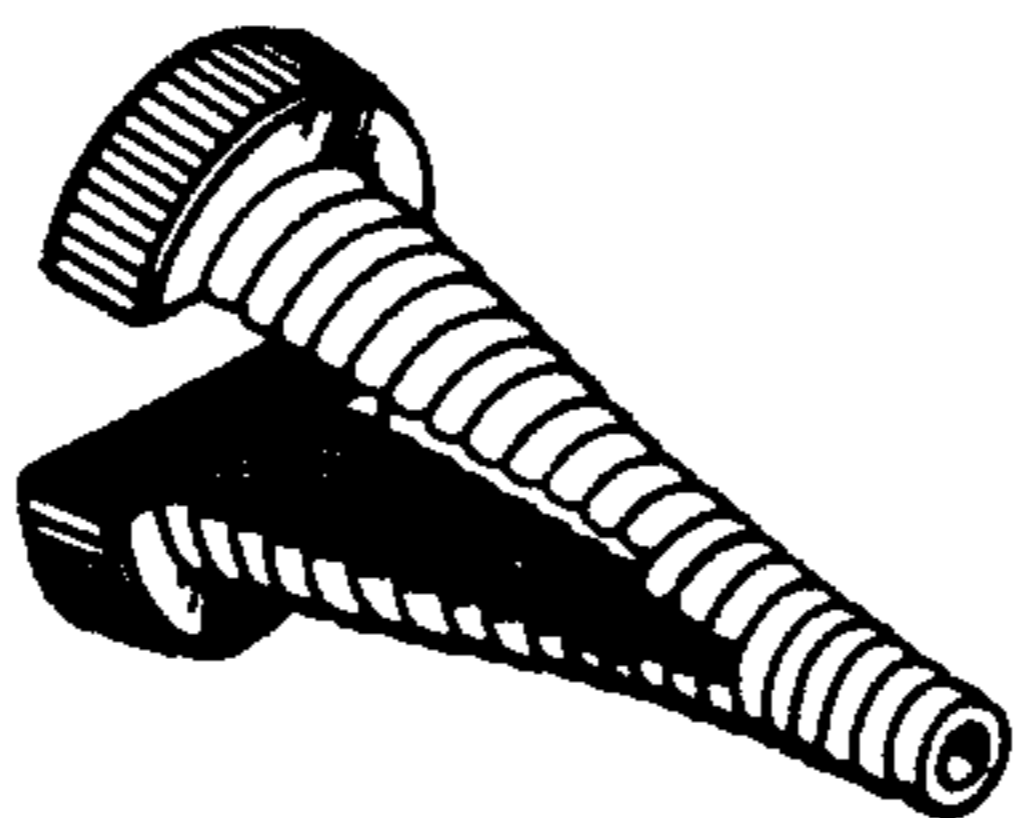

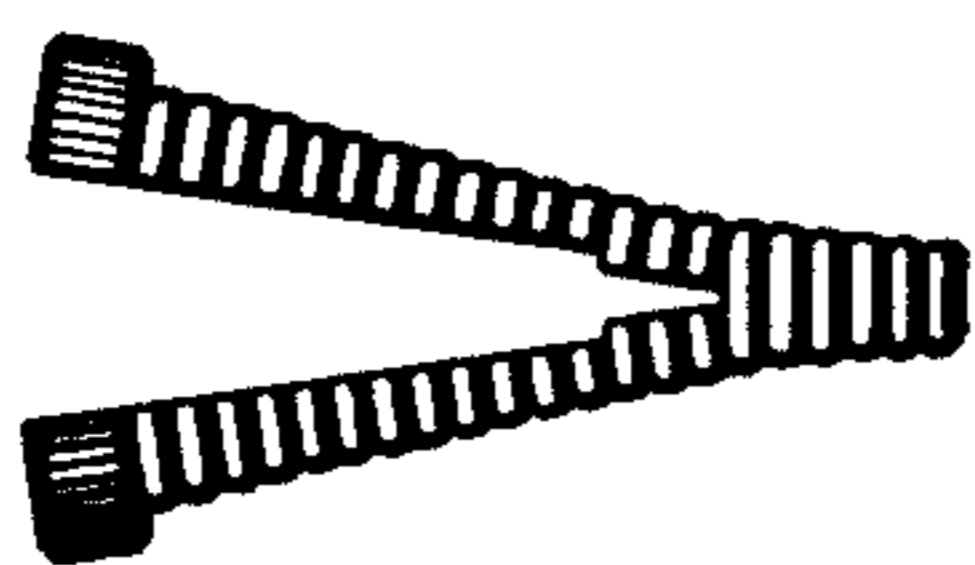
