[57] CLAIM

The ornamental design for a key head cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a key head cover show-

ing my new design it being understood that the broken lines are for illustrative purposes only;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the rear being substantially a mirror image of the front shown therein;

FIG. 4 is a side elevational view thereof, the opposite side being substantially a mirror image of the side shown therein;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view of a second embodiment of the key head cover of my new design it being understood that the broken lines are for illustrative purposes only;

FIG. 7 is a top plan view of FIG. 6;

FIG. 8 is a front elevational view of FIG. 6, the rear being substantially a mirror image of the front shown therein;

FIG. 9 is a side elevational view of FIG. 6, the opposite side being substantially a mirror image of the side shown therein;

FIG. 10 is a bottom plan view of FIG. 6;

FIG. 11 is a perspective view of a third embodiment of the key head cover of my new design it being understood that the broken lines are for illustrative purposes only;

FIG. 12 is a top plan view of FIG. 11;

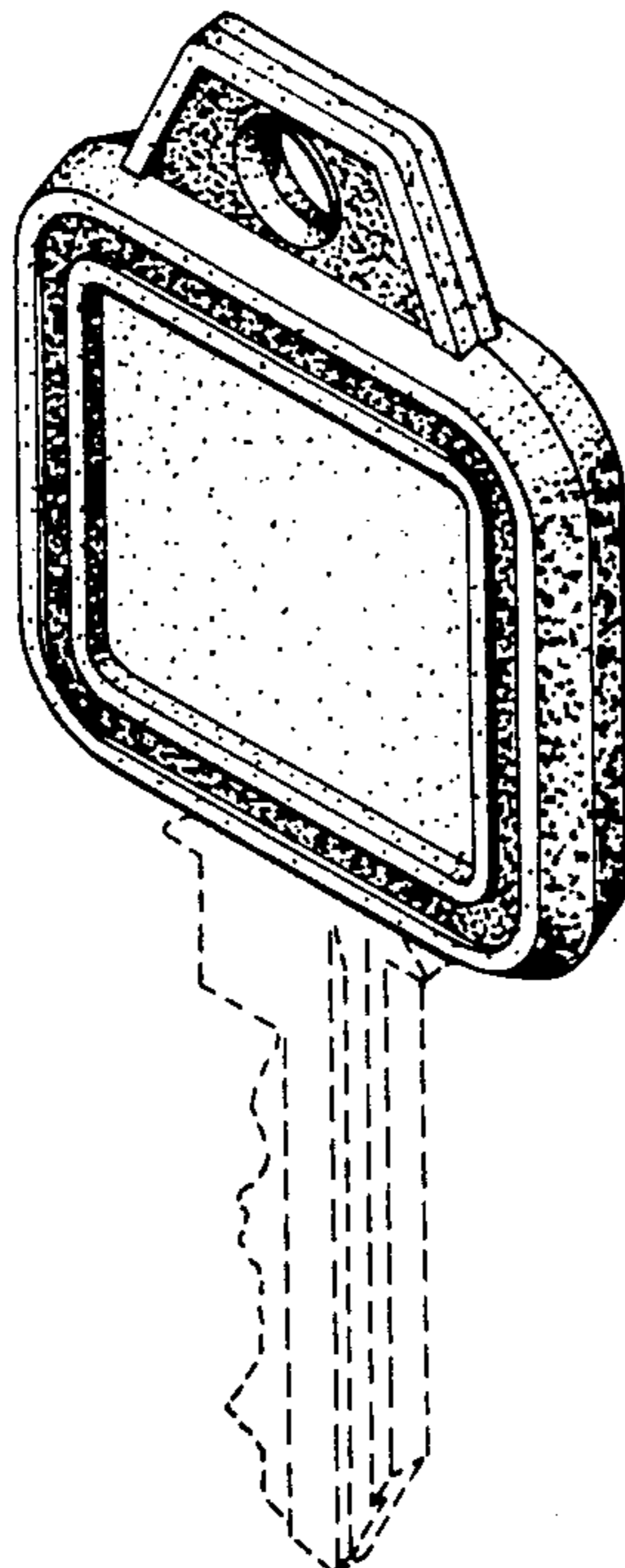
FIG. 13 is a front elevational view of FIG. 11;

FIG. 17 is a bottom plan view of FIG. 11.



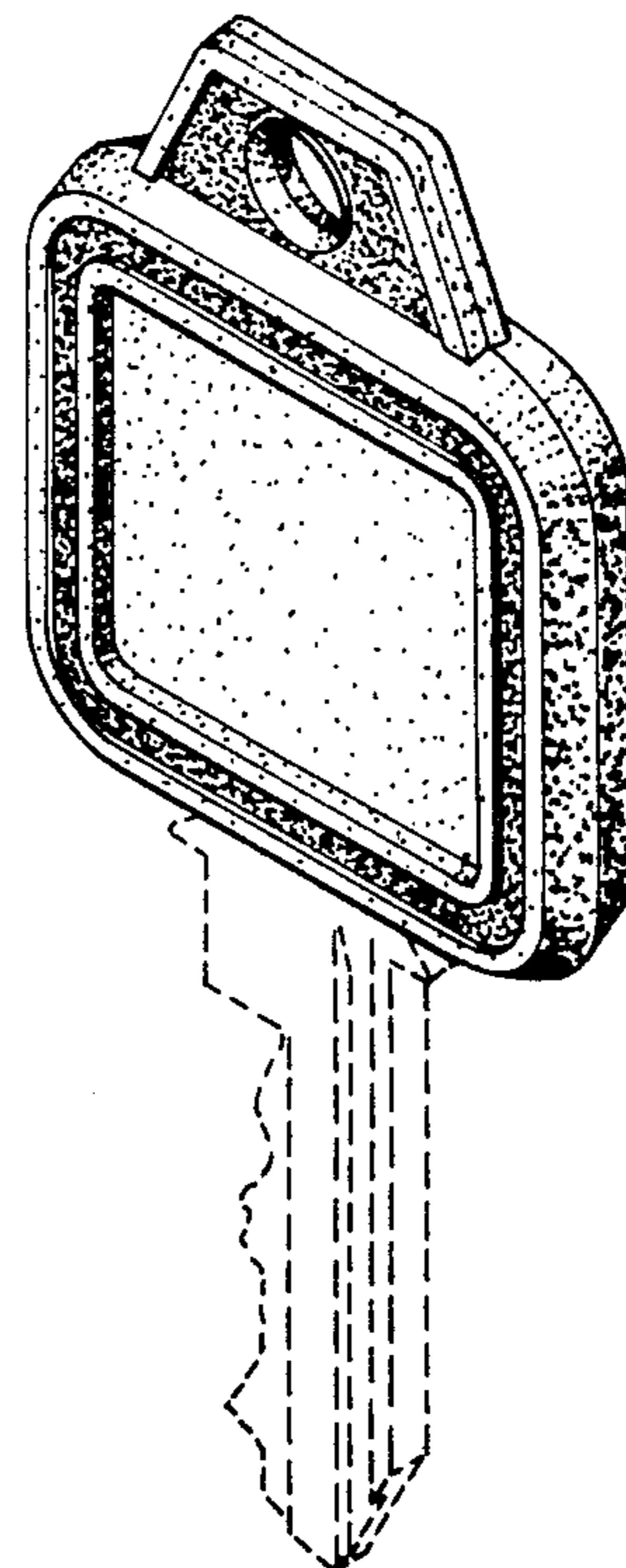

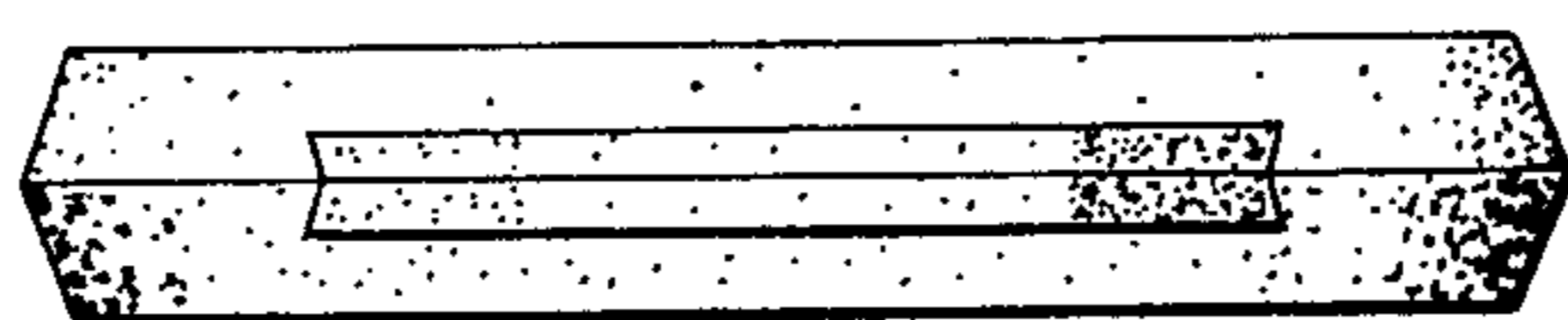

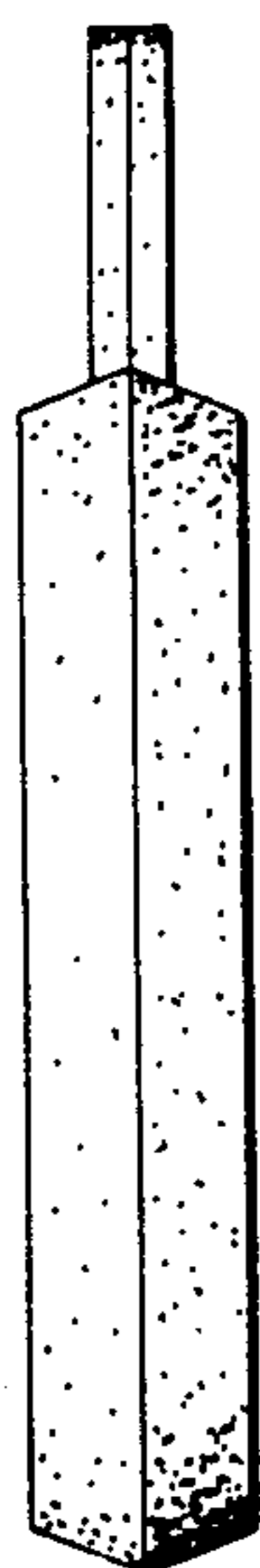

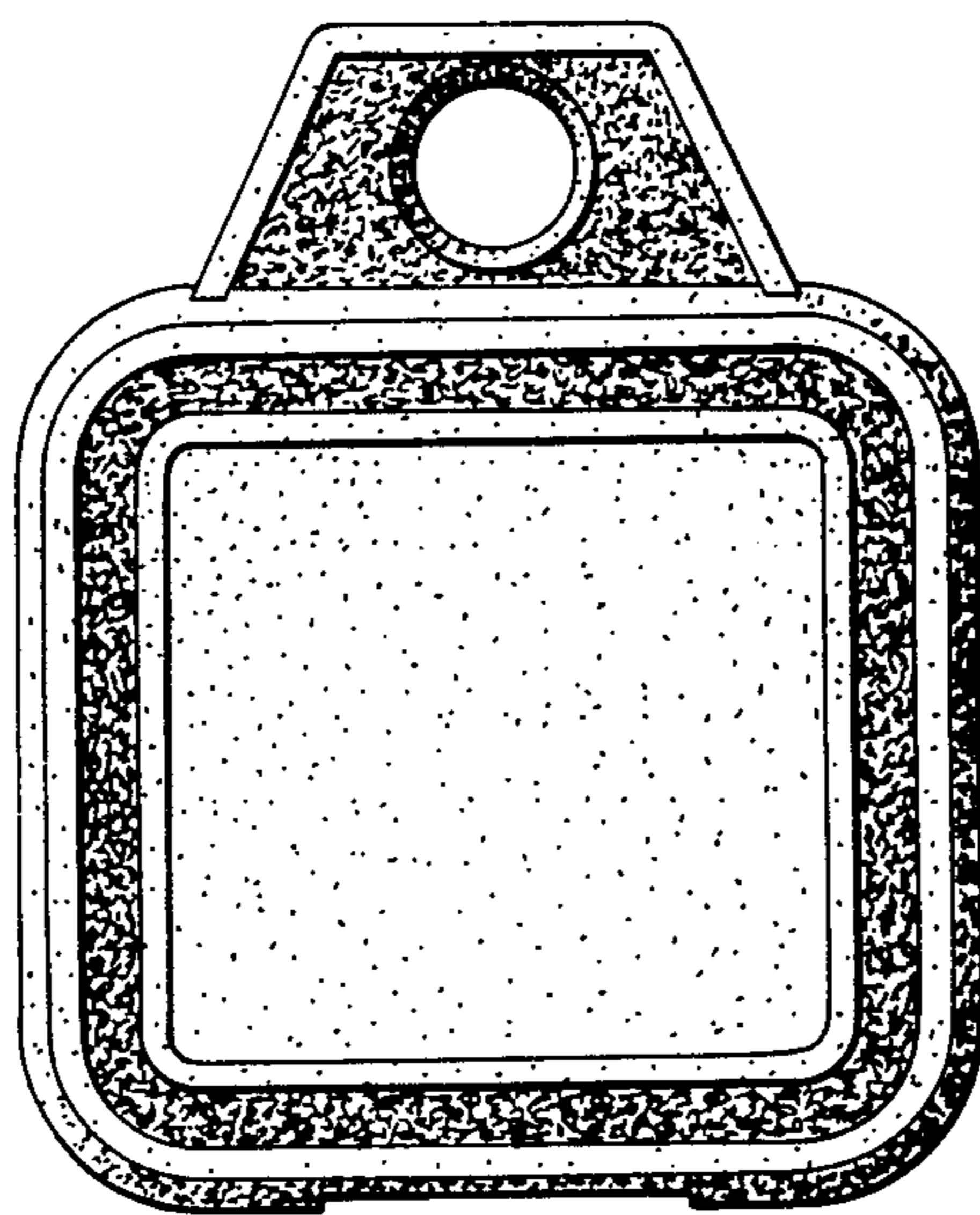

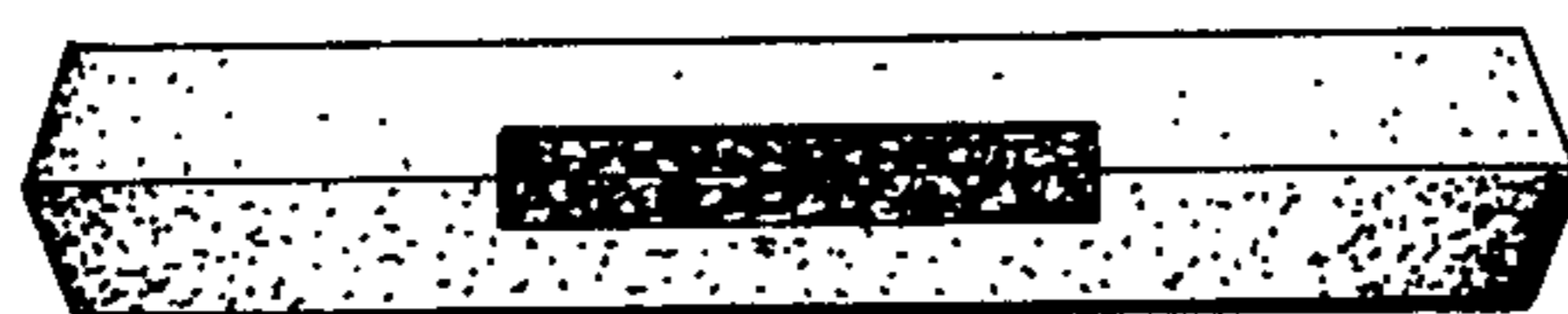

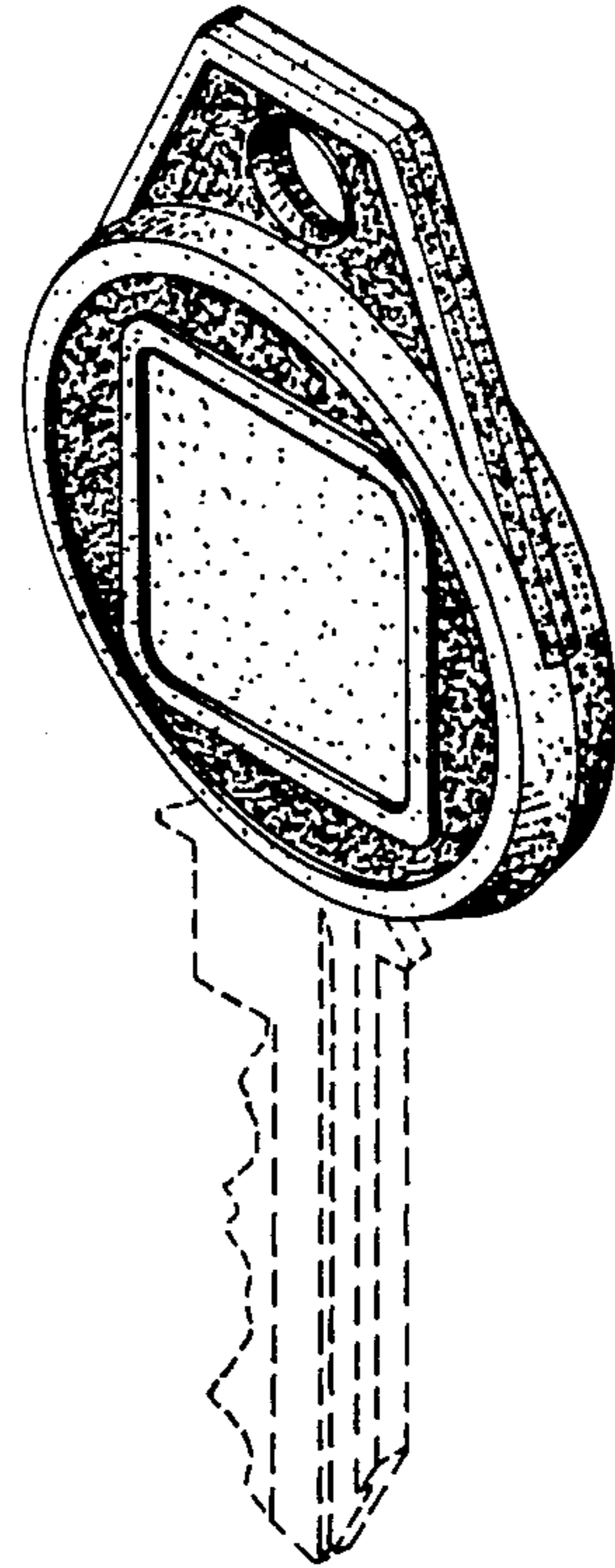

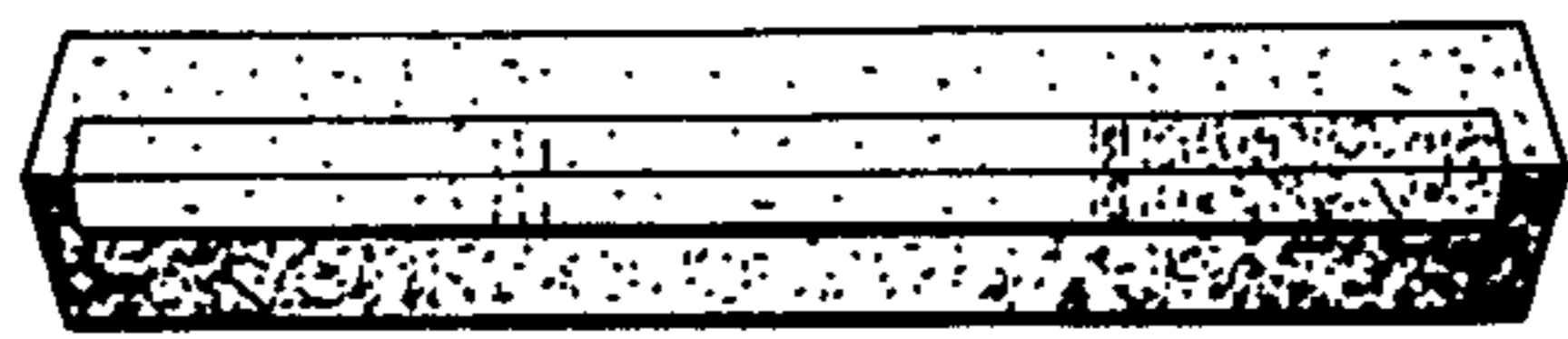

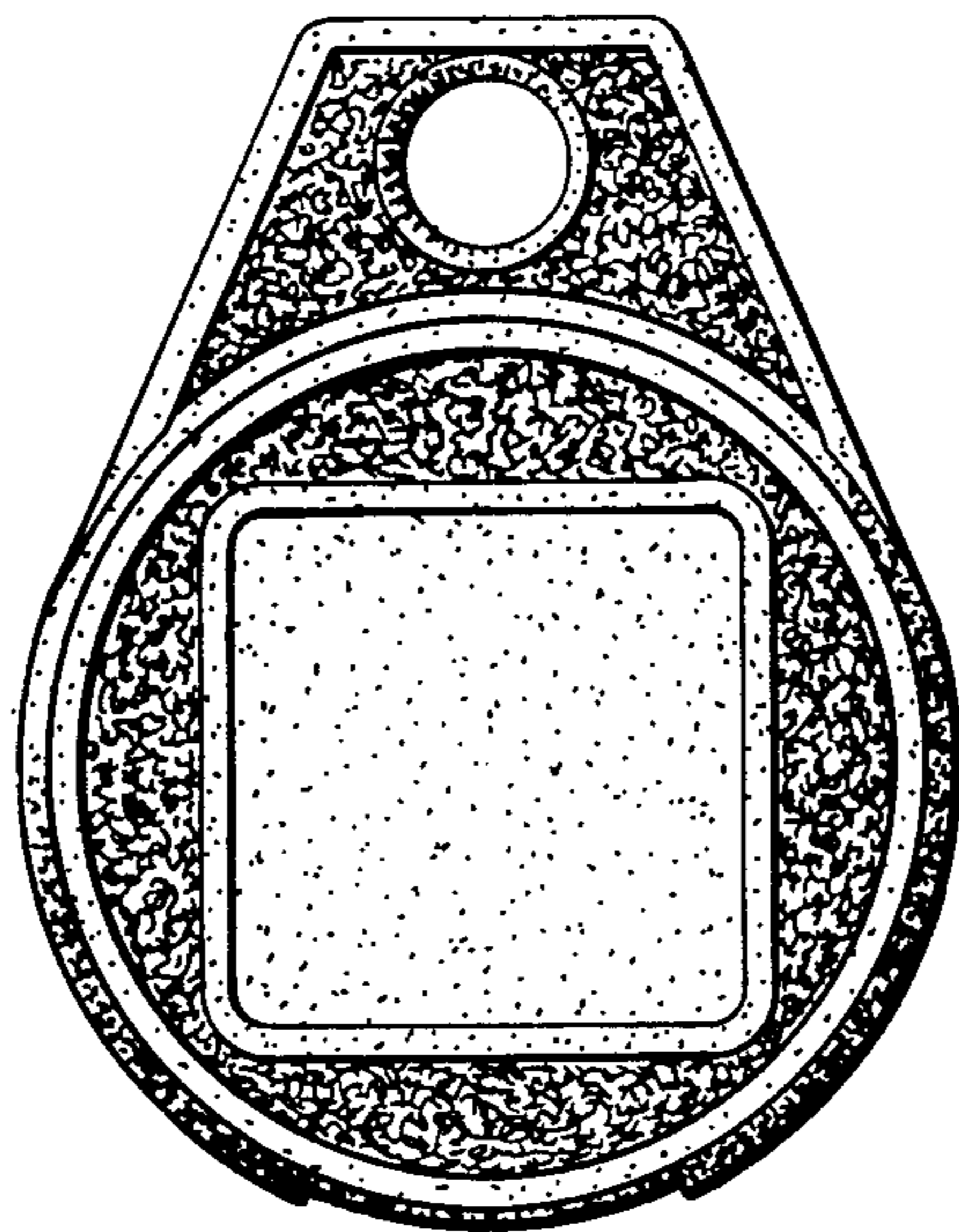

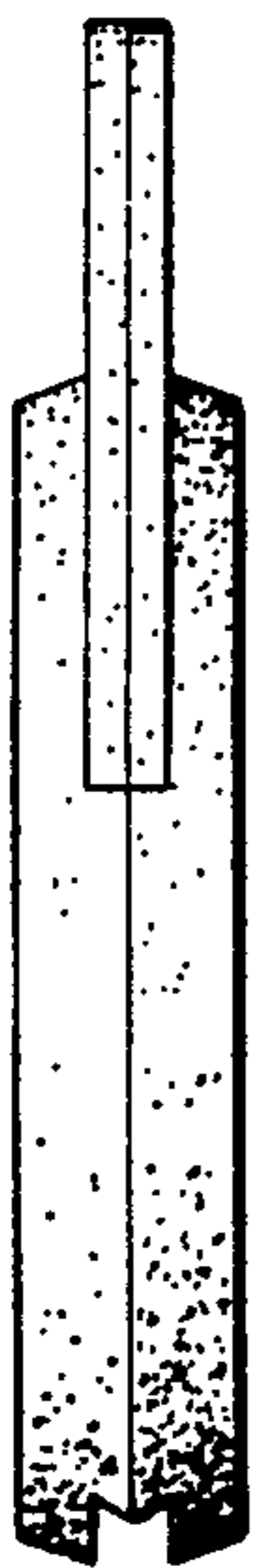

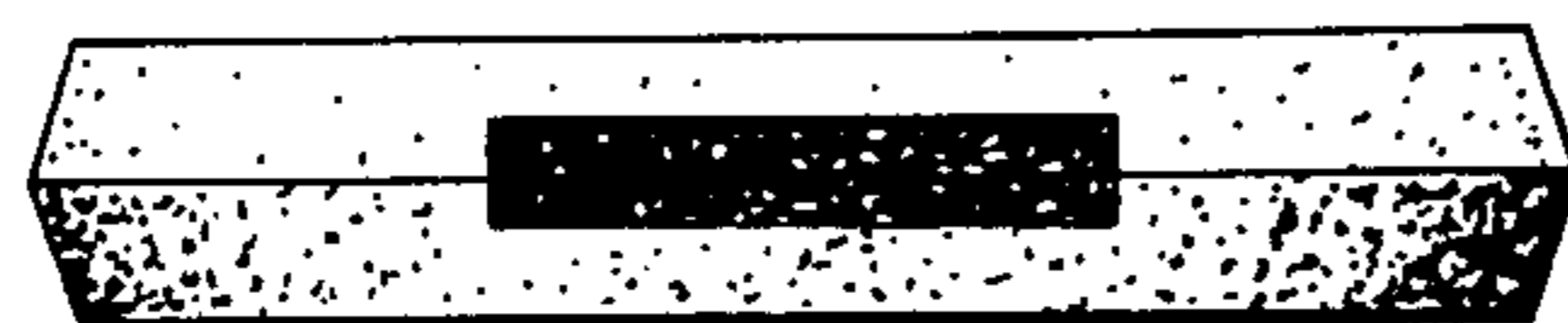

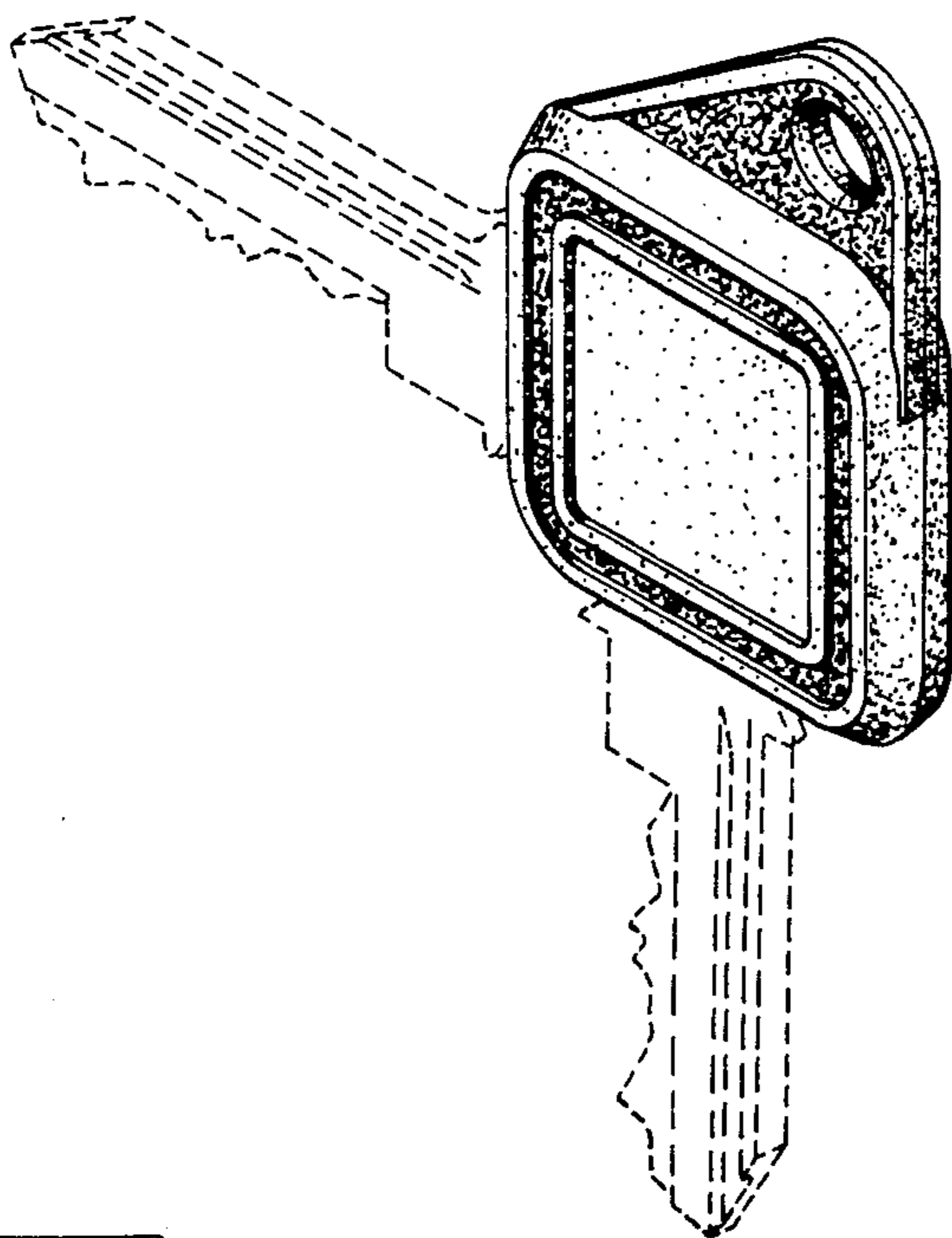

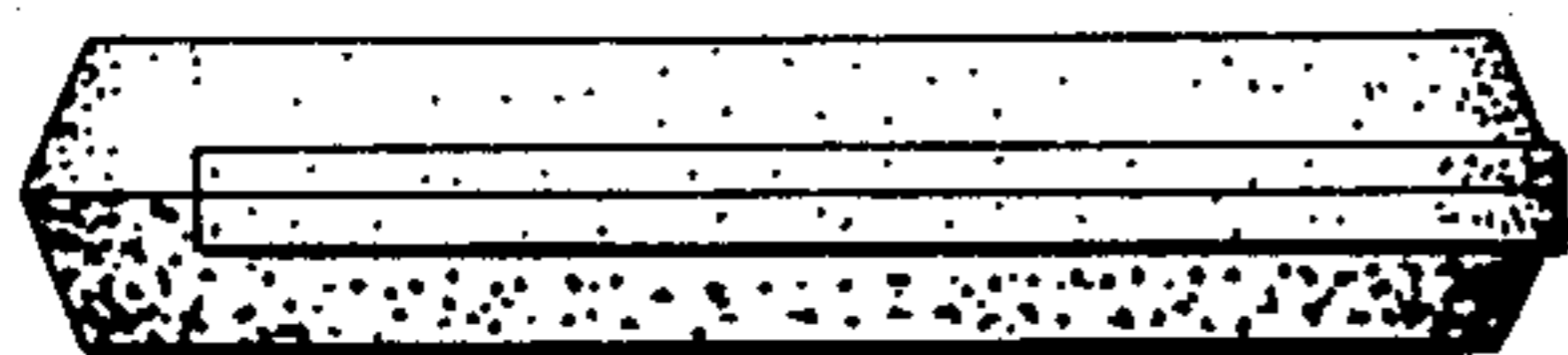

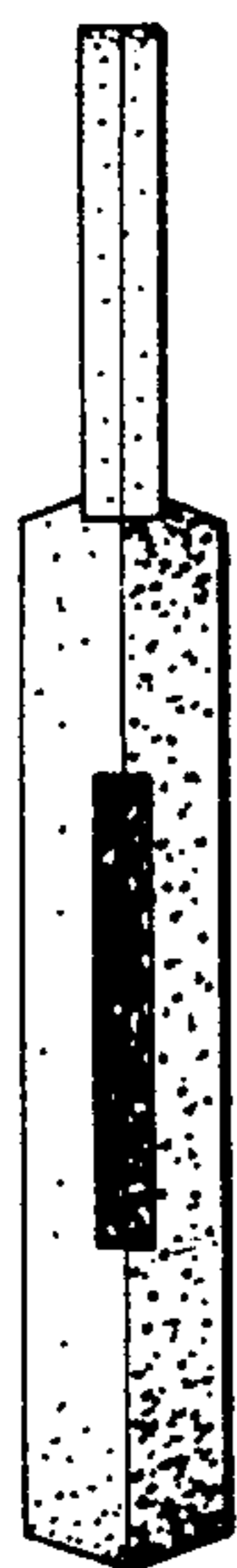

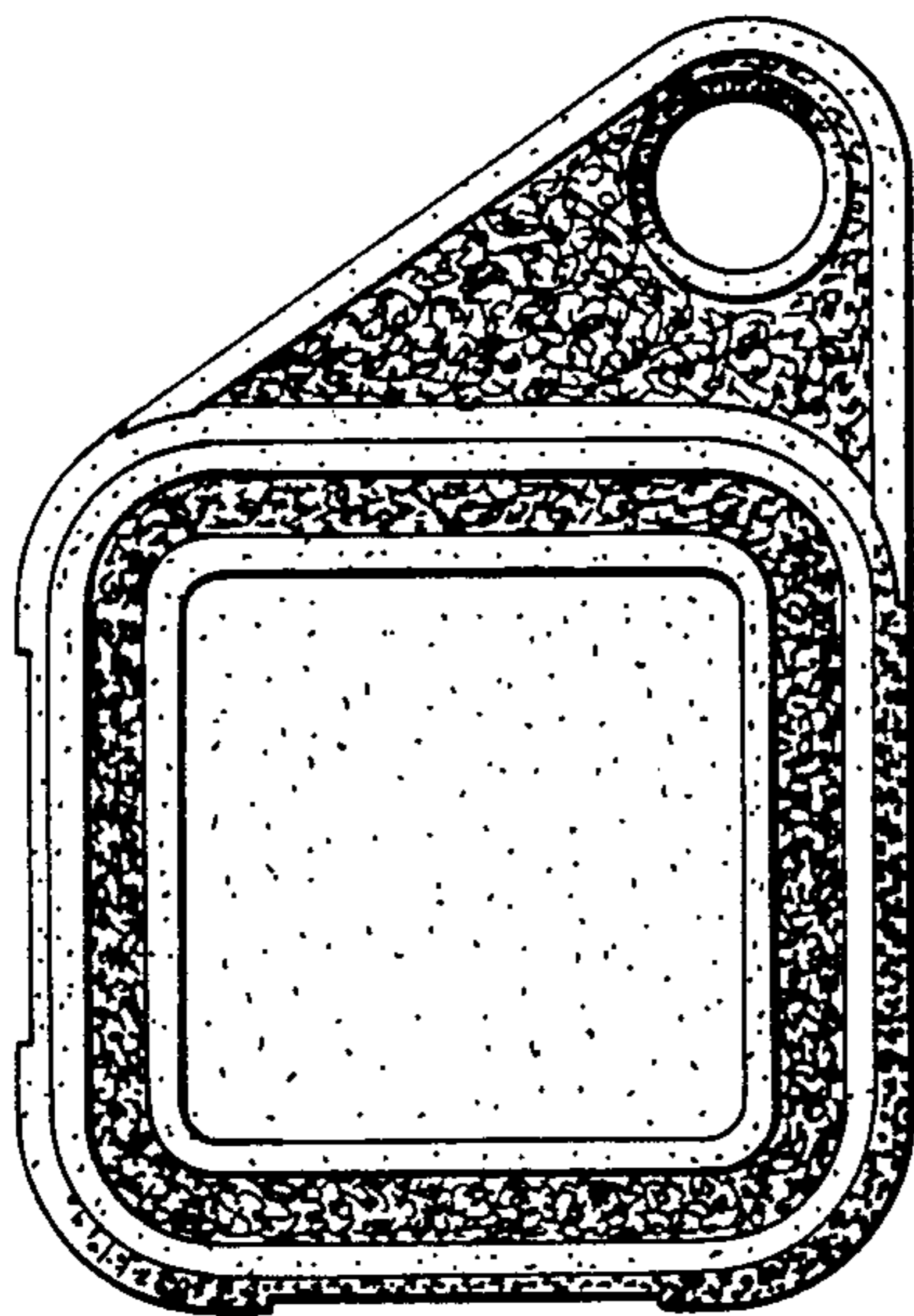

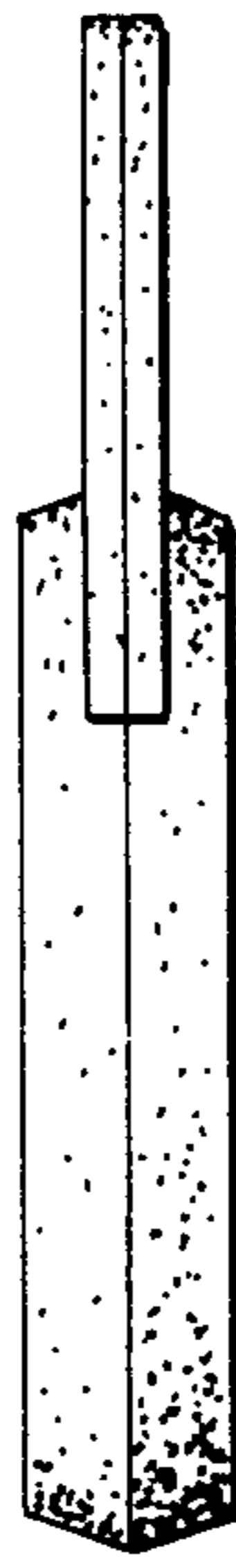

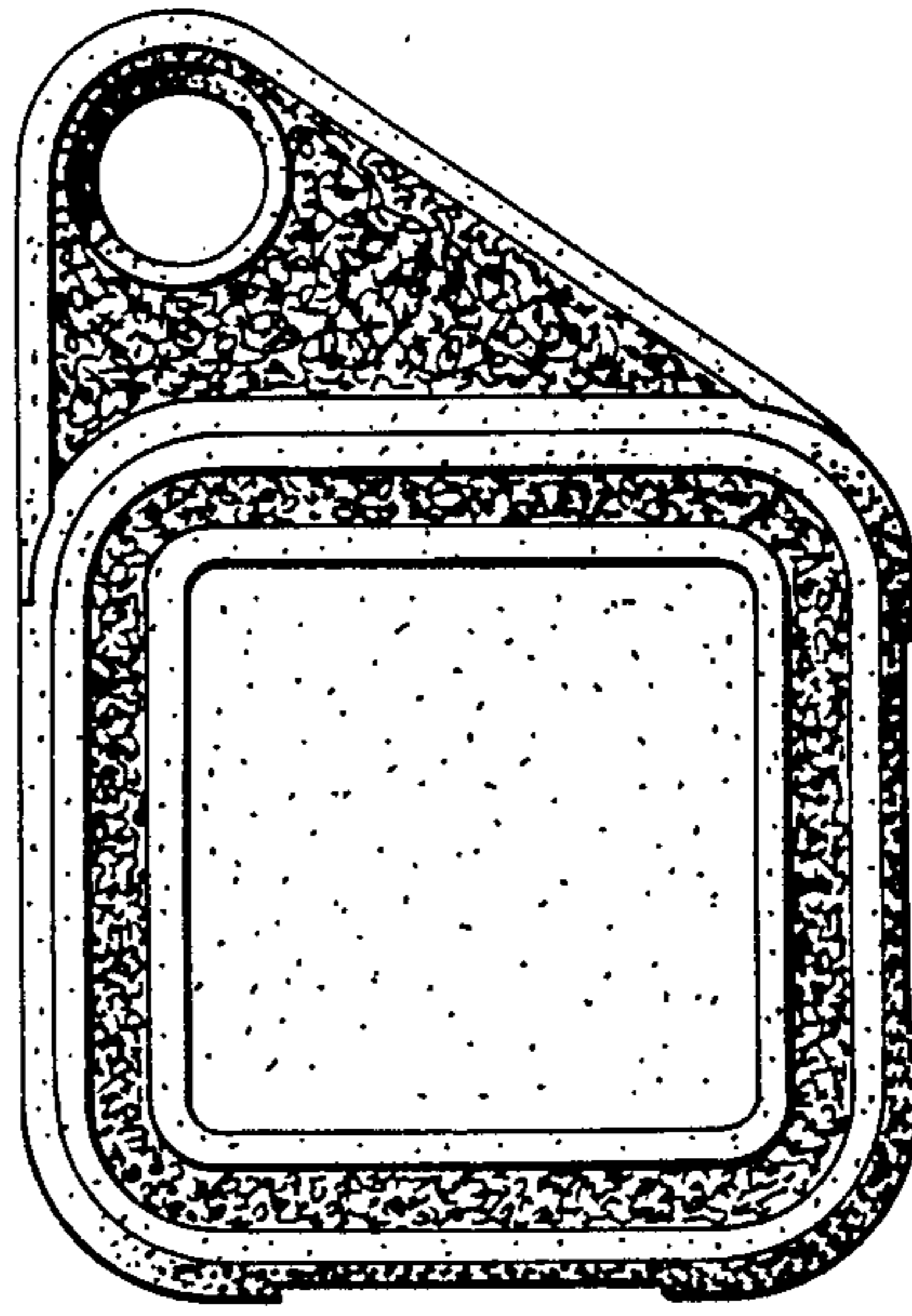

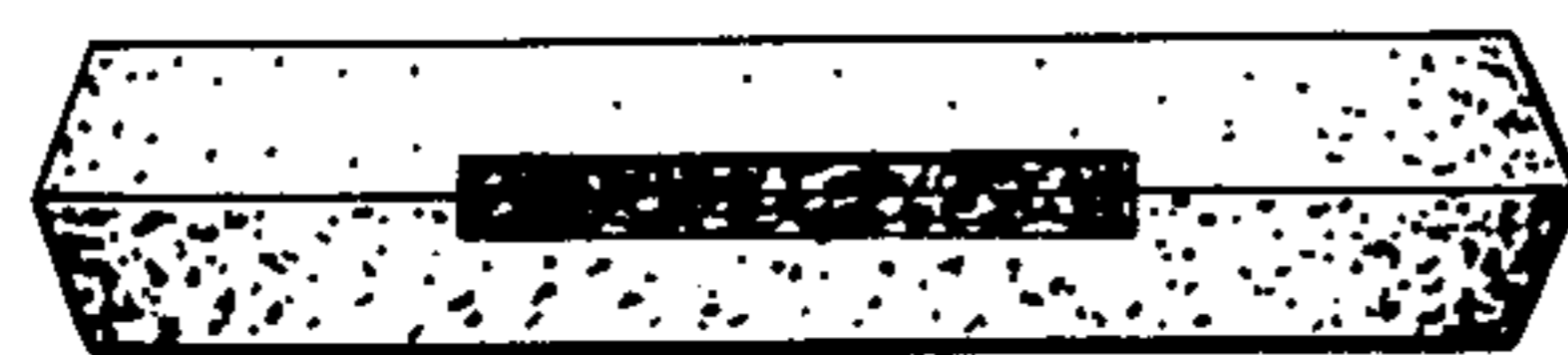
