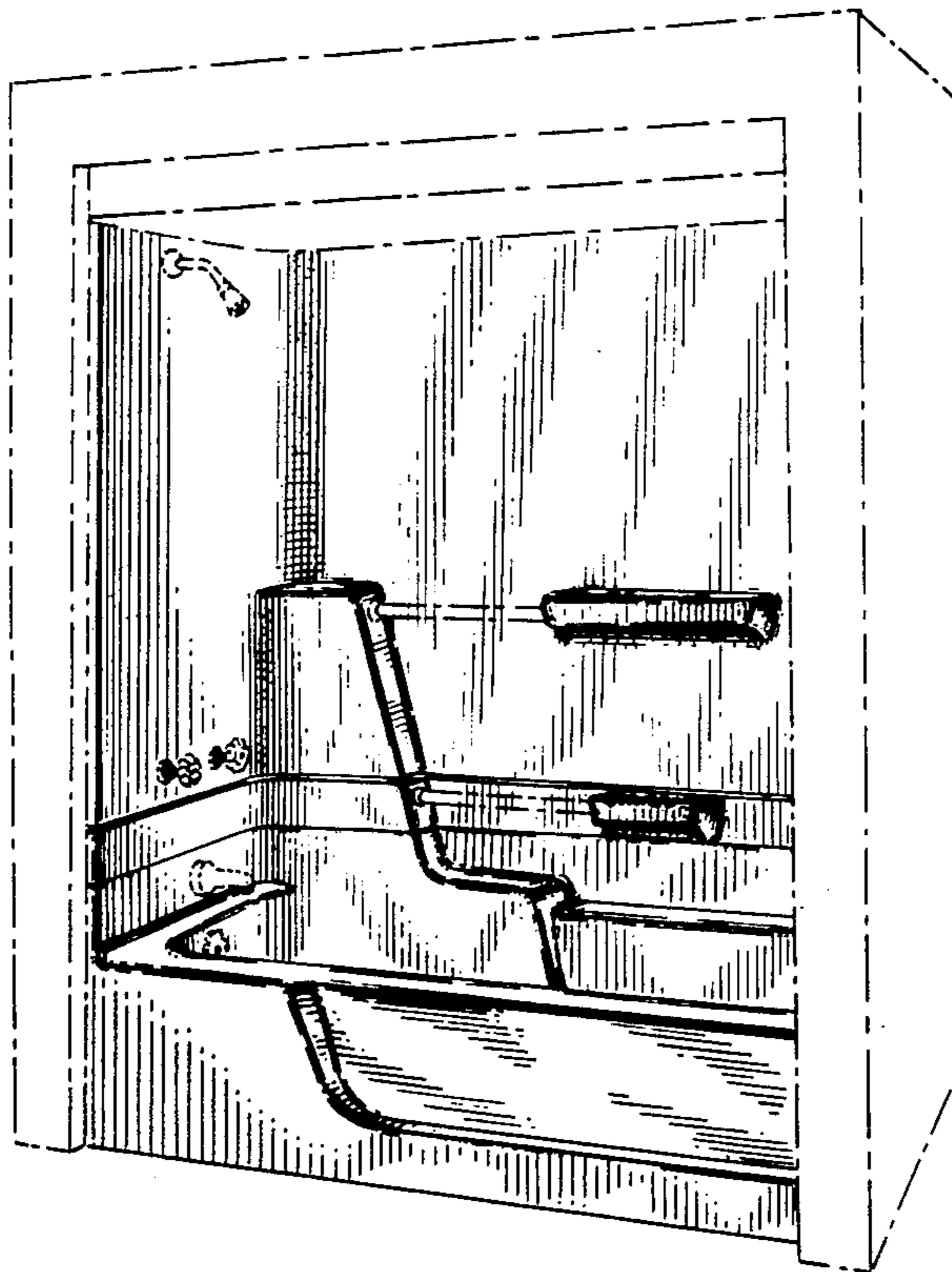

[57] CLAIM

The ornamental design for a combined bathtub and shower stall, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the combined bathtub and shower stall showing my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a cross sectional view taken on line 3—3 of FIG. 2;
 FIG. 4 is a cross sectional view taken on line 4—4 of FIG. 2;
 FIG. 5 is a cross sectional view taken on line 5—5 of FIG. 2;
 FIG. 6 is a cross sectional view taken on line 6—6 of FIG. 5;
 FIG. 7 is a cross sectional view taken on line 7—7 of FIG. 2;
 FIG. 8 is an enlarged fragmentary cross sectional view taken on line 8—8 of FIG. 7;
 FIG. 9 is an enlarged fragmentary cross sectional view taken on line 9—9 of FIG. 7; and
 FIG. 10 is an enlarged fragmentary cross sectional view taken on line 10—10 of FIG. 7.
 The broken line representation of bathroom walls and plumbing fittings in FIG. 1 and the broken line representation of grab bars in FIGS. 1, 2 and 4 through 10 are for purposes of illustration only.



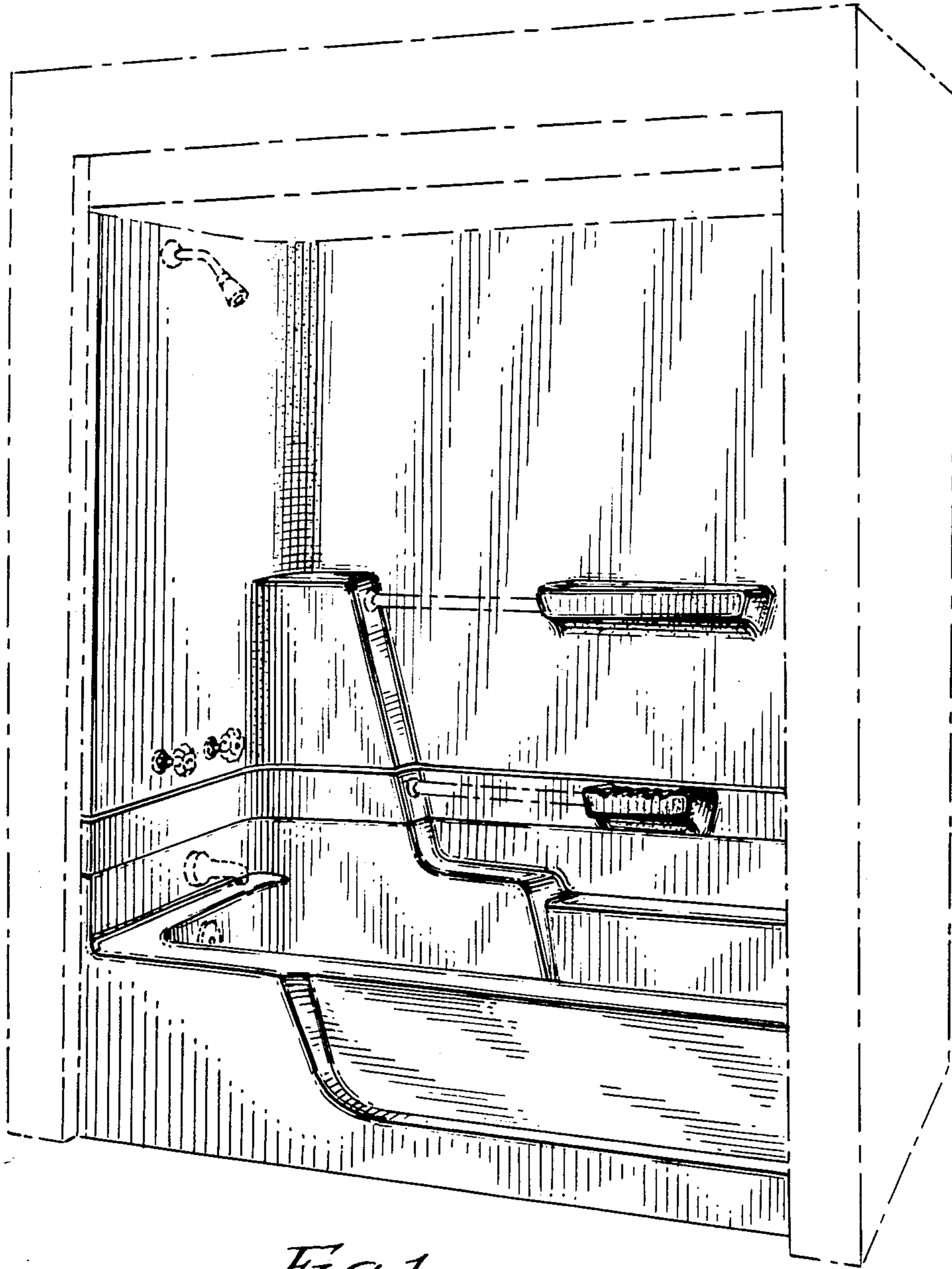
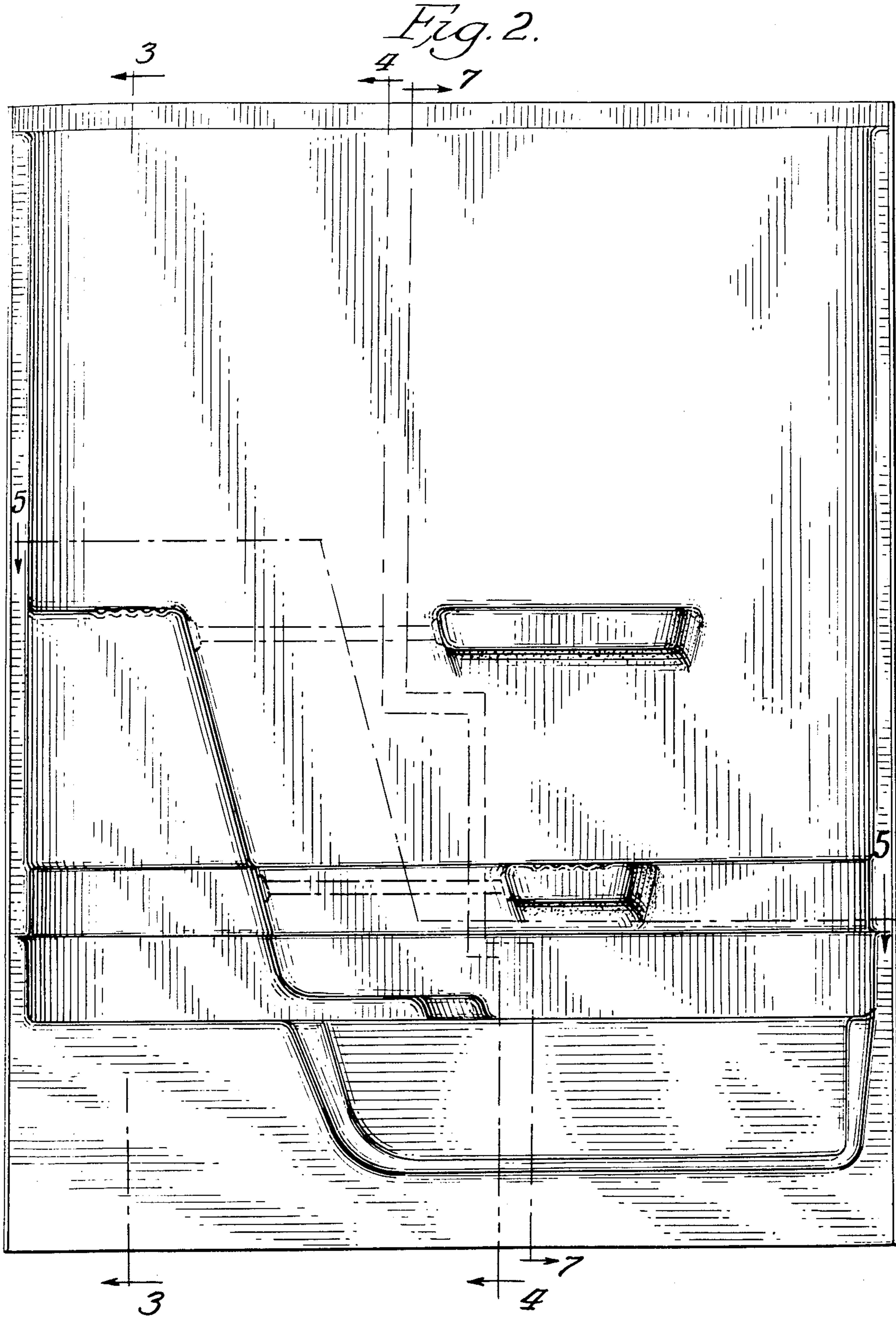

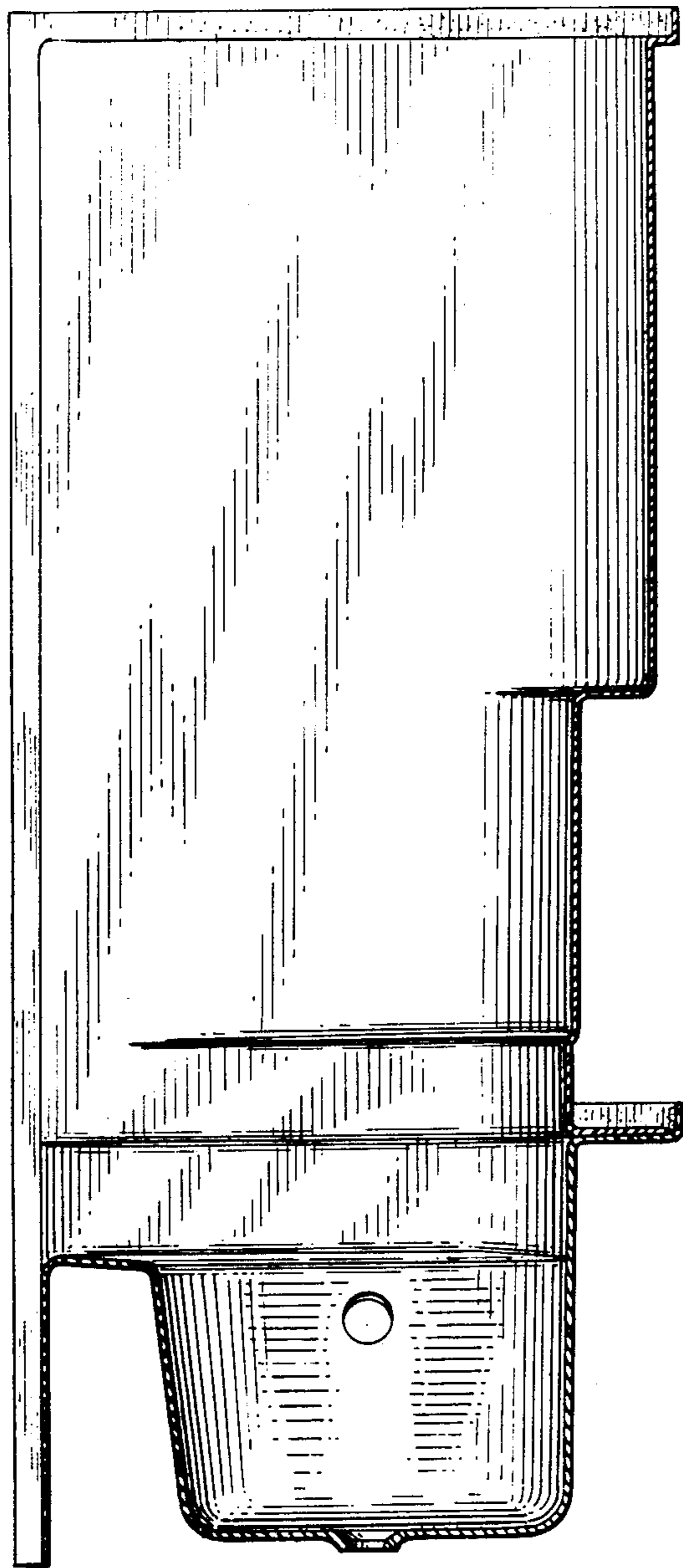

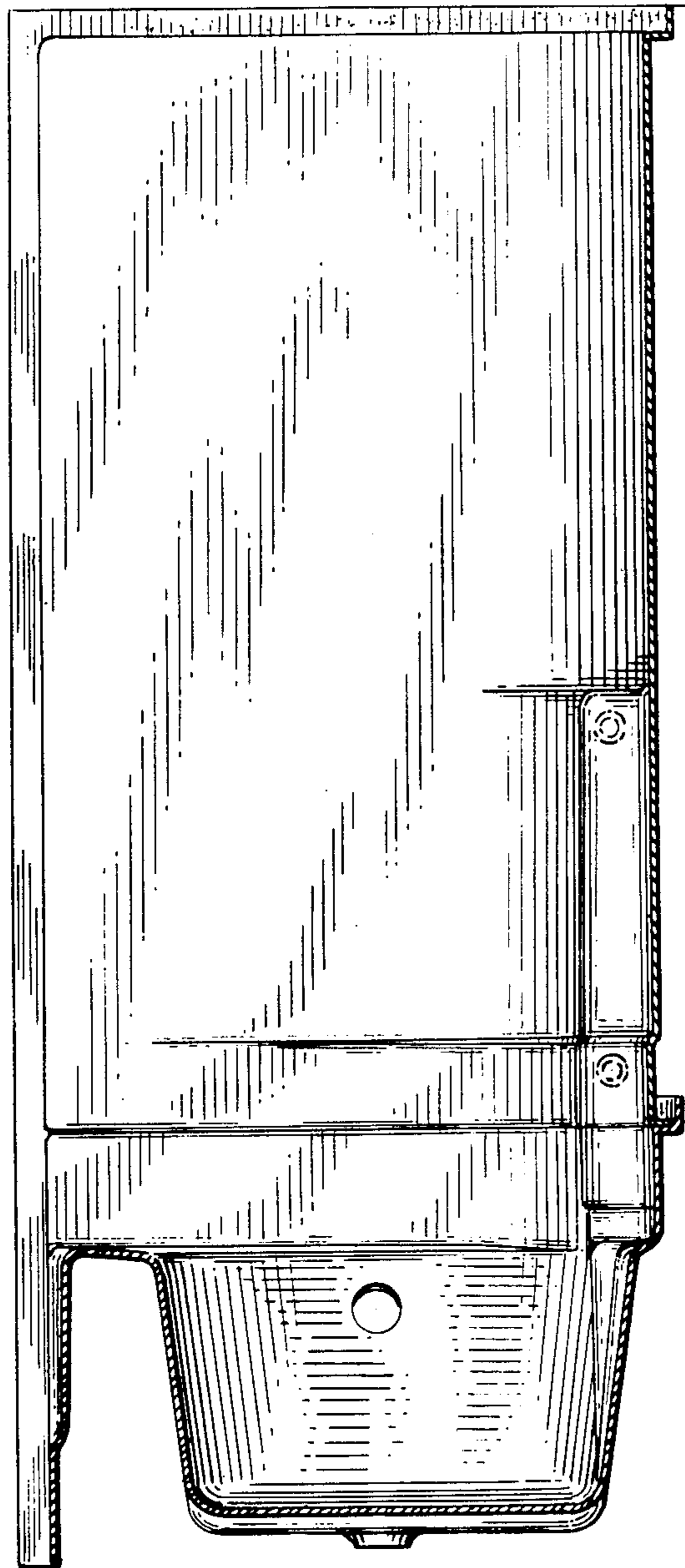
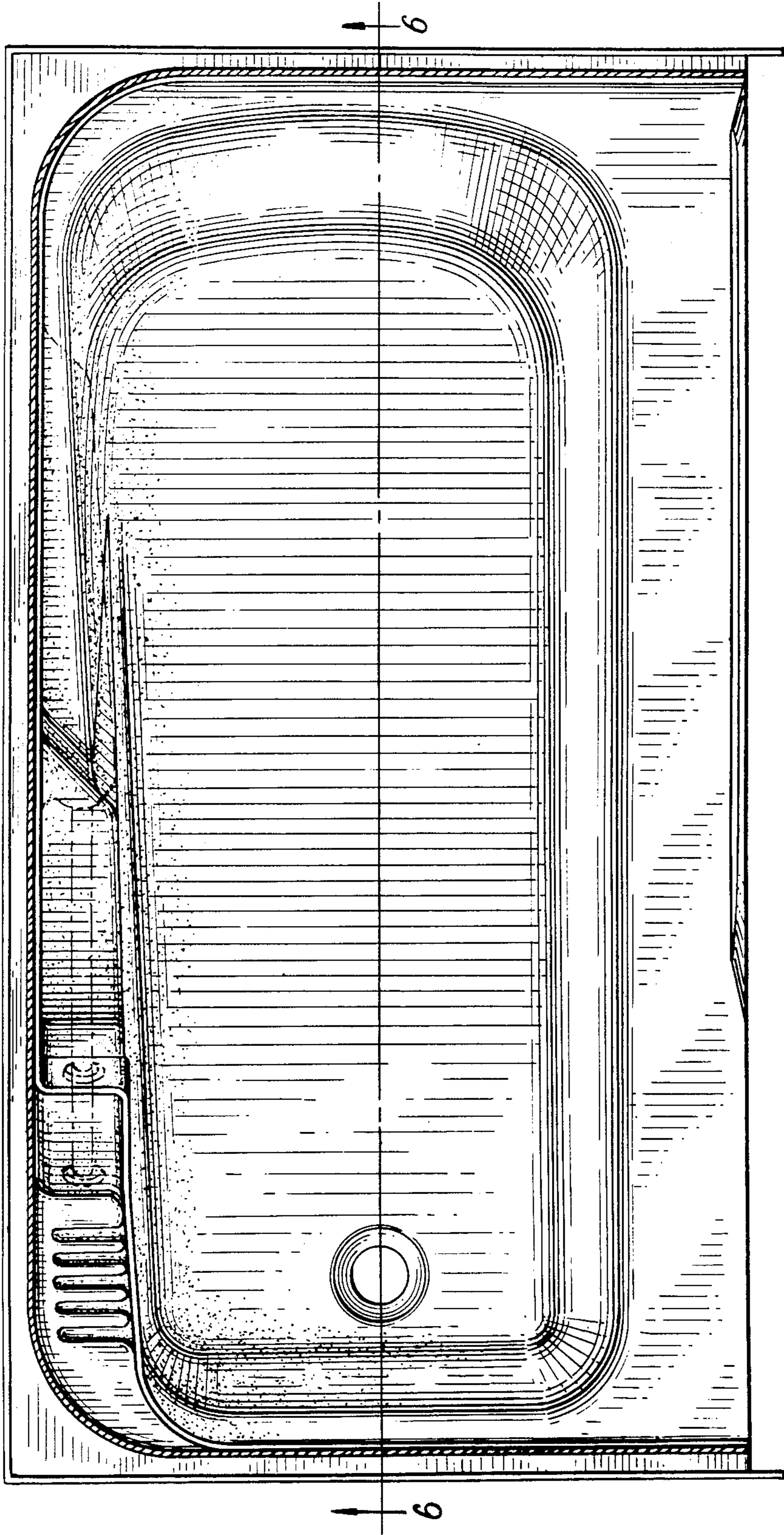

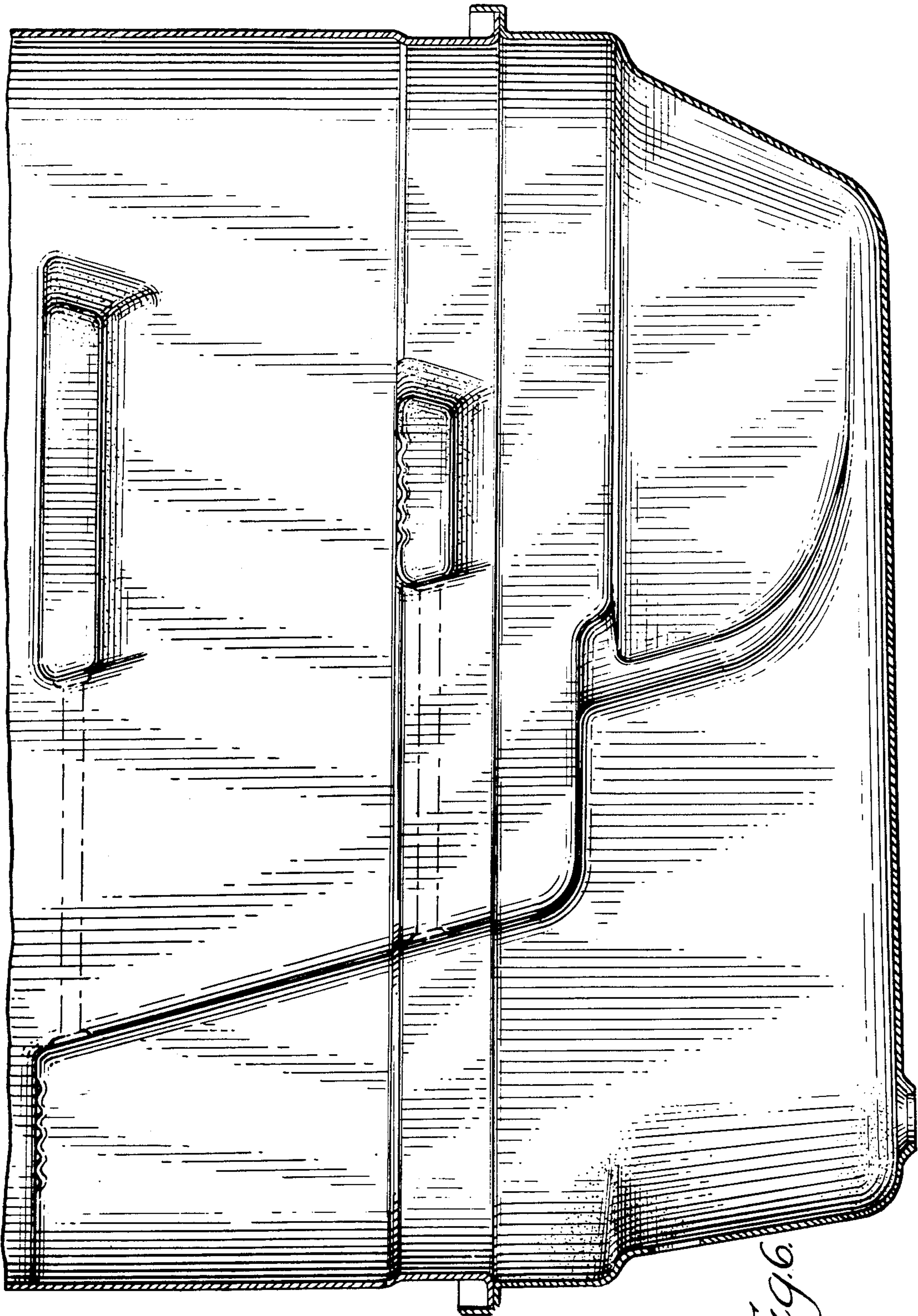

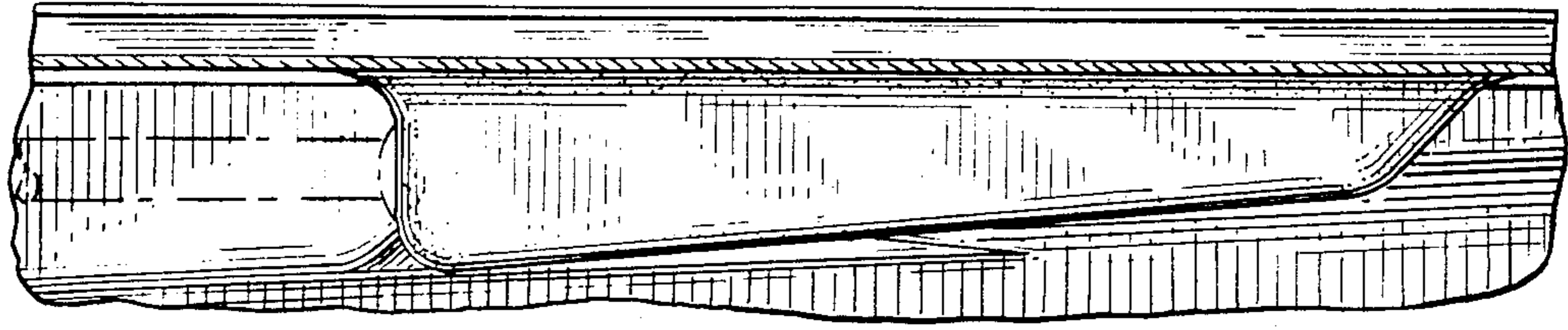

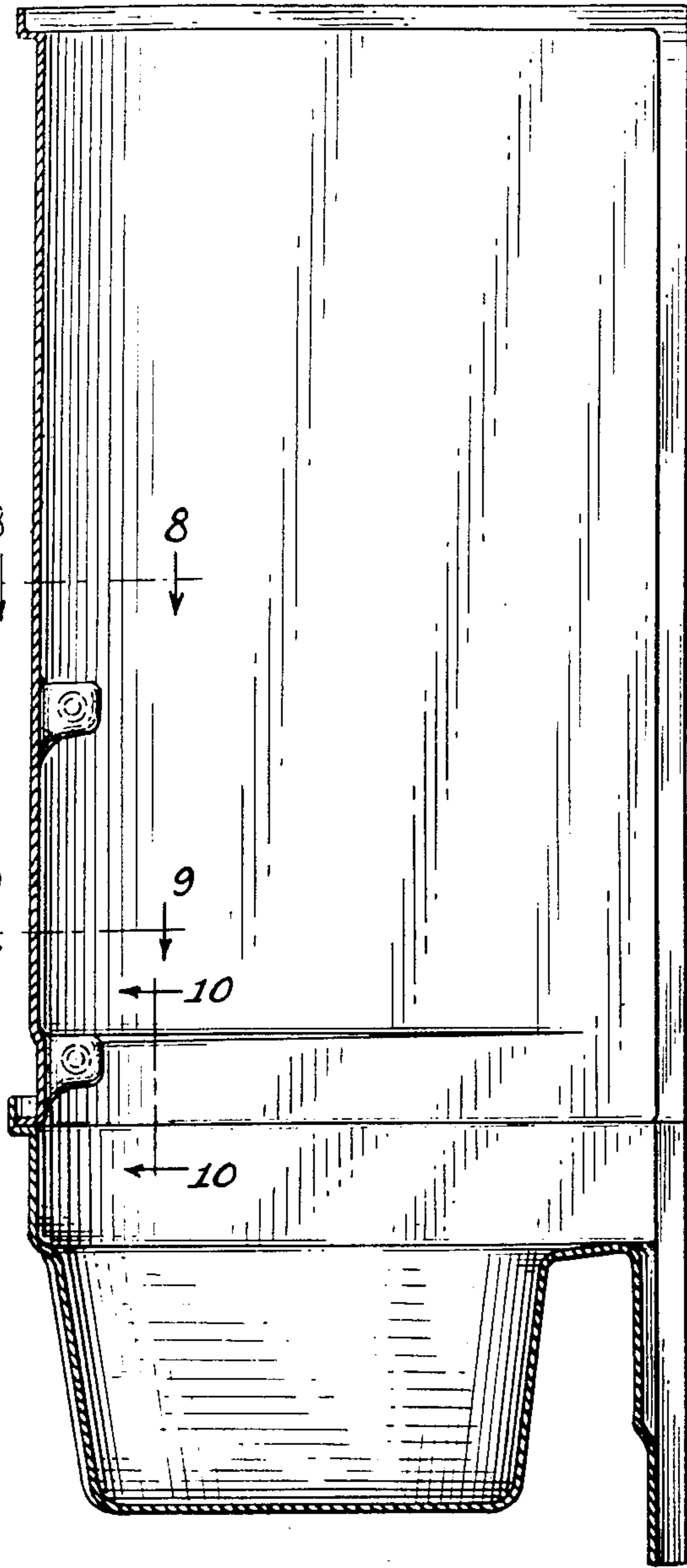

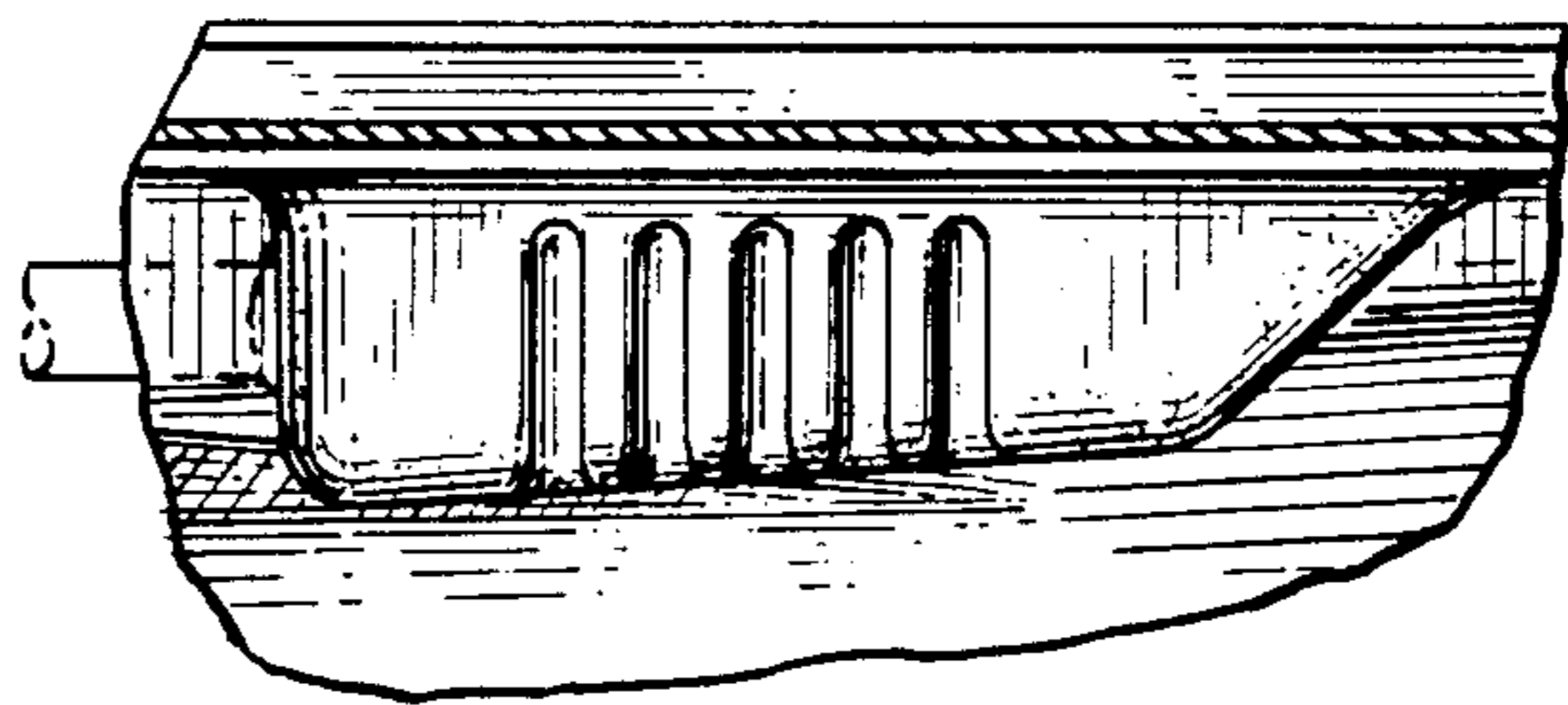
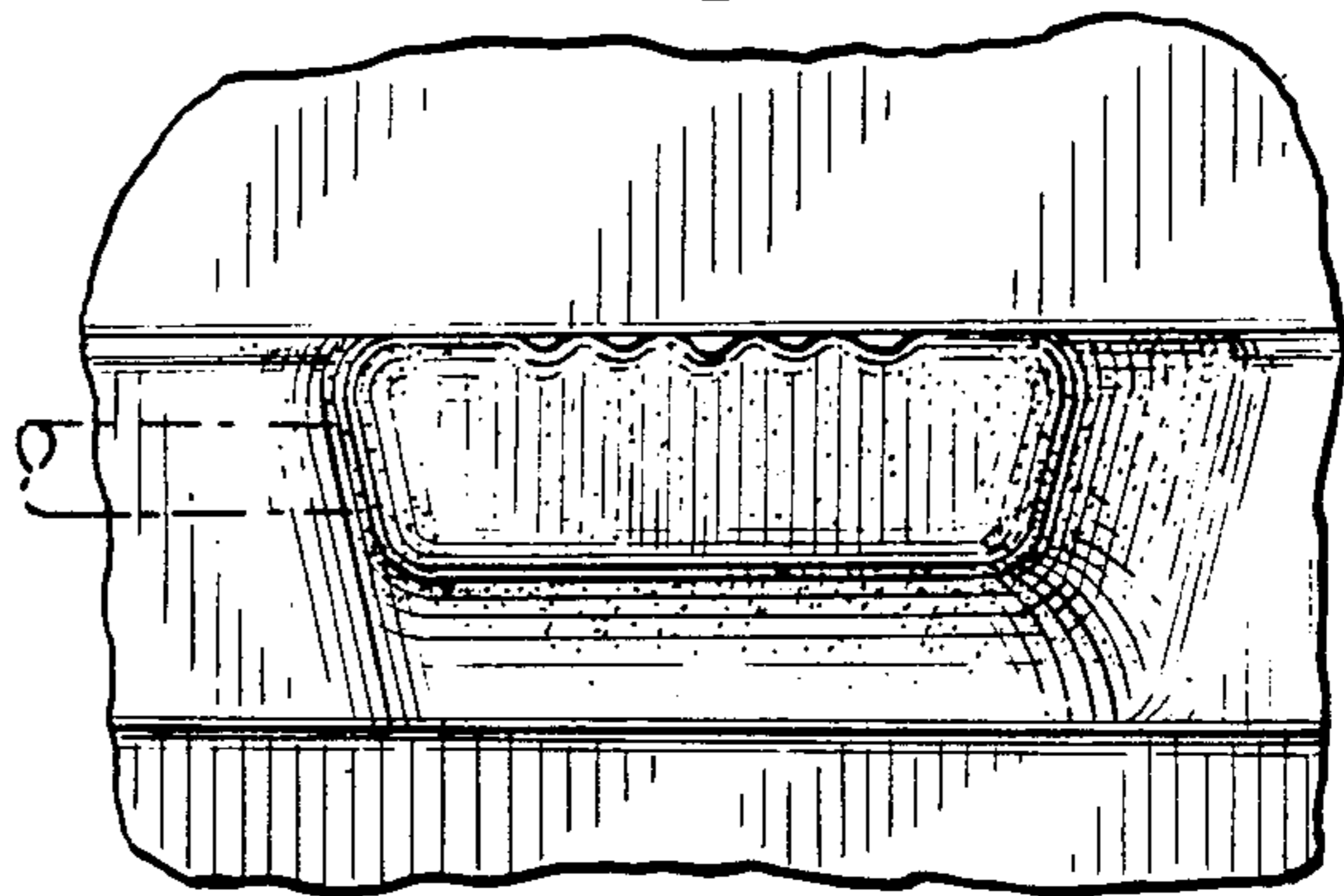
