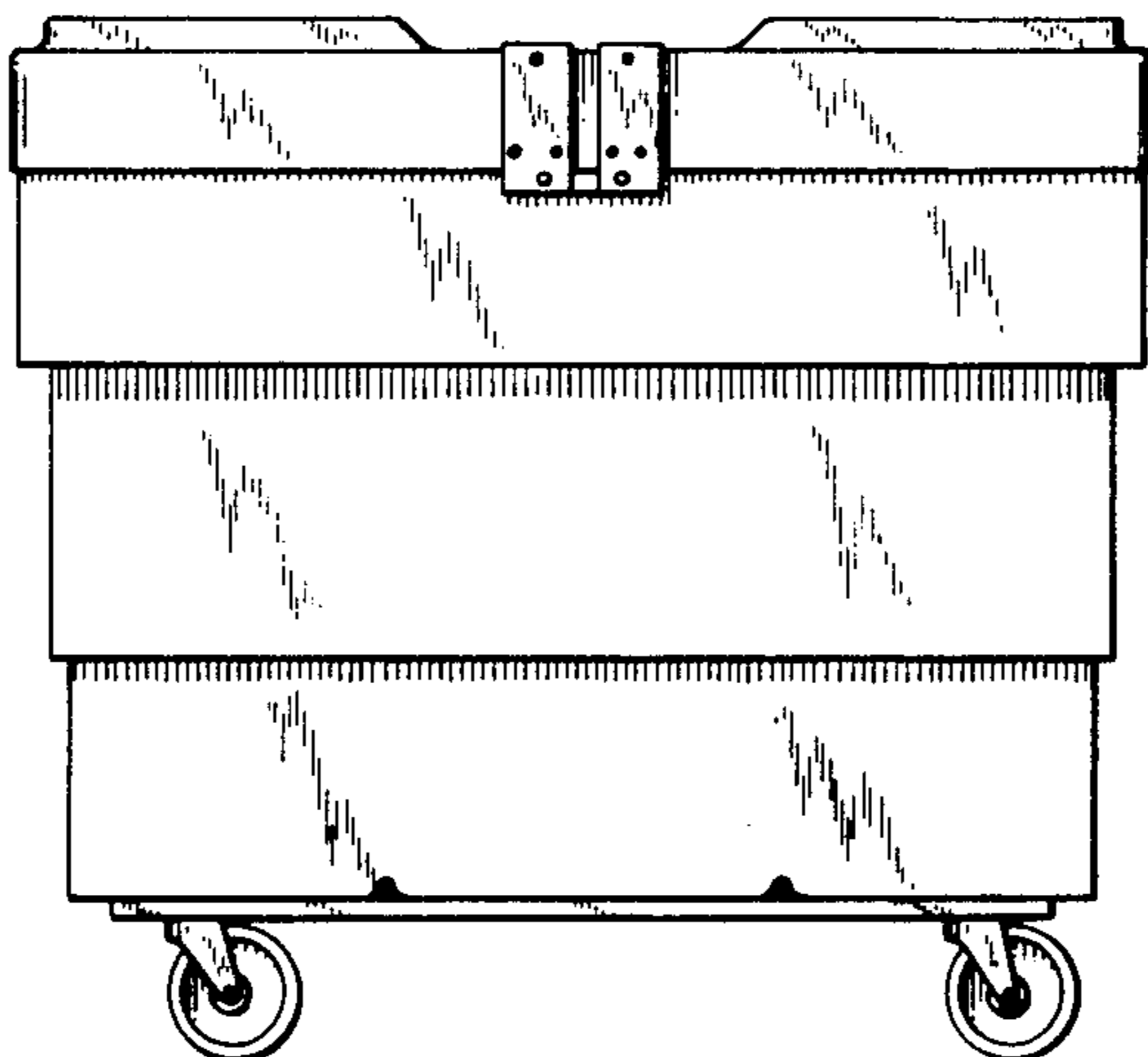
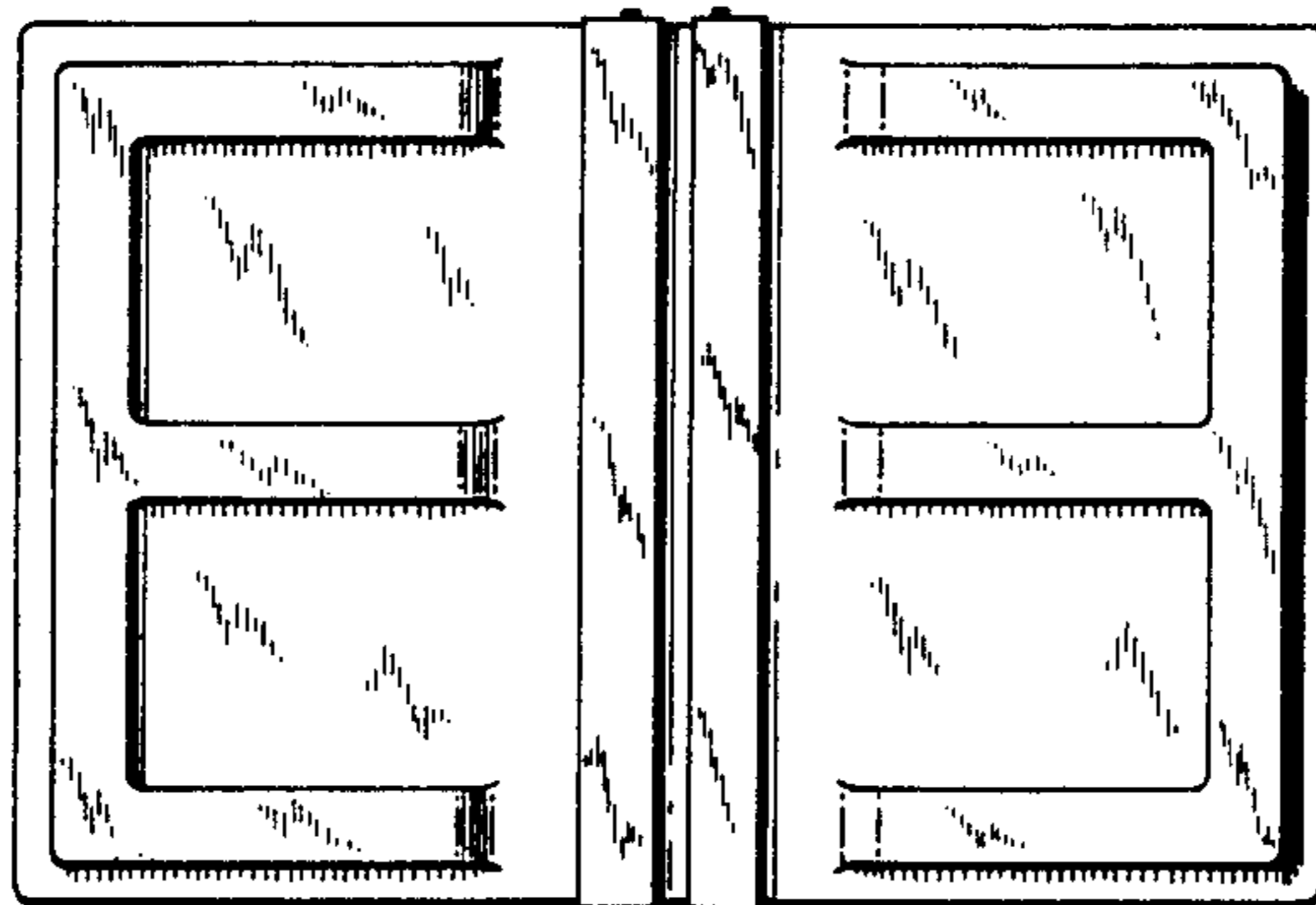

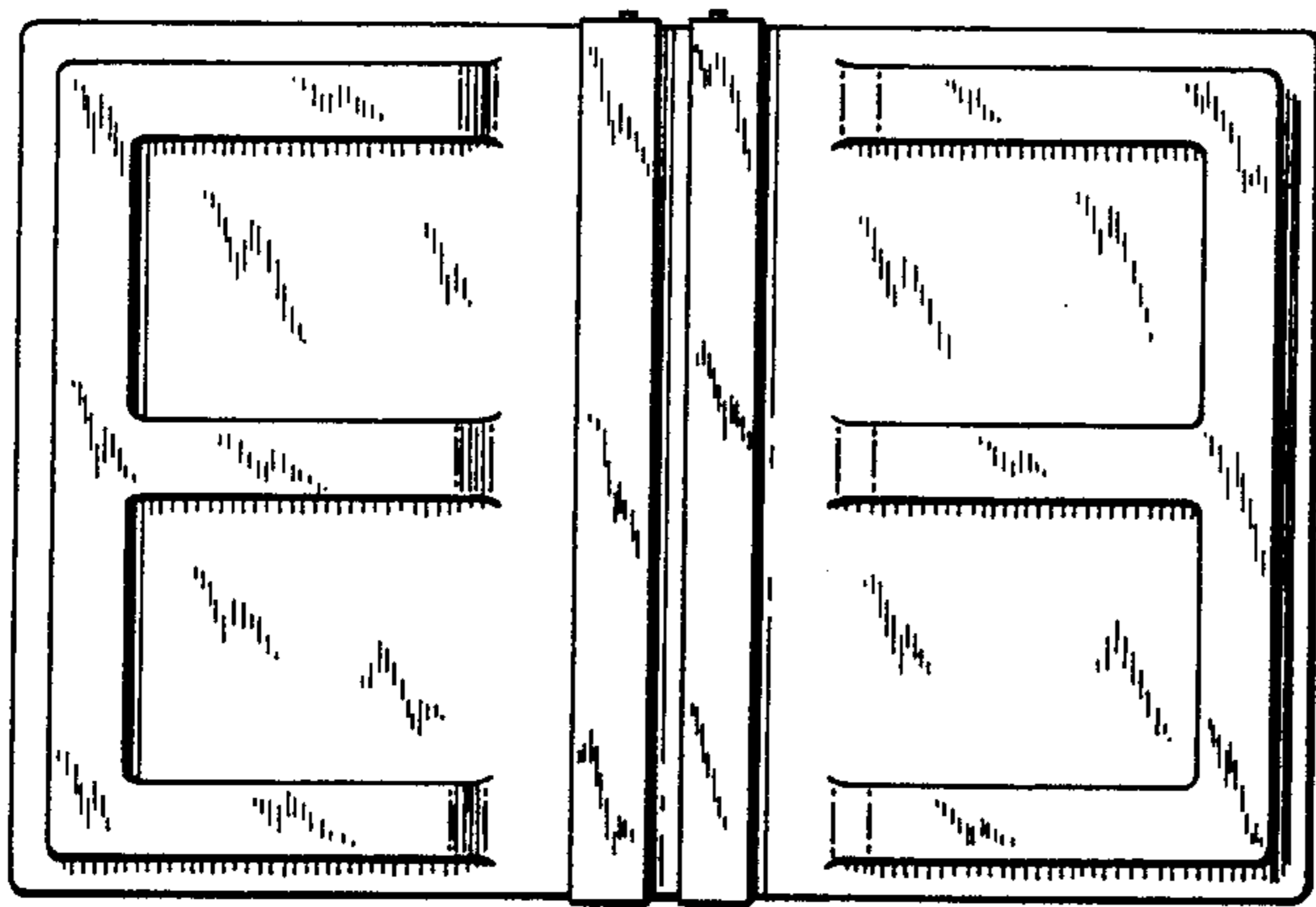

The ornamental design of a cart, substantially as shown and described.

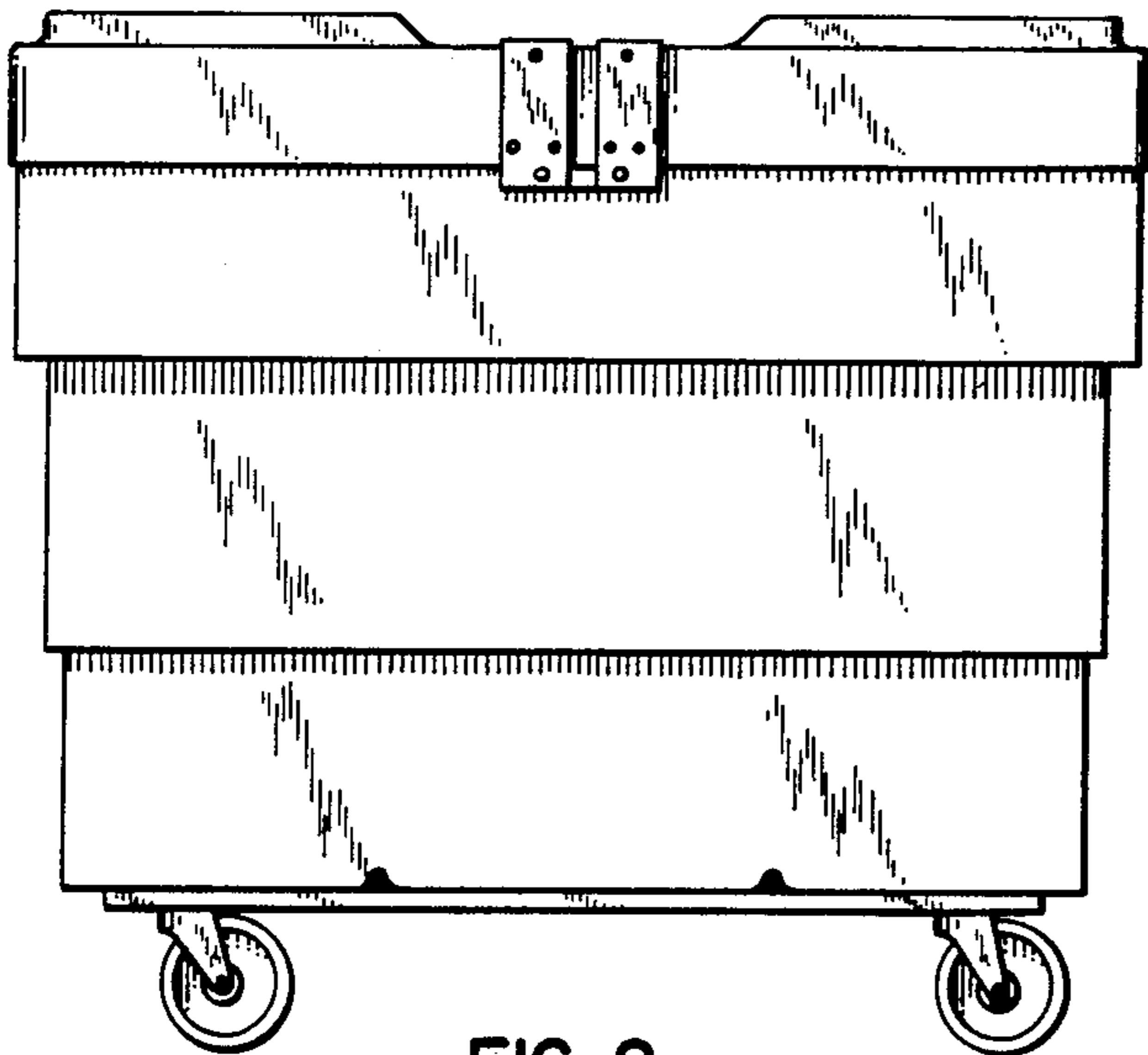
DESCRIPTION

FIG. 1 is a top plan view of a cart showing our new design; FIG. 2 is a front elevational view of FIG. 1; FIG. 3 is a rear elevational view of FIG. 1; FIG. 4 is a right side elevational view of FIG. 1; FIG. 5 is a left side elevational view of FIG. 1; FIG. 6 is a bottom plan view of FIG. 1; FIG. 7 is a top plan view of the cart shown in FIG. 1 in fully open condition; FIG. 8 is a front elevational view of FIG. 7; FIG. 9 is a rear elevational view of FIG. 7; FIG. 10 is a right side elevational view of FIG. 7; FIG. 11 is a left side elevational view of FIG. 7; FIG. 12 is a bottom plan view of FIG. 7; FIG. 13 is a top plan view of a cart showing a second embodiment of our new design; FIG. 14 is a front elevational view of FIG. 13; FIG. 15 is a rear elevational view of FIG. 13; FIG. 16 is a right side elevational view of FIG. 13; FIG. 17 is a left side elevational view of FIG. 13; and FIG. 18 is a bottom plan view of FIG. 13.

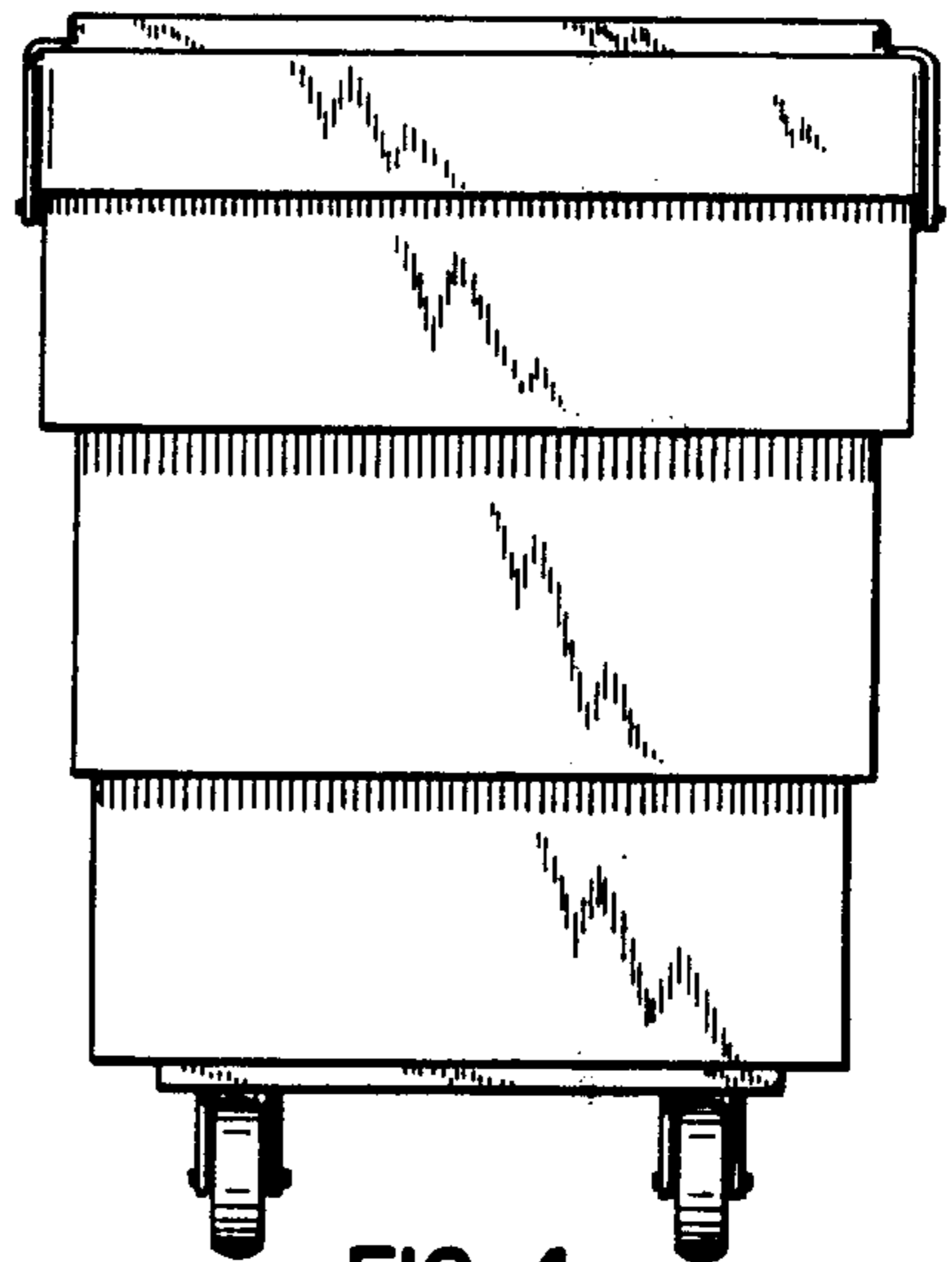




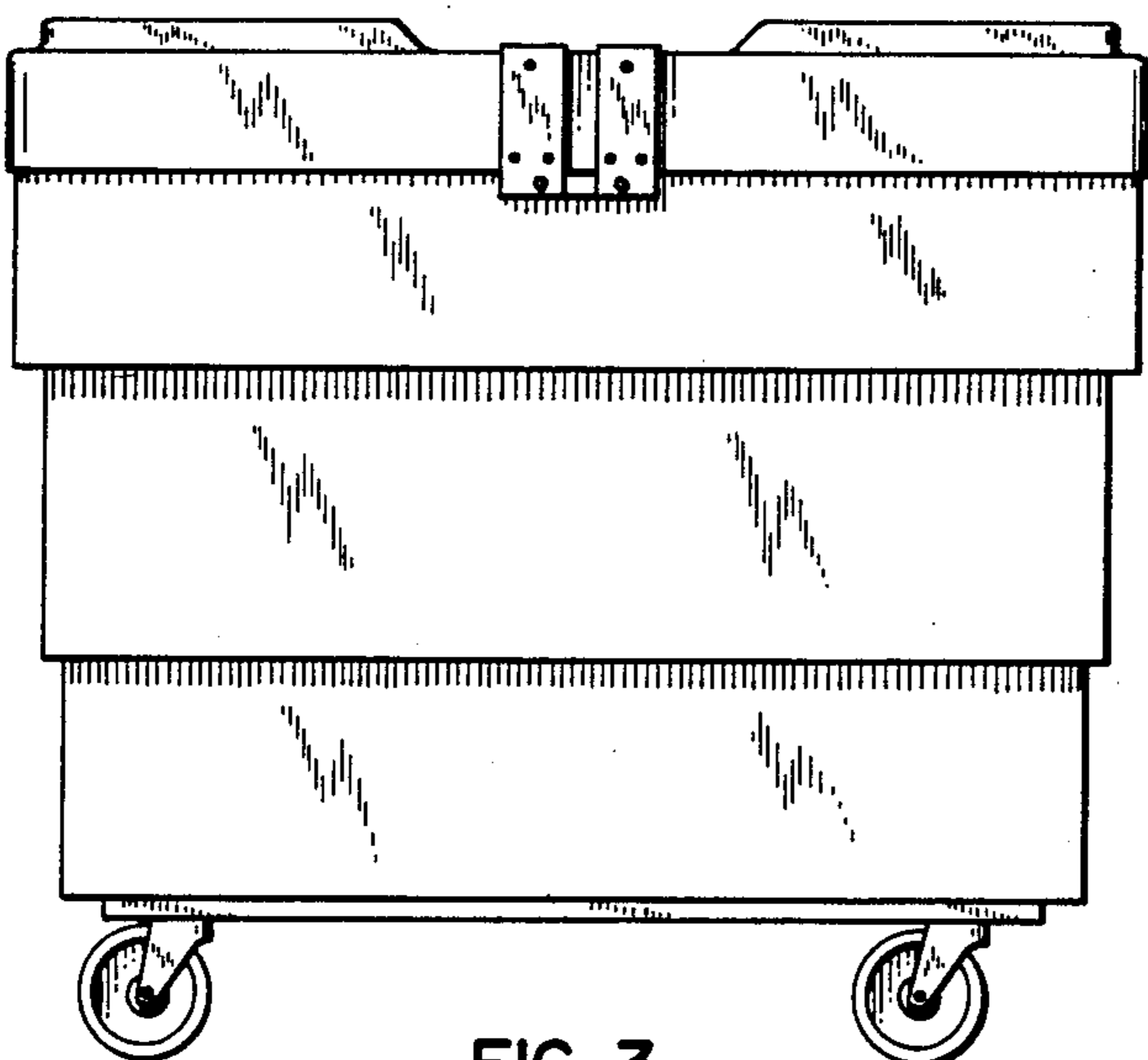

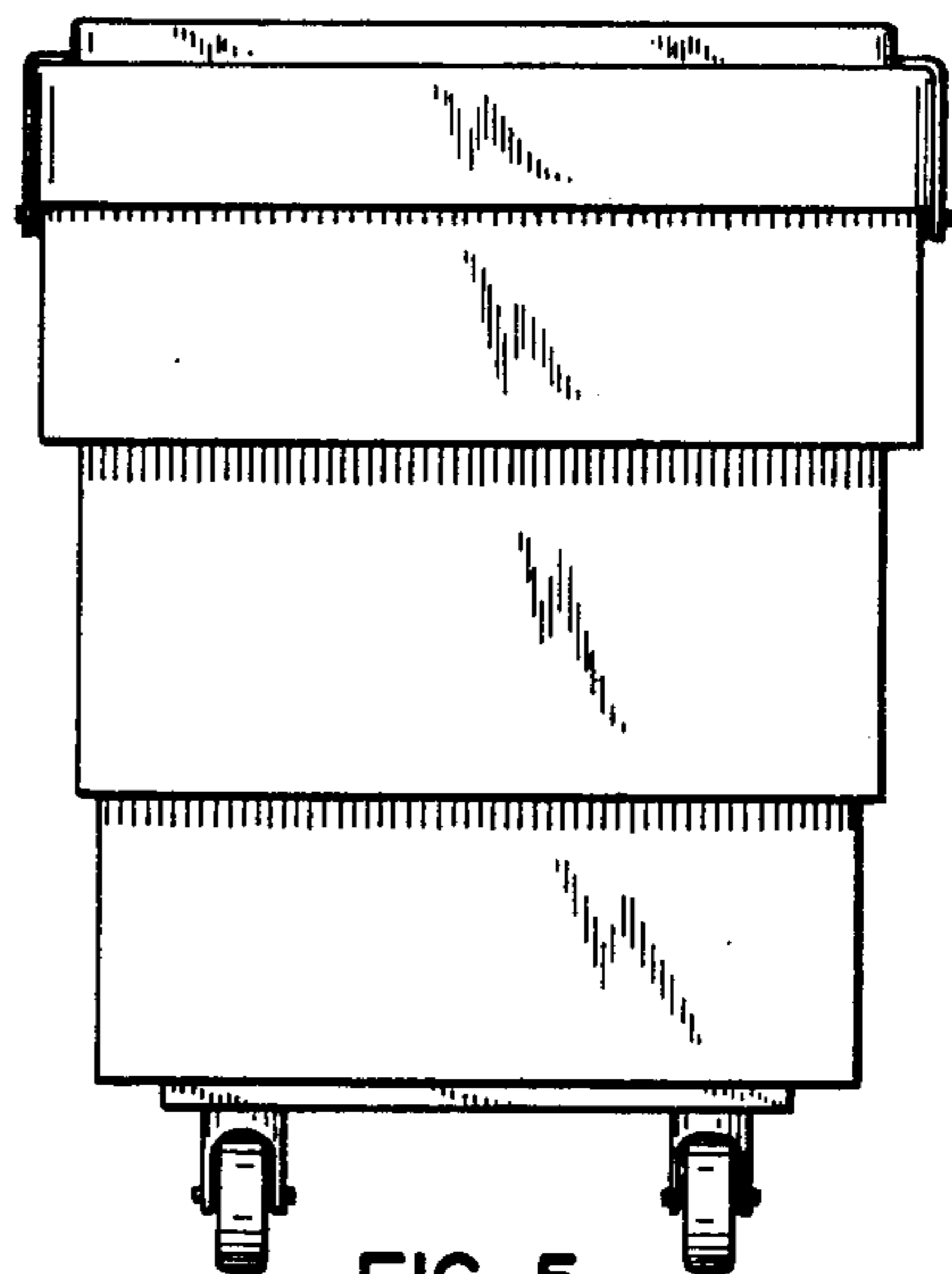

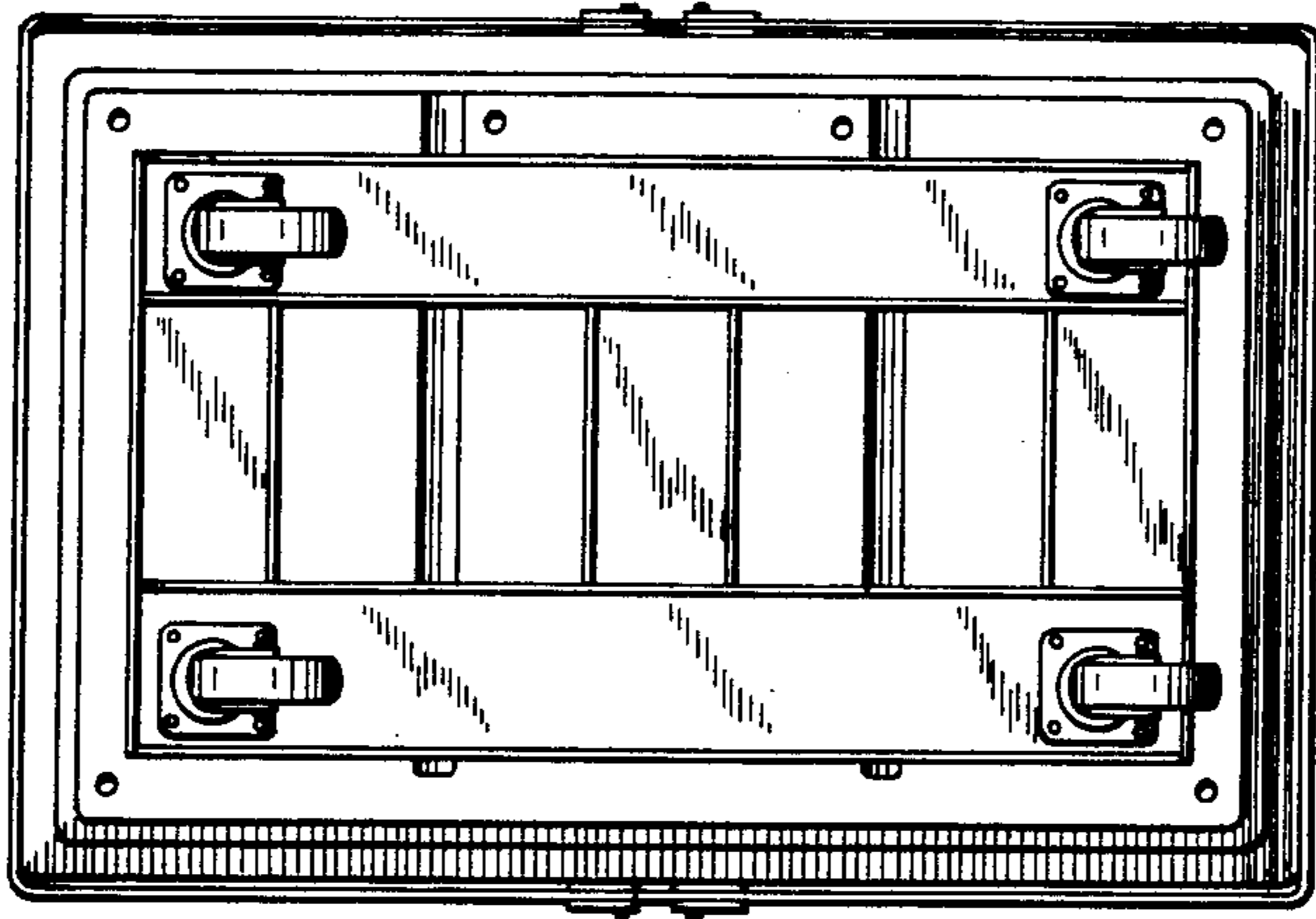

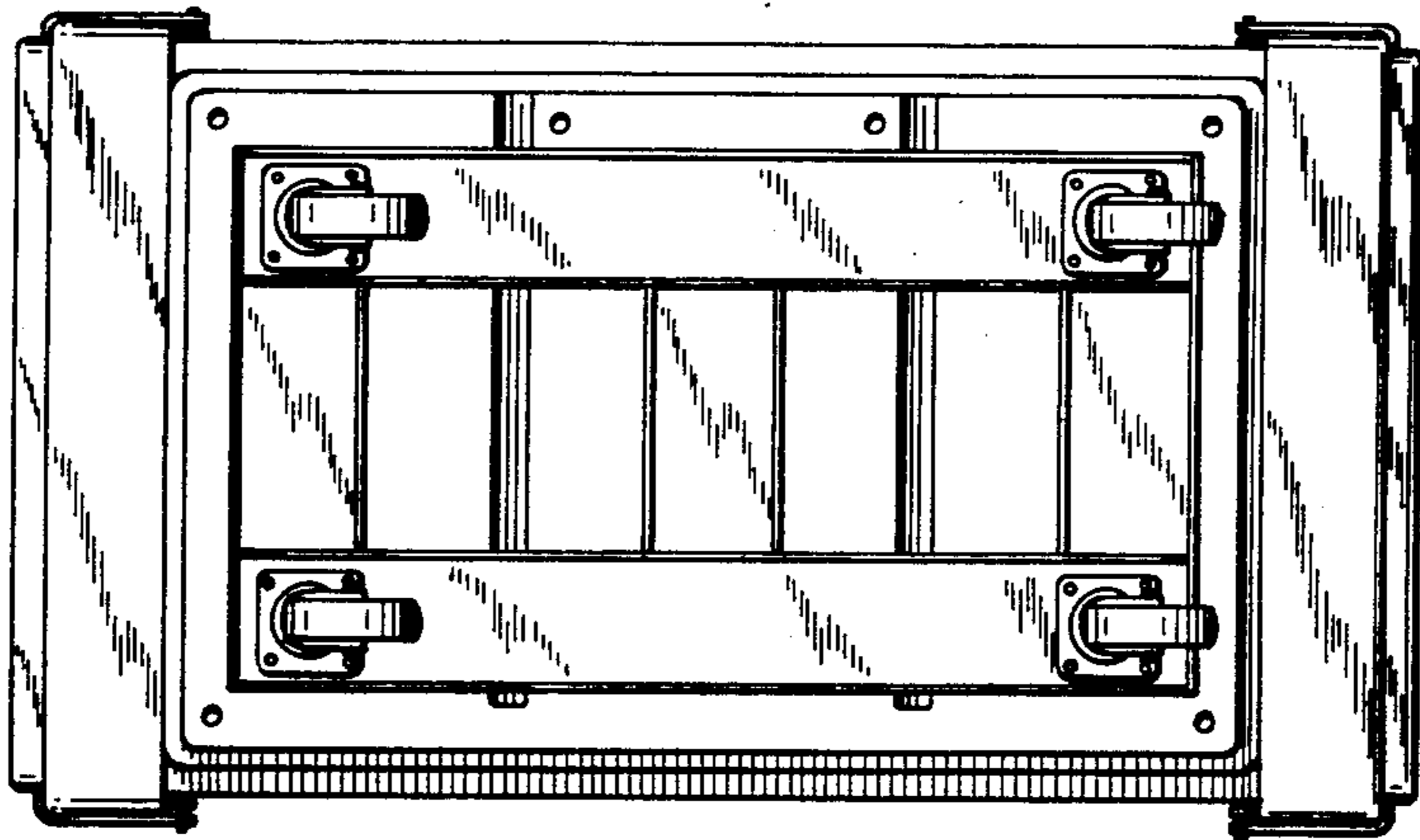

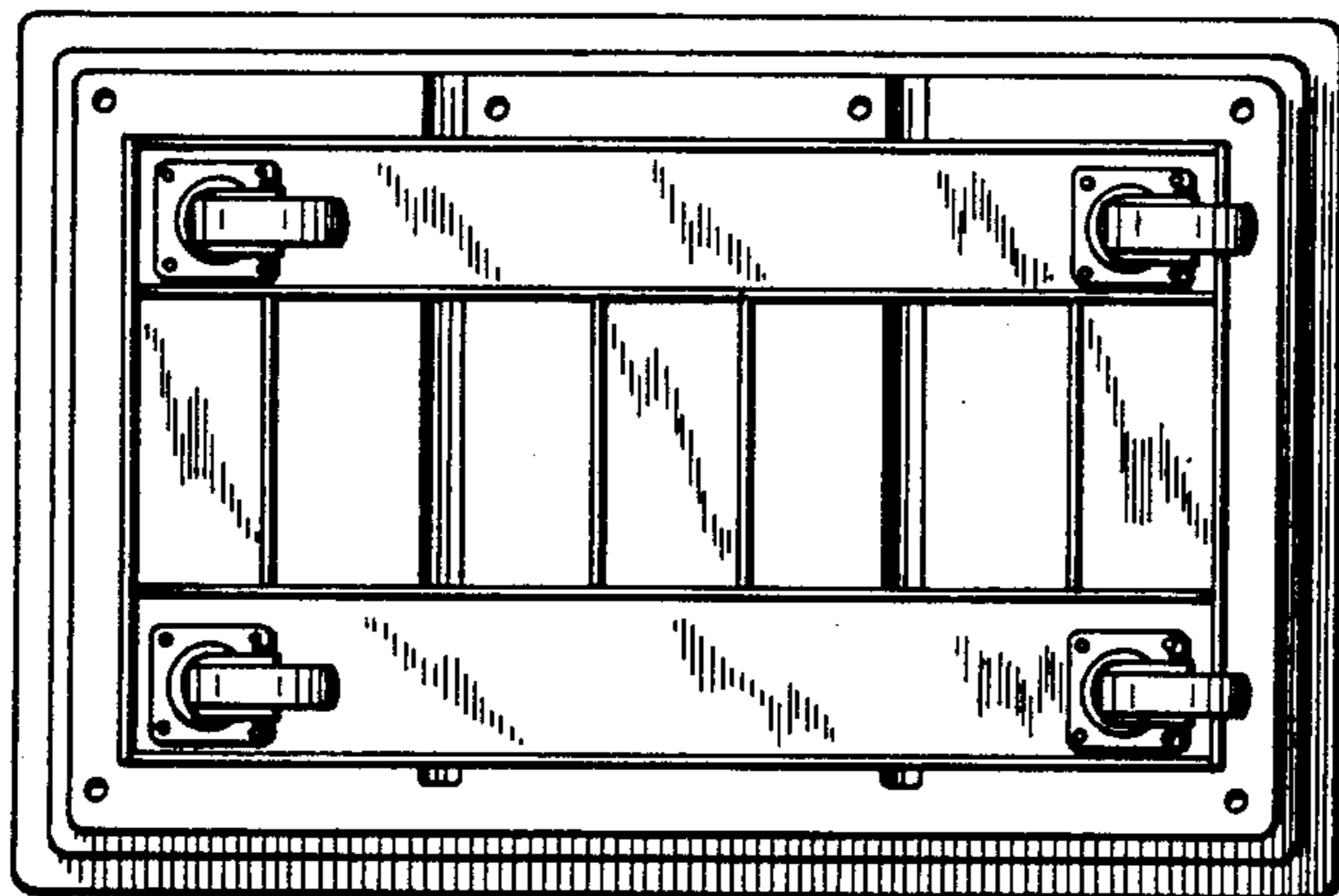

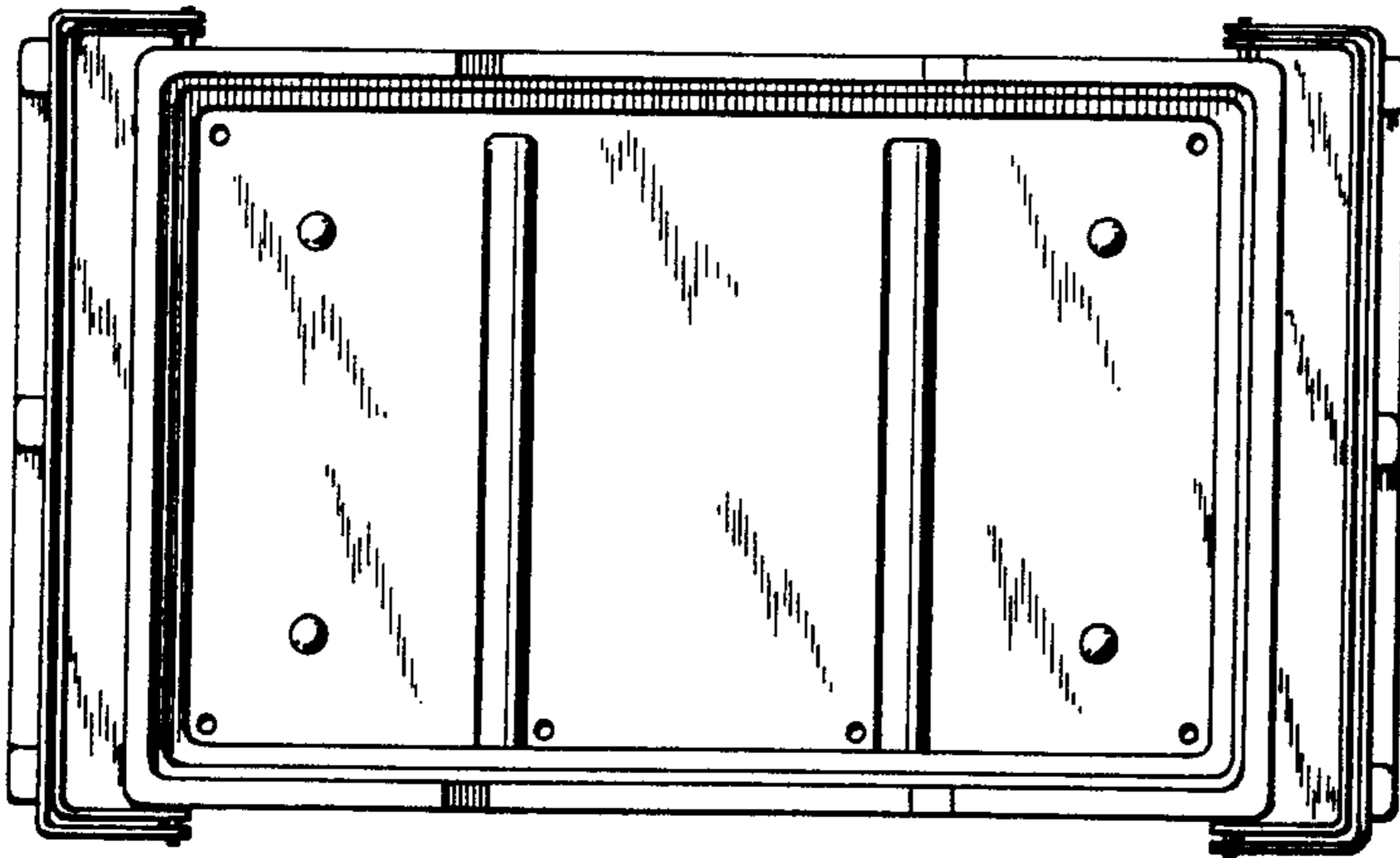

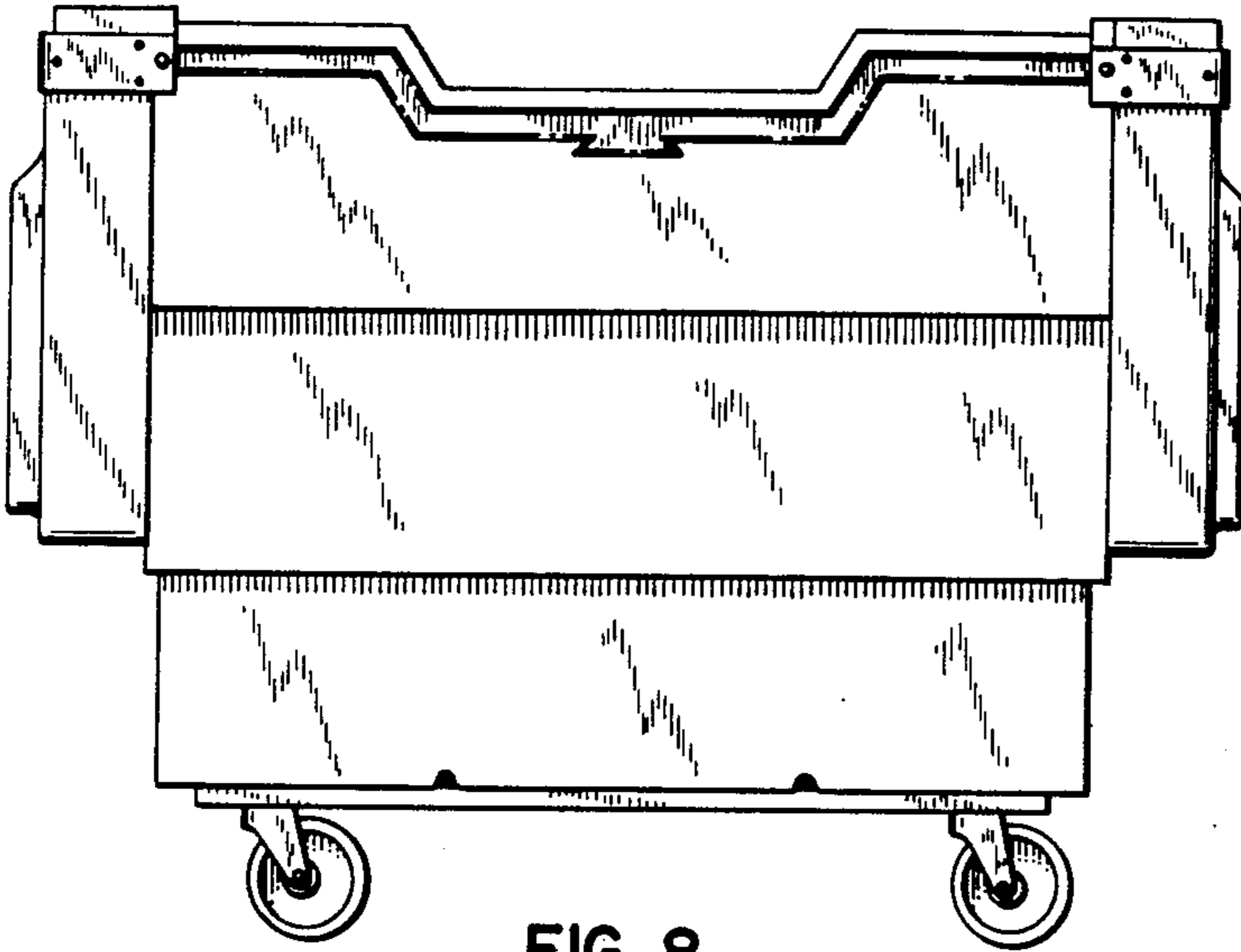

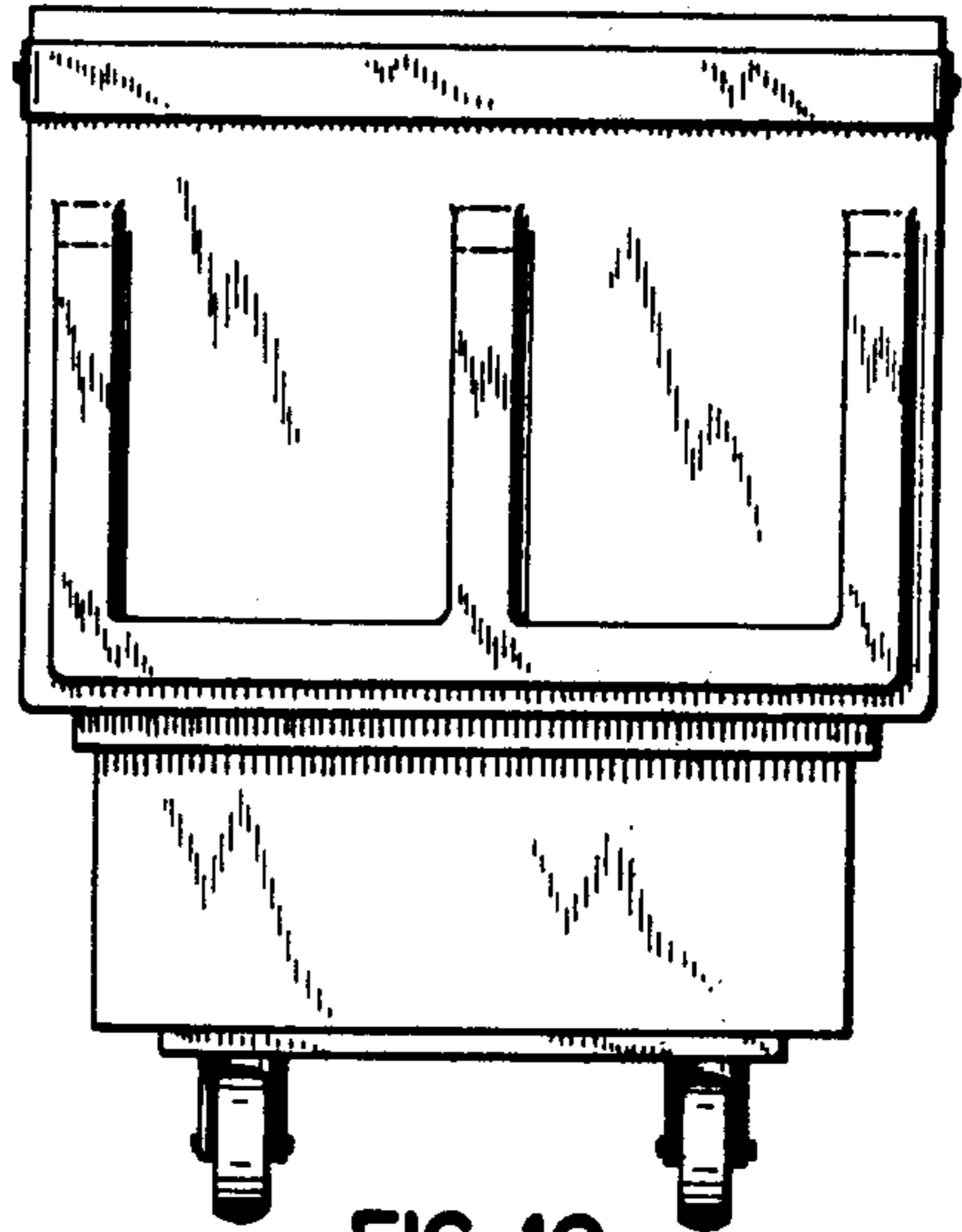

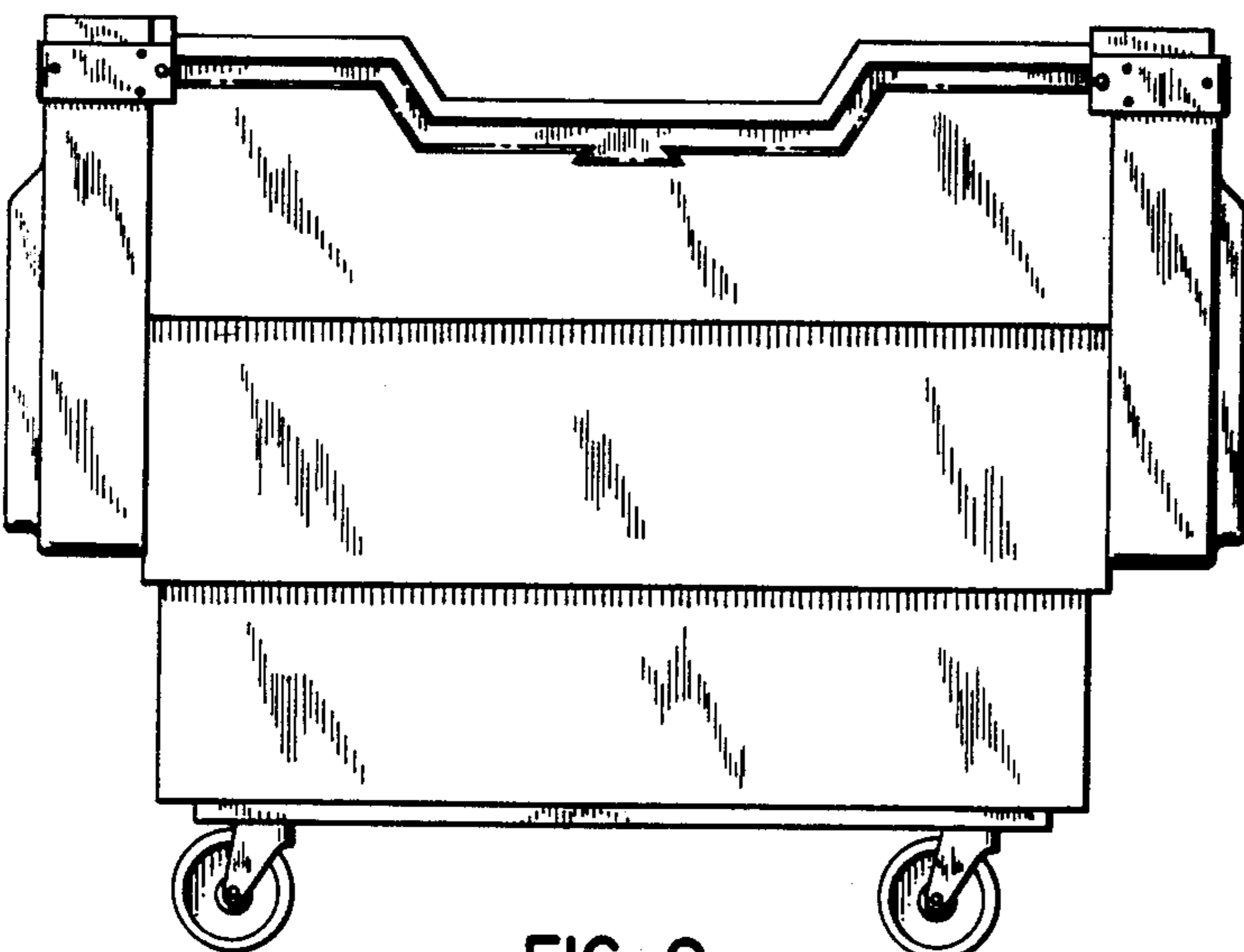

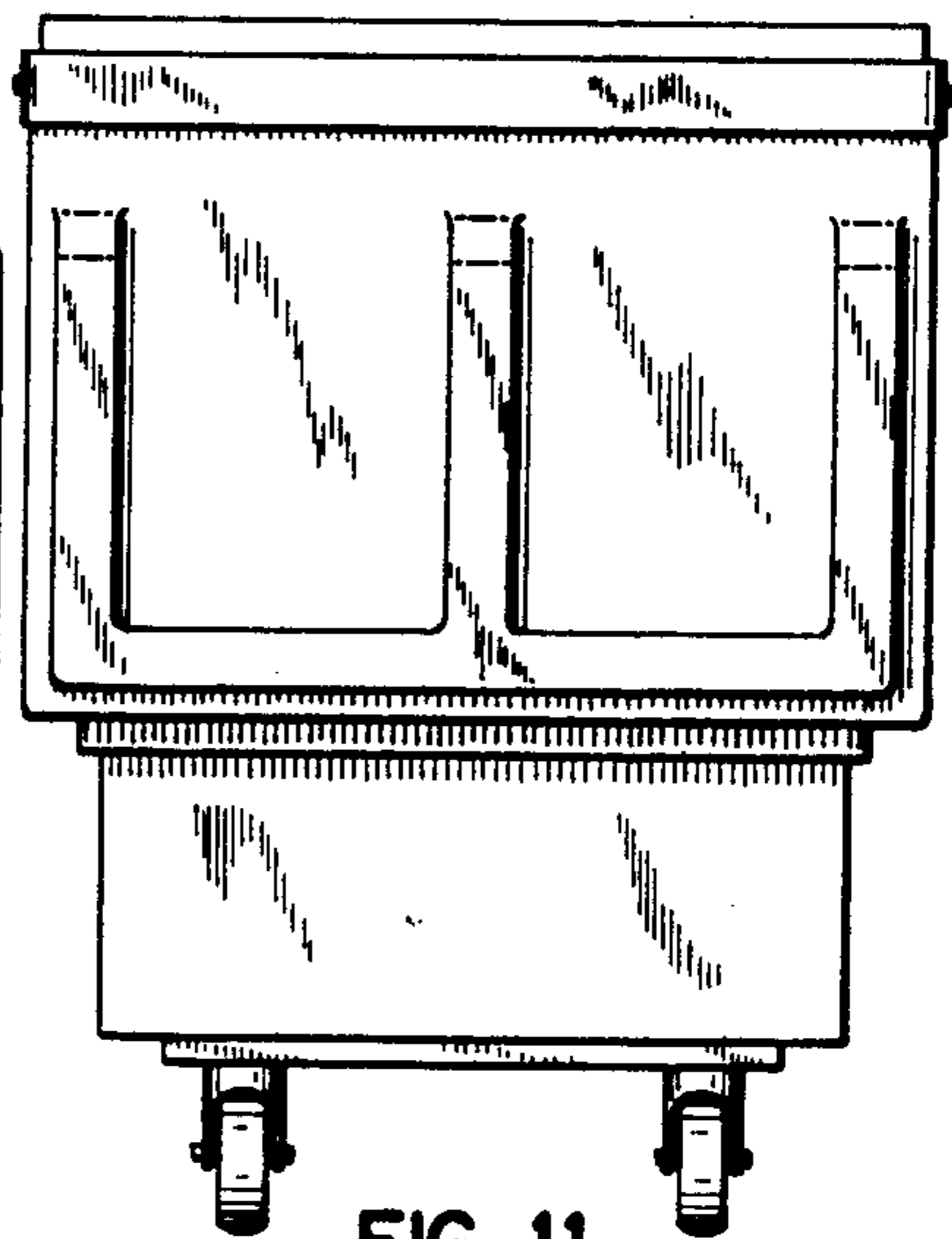

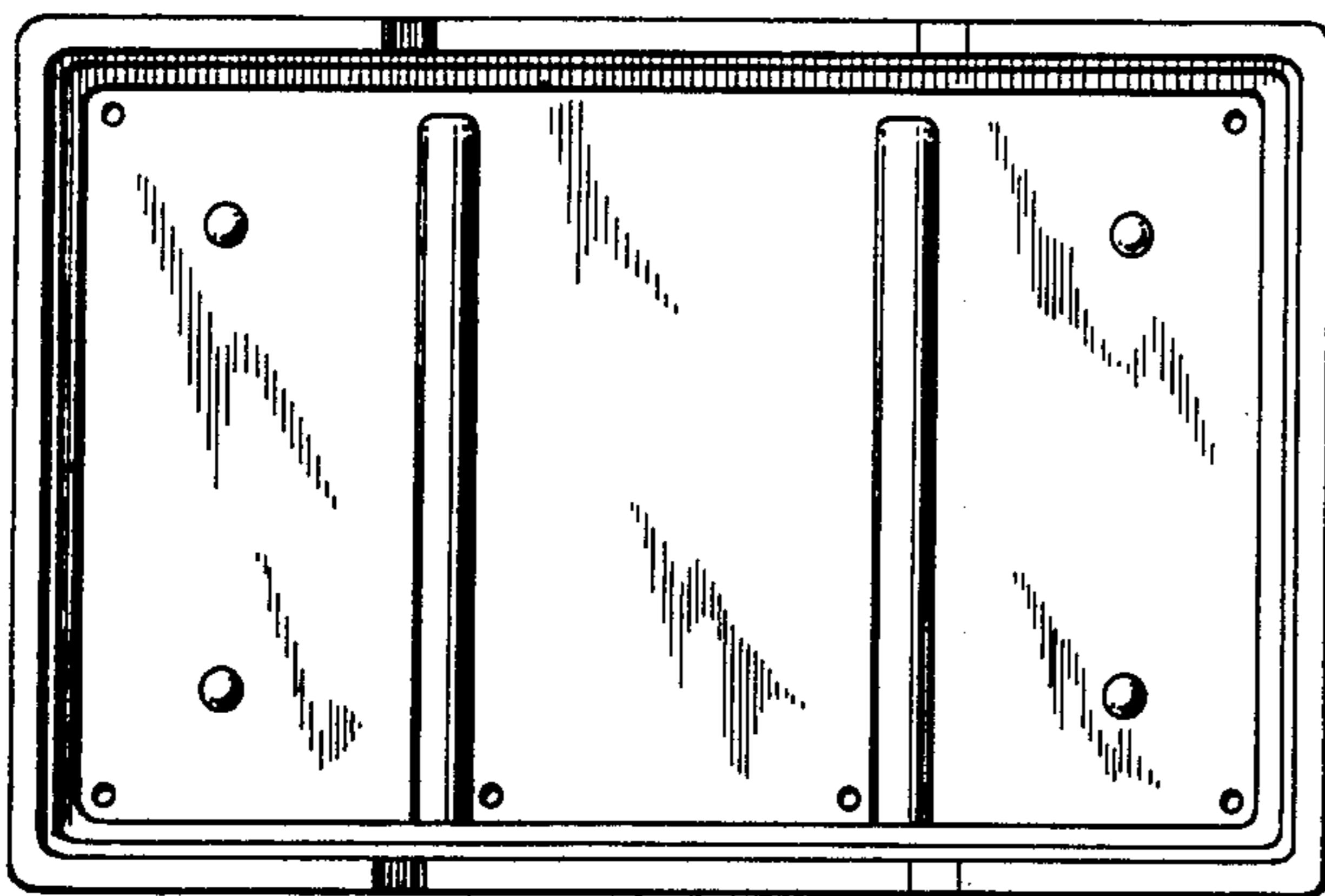

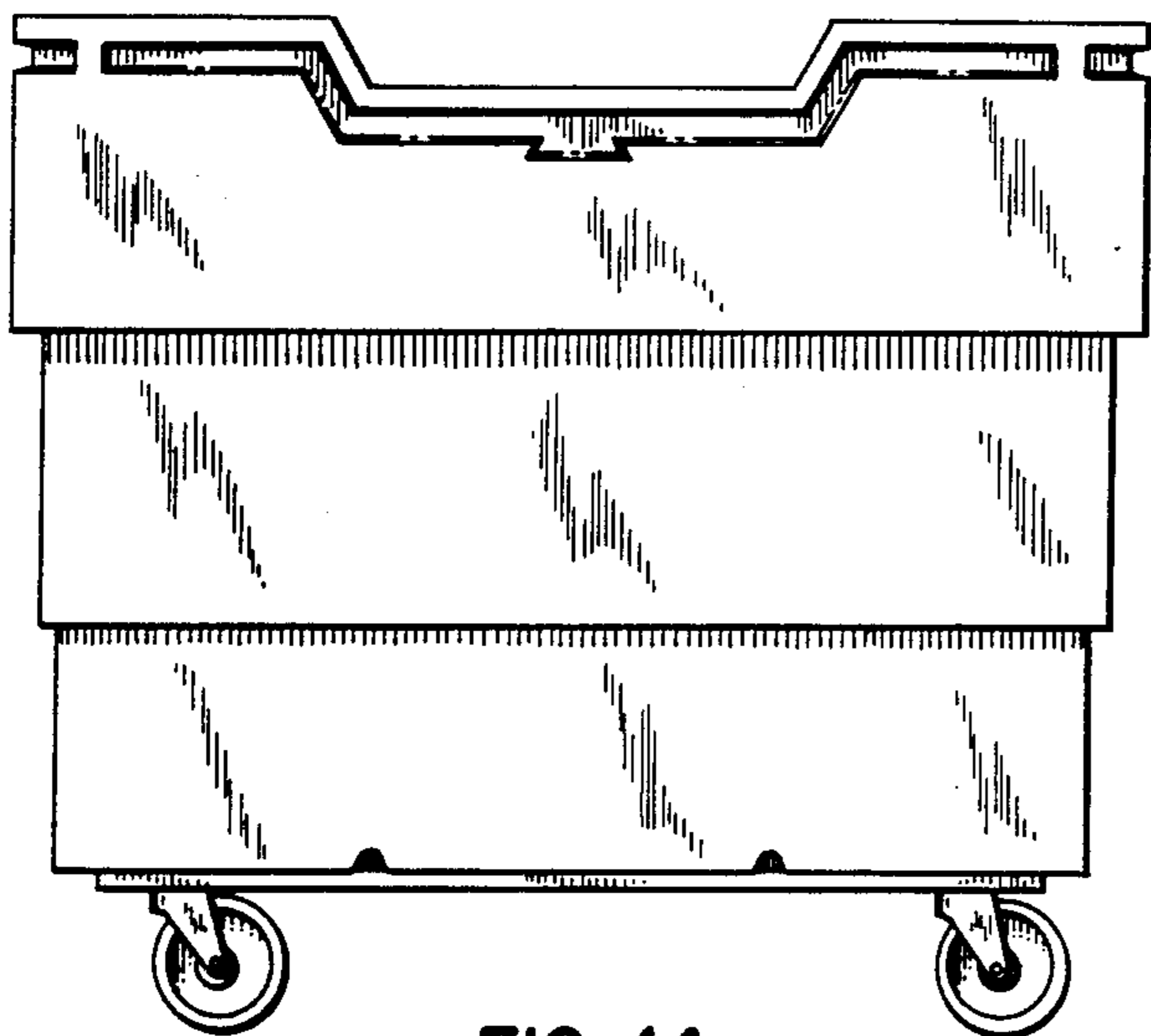

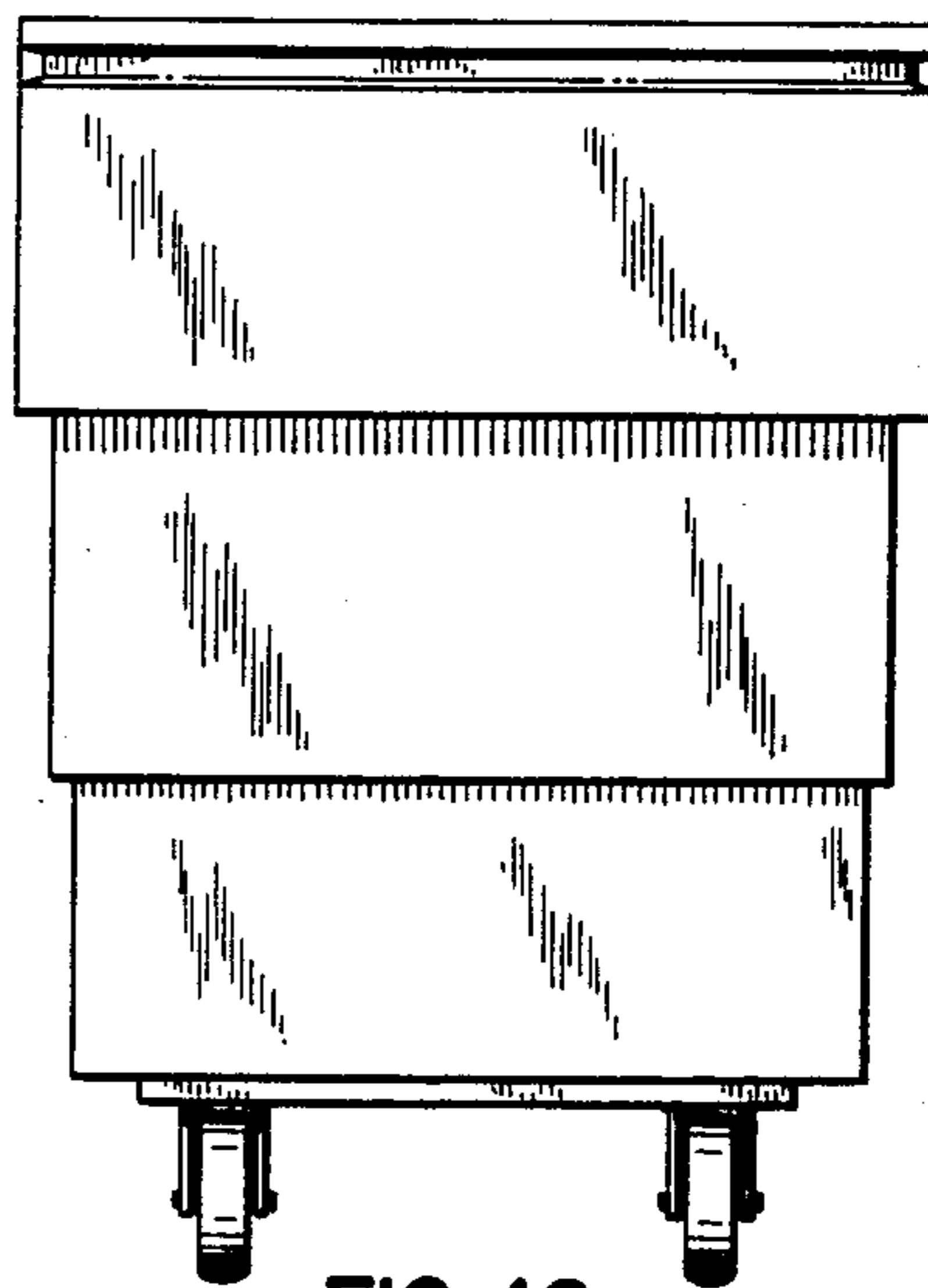

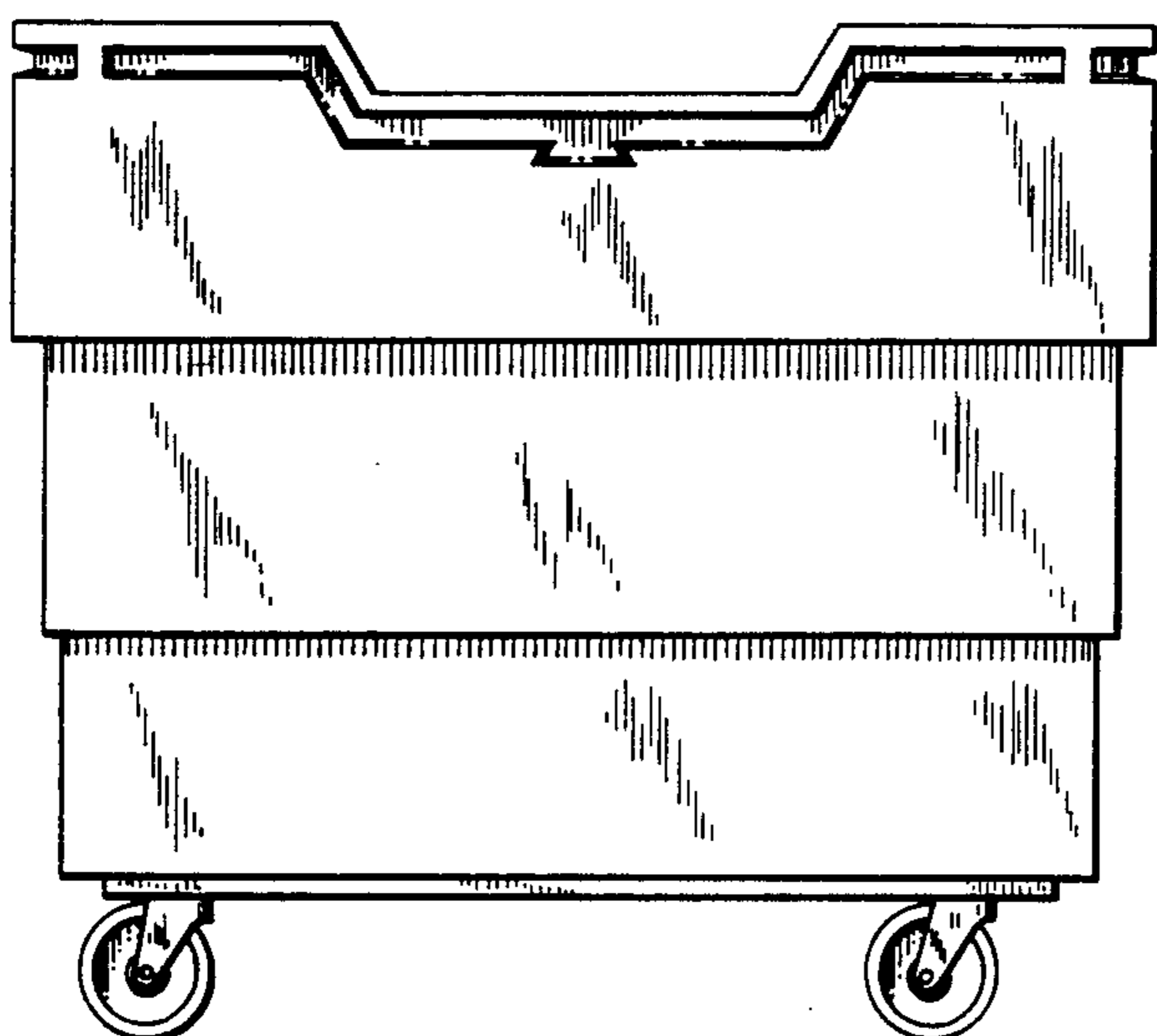

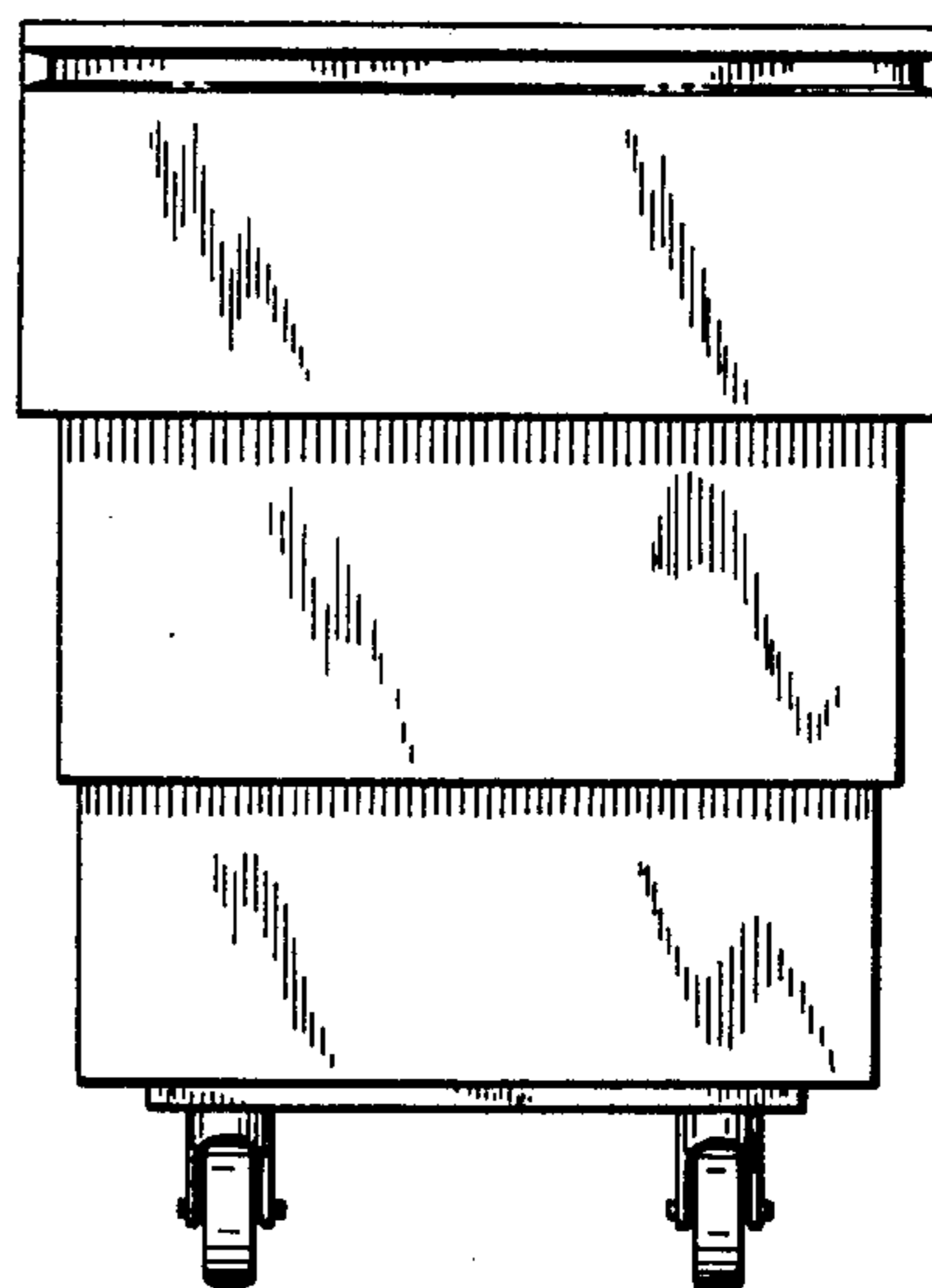
