FIG. 5 is a bottom view of the FIG. 2.

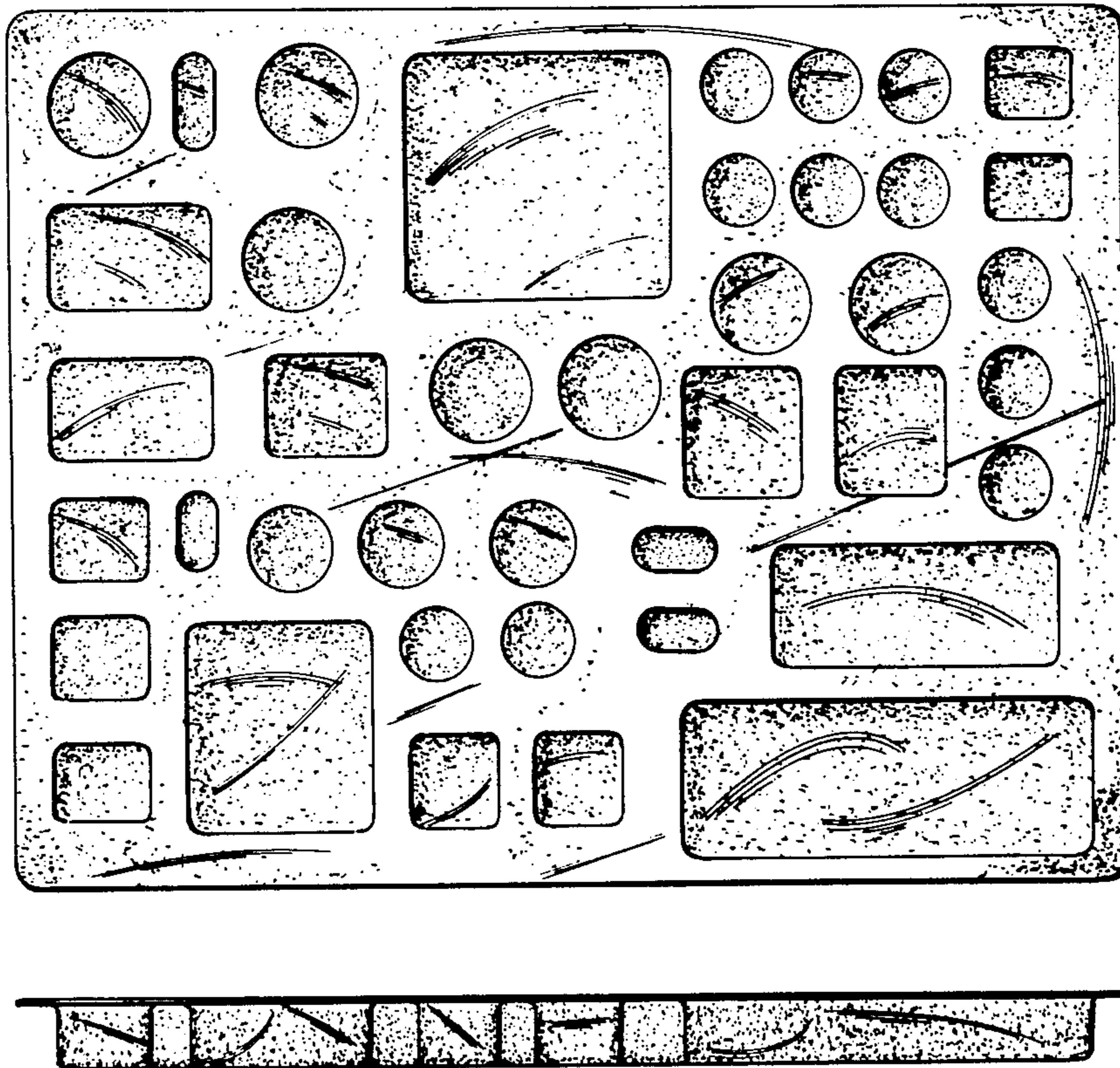

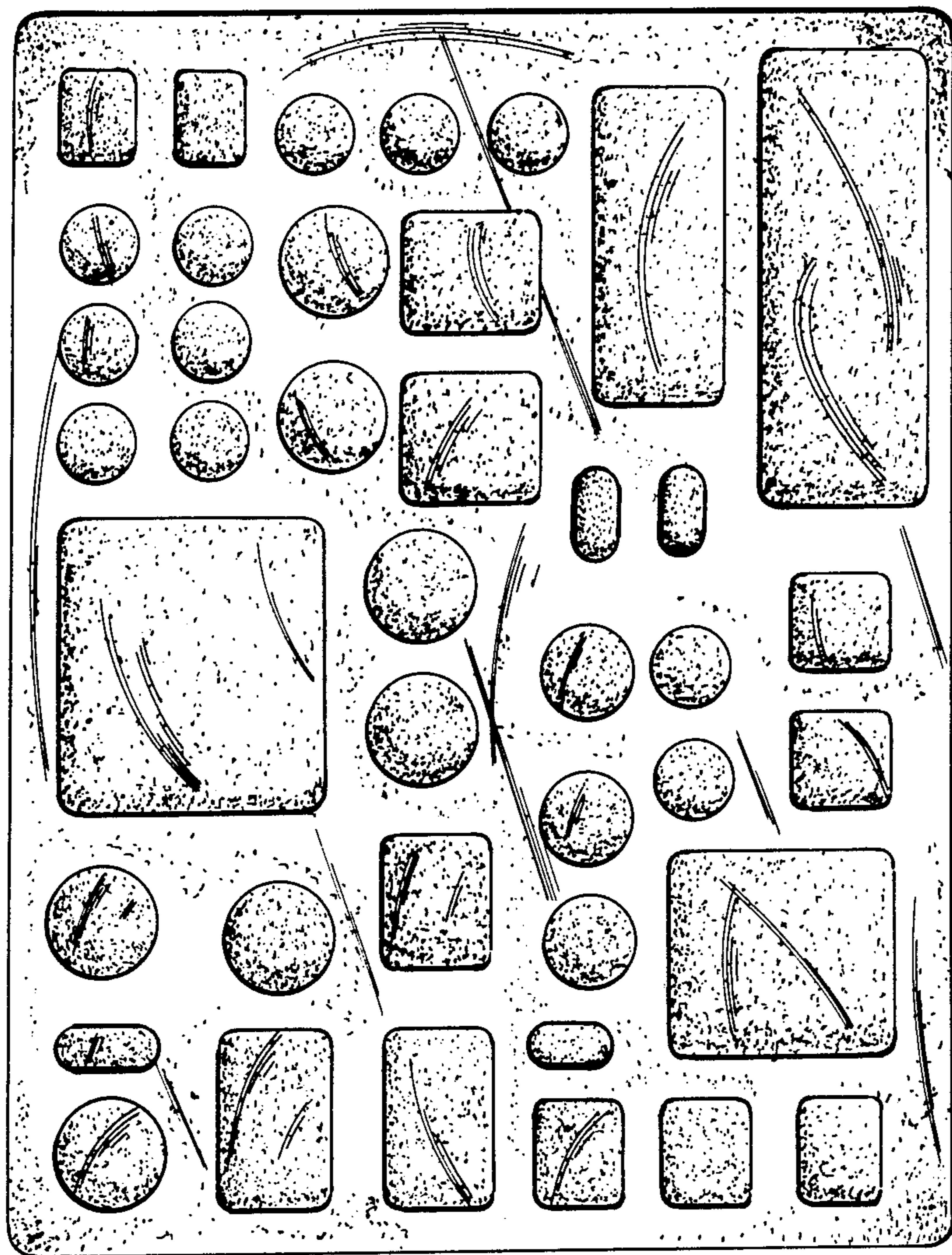


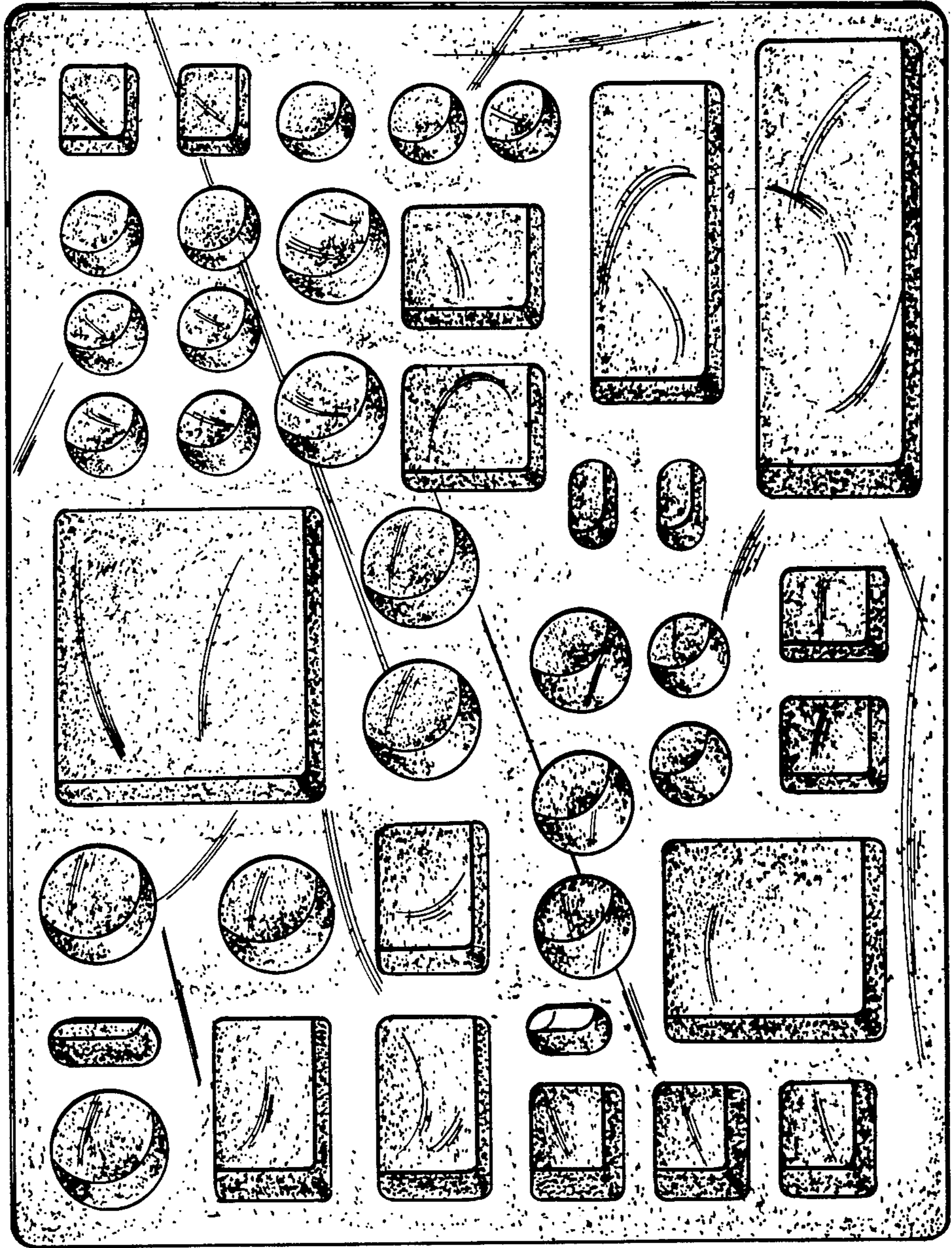
