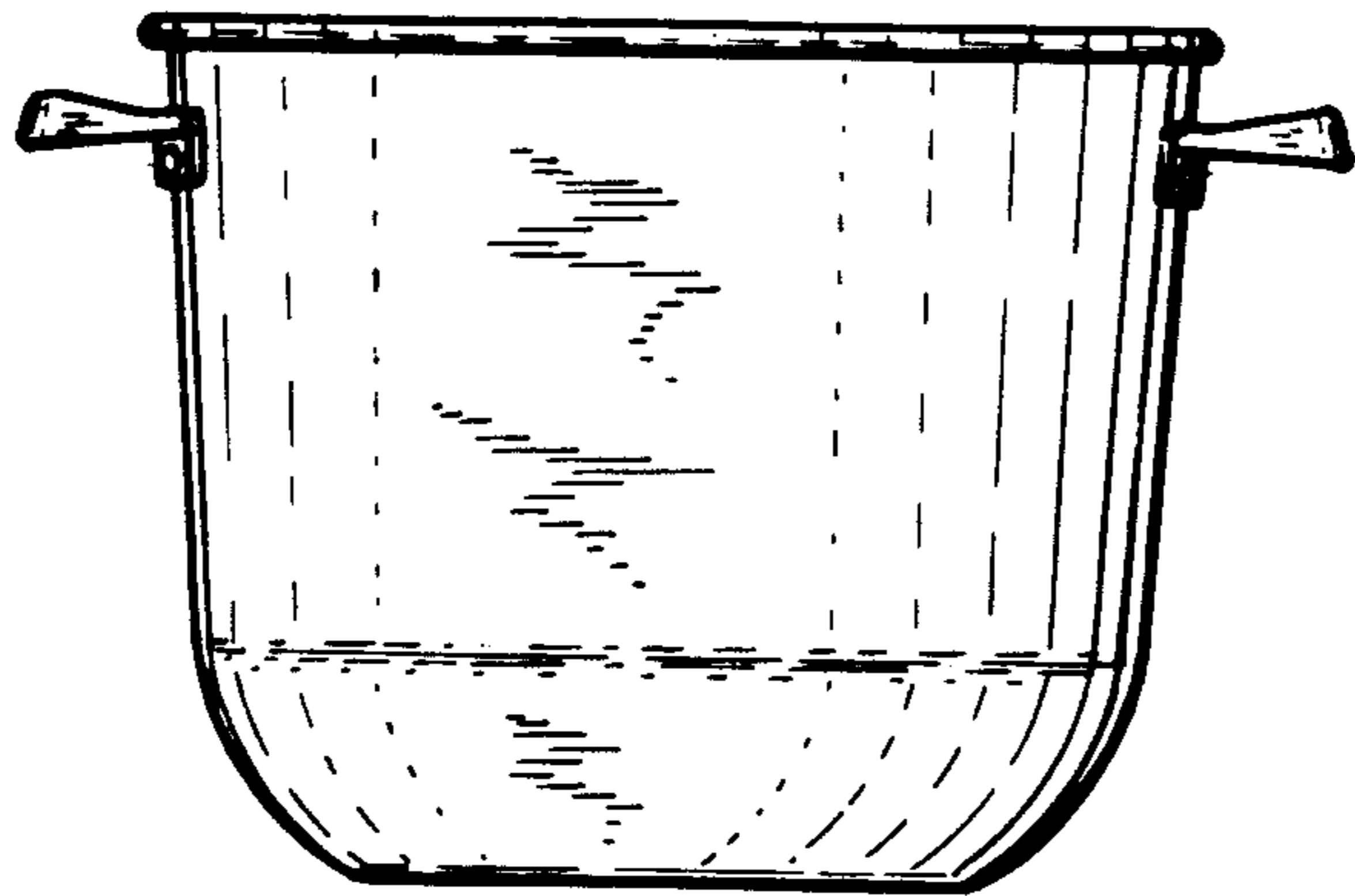
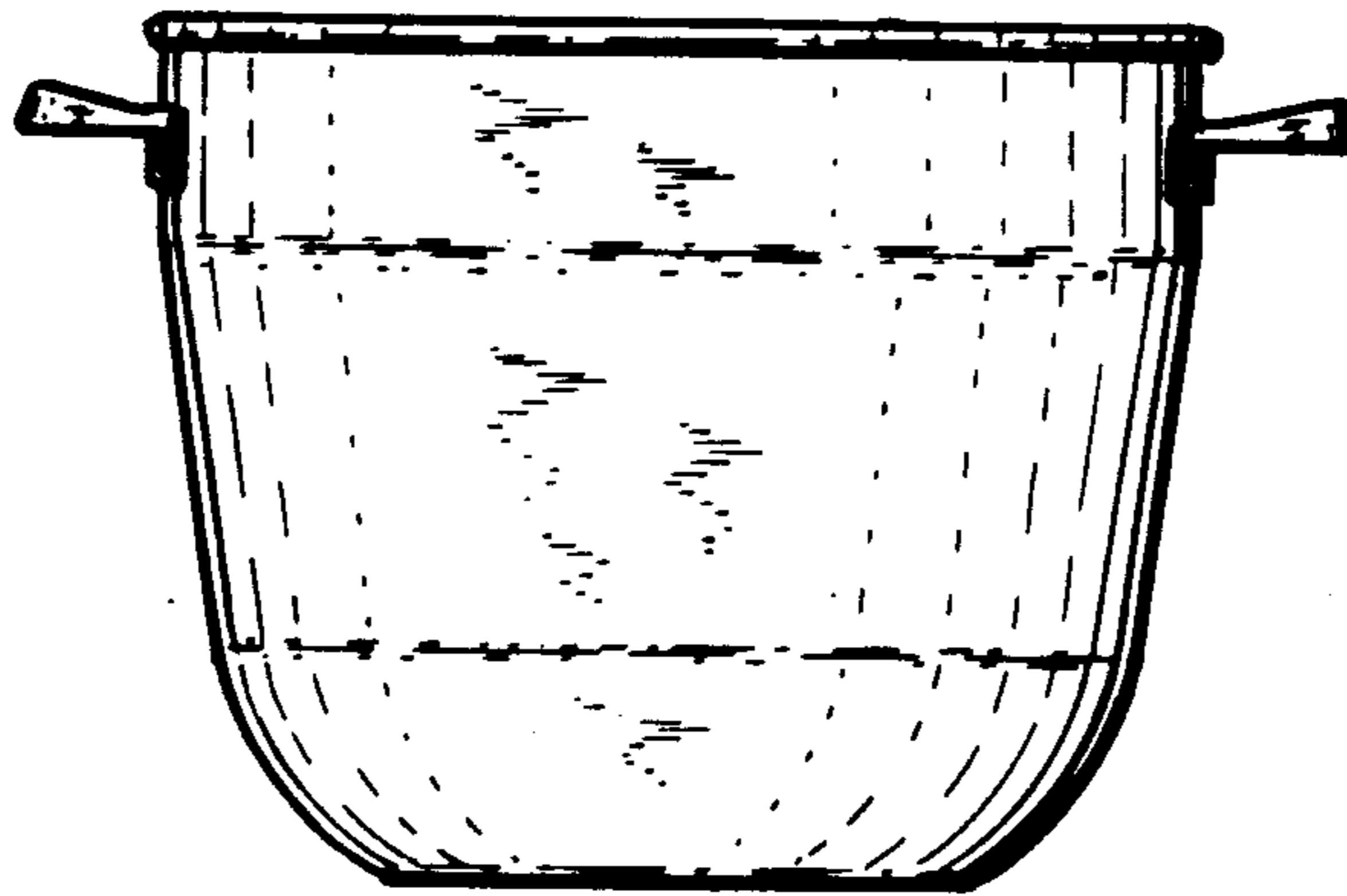

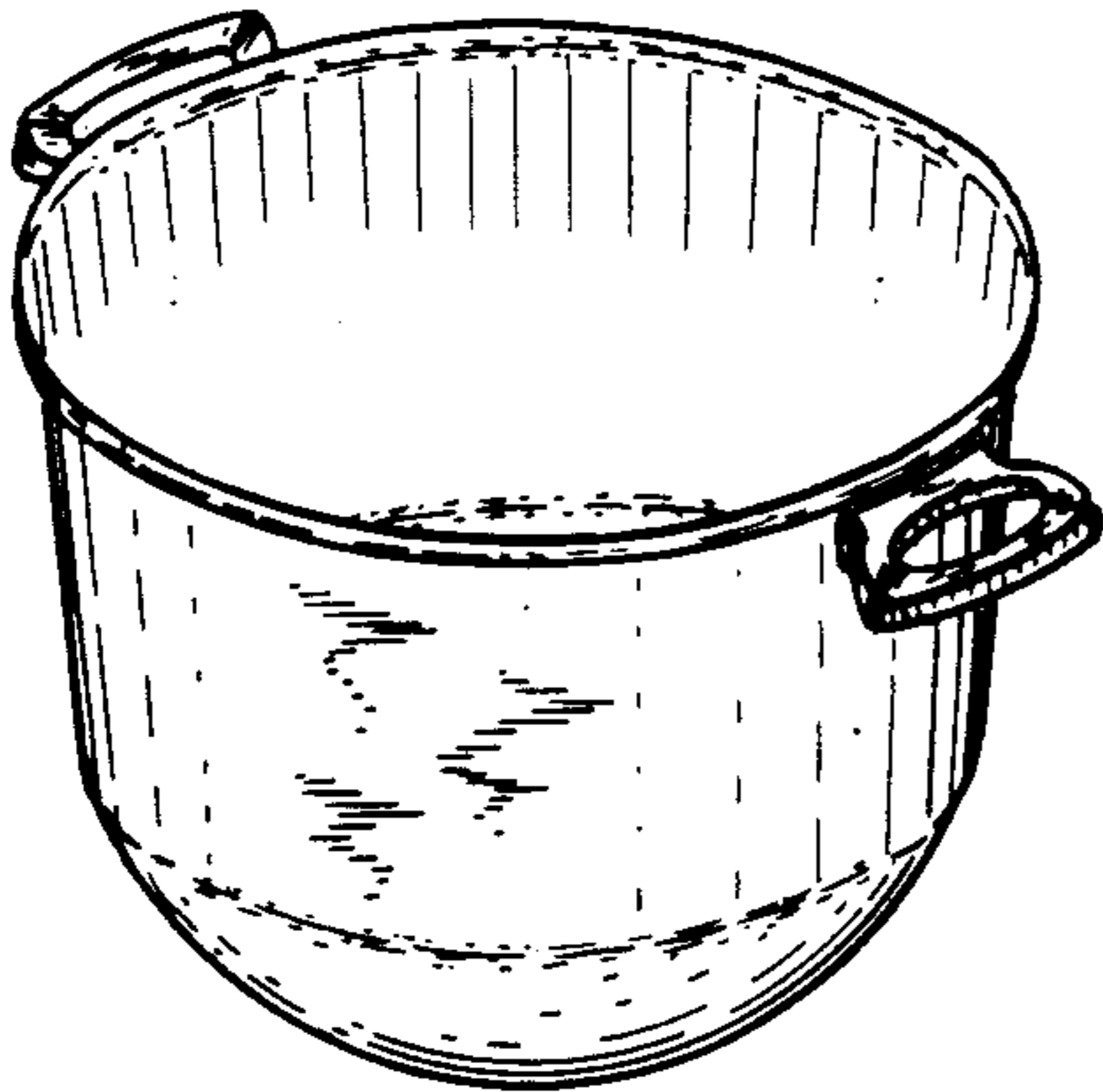
The ornamental design for a pot, as shown and described.

DESCRIPTION

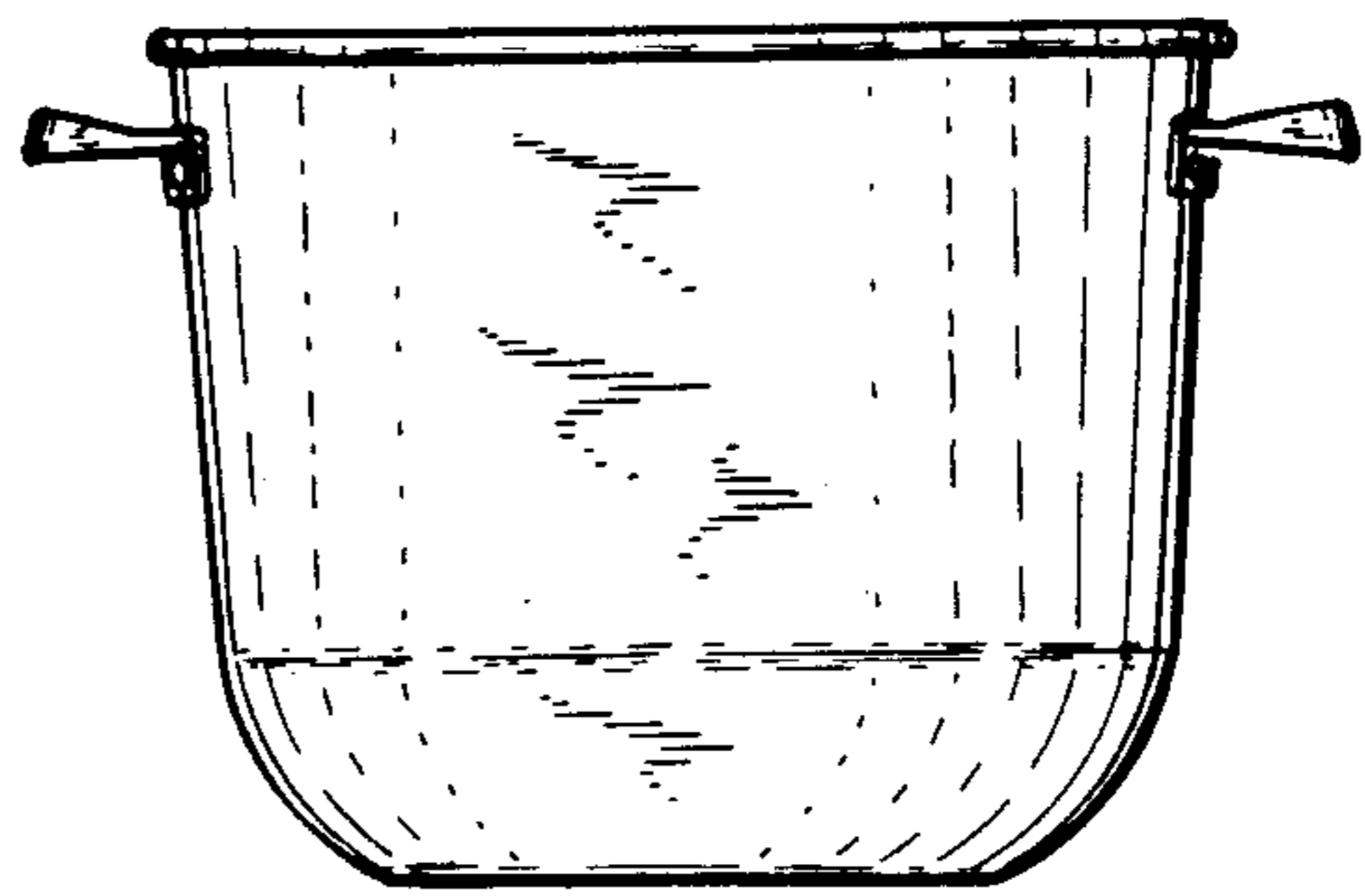
FIG. 1 is a perspective view of a pot embodying my new design;

 FIG. 14 is a side view, from the right side thereof, of the alternative embodiment shown in FIG. 8.



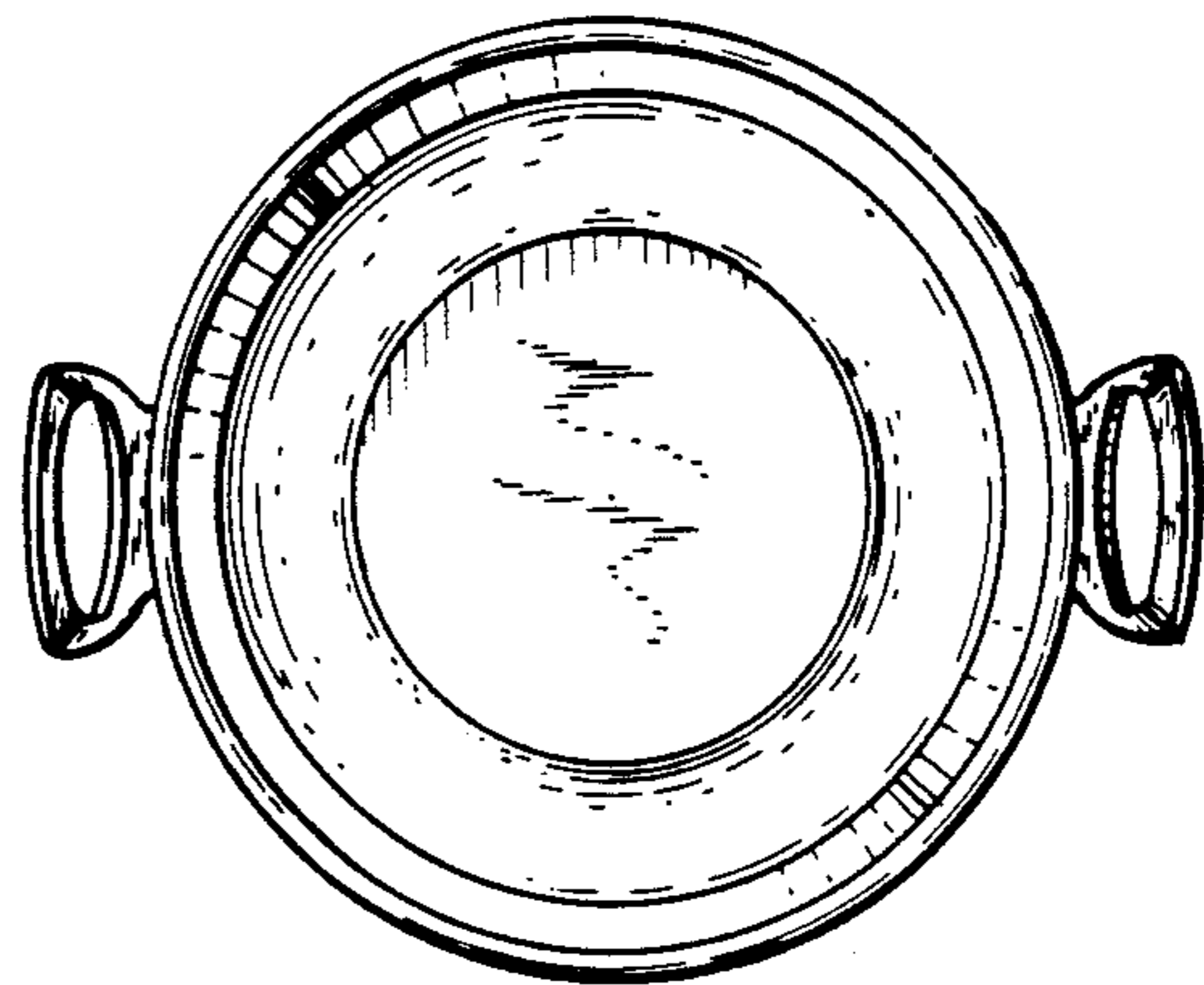

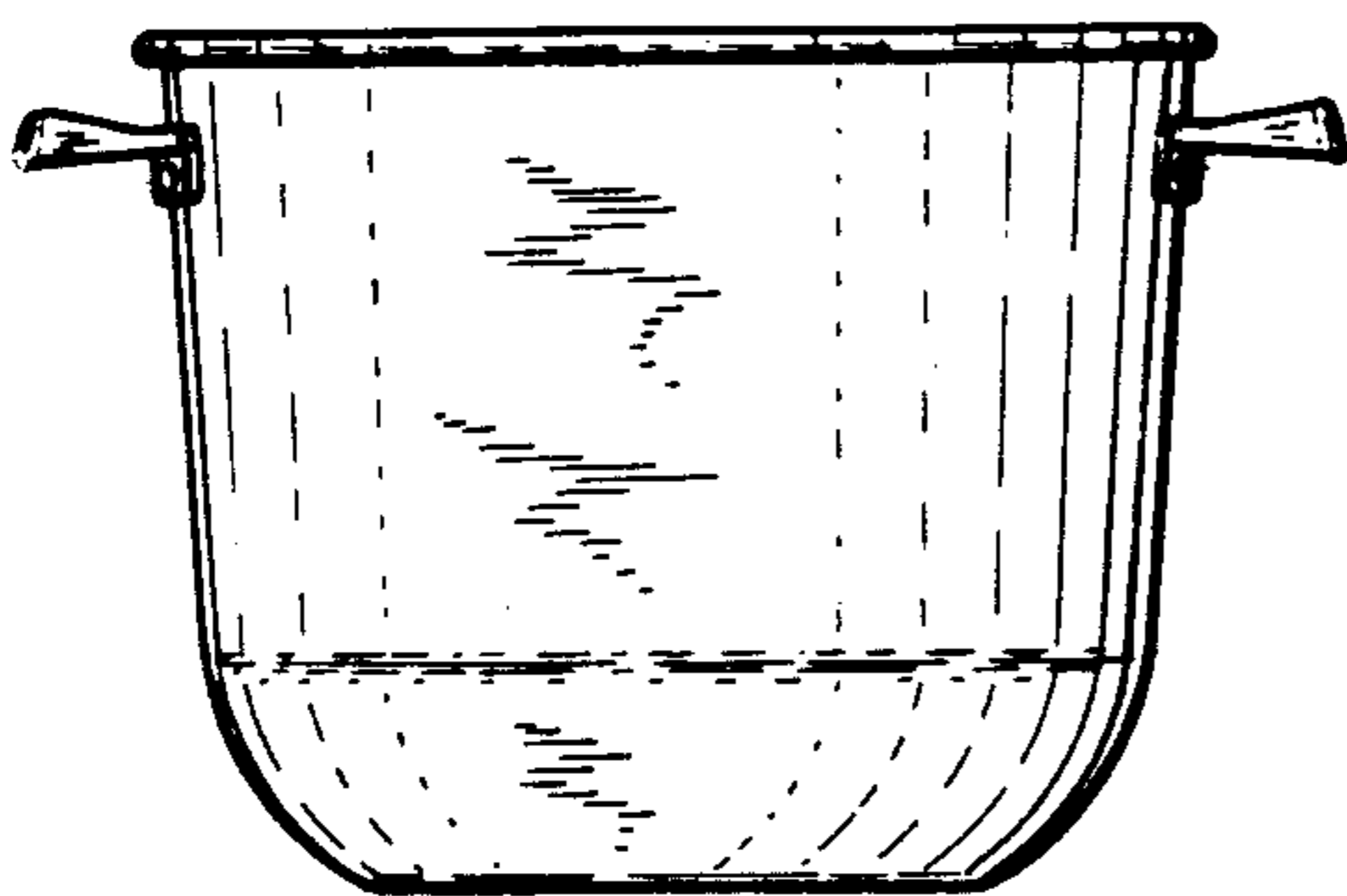

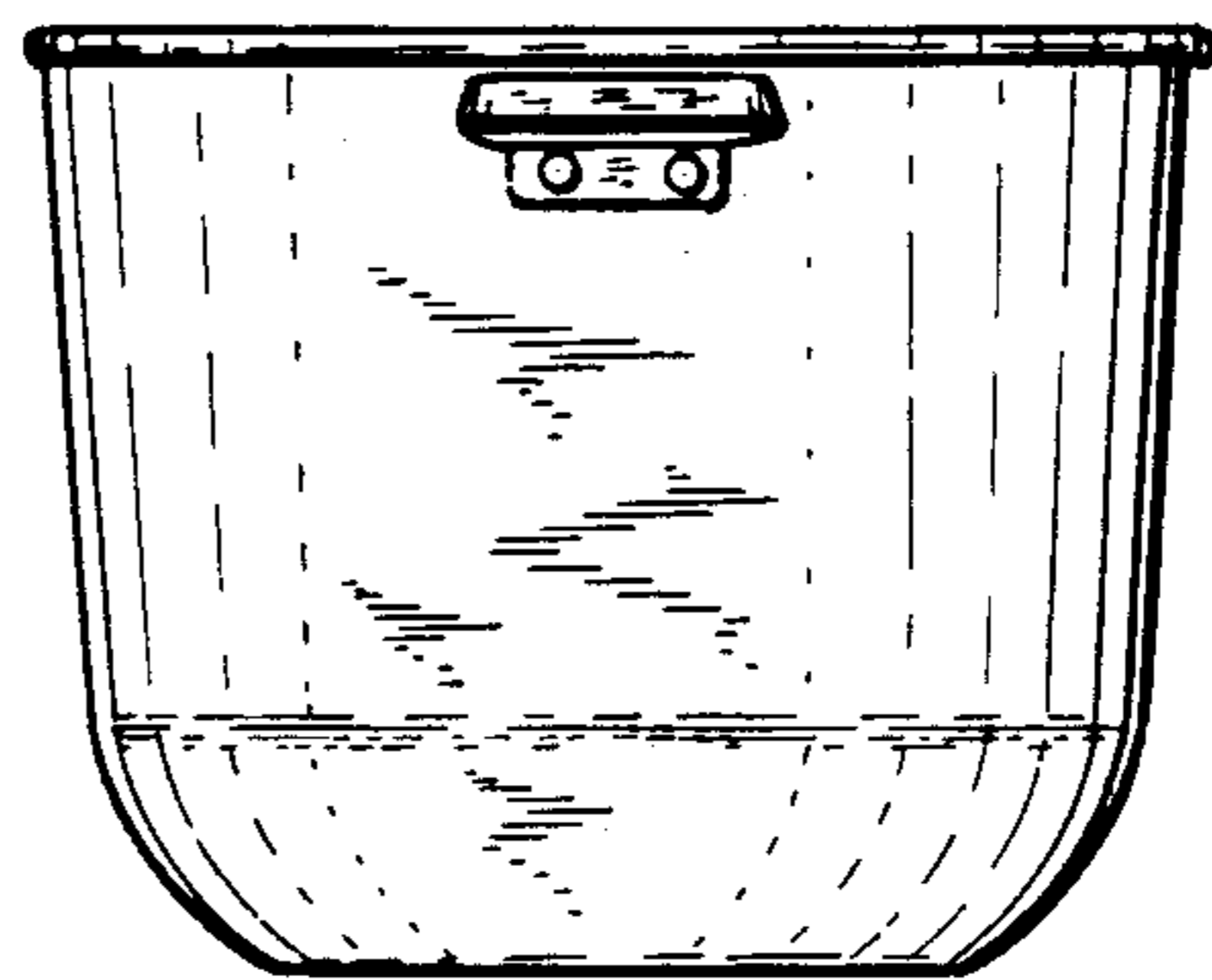

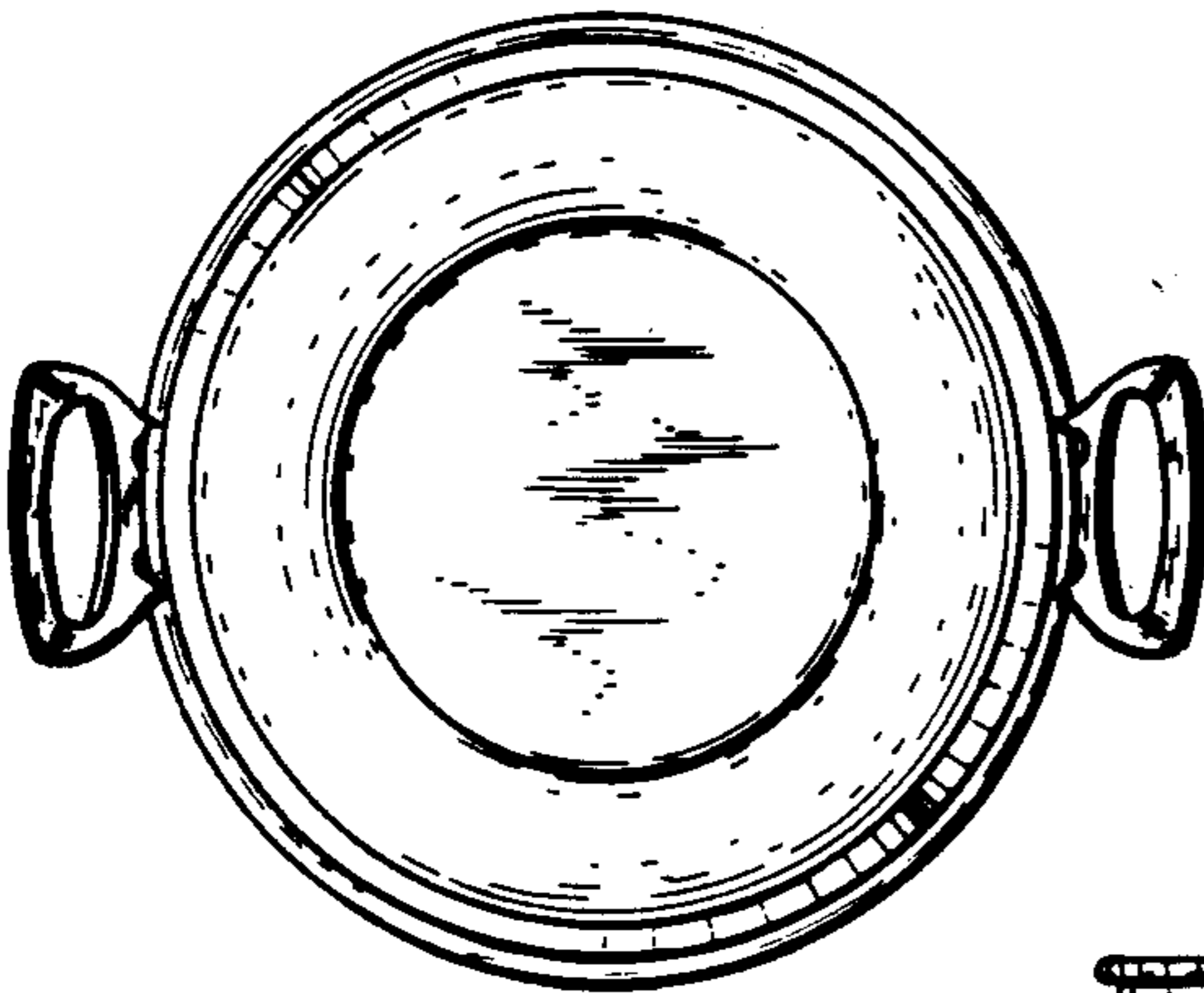

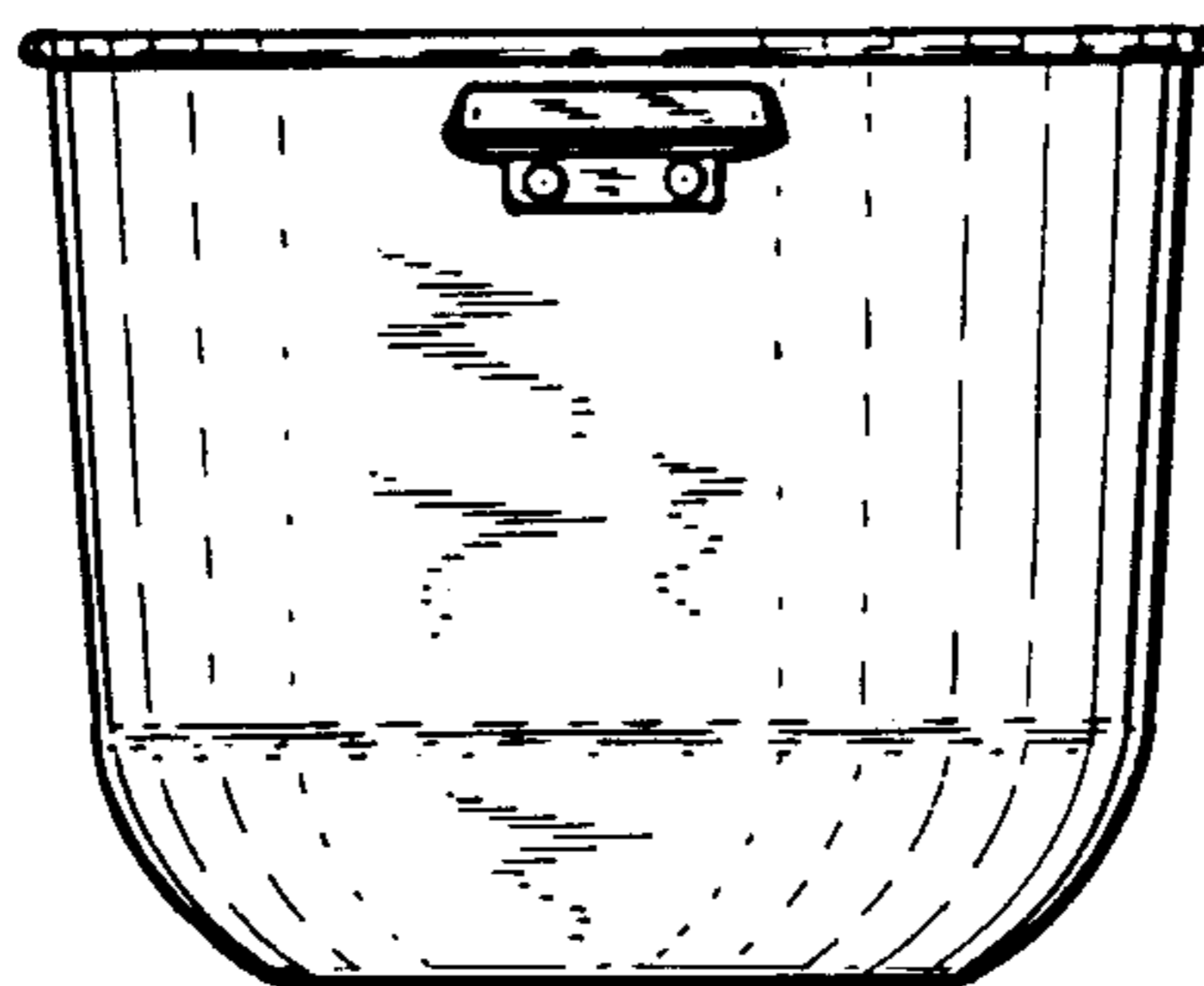

[57] **CLAIM**

The ornamental design for a heavy duty outdoor stove, substantially as shown.

**DESCRIPTION**

FIG. 1 is a front elevational view of an outdoor stove in accord with my new design,  
 FIG. 2 is a rear elevational view,  
 FIG. 3 is a sectional view thereof, taken along line 3-3 of FIG. 4;  
 FIG. 4 is an elevational view as taken from the right of FIG. 1, the end elevational view of the opposite end being the mirror image thereof.
