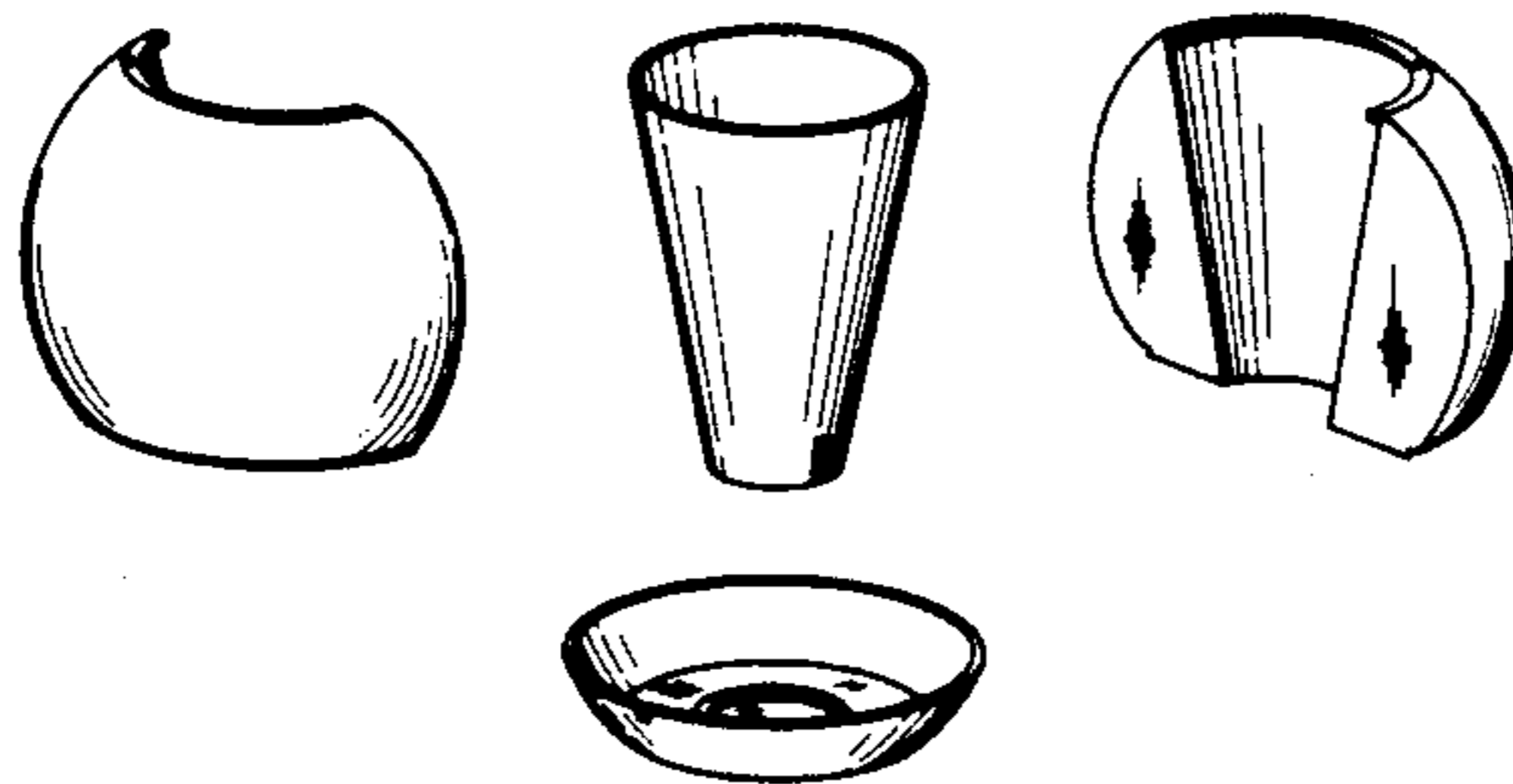
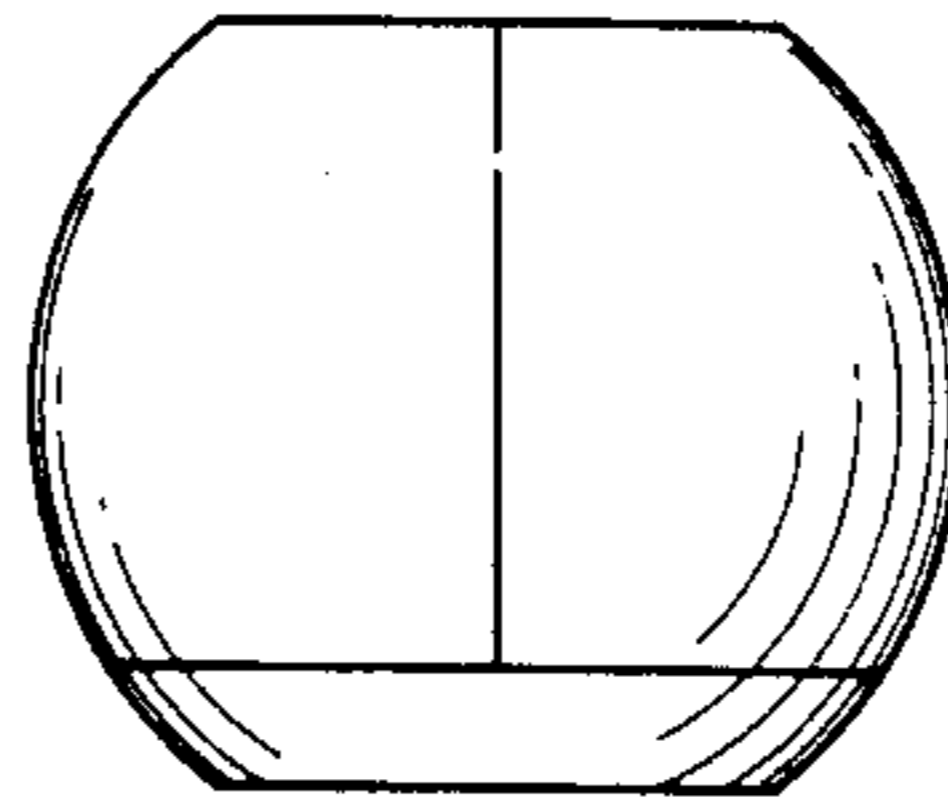

[57] CLAIM

The ornamental design for combined flowerpot, tray and watering reservoirs, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top view of a combined flowerpot, tray and watering reservoirs showing my design;
 FIG. 2 is a front view of FIG. 1;
 FIG. 3 is a side view of FIG. 1;
 FIG. 4 is a bottom view of FIG. 1;
 FIG. 5 is an exploded perspective view thereof;
 FIG. 6 is a front perspective view of the flowerpot and tray in assembled relation;
 FIG. 7 is a side perspective view of FIG. 6;
 FIG. 8 is an elevational view of the inside of one of the watering reservoirs;
 FIG. 9 is a top view of FIG. 8;
 FIG. 10 is a side view of FIG. 8;
 FIG. 11 is a bottom view of FIG. 8; and
 FIG. 12 is perspective view of the flowerpot, tray and one of the watering reservoirs in assembled relation.
 In FIGS. 5 through 12, the individual elements of the combined flowerpot, tray and watering reservoirs therefor are shown separately and in combination for illustrative purposes only.



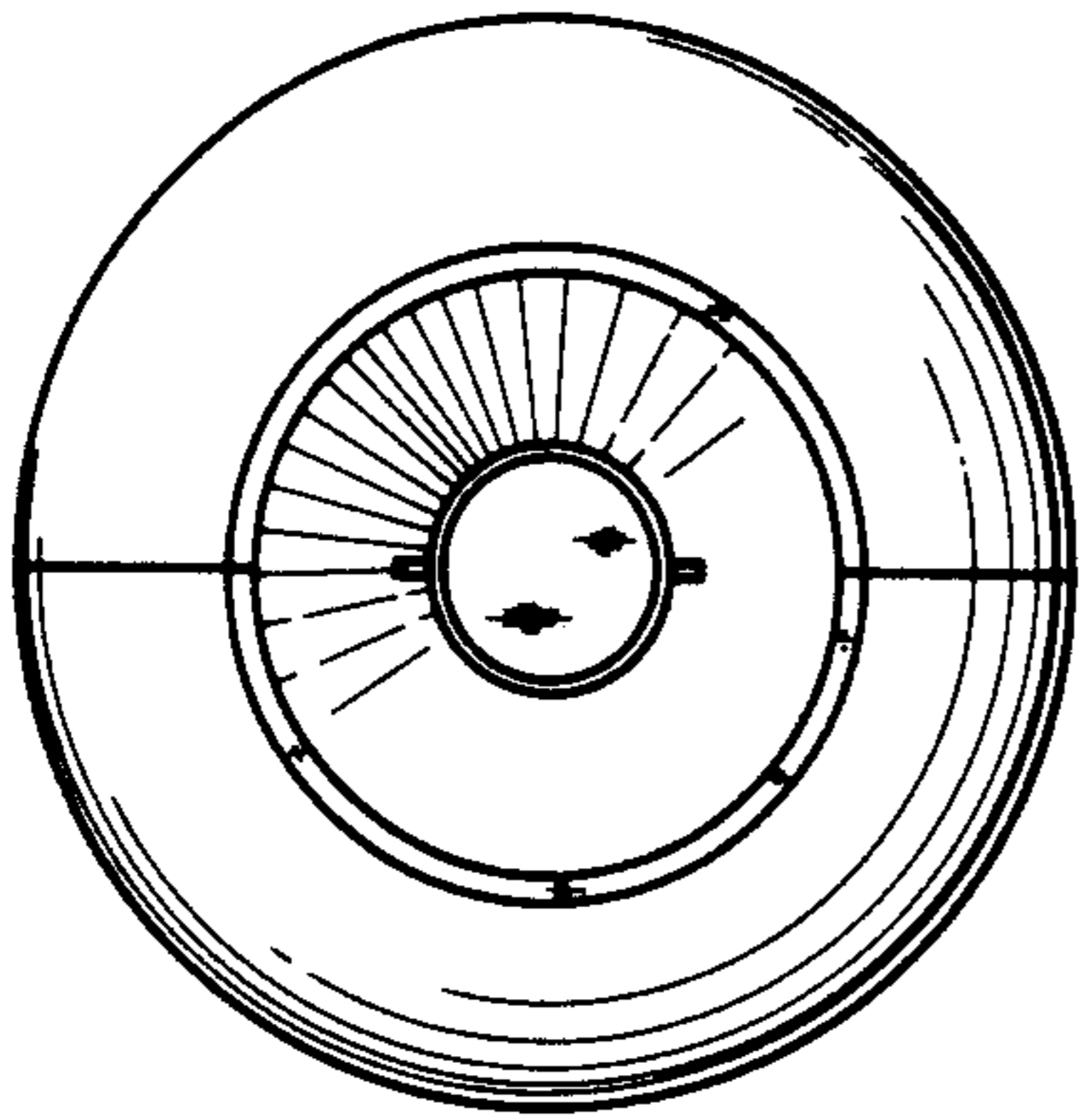

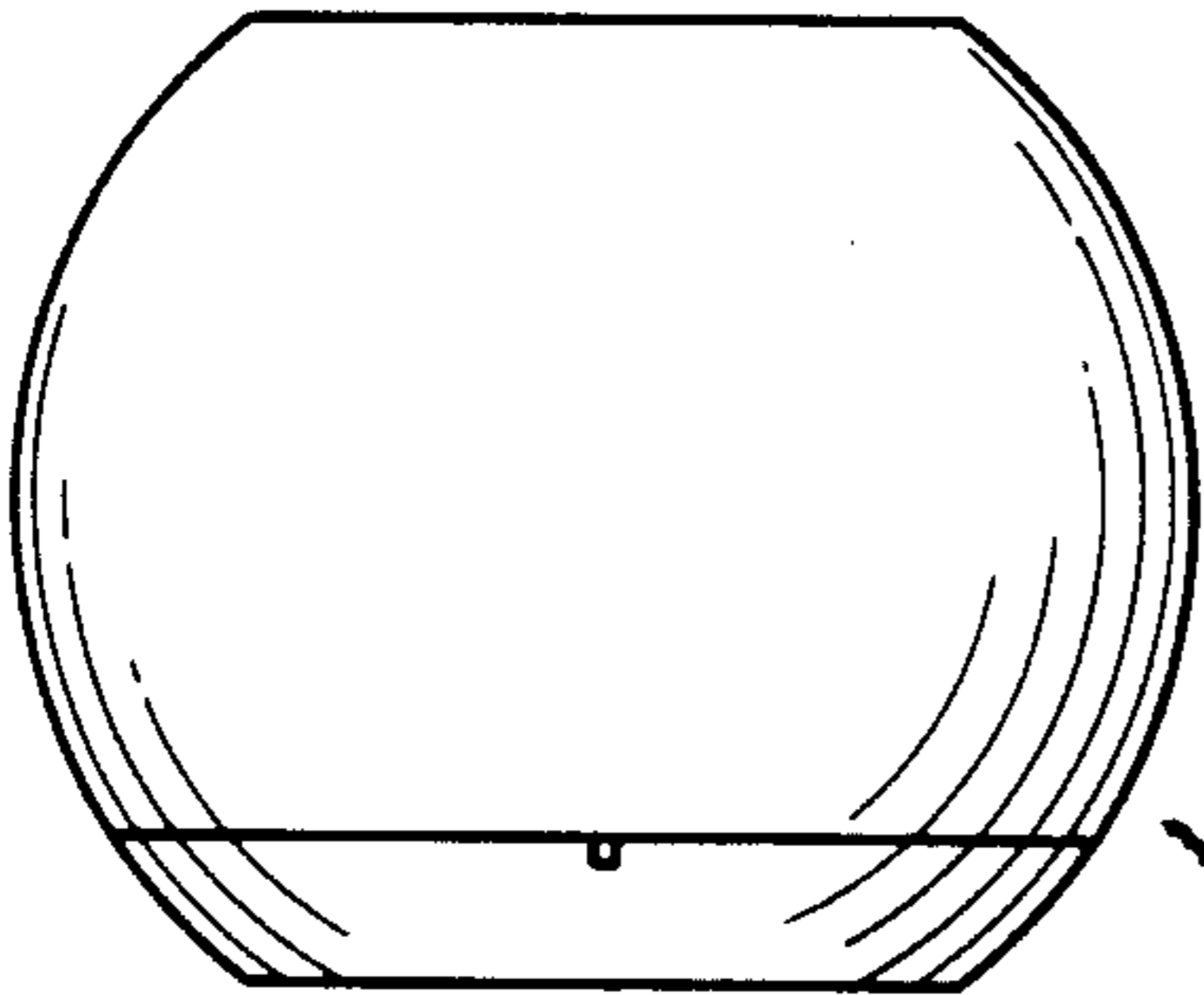

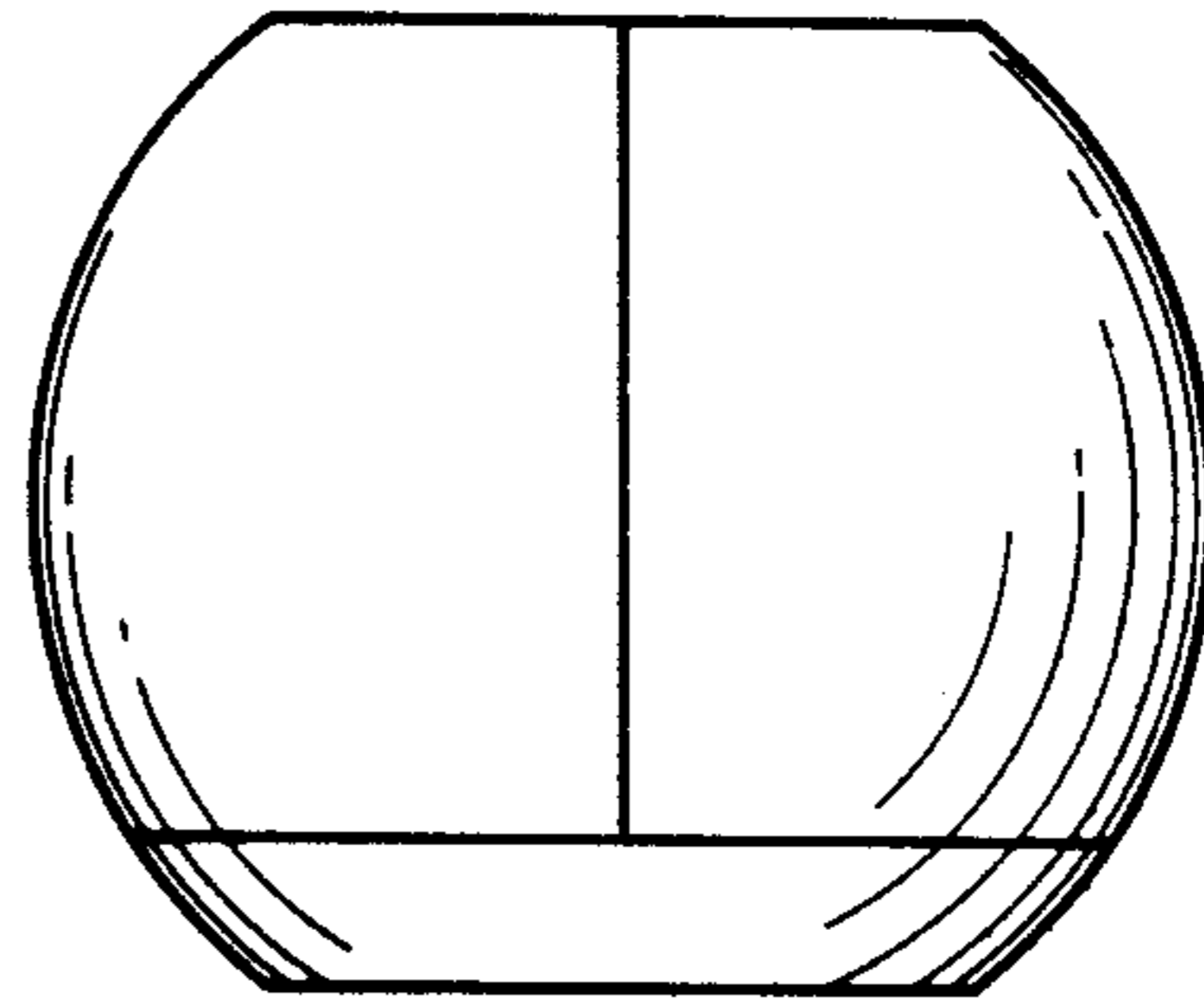

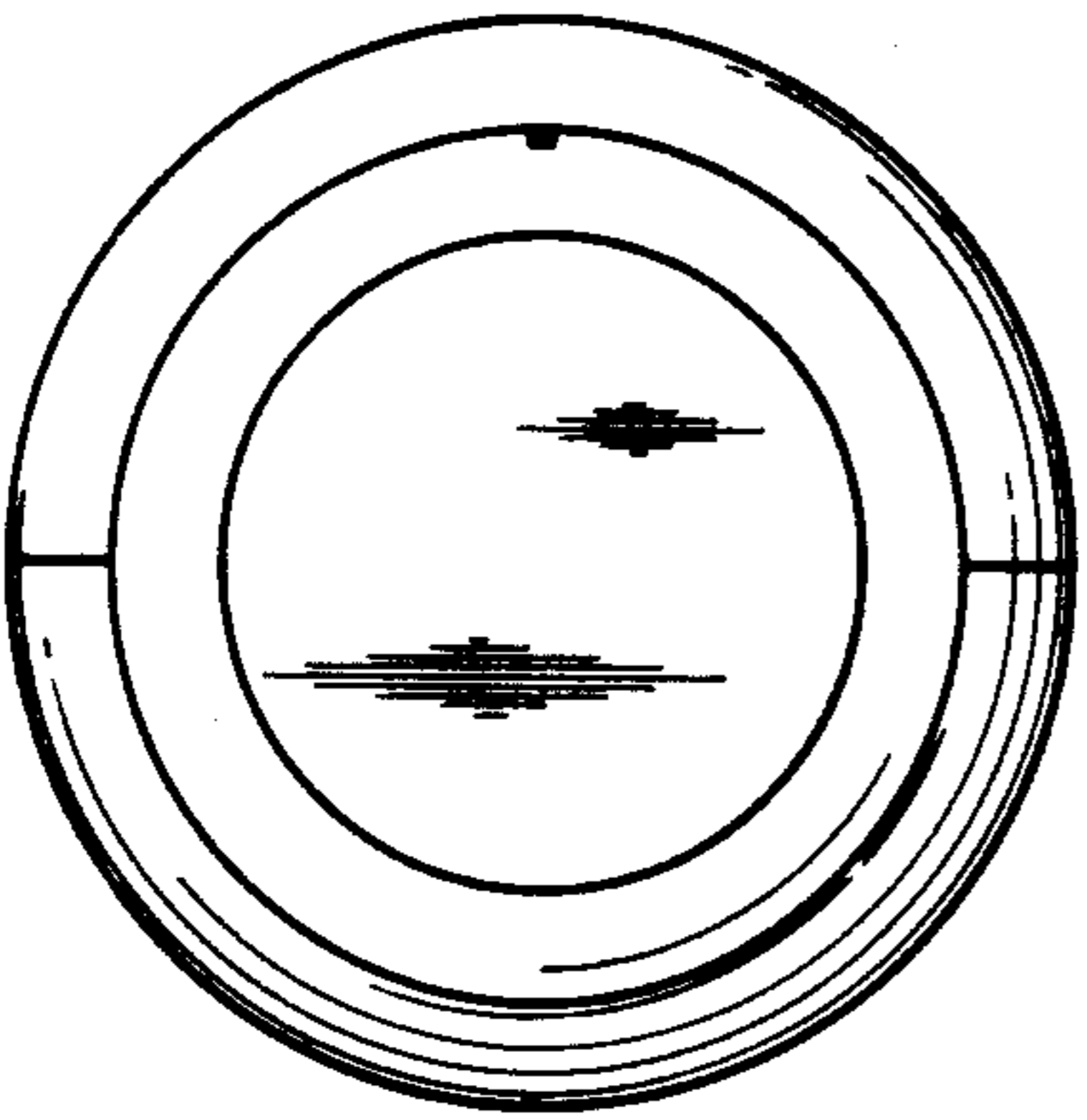

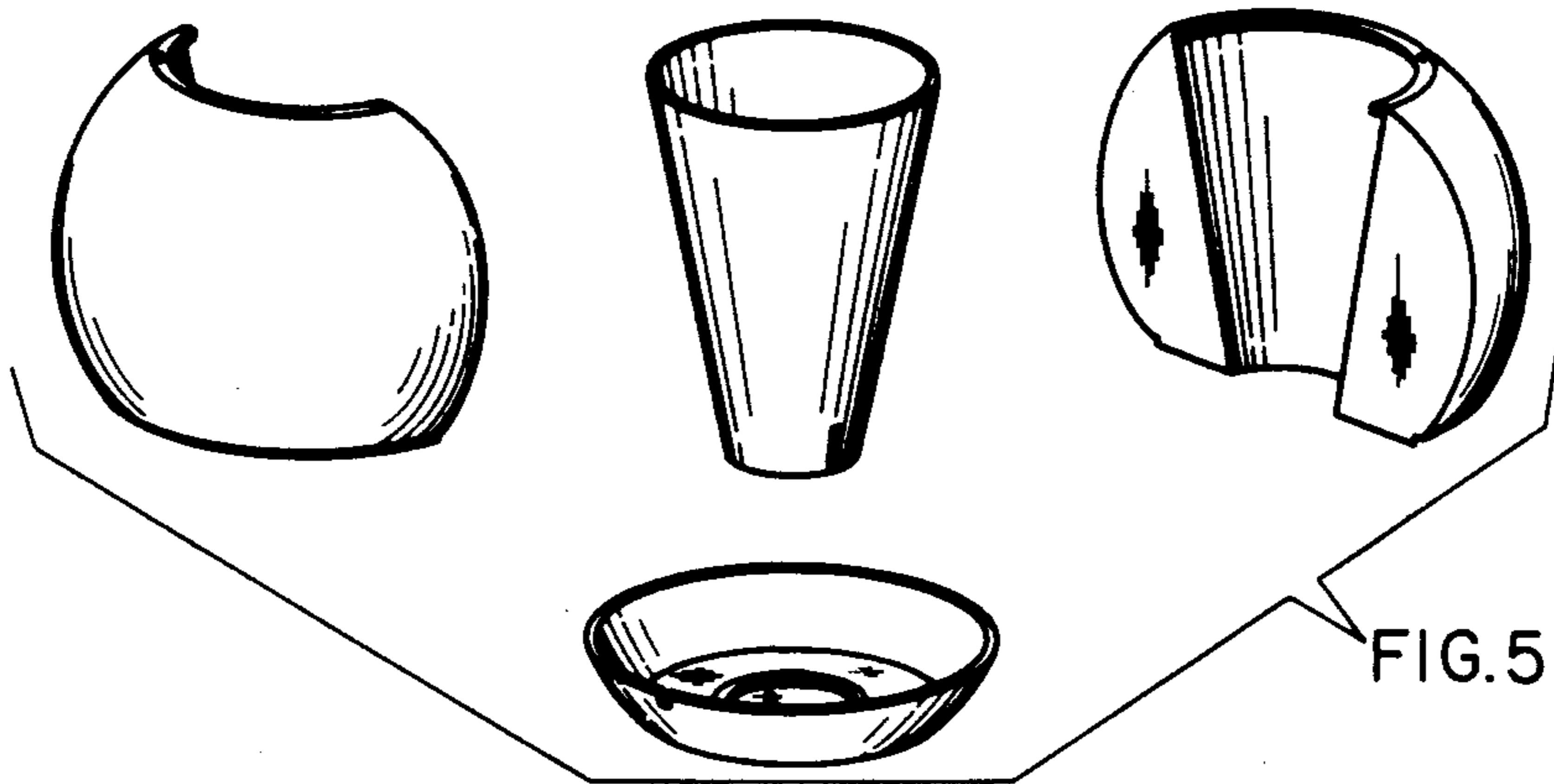

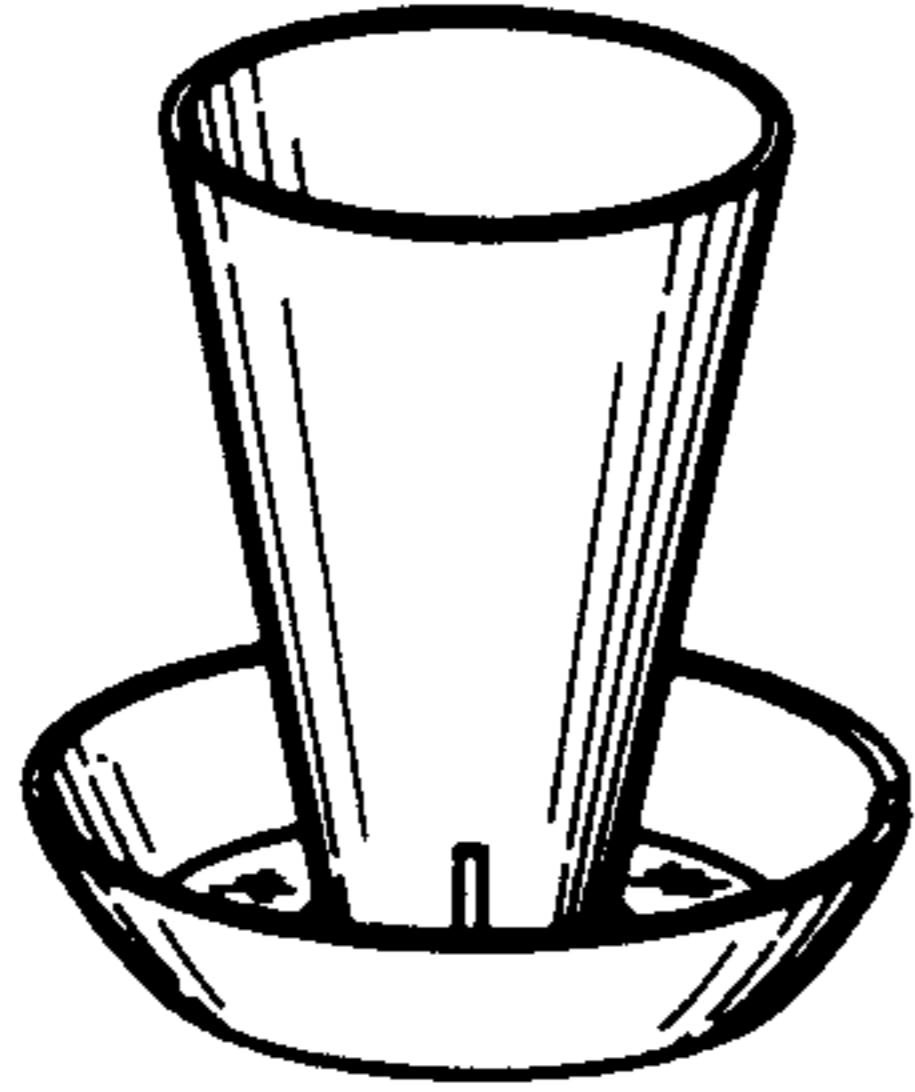

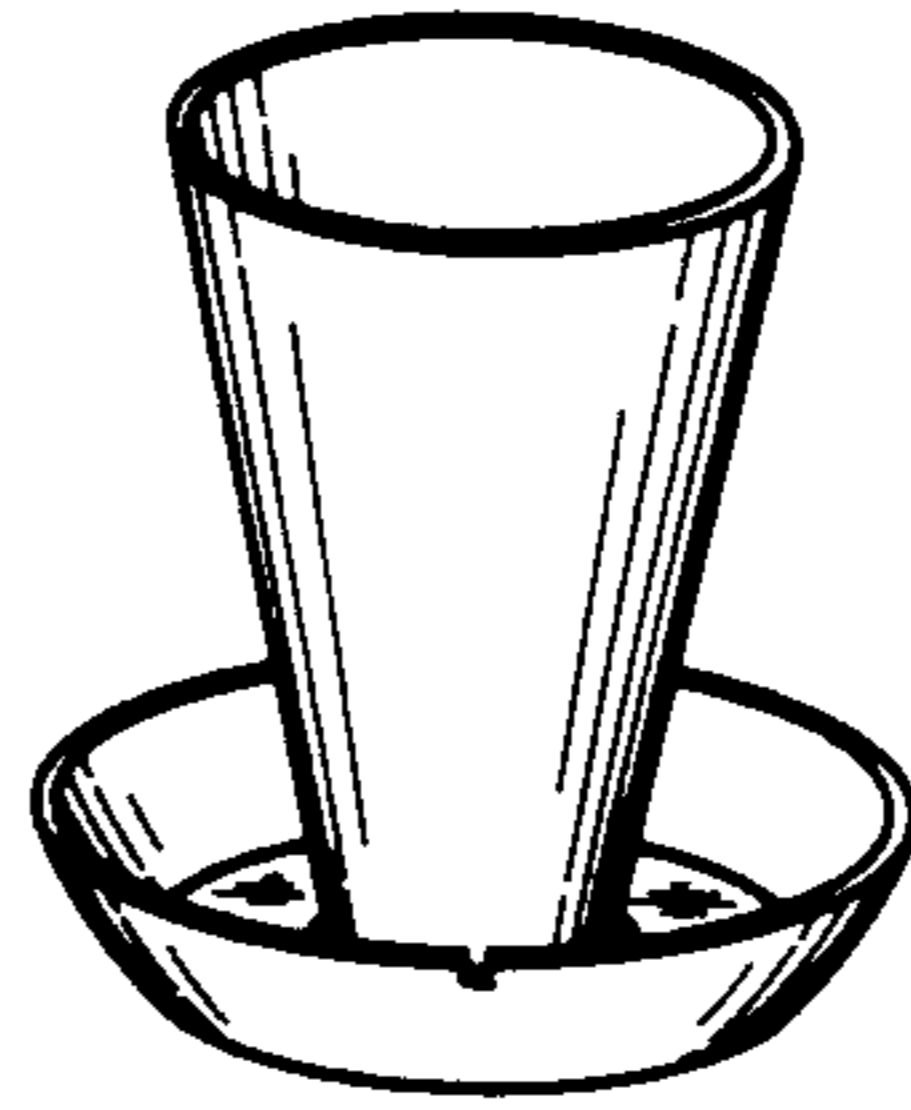

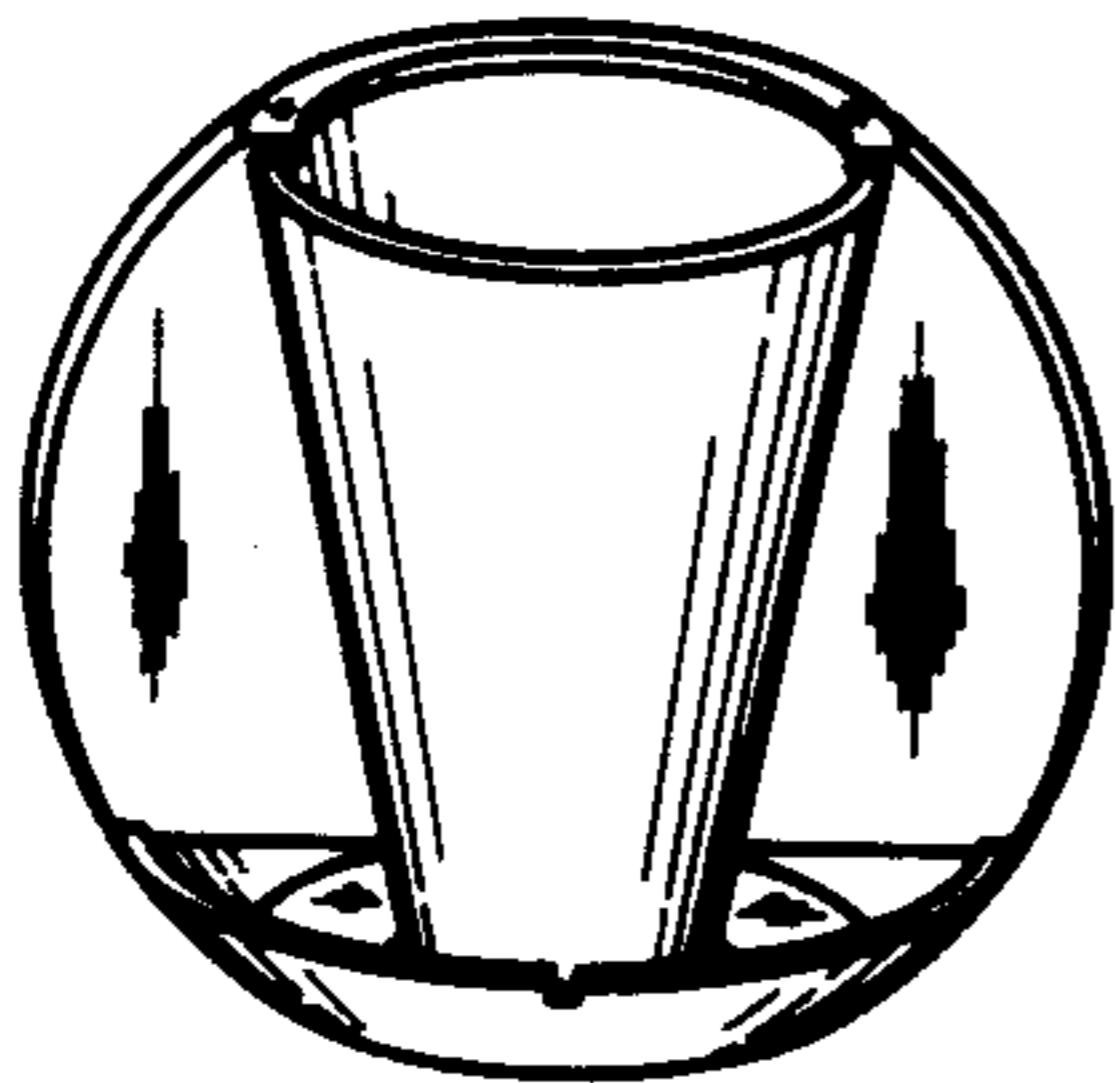

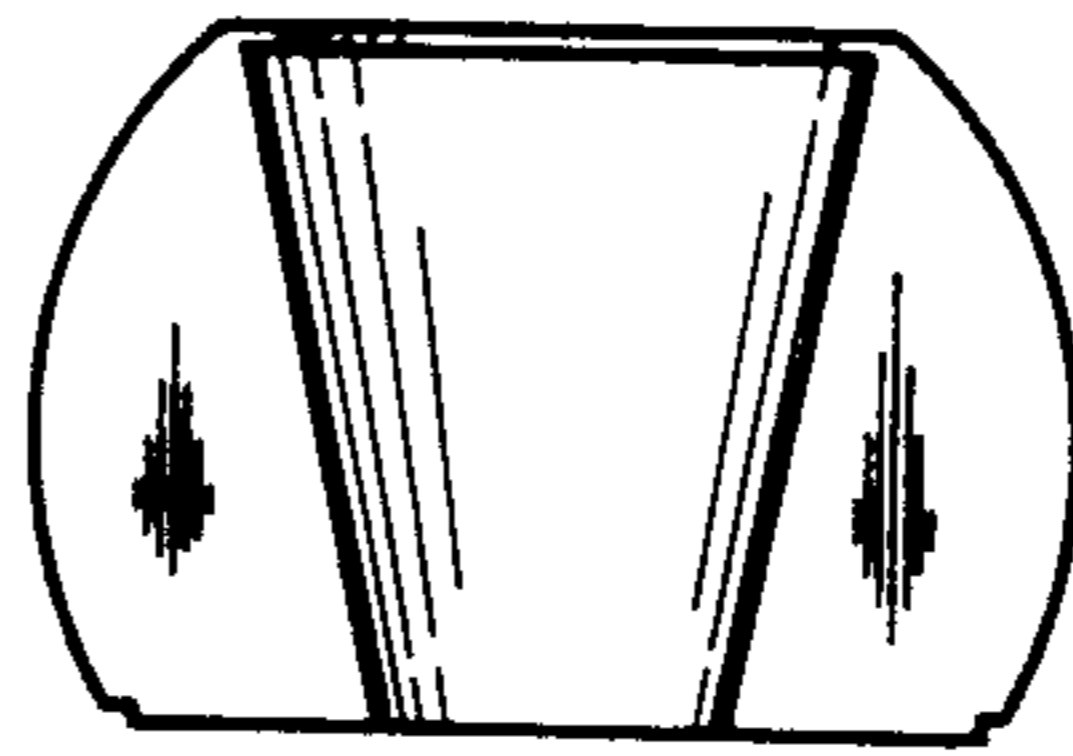

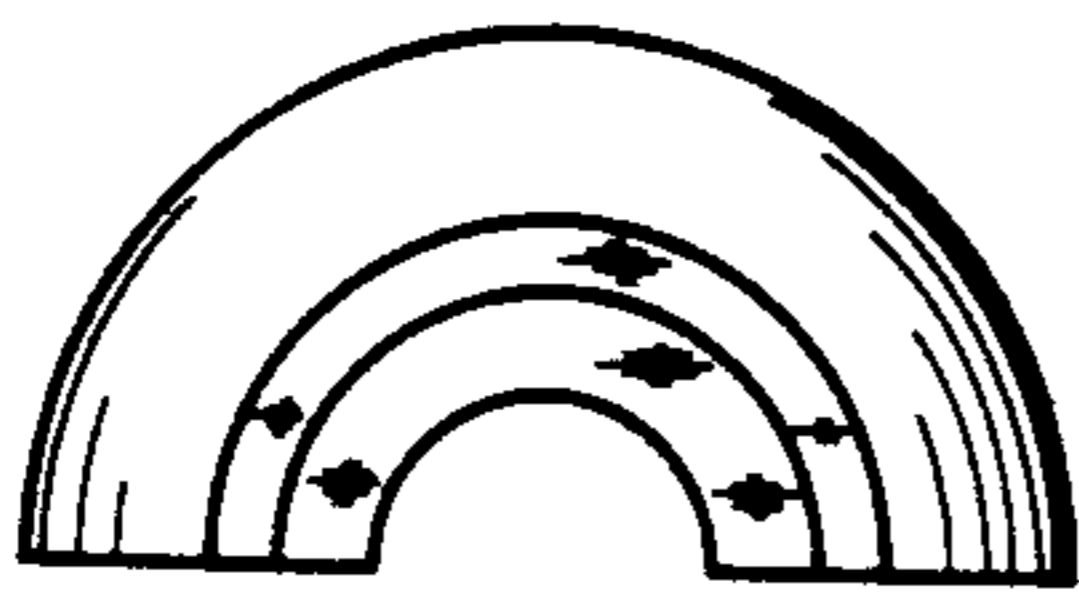

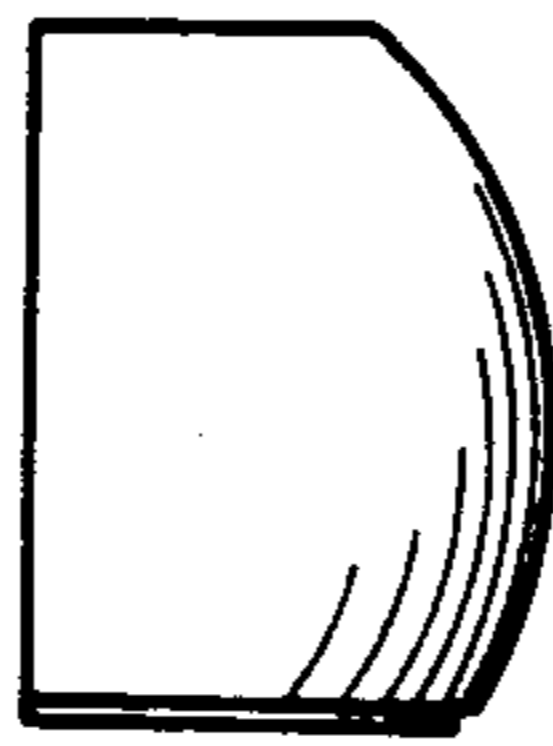

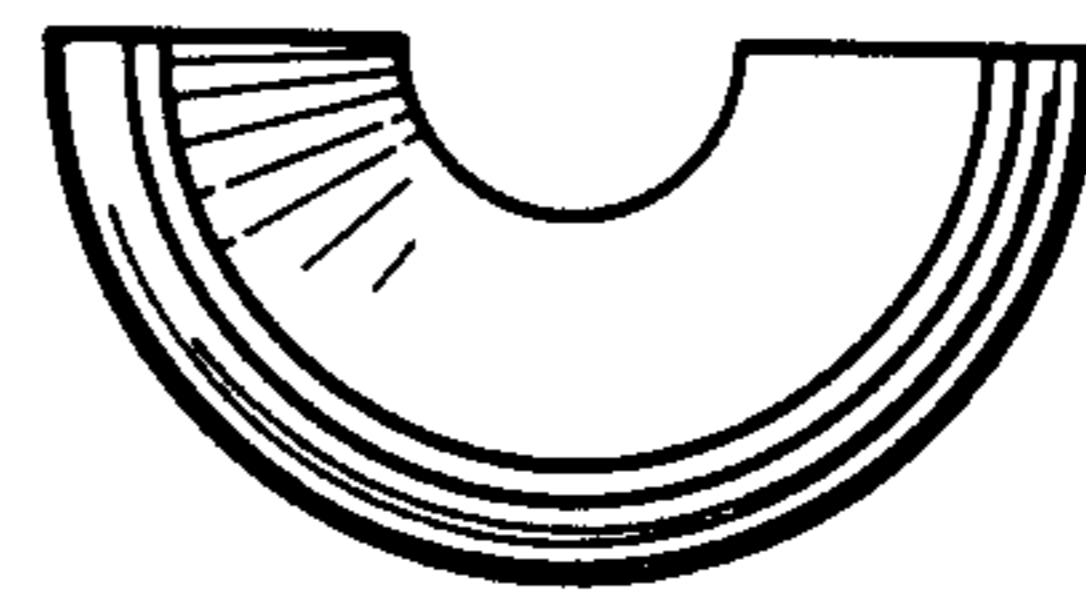
